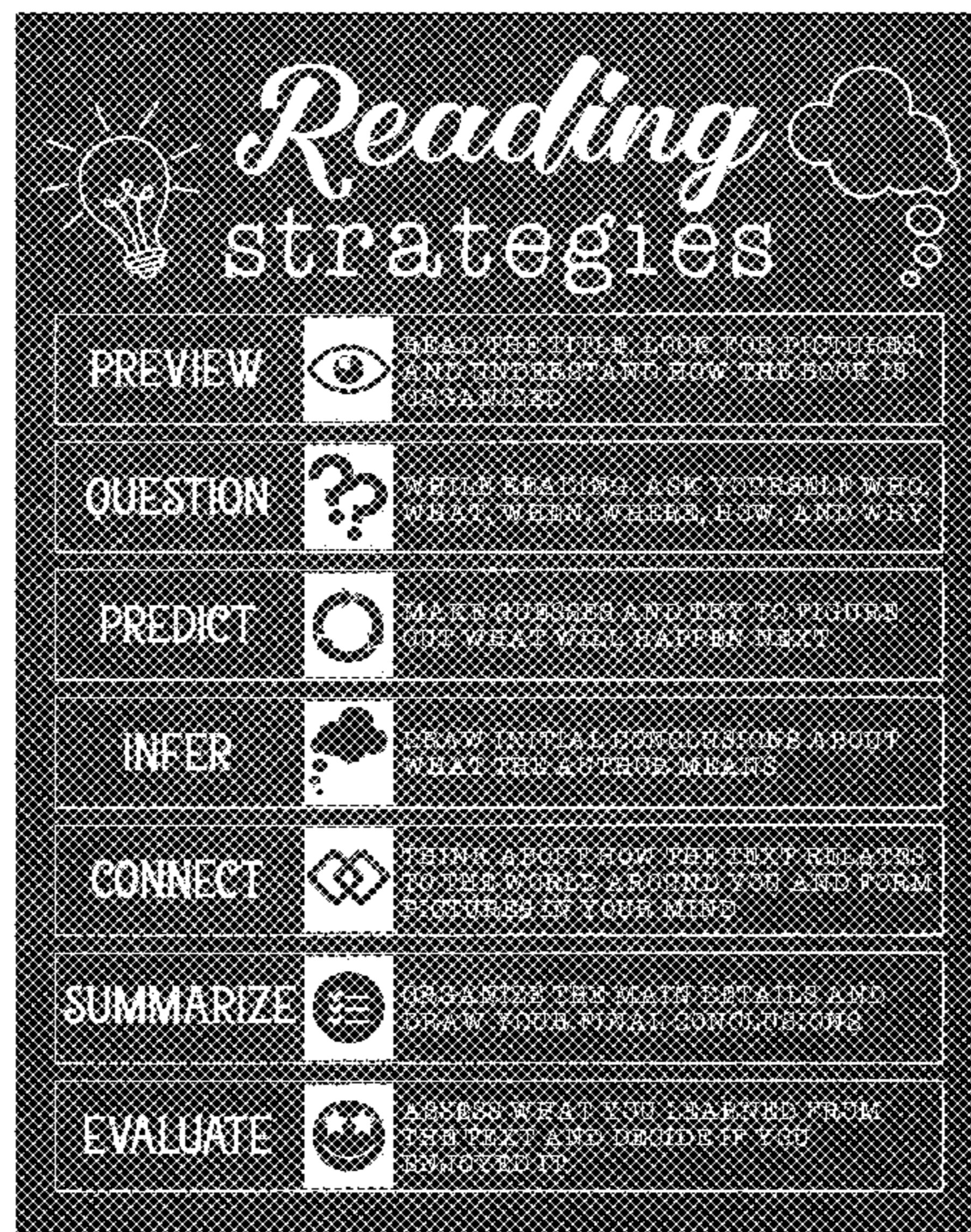



<b>QUESTION</b>		WHILE READING, ASK YOURSELF WHO, WHAT, WHEN, WHERE, HOW, AND WHY
<b>PREDICT</b>		MAKE GUESSES AND TRY TO FIGURE OUT WHAT WILL HAPPEN NEXT
<b>INFER</b>		DRAW INITIAL CONCLUSIONS ABOUT WHAT THE AUTHOR MEANS
<b>CONNECT</b>		THINK ABOUT HOW THE TEXT RELATES TO THE WORLD AROUND YOU AND FORM PICTURES IN YOUR MIND
<b>SUMMARIZE</b>		ORGANIZE THE MAIN DETAILS AND DRAW YOUR FINAL CONCLUSIONS
<b>EVALUATE</b>		ASSESS WHAT YOU LEARNED FROM THE TEXT AND DECIDE IF YOU ENJOYED IT
