DESCRIPTION

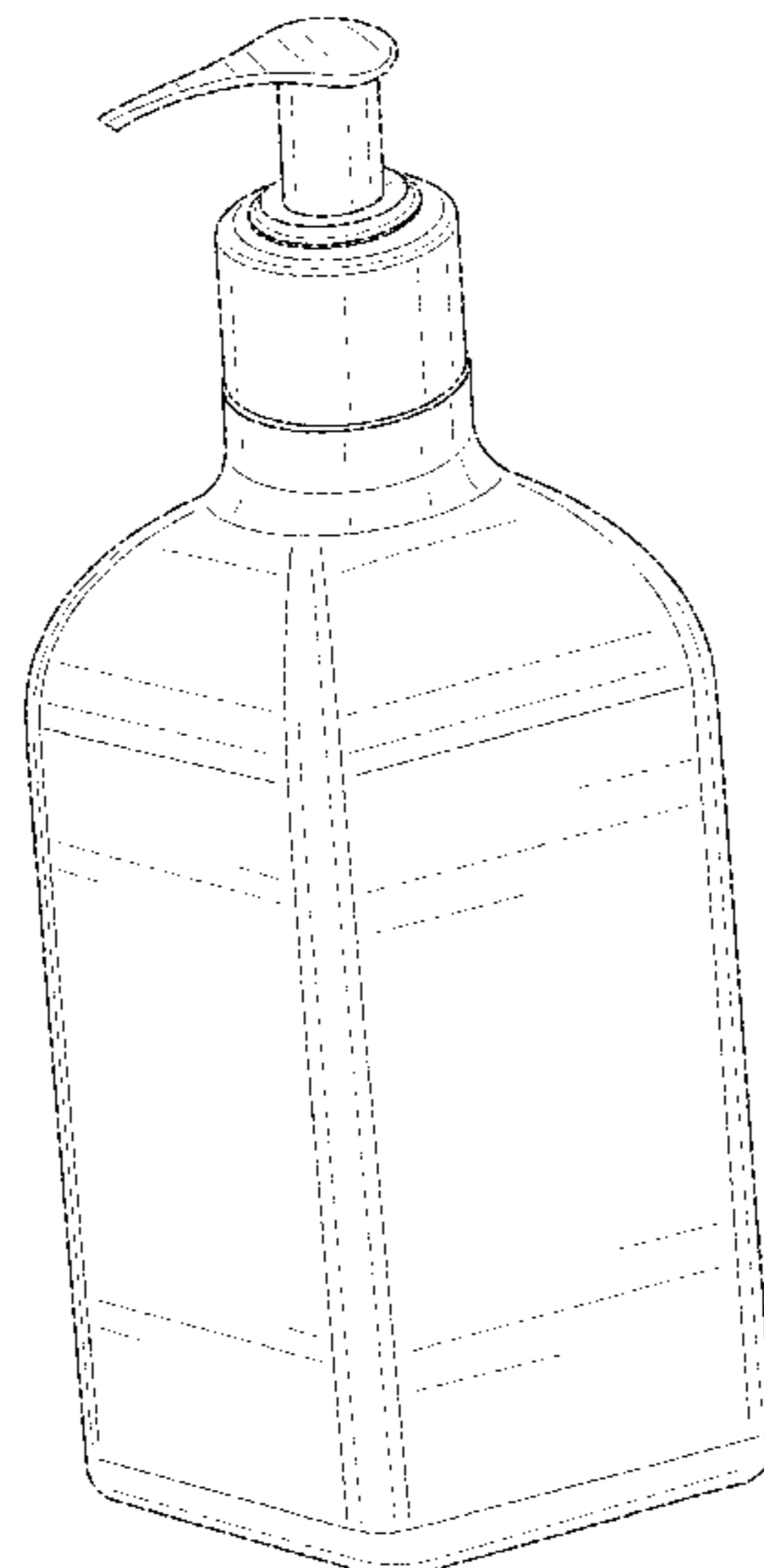
FIG. 1 is a front, upper, left perspective view of a bottle of our new design;

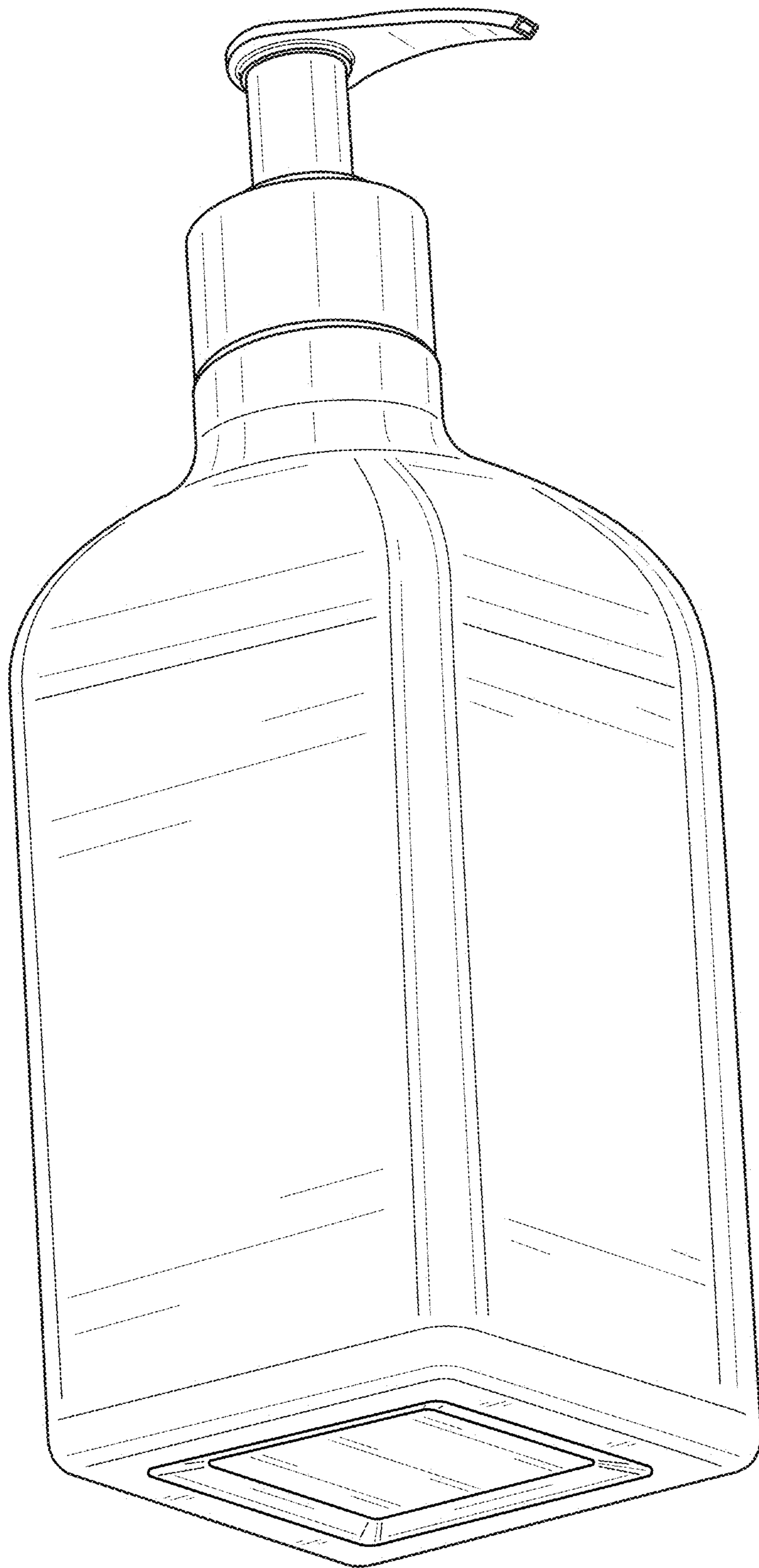

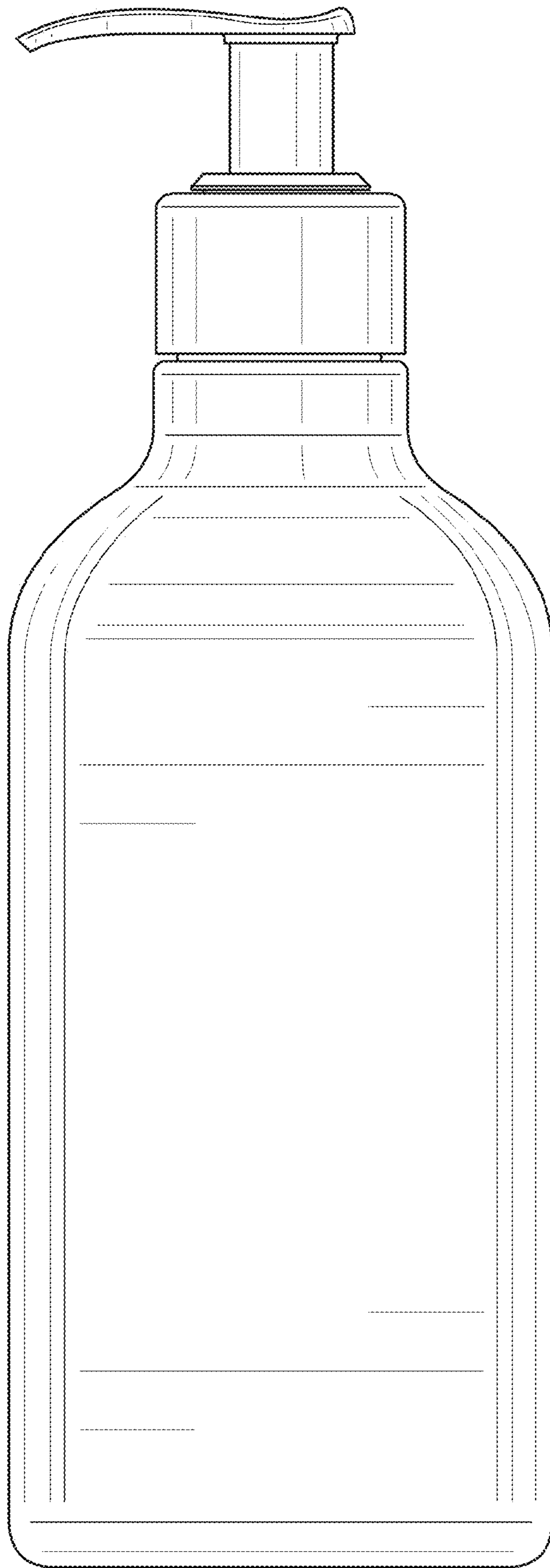

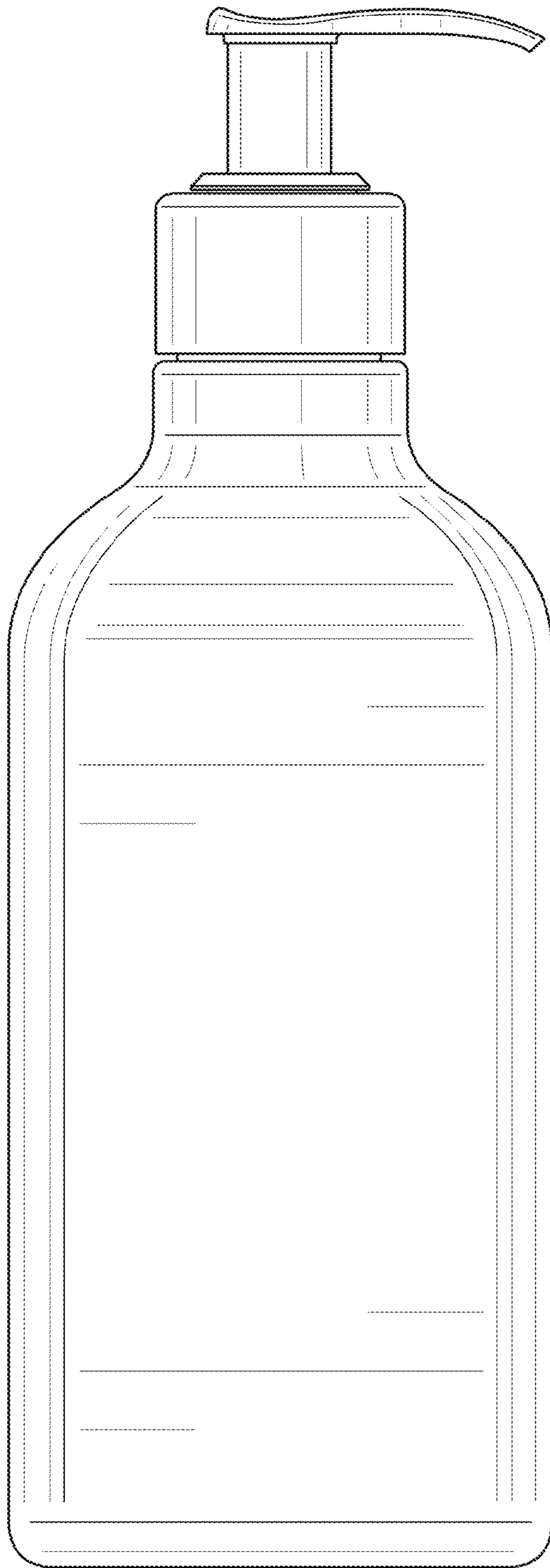

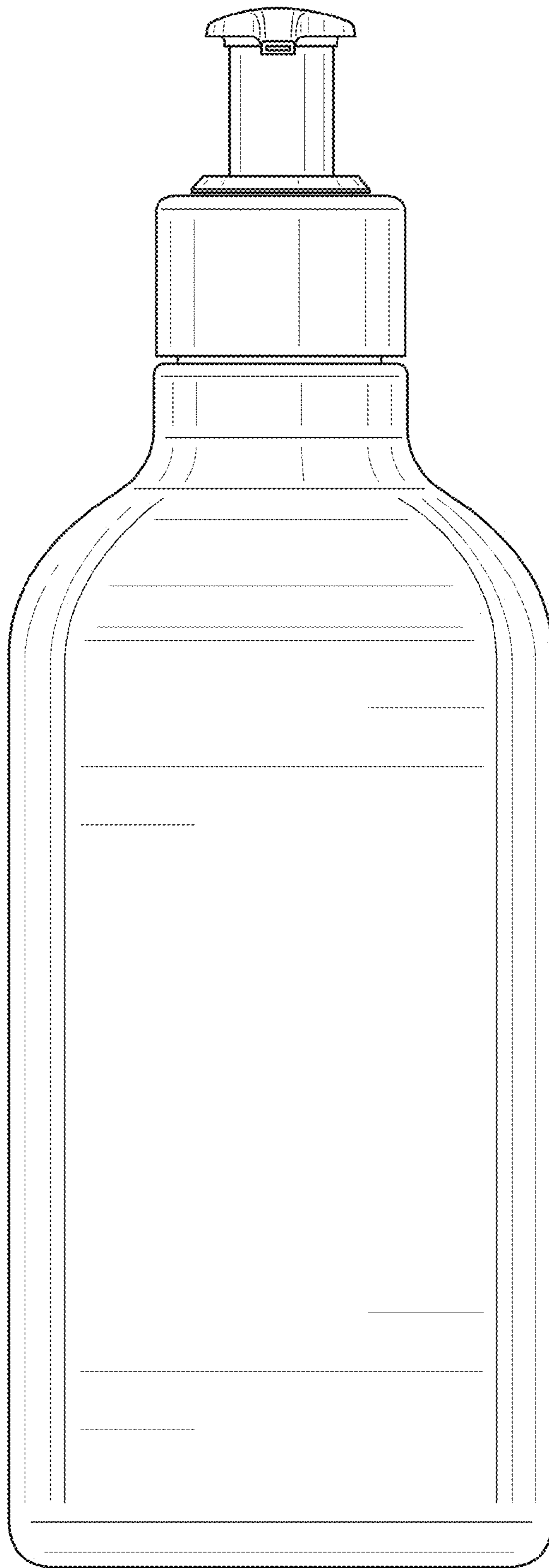

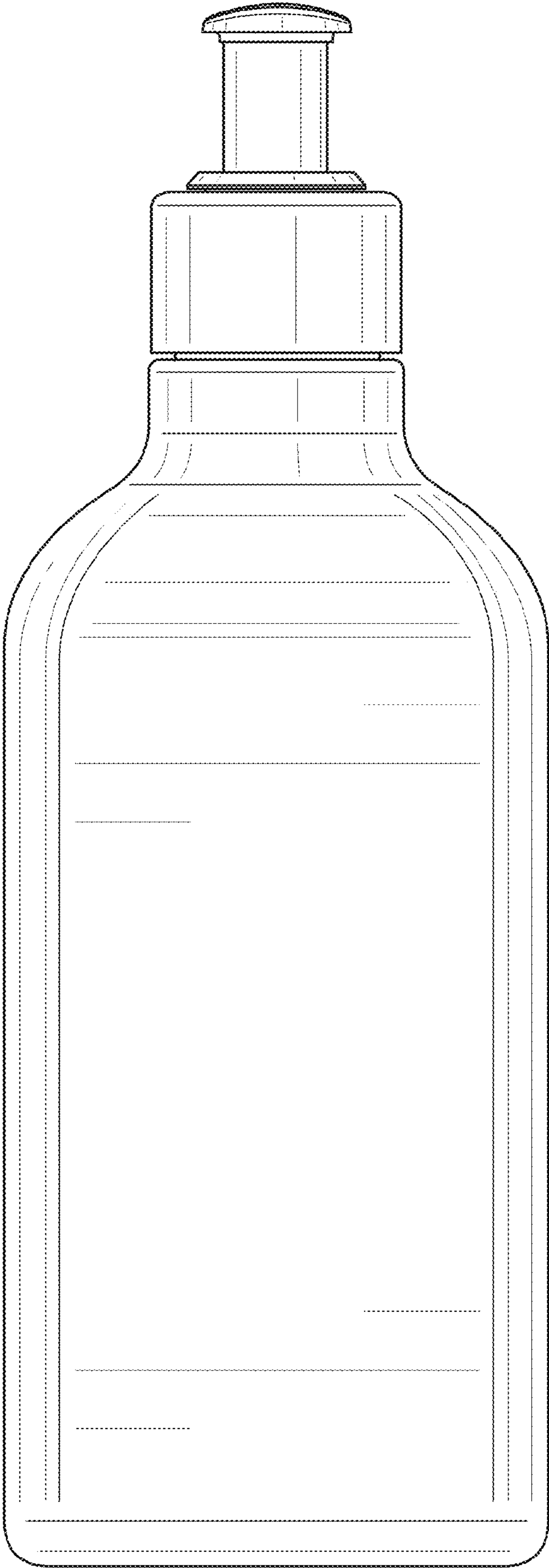

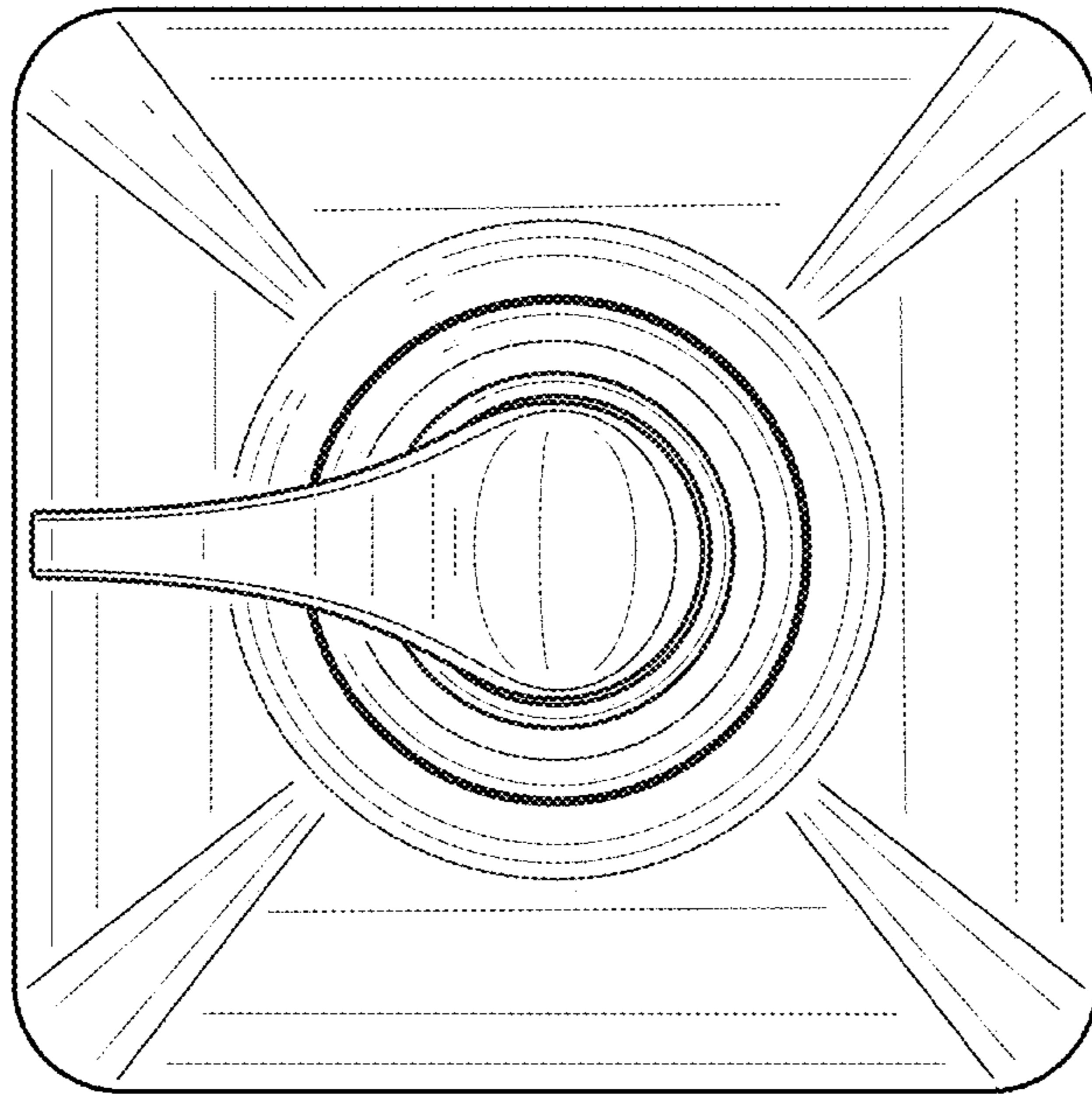

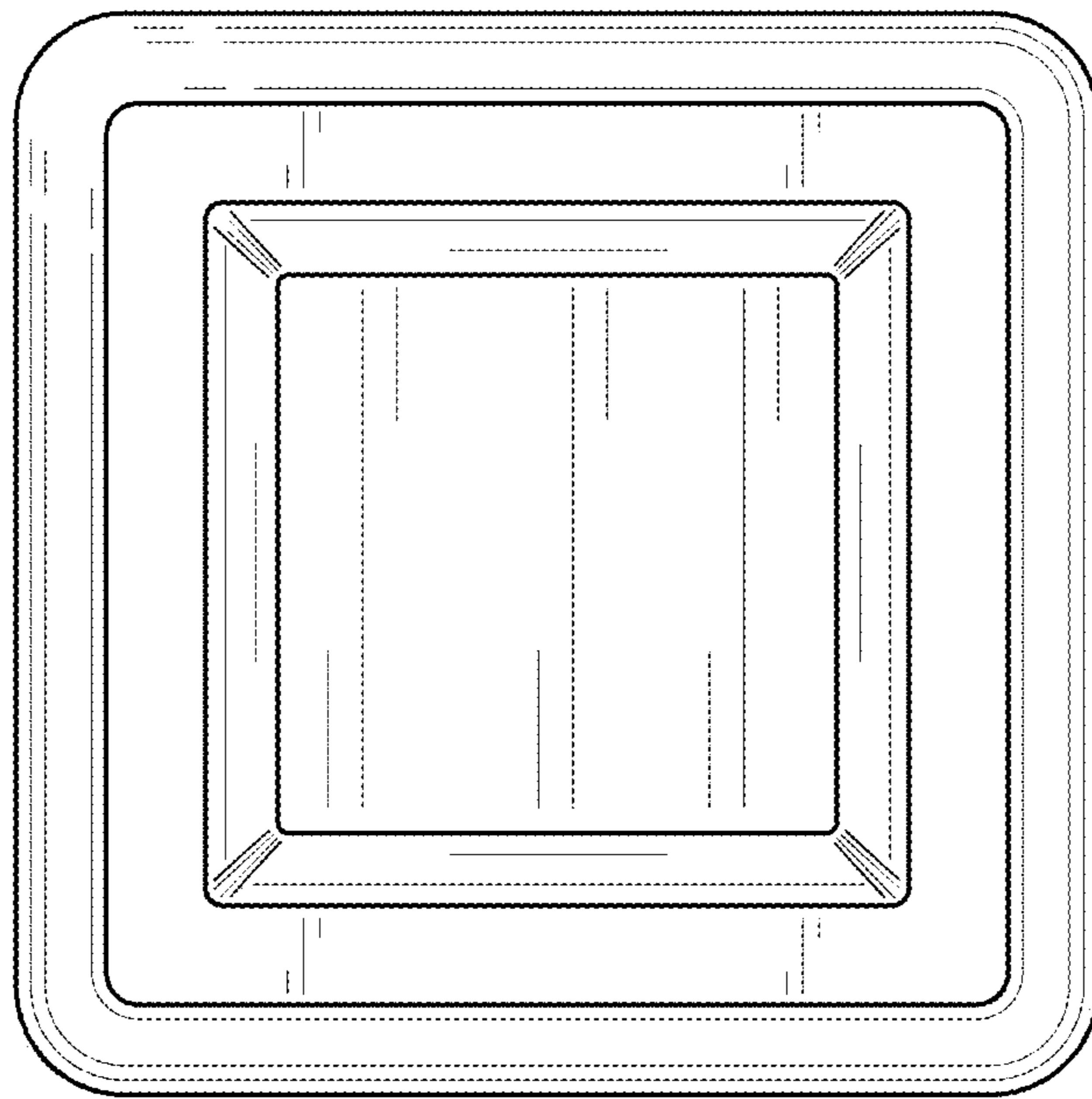
