DESCRIPTION

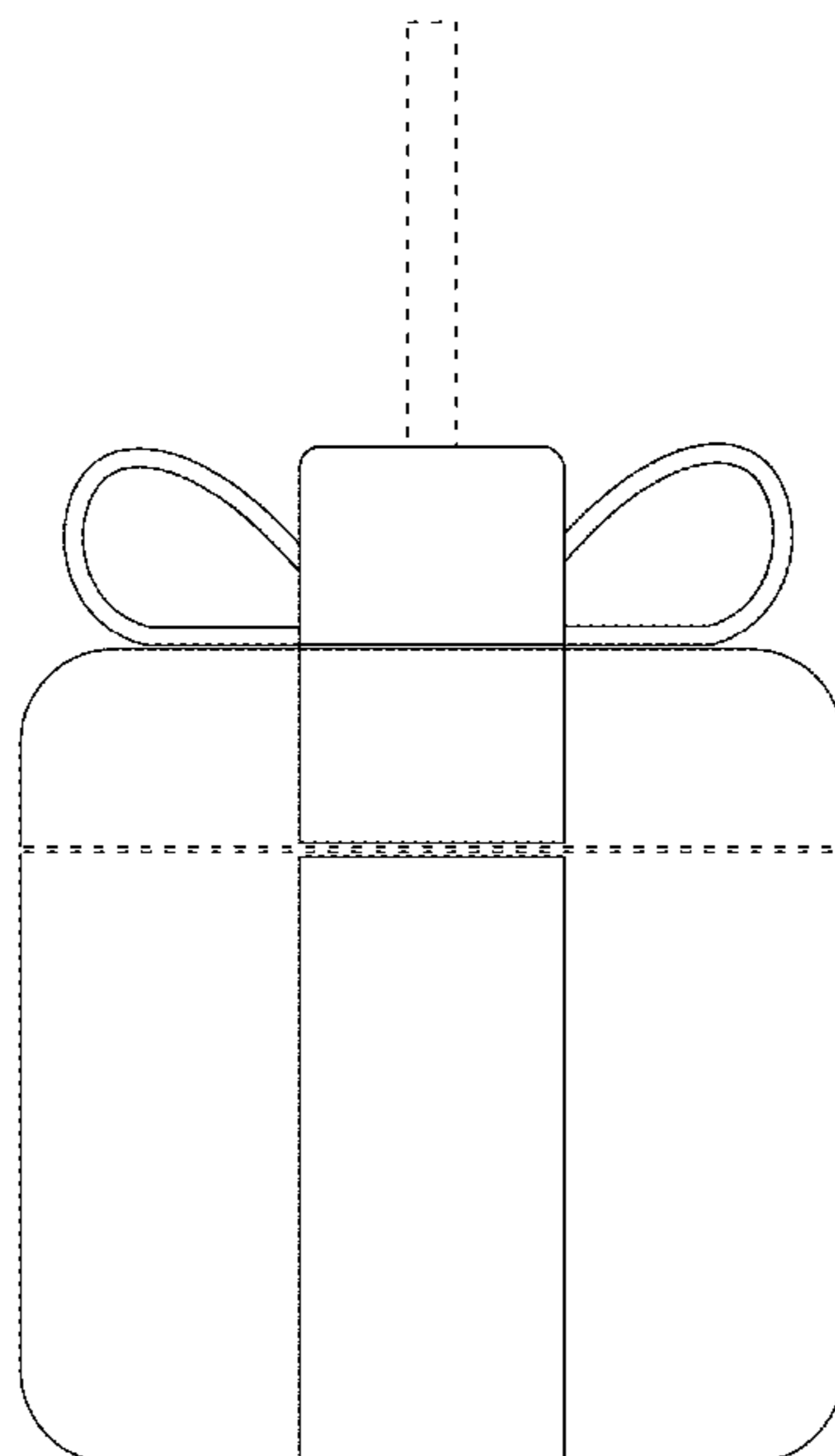
FIG. 1 is a front view of a present cup showing my new design;

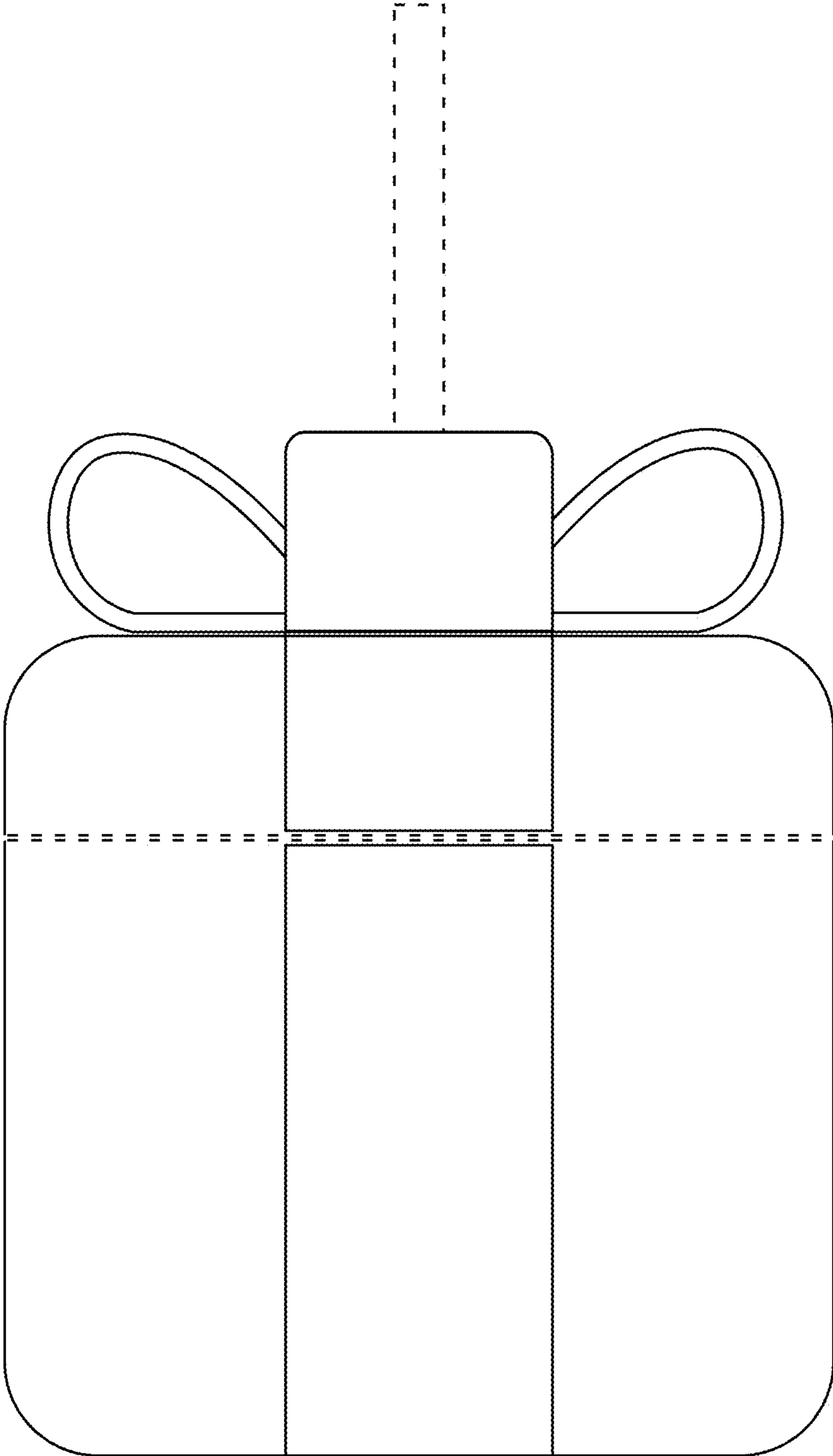

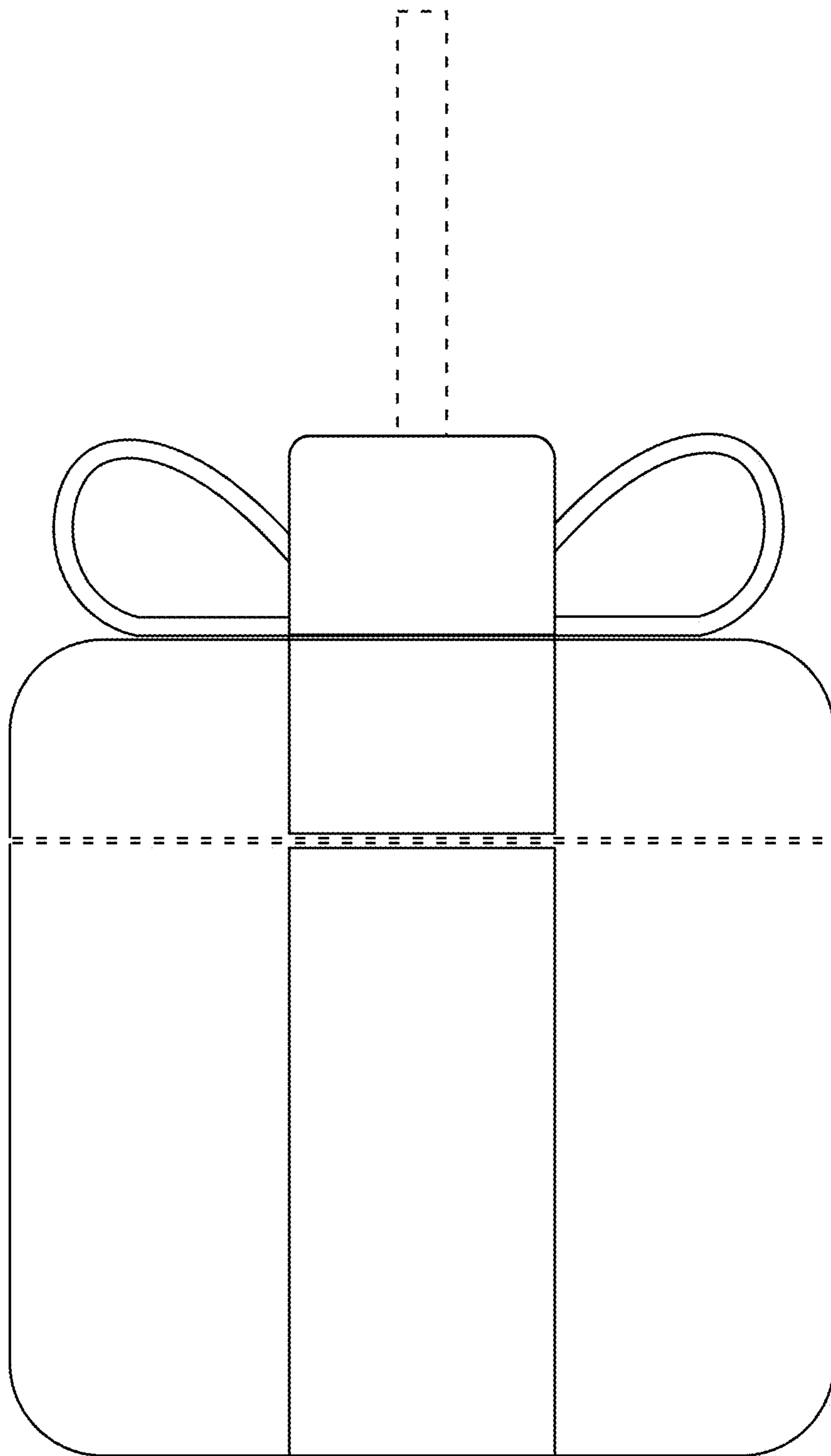

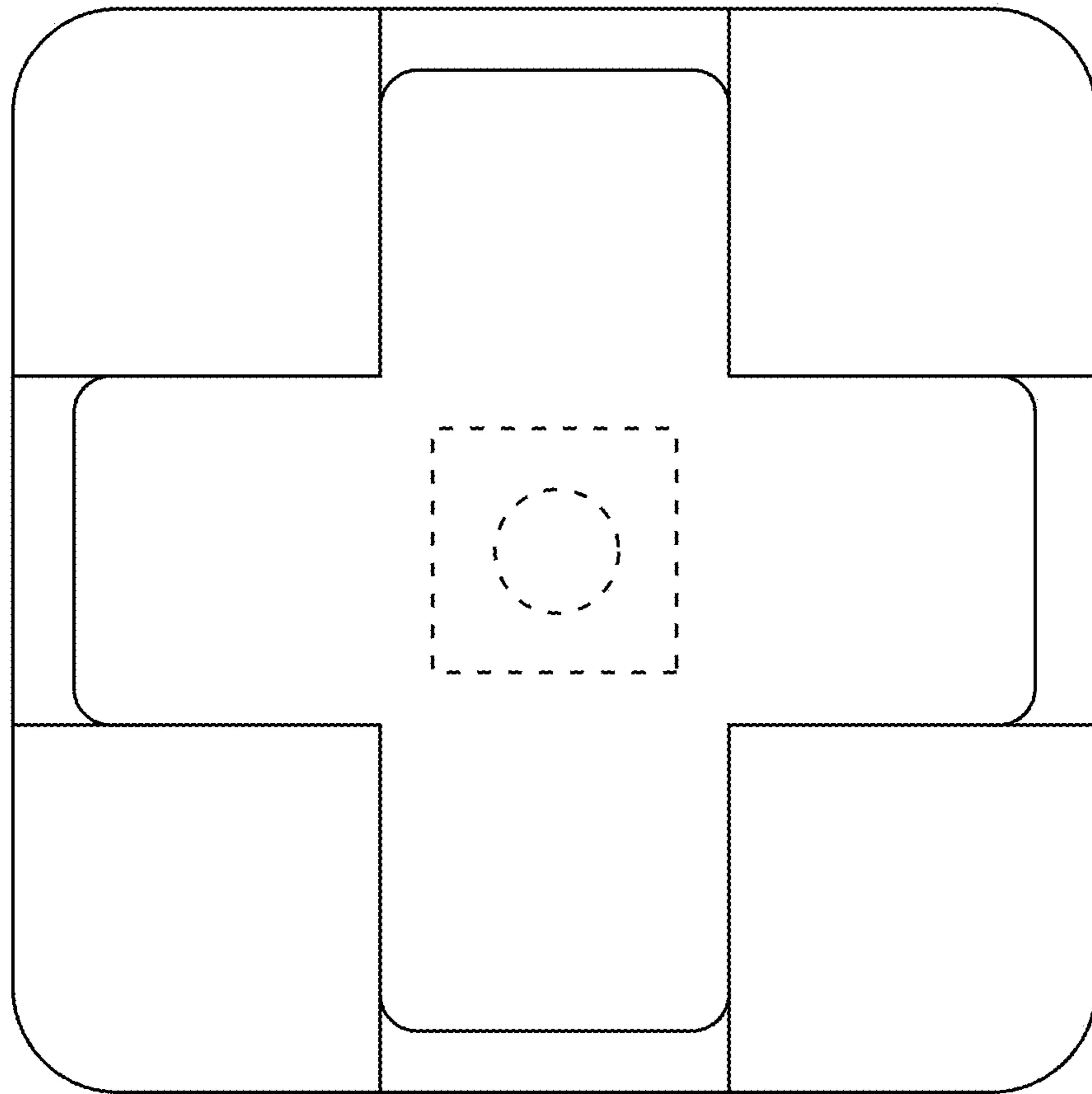
