The ornamental design for a educational poster, as shown and described.

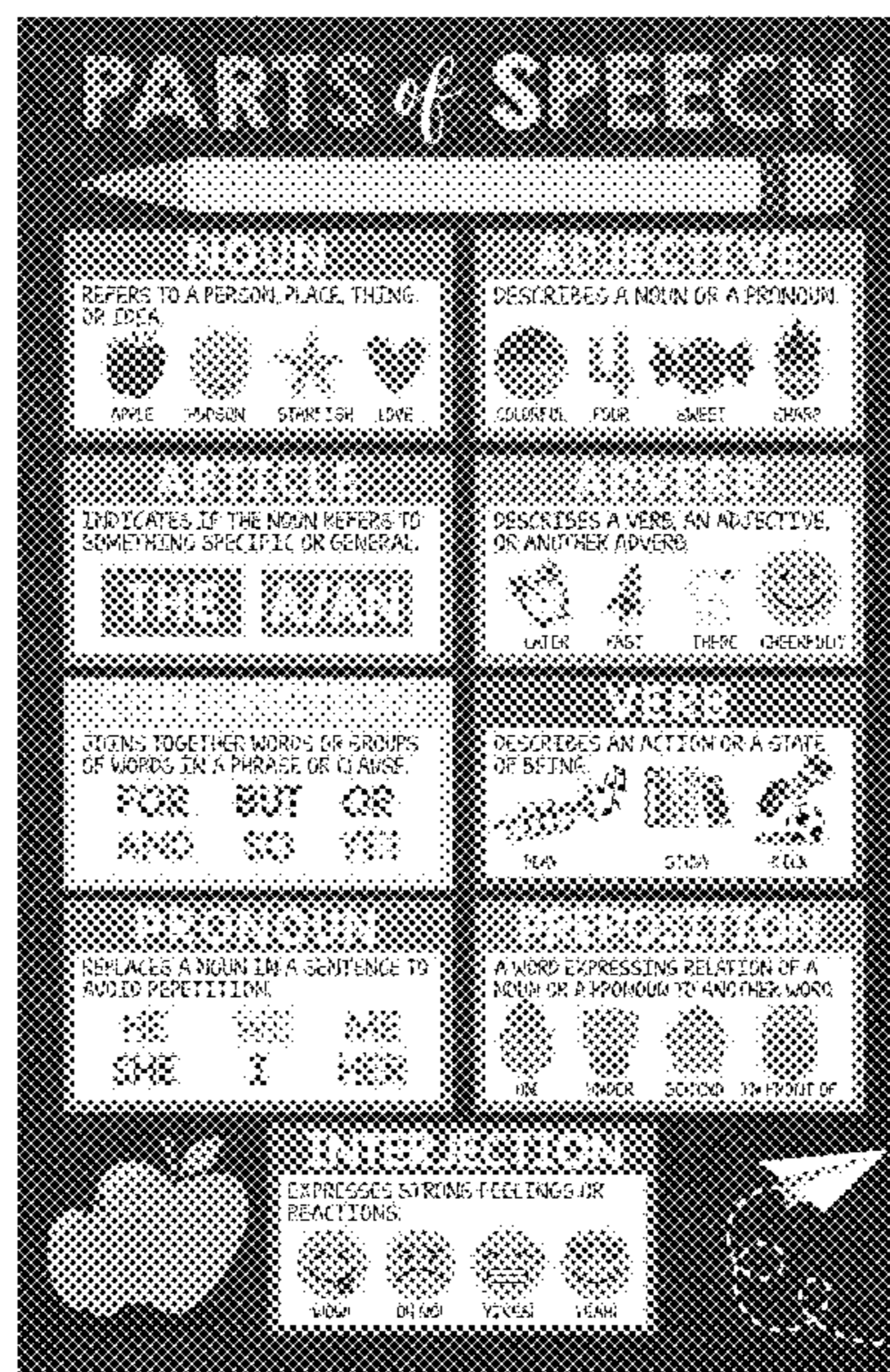
DESCRIPTION
