DESCRIPTION

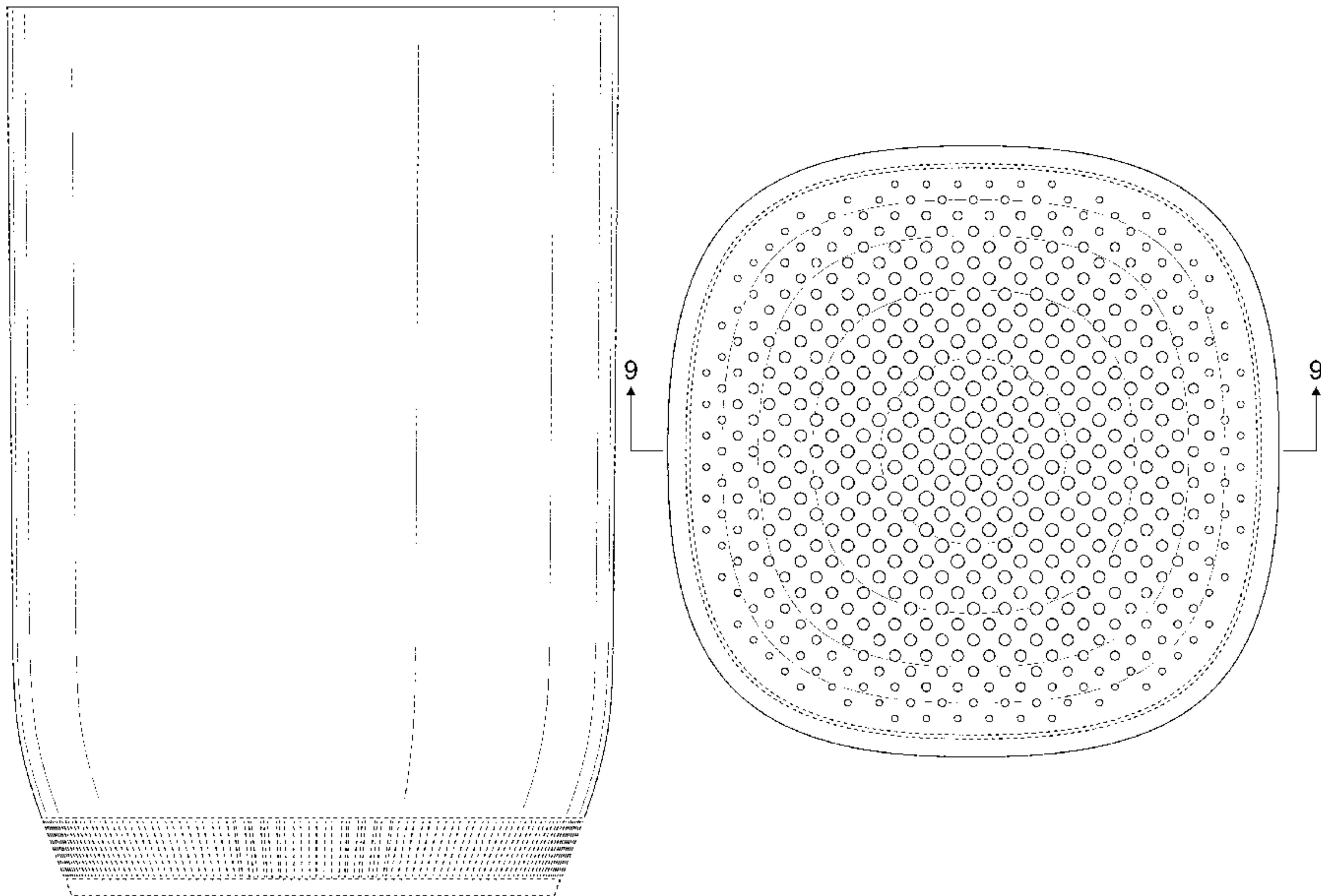
FIG. 1 is a front perspective view of a range extender showing our new design;

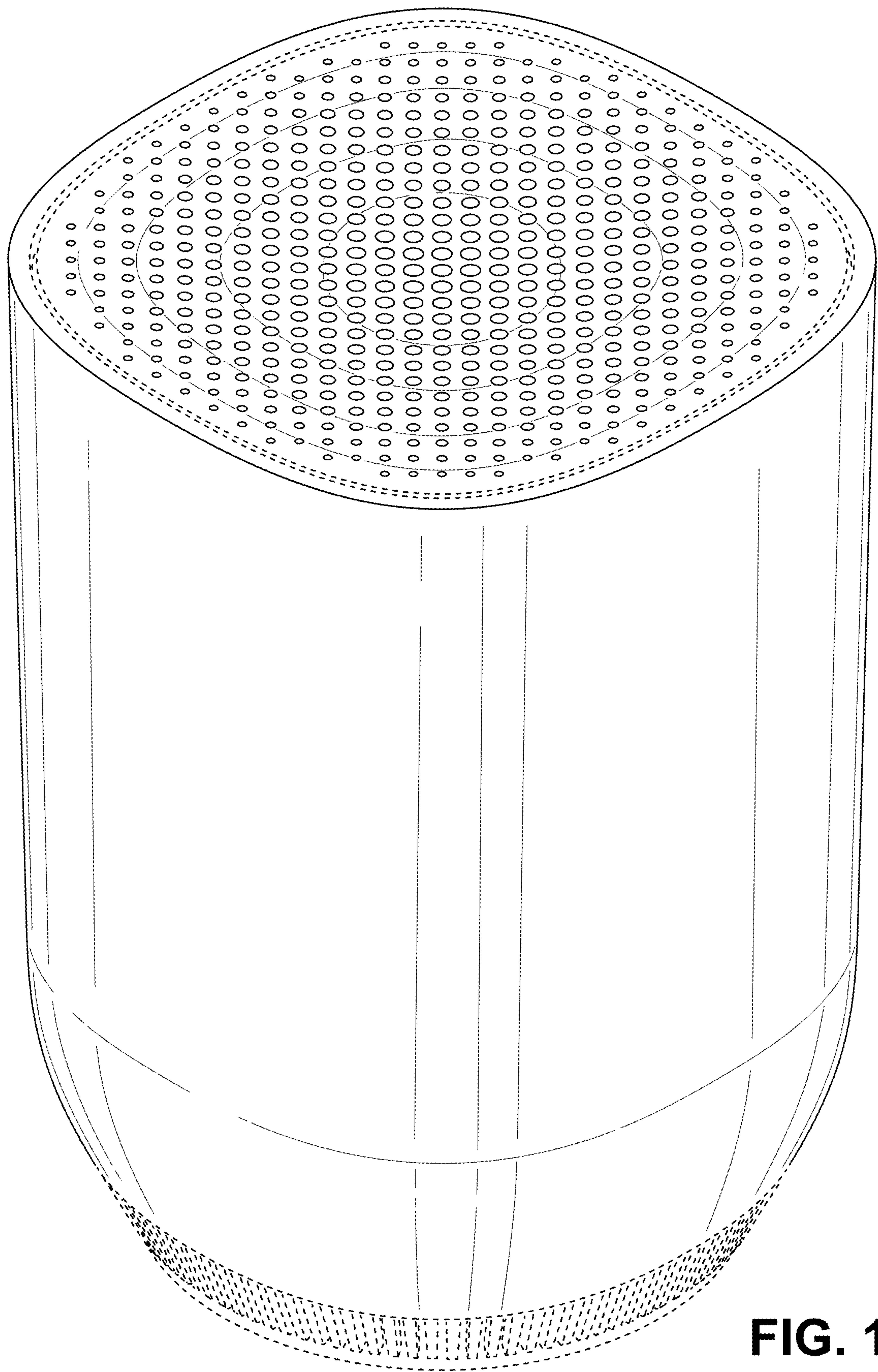

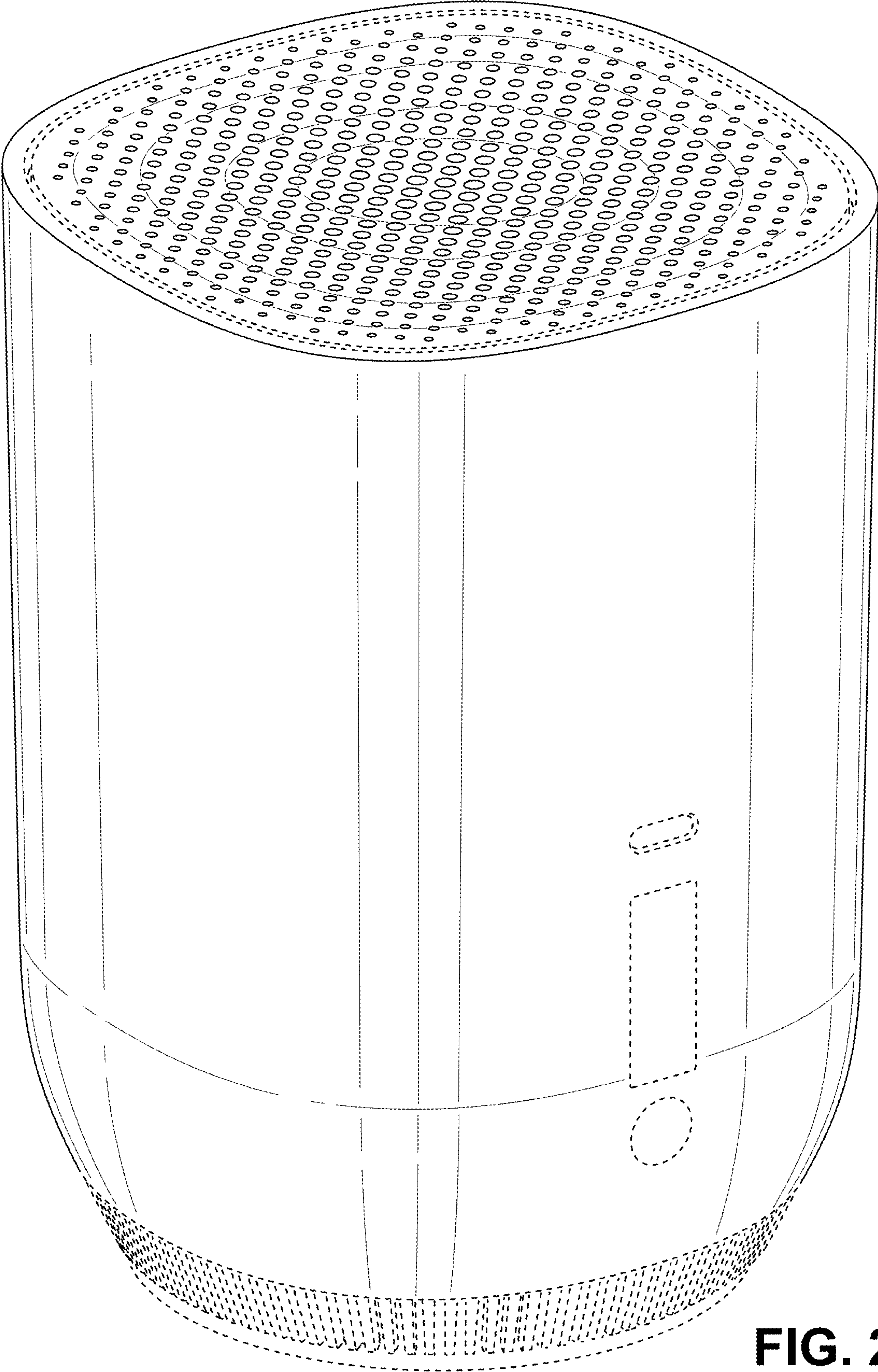

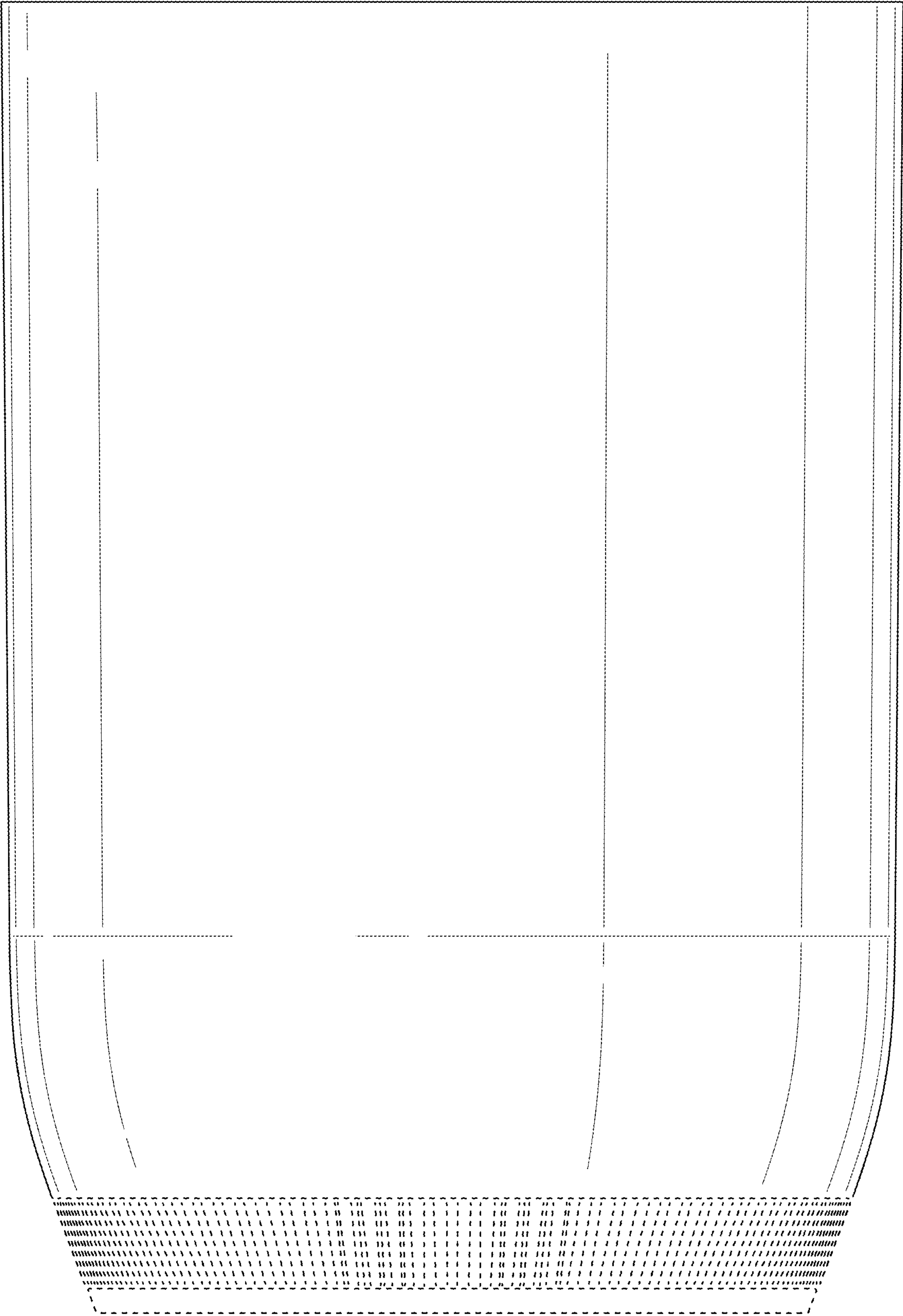

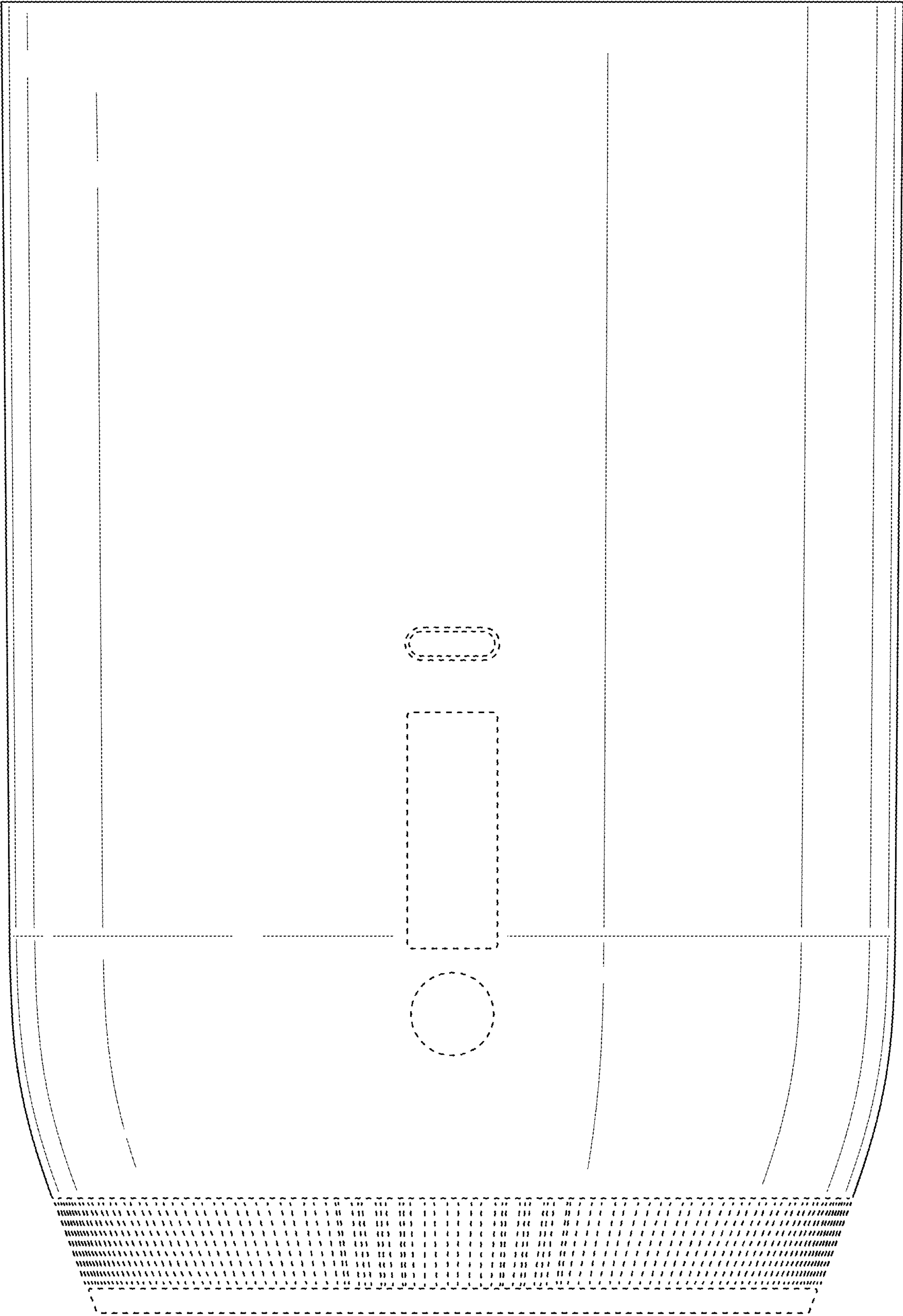

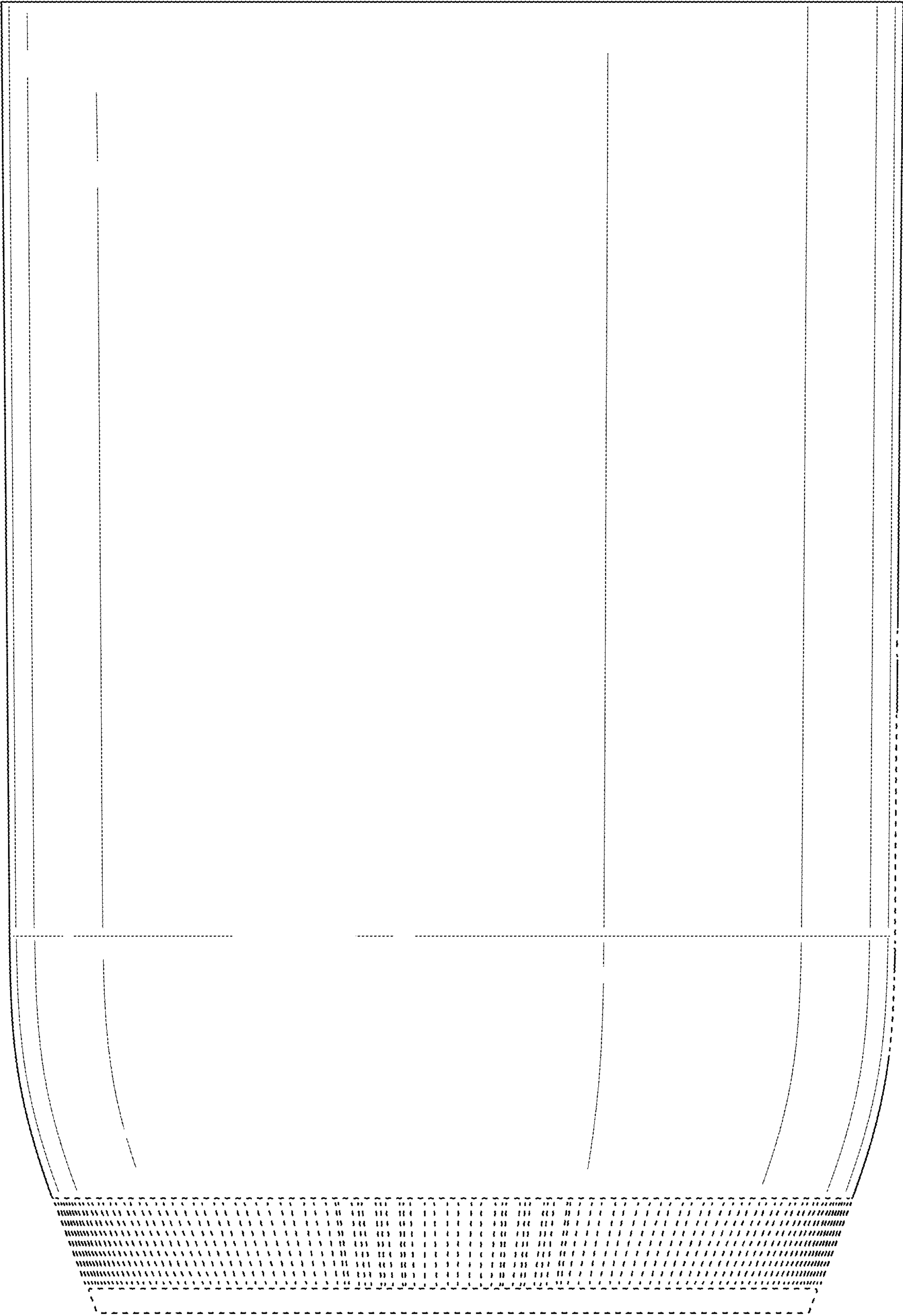

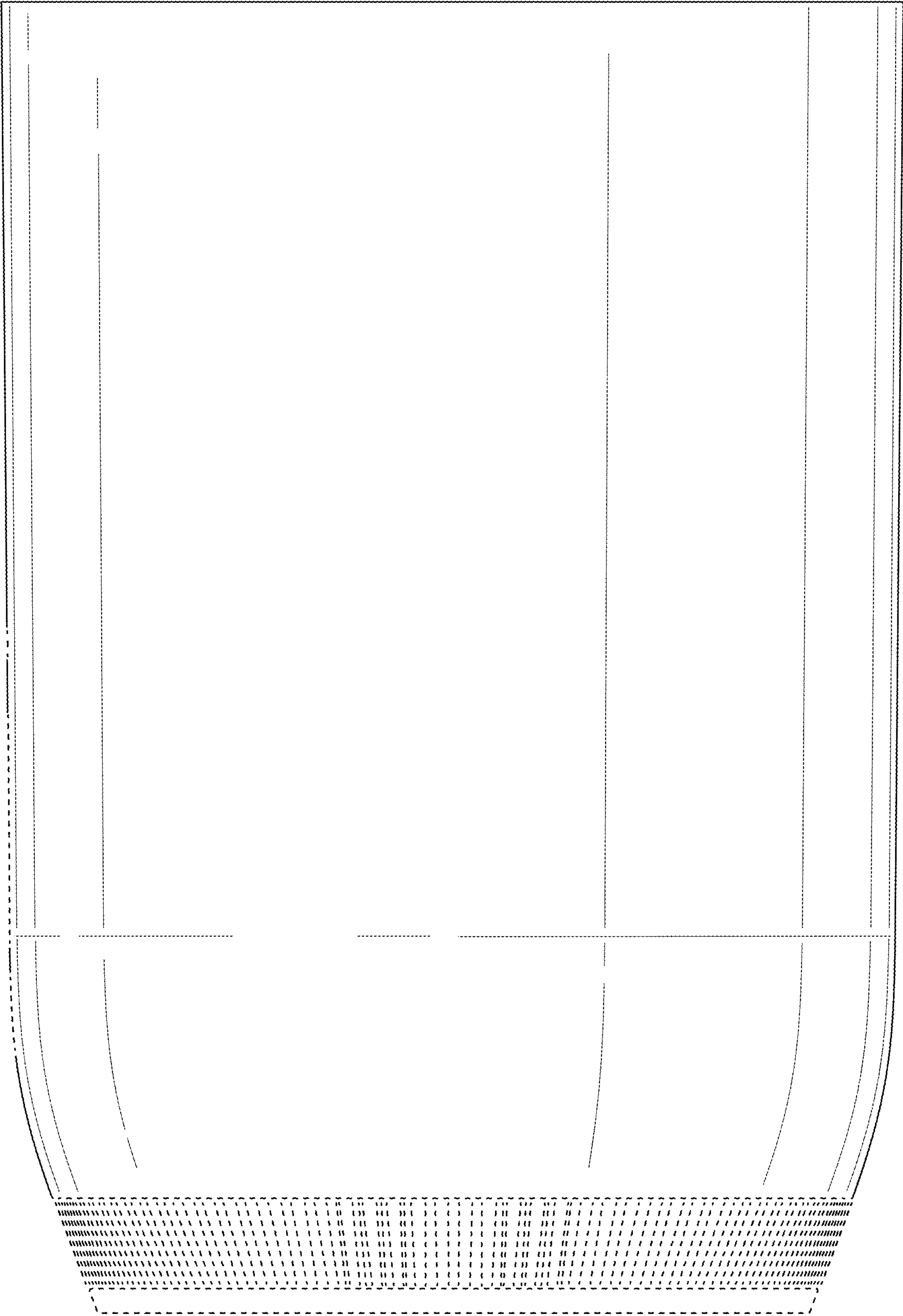

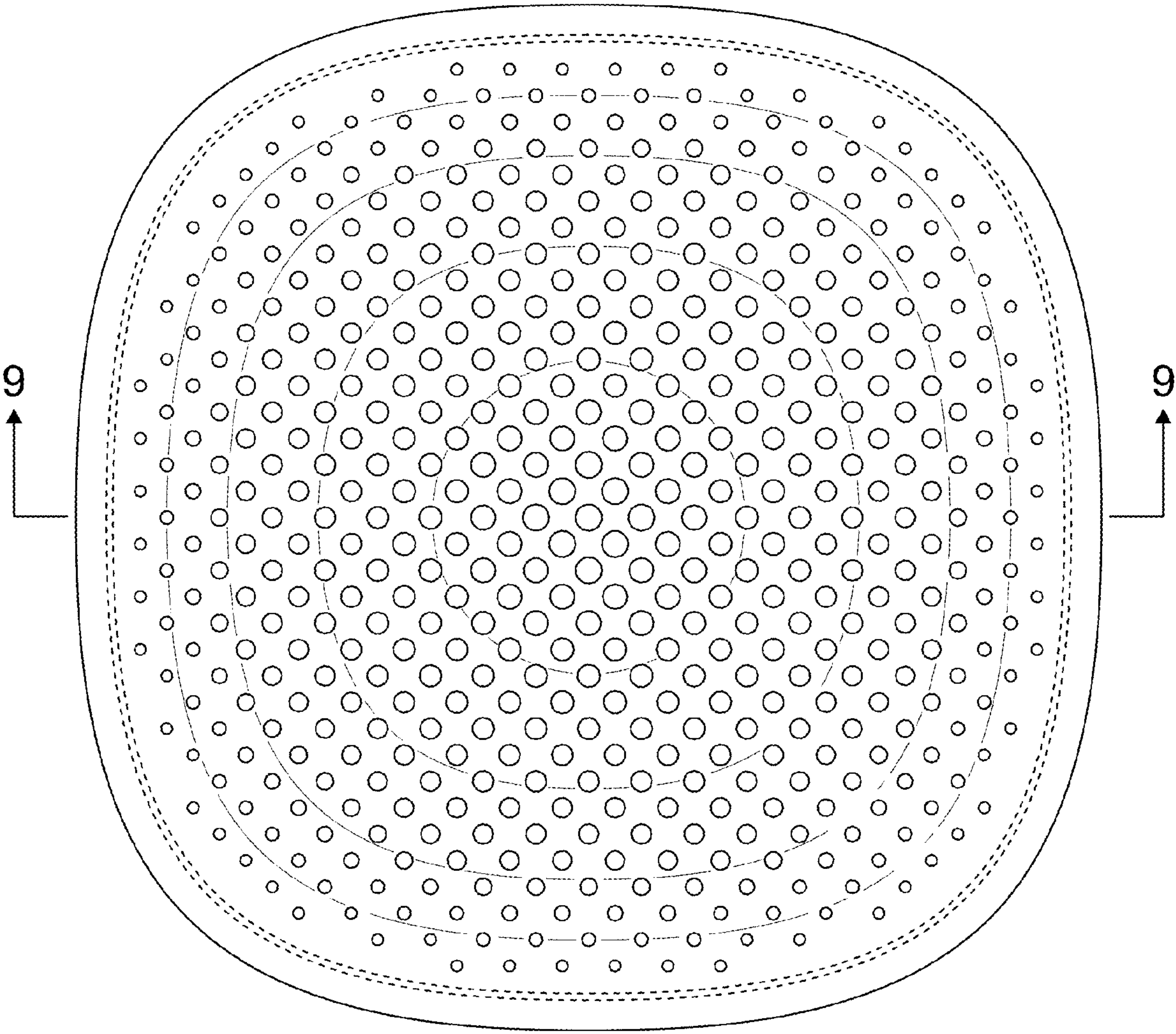

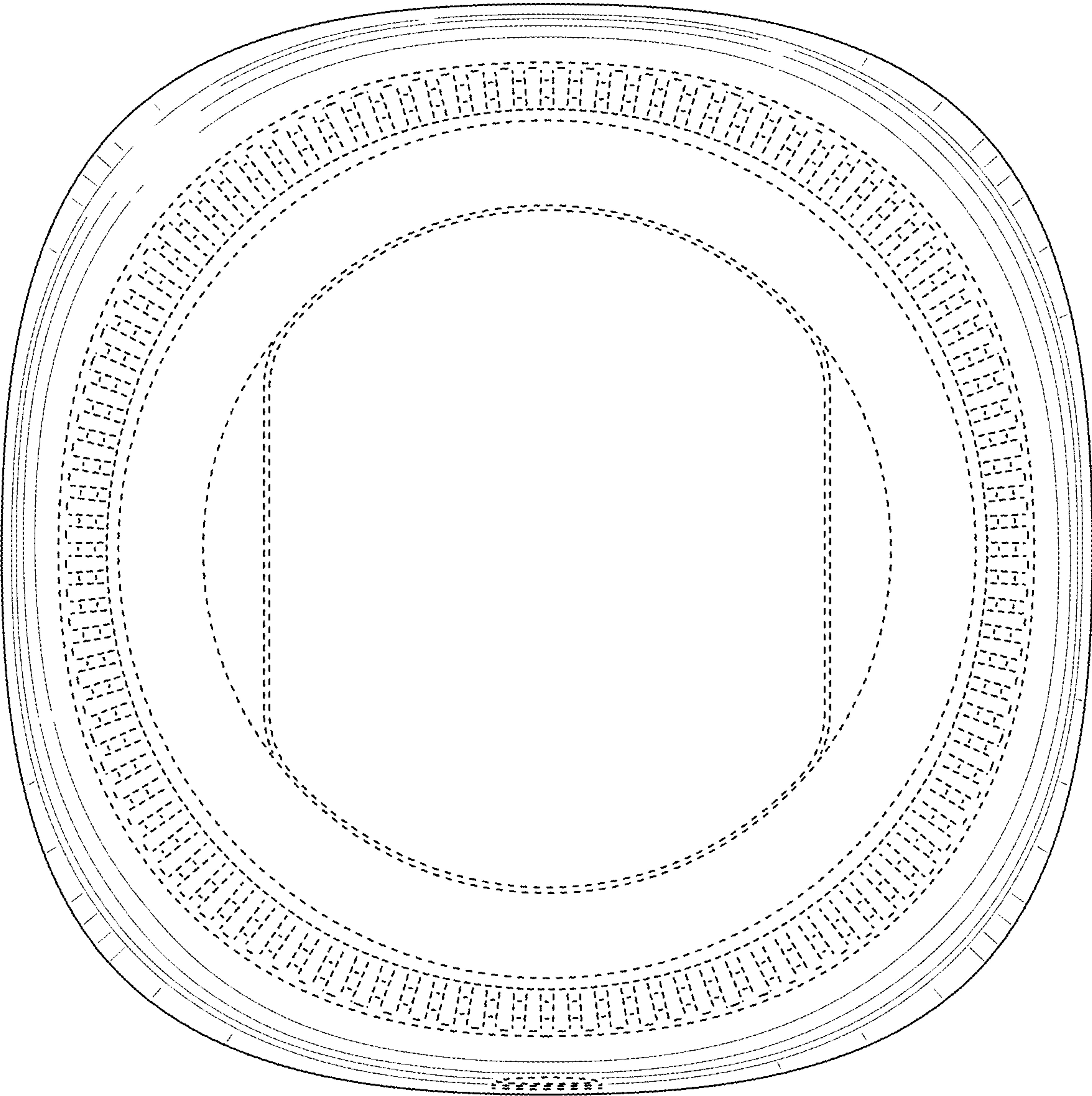

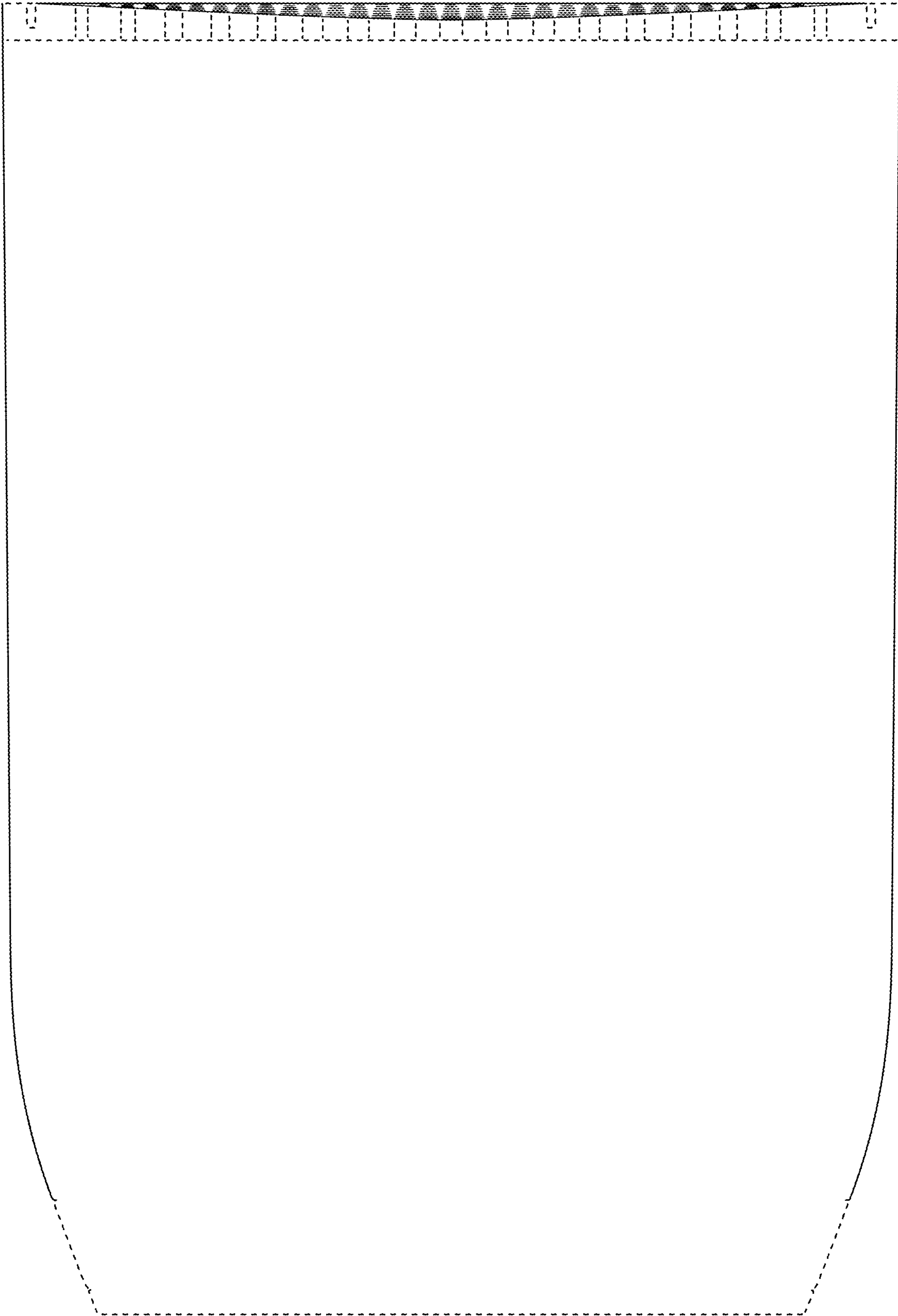
