(57) CLAIM

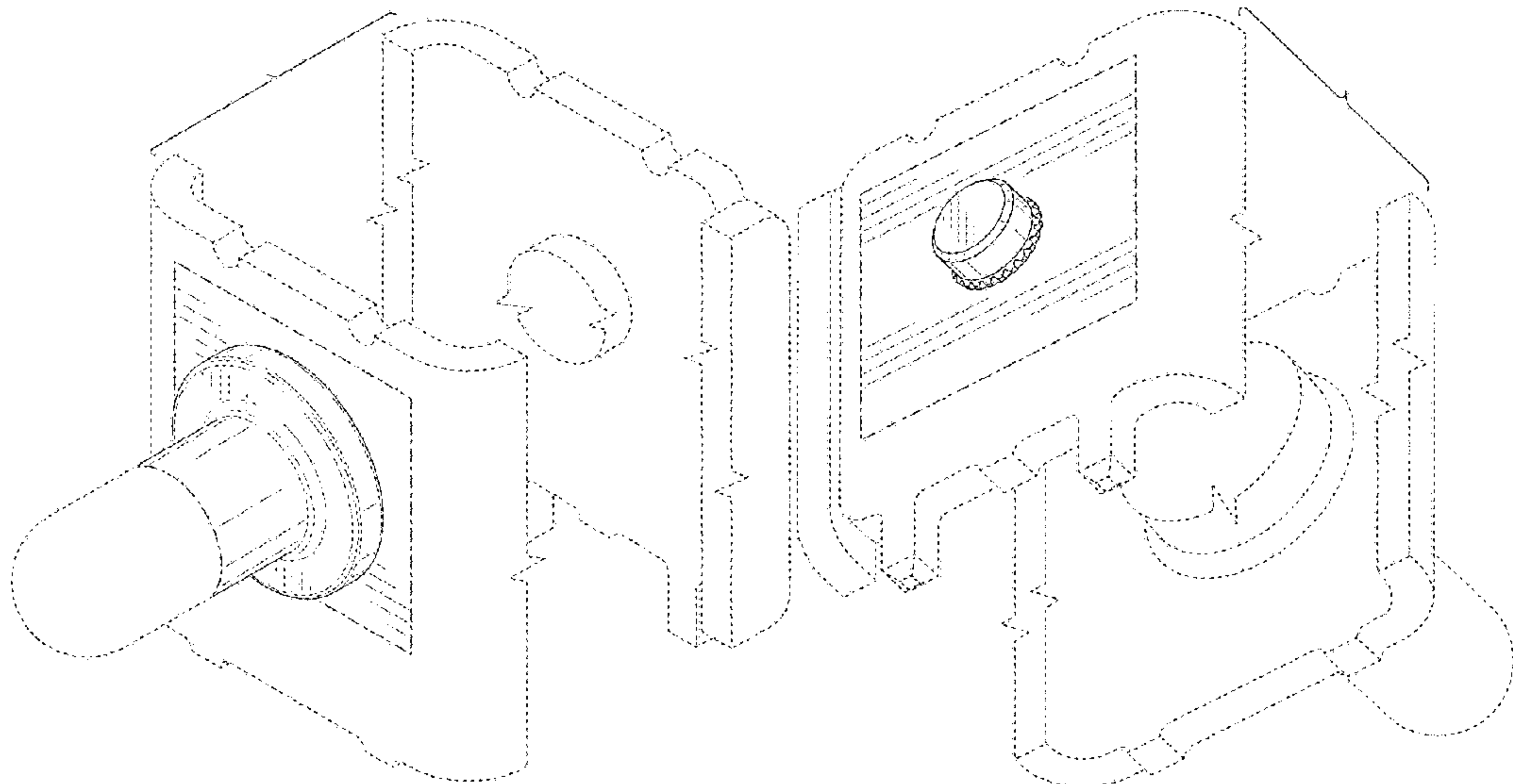
The ornamental design for a connector, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a connector showing our new design;
FIG. 2 is a front bottom perspective view thereof;
FIG. 3 is a rear top perspective view thereof;
FIG. 4 is a rear bottom perspective view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a left side view thereof;
FIG. 8 is a right side view thereof;
FIG. 9 is a top view thereof; and,
FIG. 10 is a bottom view thereof.

The uneven-length broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The even-length broken lines depicting the remainder of the connector form no part of the claimed design. The connector is shown with a symbolic break in length. The appearance of any portion of the connector between the break lines indicated by brackets forms no part of the claimed design.

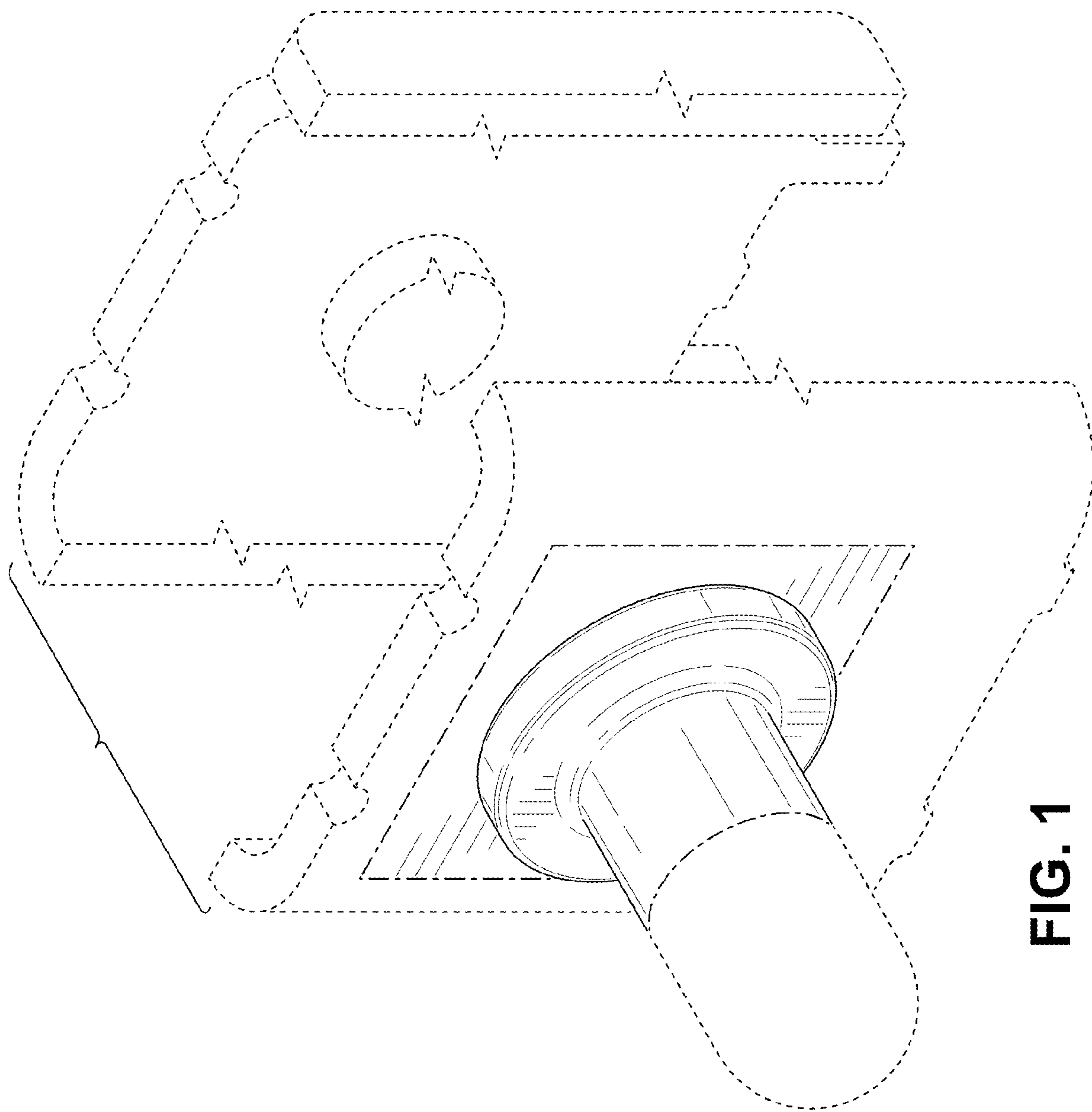

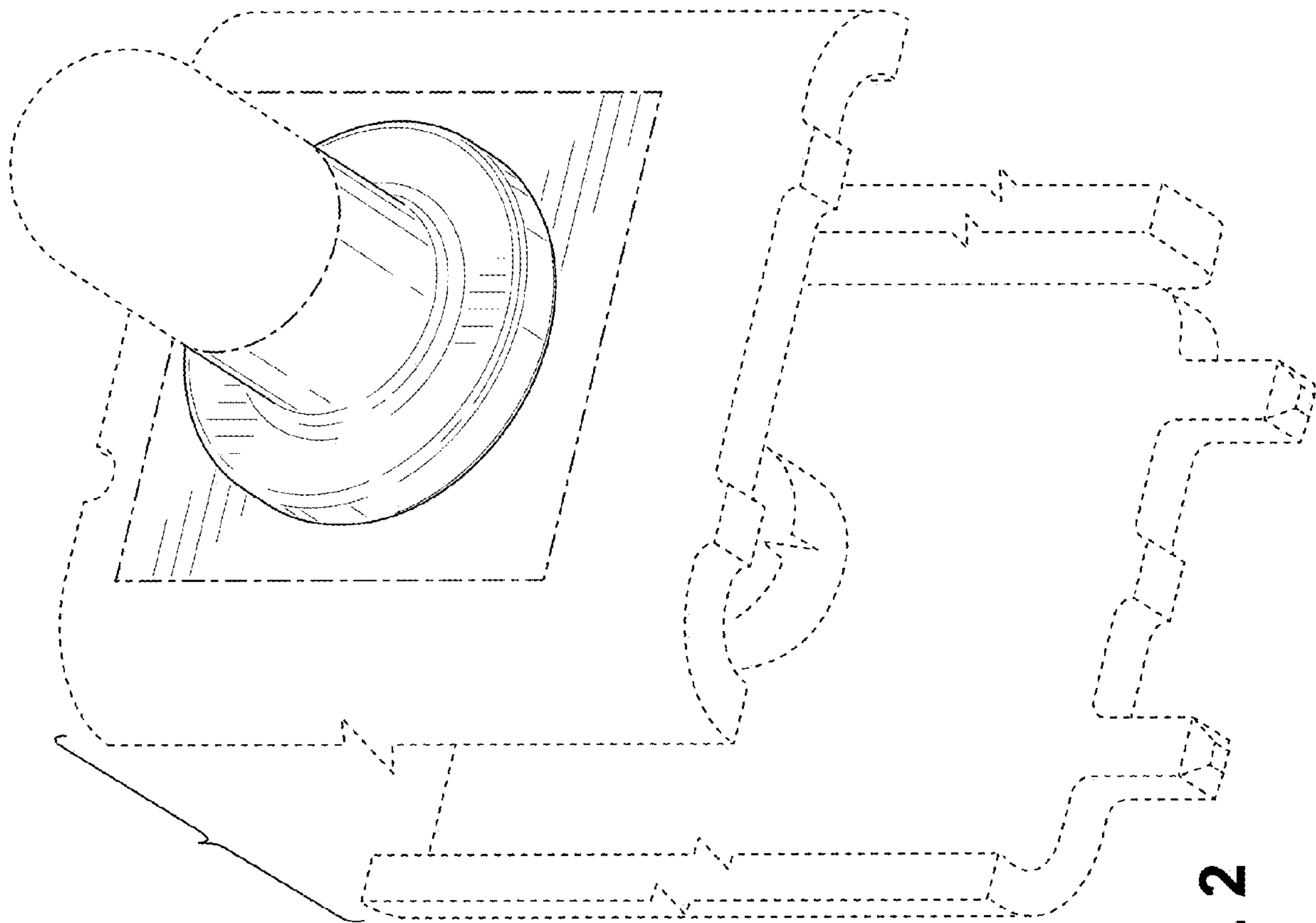

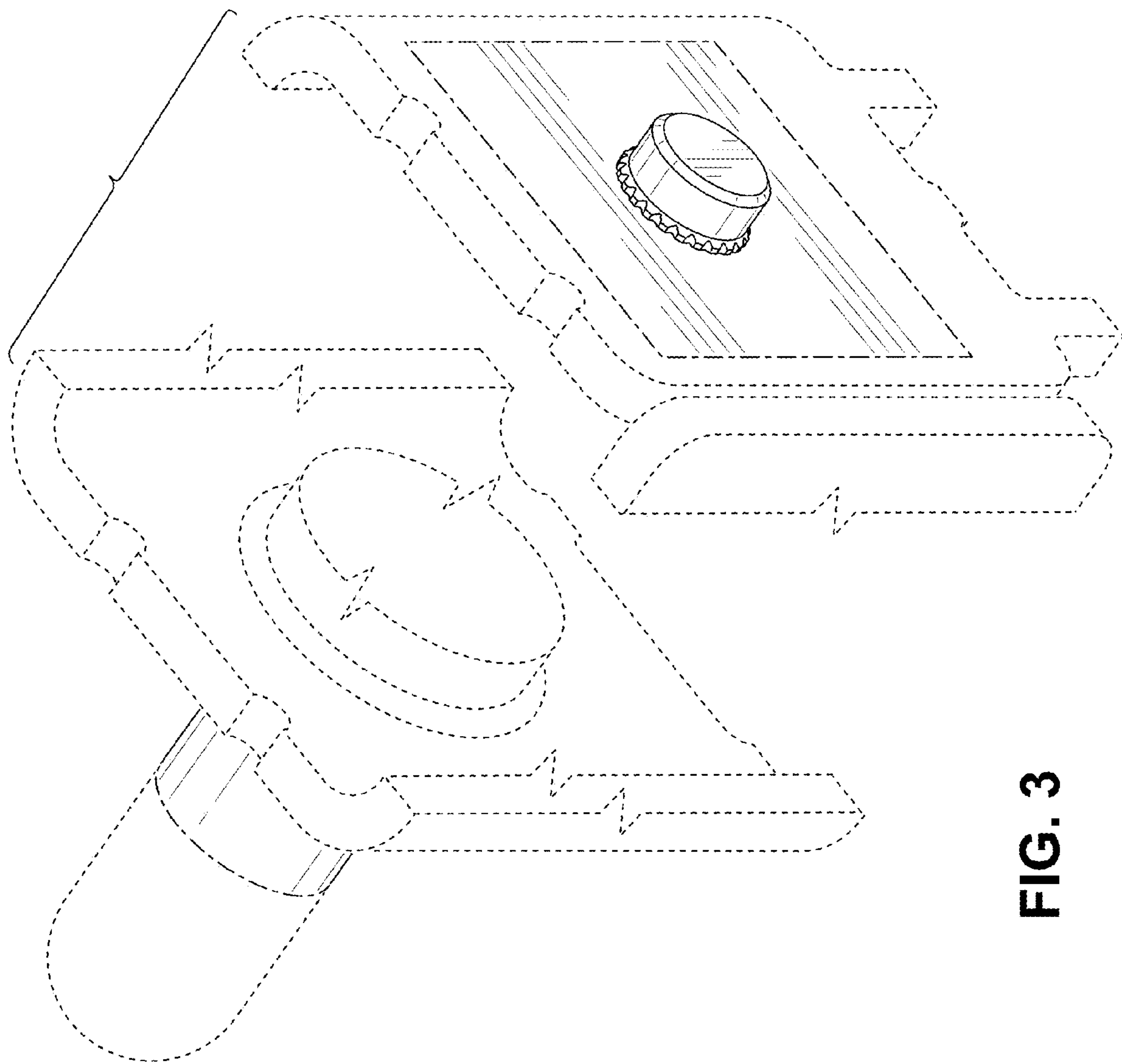

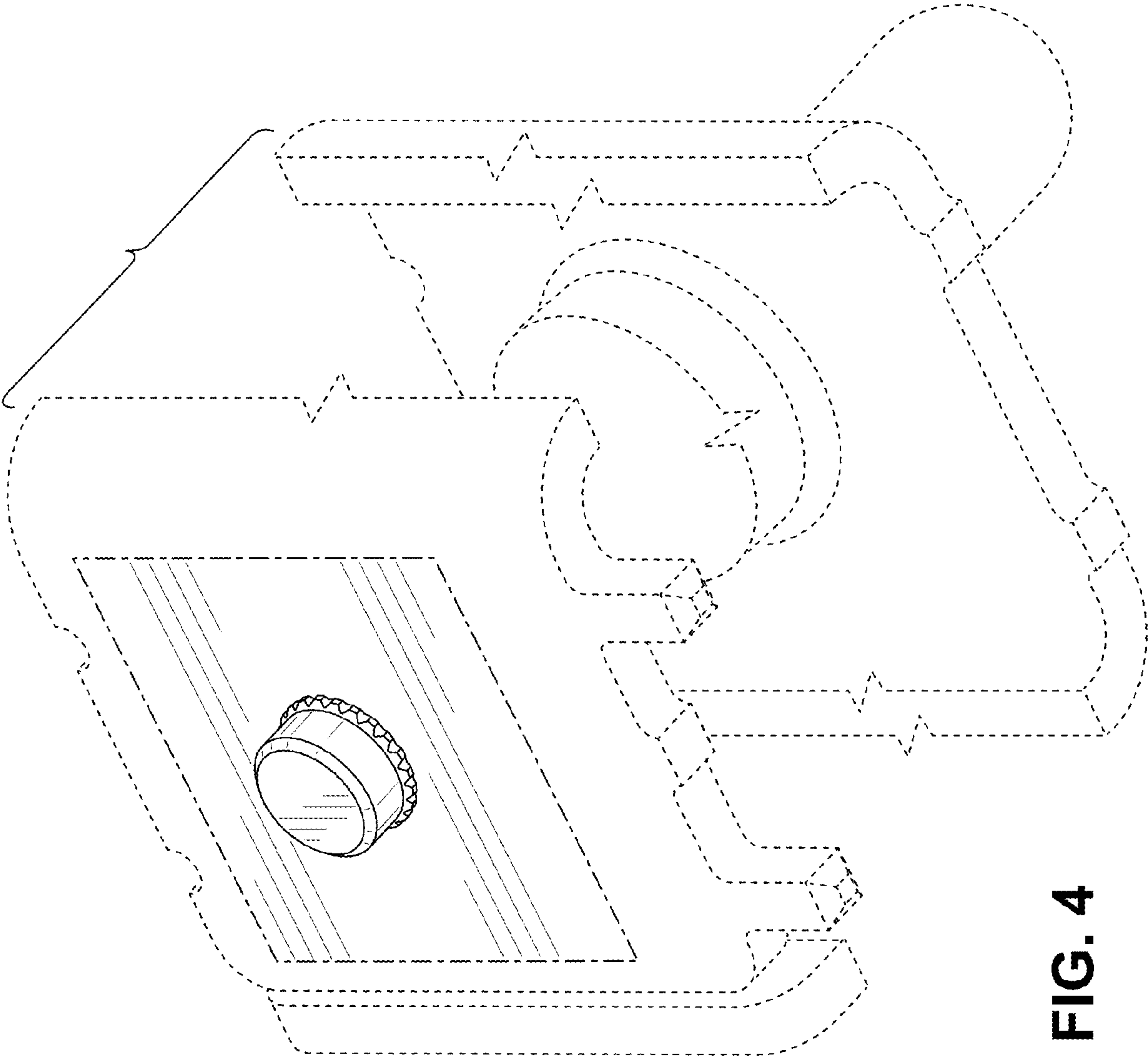

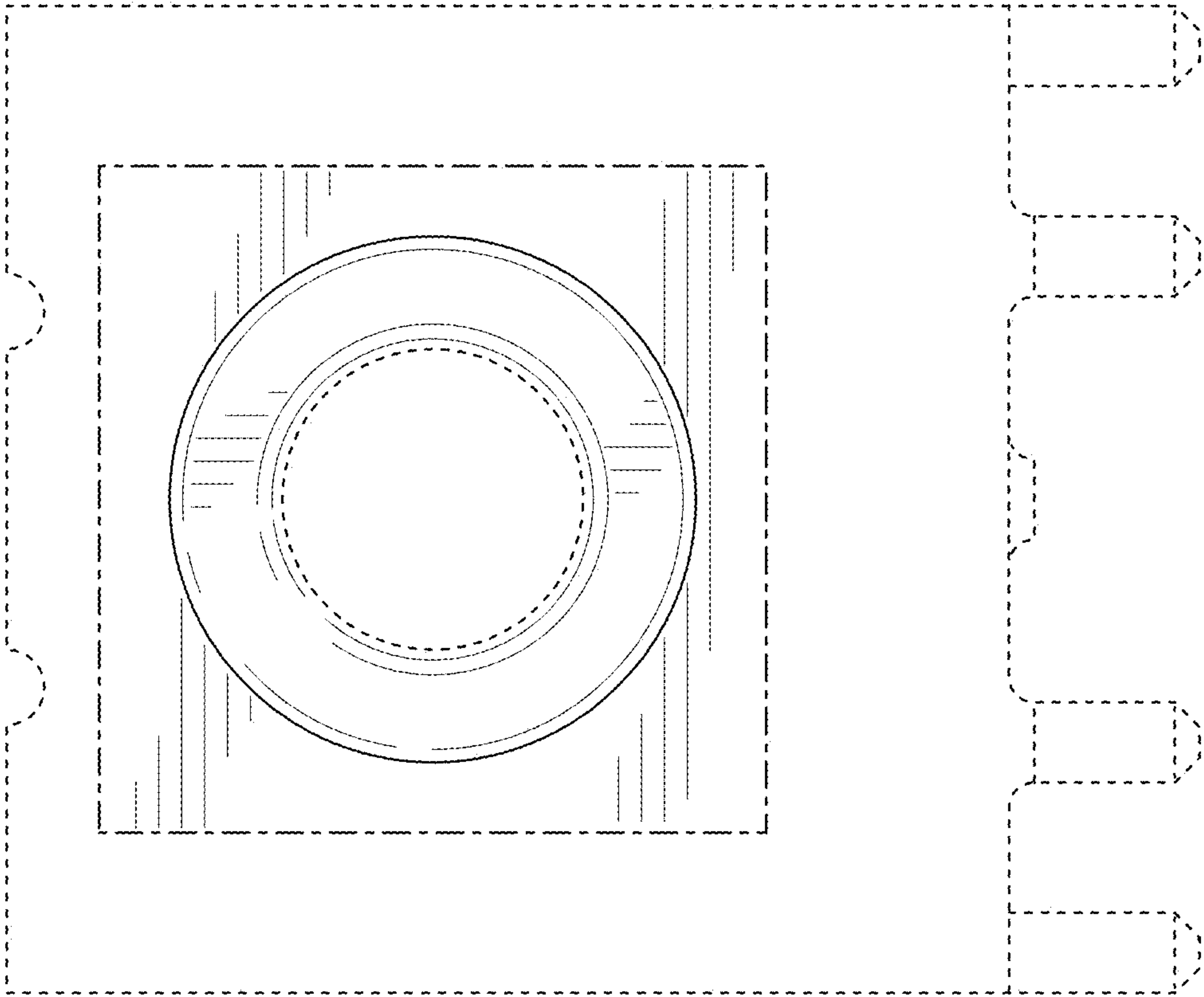

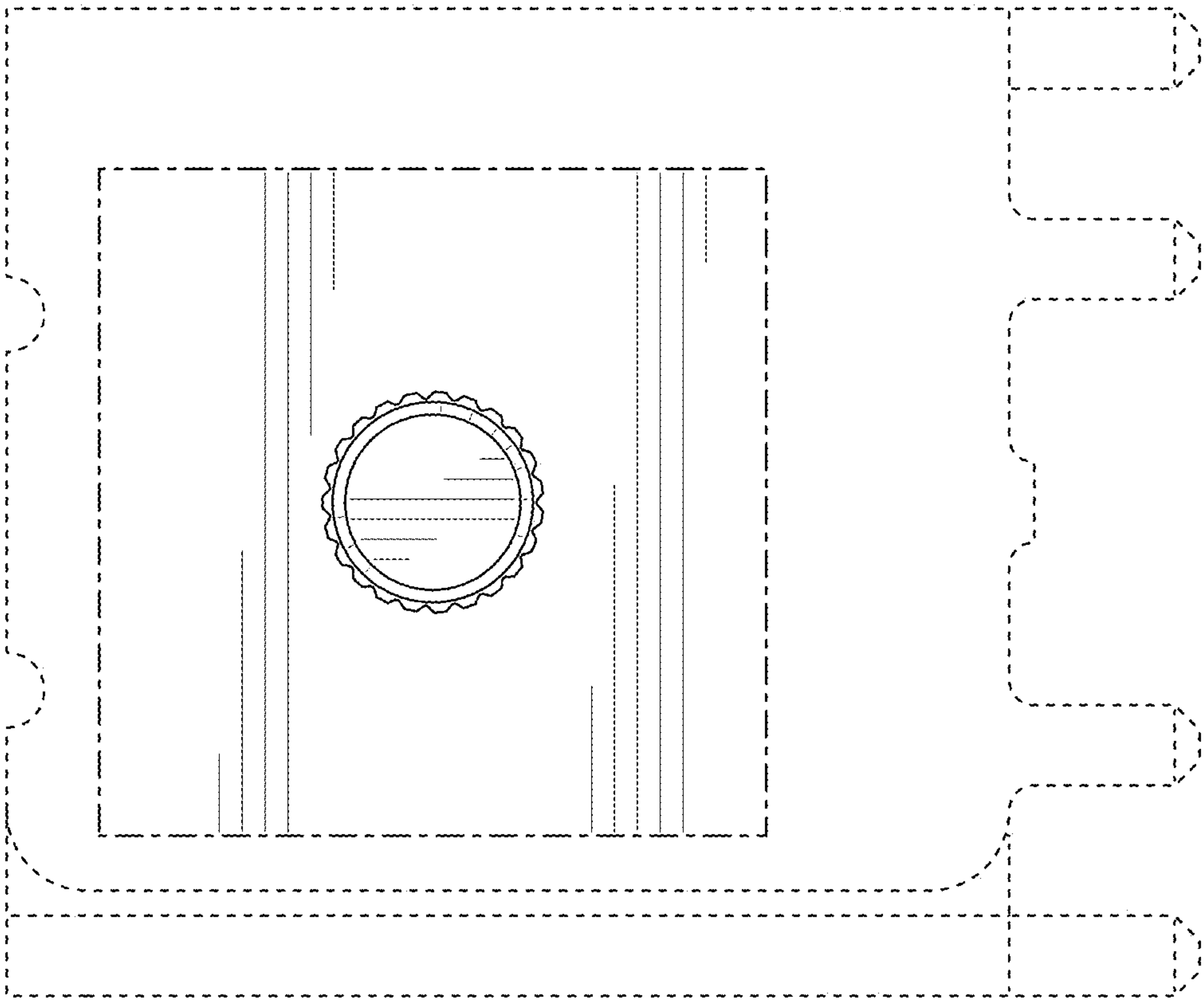

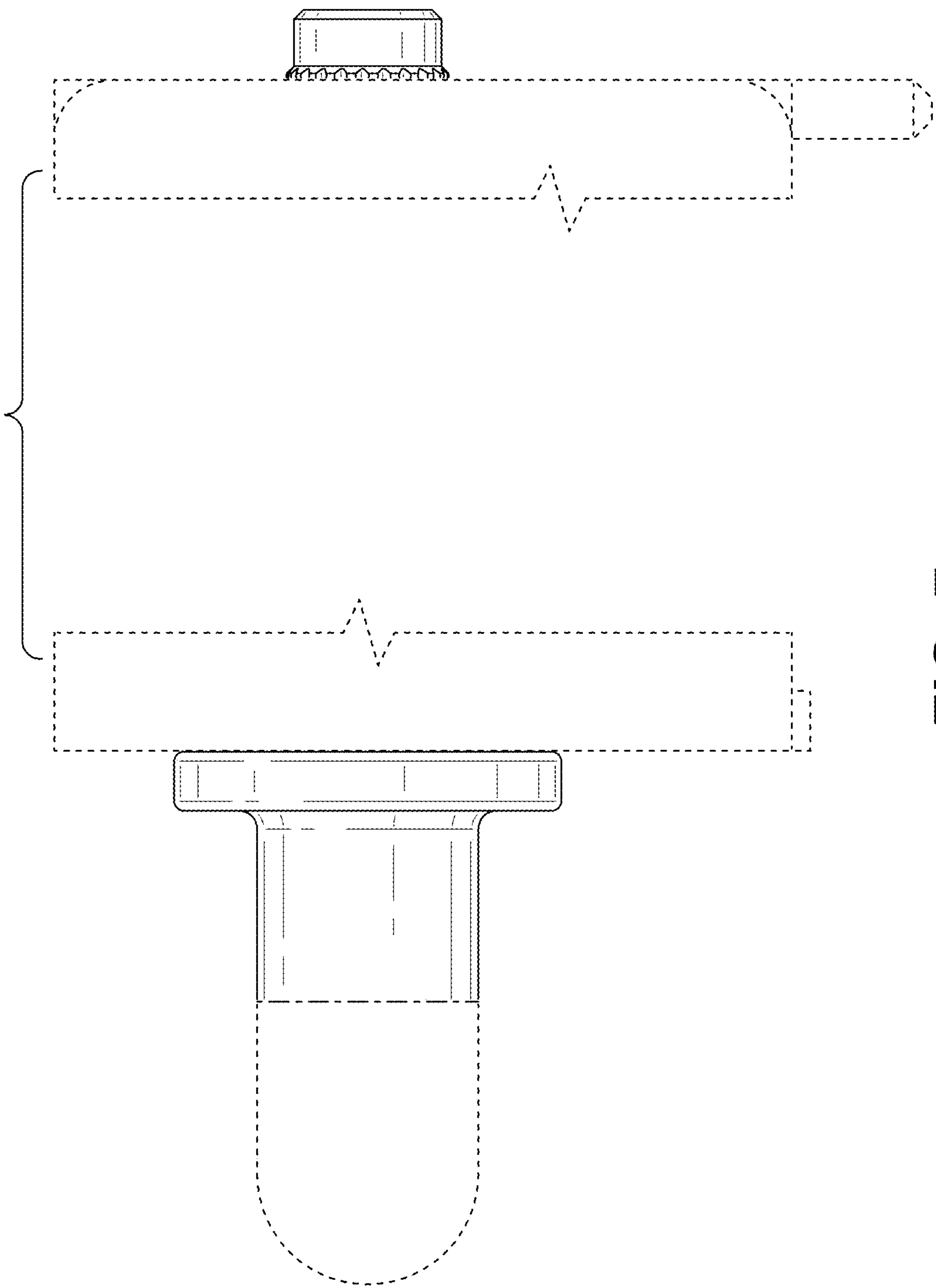

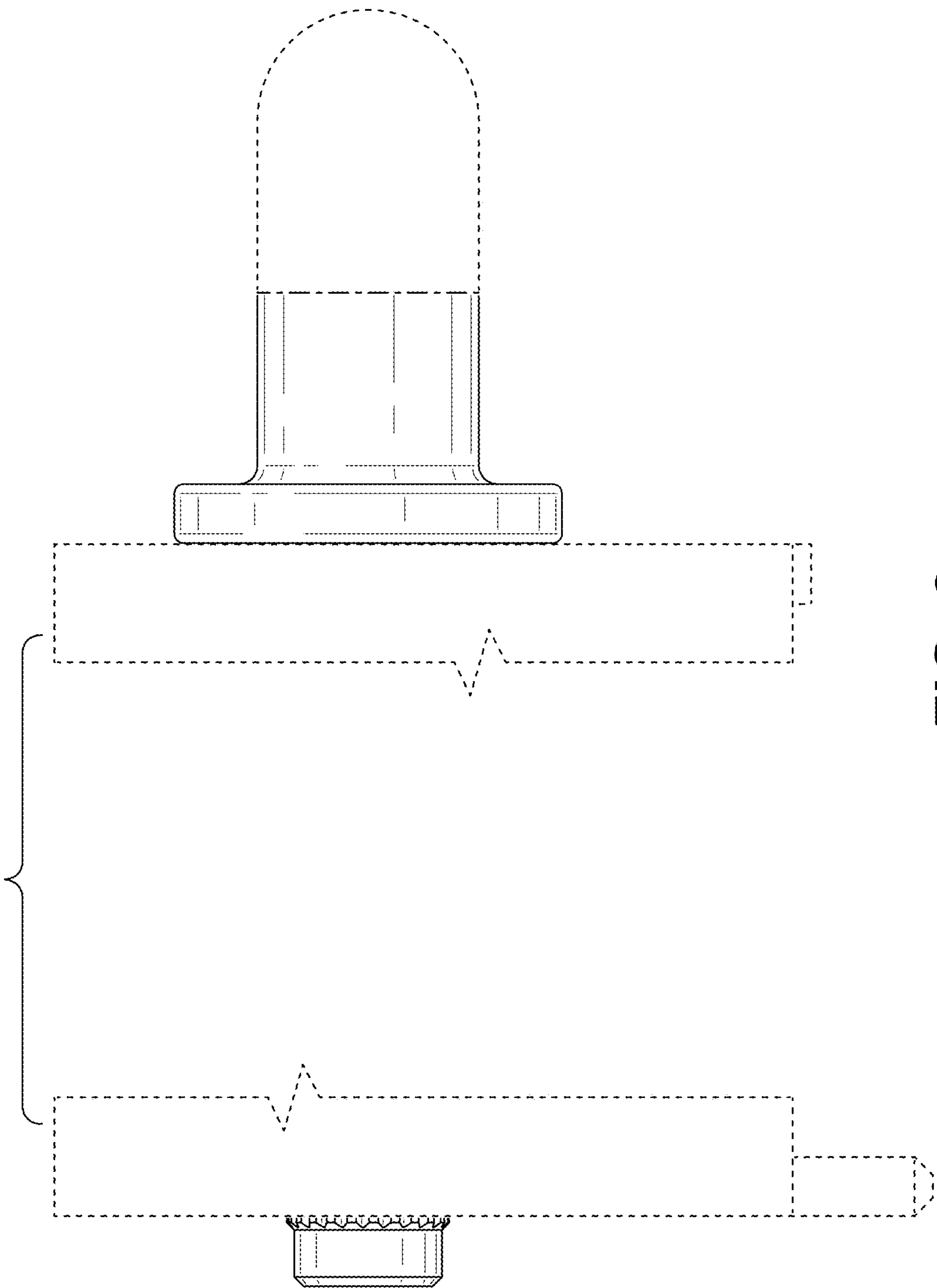

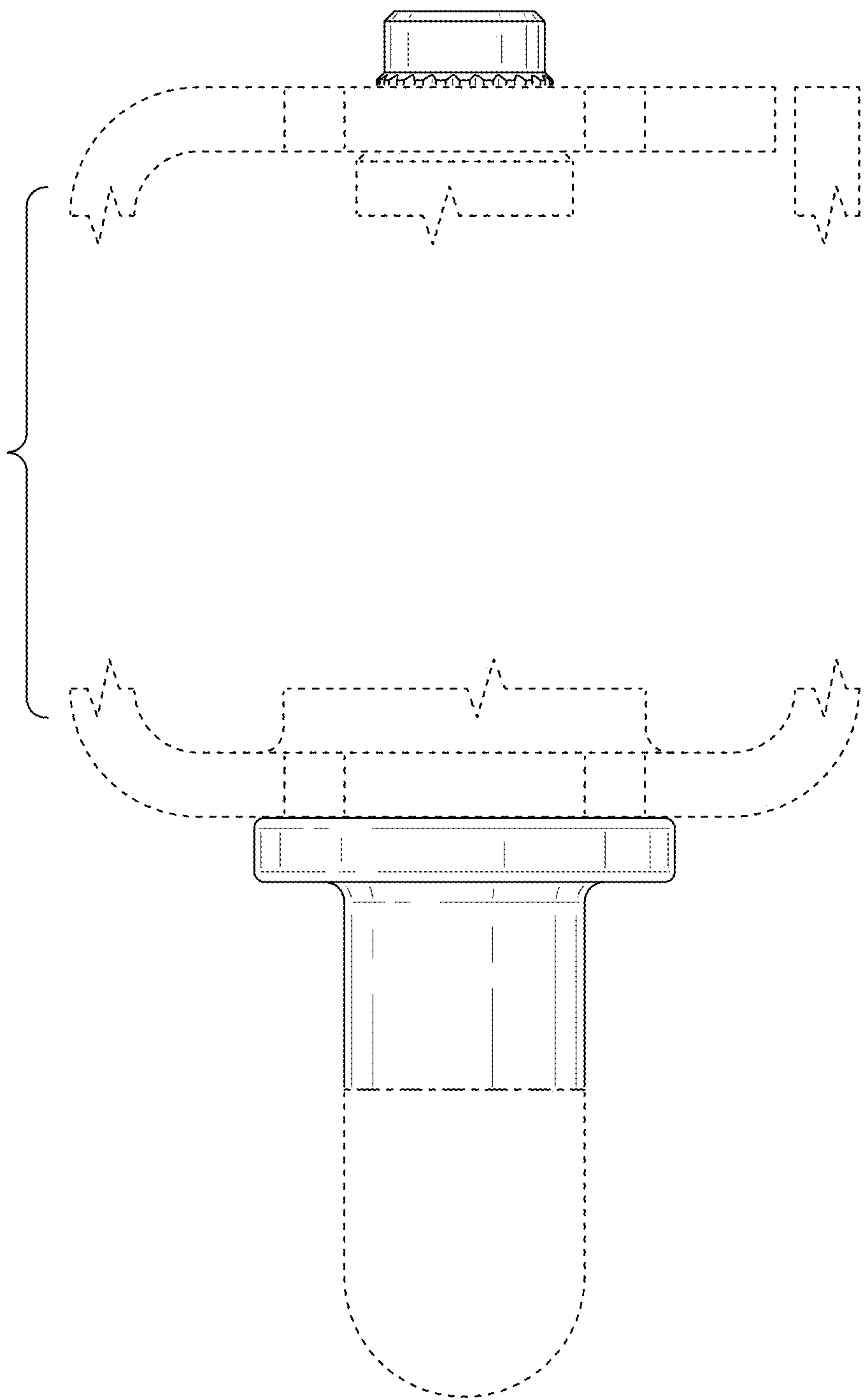

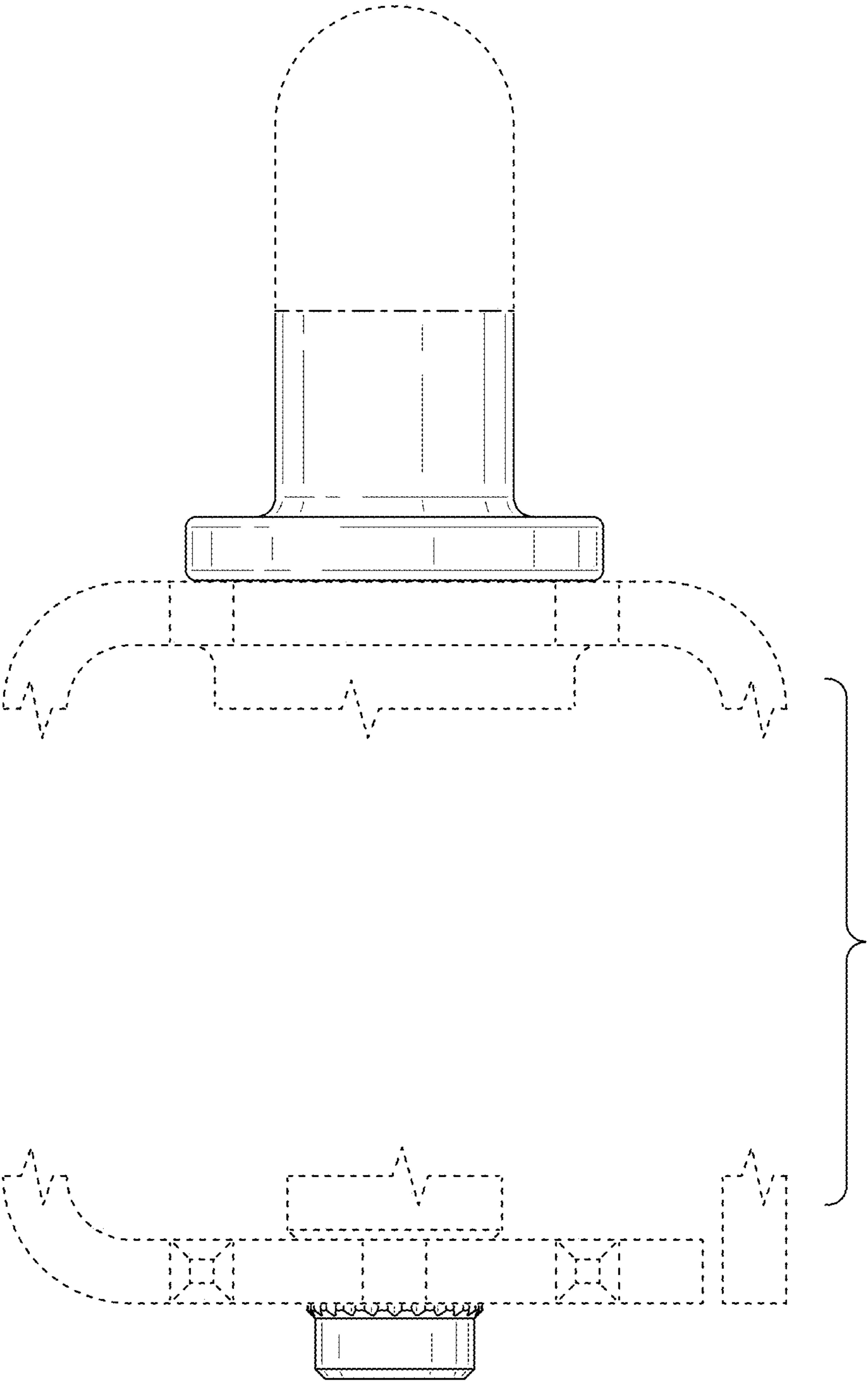
