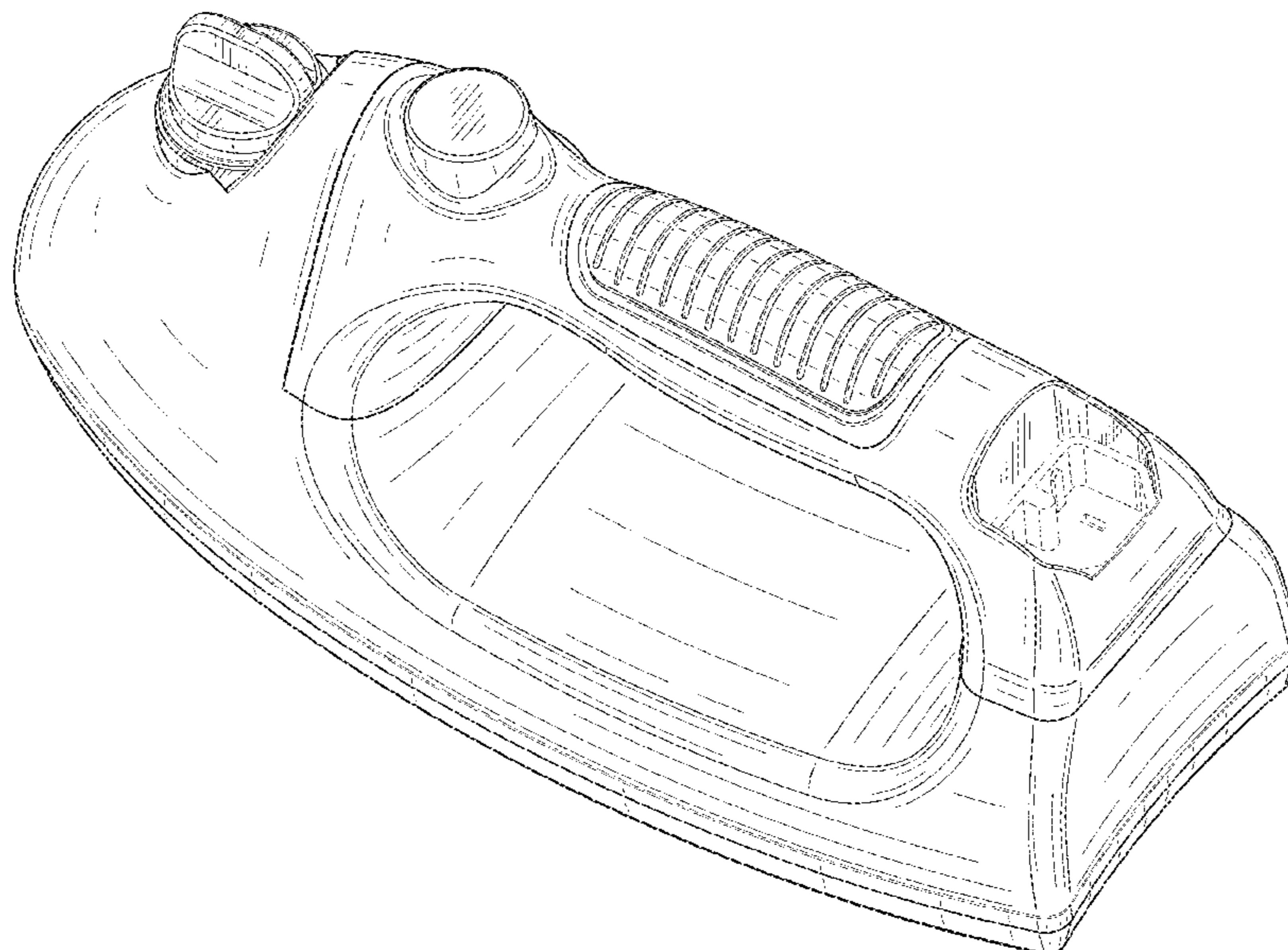
(57) **CLAIM**

I claim the ornamental design for a steamer, as shown and described.

DESCRIPTION

FIG. 1 is a top rear left perspective view of a steamer. FIG. 2 is a bottom front right perspective view thereof. FIG. 3 is a top view thereof. FIG. 4 is a bottom view thereof. FIG. 5 is a left view thereof. FIG. 6 is a right view thereof. FIG. 7 is a rear view thereof; and, FIG. 8 is a front view thereof. The broken lines, where shown, represent portions of the steamer that form no part of the claimed design.

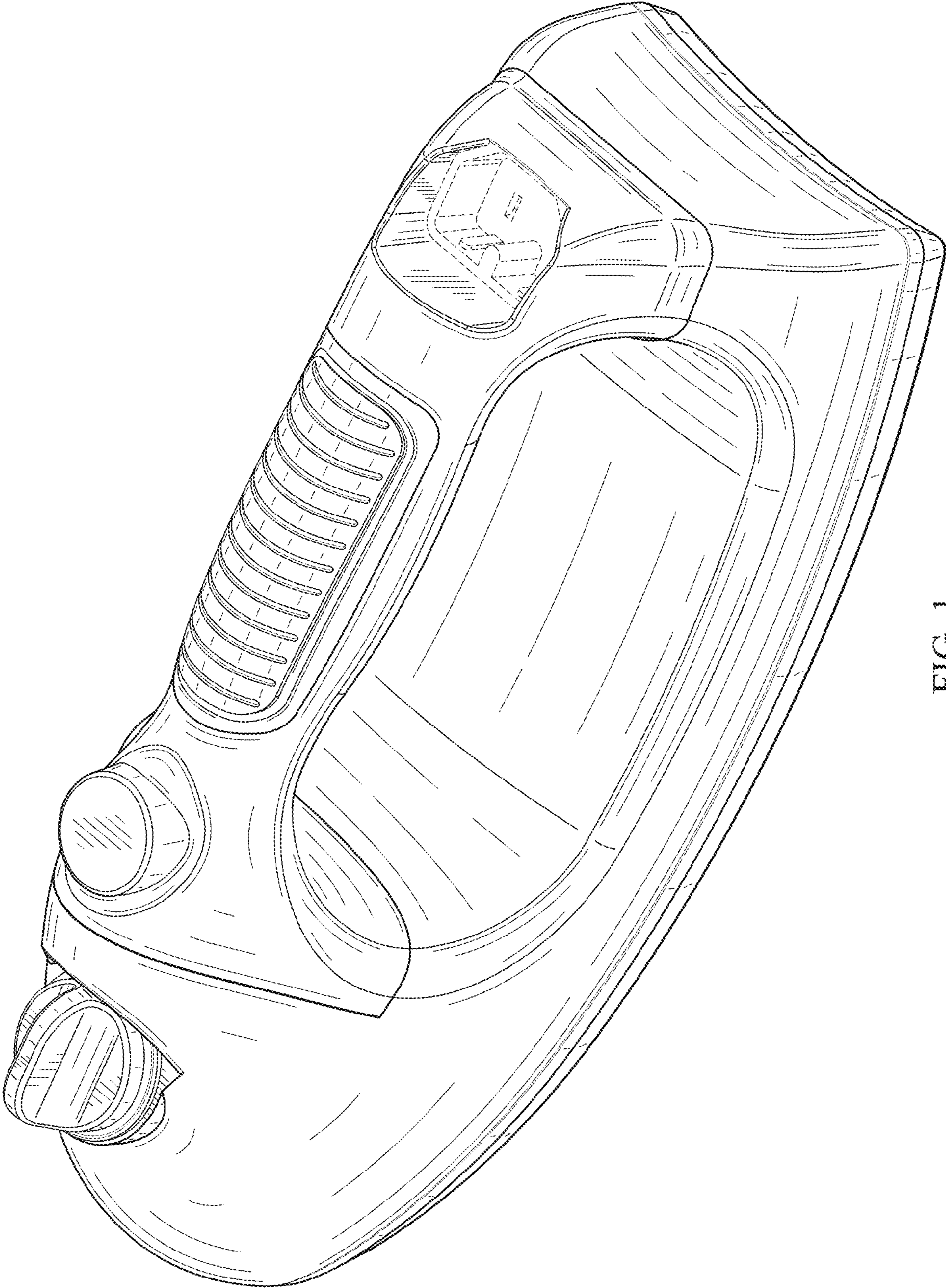

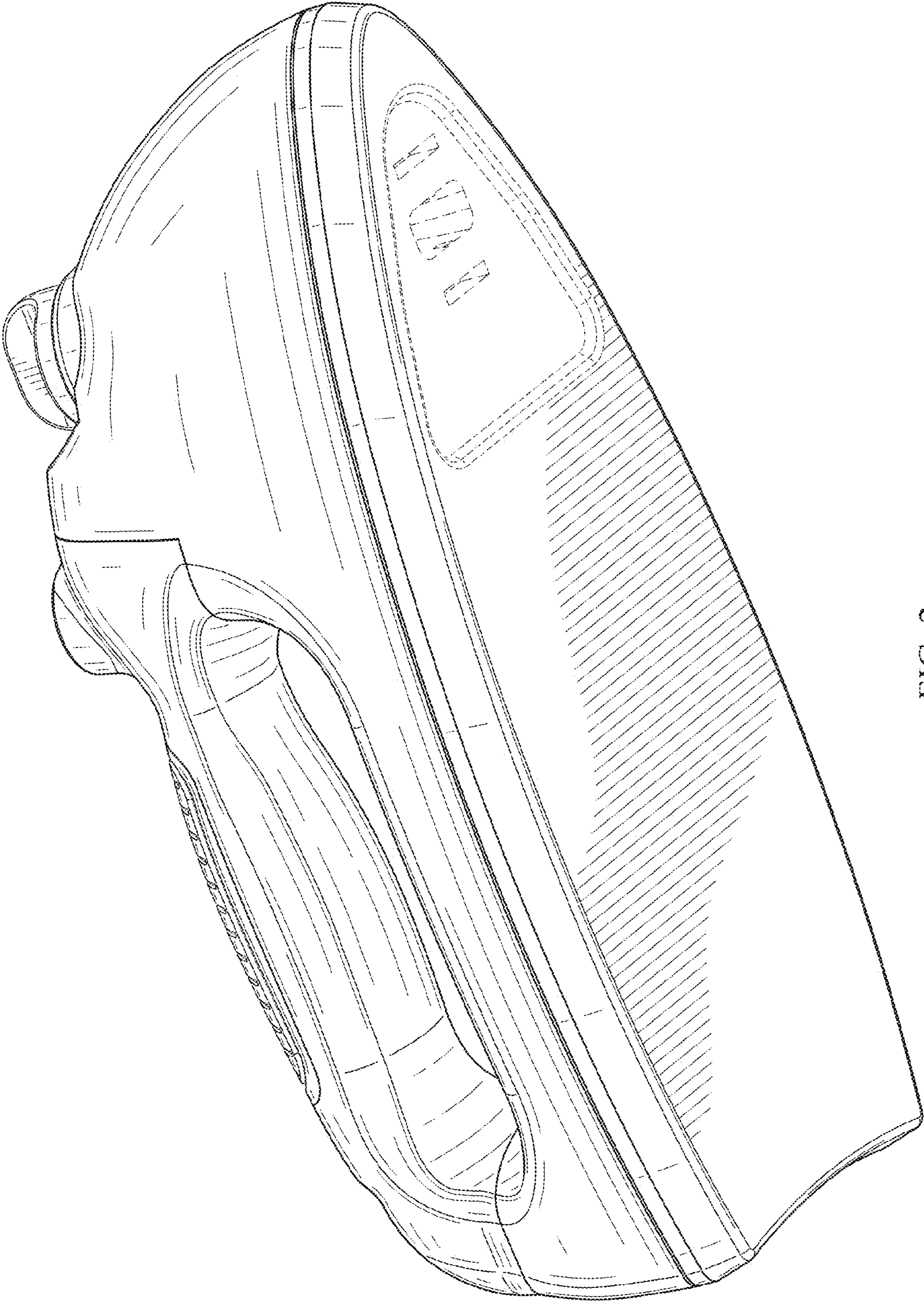

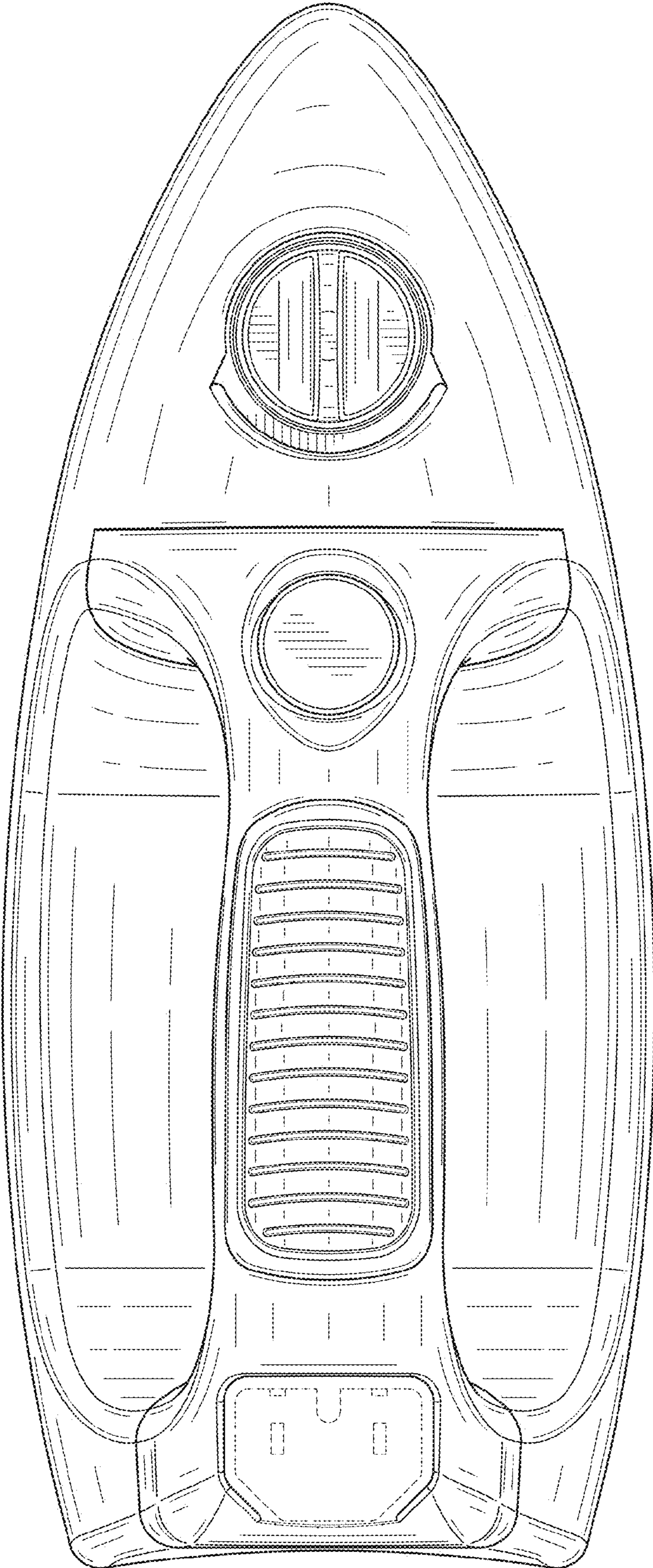

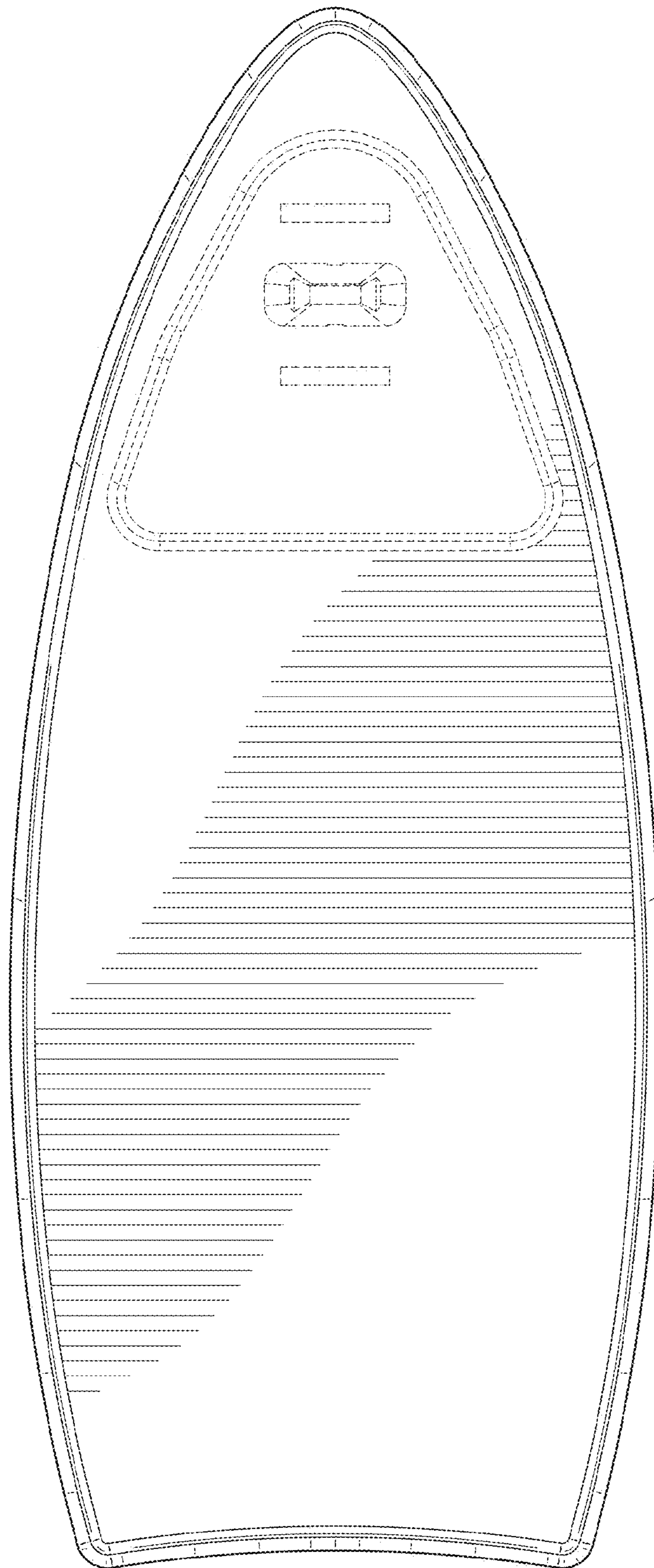

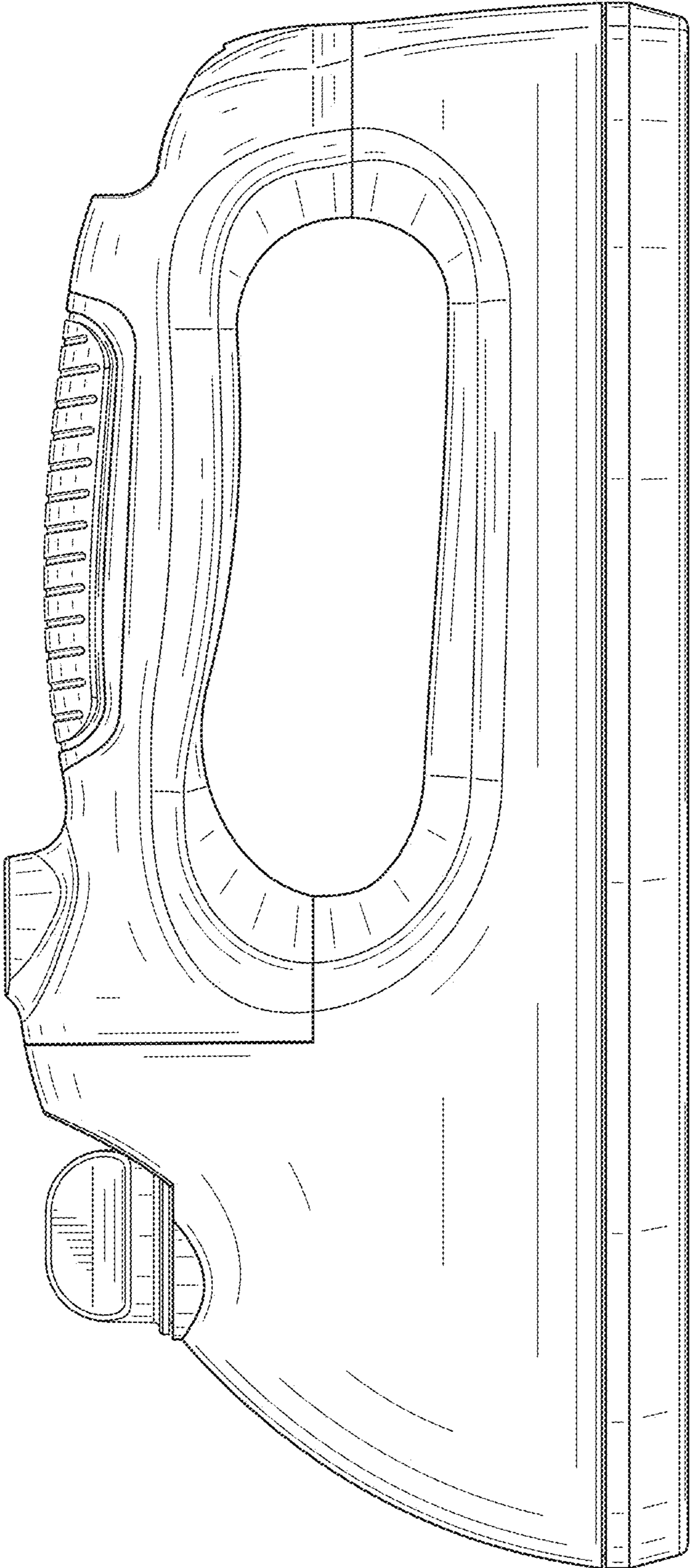

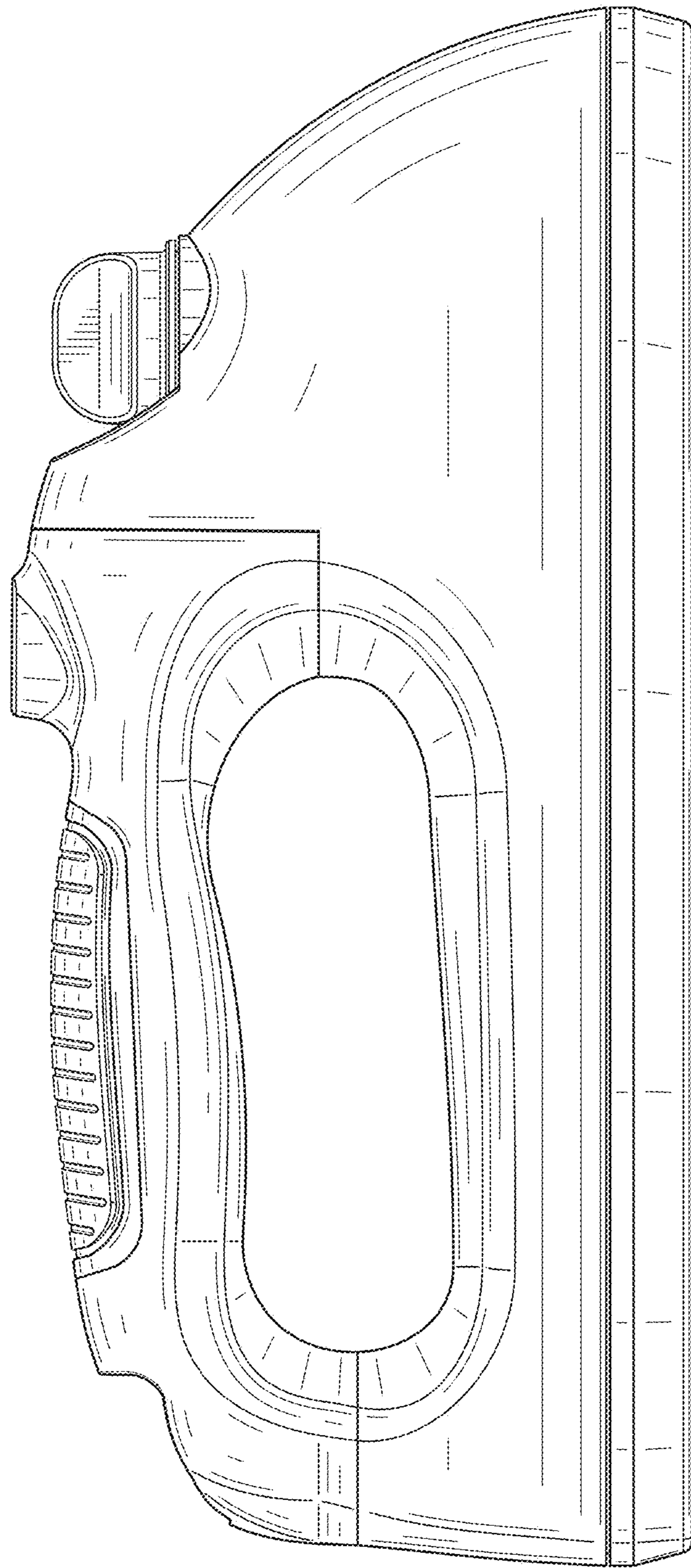

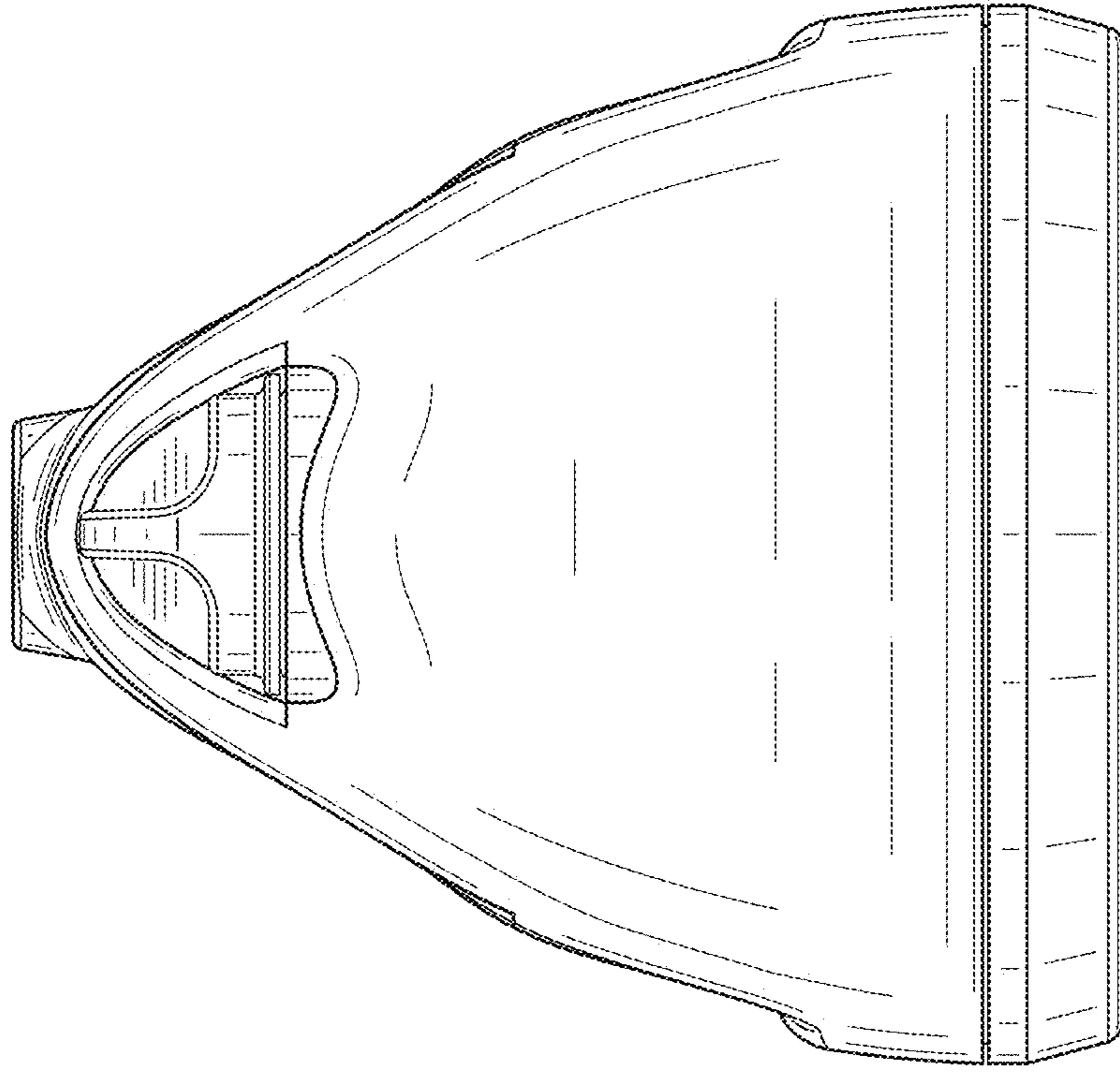

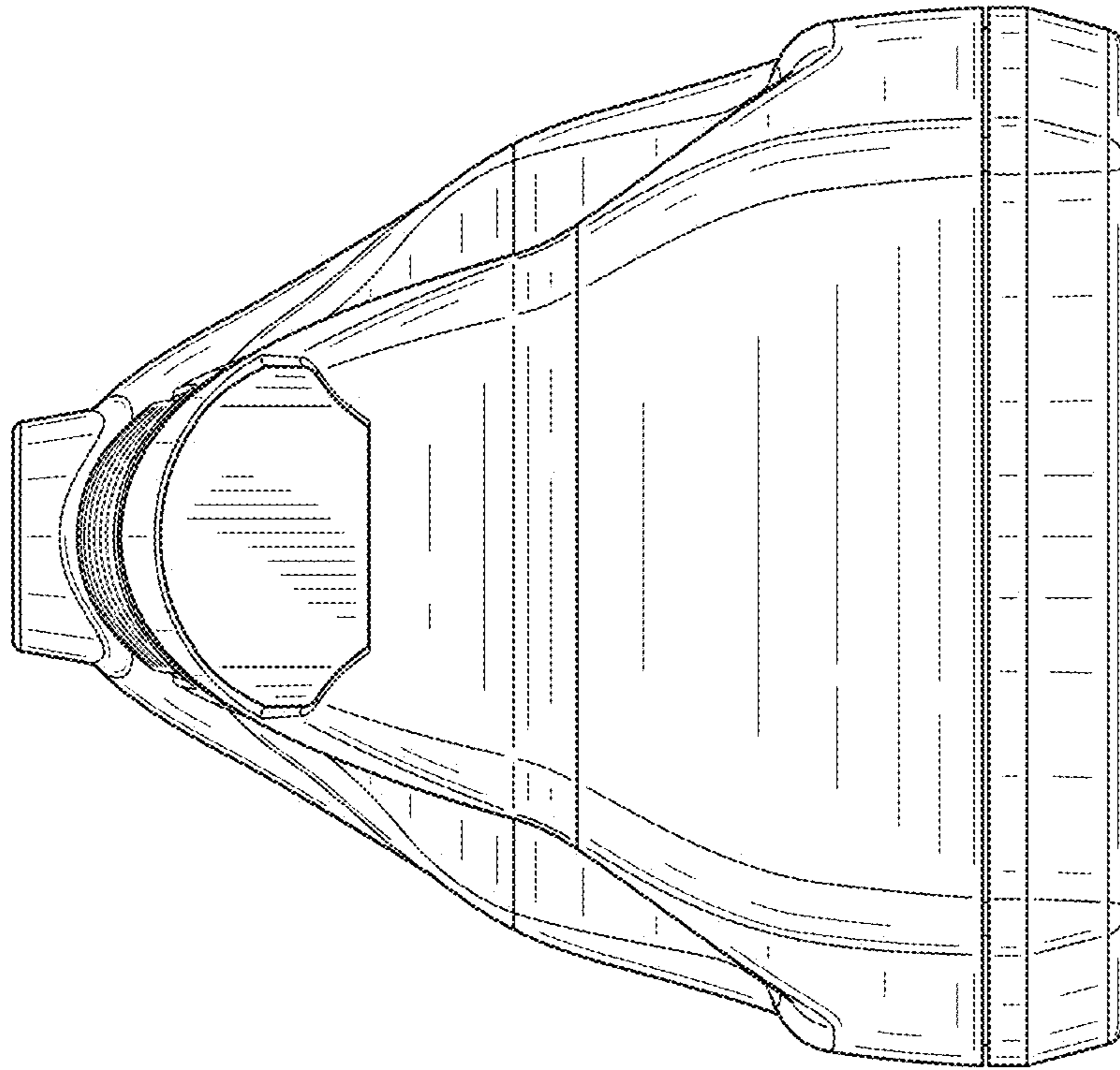
