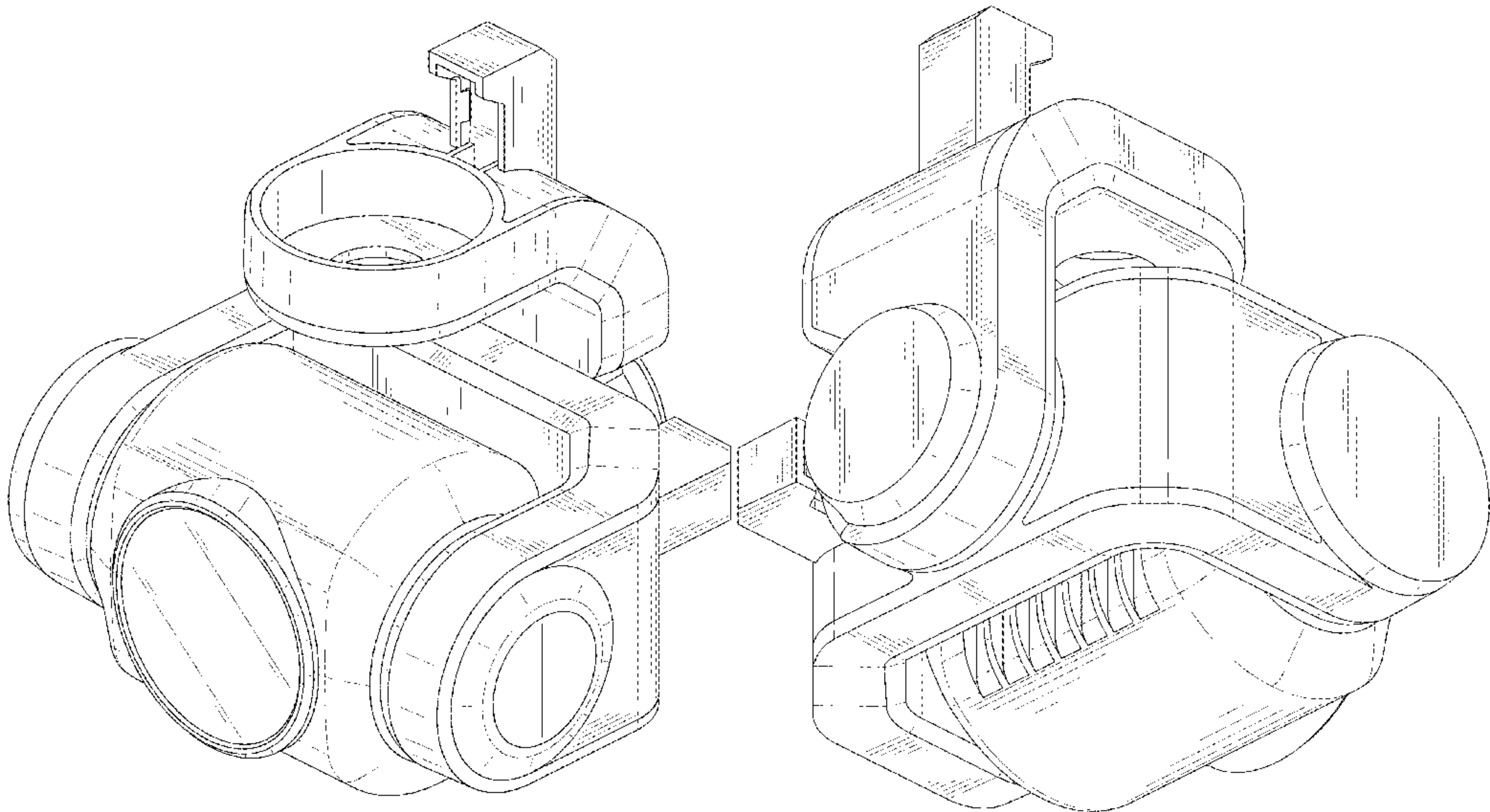
(57) CLAIM

The ornamental design for a gimbal with camera, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a gimbal with camera showing our new design;
FIG. 2 is a bottom, rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

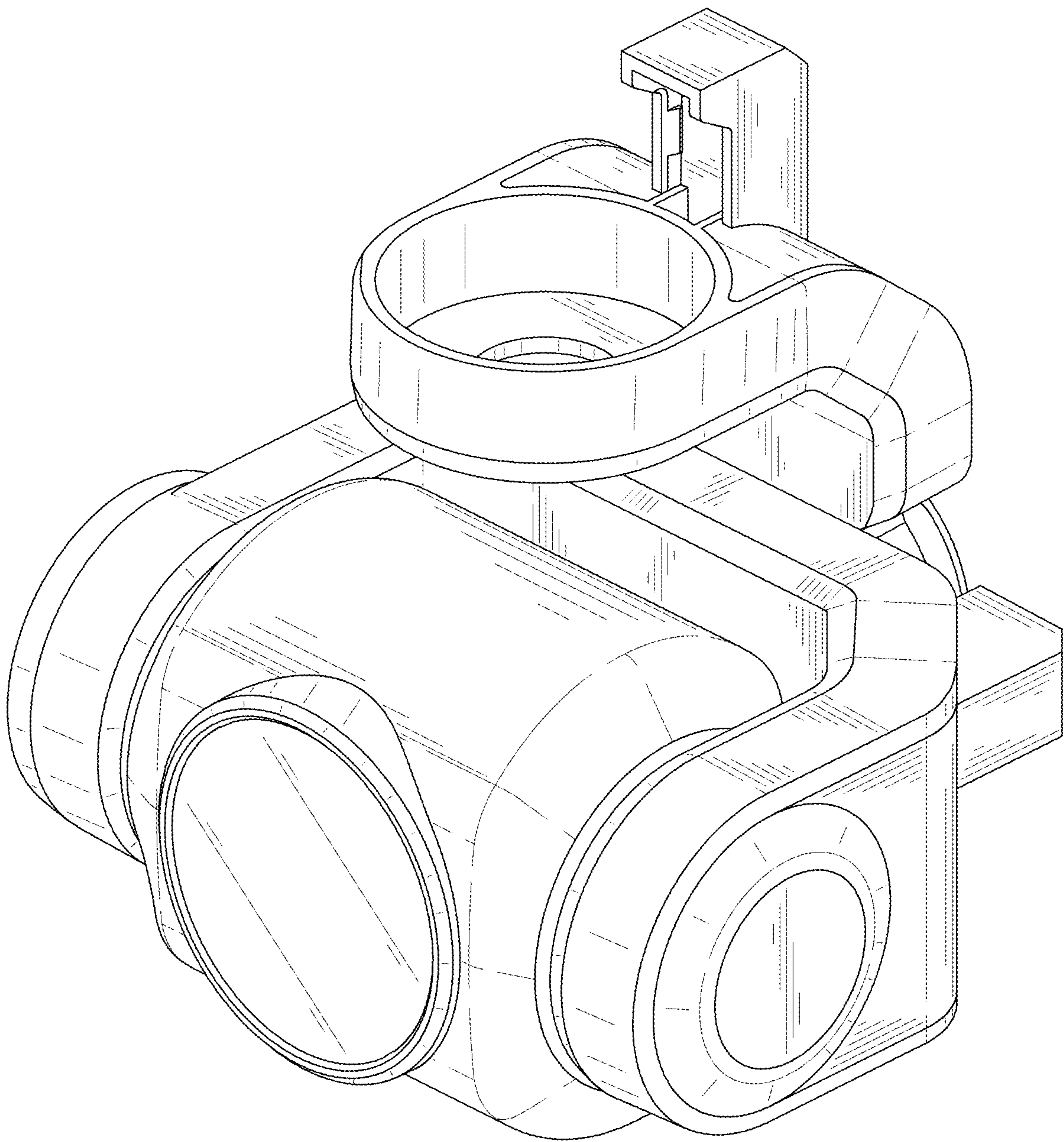

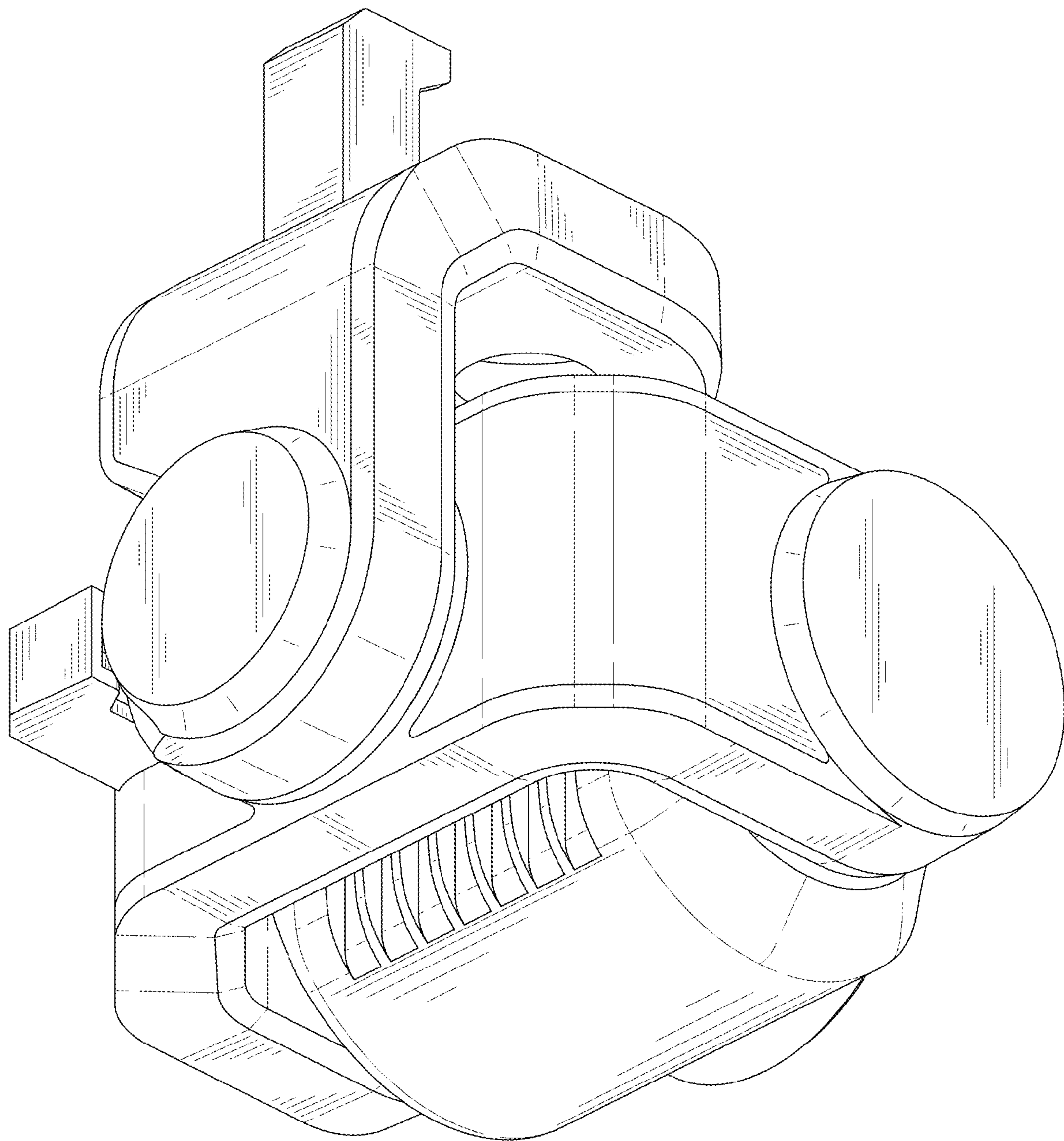

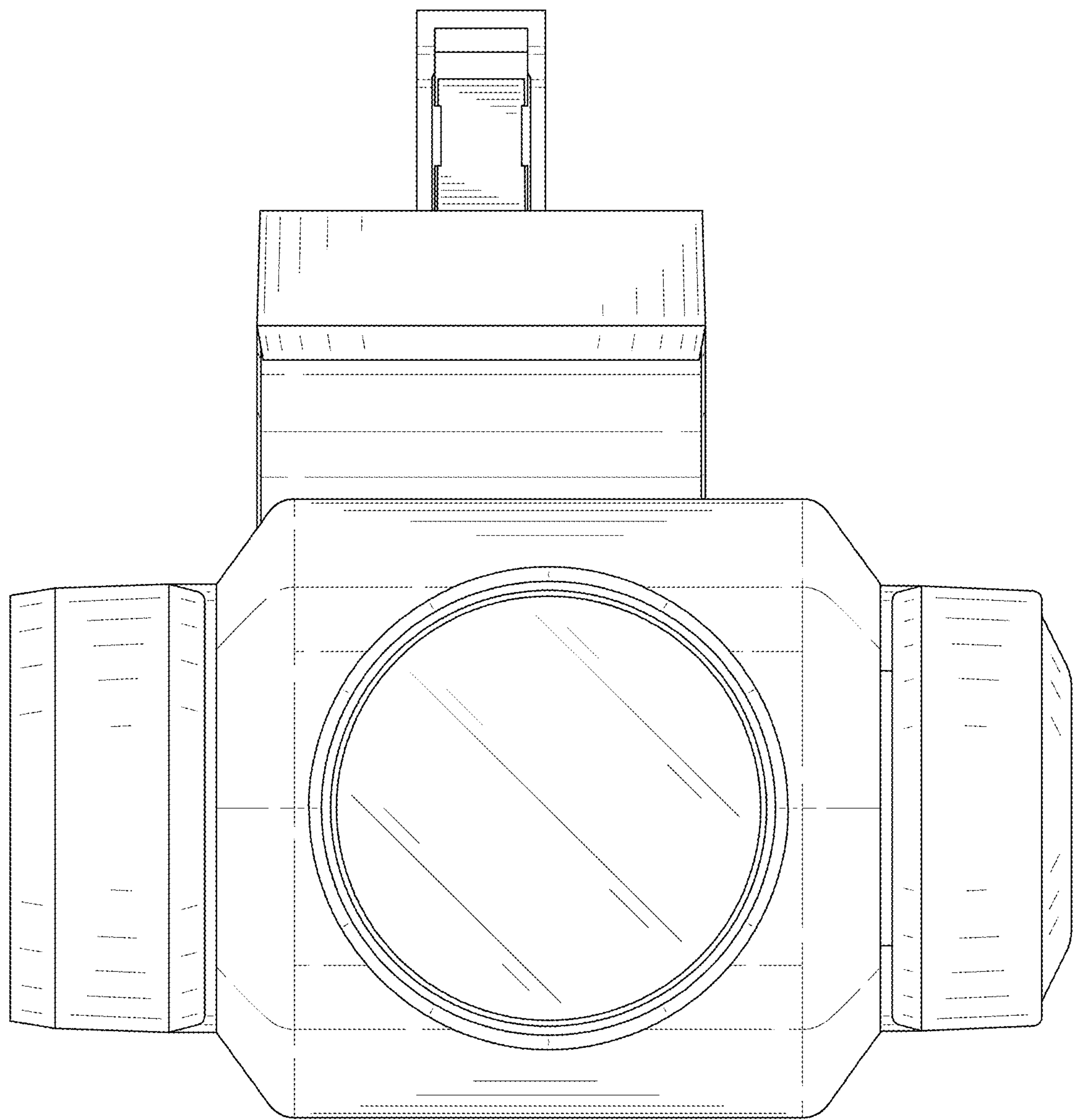

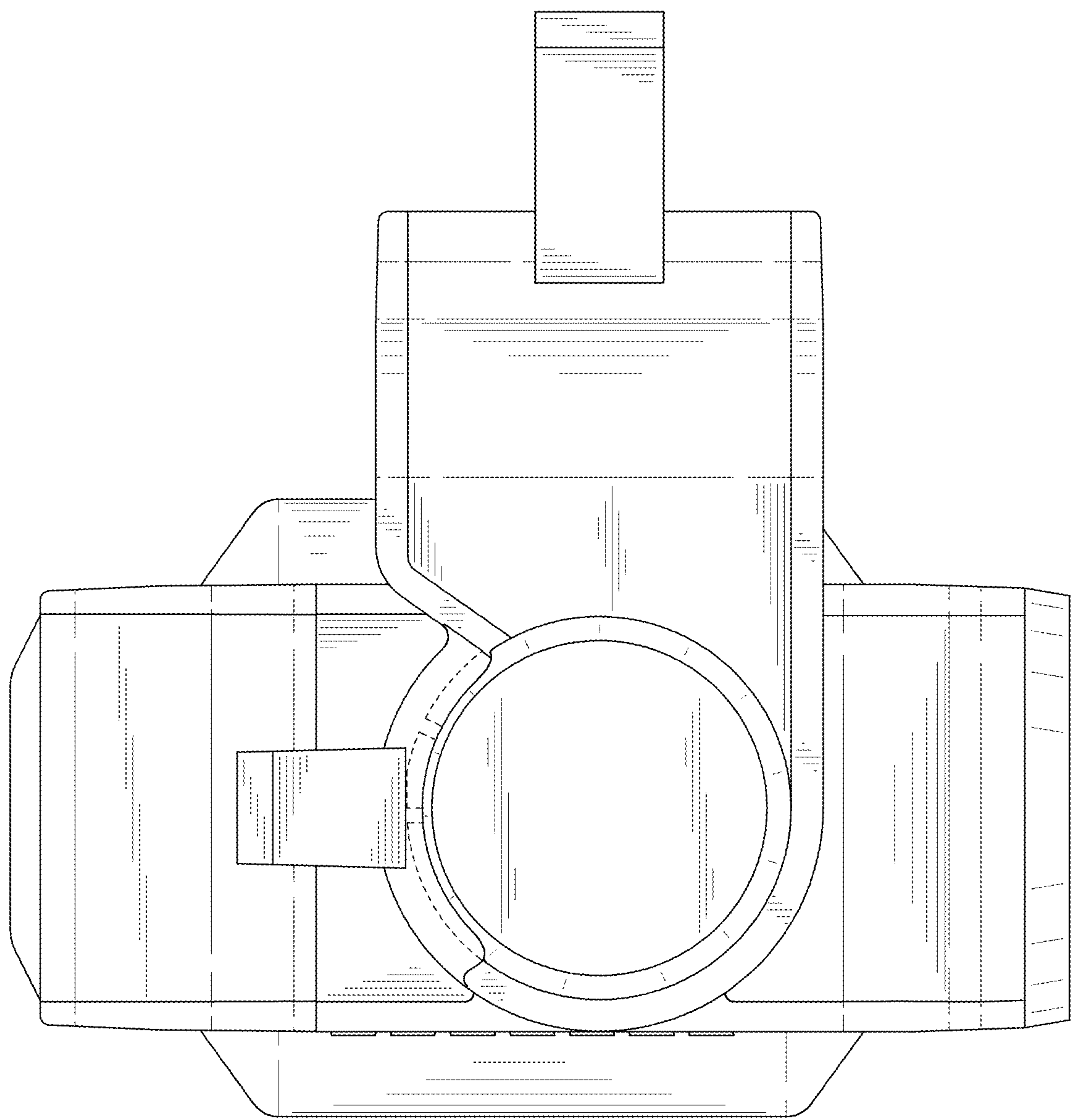

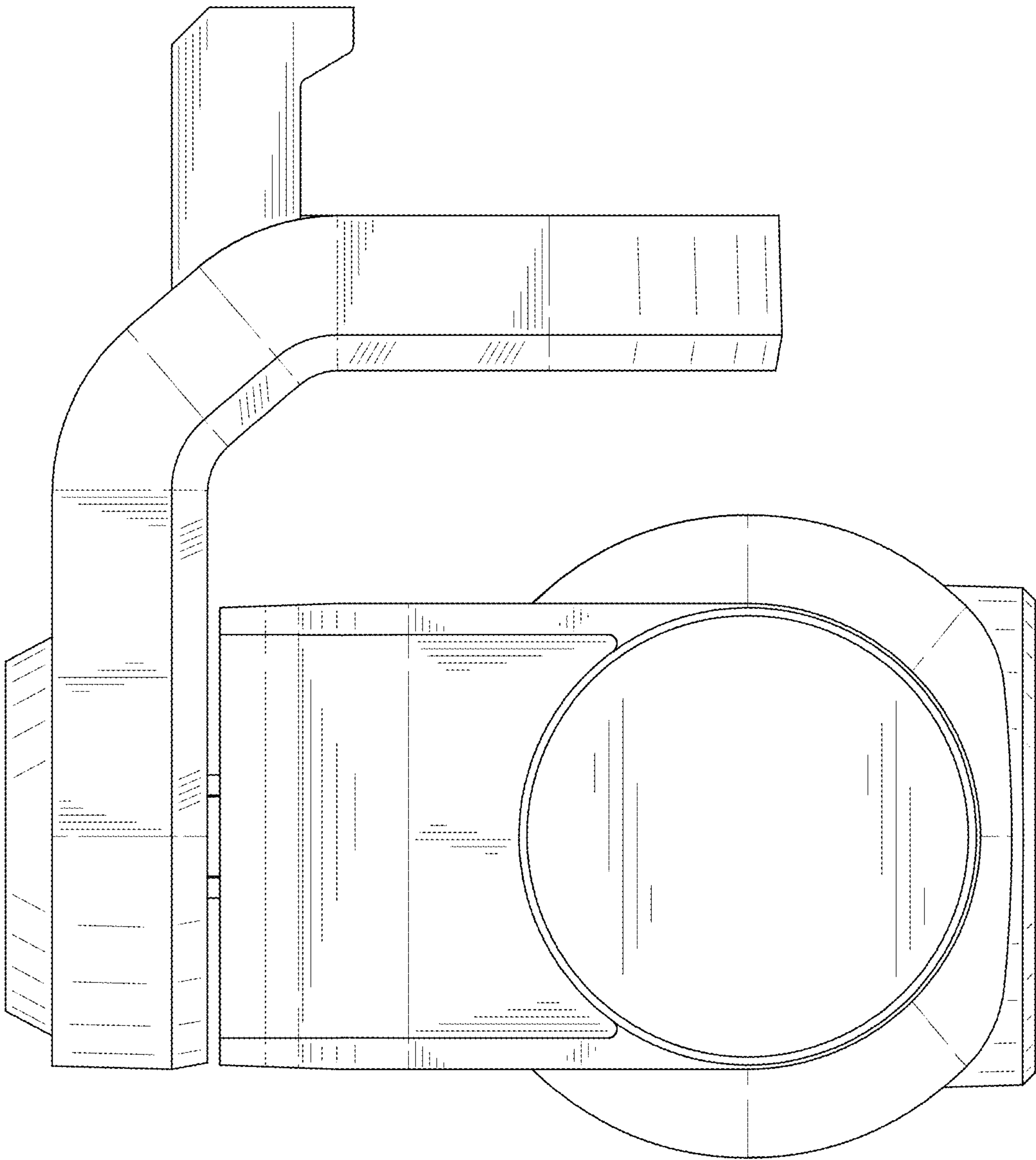

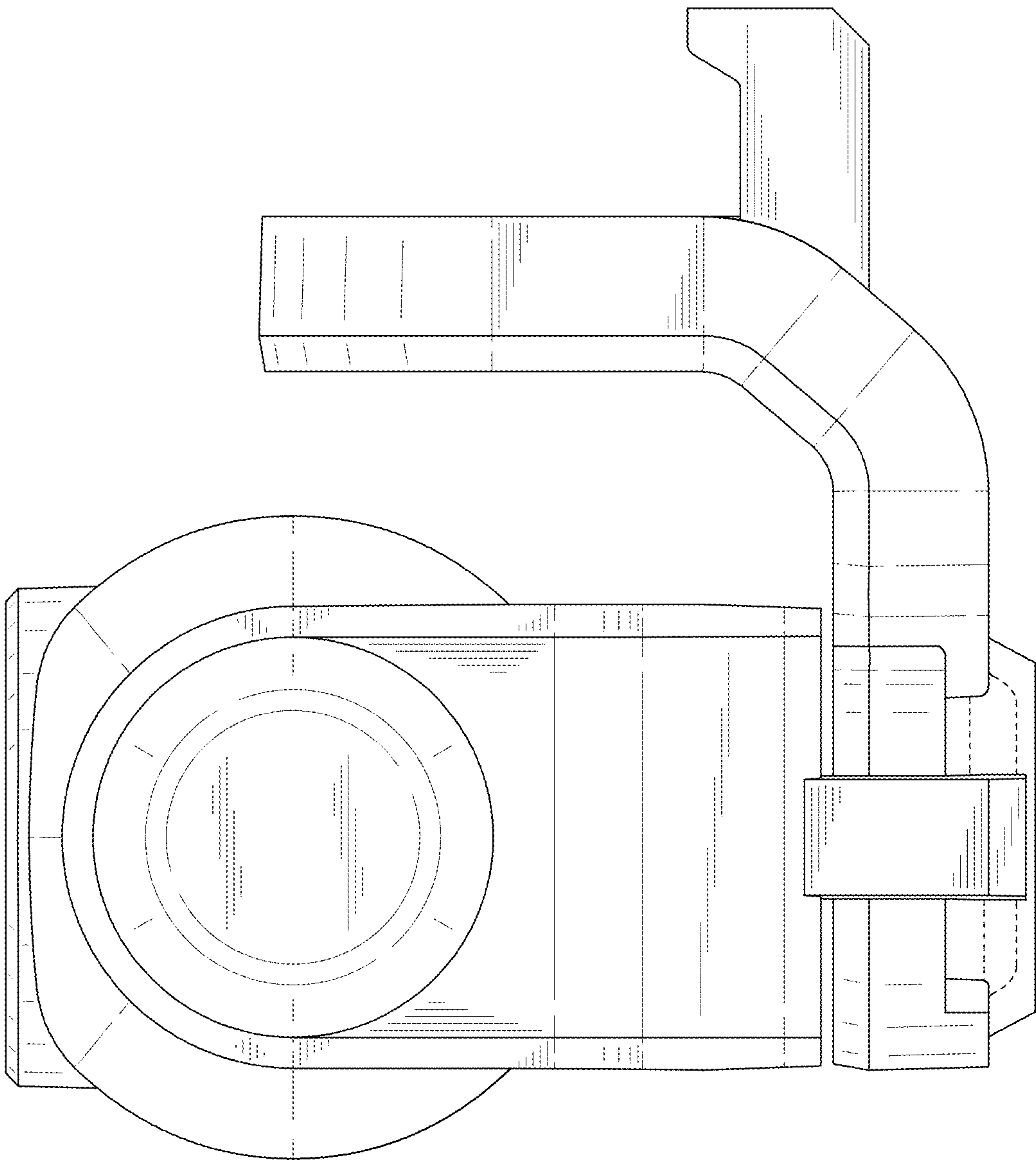

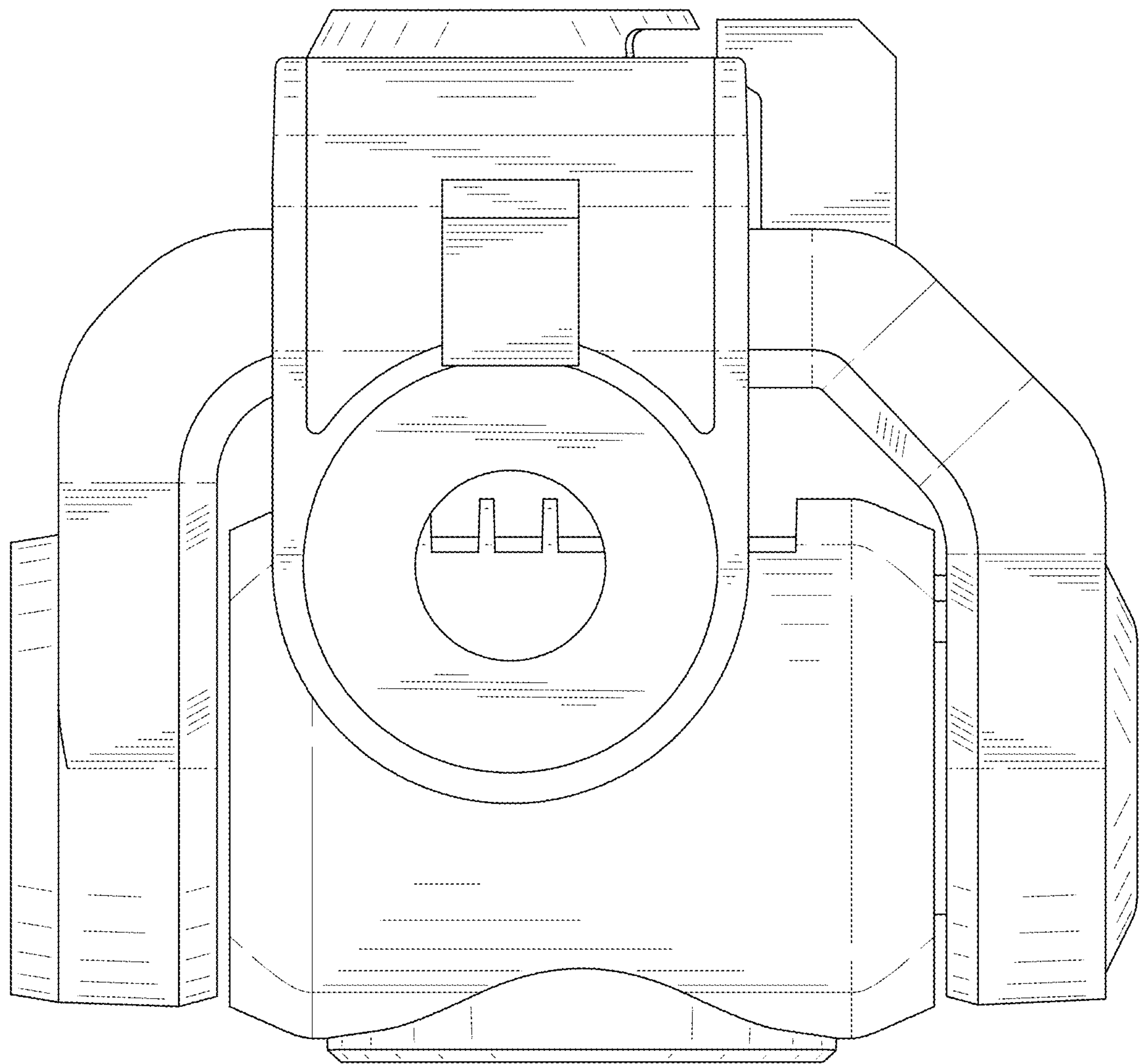

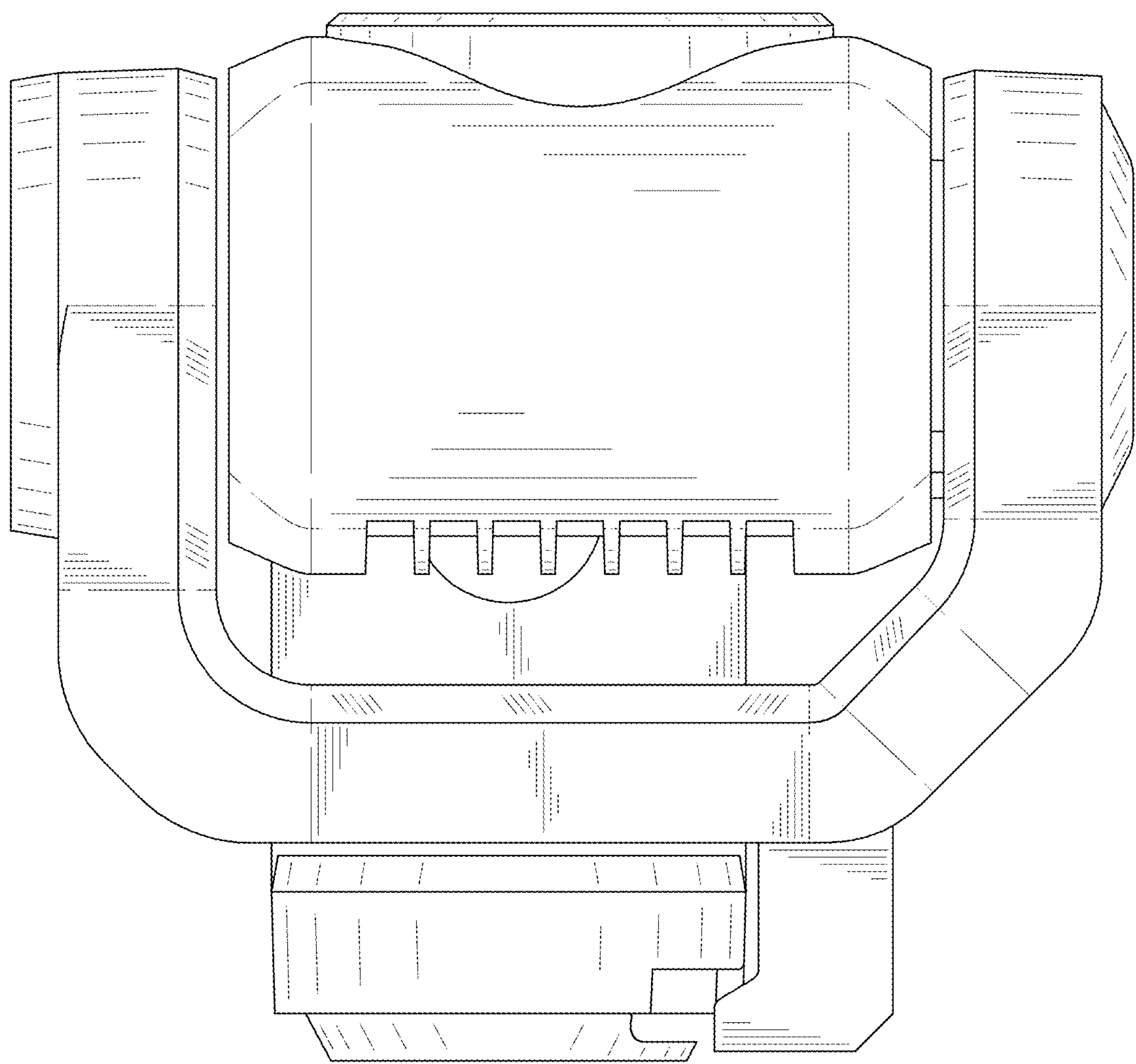
