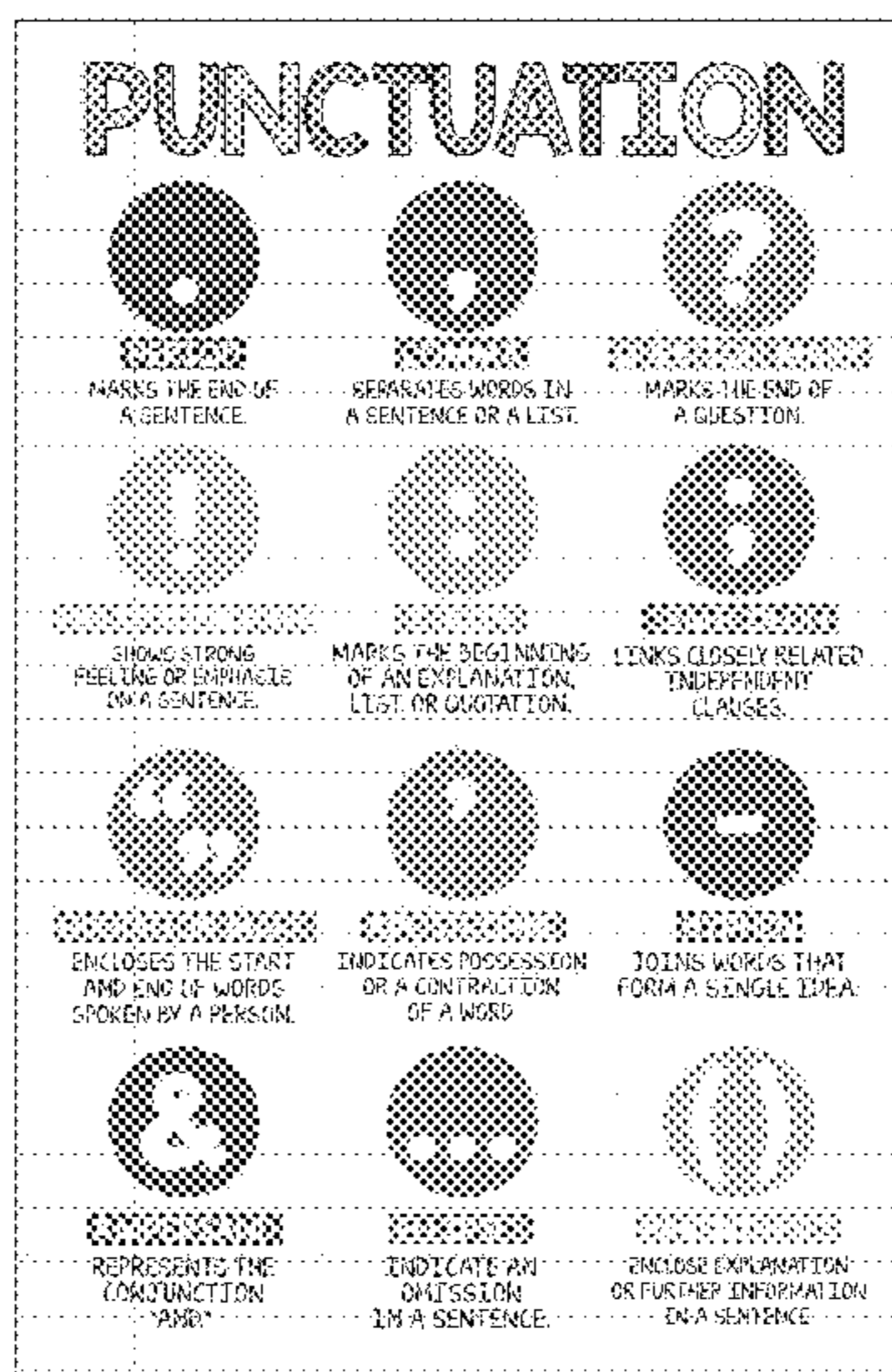

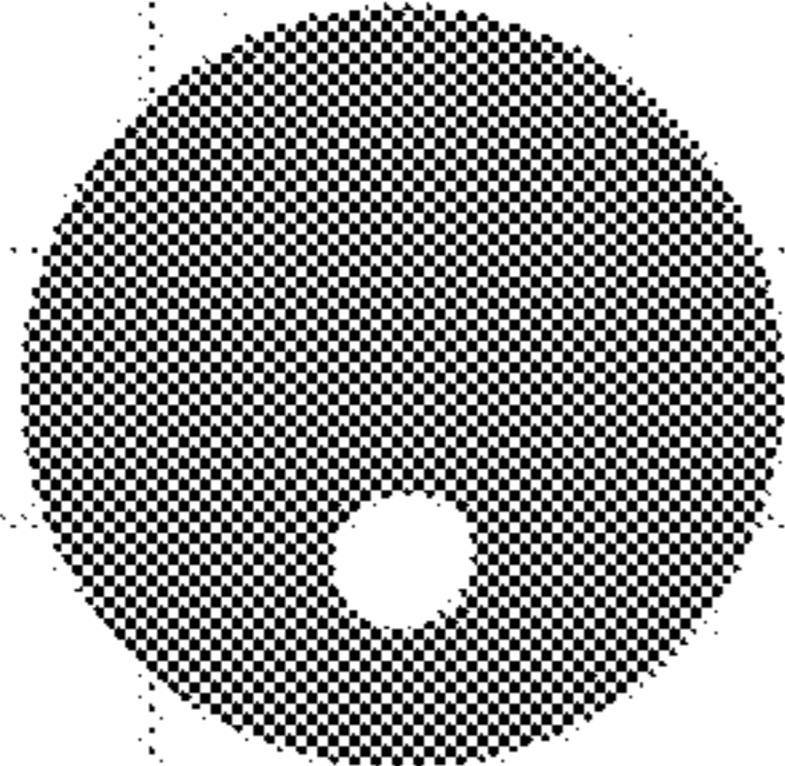

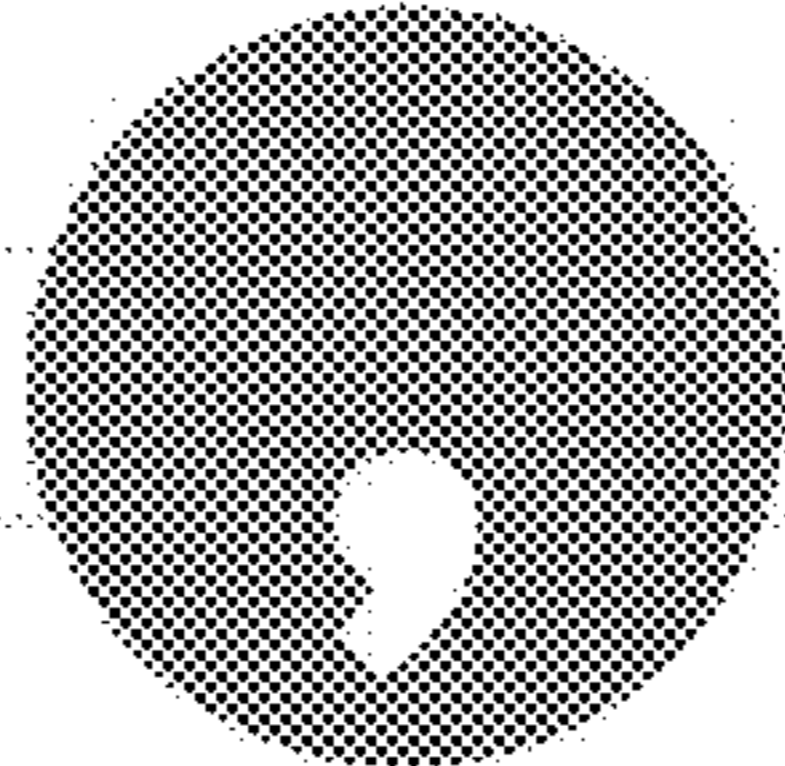

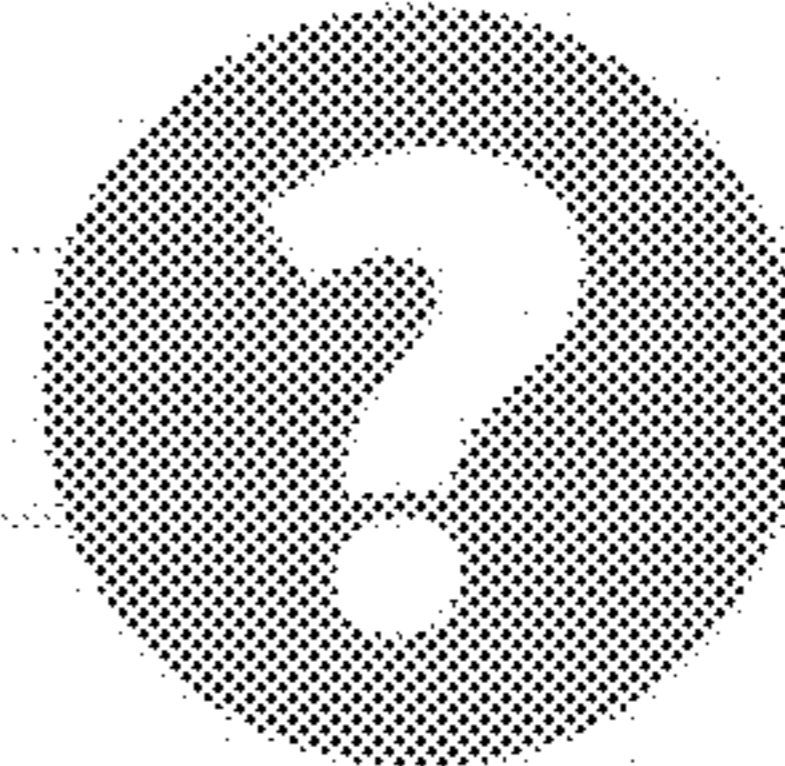

MARKS THE END OF A SENTENCE.



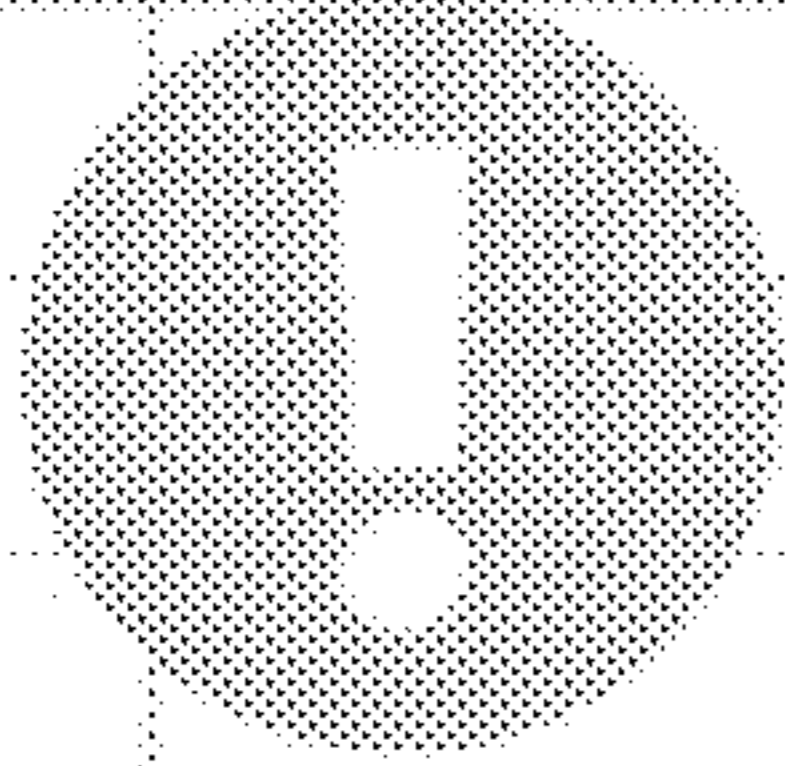
COMMA

SEPARATES WORDS IN A SENTENCE OR A LIST.



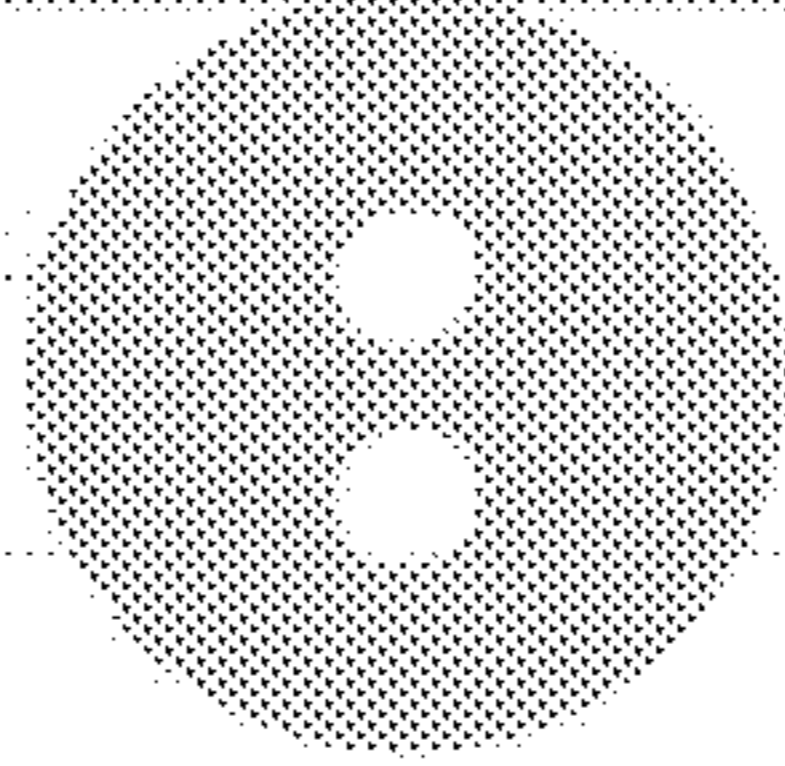
QUESTION MARK

MARKS THE END OF A QUESTION.



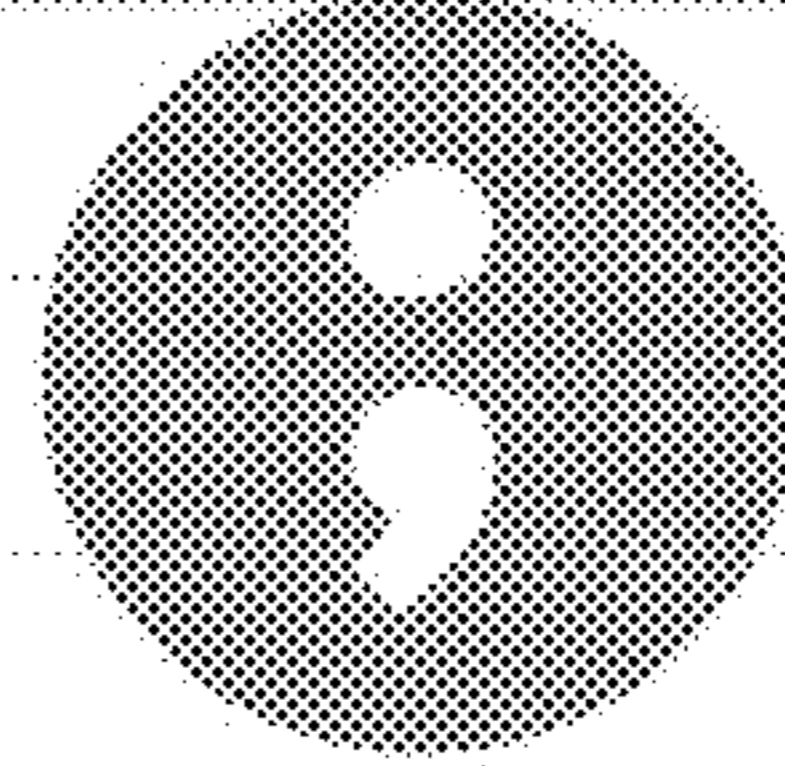
EXCLAMATION MARK

SHOWS STRONG FEELING OR EMPHASIS ON A SENTENCE.



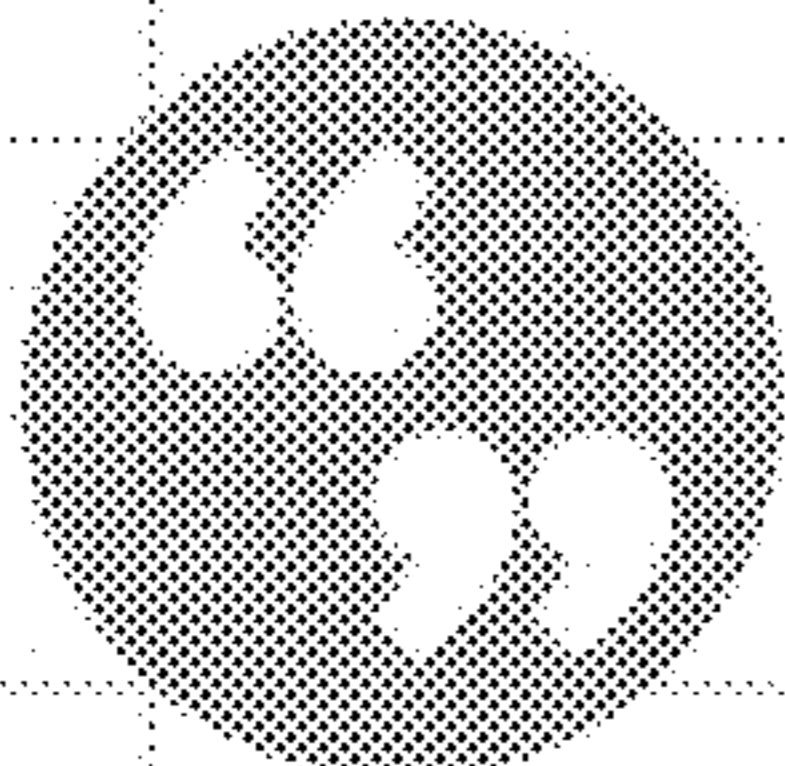
COLON

MARKS THE BEGINNING OF AN EXPLANATION, LIST, OR QUOTATION.



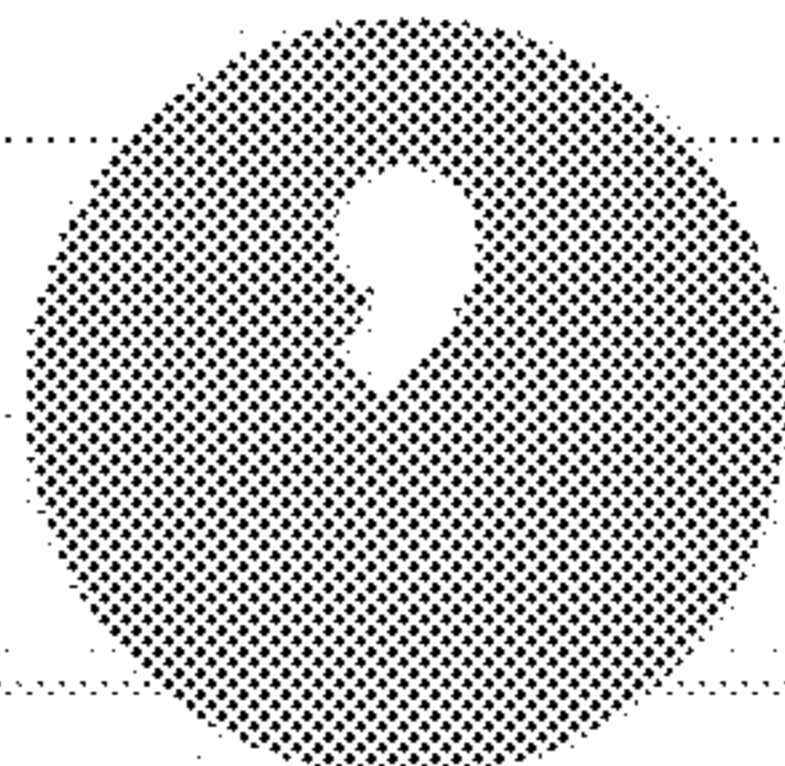
SEMICOLON

LINKS CLOSELY RELATED INDEPENDENT CLAUSES.



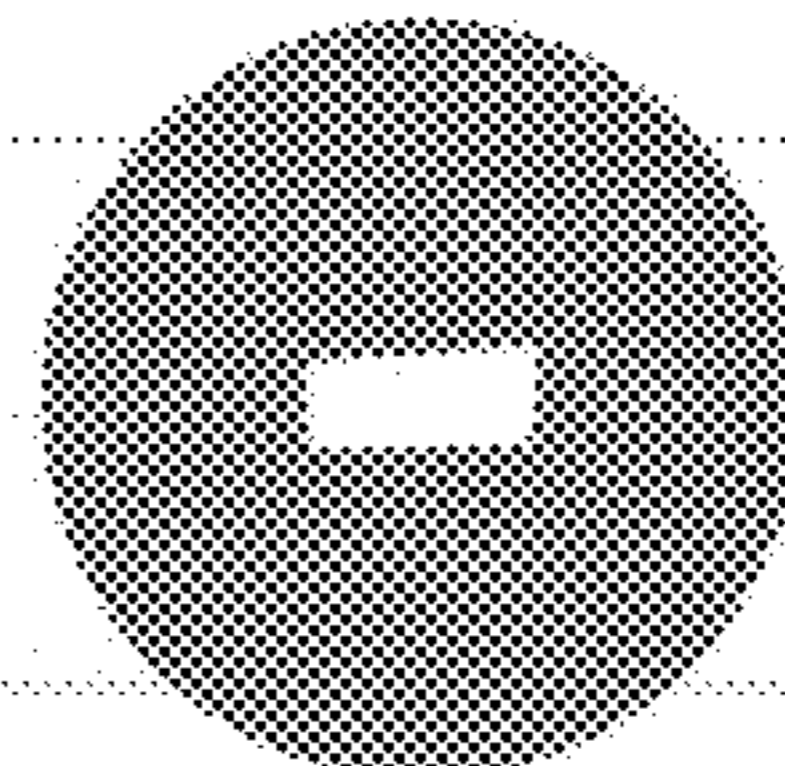
QUOTATION MARK

ENCLOSES THE START AND END OF WORDS SPOKEN BY A PERSON.



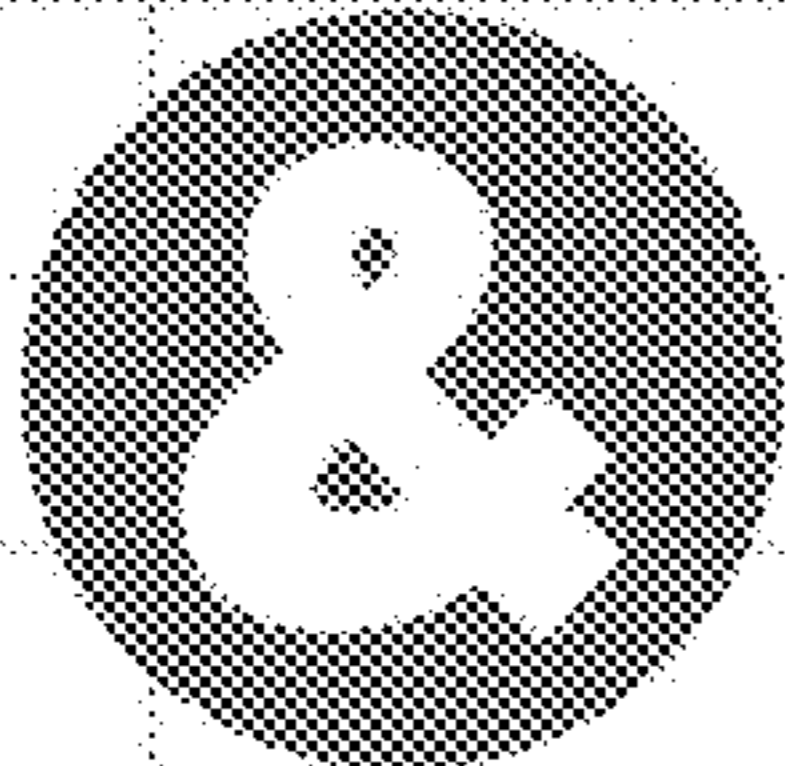
APOSTROPHE

INDICATES POSSESSION OR A CONTRACTION OF A WORD.



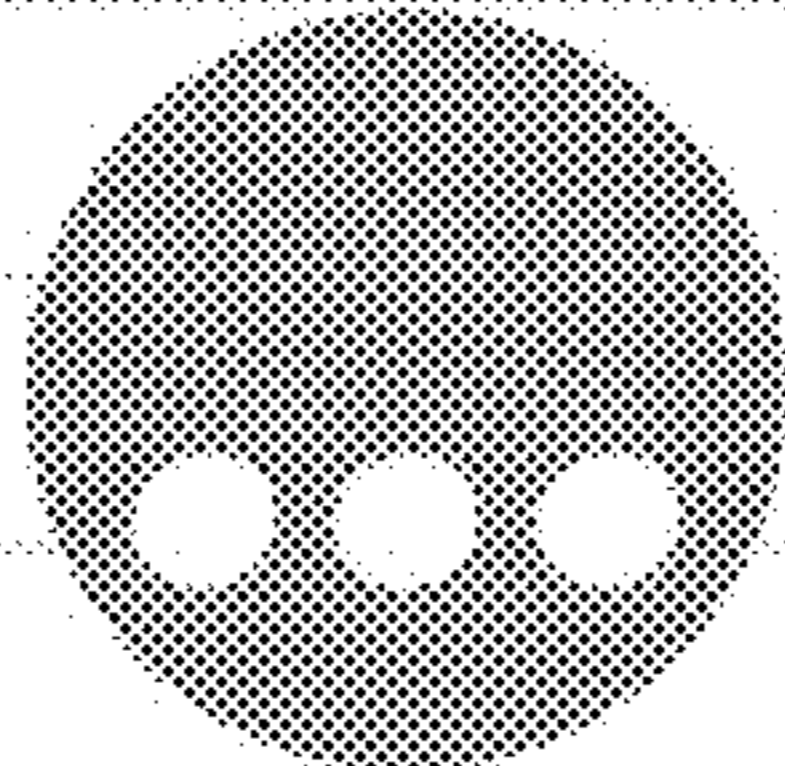
HYPHEN

JOINS WORDS THAT FORM A SINGLE IDEA.



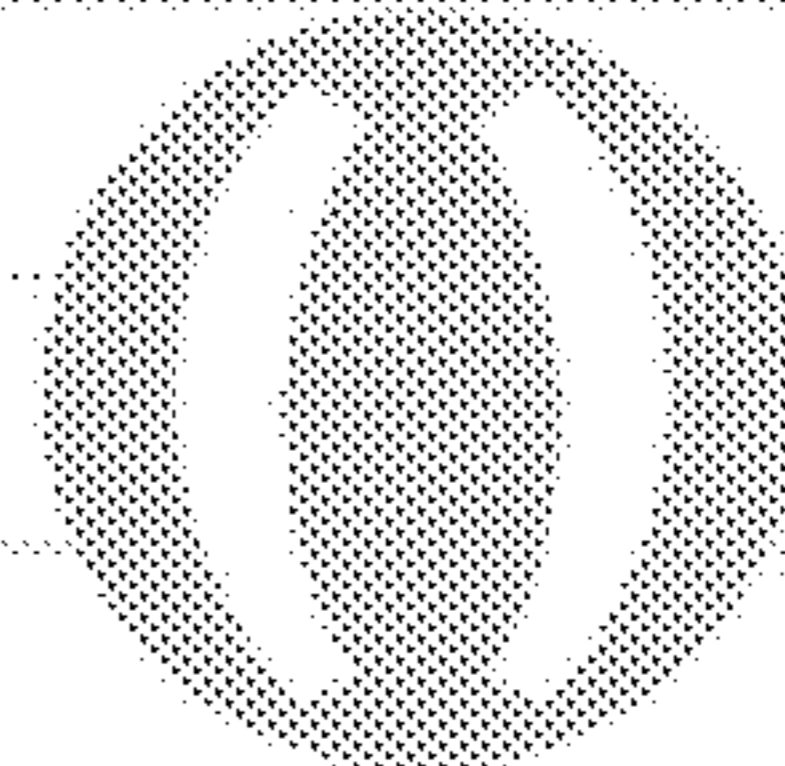
AMPERSAND
