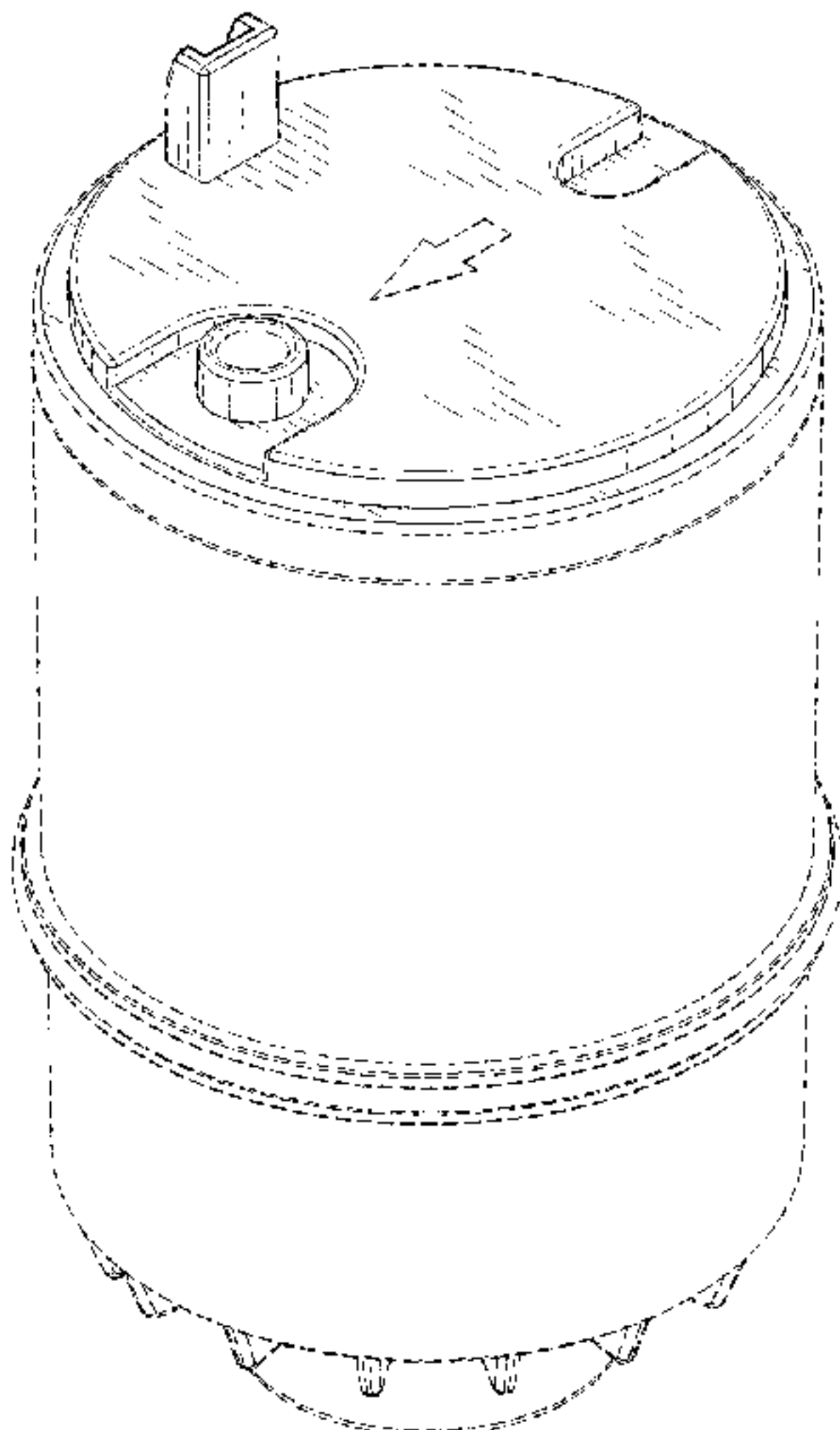
CLAIM

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a water
filter, showing the claimed design;
FIG. 2 is a front elevation view thereof;

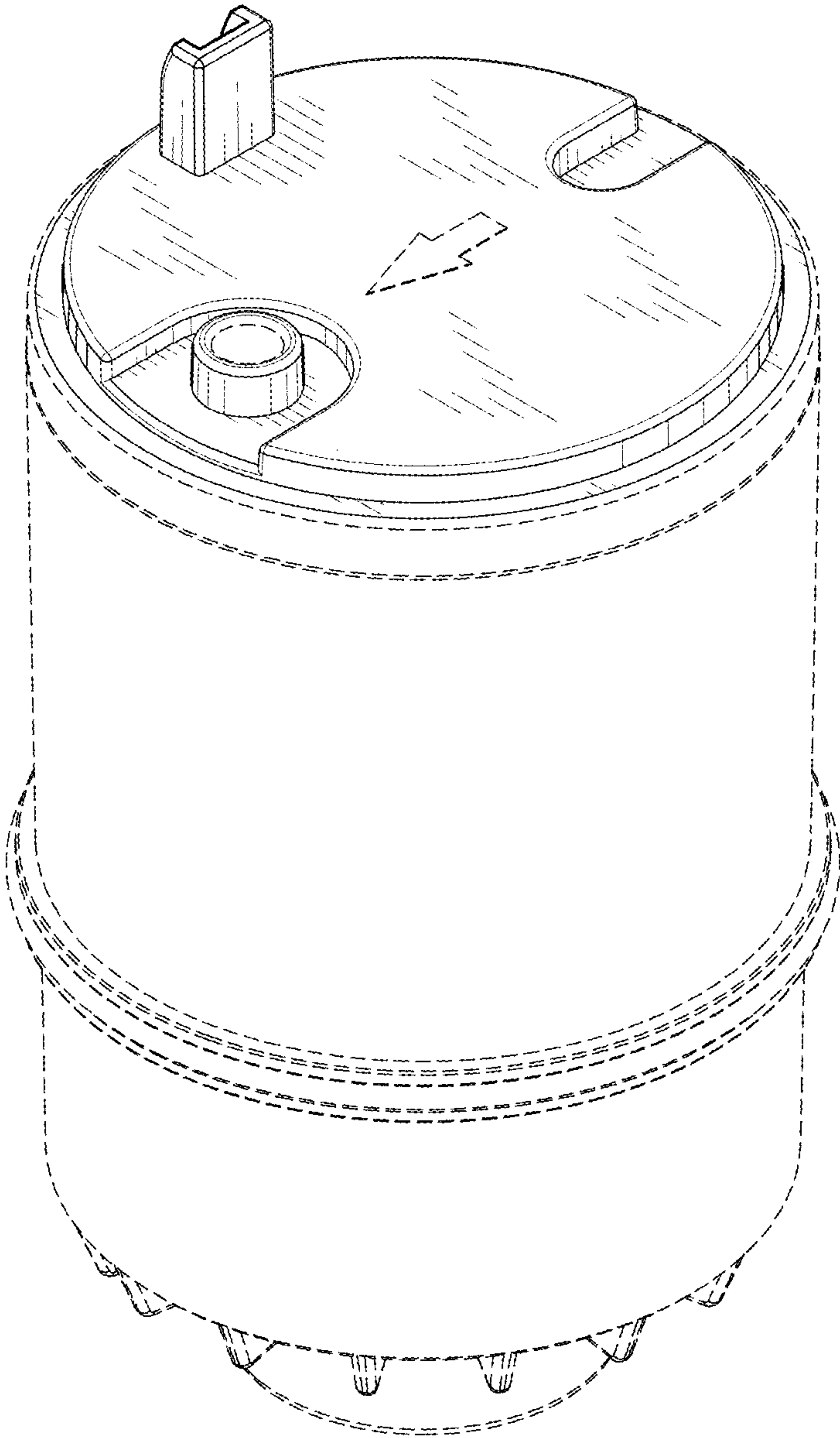

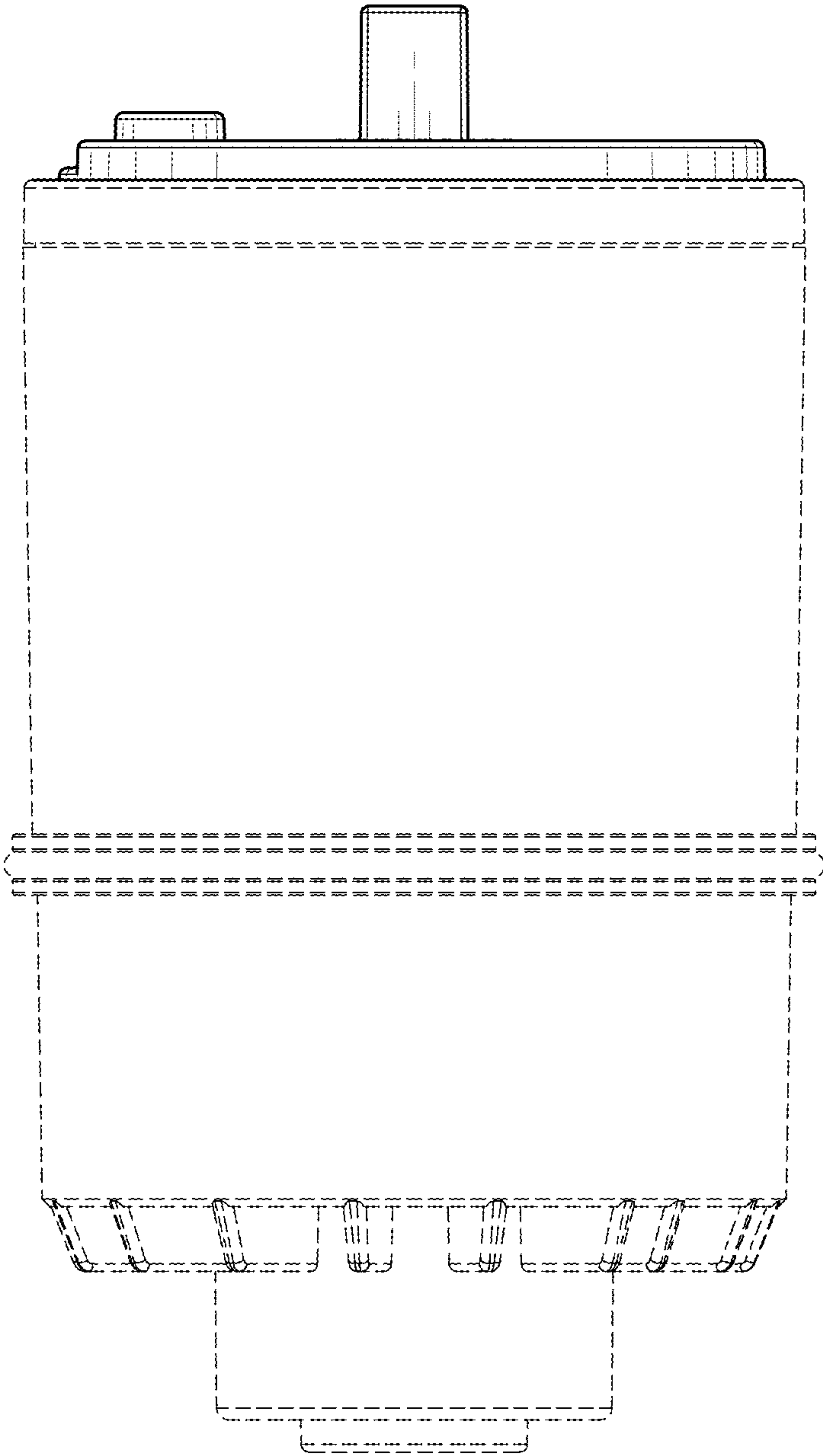

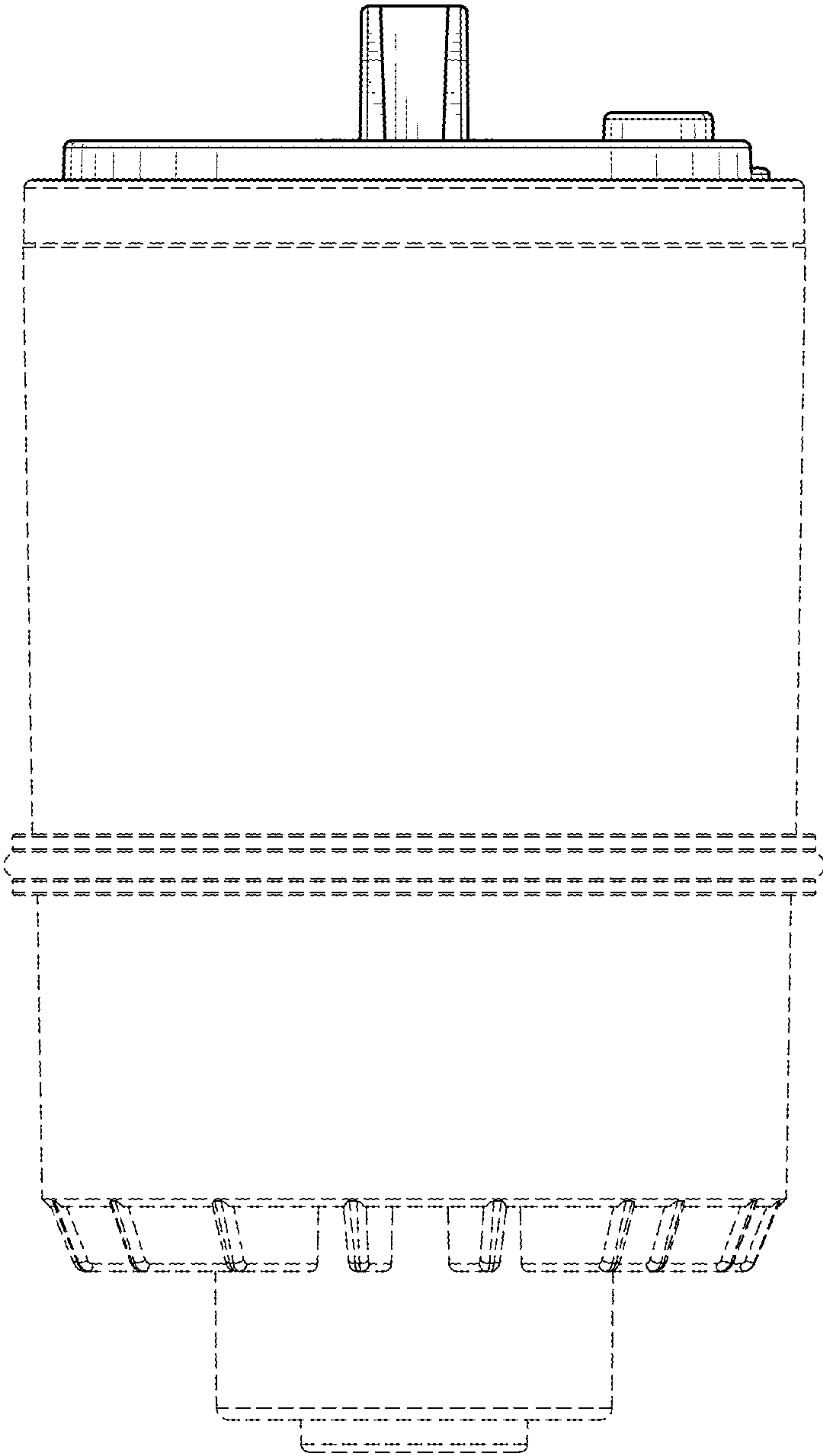

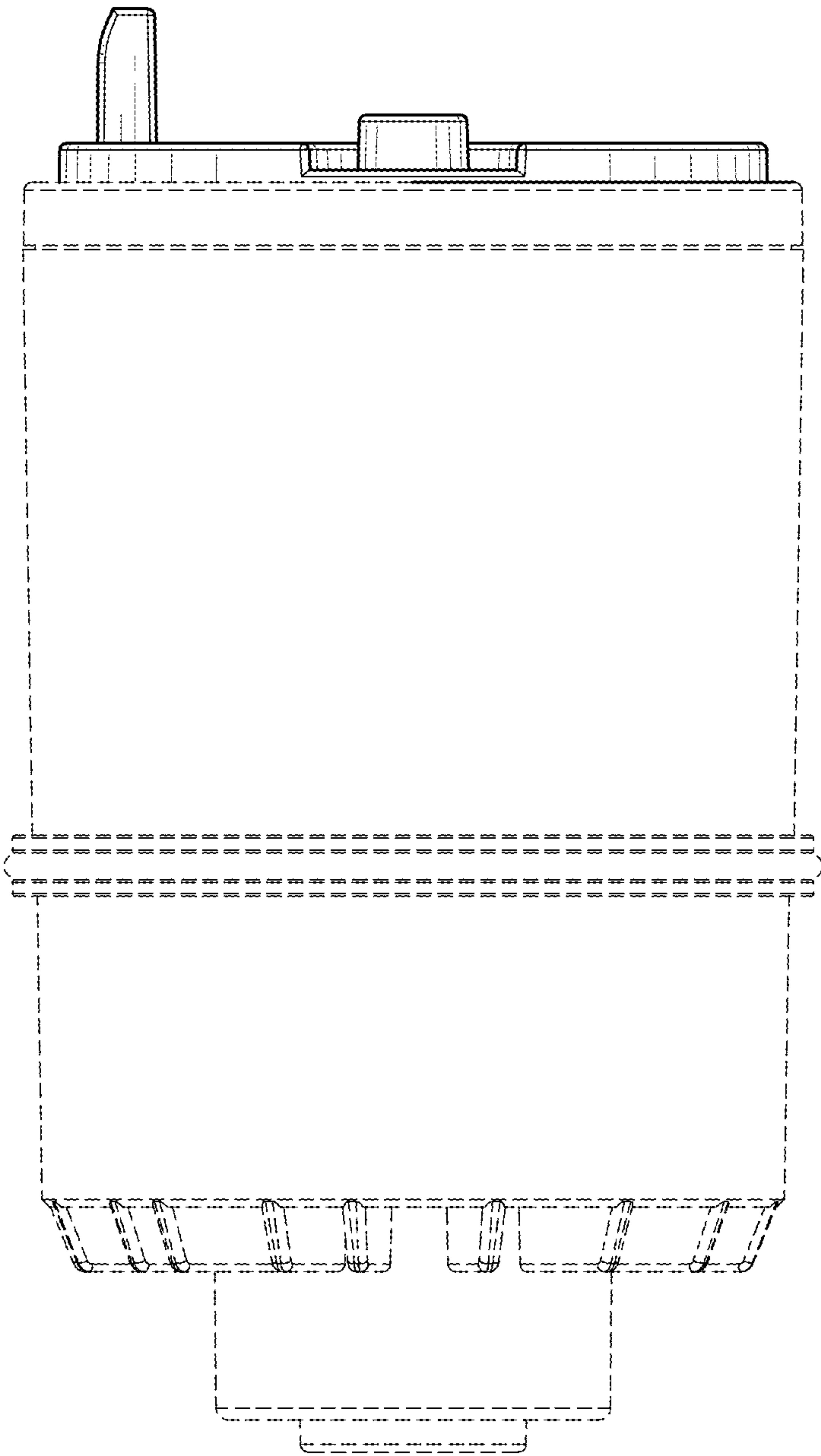

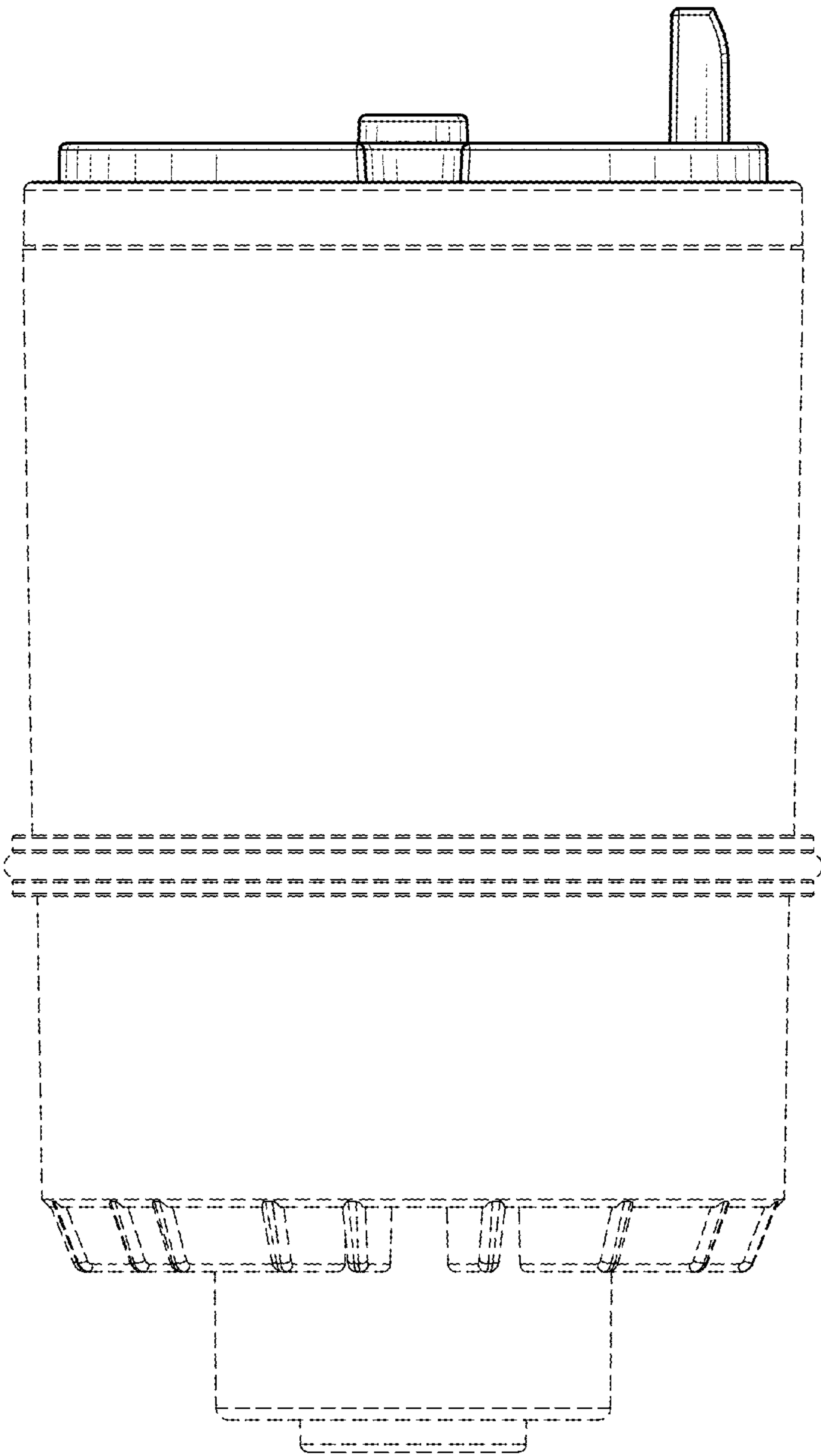

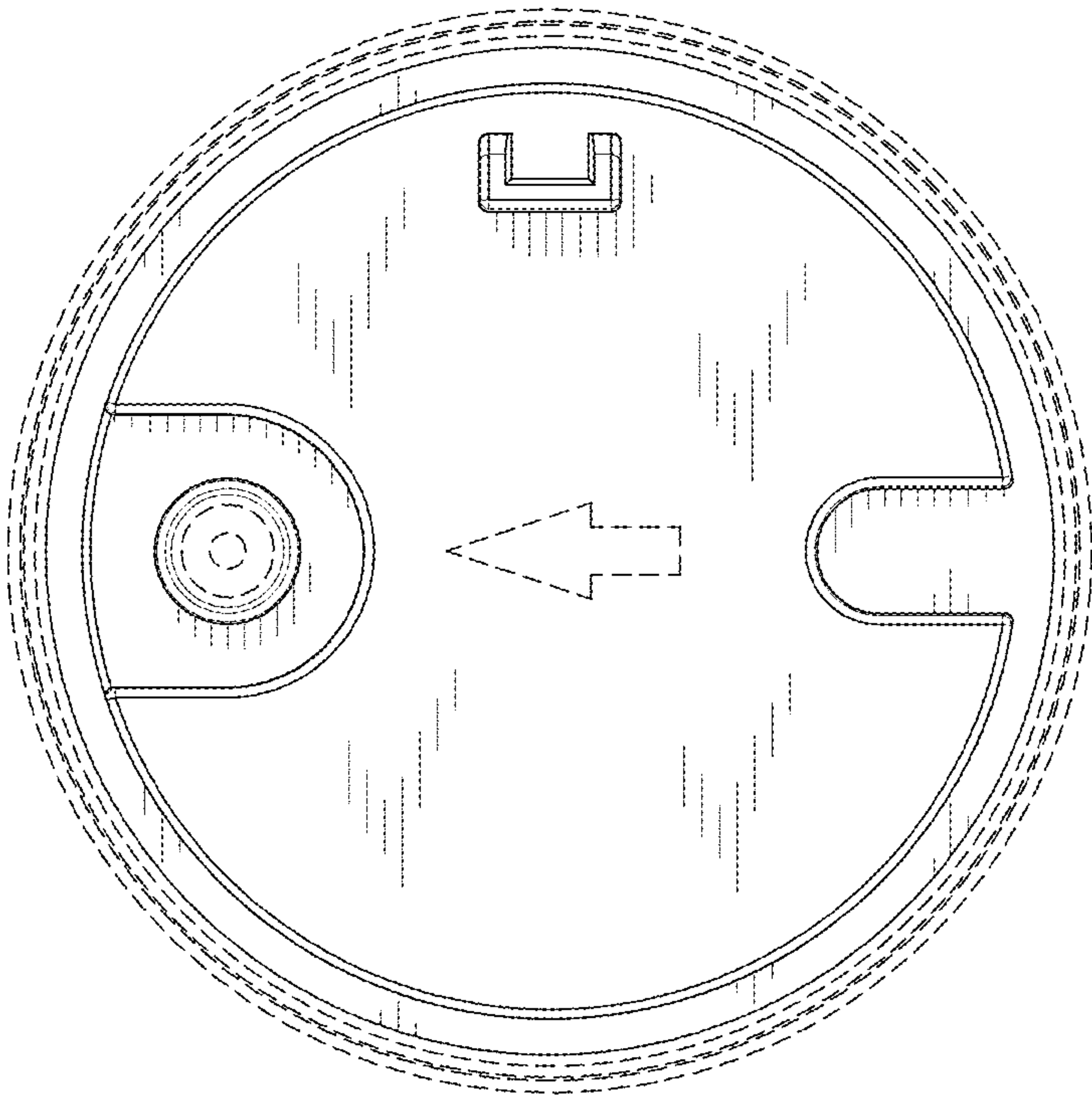

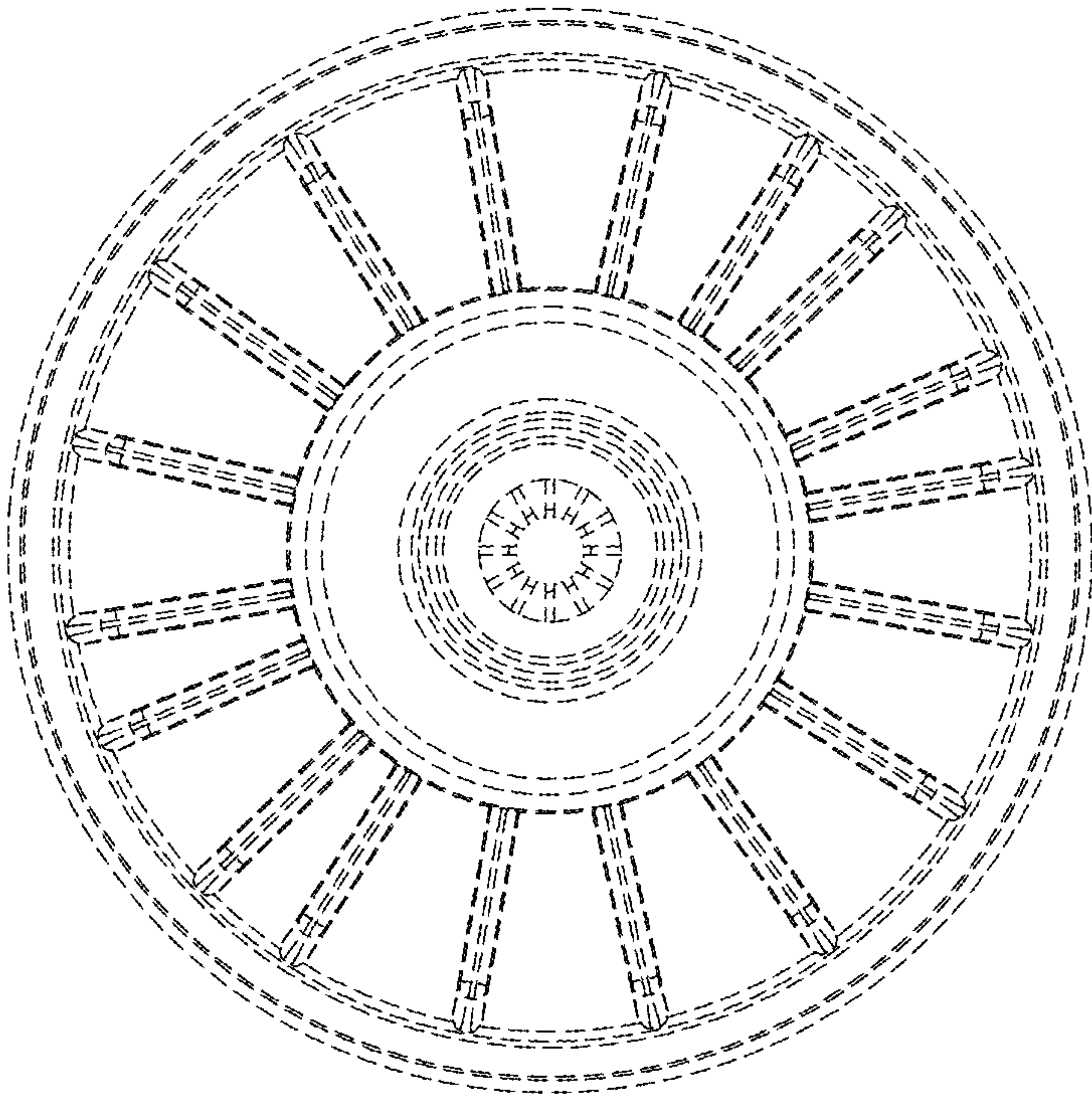
