DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an aromatherapy lamp elbow, showing my new design;
FIG. 2 is a bottom, front and left side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a top plan view thereof.
The lamp cap and lamp base outlined by broken lines assists in illustrating how the aromatherapy lamp elbow may appear when in a position of use, but forms no part of the claimed design.

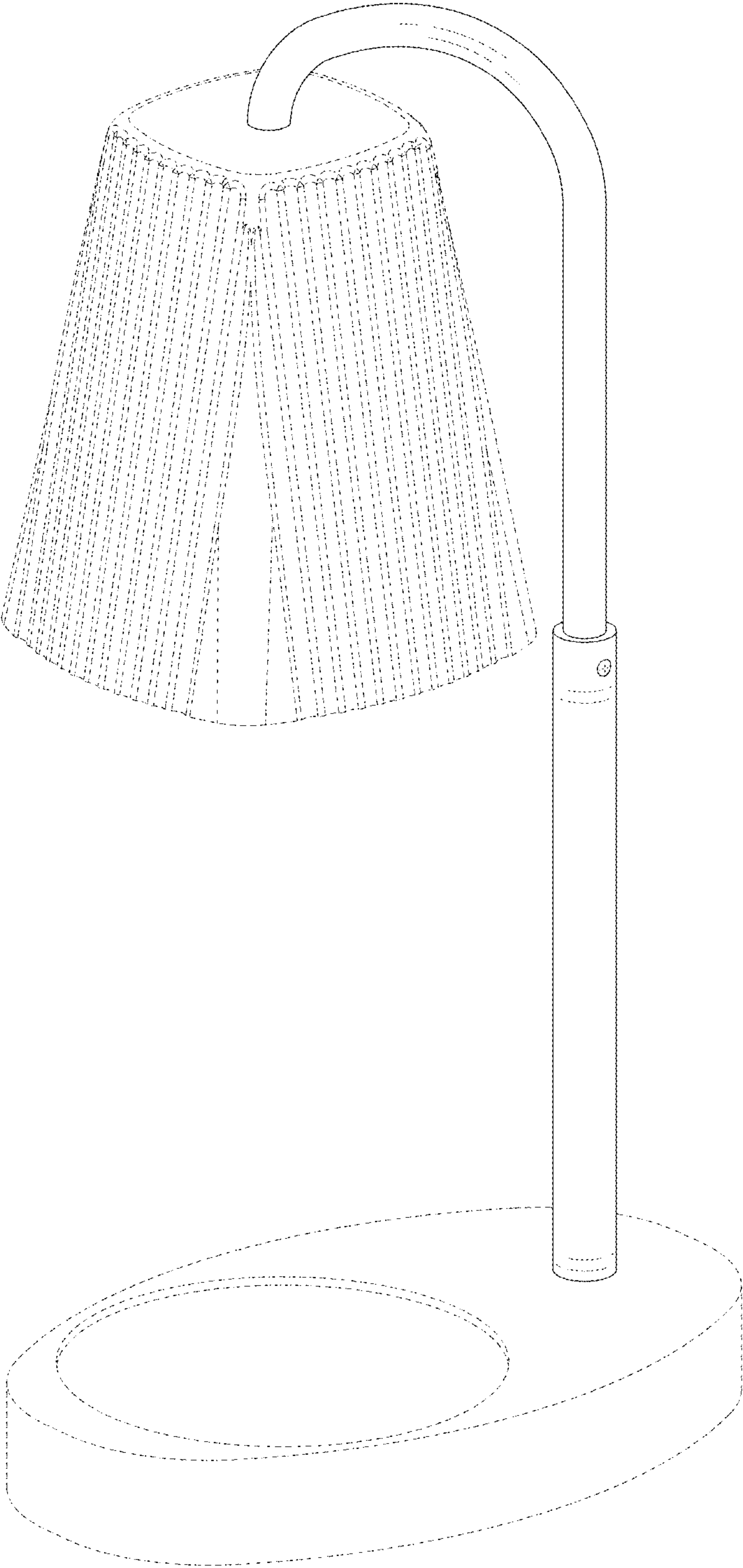

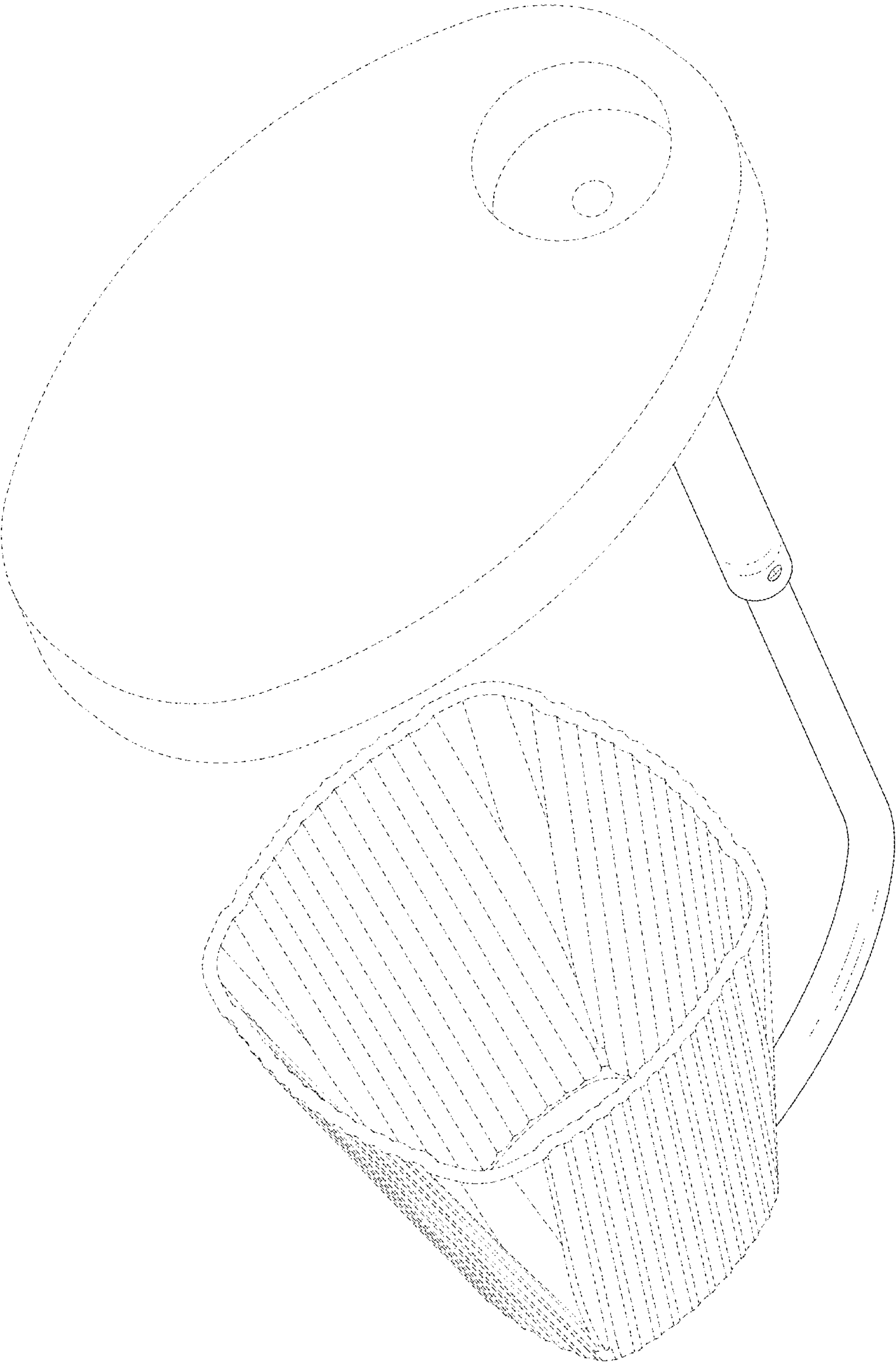

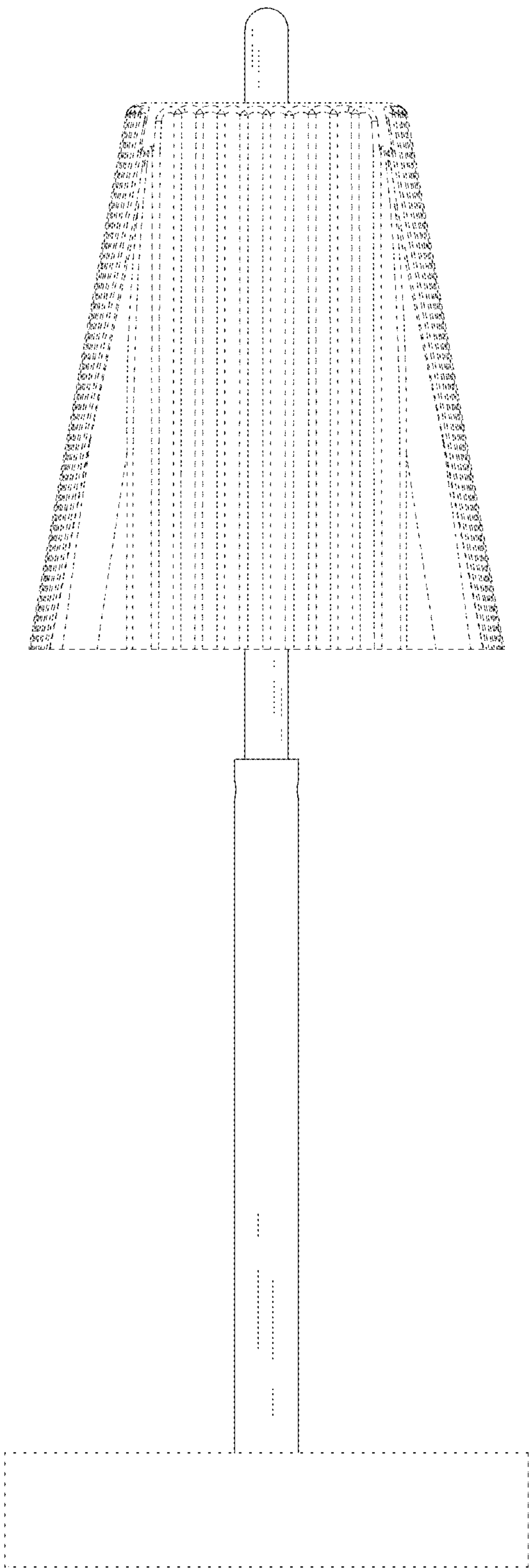

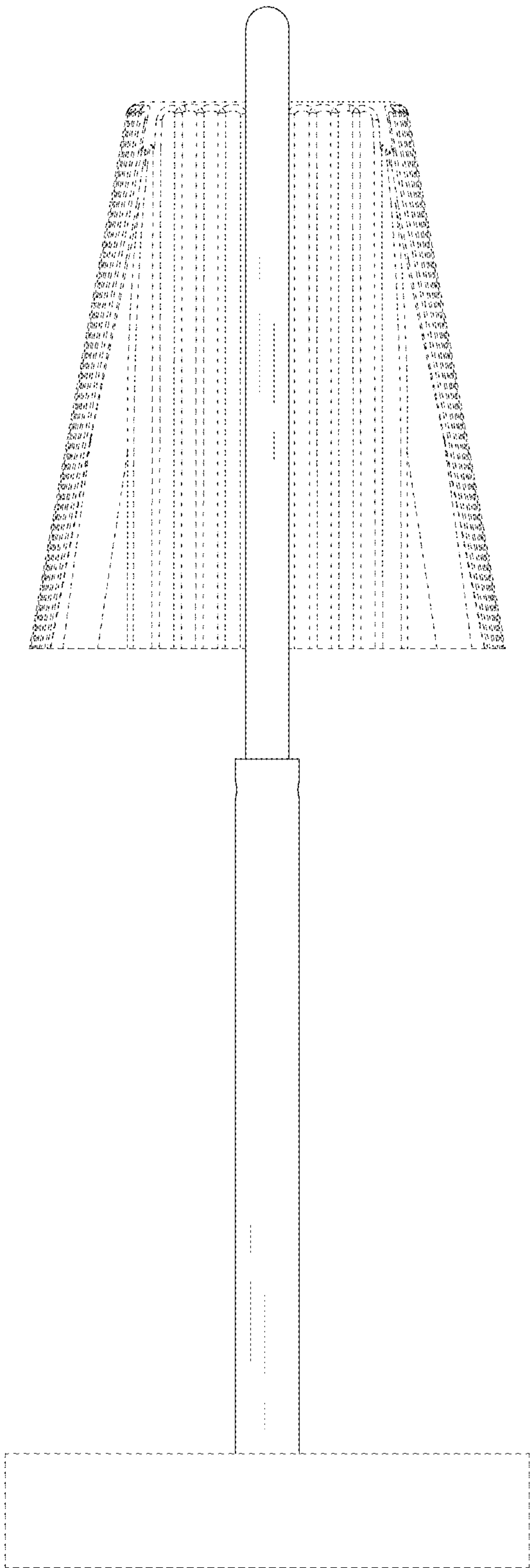

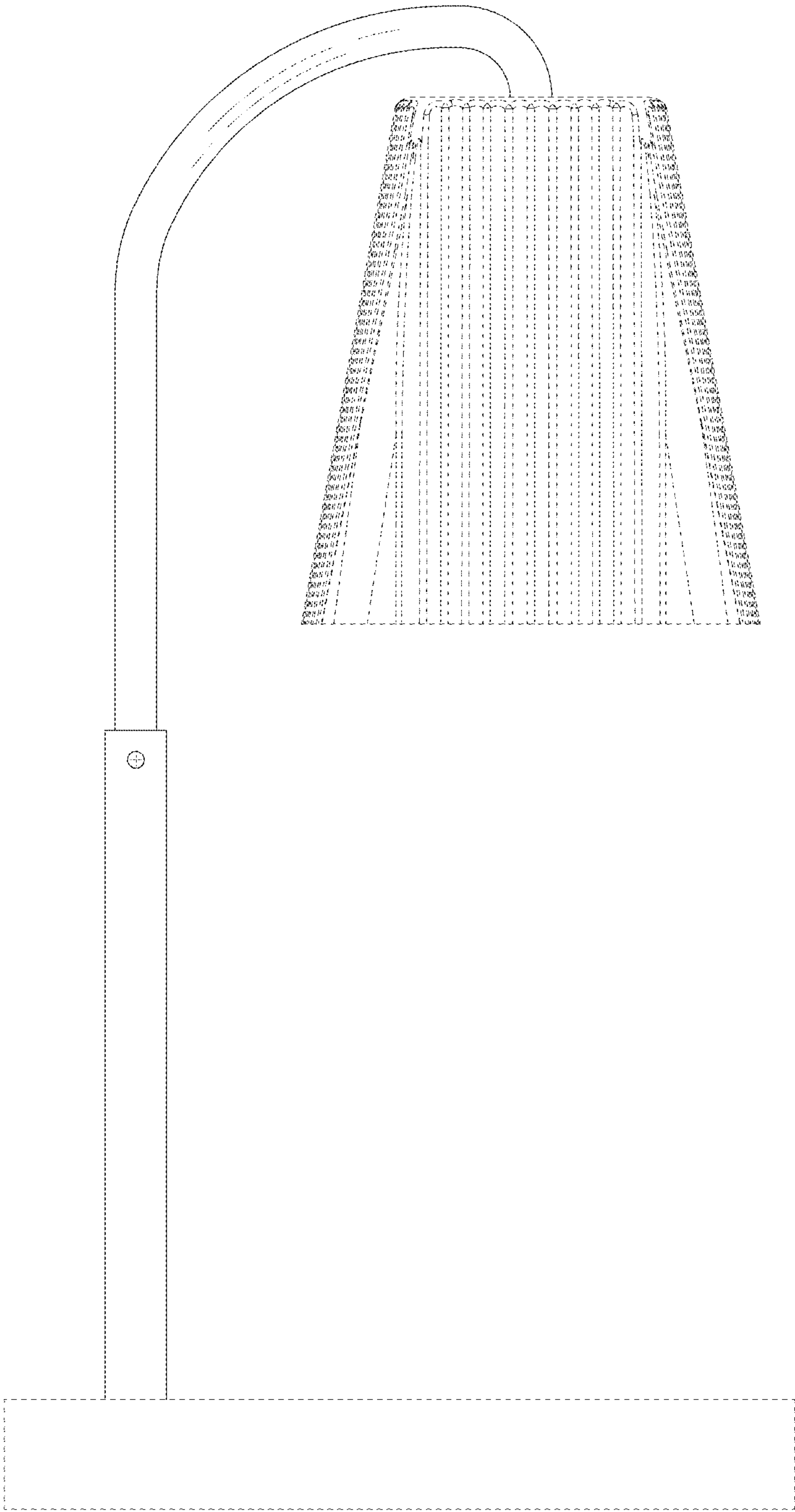

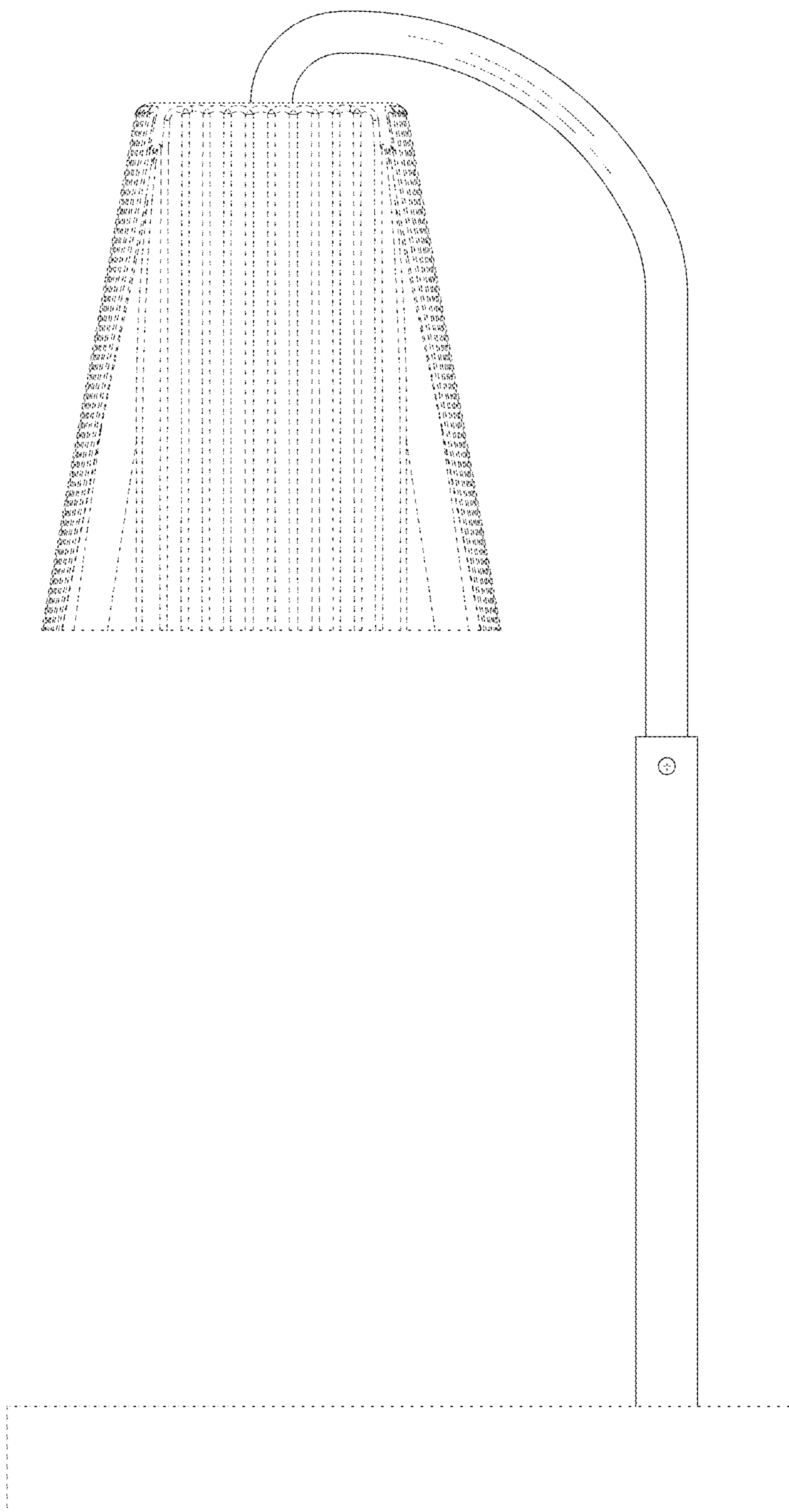

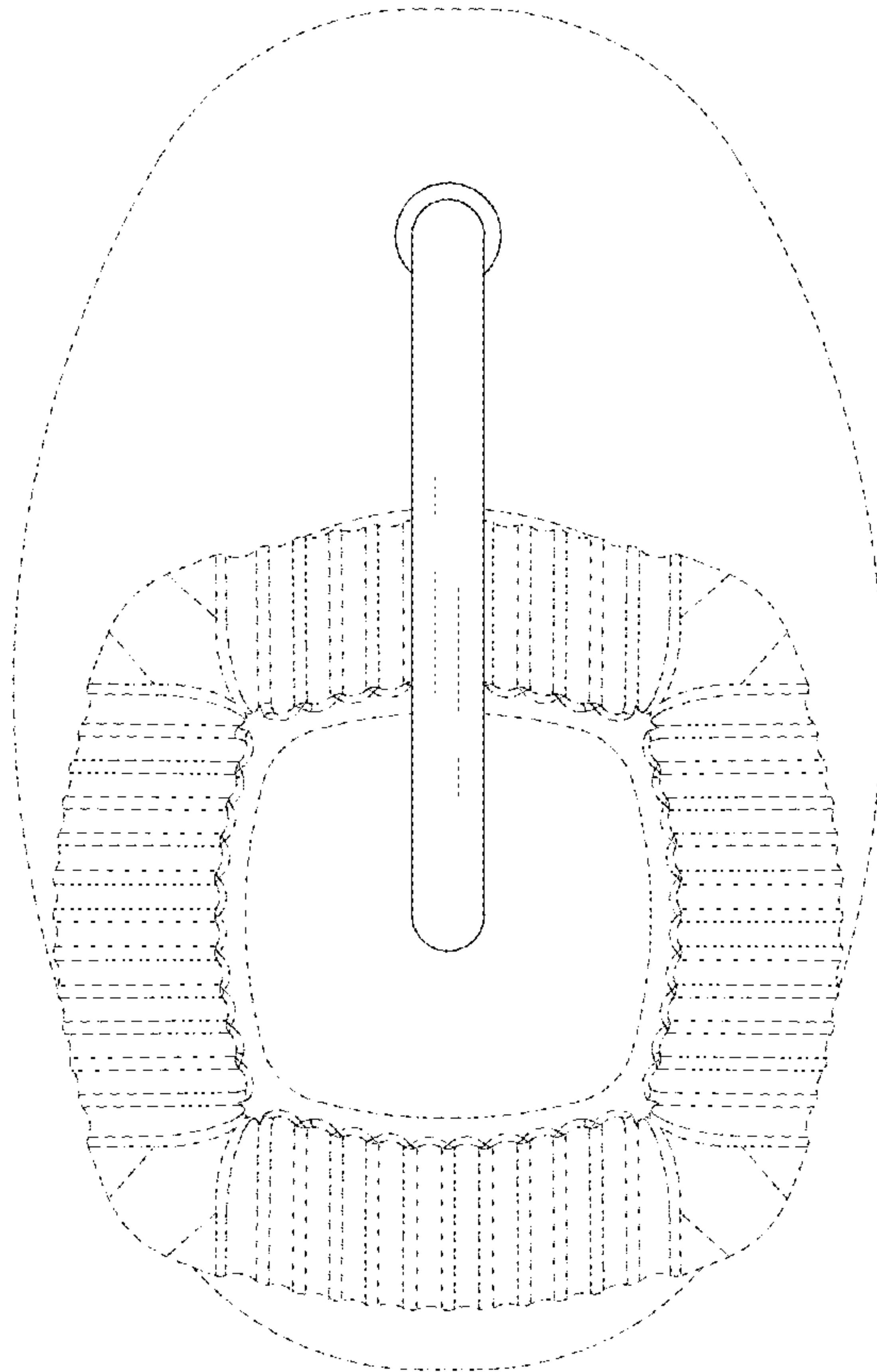
