(57) **CLAIM**

The ornamental design for a support garment for a stringed musical instrument, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a support garment for a stringed musical instrument showing my new design;

FIG. 2 is a bottom-front-left perspective view thereof;

FIG. 3 is a top-rear-right perspective view thereof;

FIG. 4 is a bottom-rear-right perspective view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

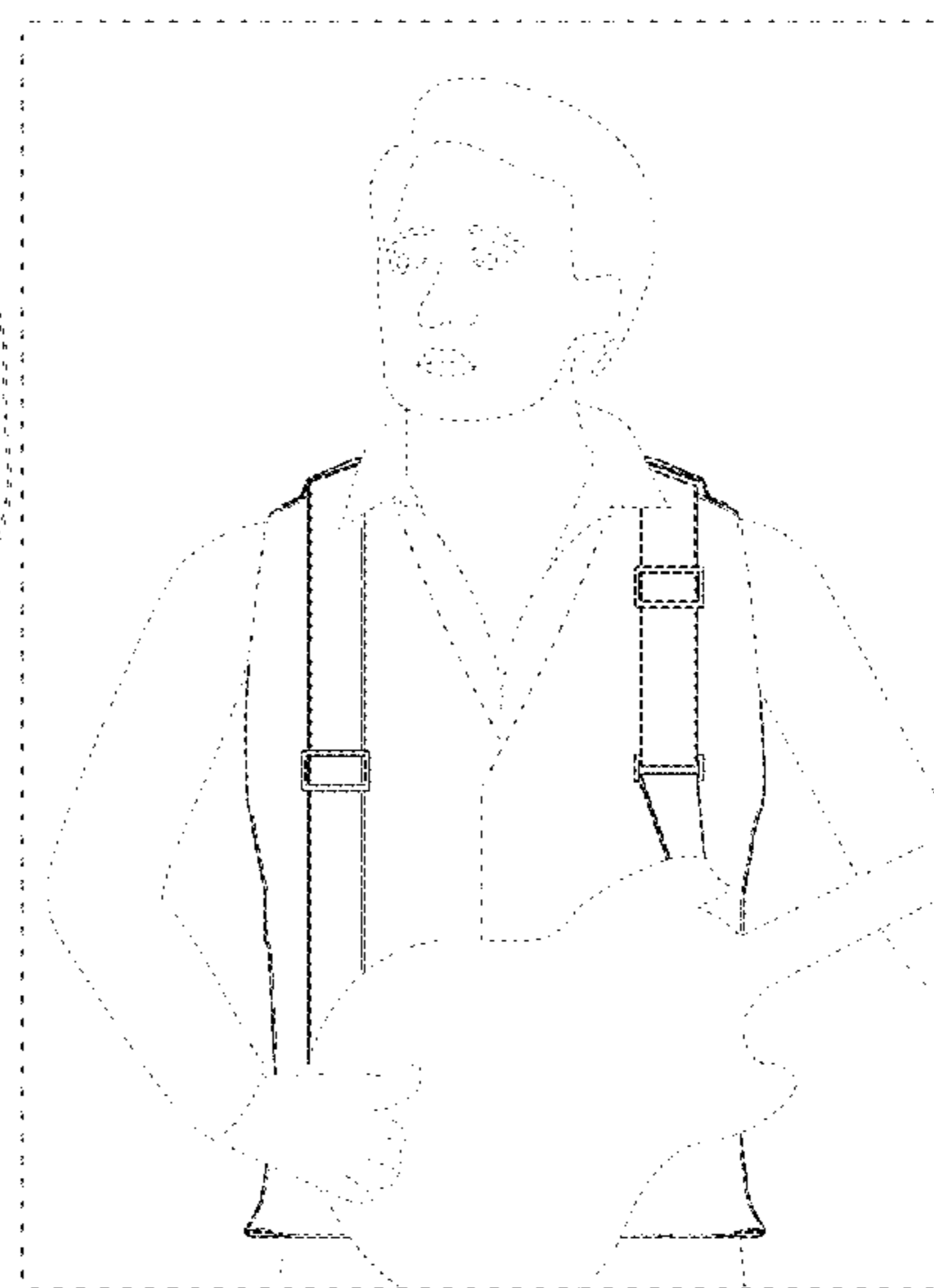
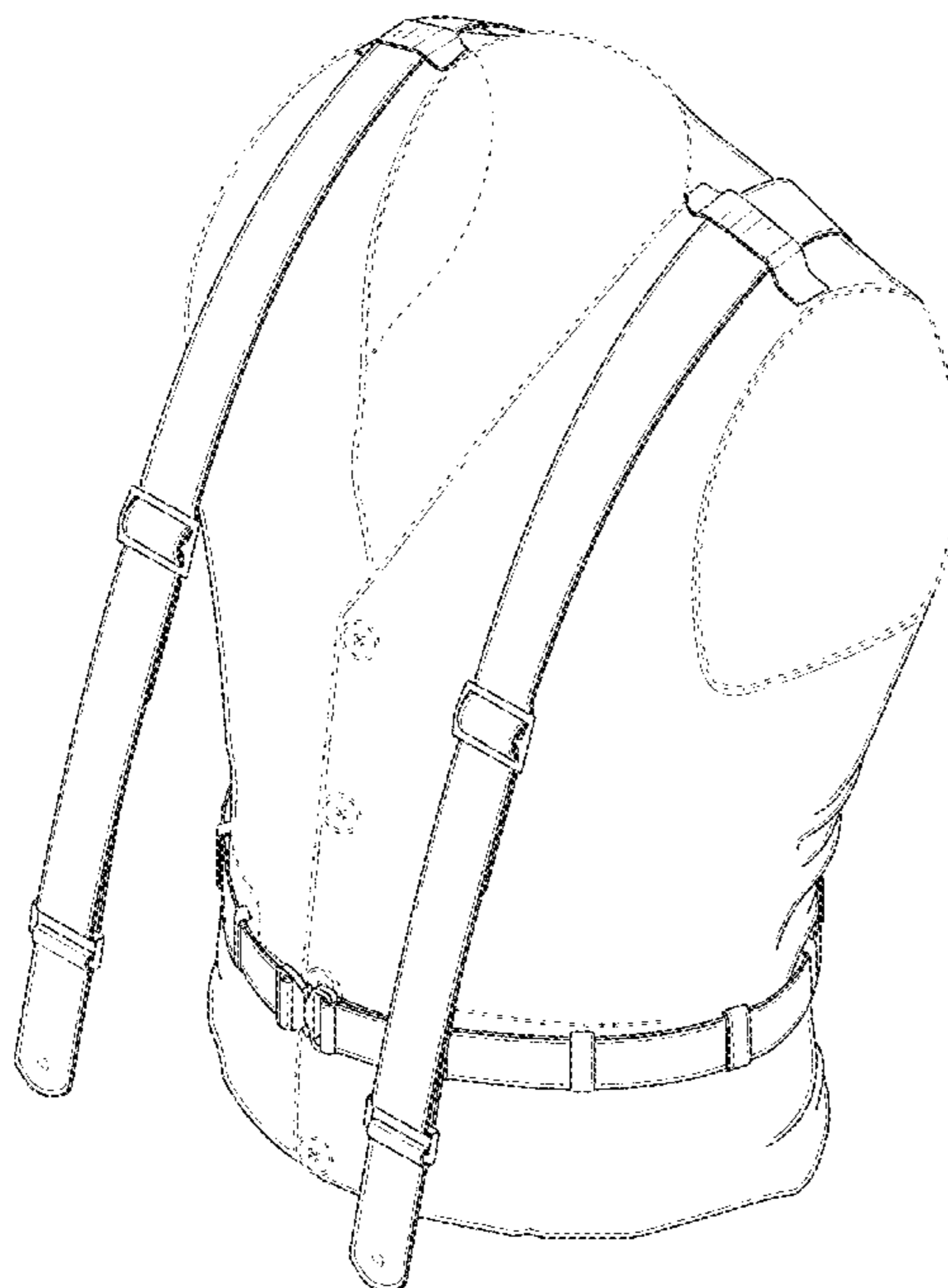
FIG. 9 is a right elevational view thereof;

FIG. 10 is a left elevational view thereof; and,

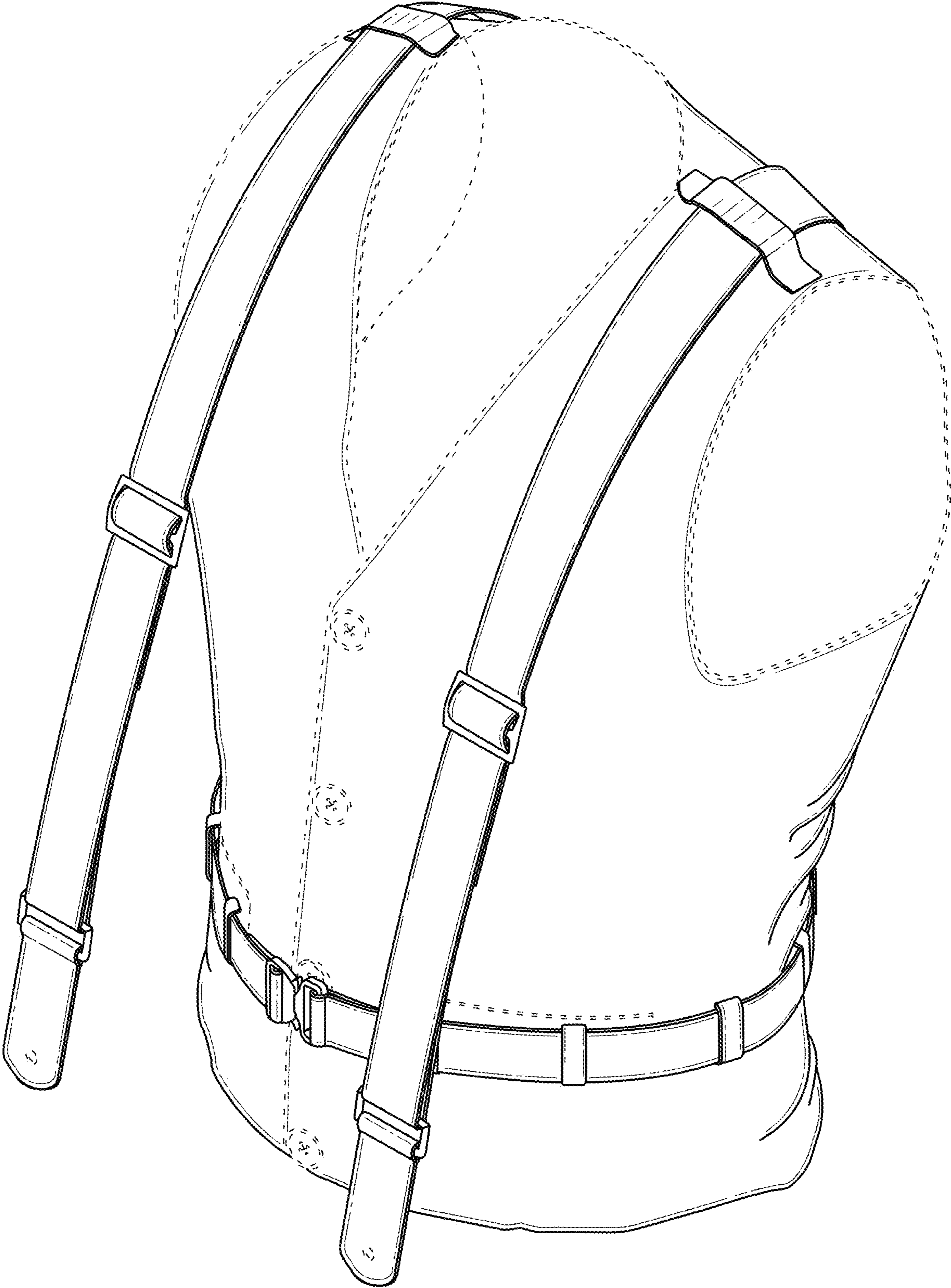

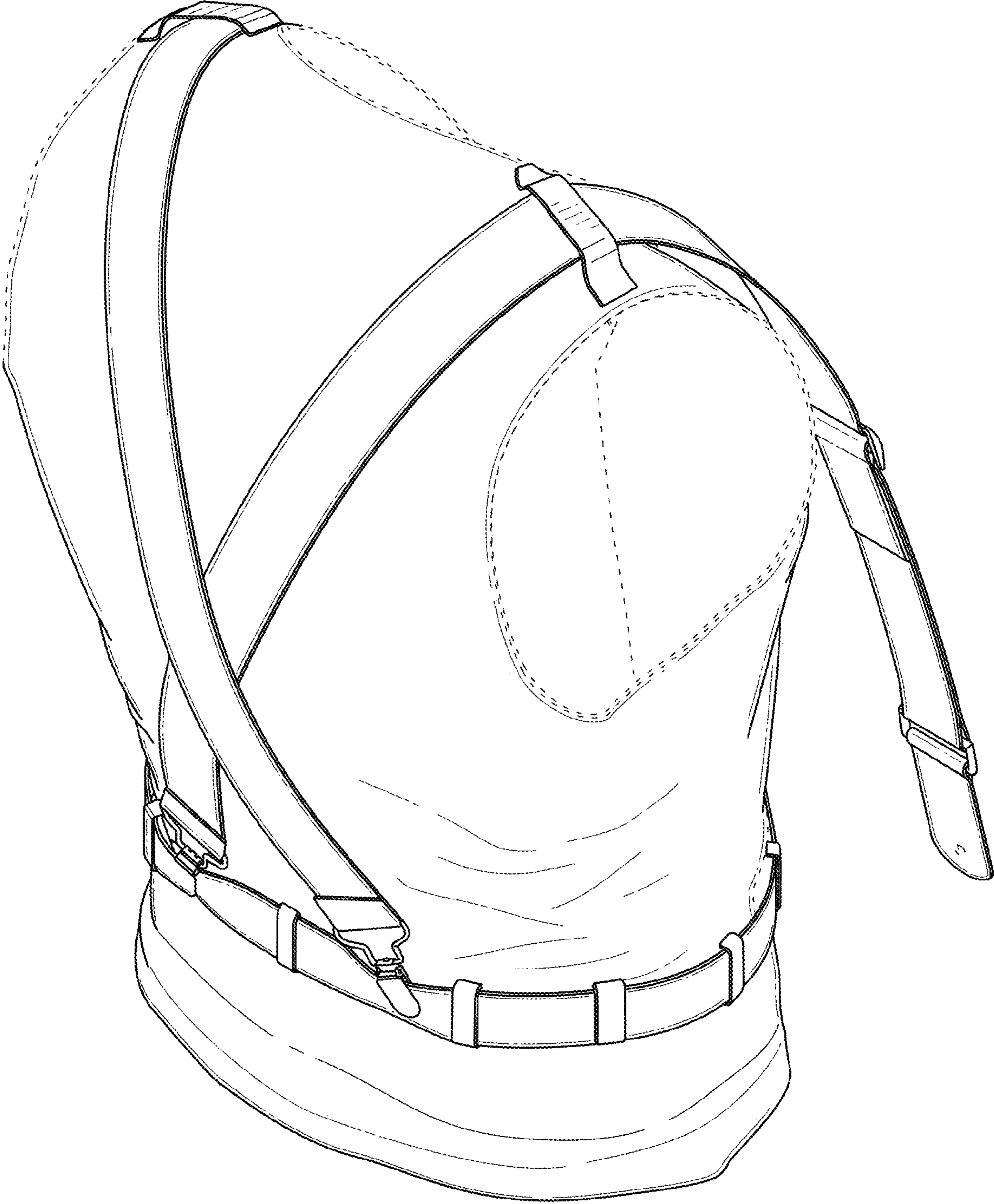

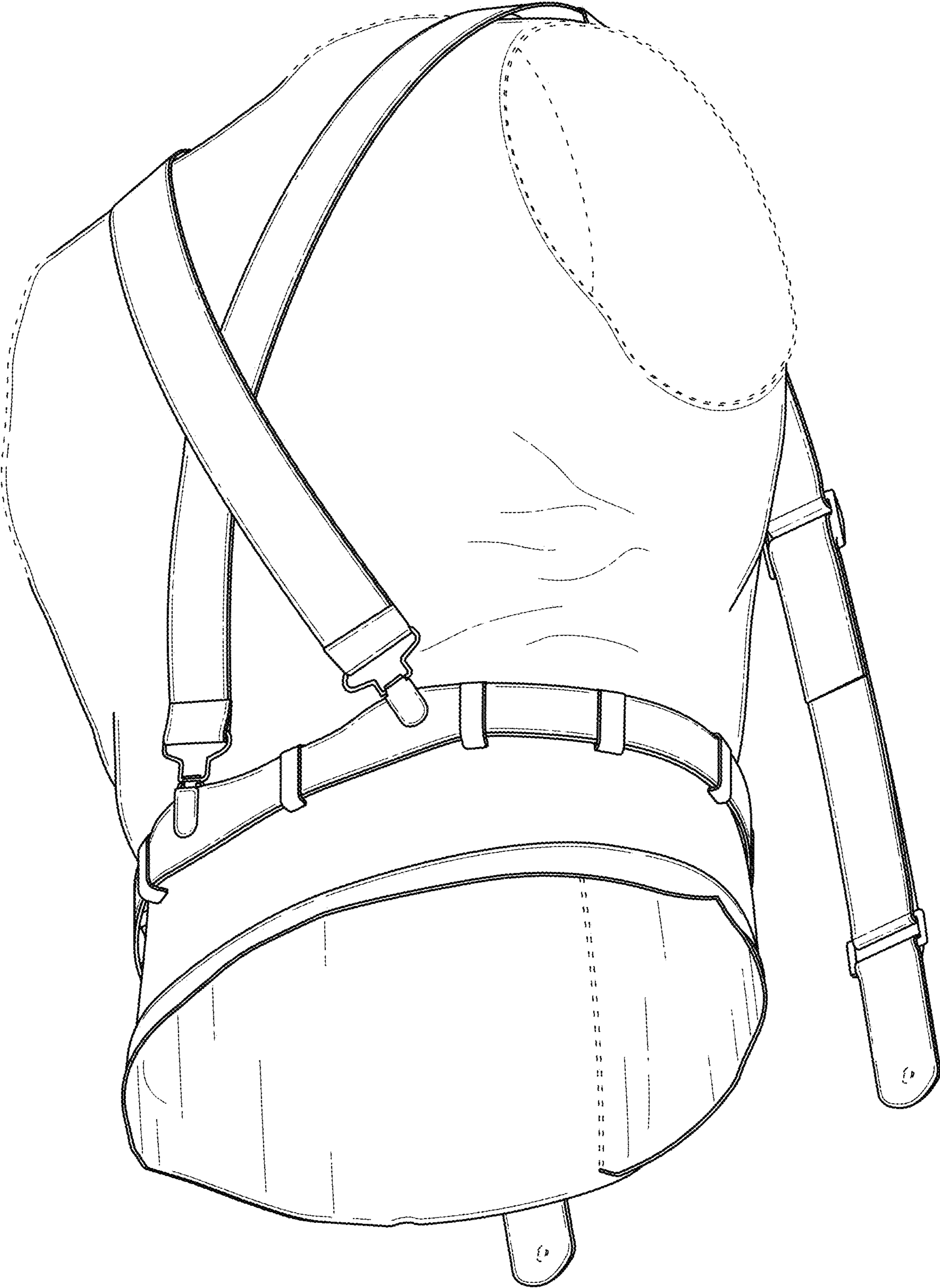

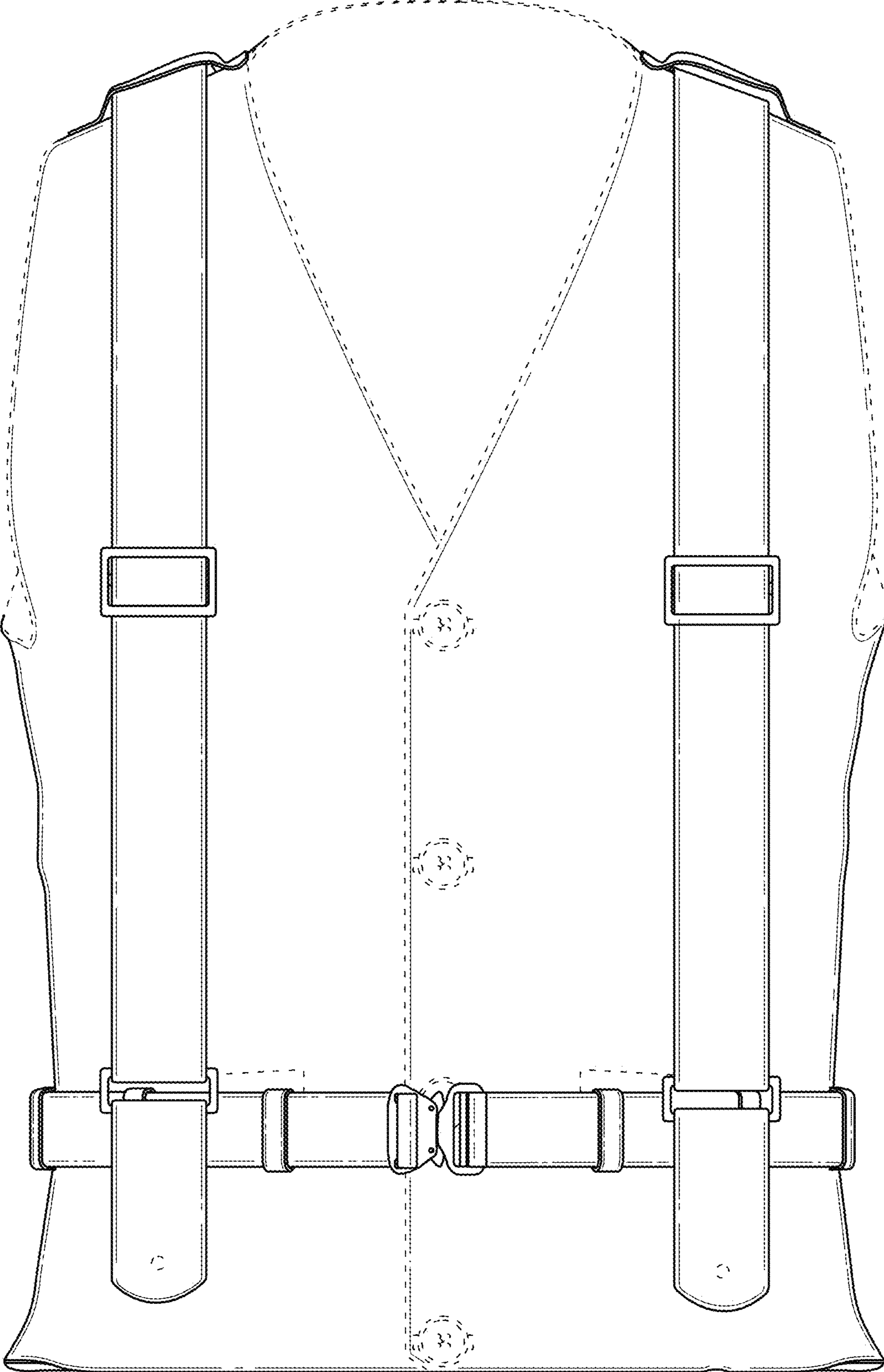

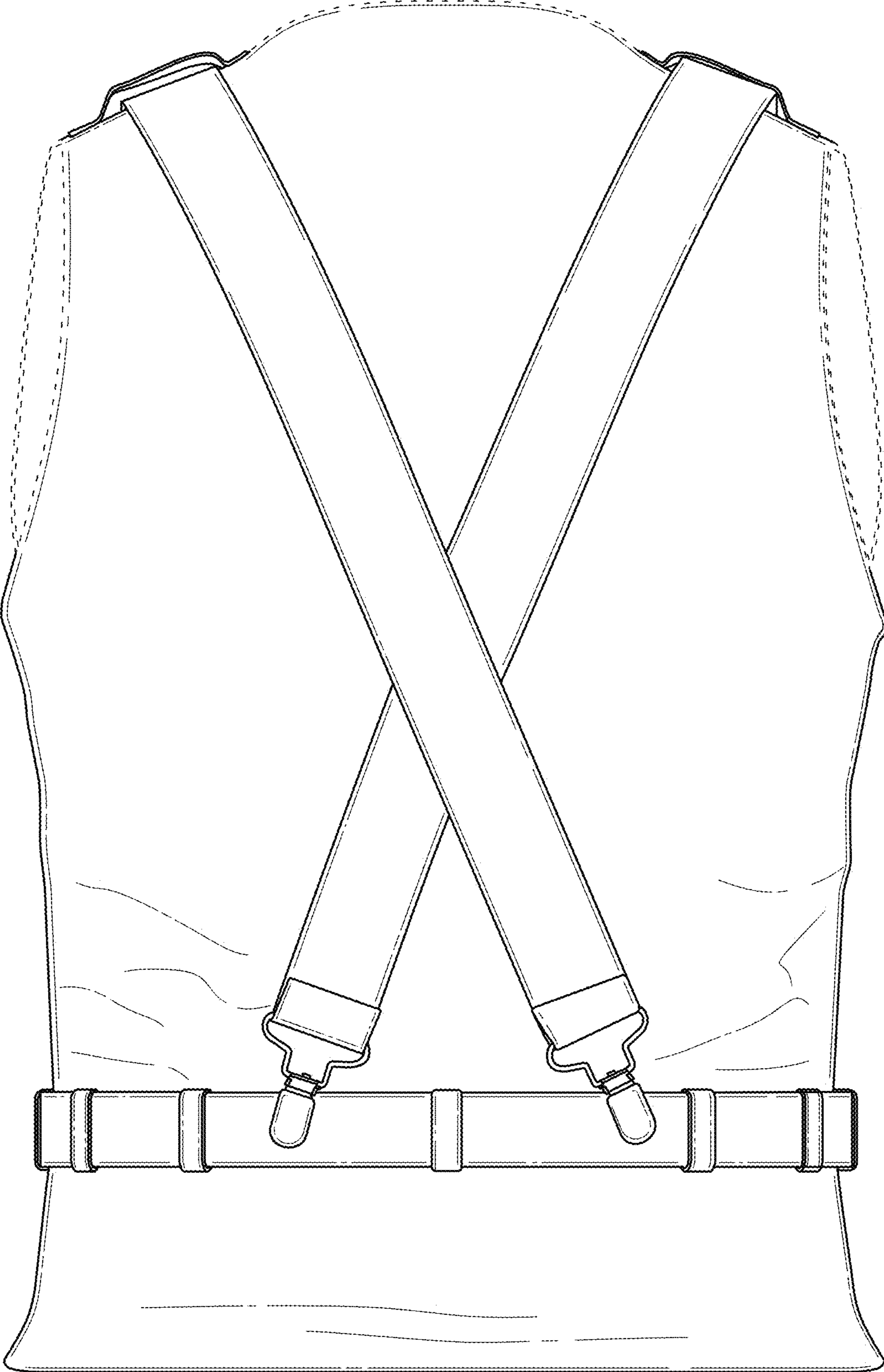

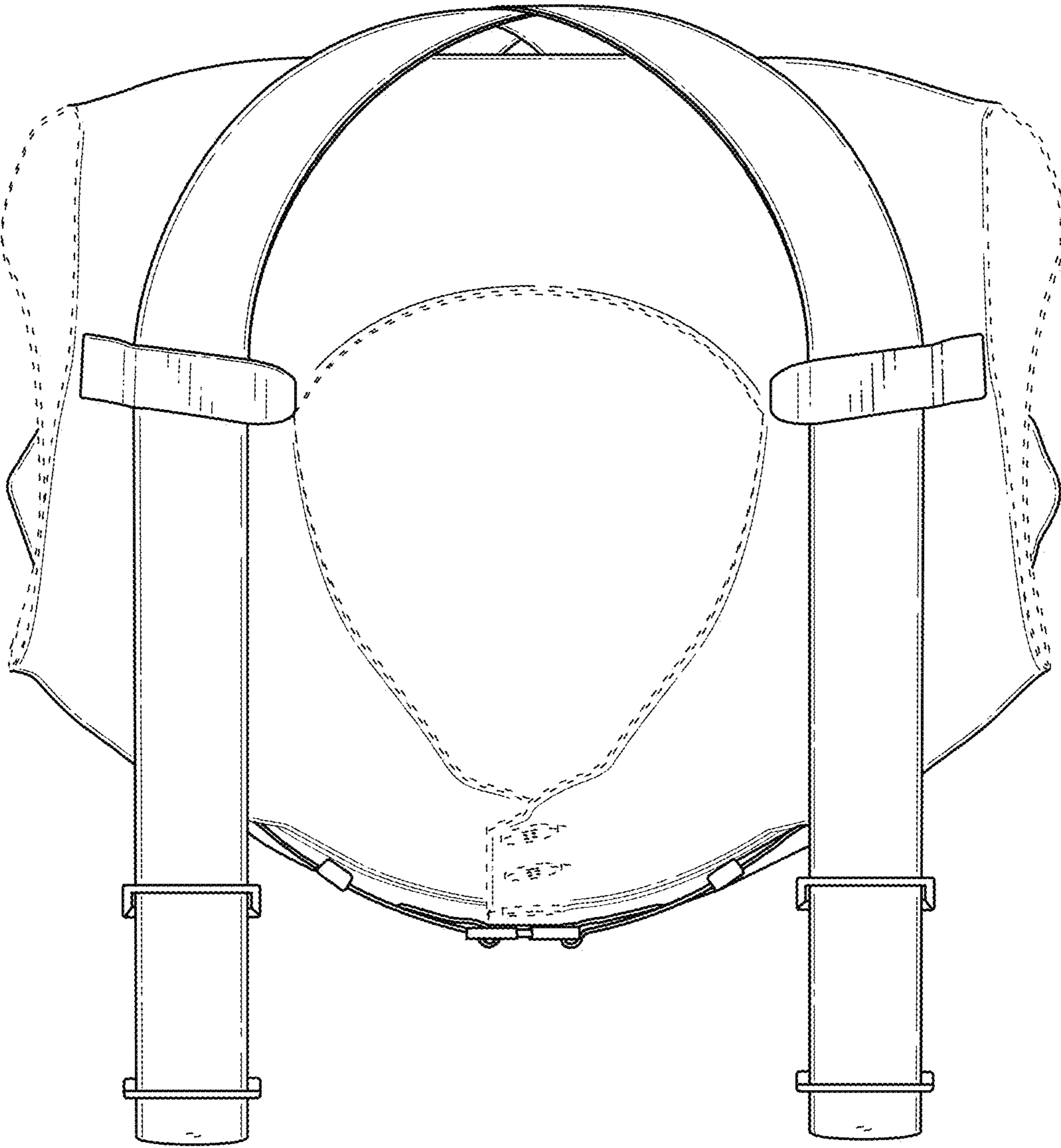

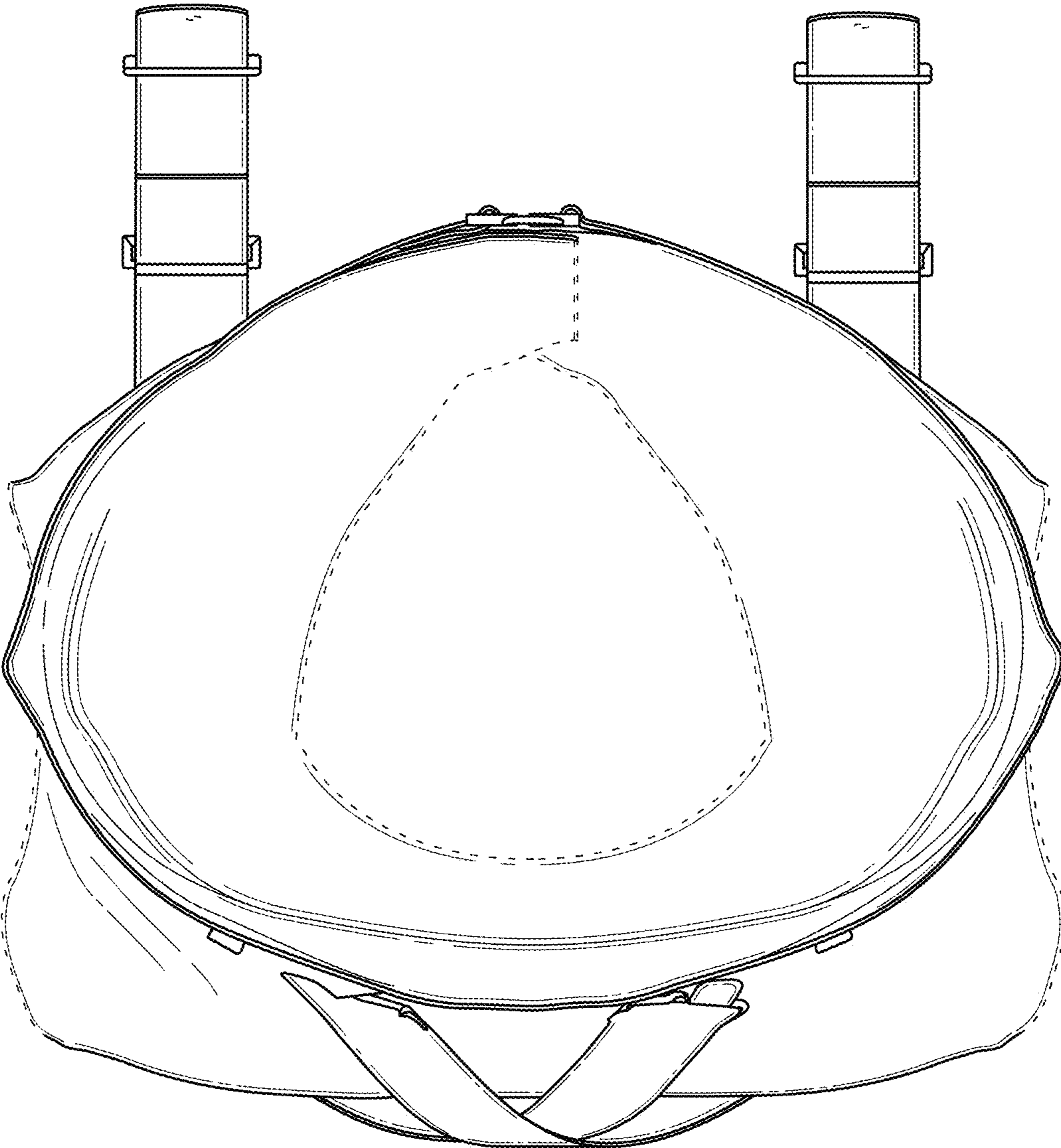

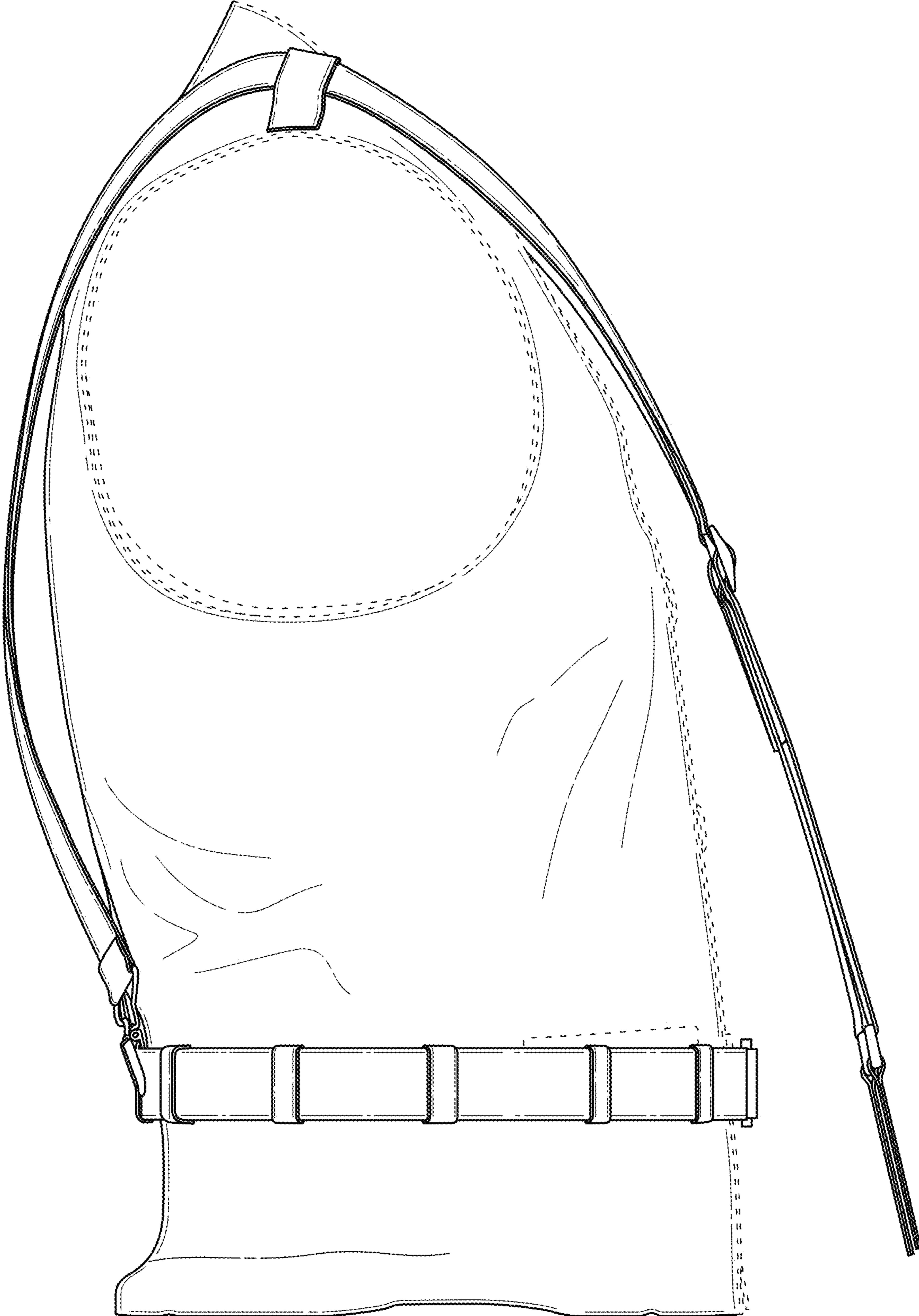

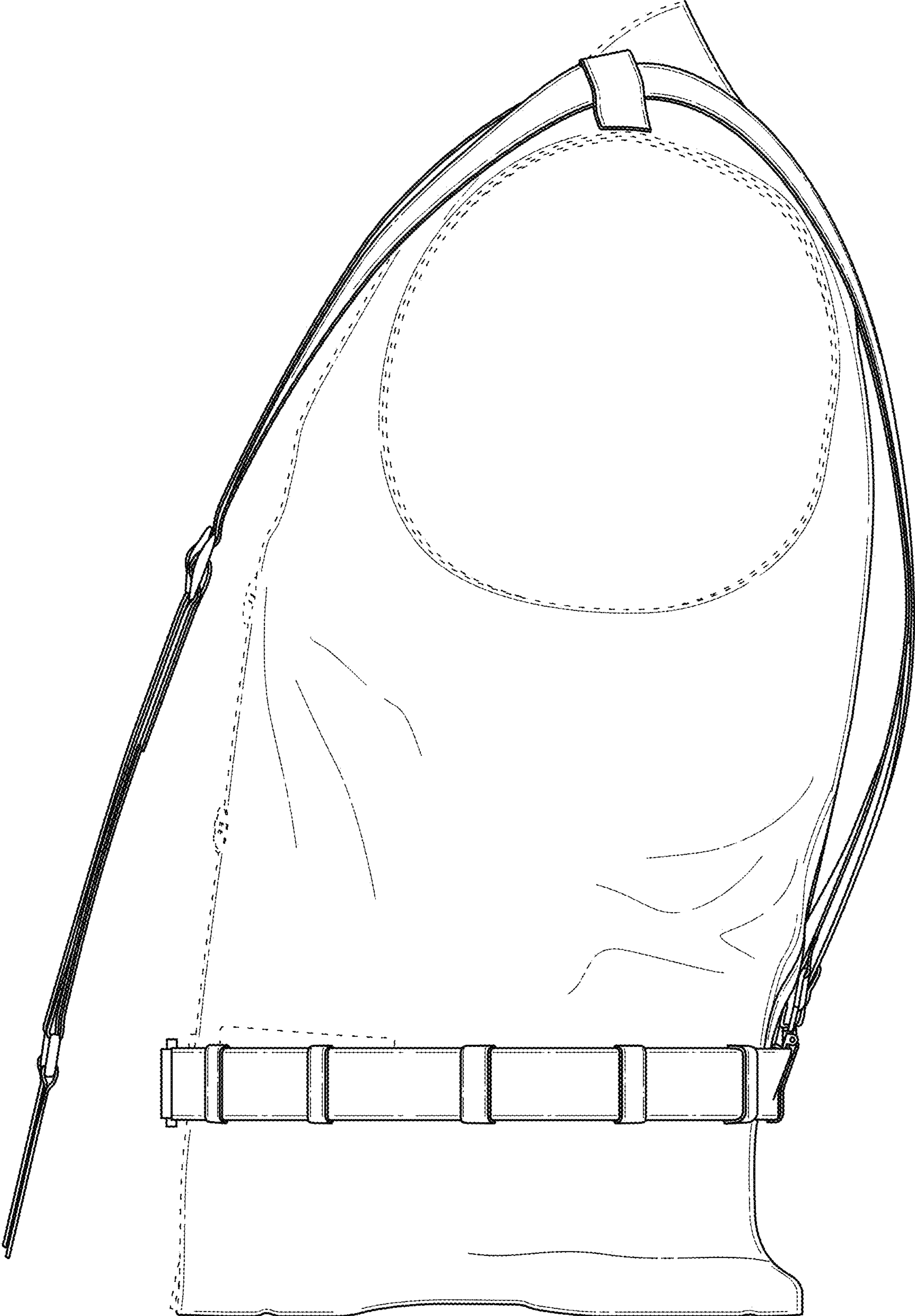

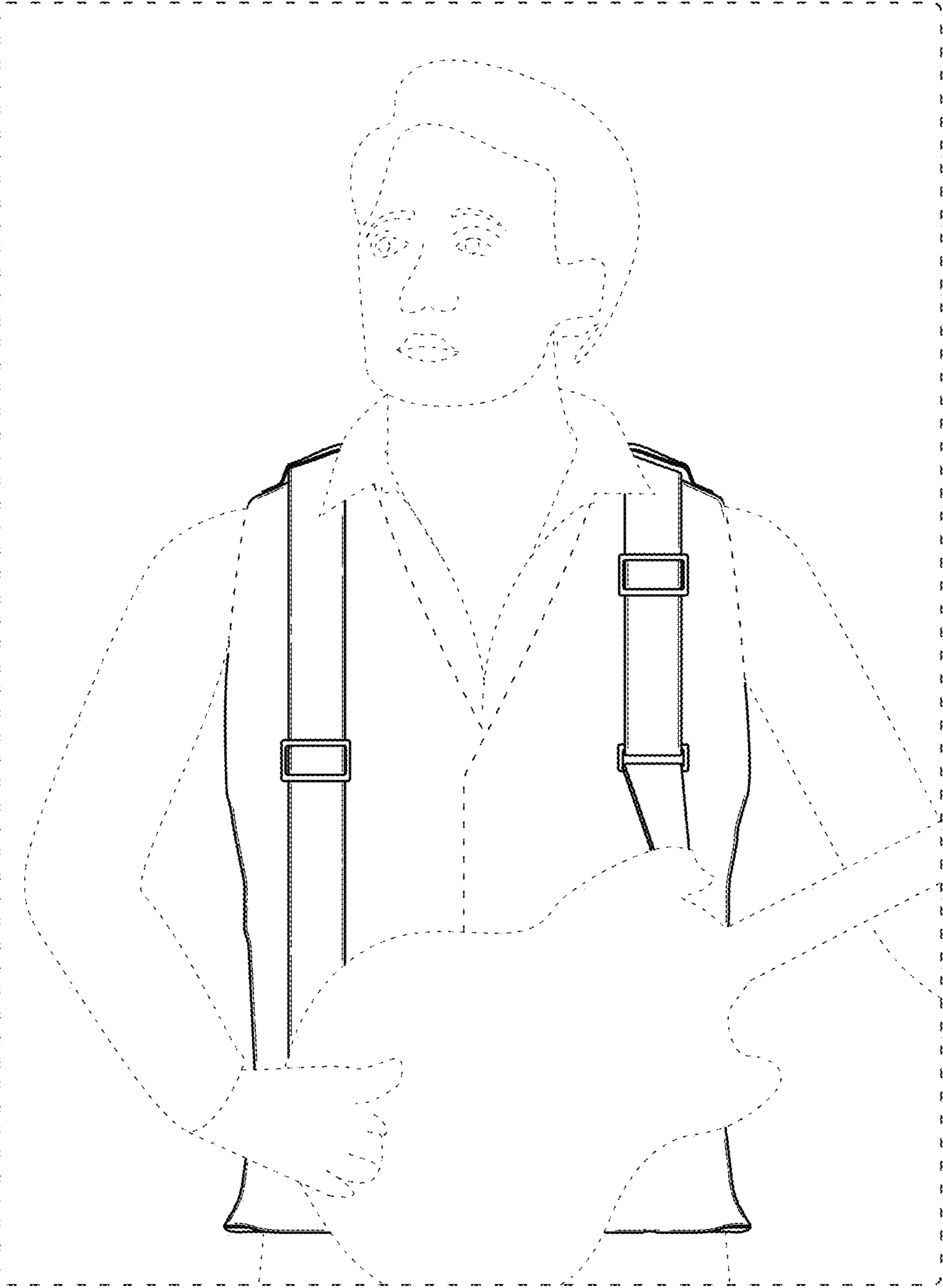
