The ornamental design for a shoe as shown and described.

DESCRIPTION

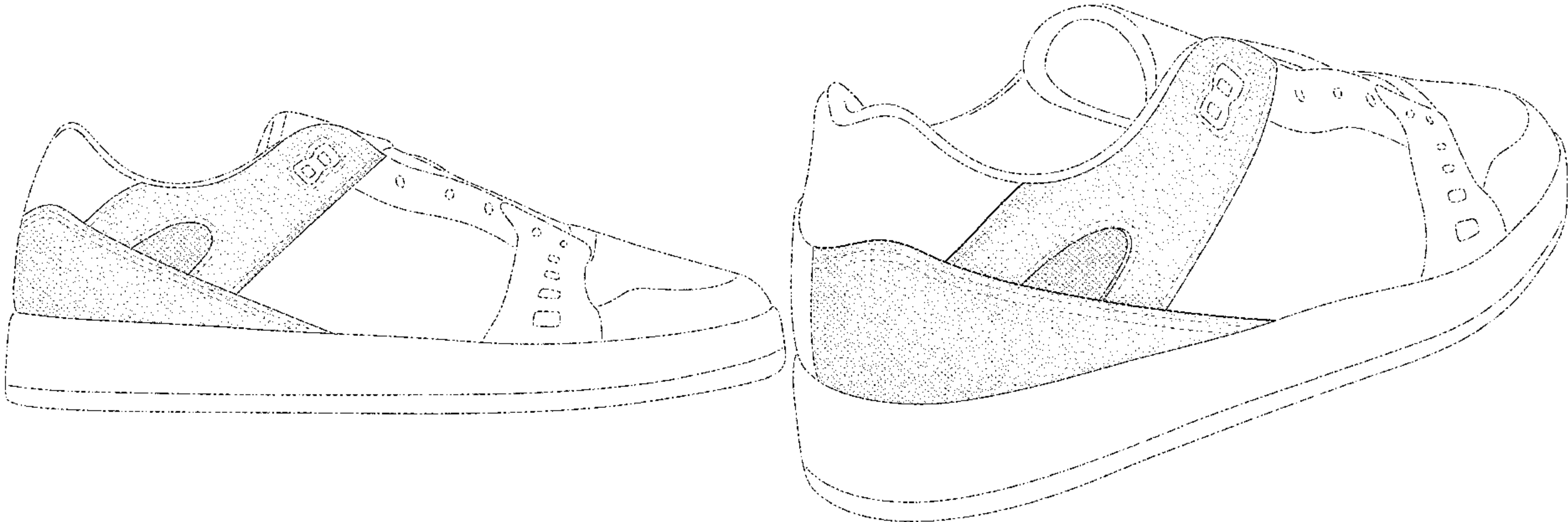
FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 2 is a side view thereof; and,

FIG. 3 is a rear perspective view thereof.

The uneven-length broken line immediately adjacent to the rear of the shaded area defines the bound of the claimed design and forms no part thereof. The uneven-length broken lines showing the hour-glass shaped element forms no part of the claimed design. The even-length broken lines represent stitching that forms no part of the claimed design. The uneven-length broken lines depicting the remainder of the shoe form no part of the claimed design.

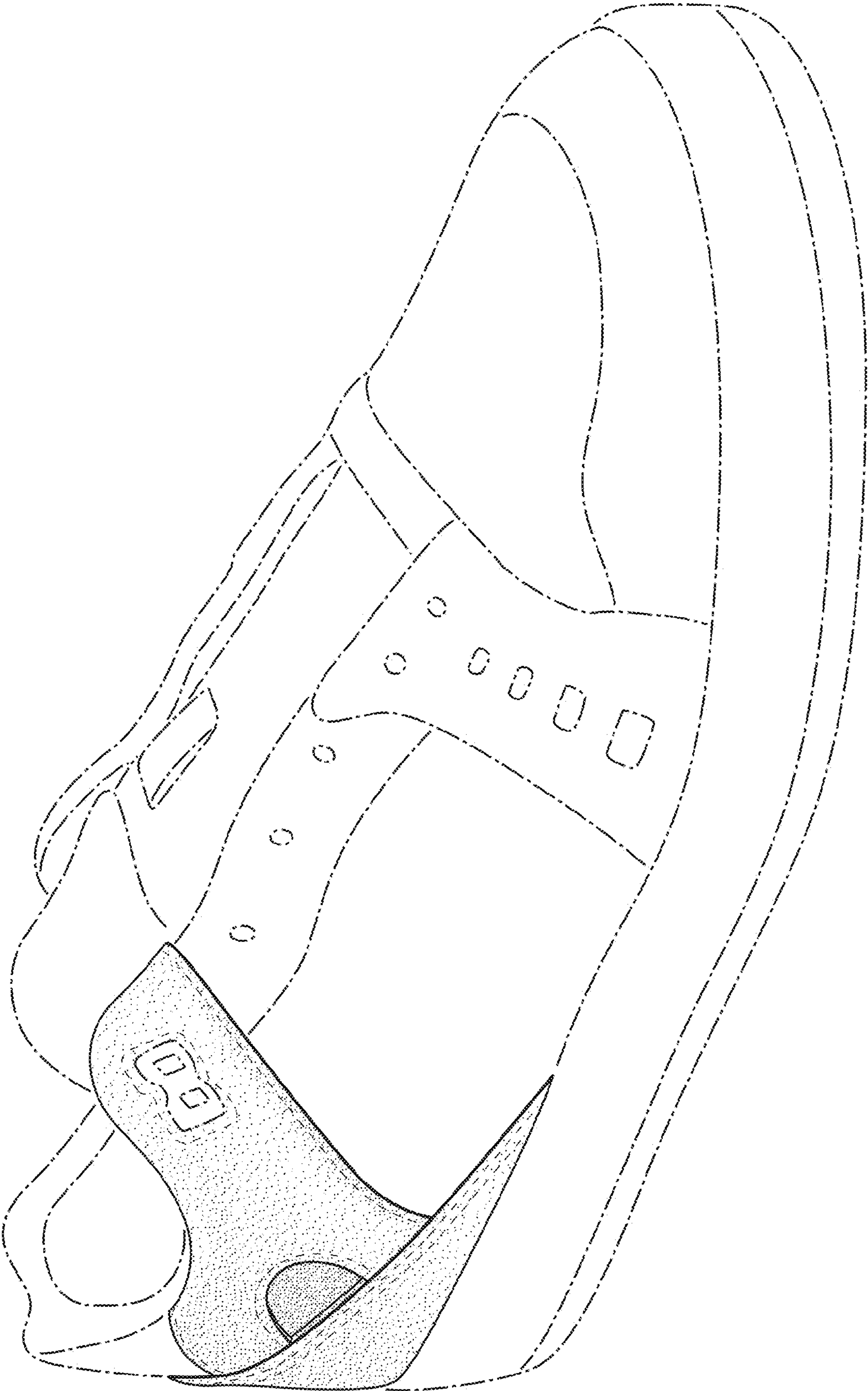

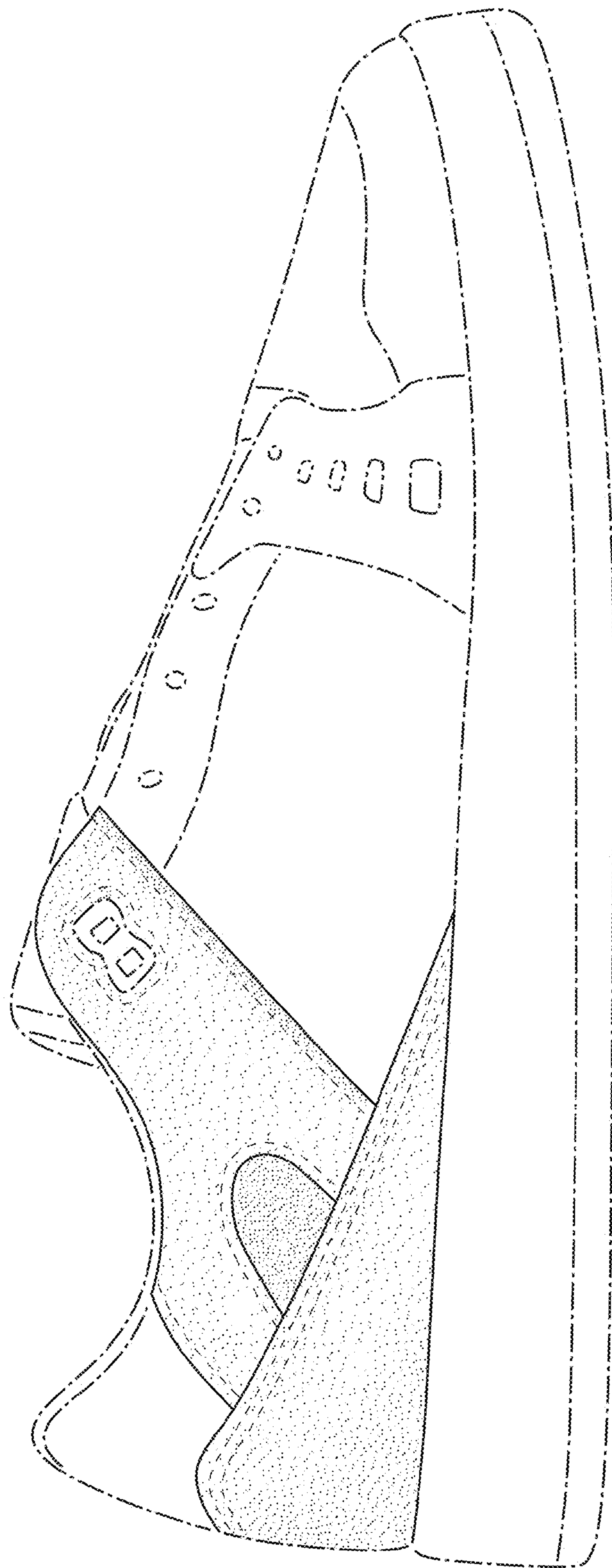

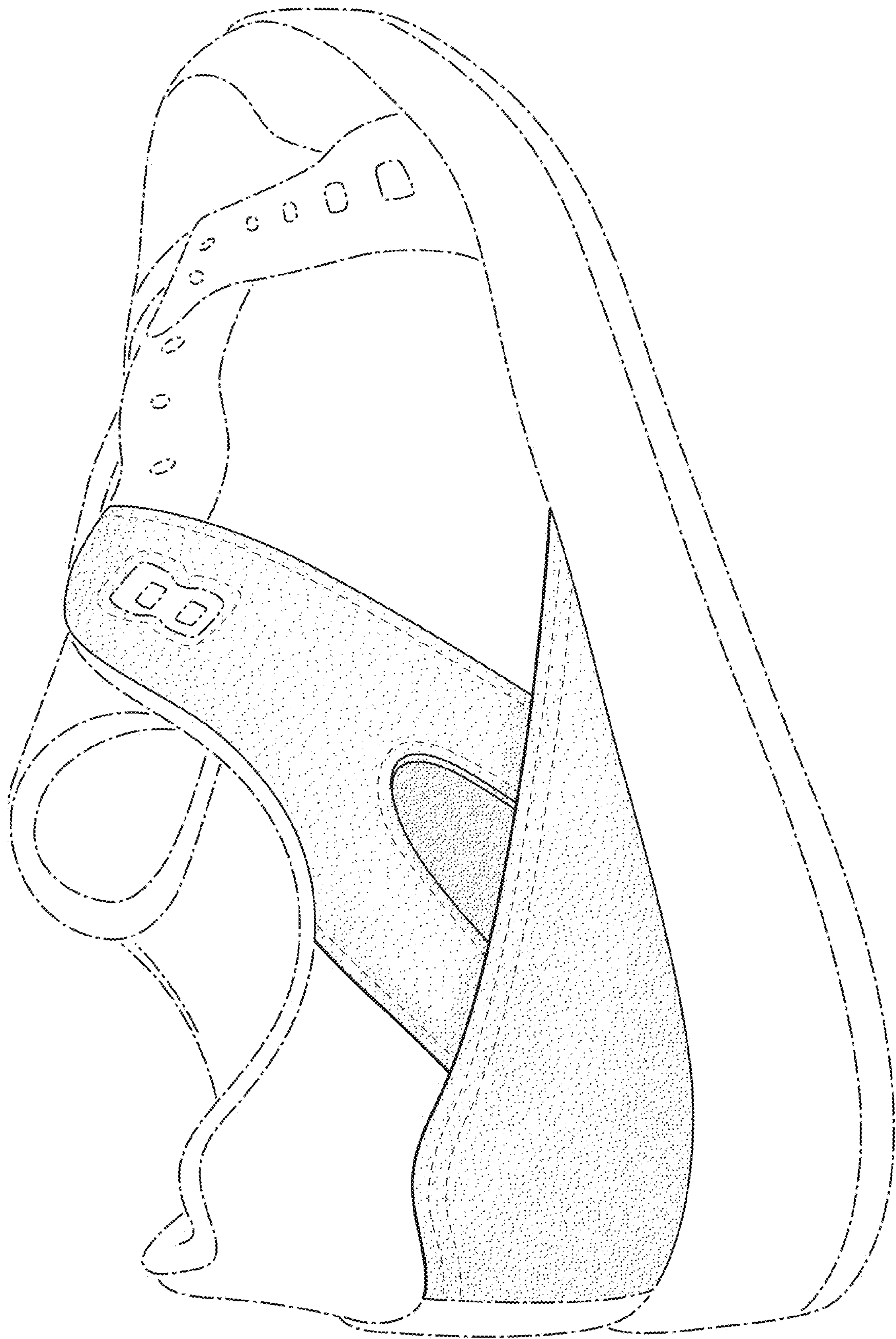
