(57) **CLAIM**

The ornamental design for a case for handheld brushes and tools, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom perspective view of the case for handheld brushes and tools;

FIG. 2 is a front elevation view of the case for handheld brushes and tools;

FIG. 3 is a back elevation view of the case for handheld brushes and tools;

FIG. 4 is a left side elevation view of the case for handheld brushes and tools;

FIG. 5 is a right side elevation view of the case for handheld brushes and tools;

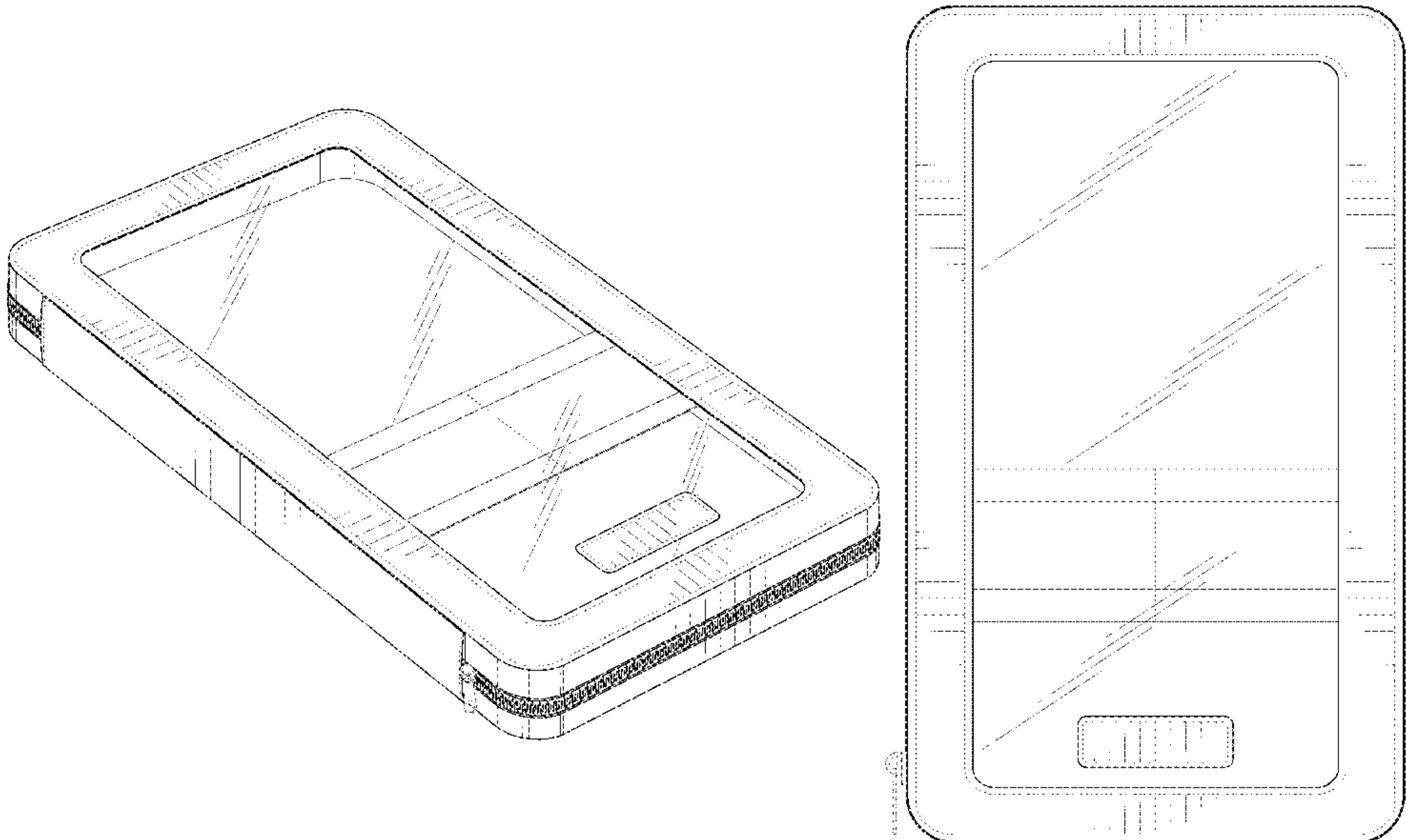
FIG. 6 is a top plan view of the case for handheld brushes and tools;

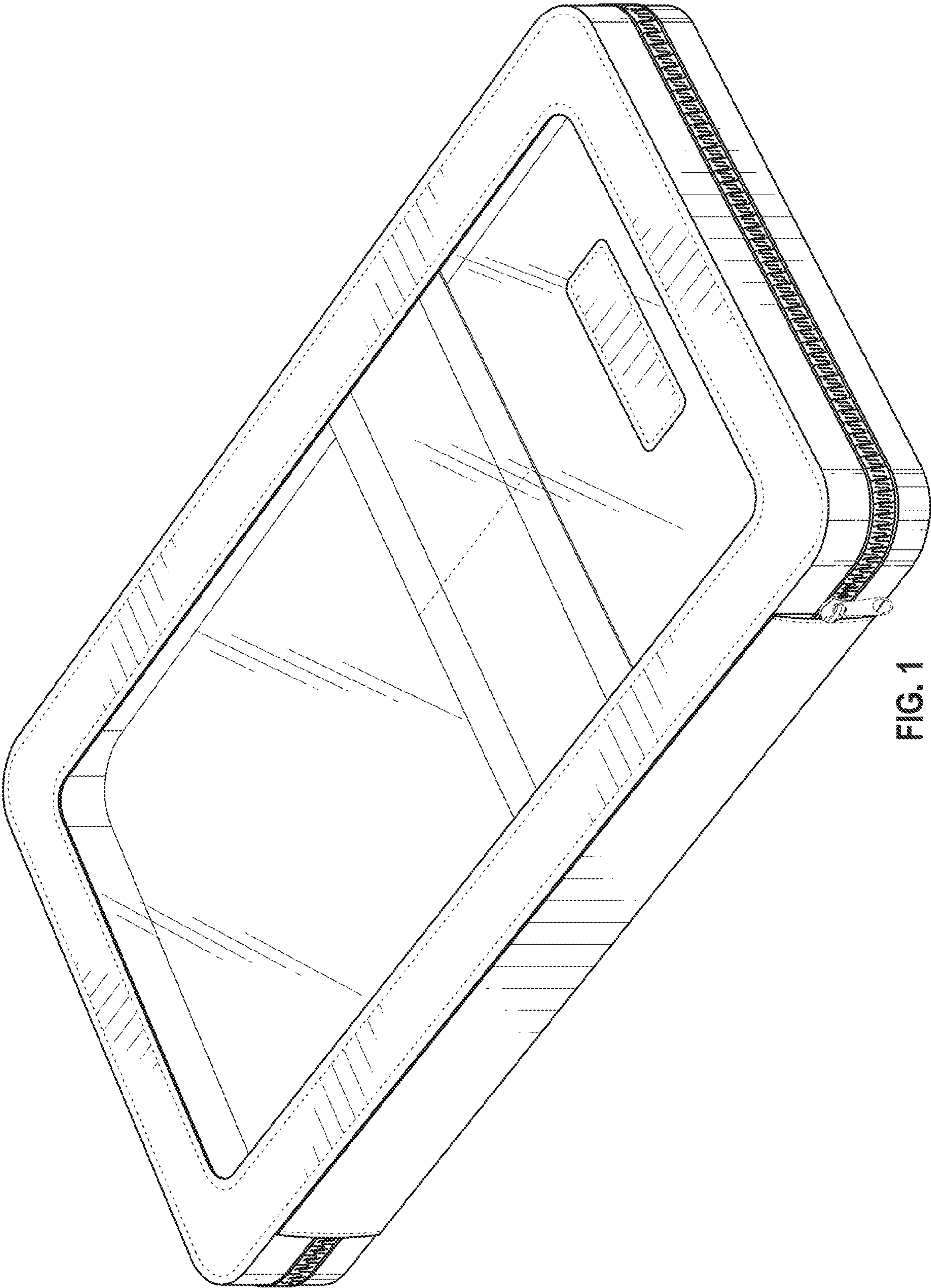

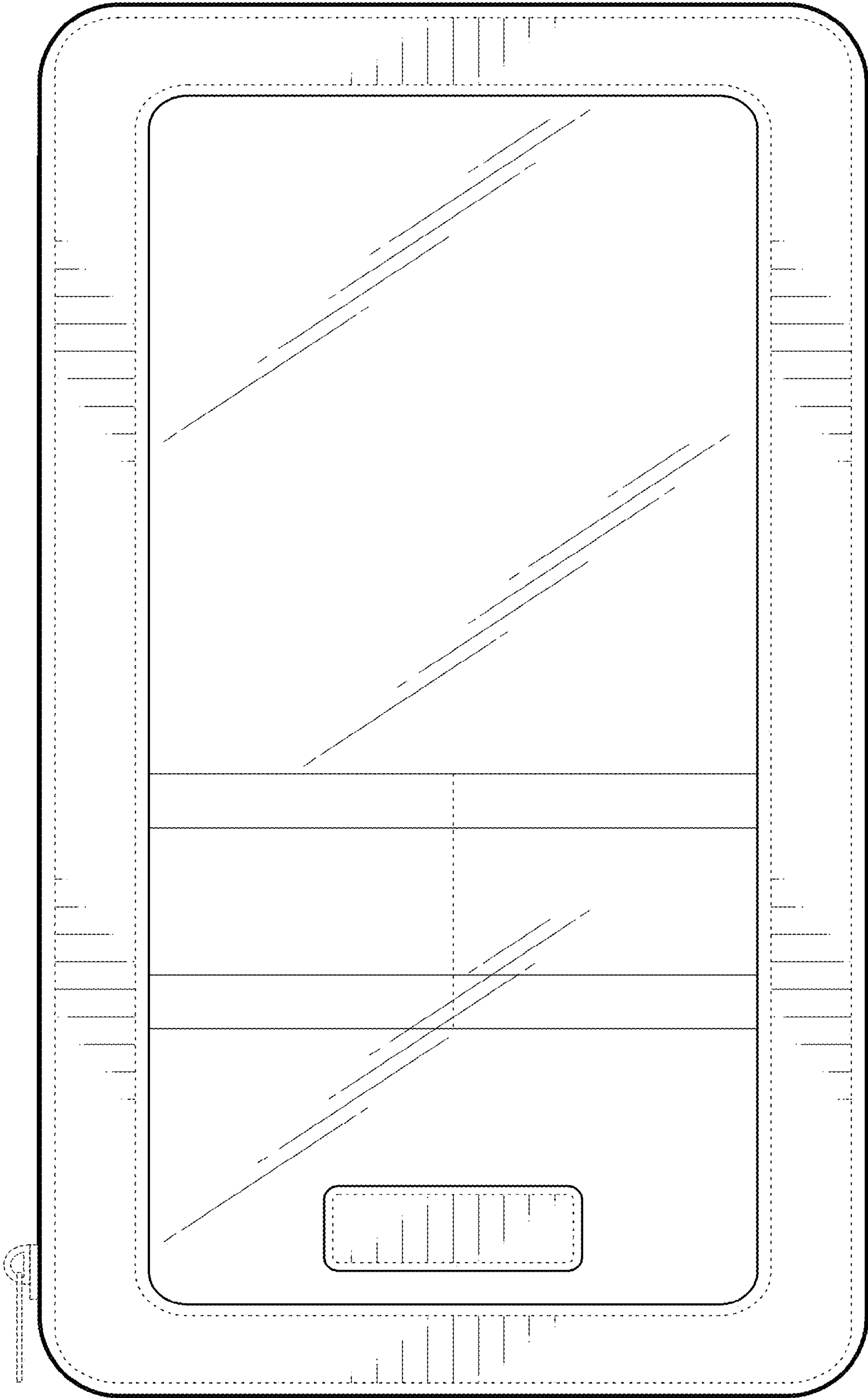

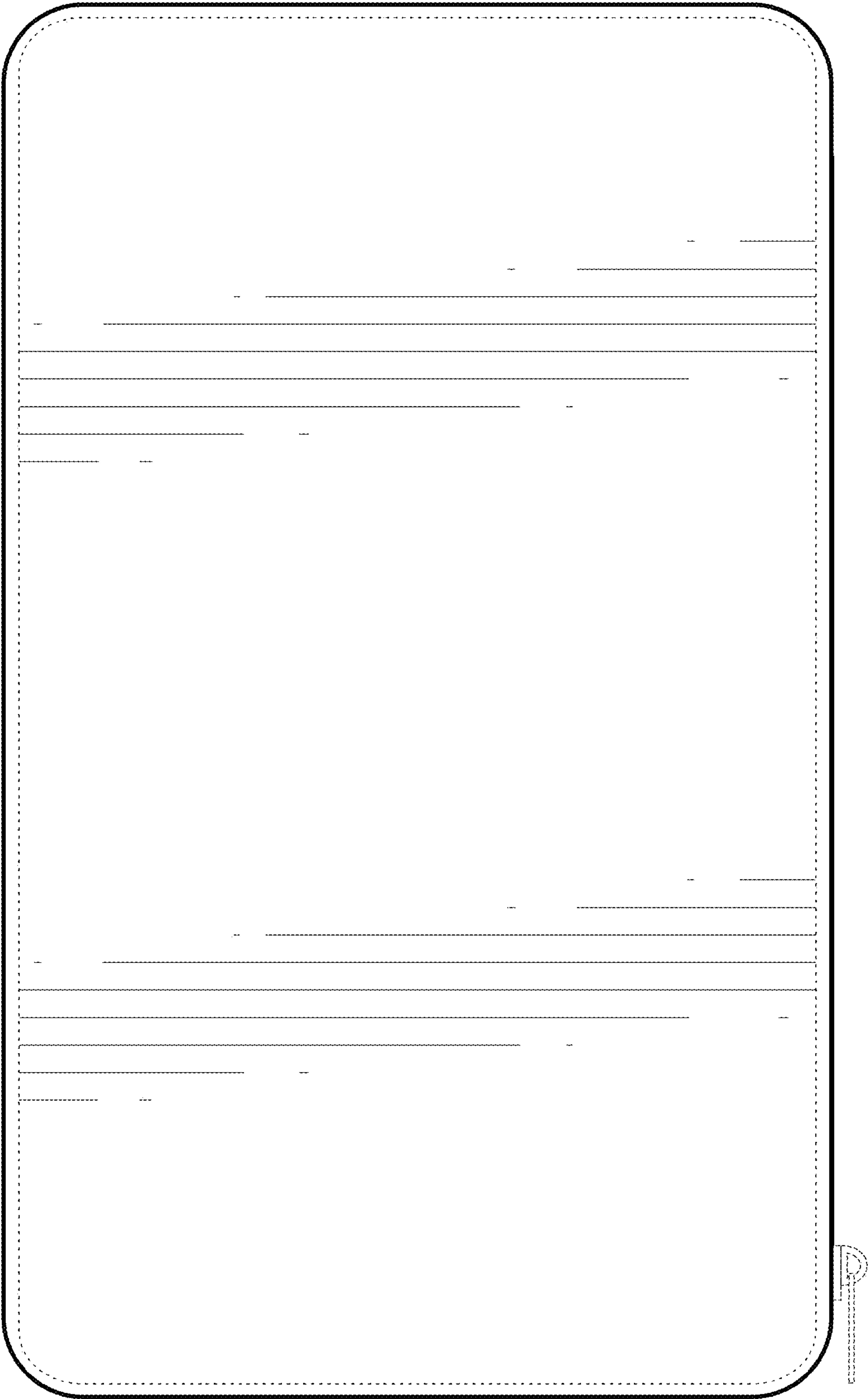

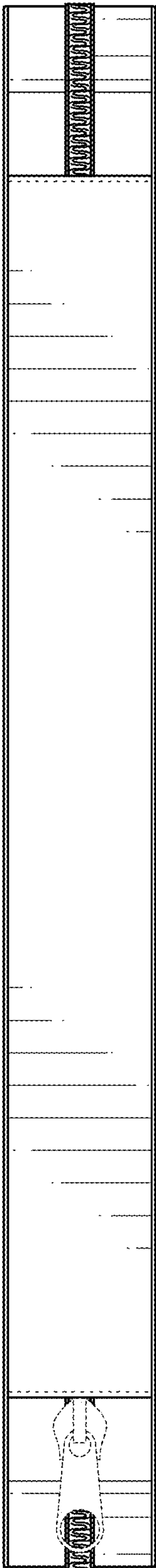

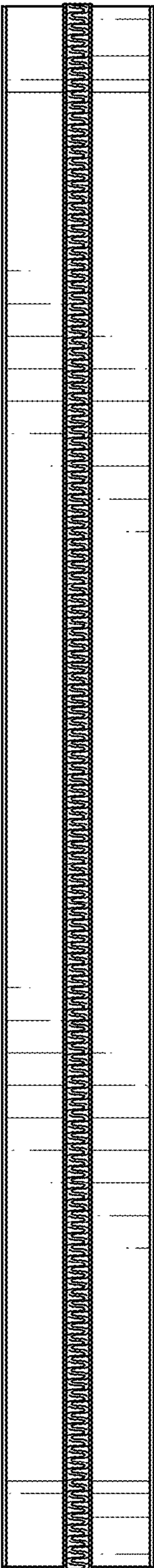

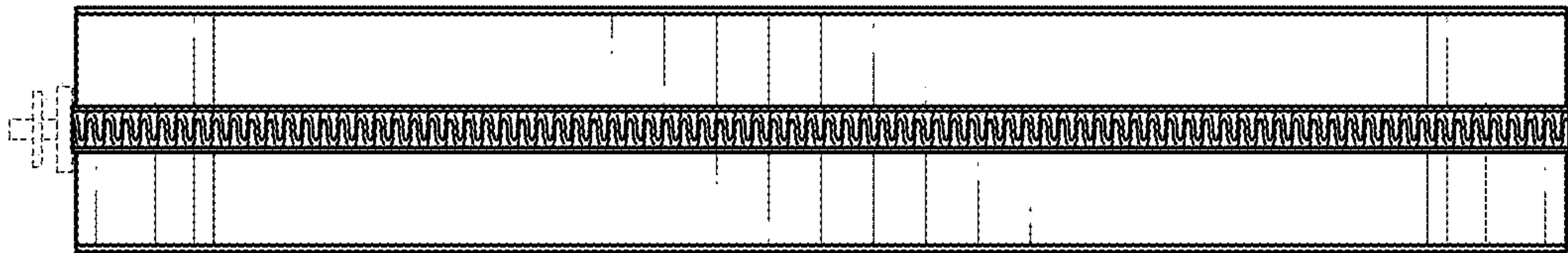

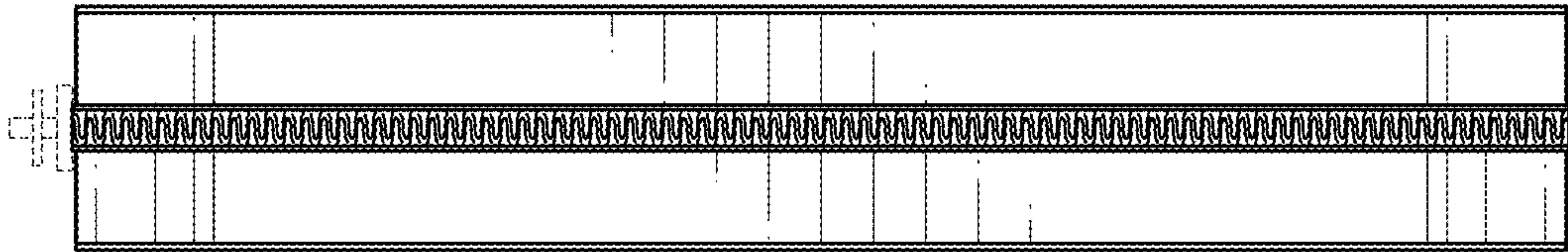

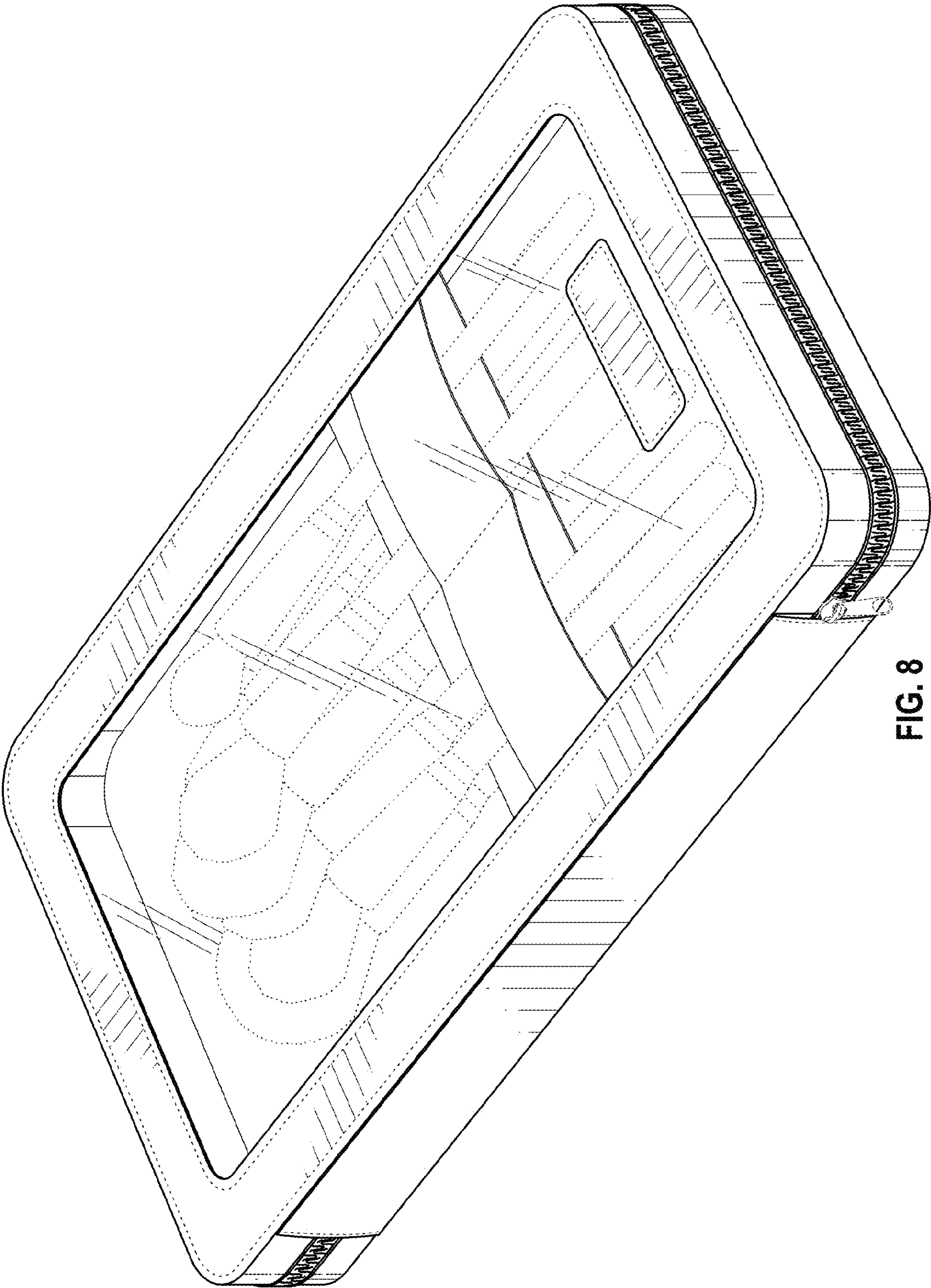
