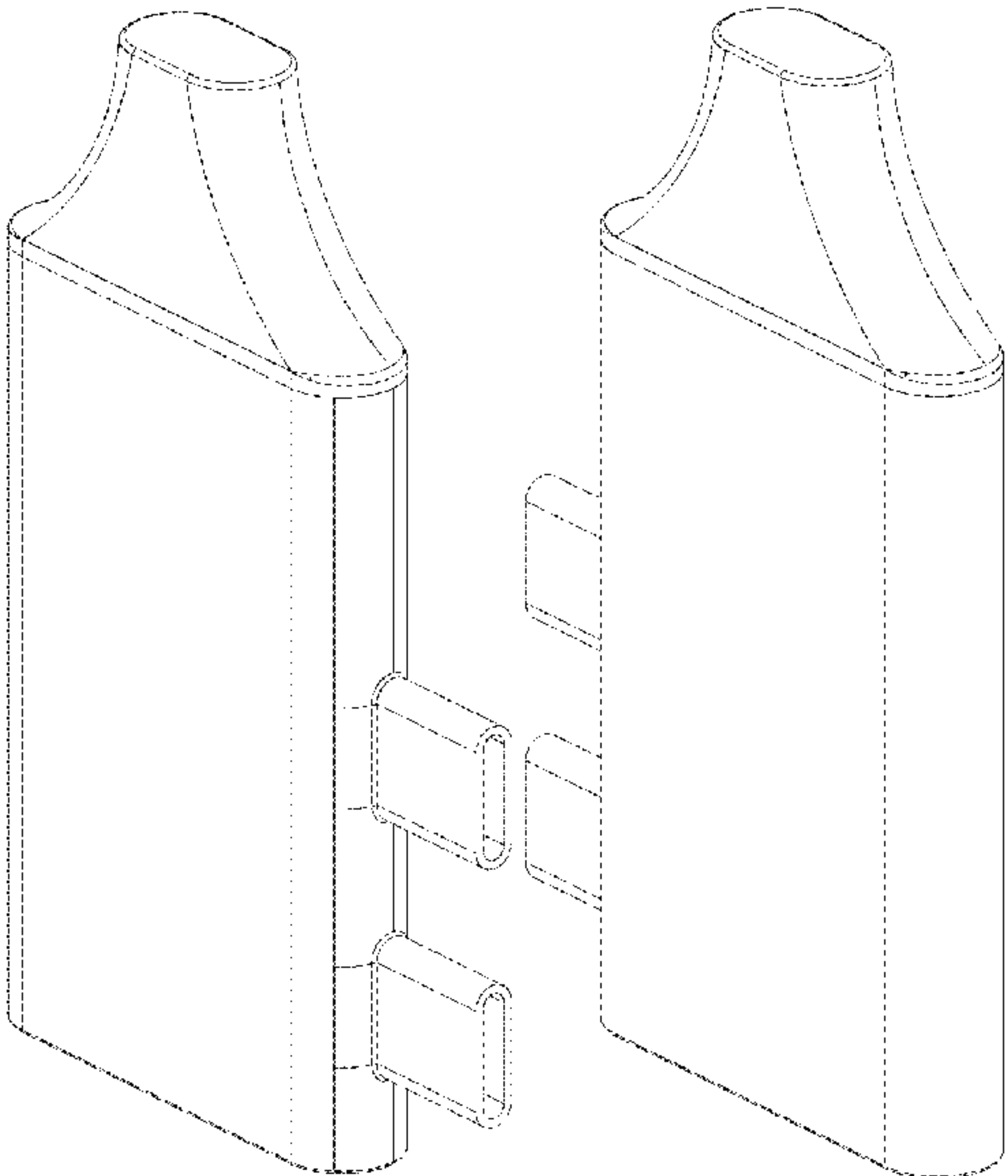
CLAIM

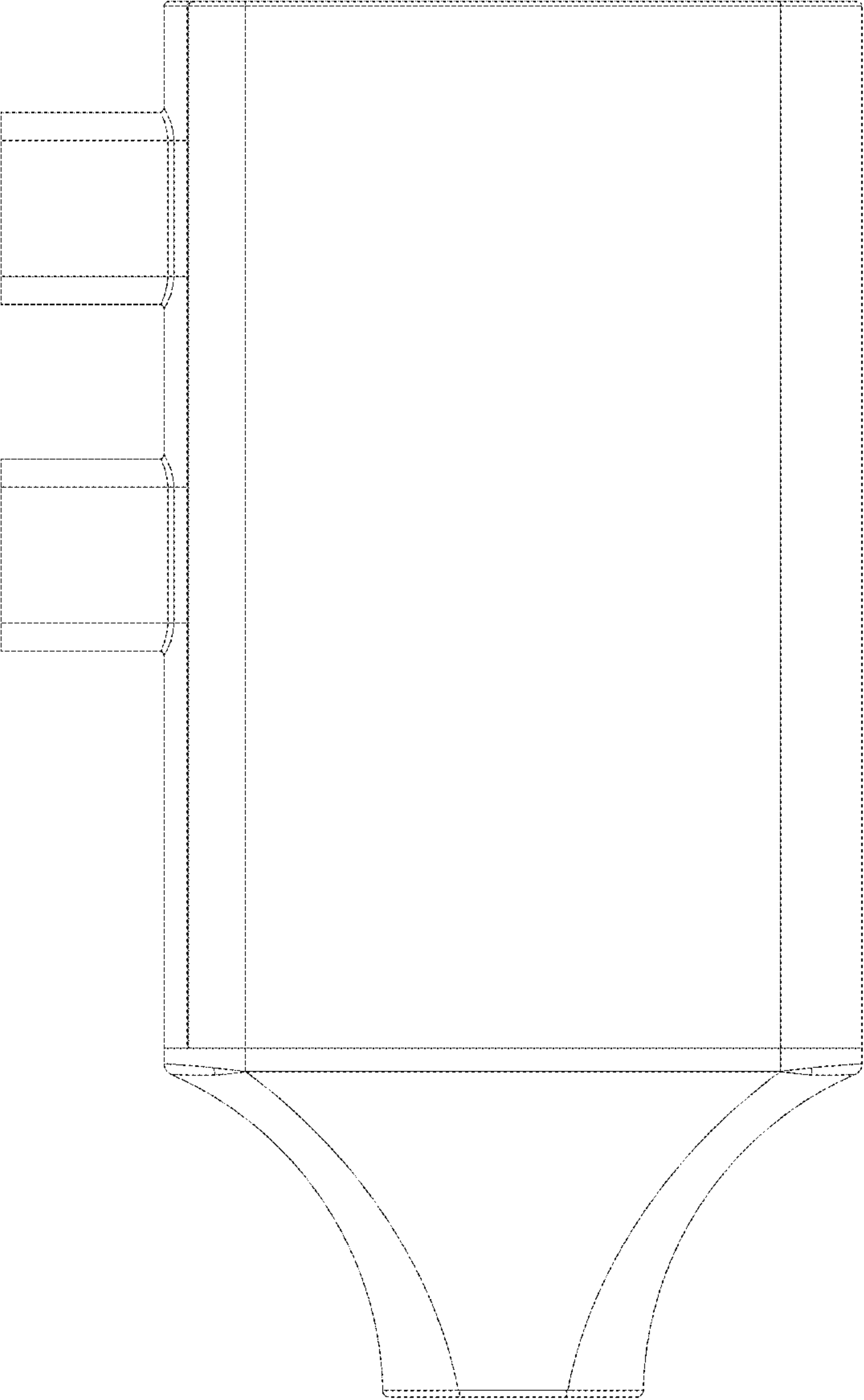

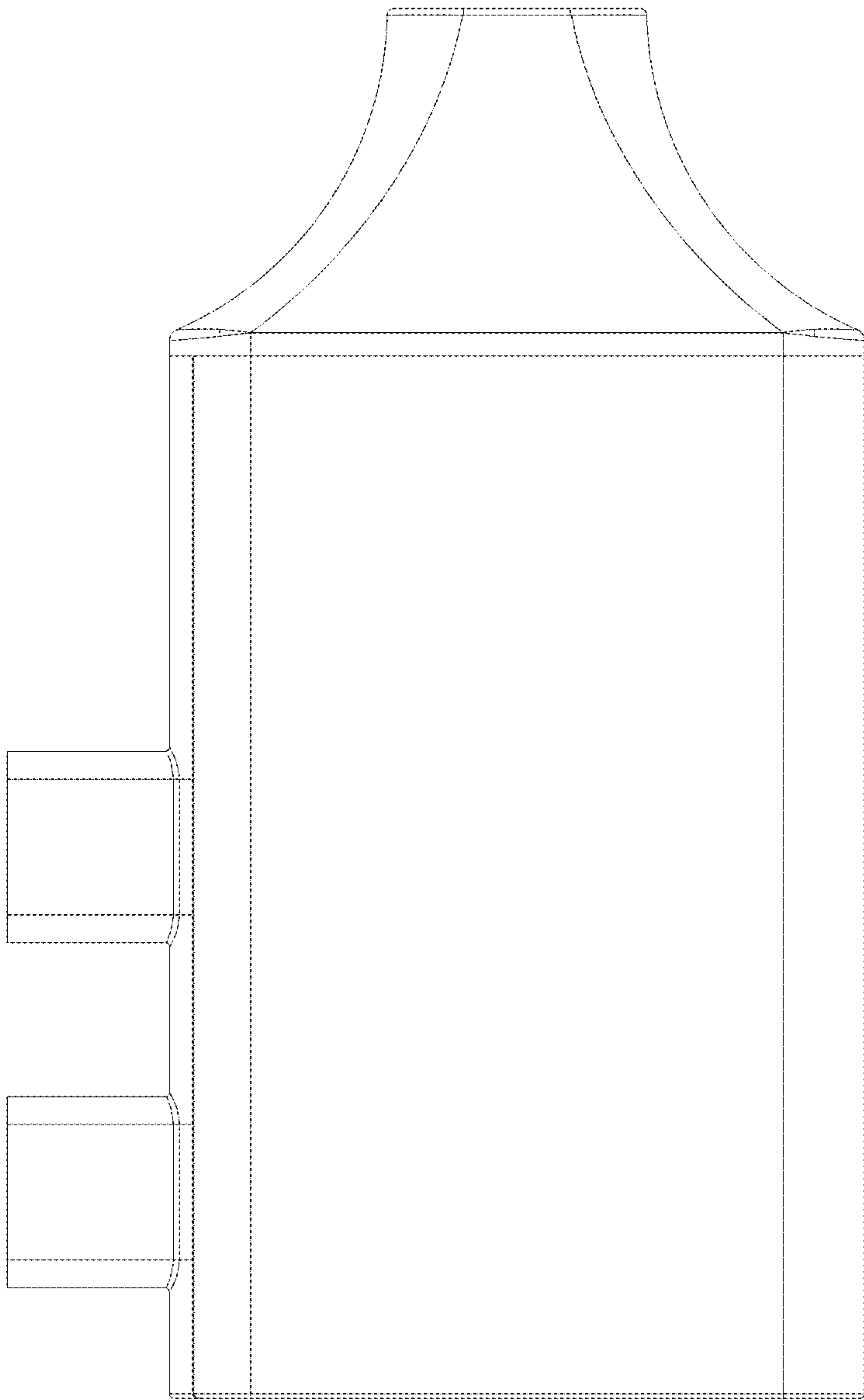

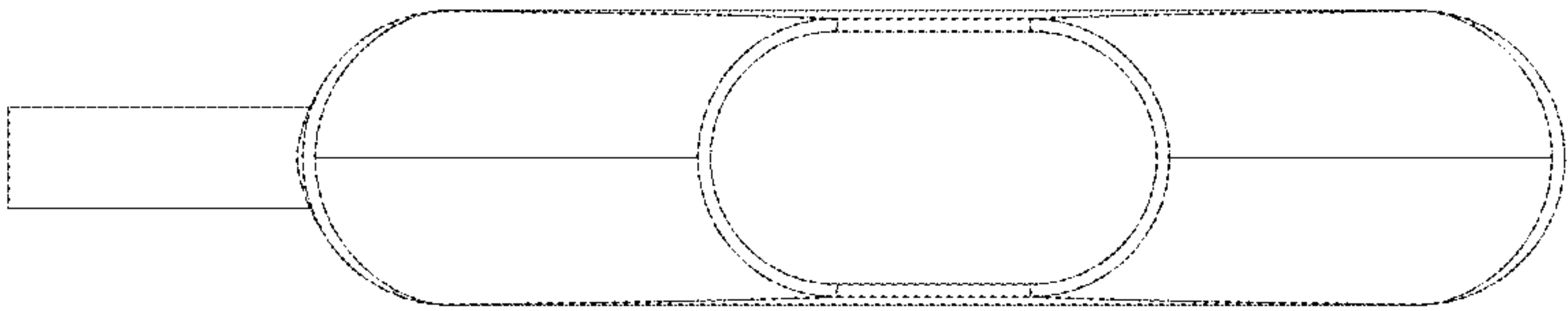

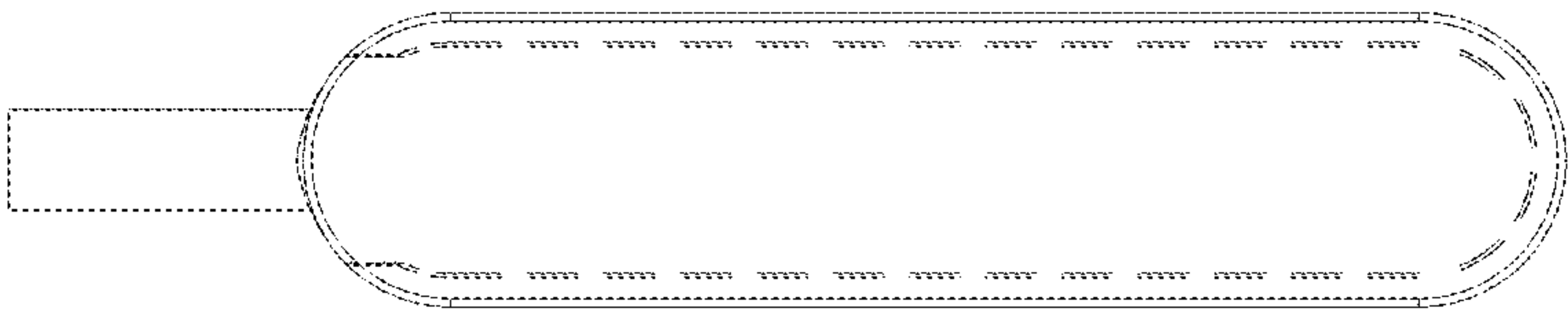

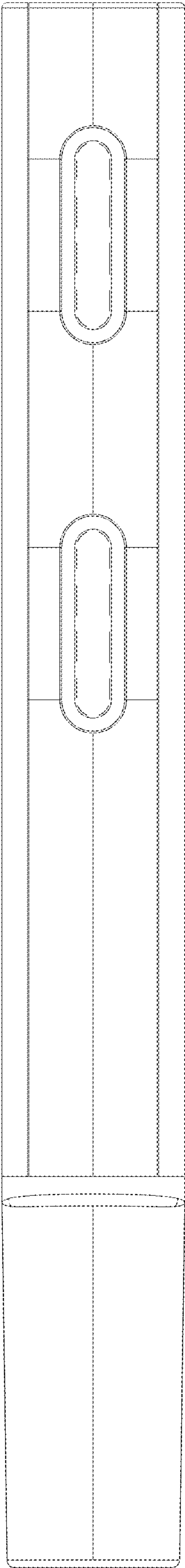

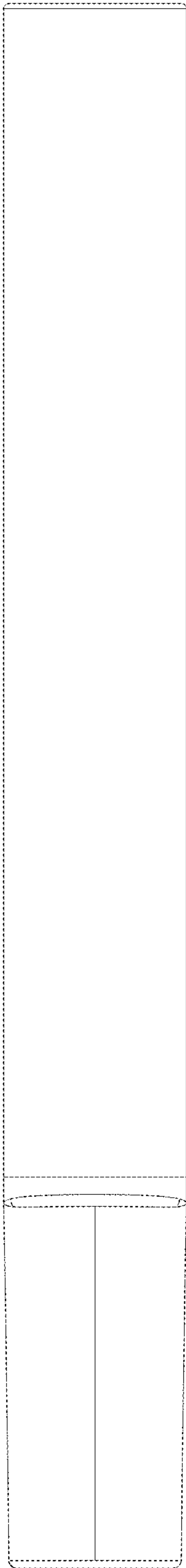

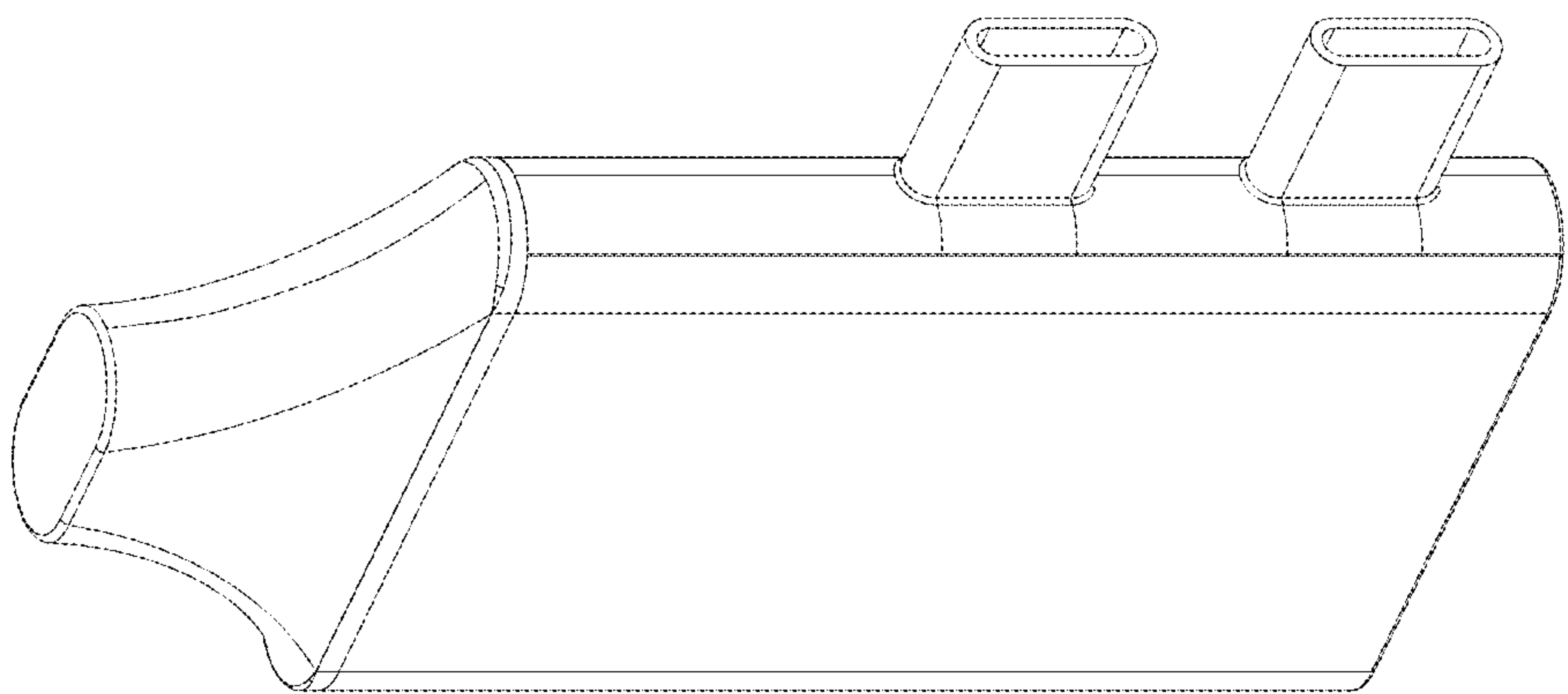

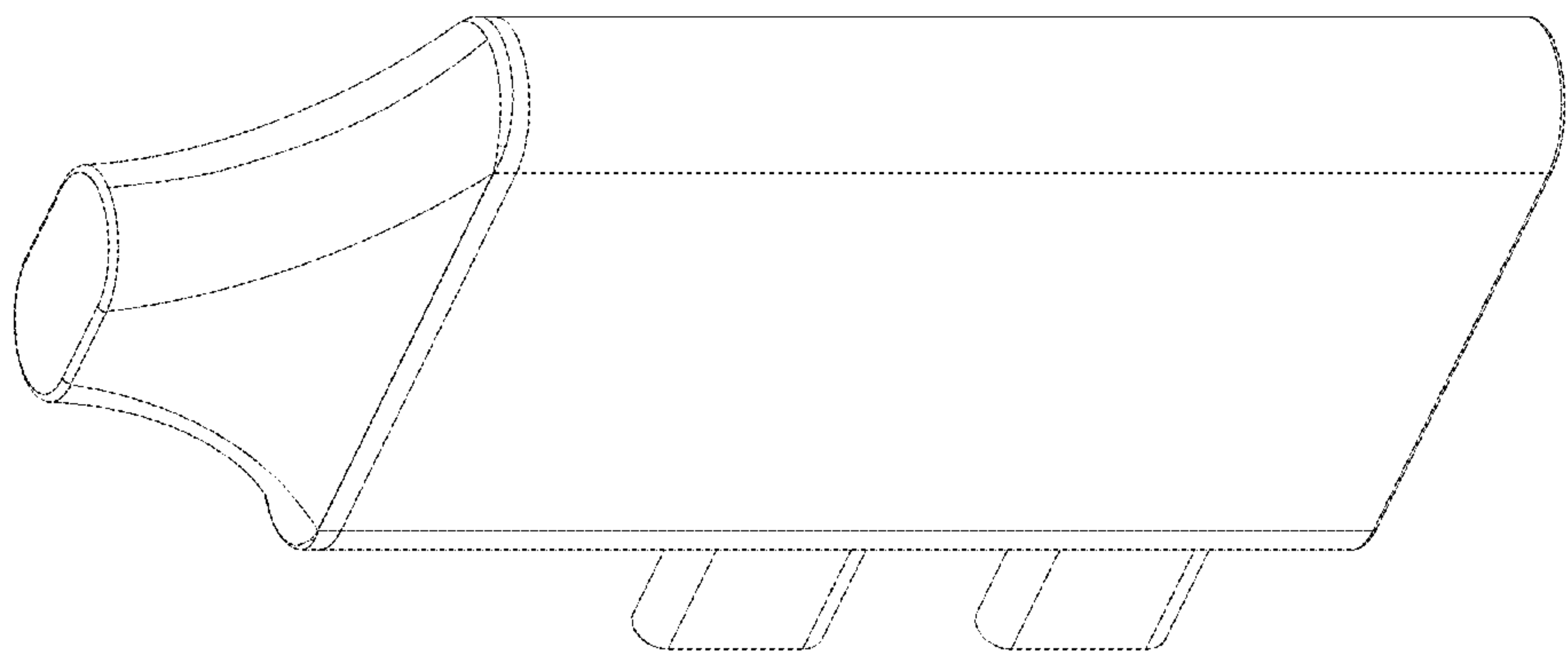
