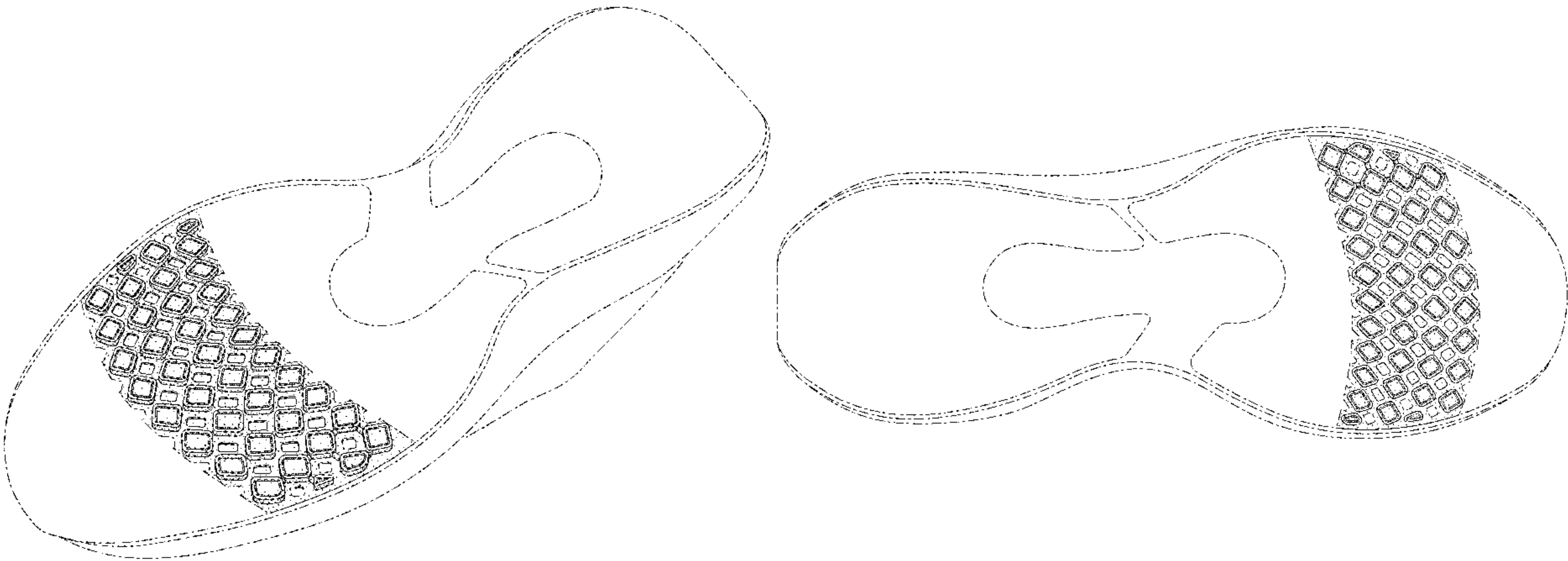
(57) CLAIM

The broken line showing of the six diamond shaped regions form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

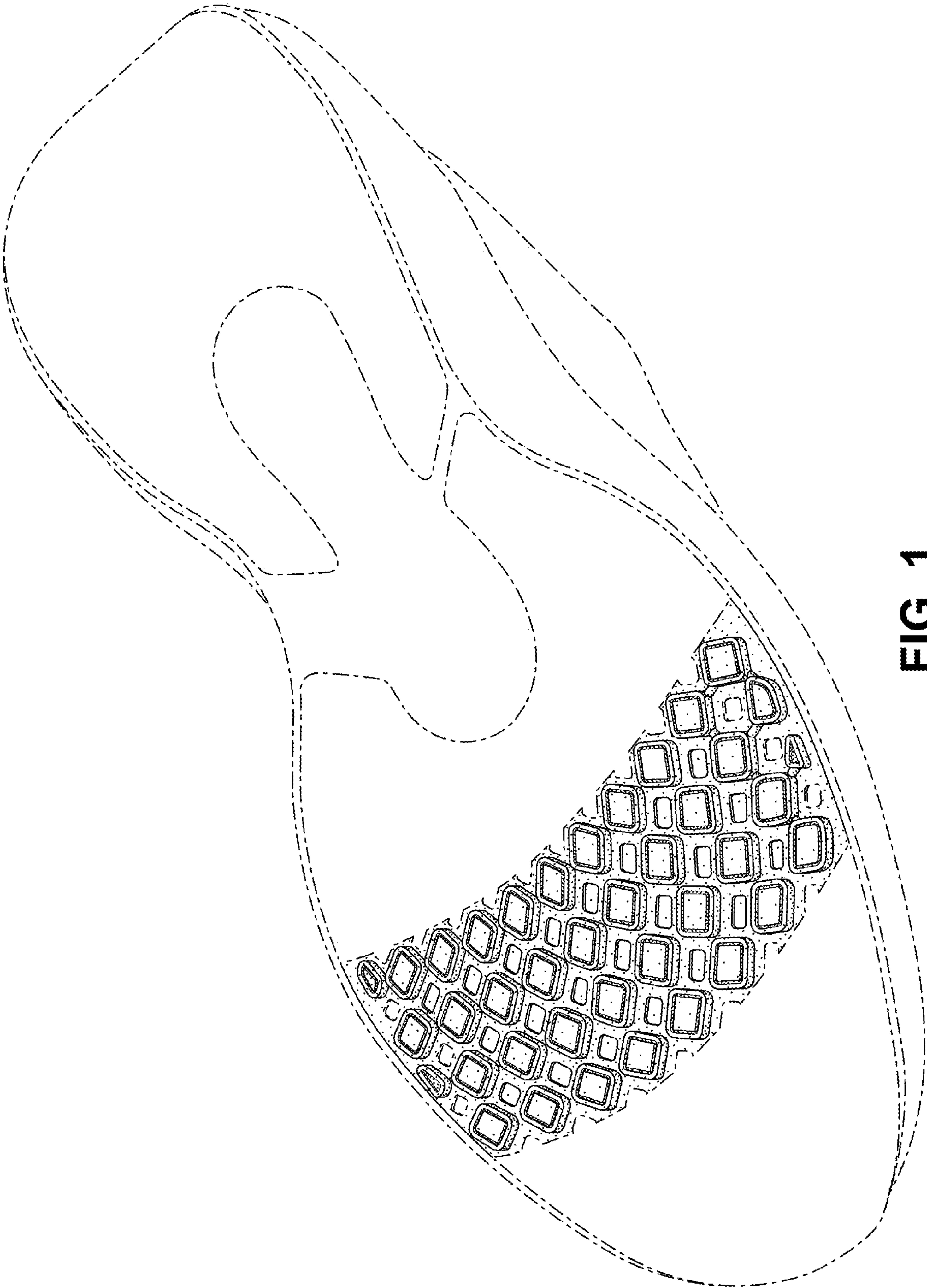

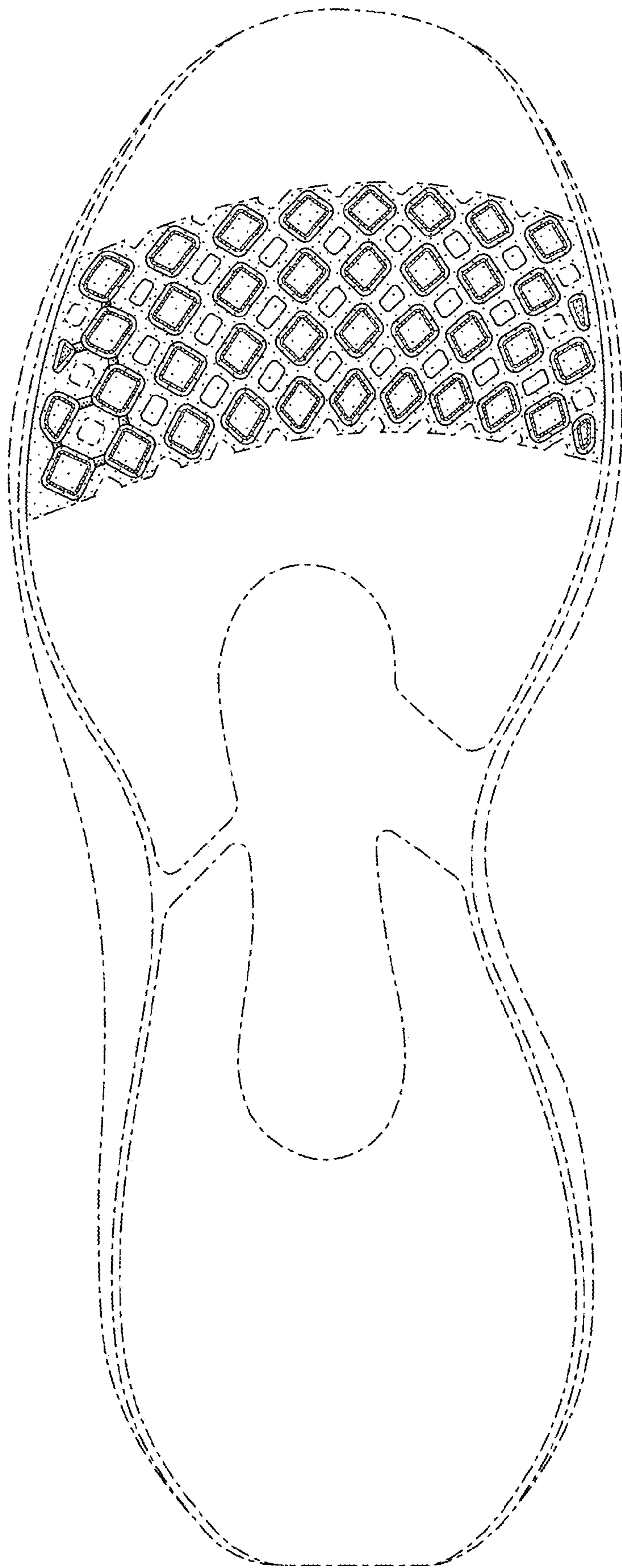

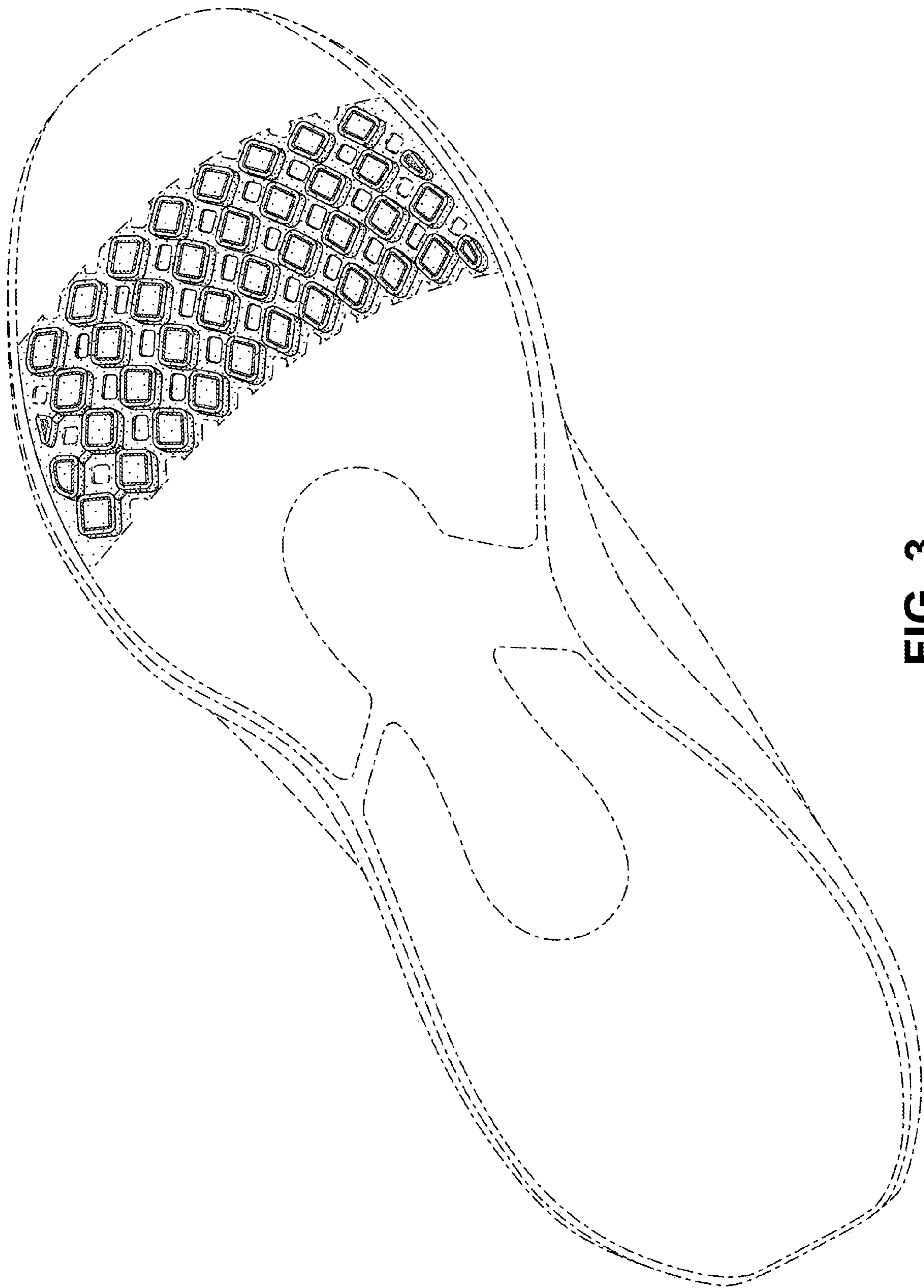
