DESCRIPTION

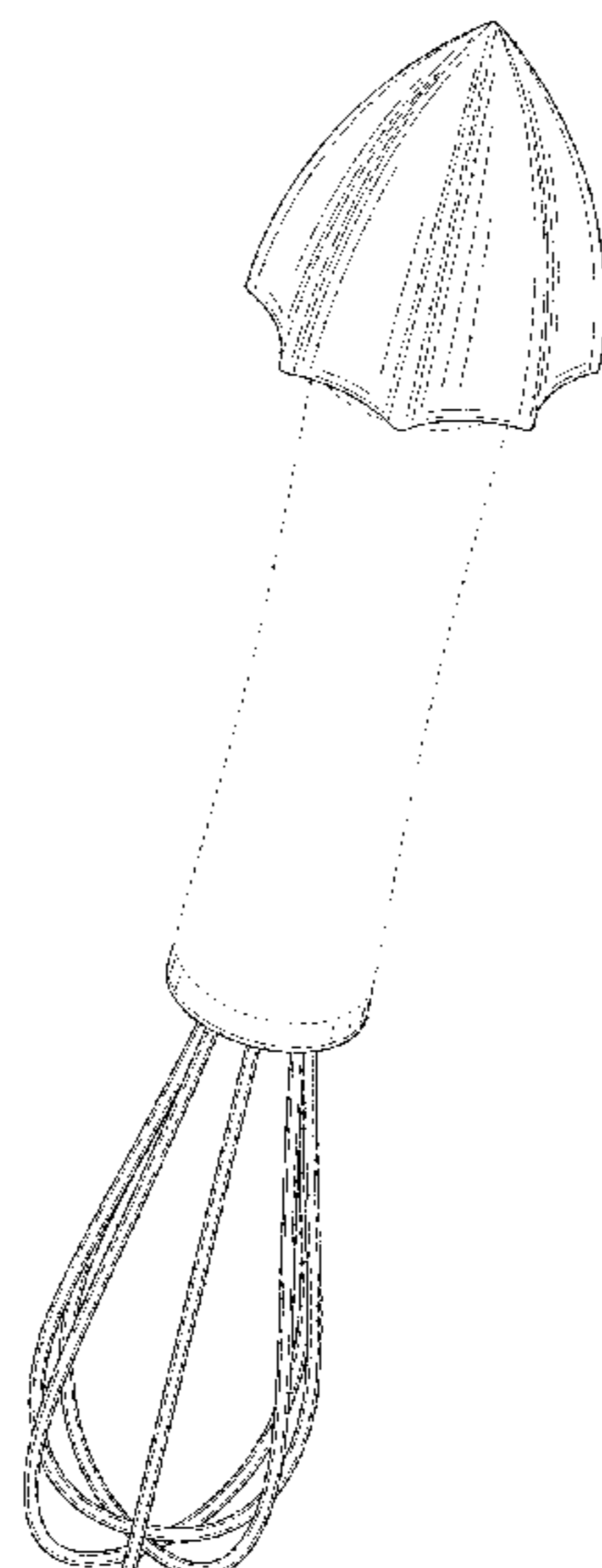
FIG. 1 is a front perspective view of the food preparation tool showing my new design.

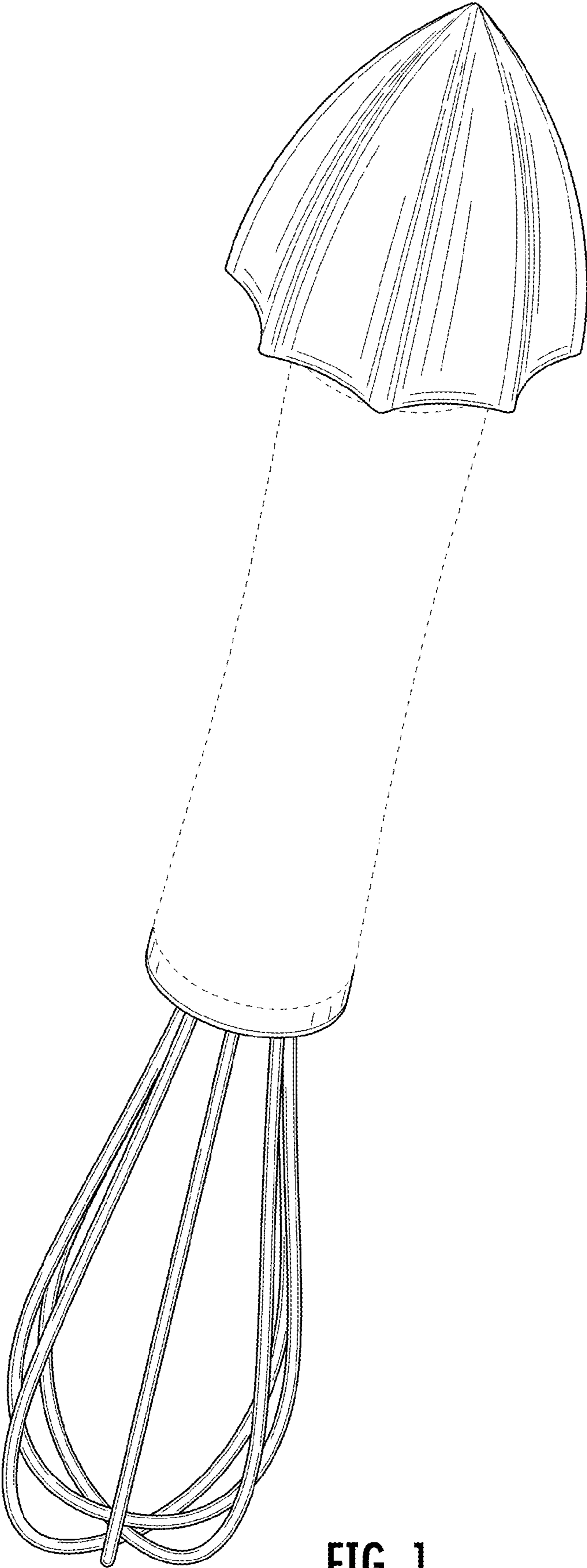

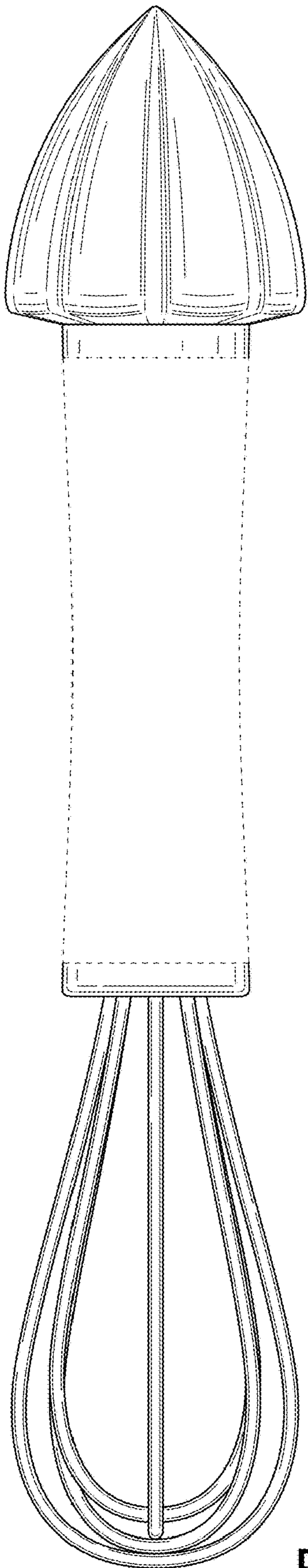

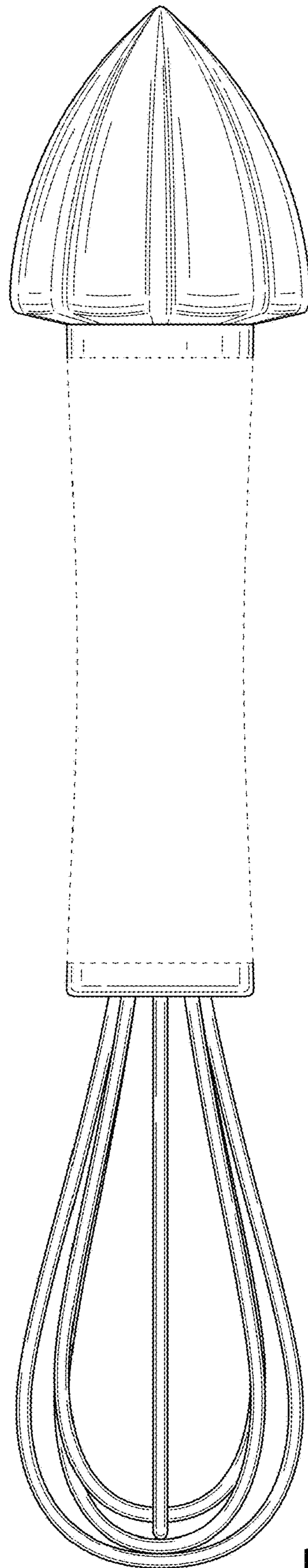

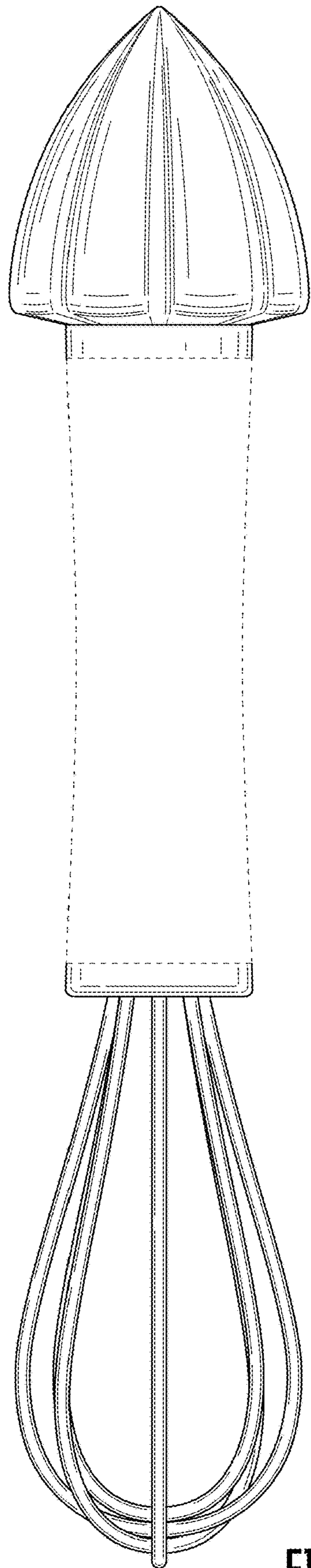

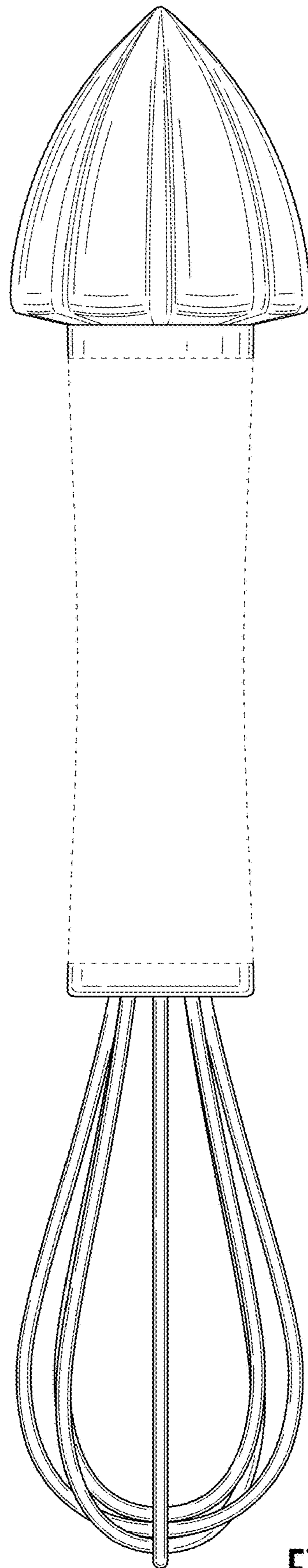

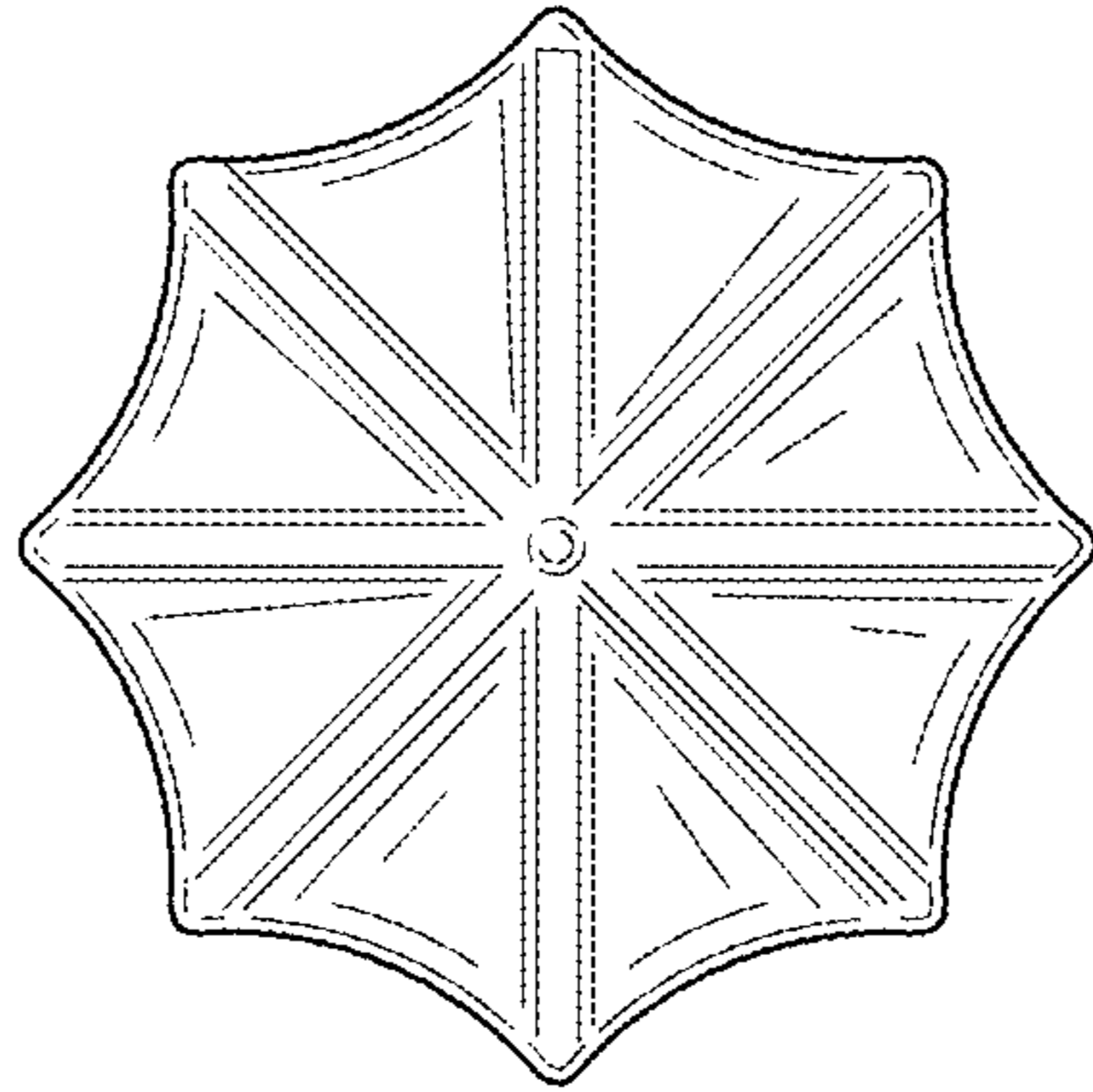

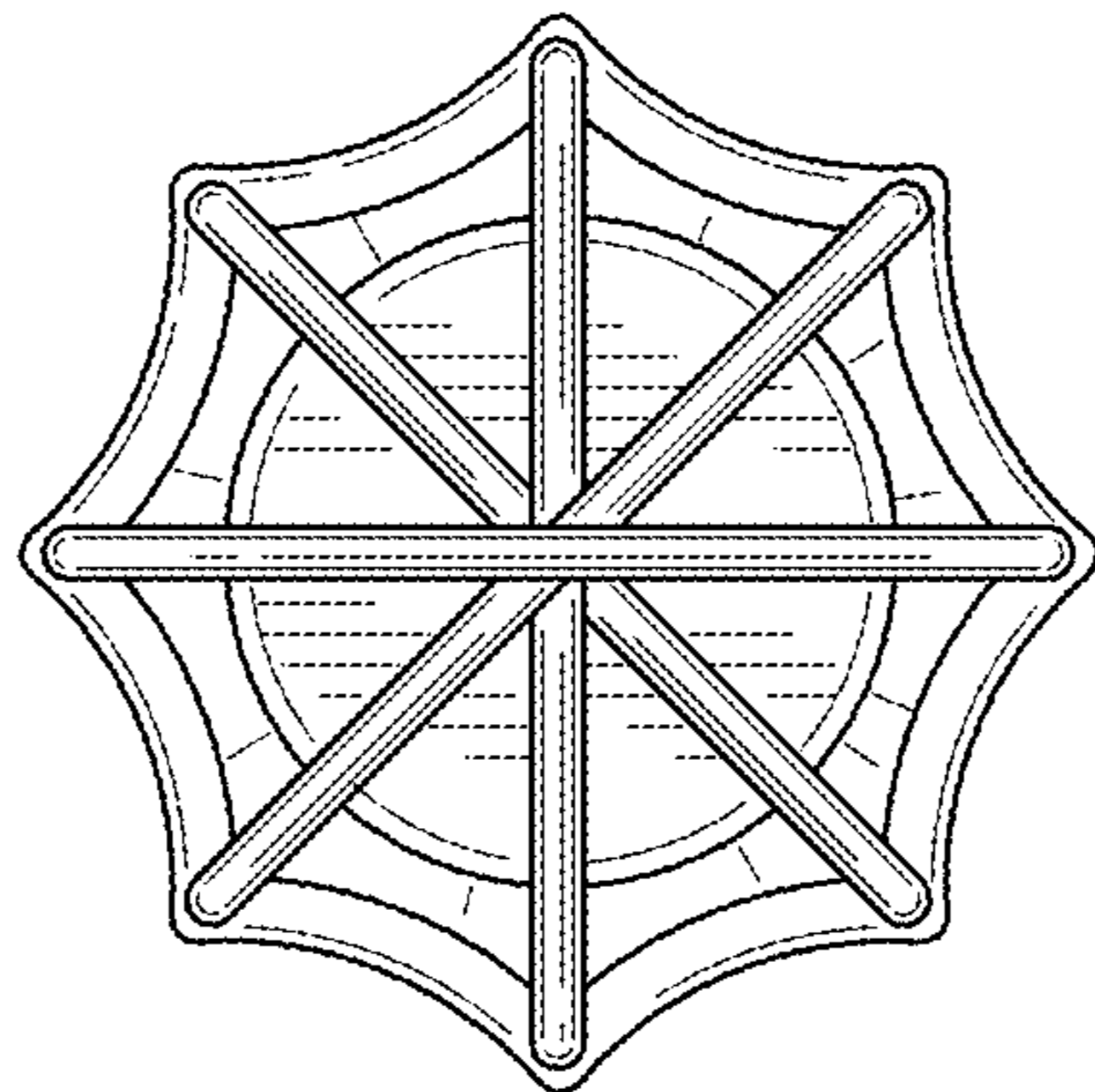
