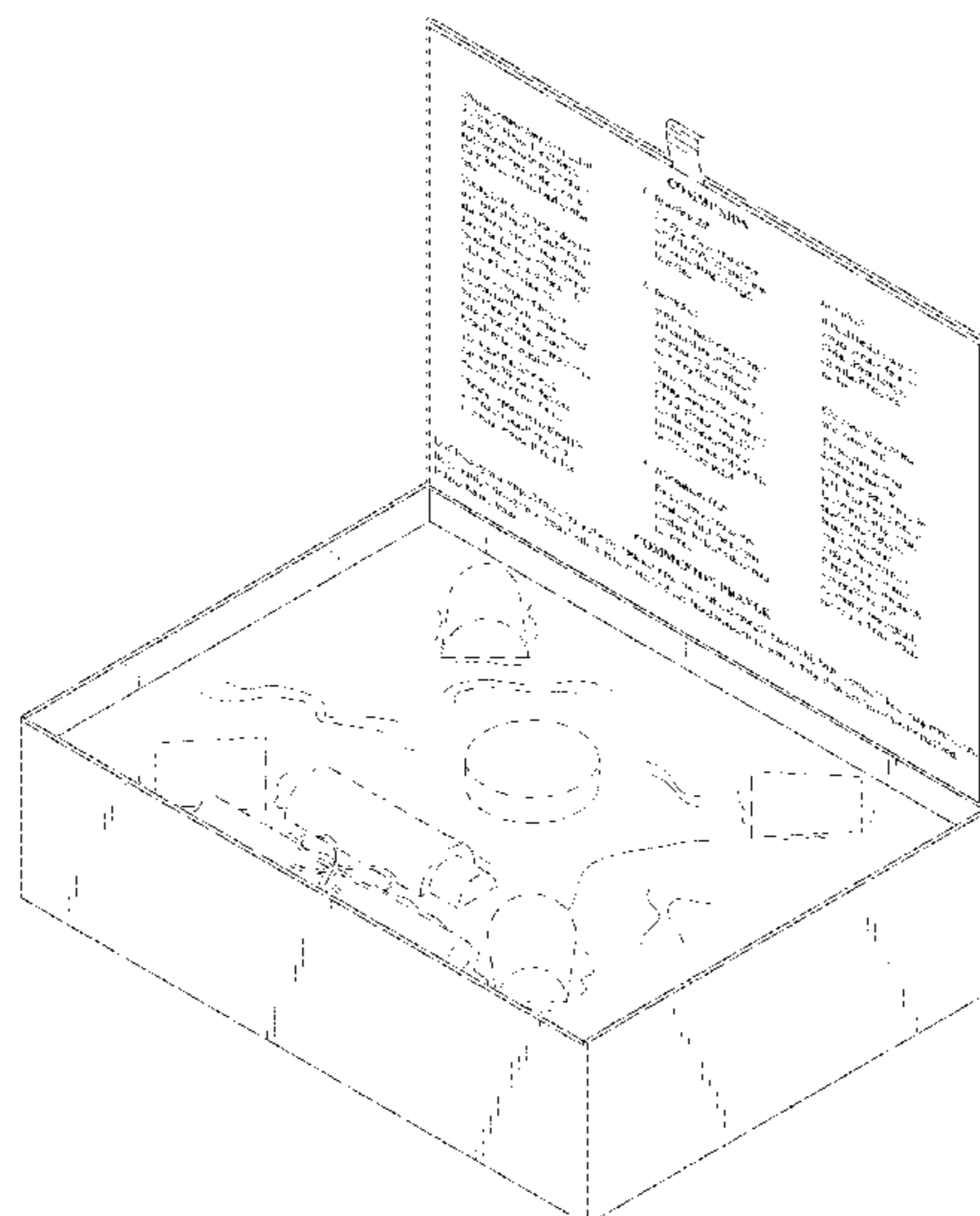
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front perspective view of a communion box, showing my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right-side elevation view thereof with a left-side elevation view being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,

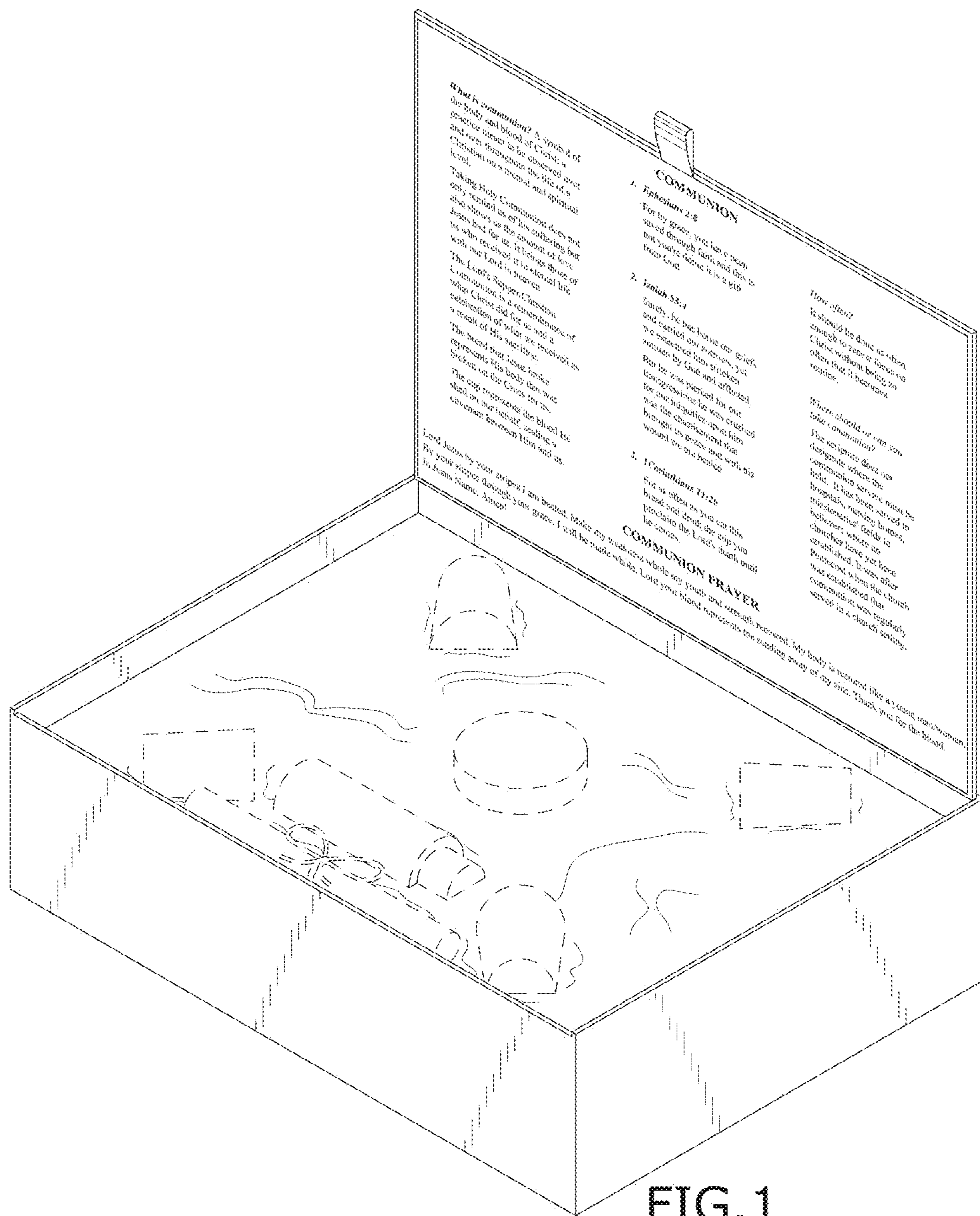

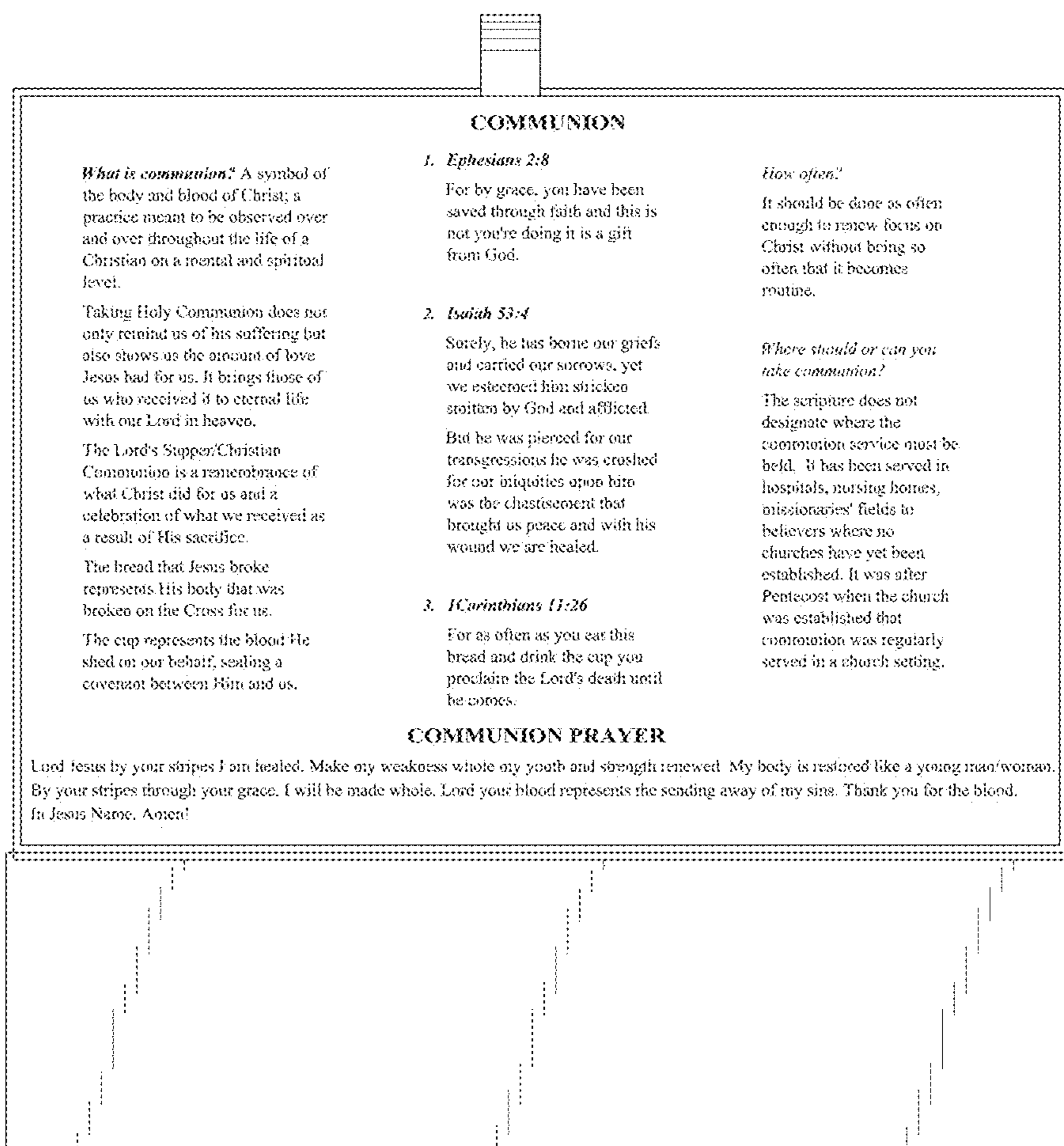

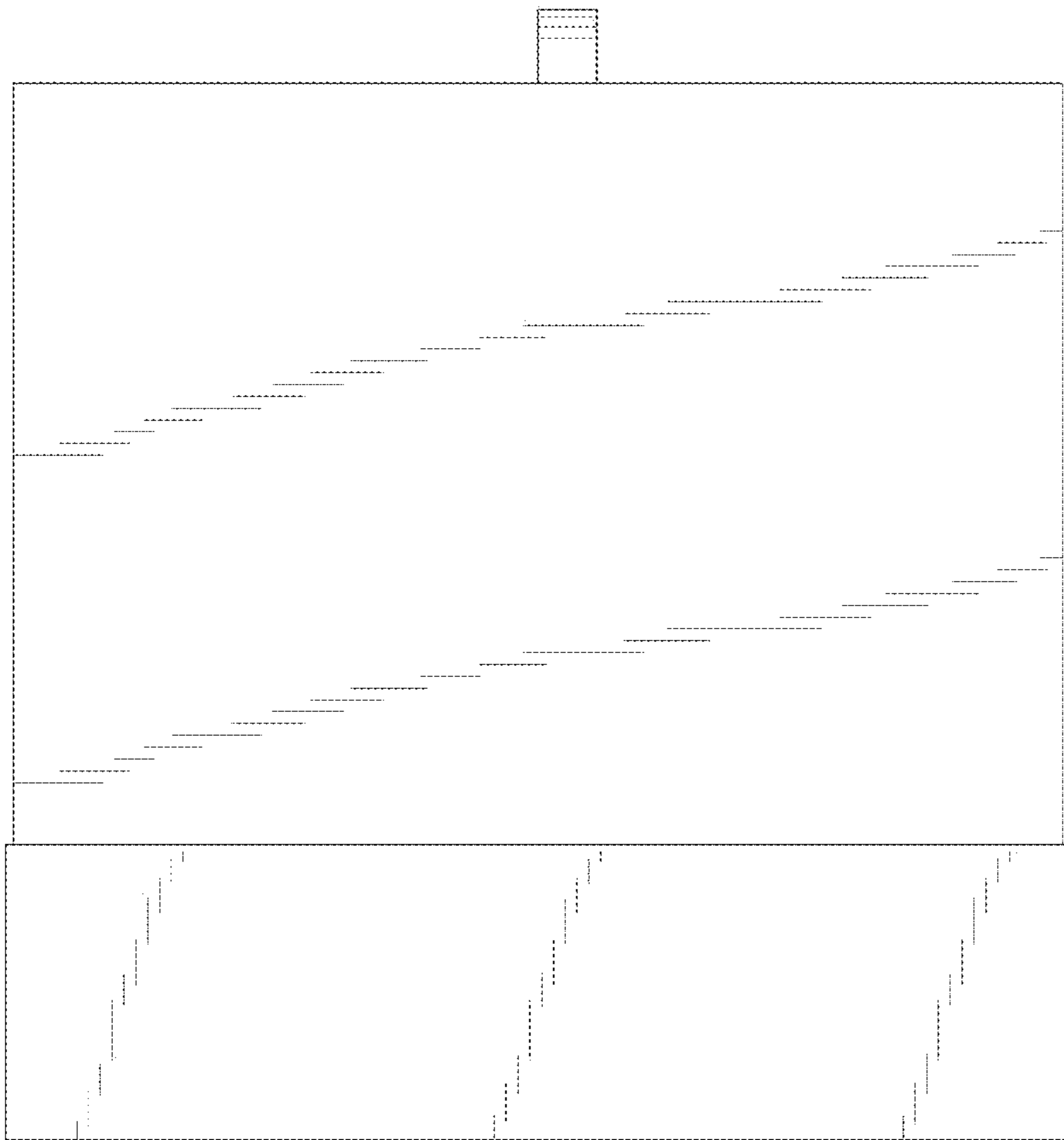

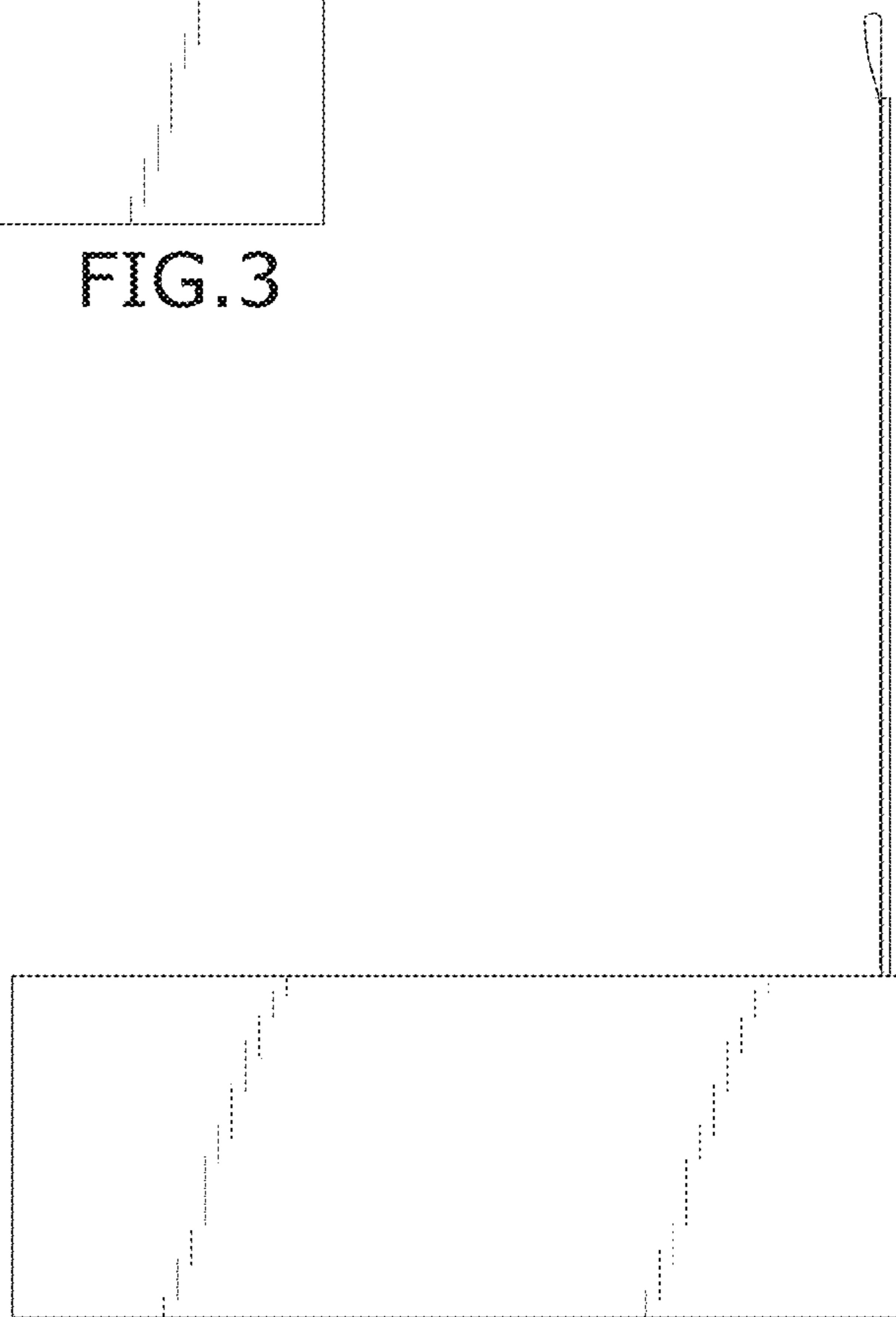

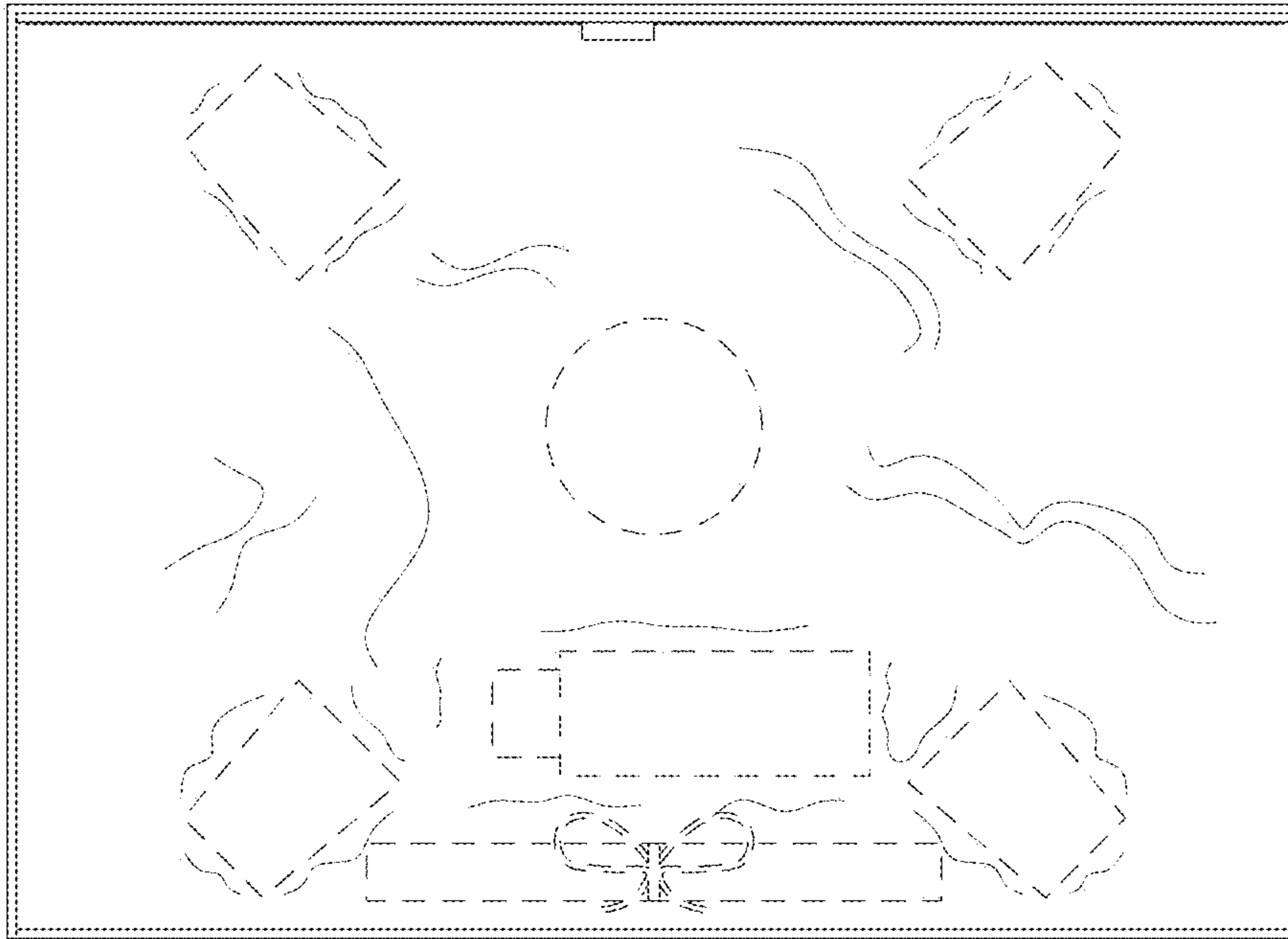

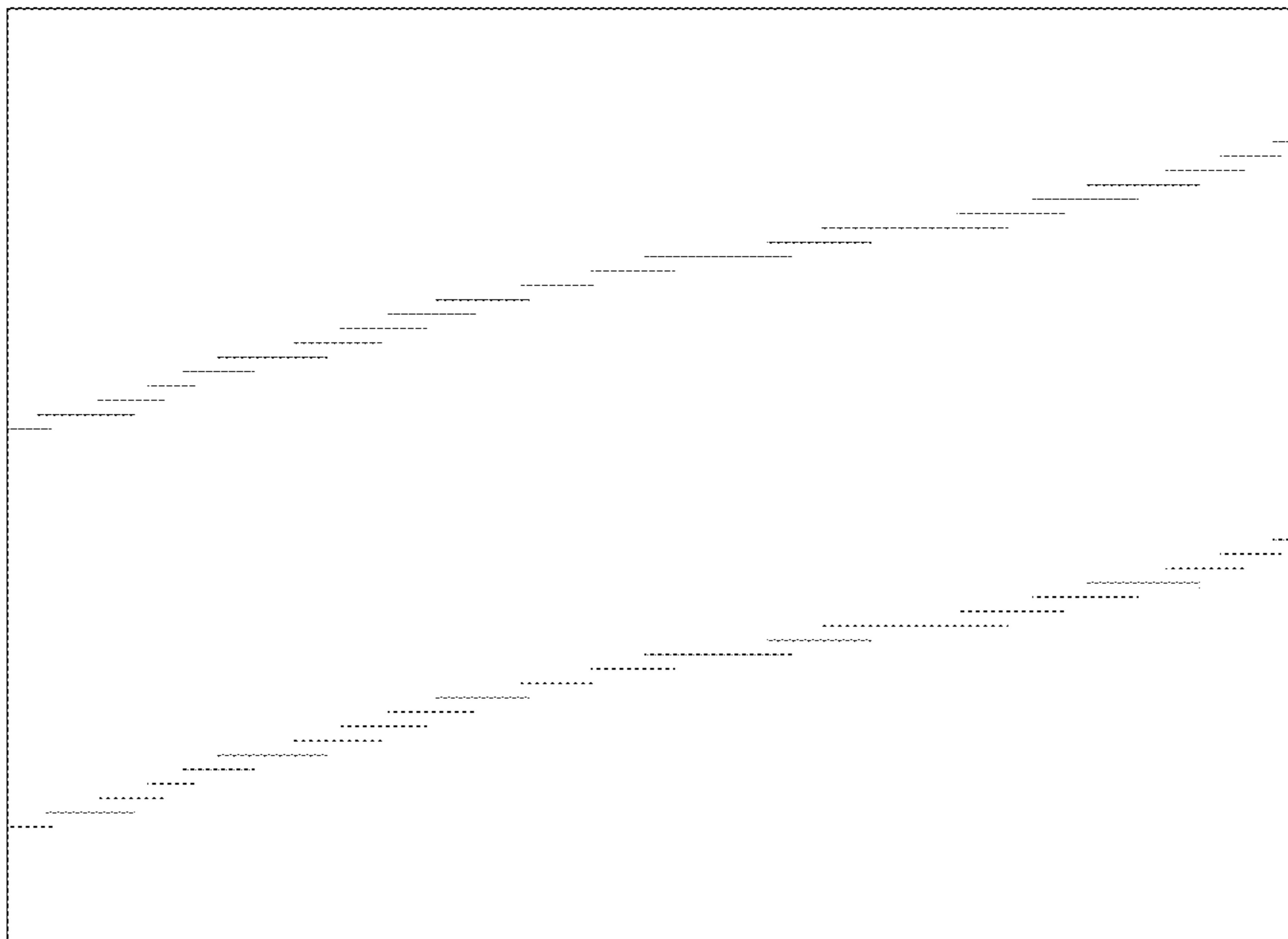
