(57) **CLAIM**

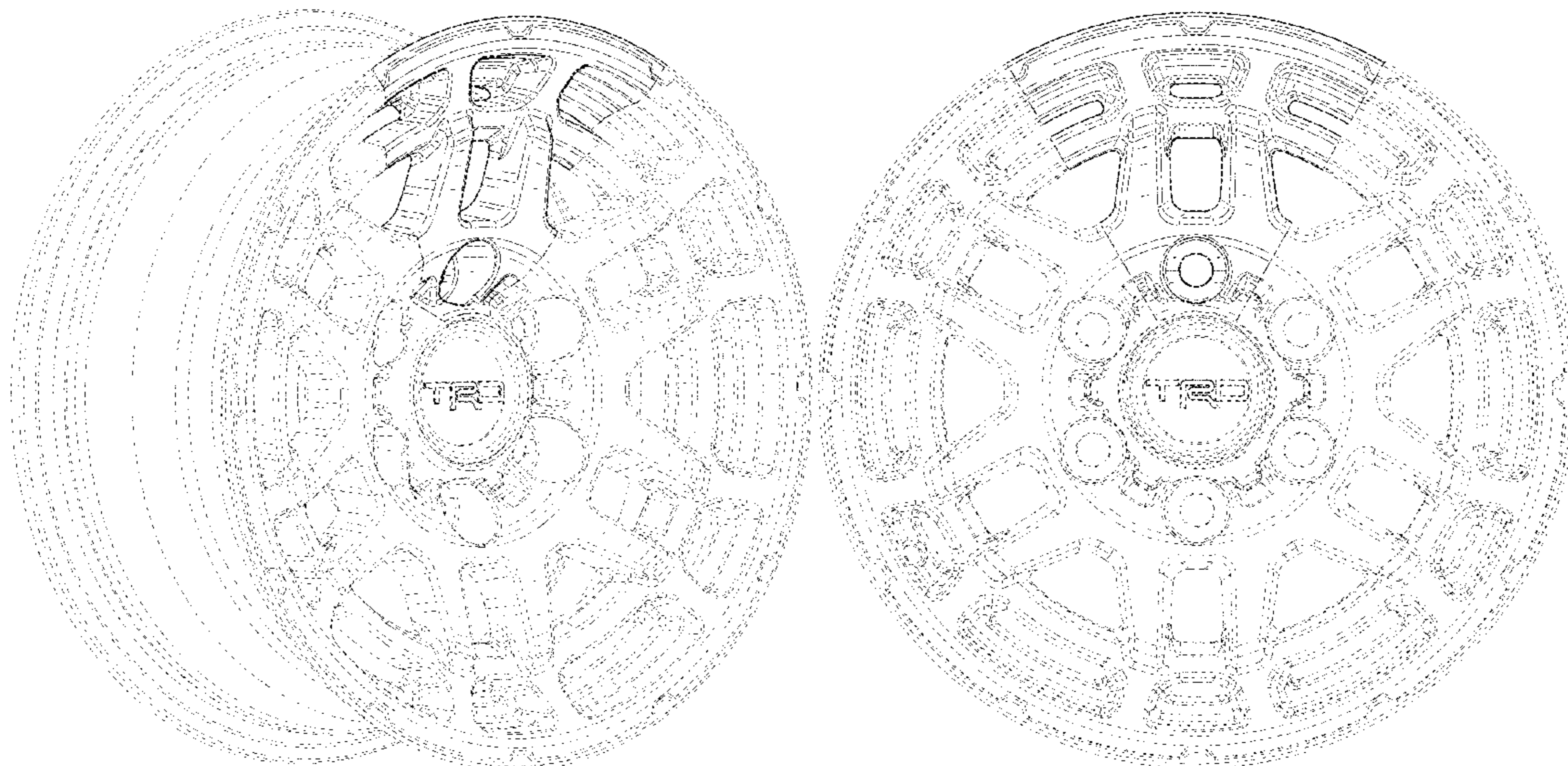
The ornamental design for a vehicle wheel as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vehicle wheel showing our new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof; and,  
FIG. 5 is a side view thereof.

The broken lines in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design. The dot-dashed lines are included for the purpose of illustrating boundary lines and form no part of the claimed design. The side view depicted in FIG. 5 depicts a view of the vehicle wheel from a single side and the opposite side is a mirror image.

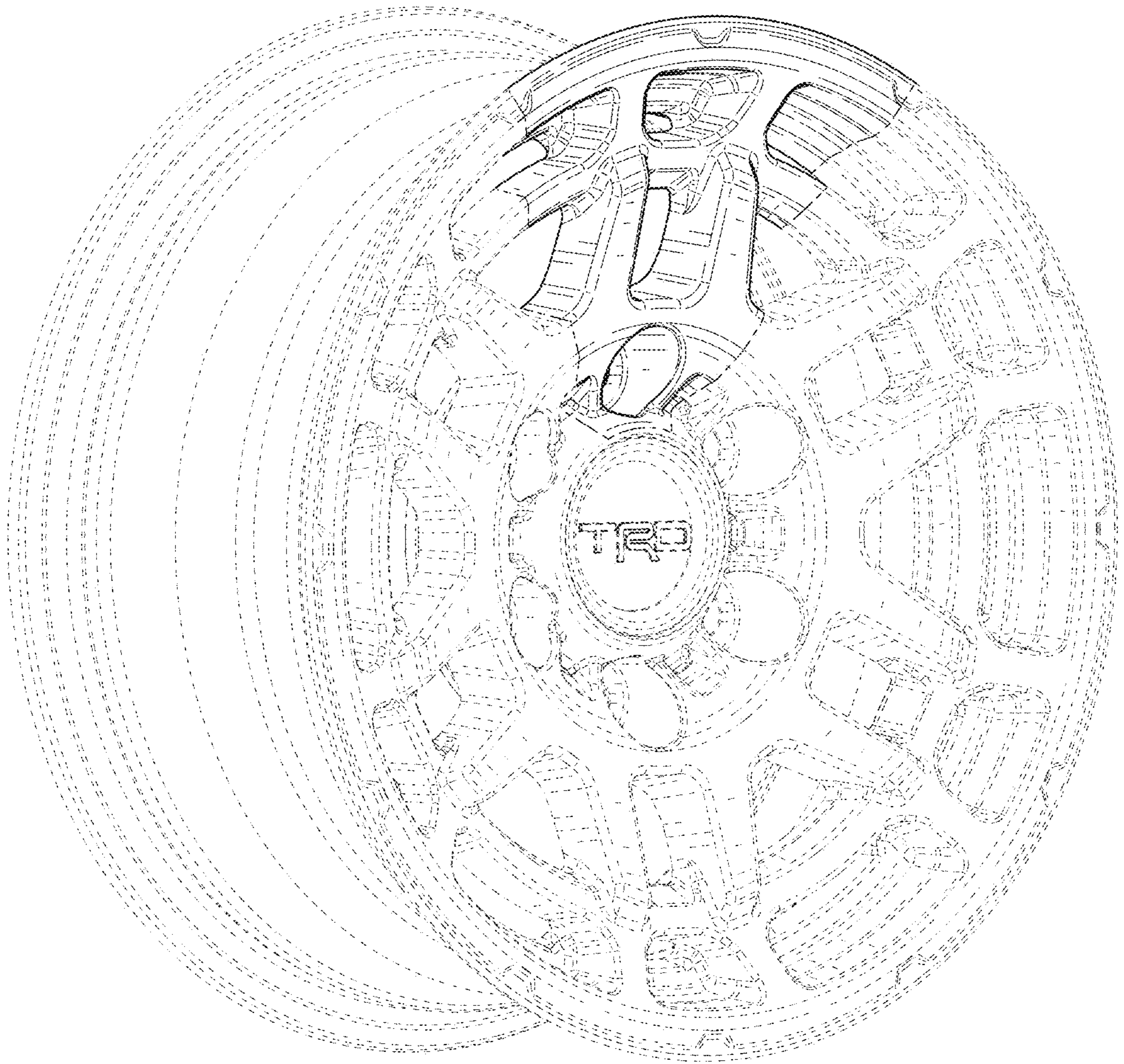

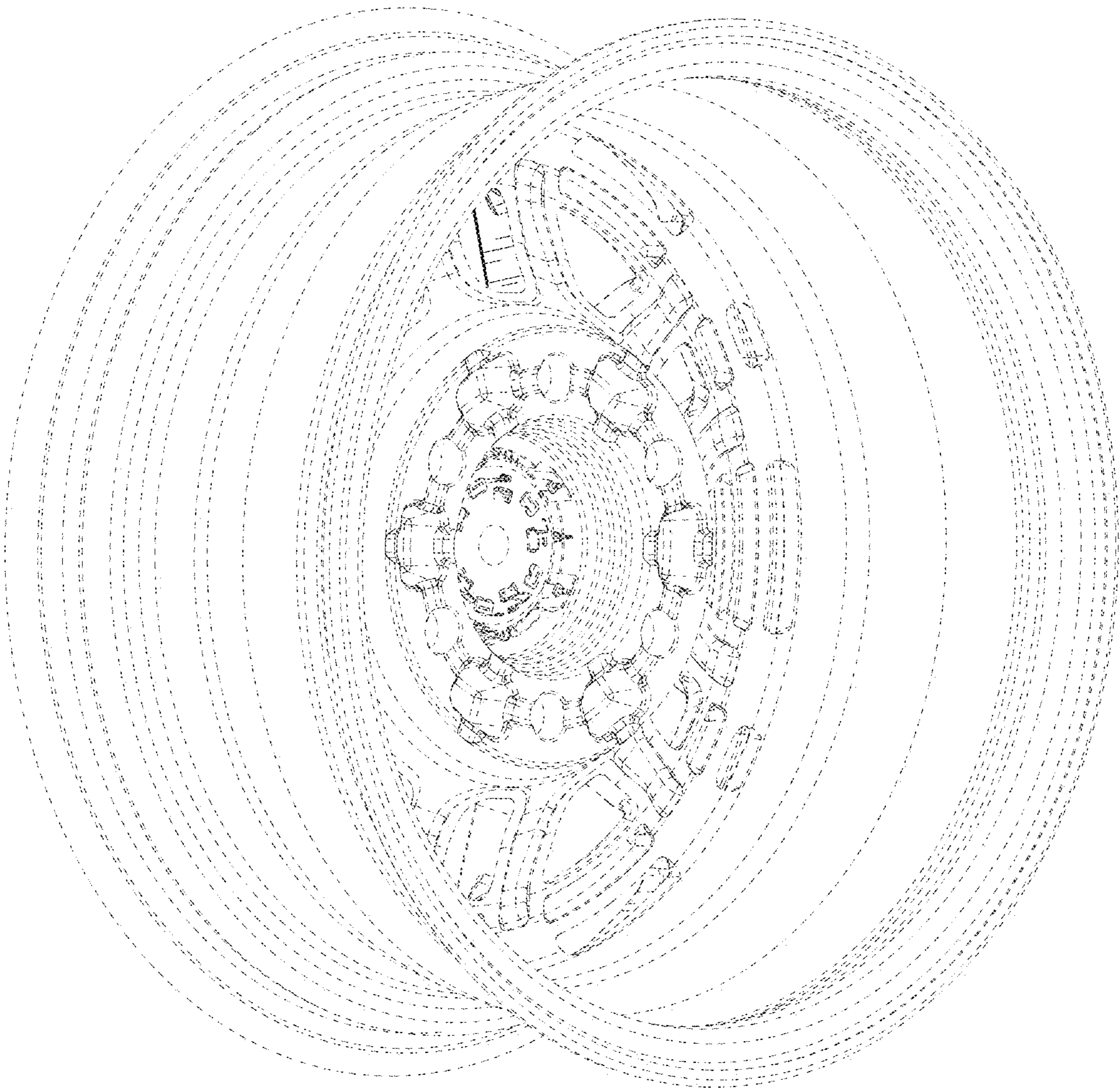

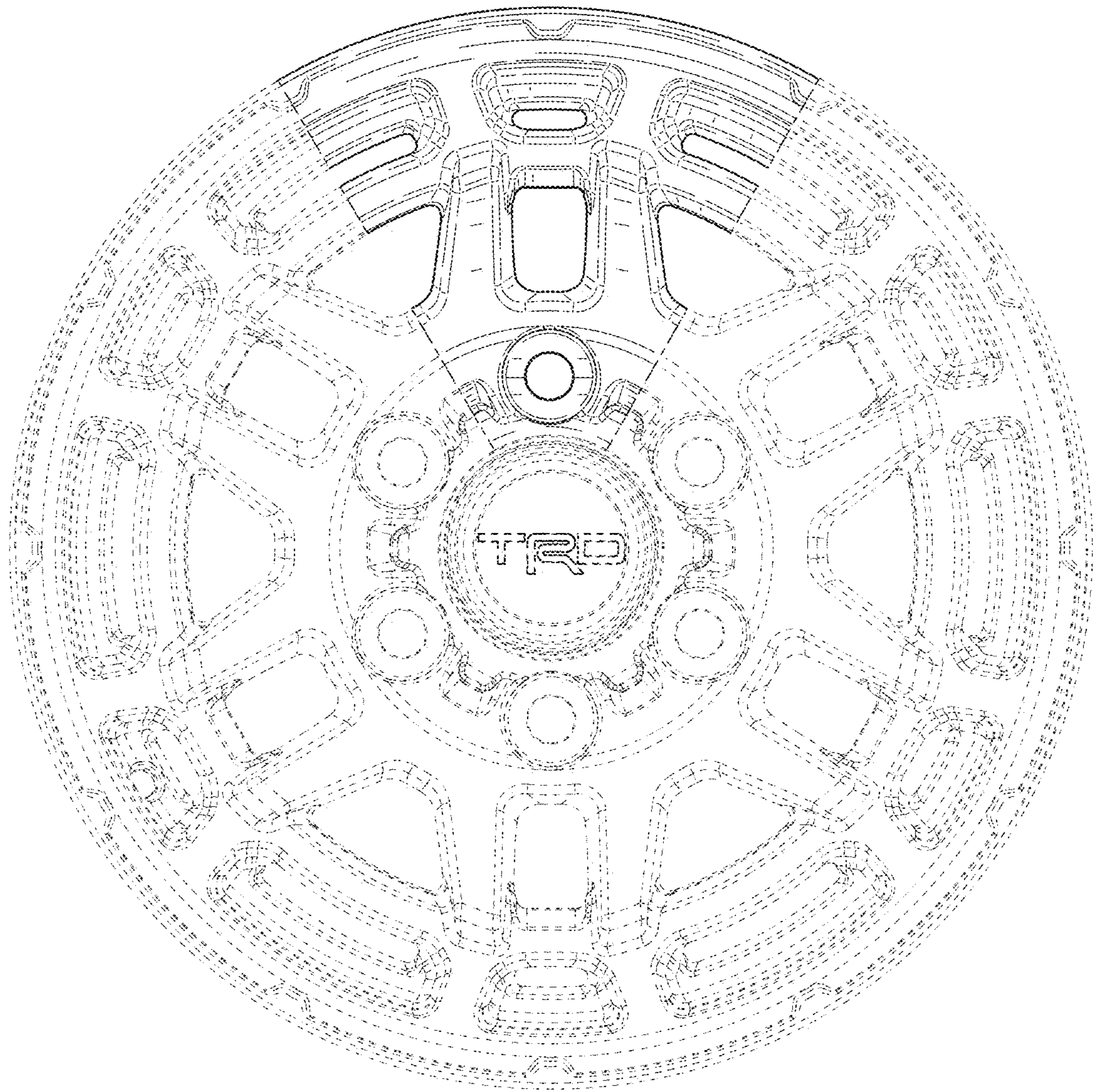

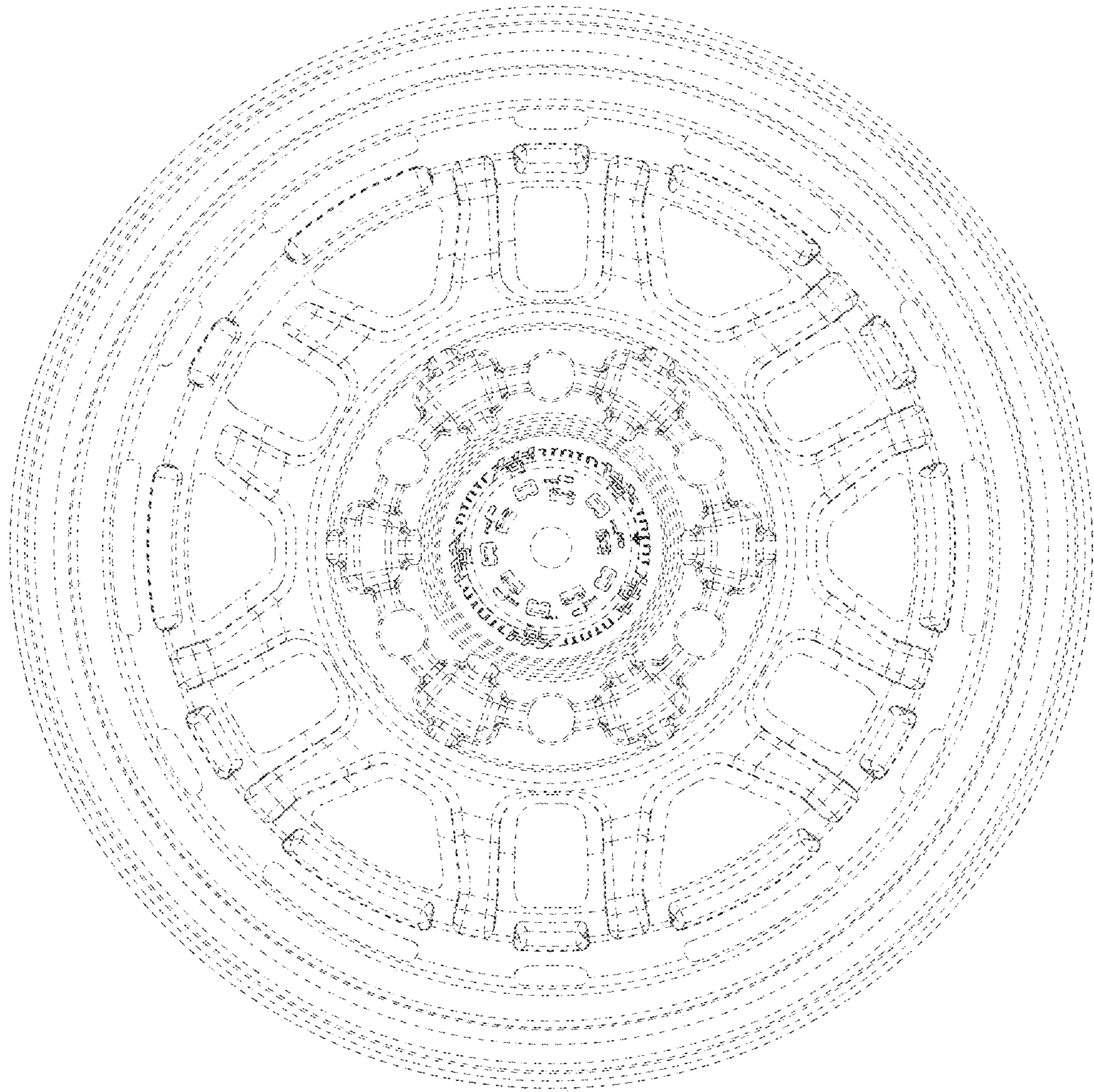

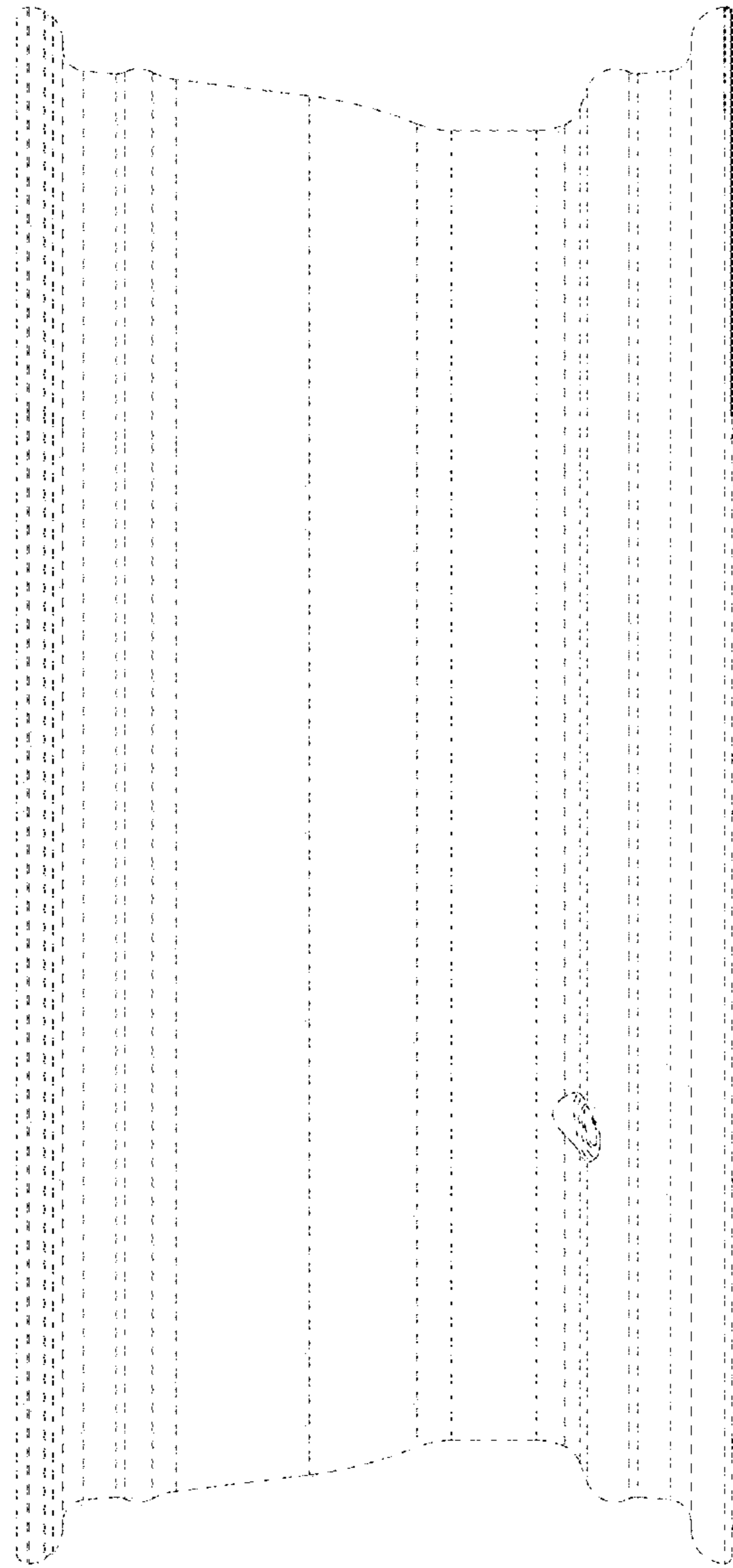
