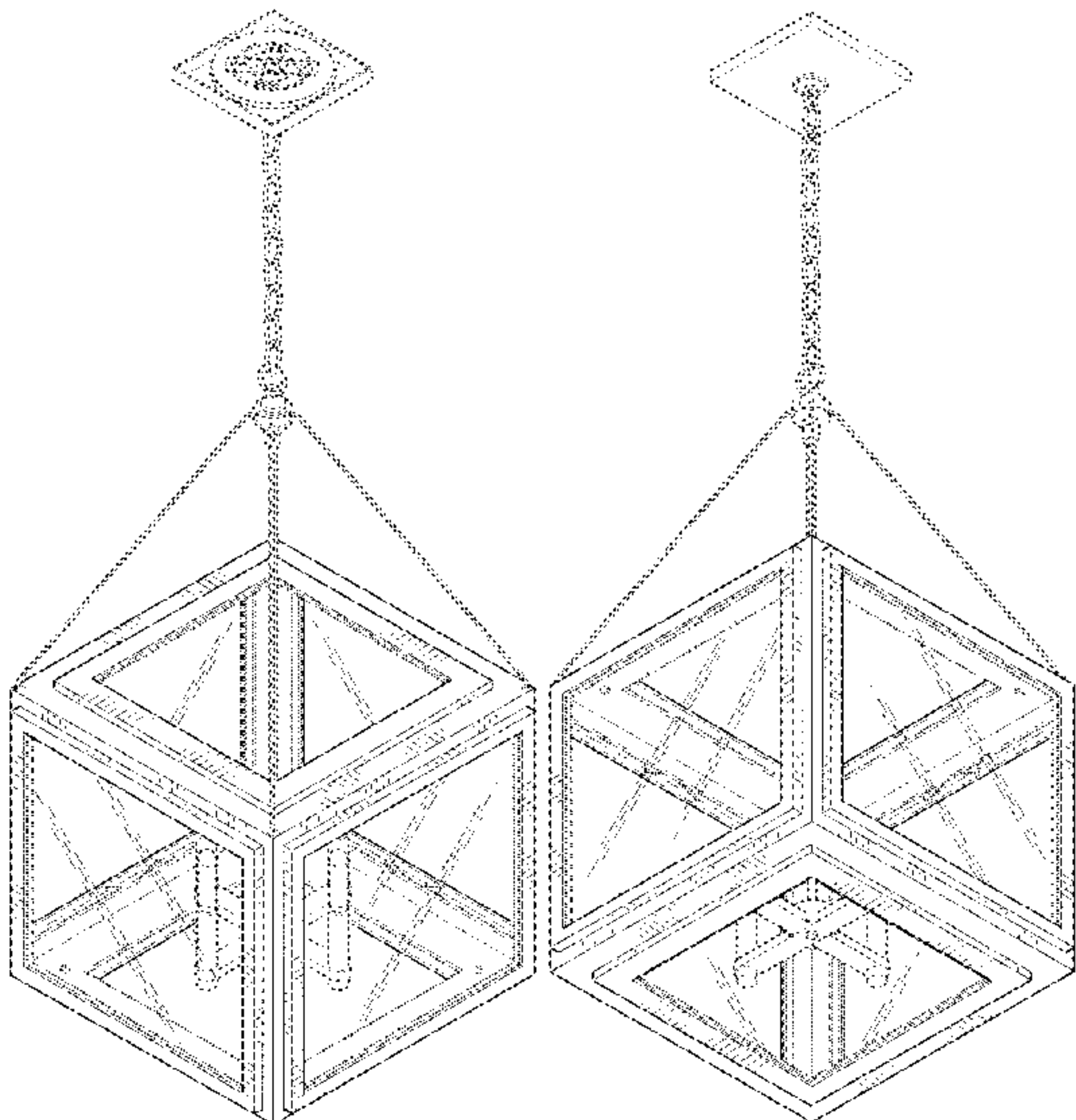
(57) CLAIM

DESCRIPTION

FIG. 1 is a top perspective view of a lighting fixture depicting a new design;

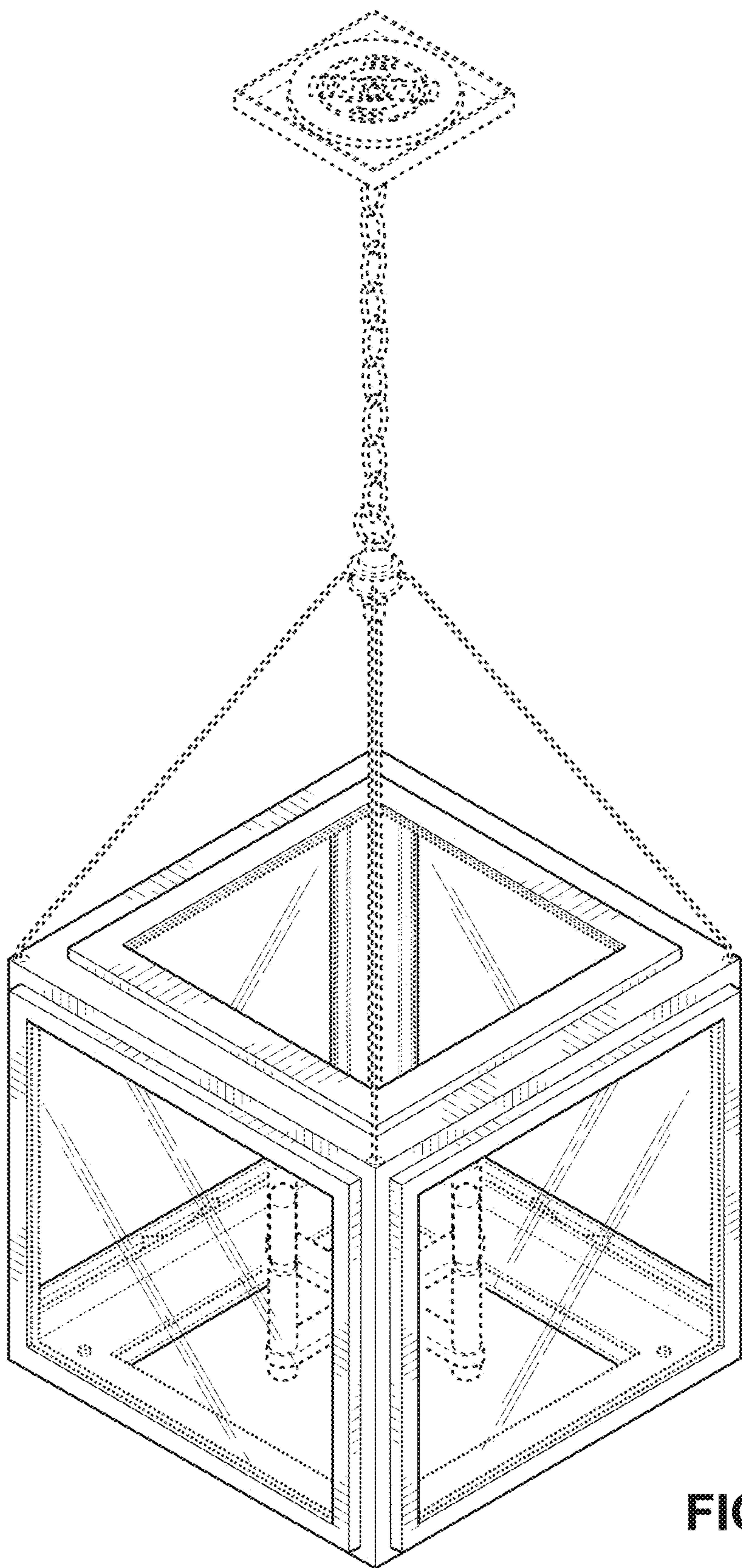

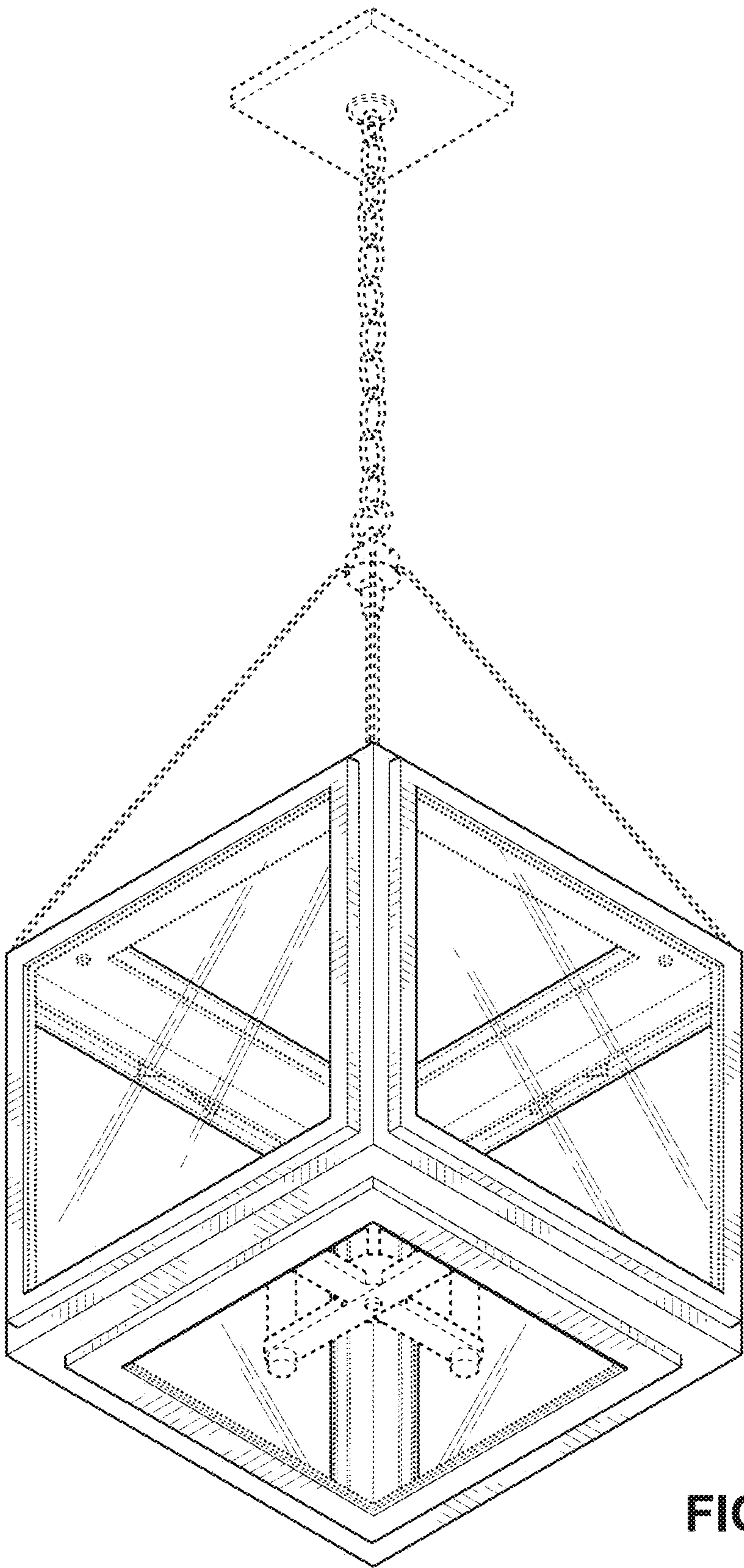

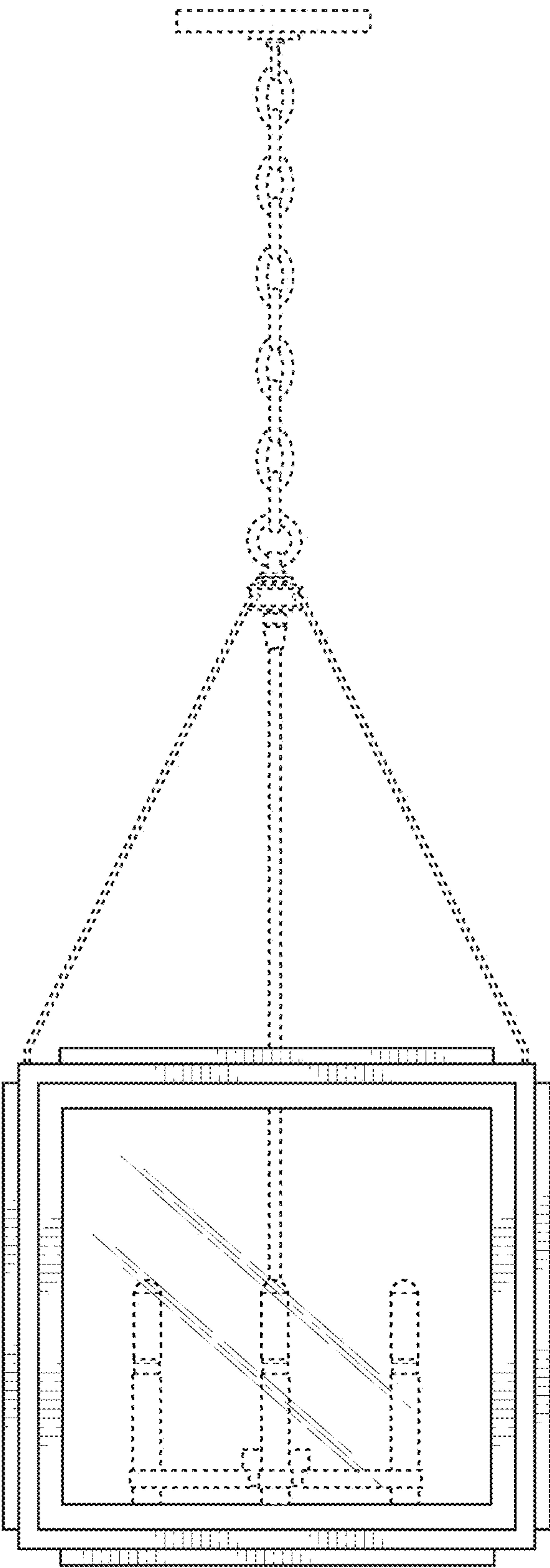

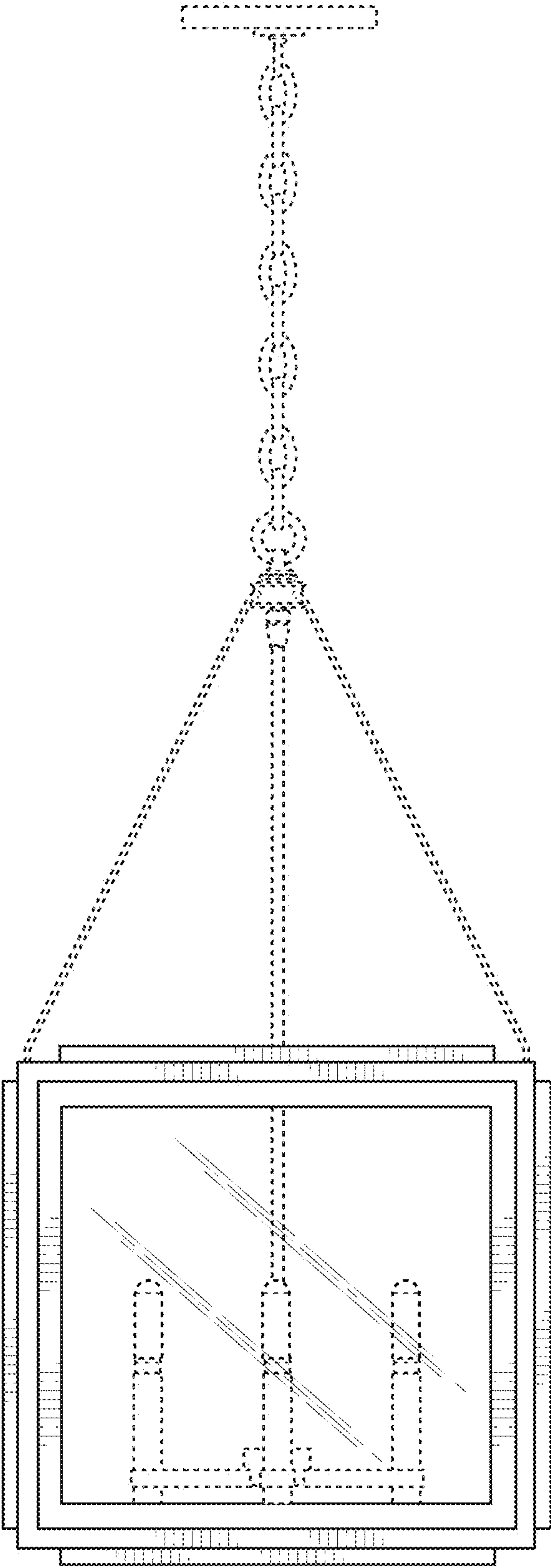

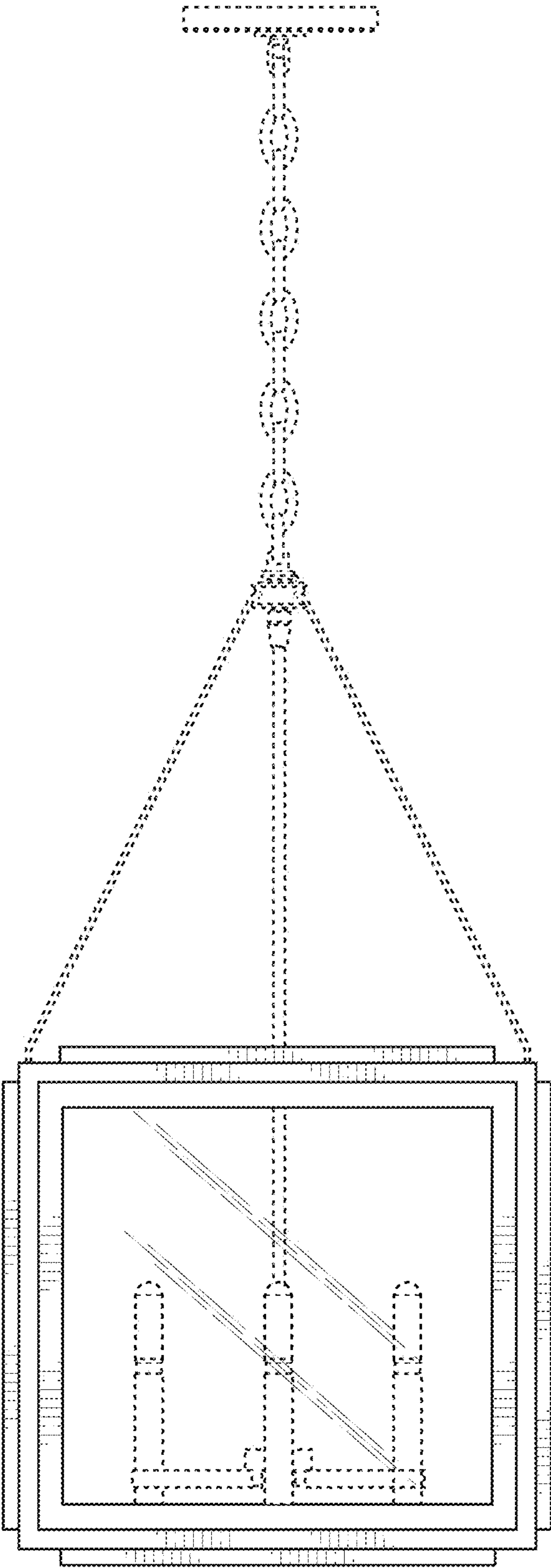

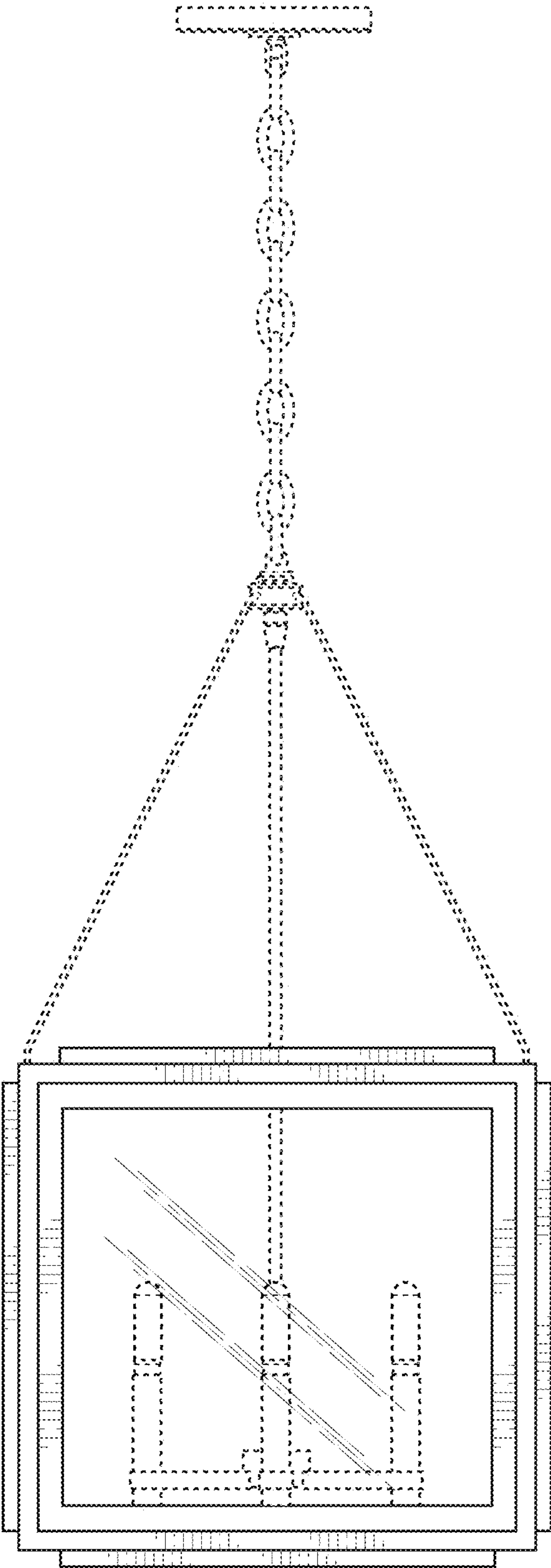

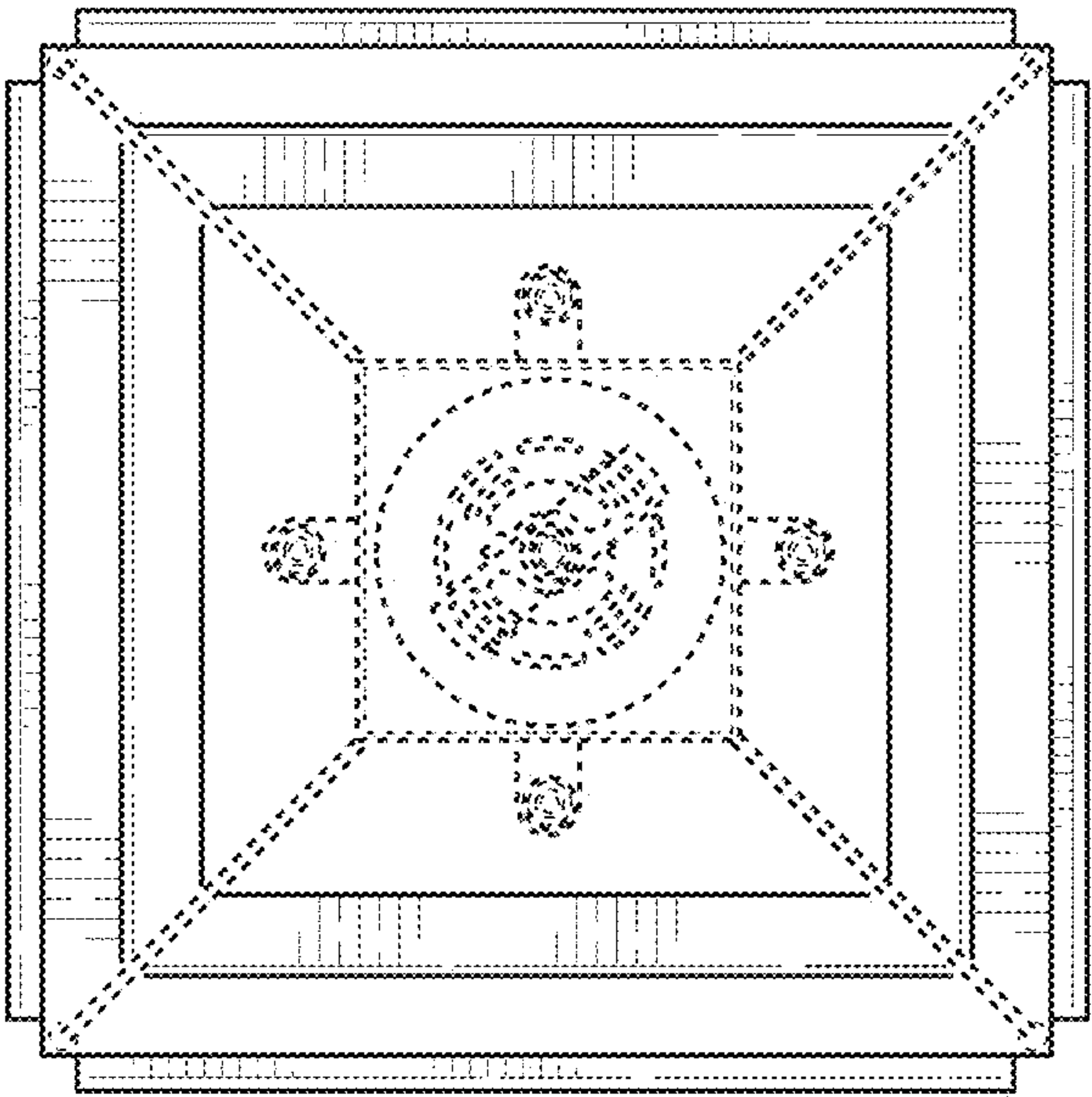

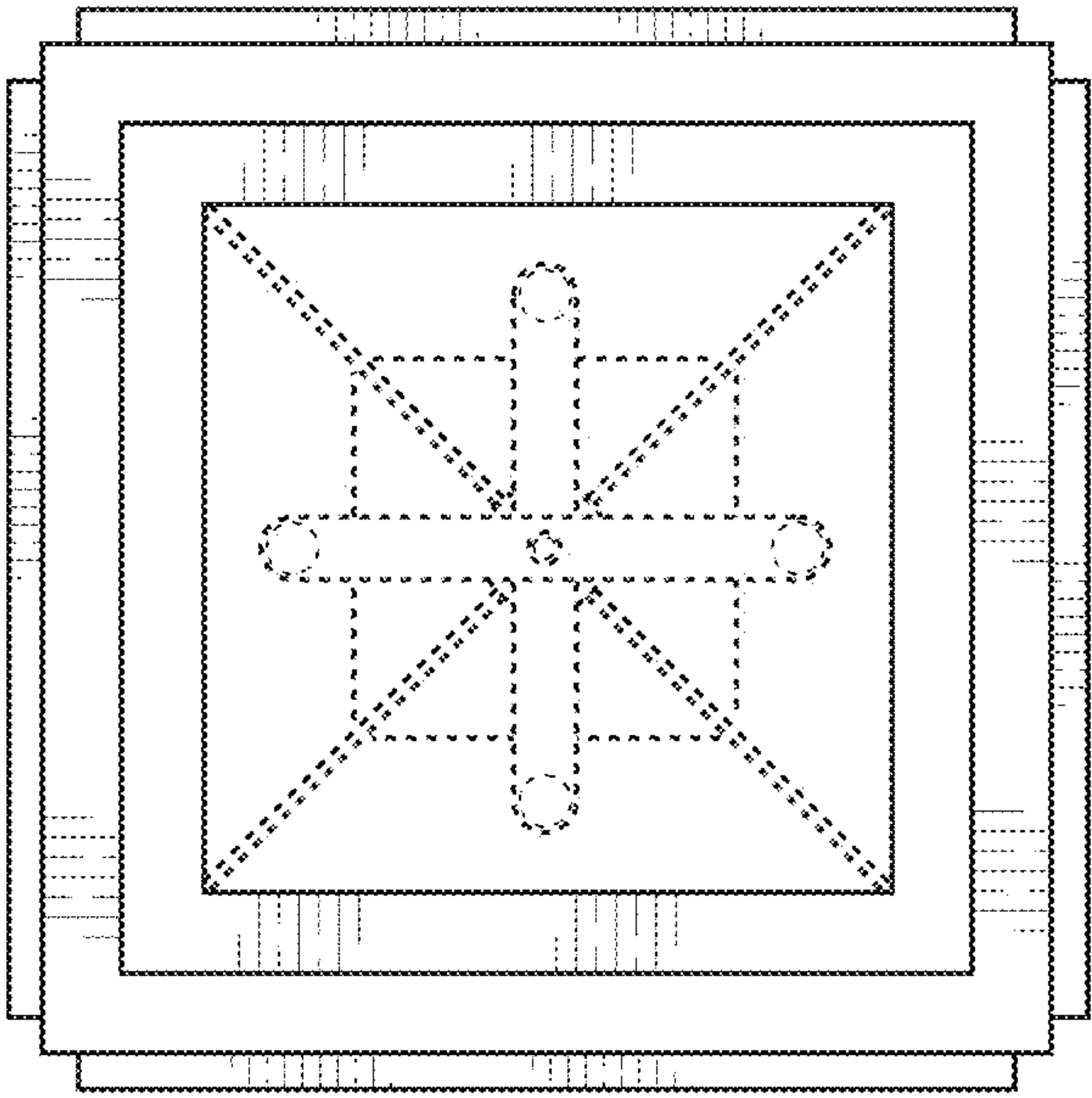
