FIG. 2 is a left side view of the stool shown in FIG. 1, the right side view being a mirror image thereof;

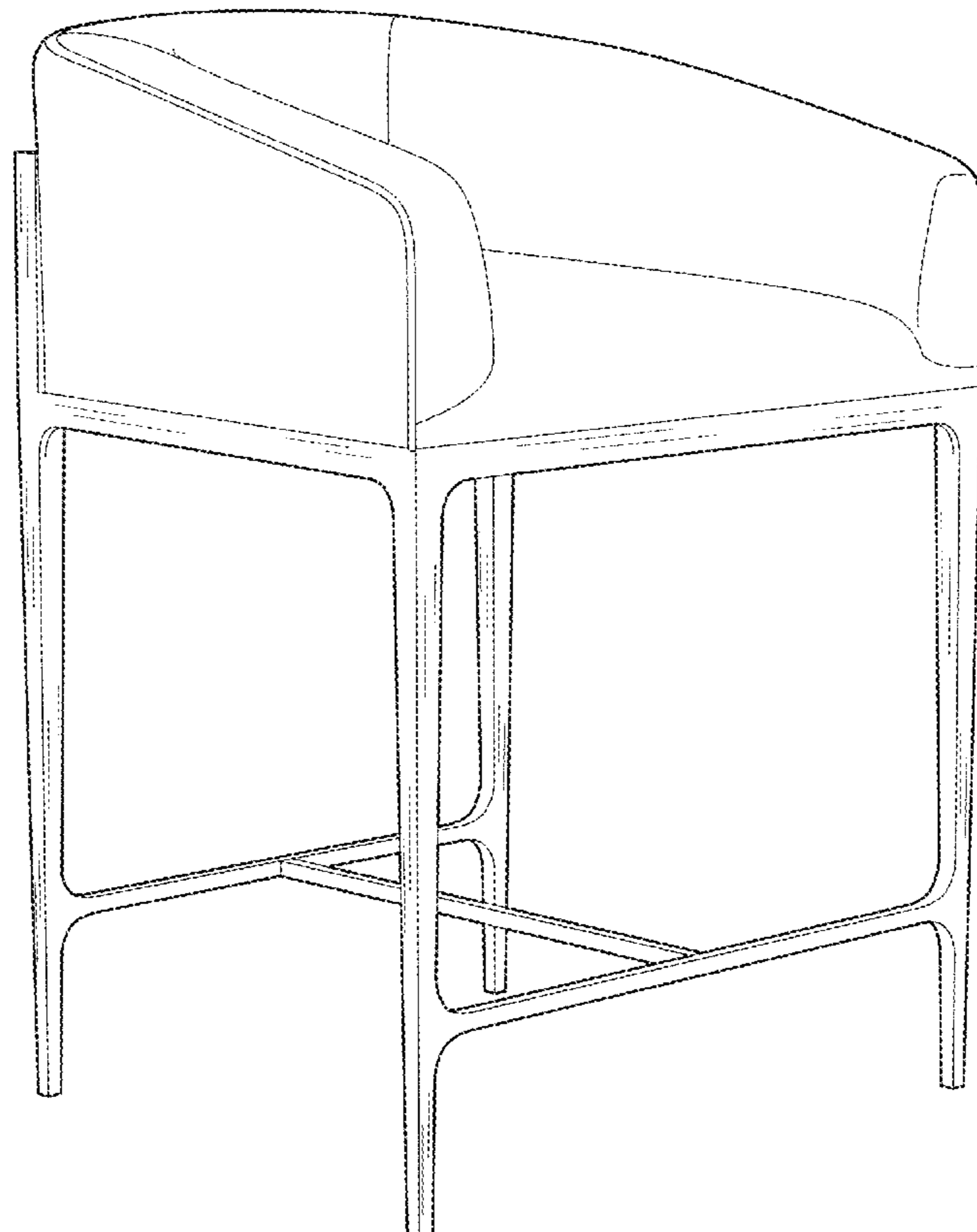
FIG. 3 is a front view of the stool shown in FIG. 1;

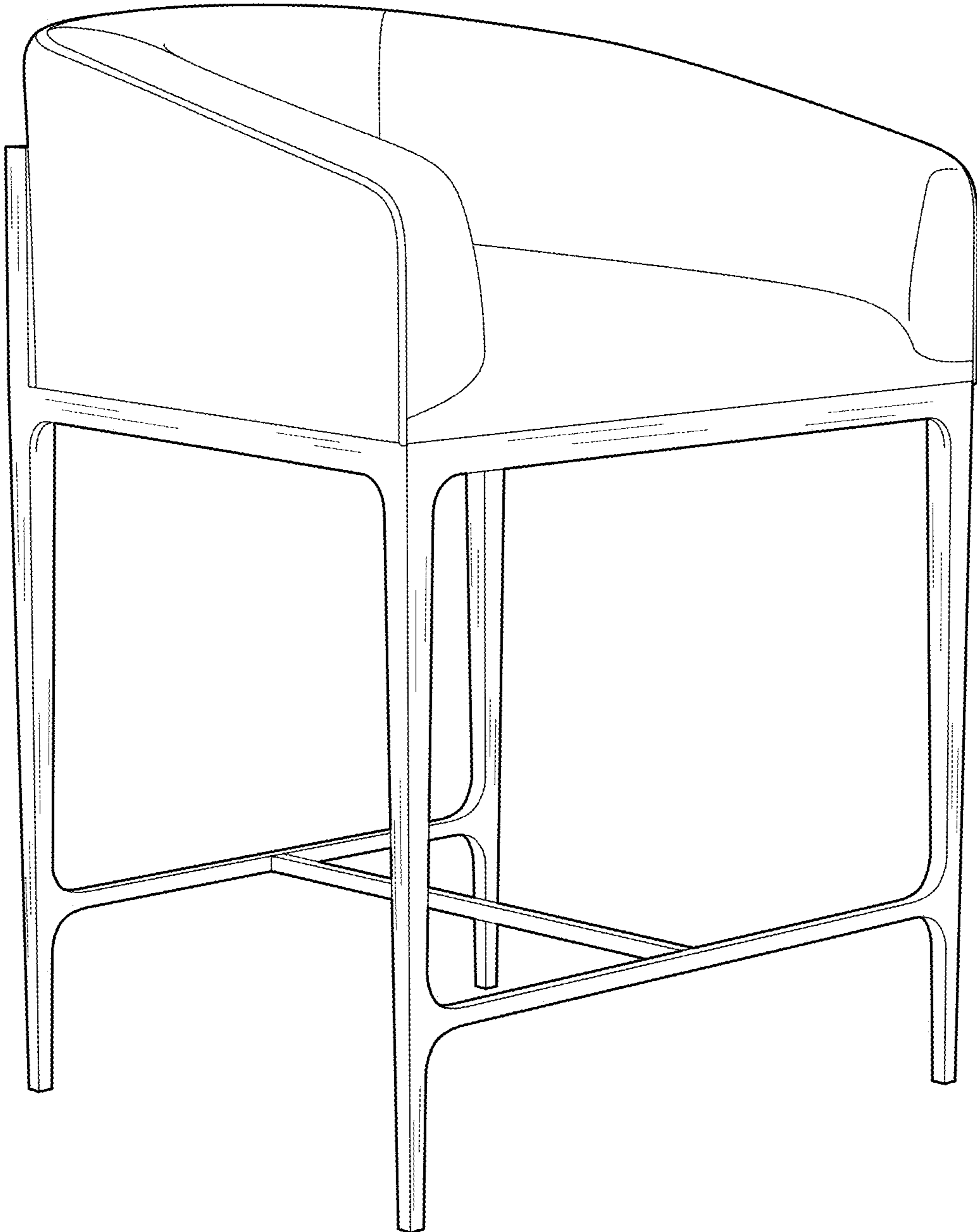

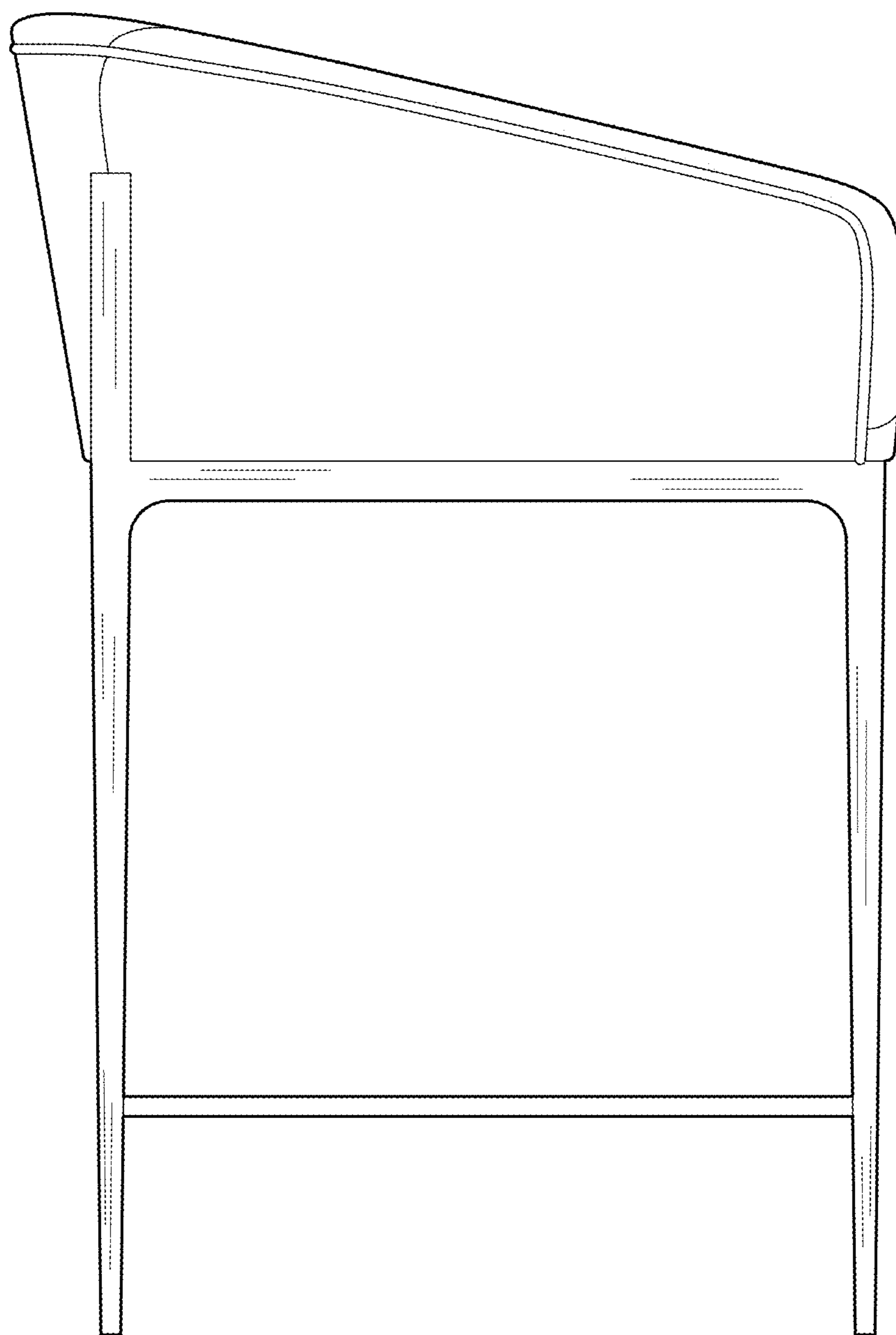

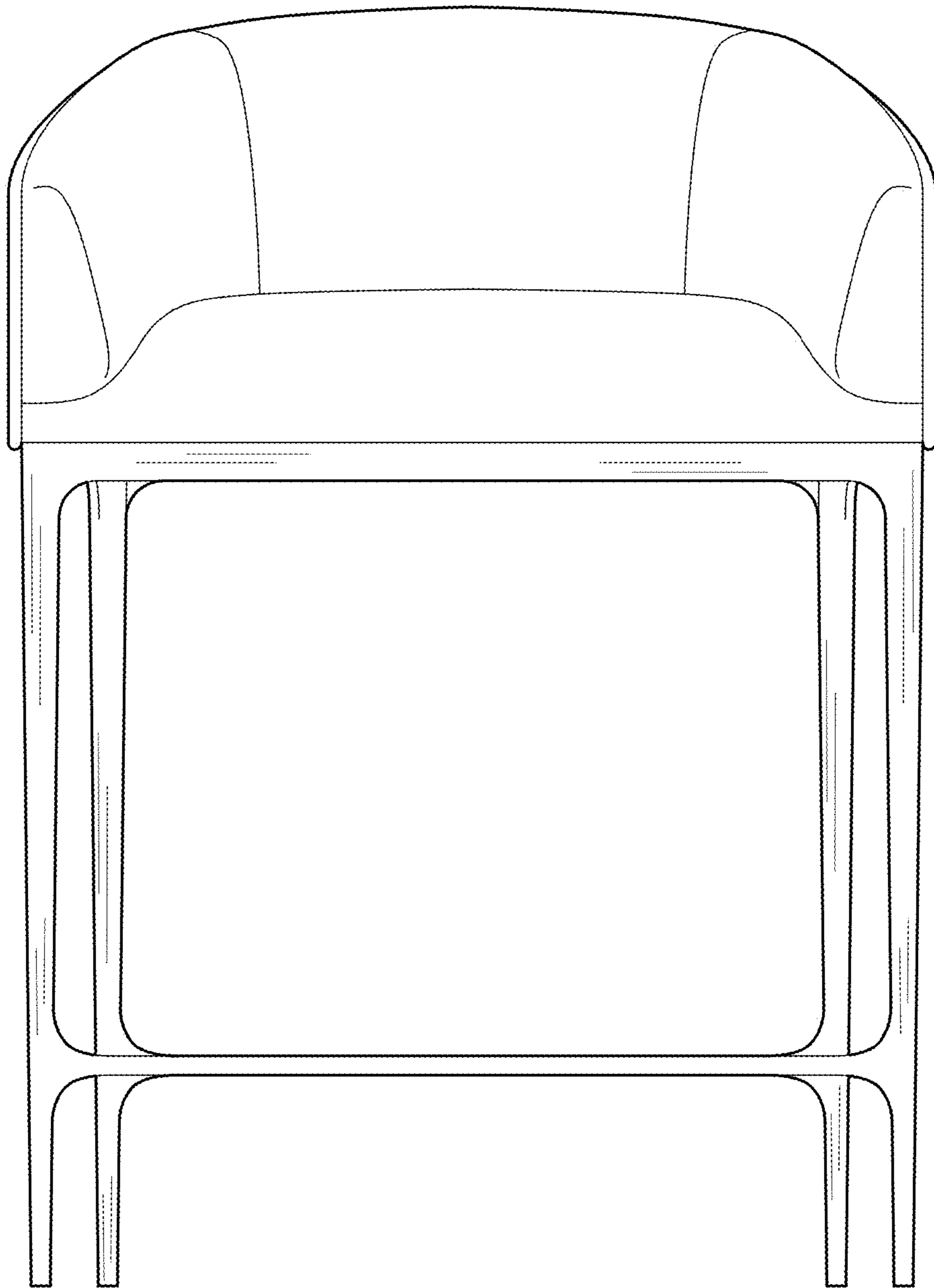

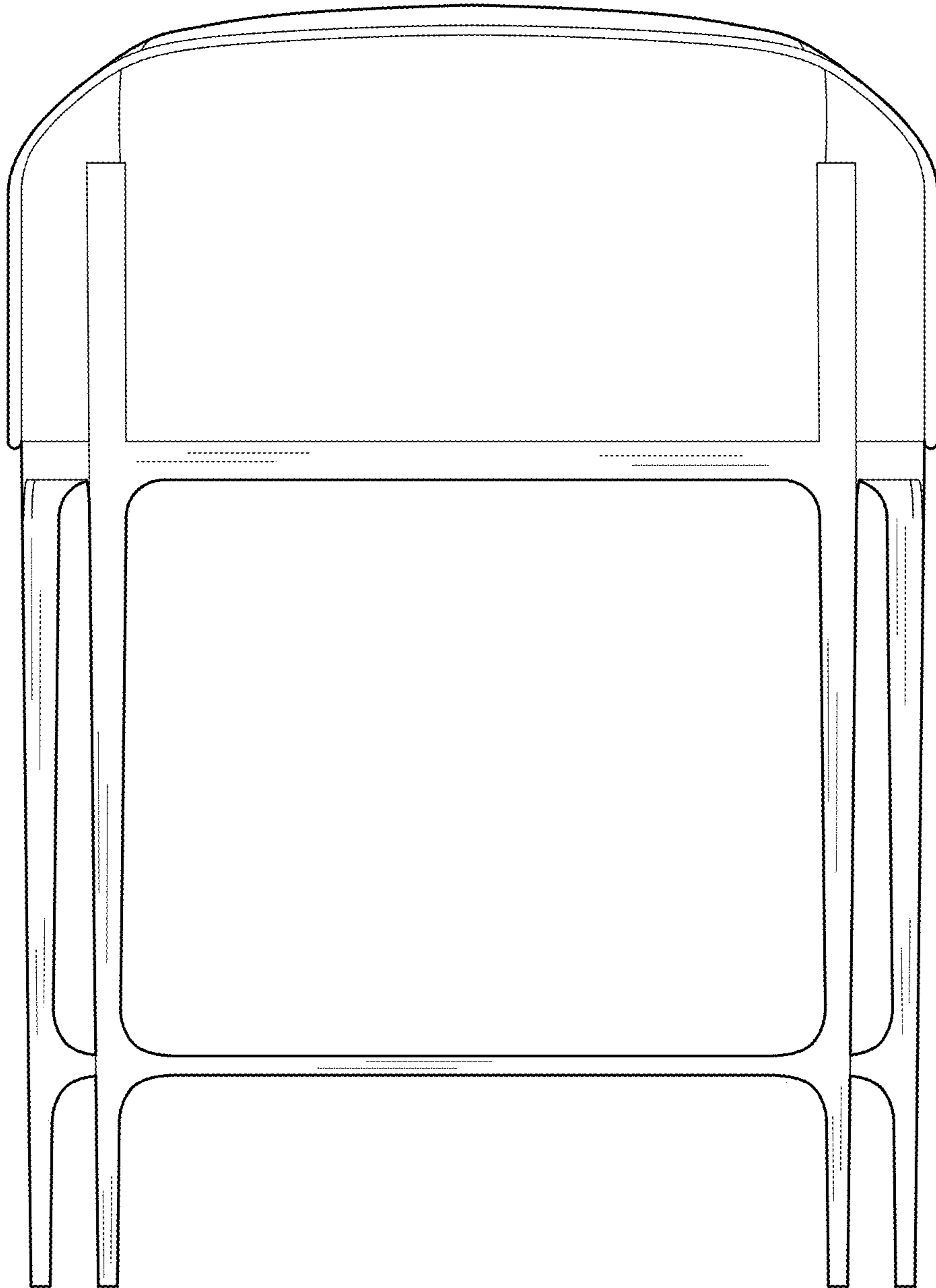

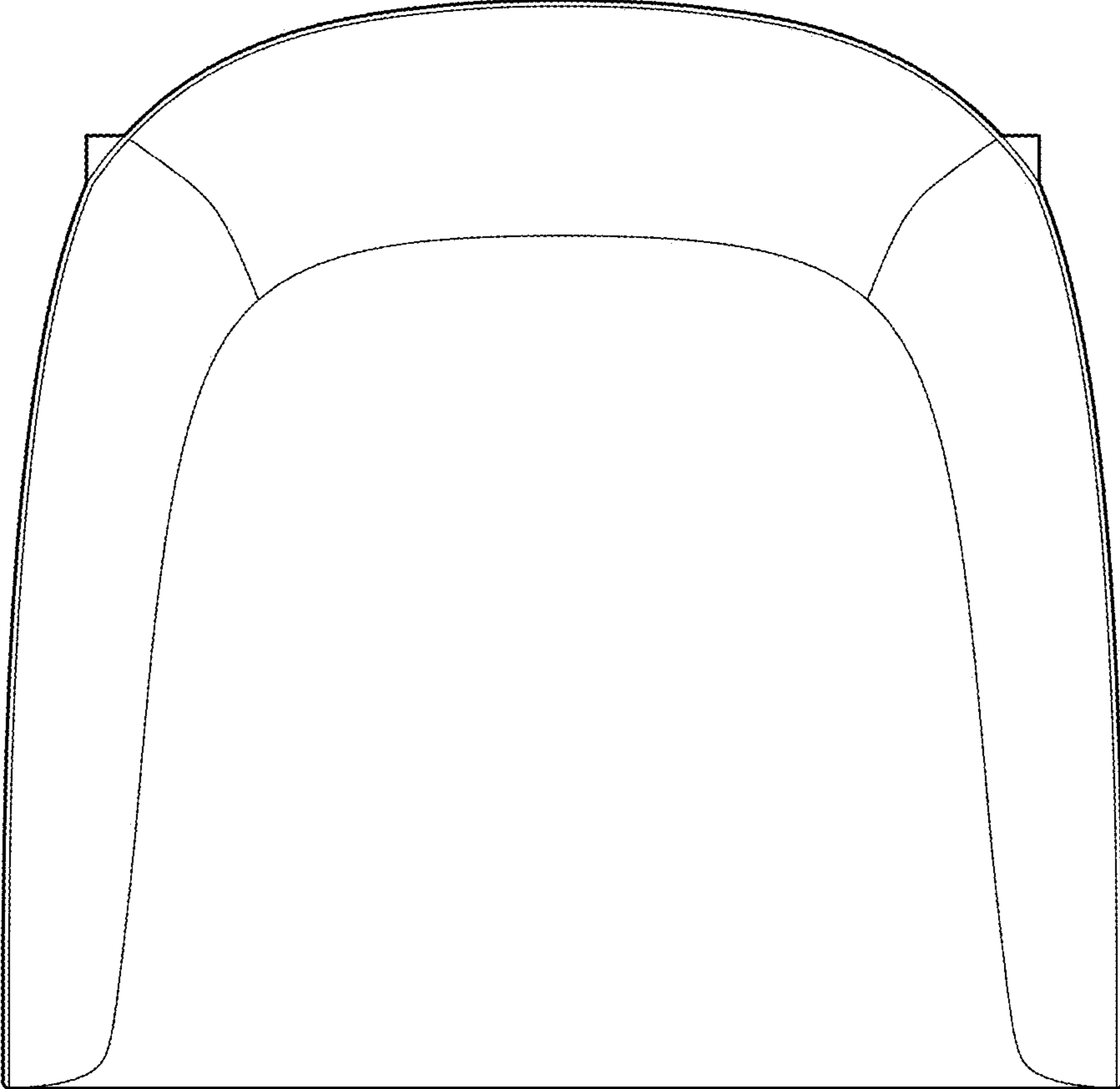

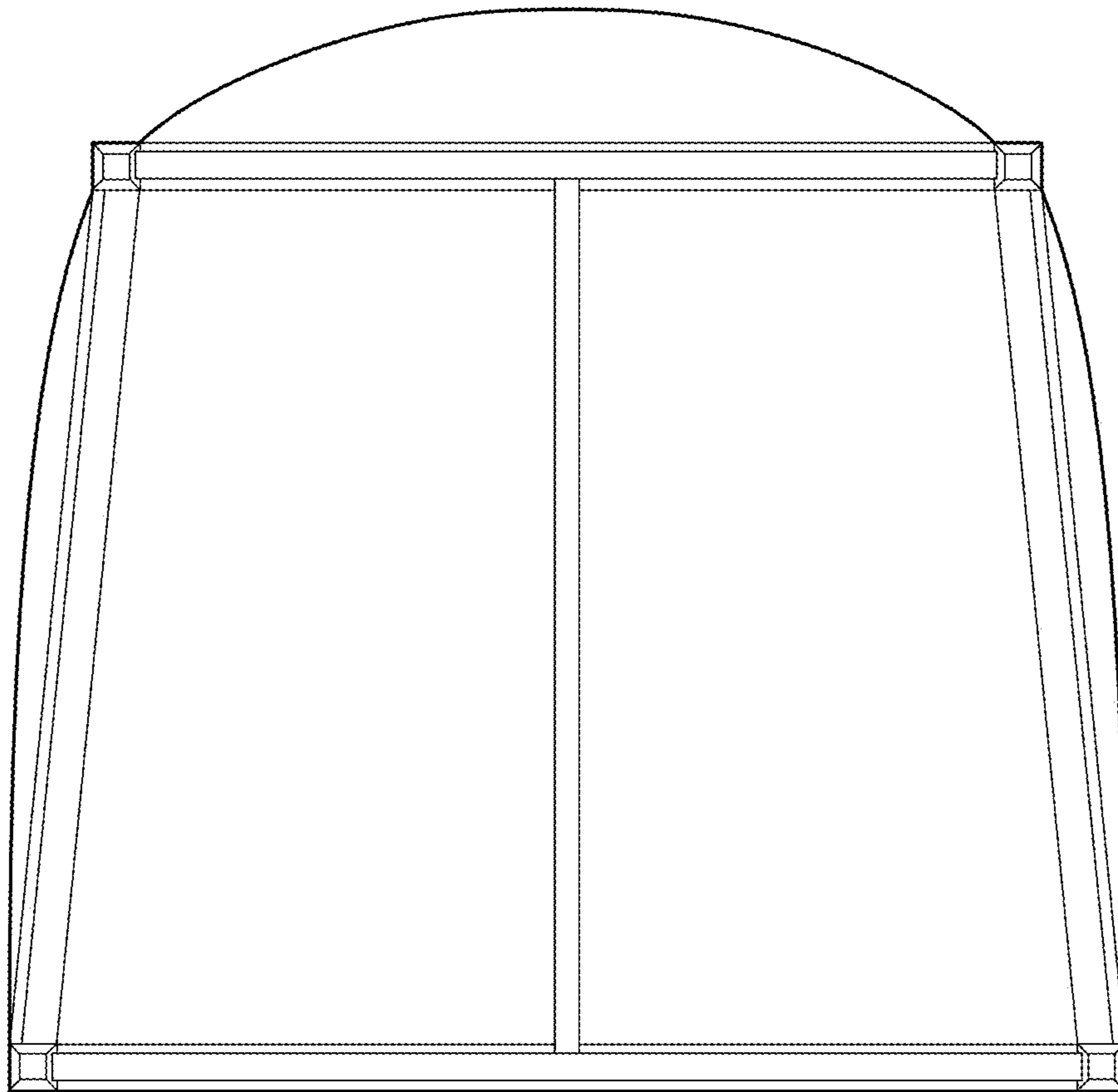
