(57) CLAIM

The ornamental design for a medical imaging device as shown and described.

DESCRIPTION

FIG. 1 is a front view of a medical imaging device showing our new design;

FIG. 2 is a back elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left-side elevational view thereof;

FIG. 6 is a right-side elevational view thereof;

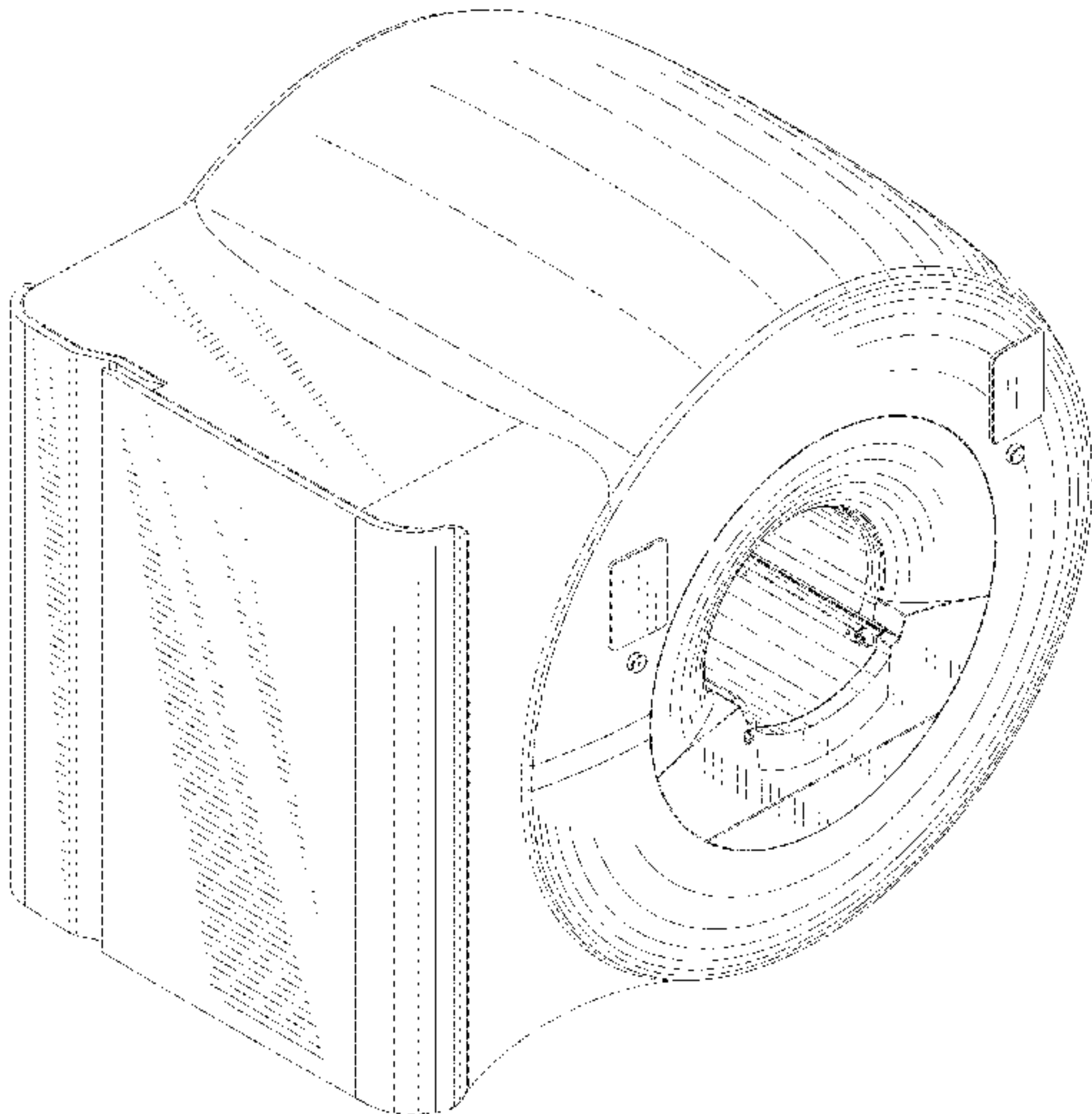
FIG. 7 is a top, front, right-side perspective view thereof;

FIG. 8 is an enlarged partial view of FIG. 7 showing the front opening of the bore; and,

FIG. 9 is an enlarged partial view of FIG. 2 showing the rear opening of the bore.

The unshaded areas and broken lines depicting the remainder of the medical imaging device form no part of the claimed design. 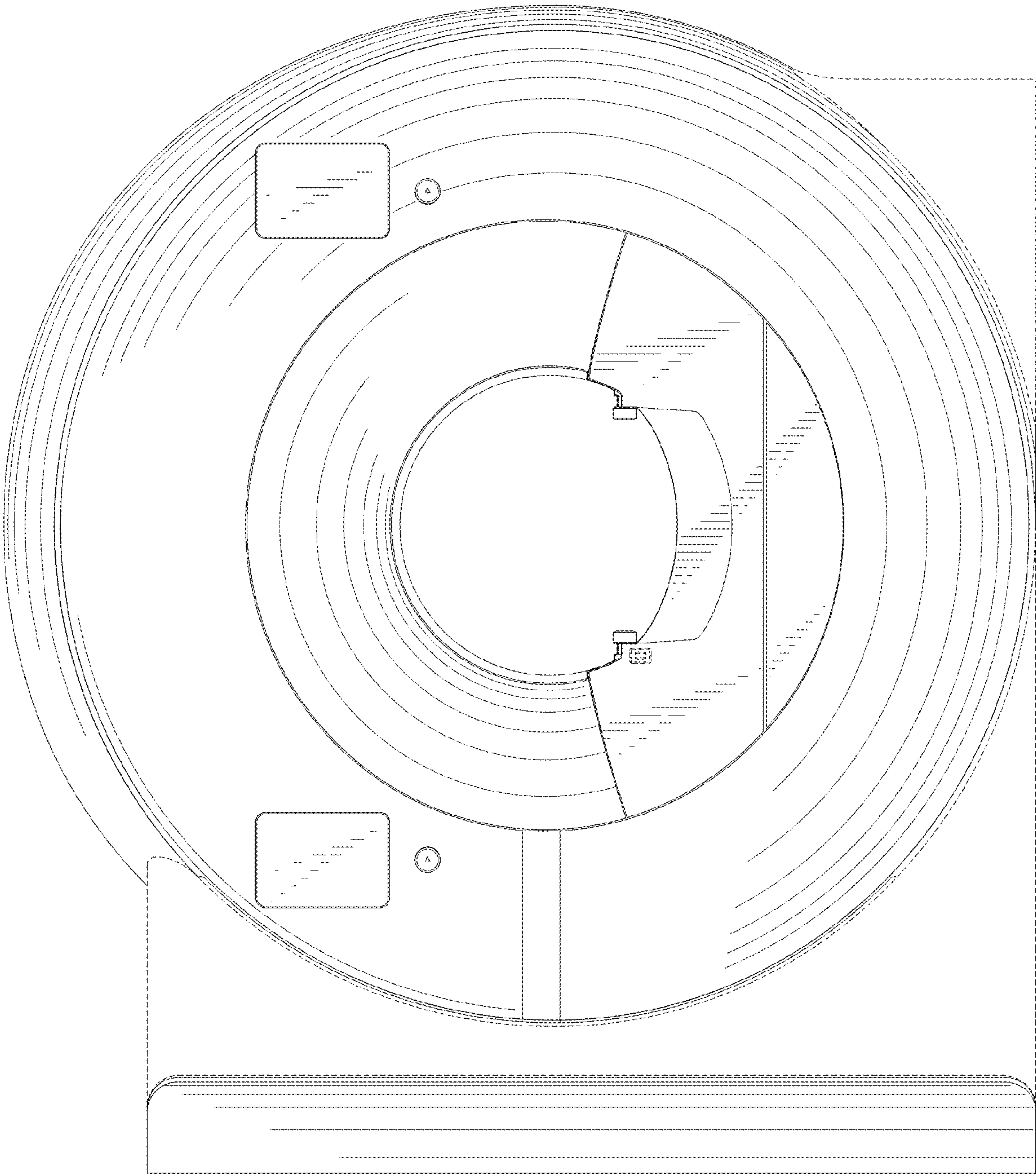

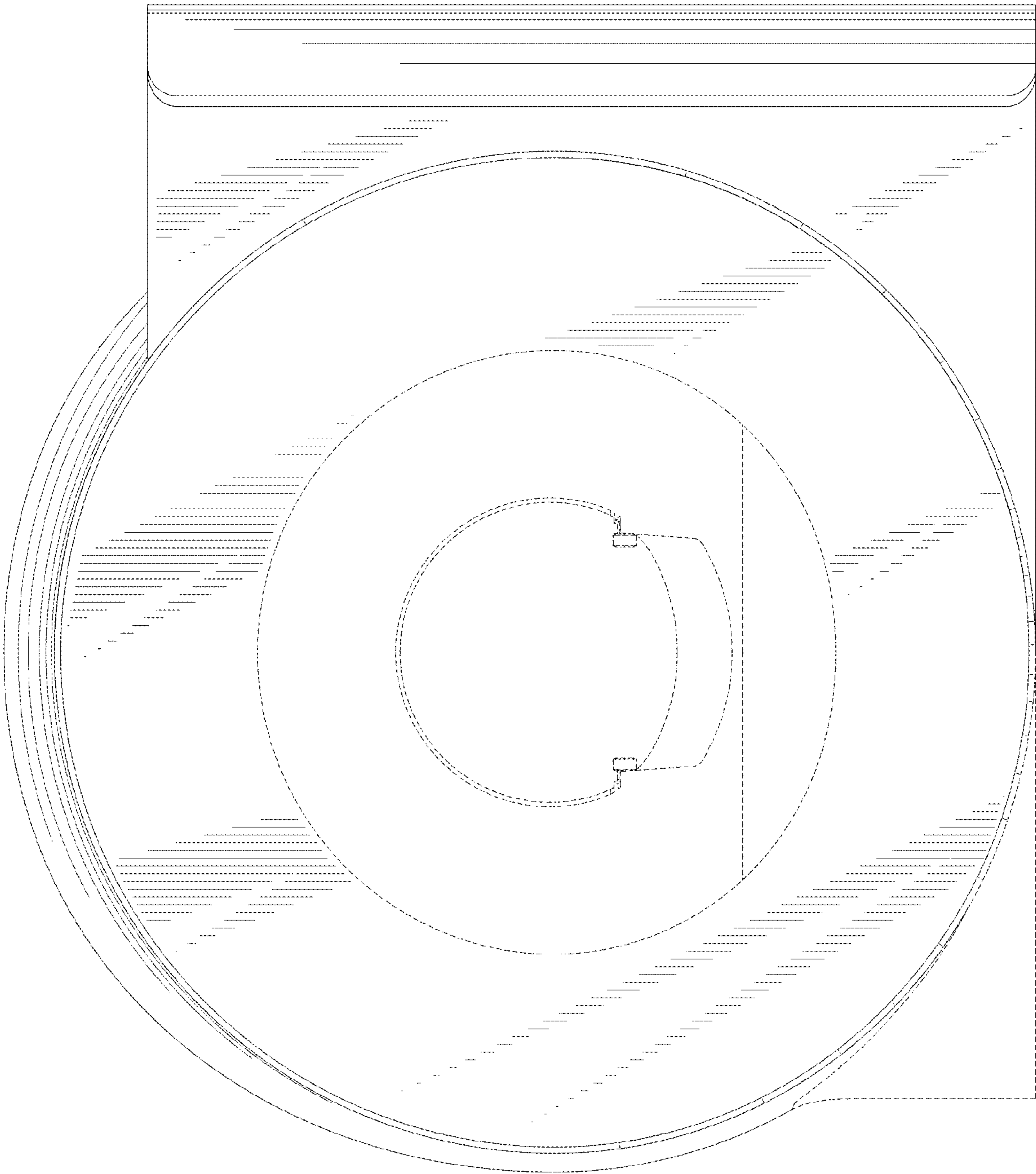

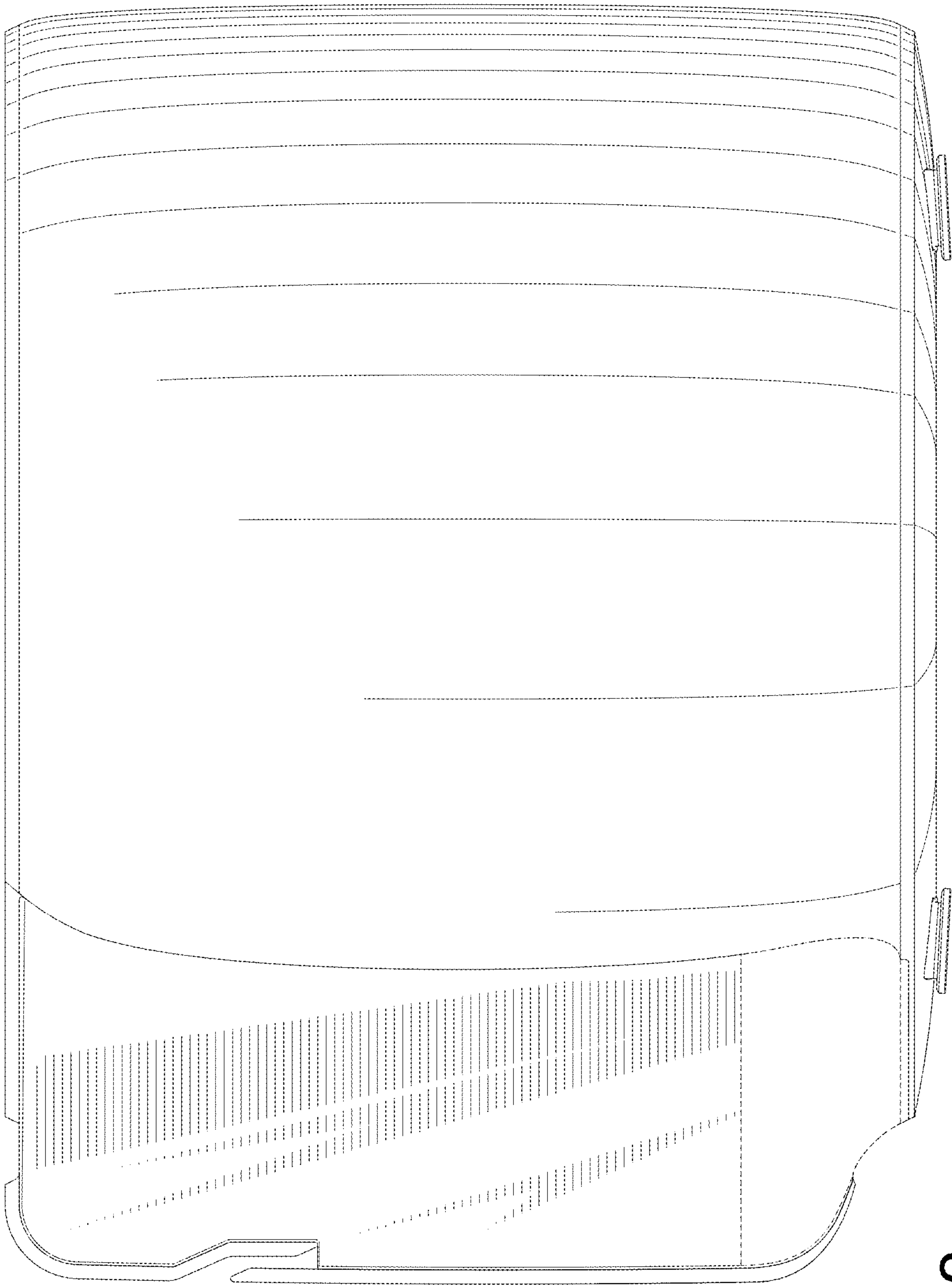
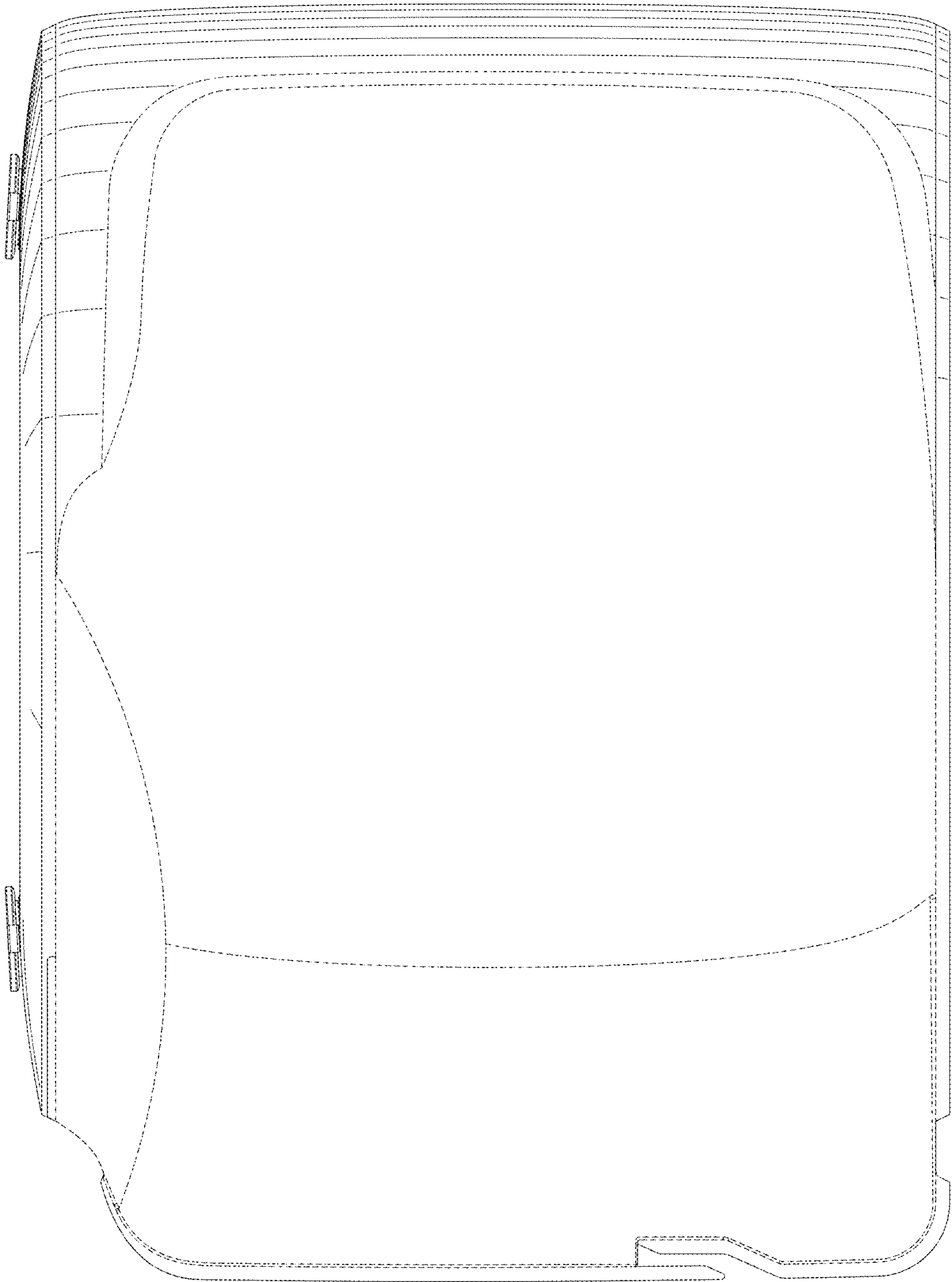

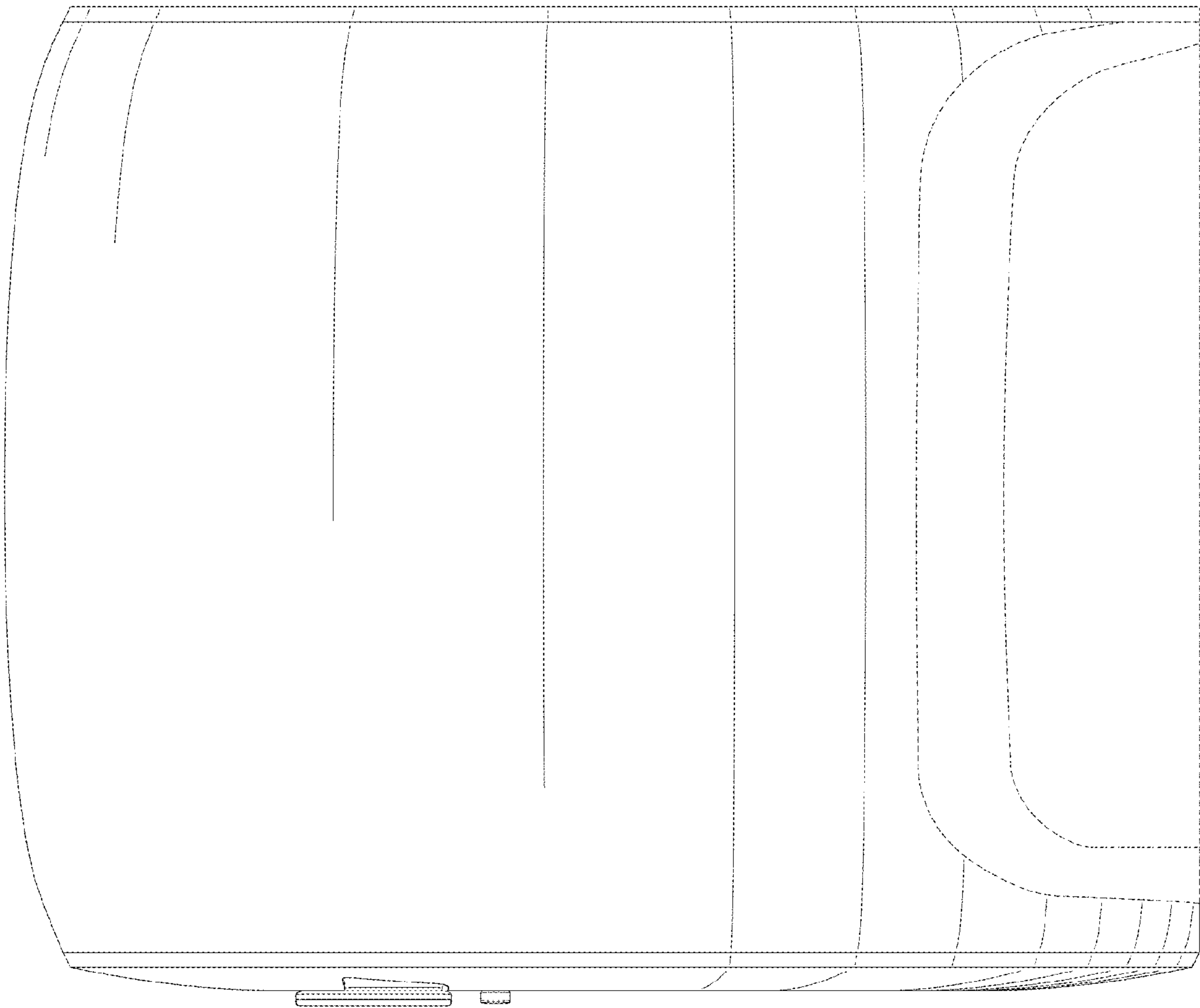

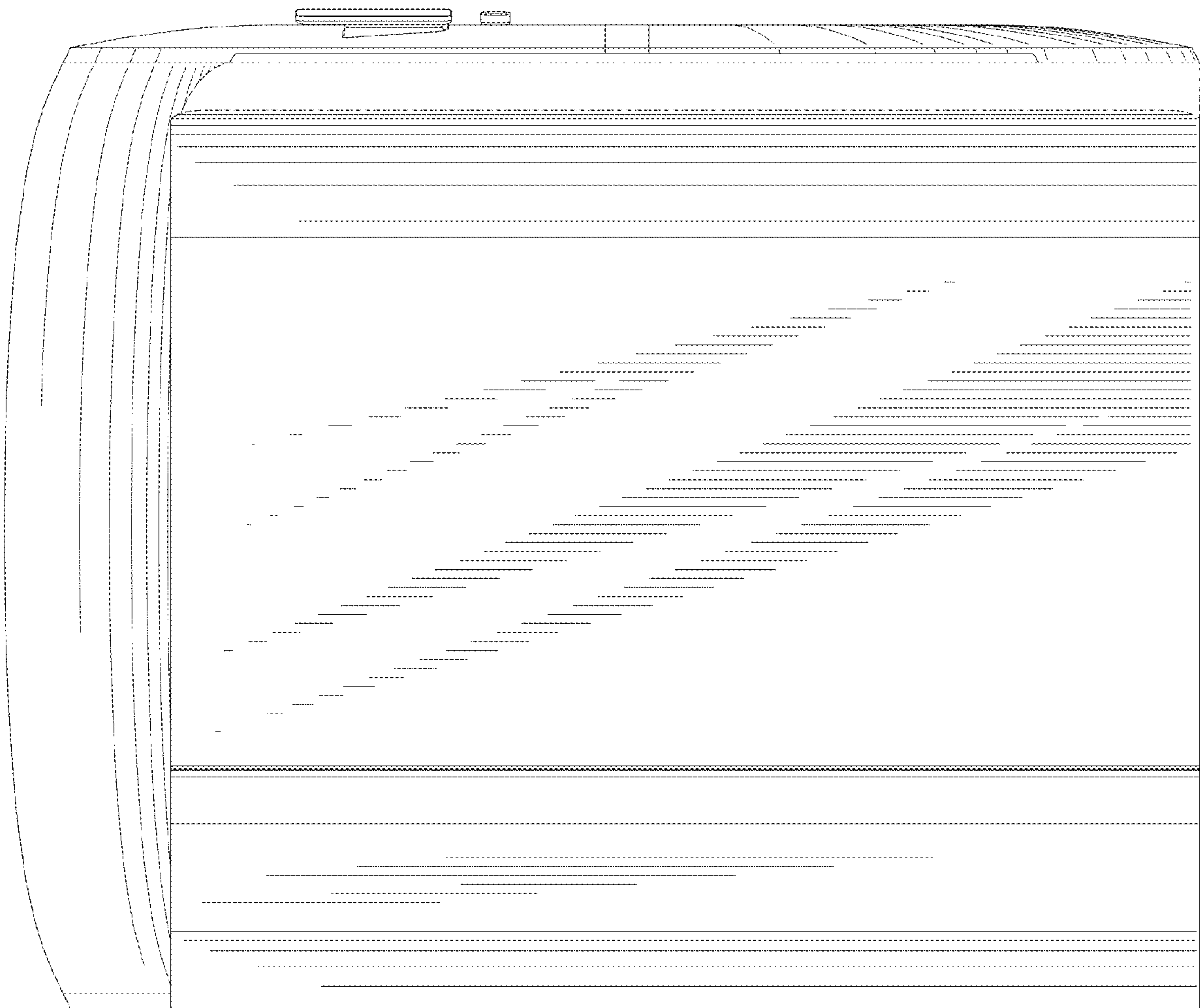

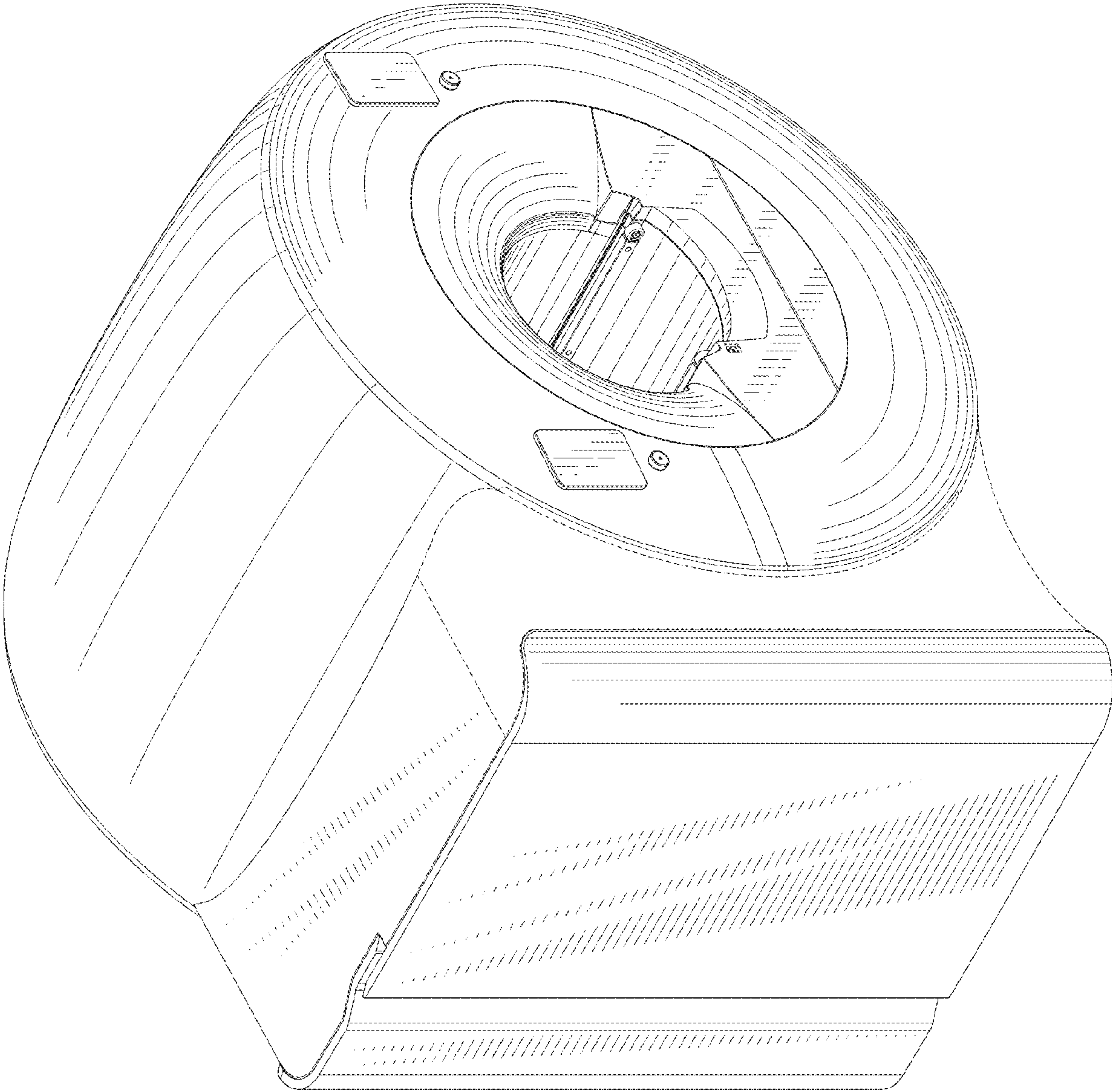

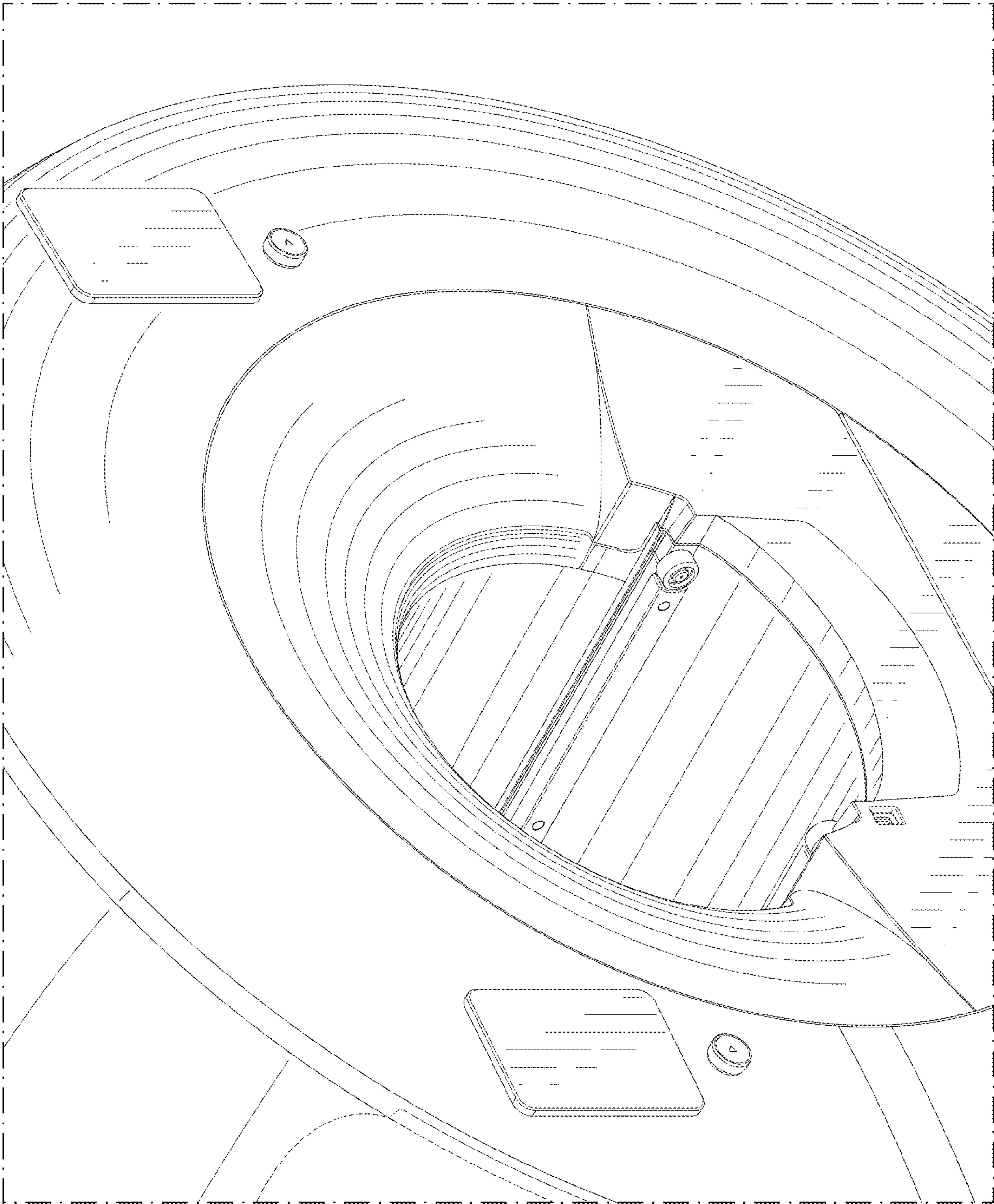

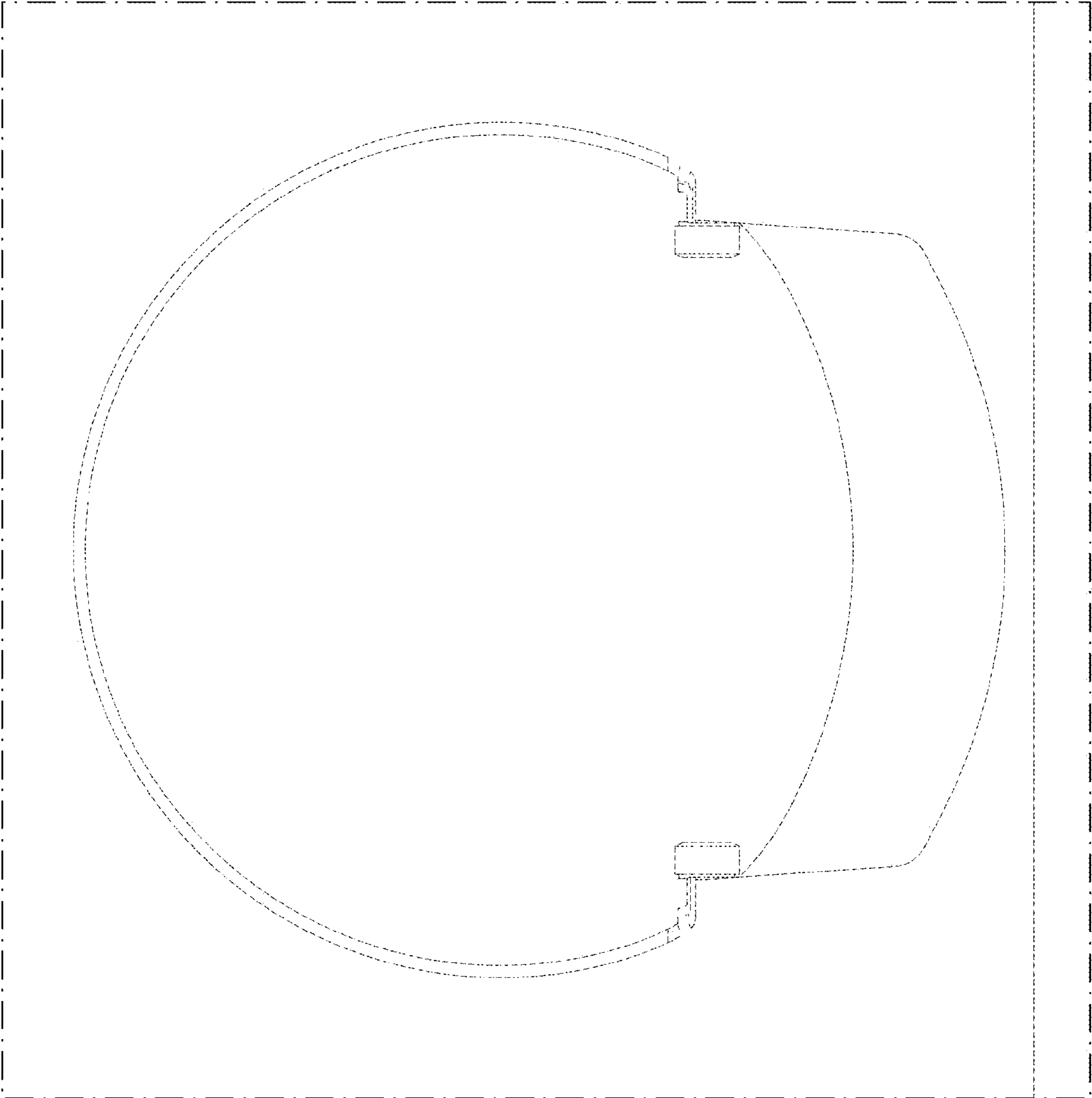
