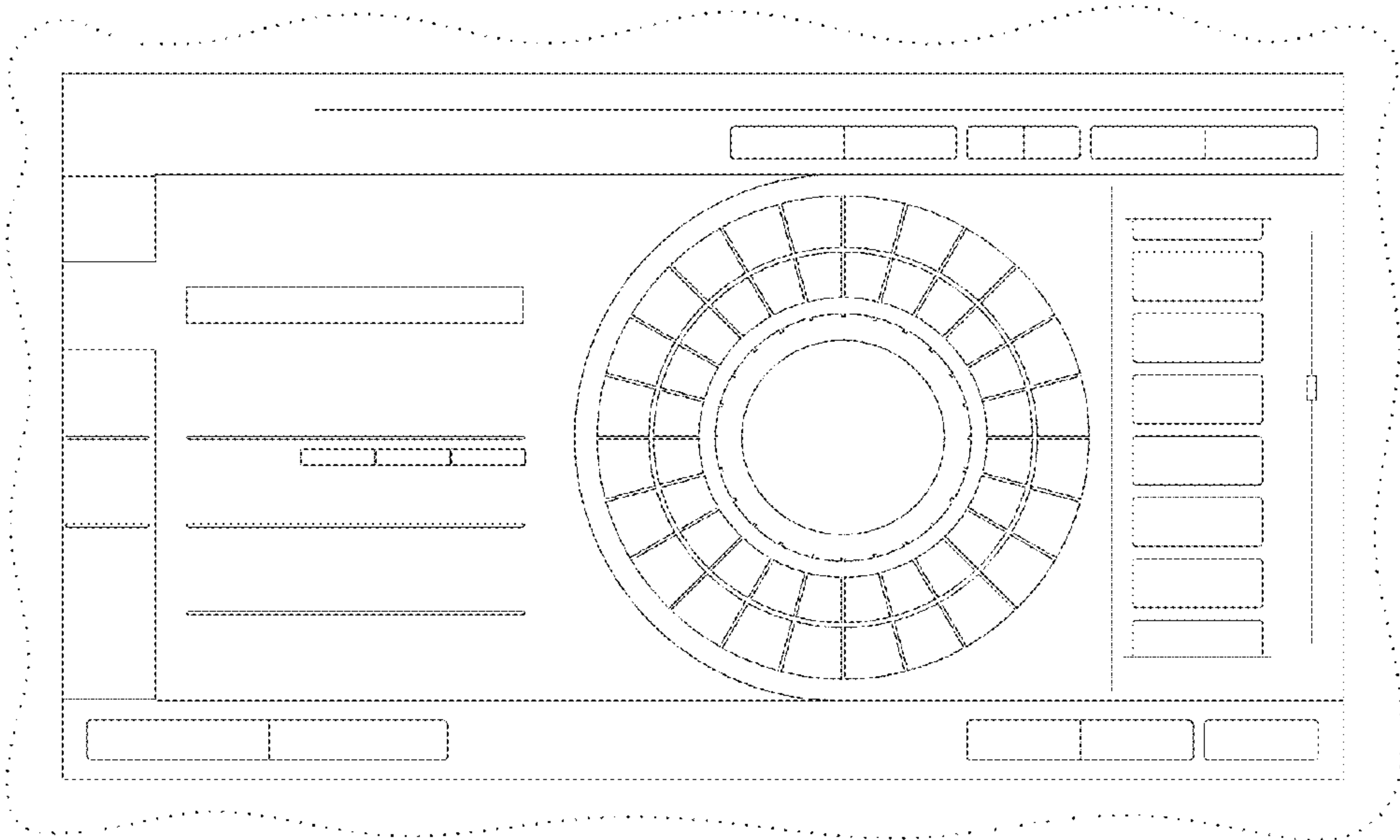
The ornamental design for a display screen or portion thereof with graphical user interface as shown and described.
