The ornamental design for a wireless controller, as shown and described.

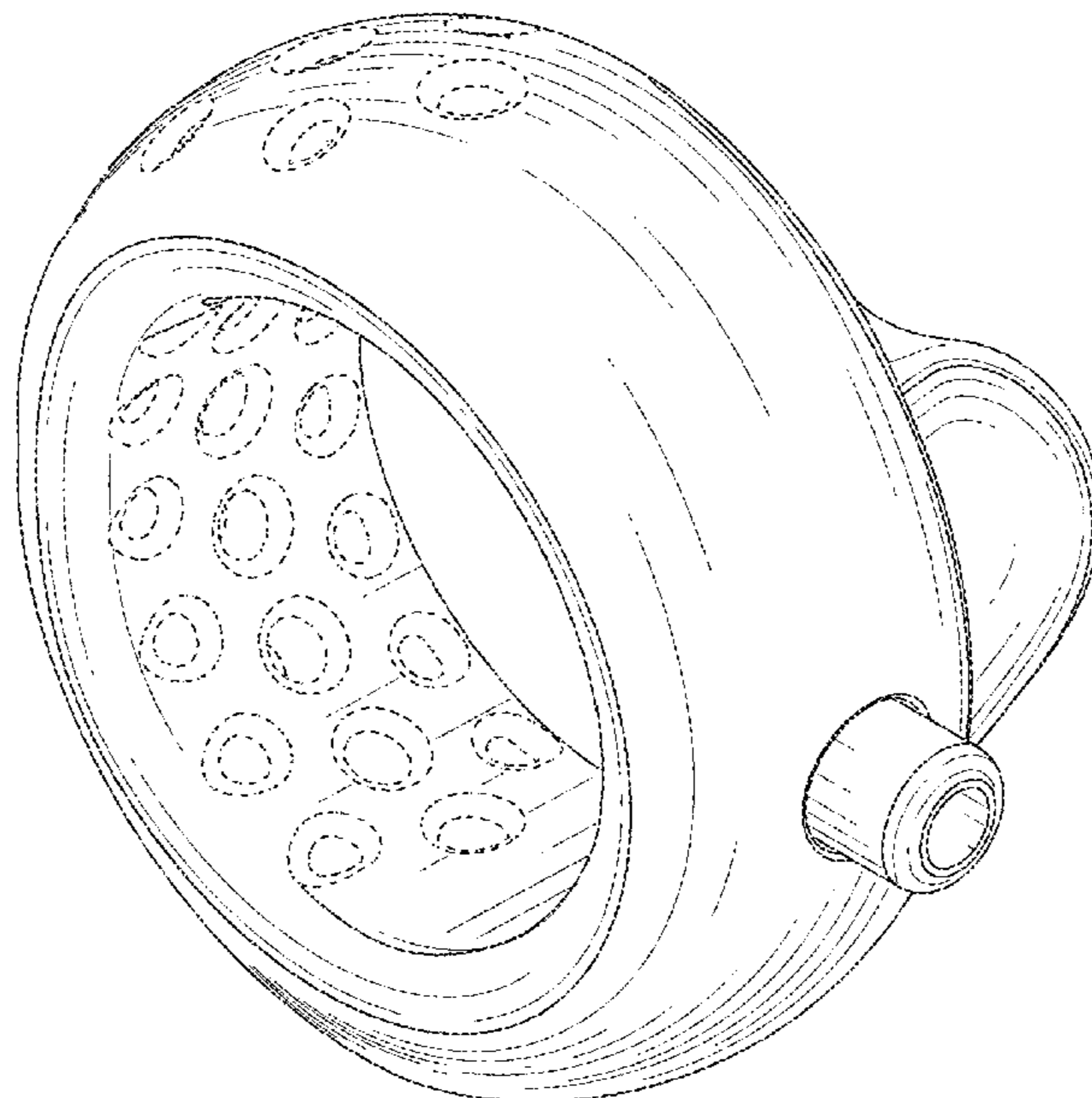
**DESCRIPTION**

FIG. 1 is a front-bottom-right perspective view of a wireless controller showing my new design;  
FIG. 2 is a rear-top-right perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom view thereof; and,

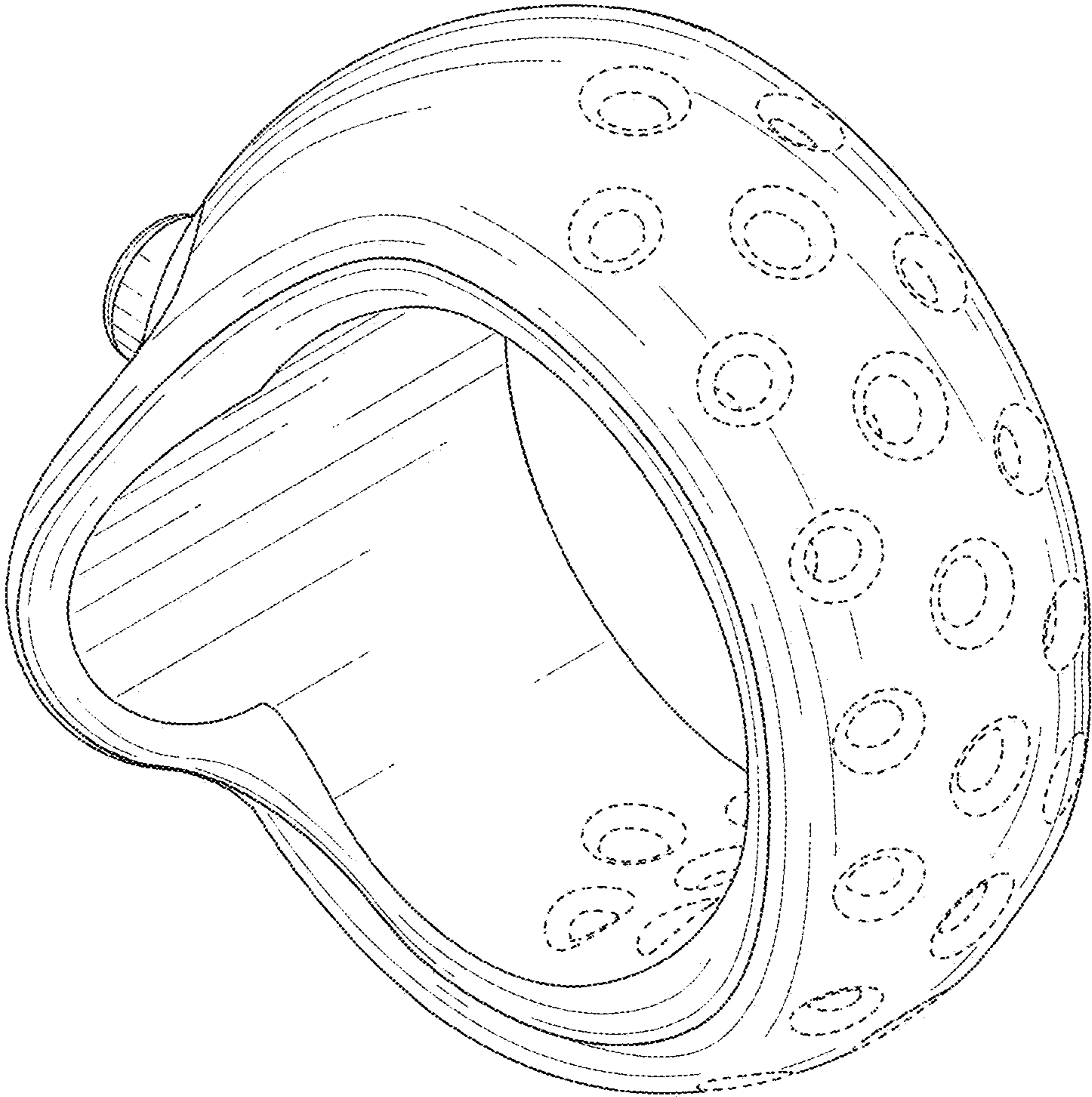

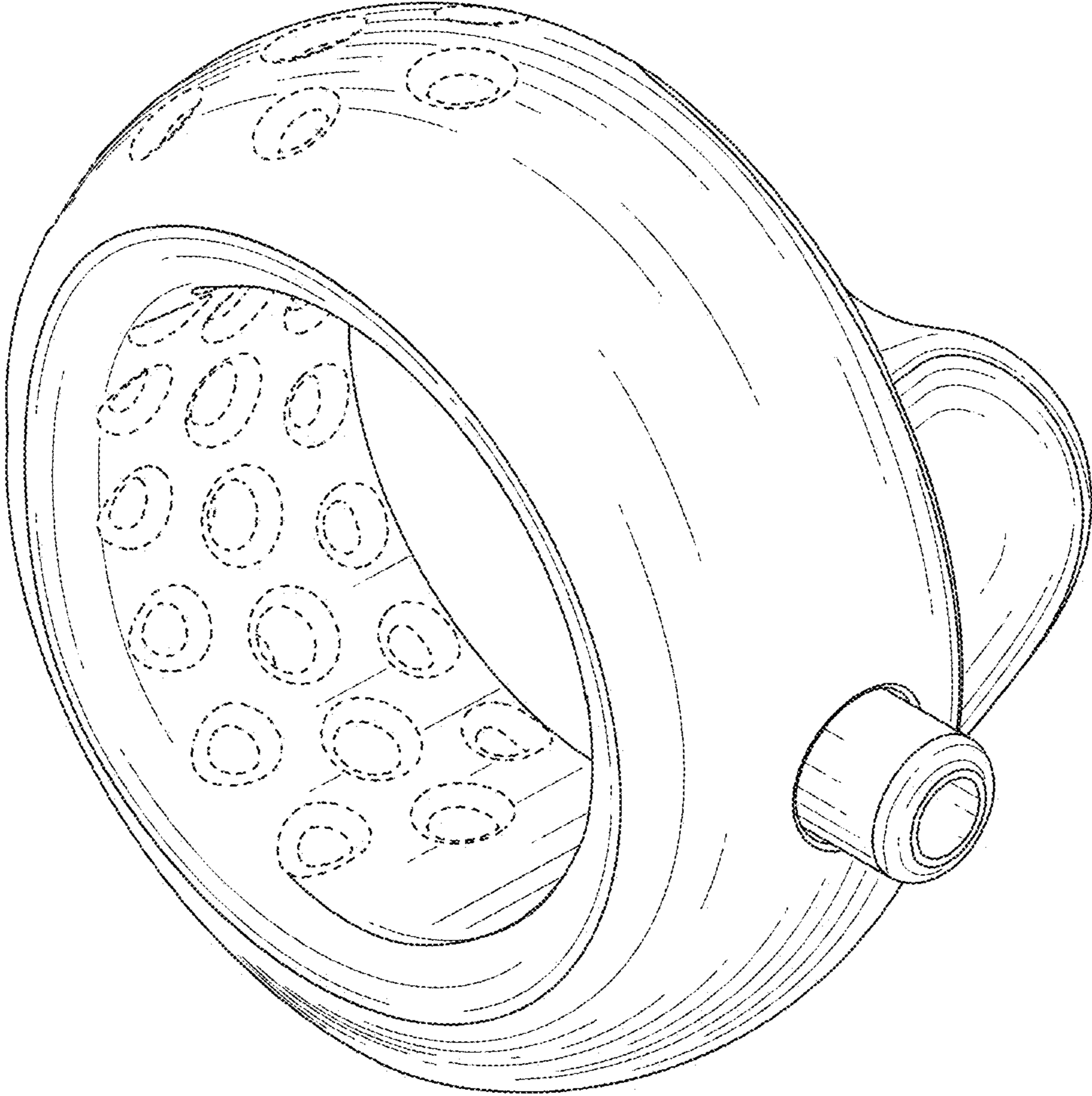

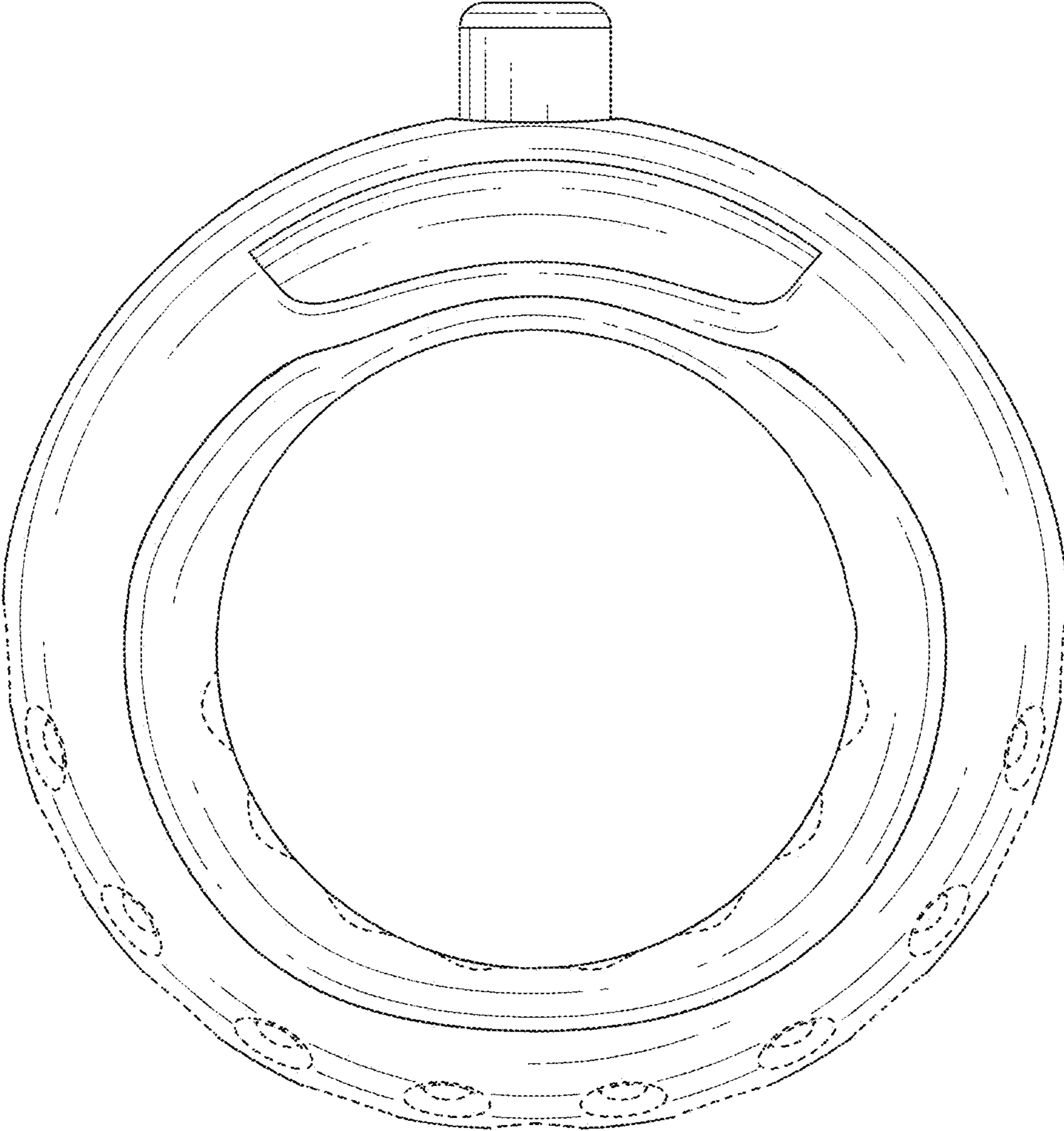

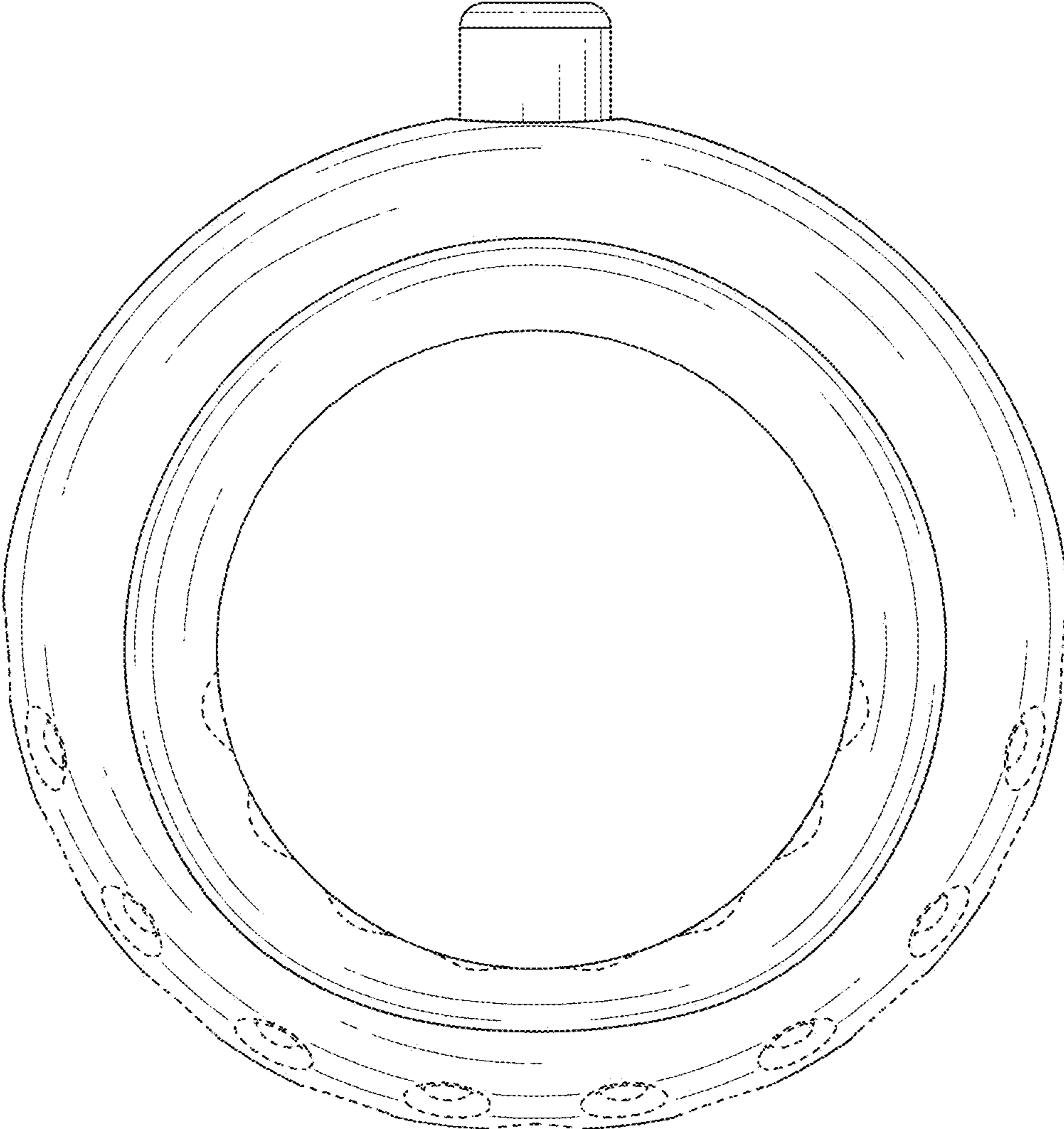

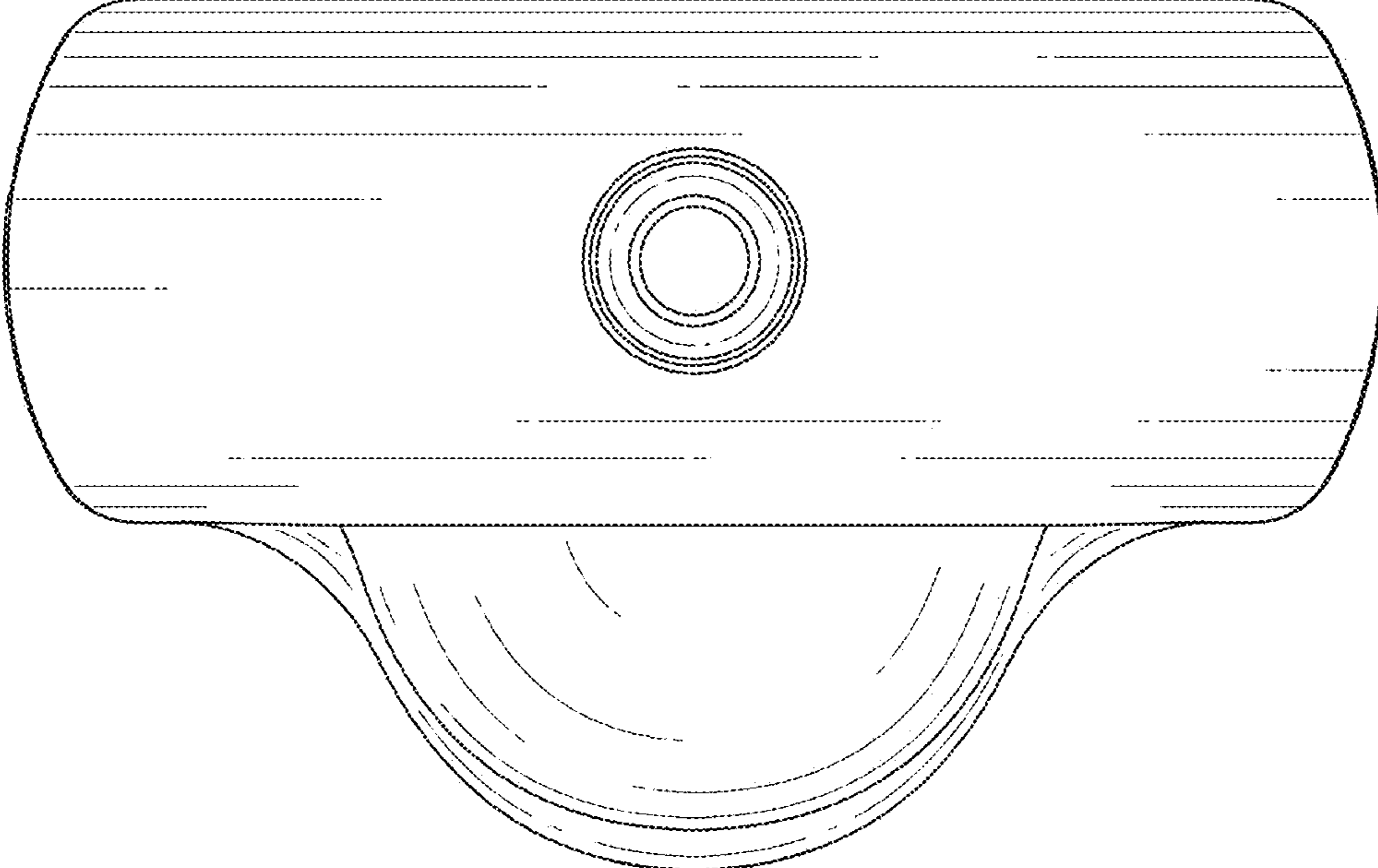

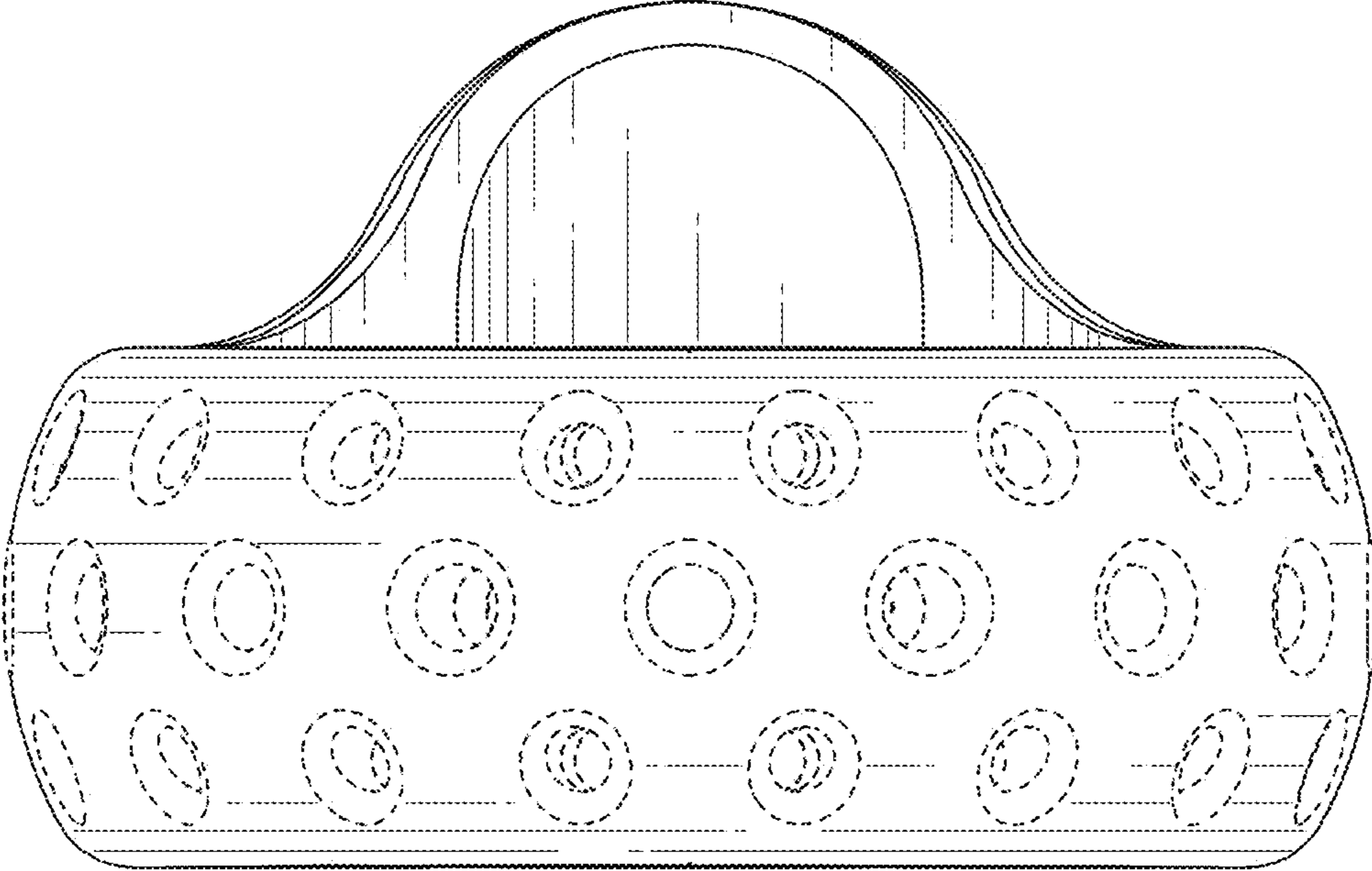

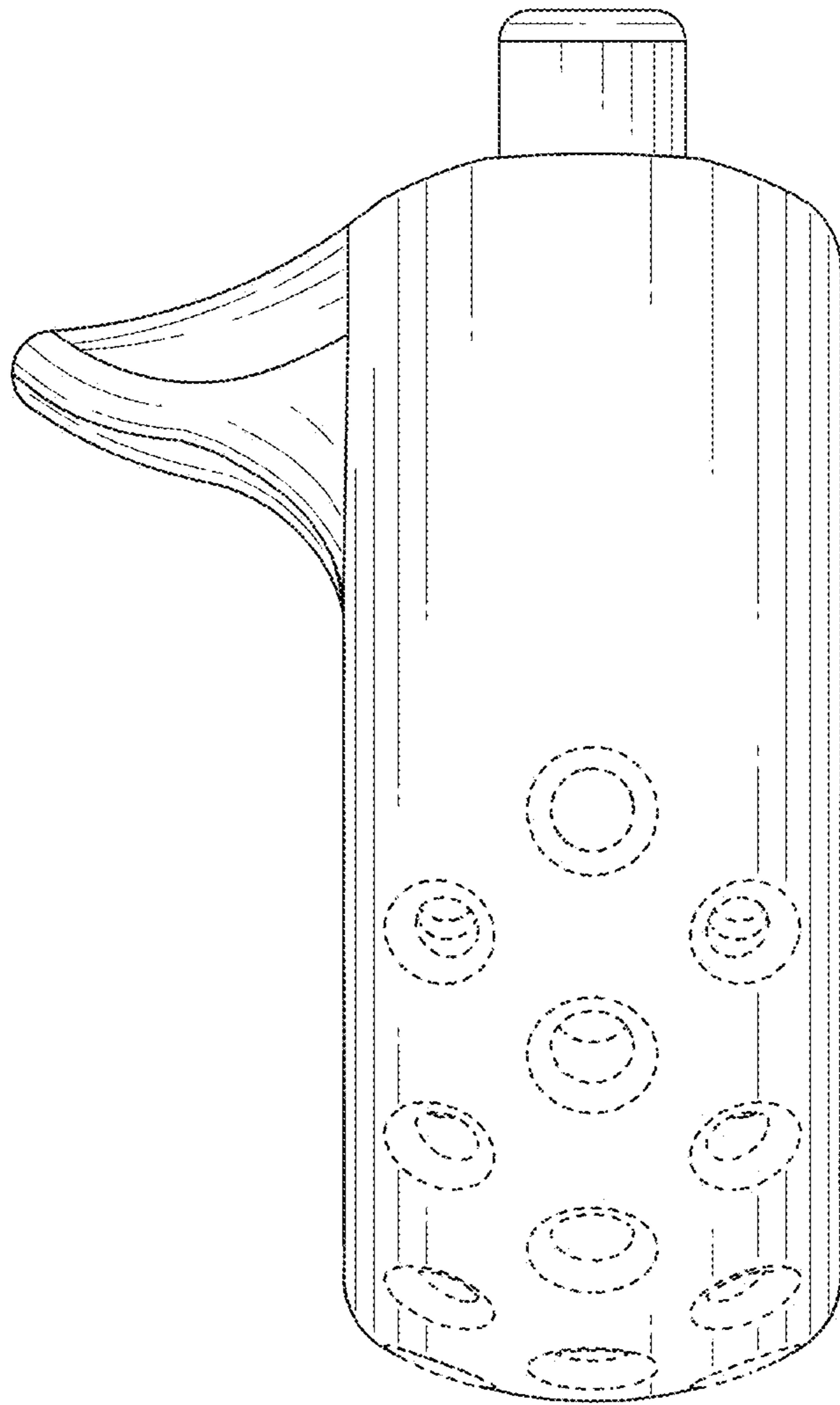
