The ornamental design for a toner container as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a toner container;

FIG. 2 is a rear, right side, top perspective view thereof;

FIG. 3 is a front, right side, bottom perspective view thereof;

FIG. 4 is a rear, left side, bottom perspective view thereof;

FIG. 5 is an elevation view of the right side thereof;

FIG. 7 is an elevation view of the rear thereof;

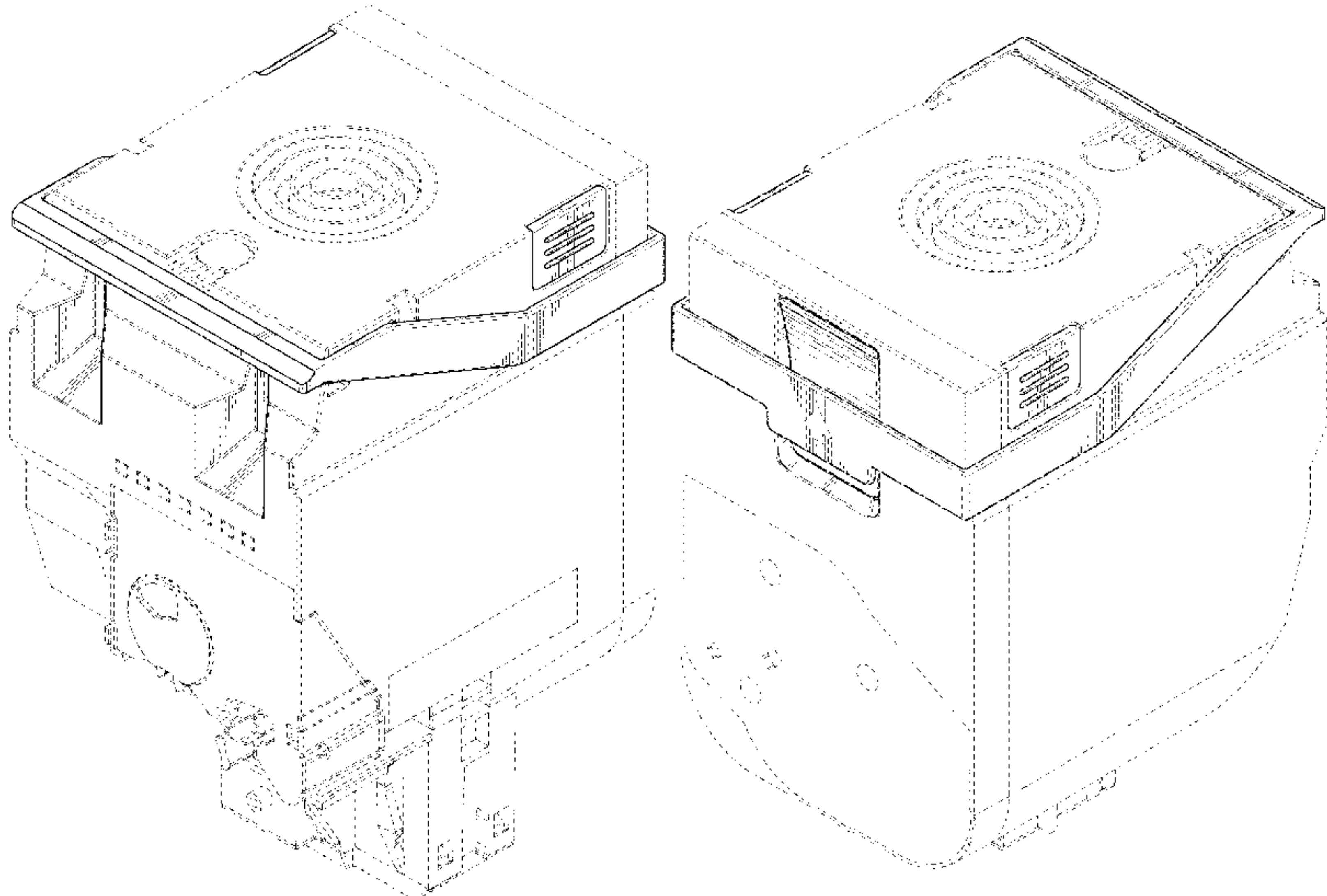
FIG. 8 is an elevation view of the left side thereof;

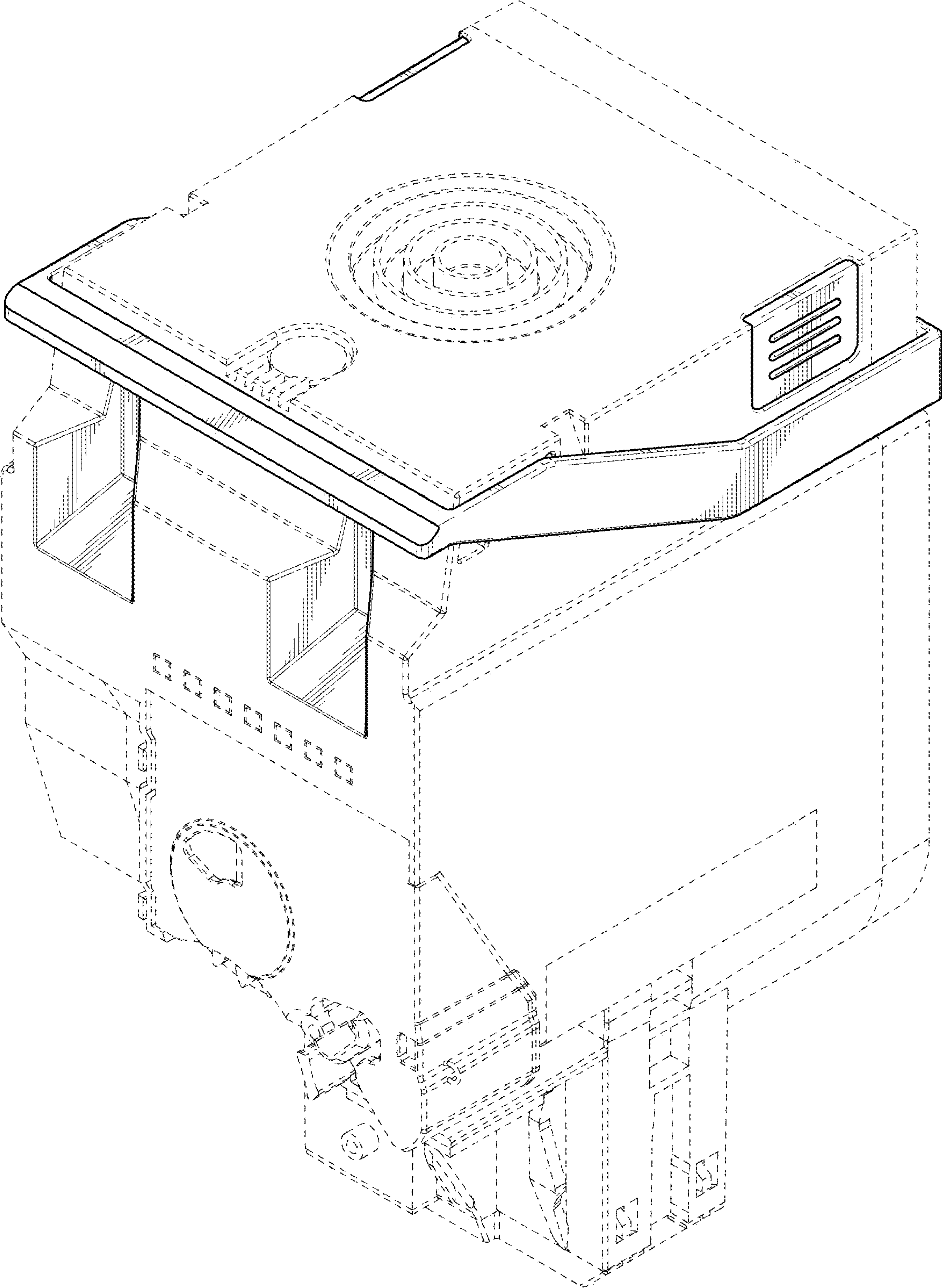

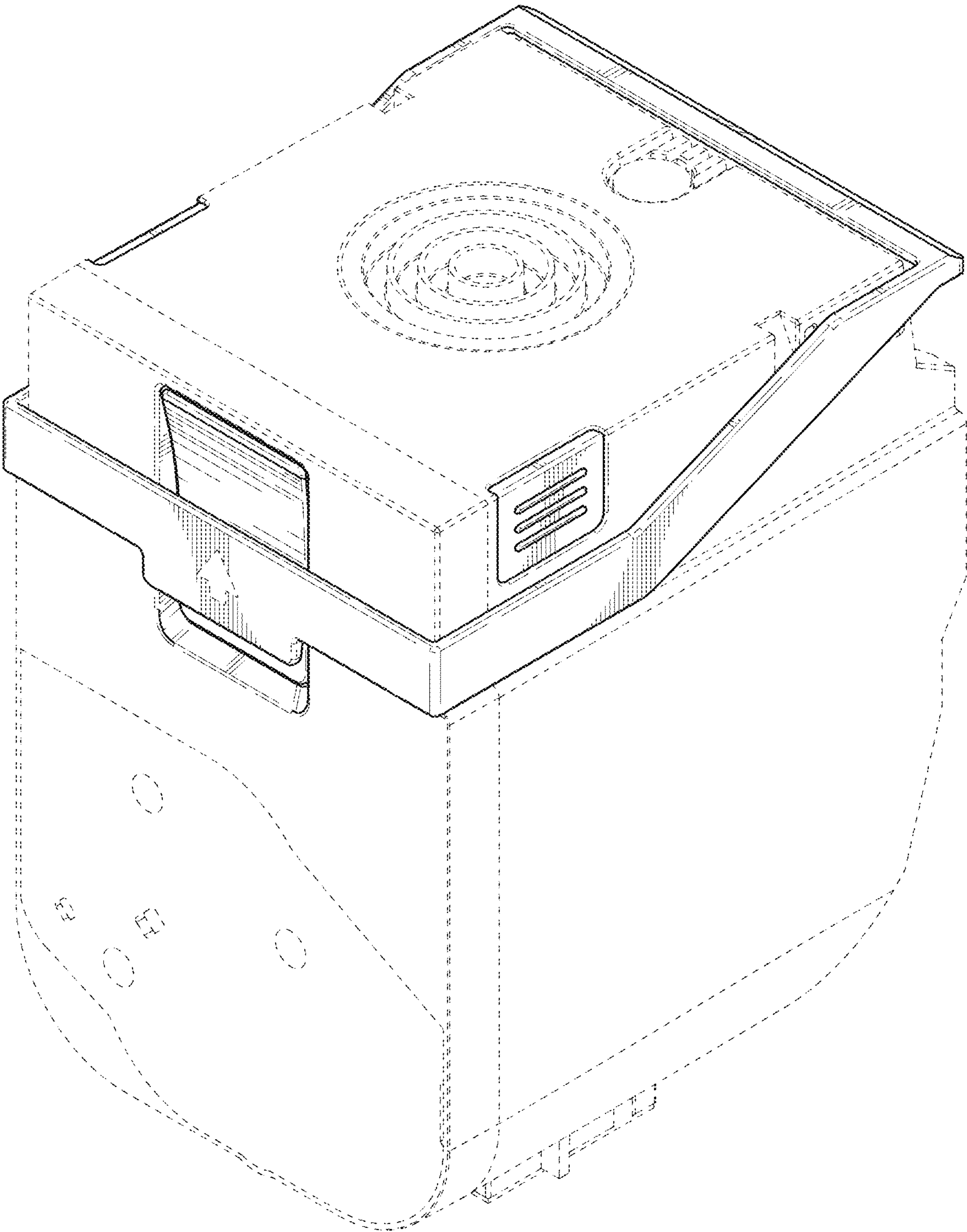

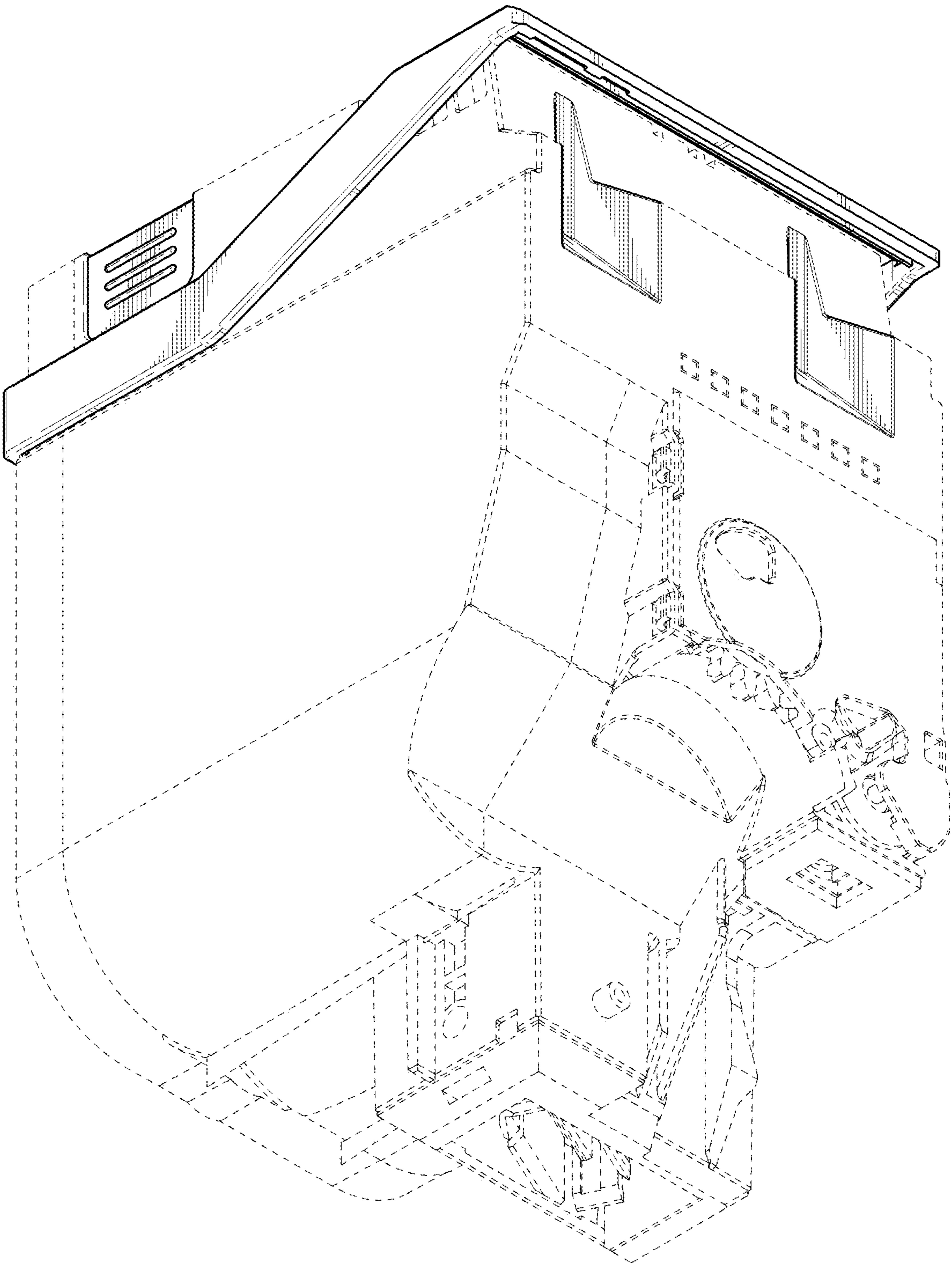

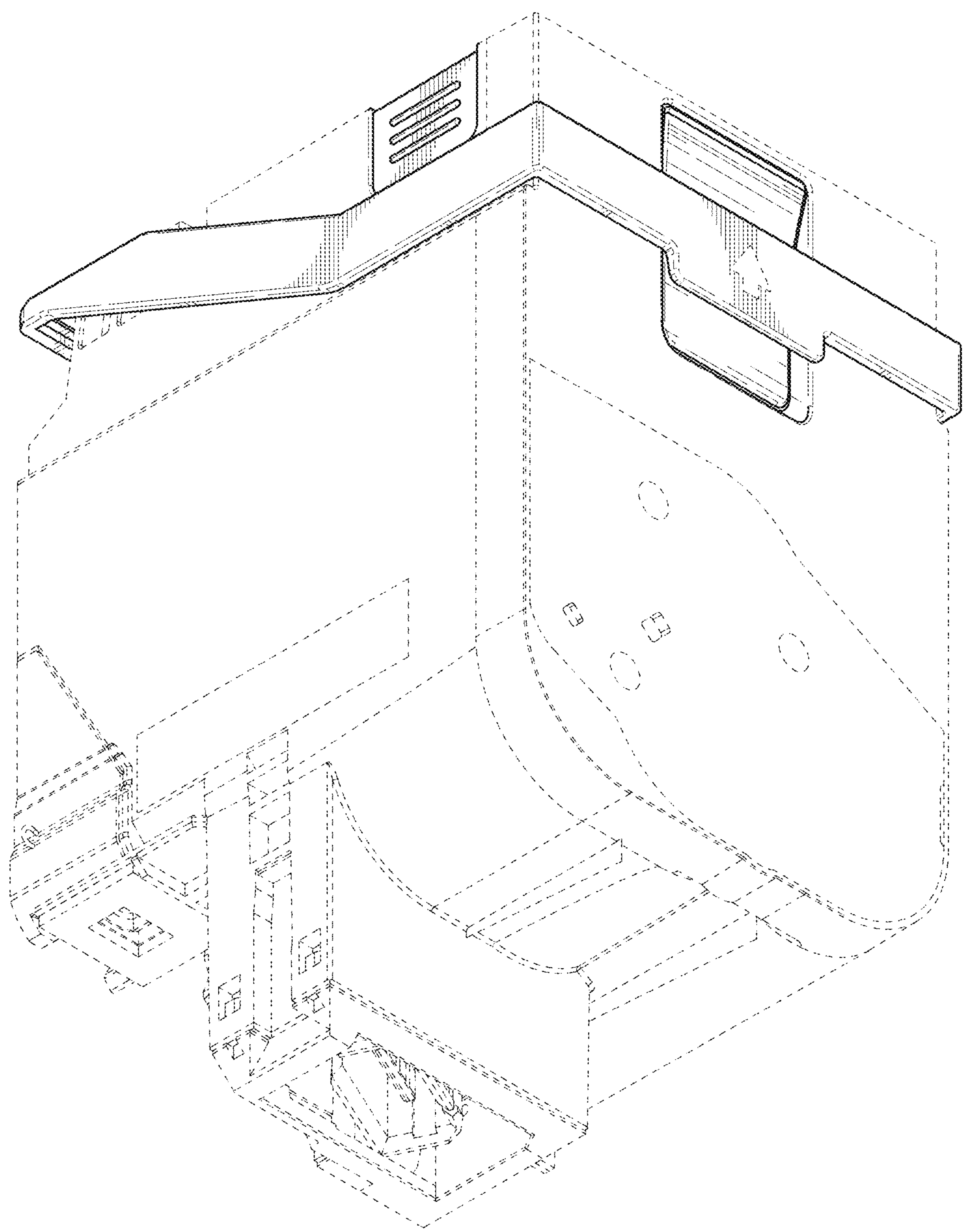

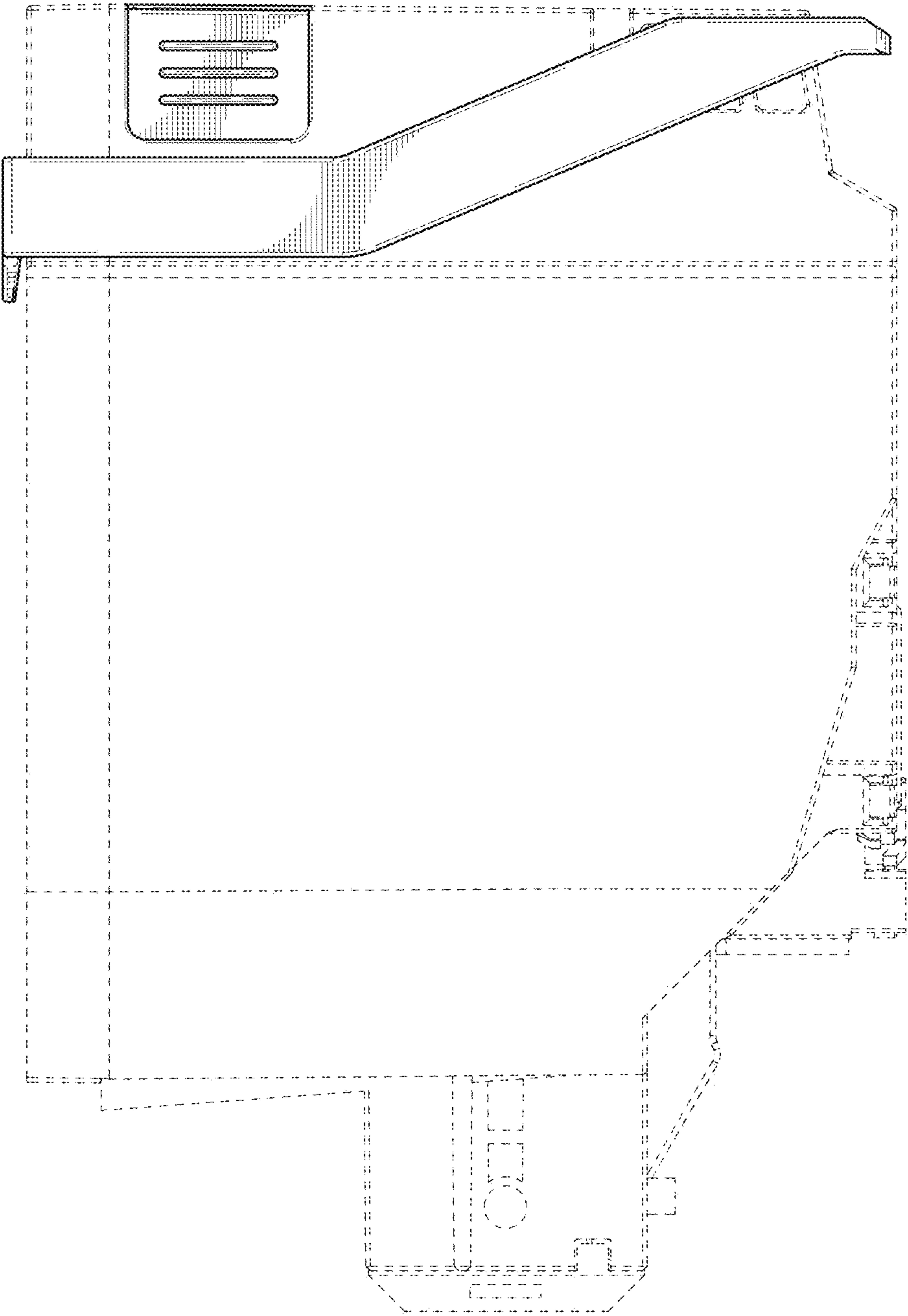

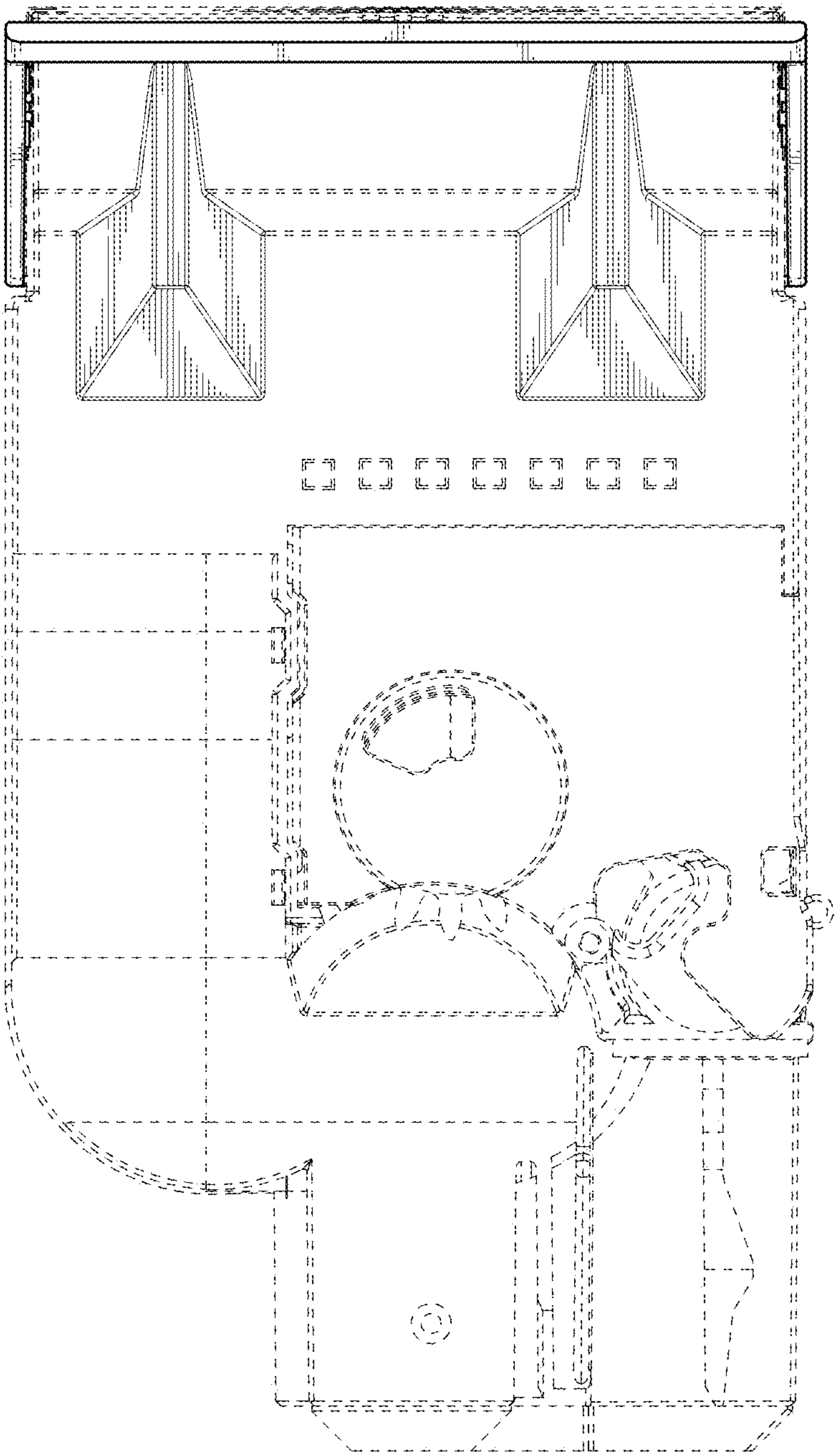

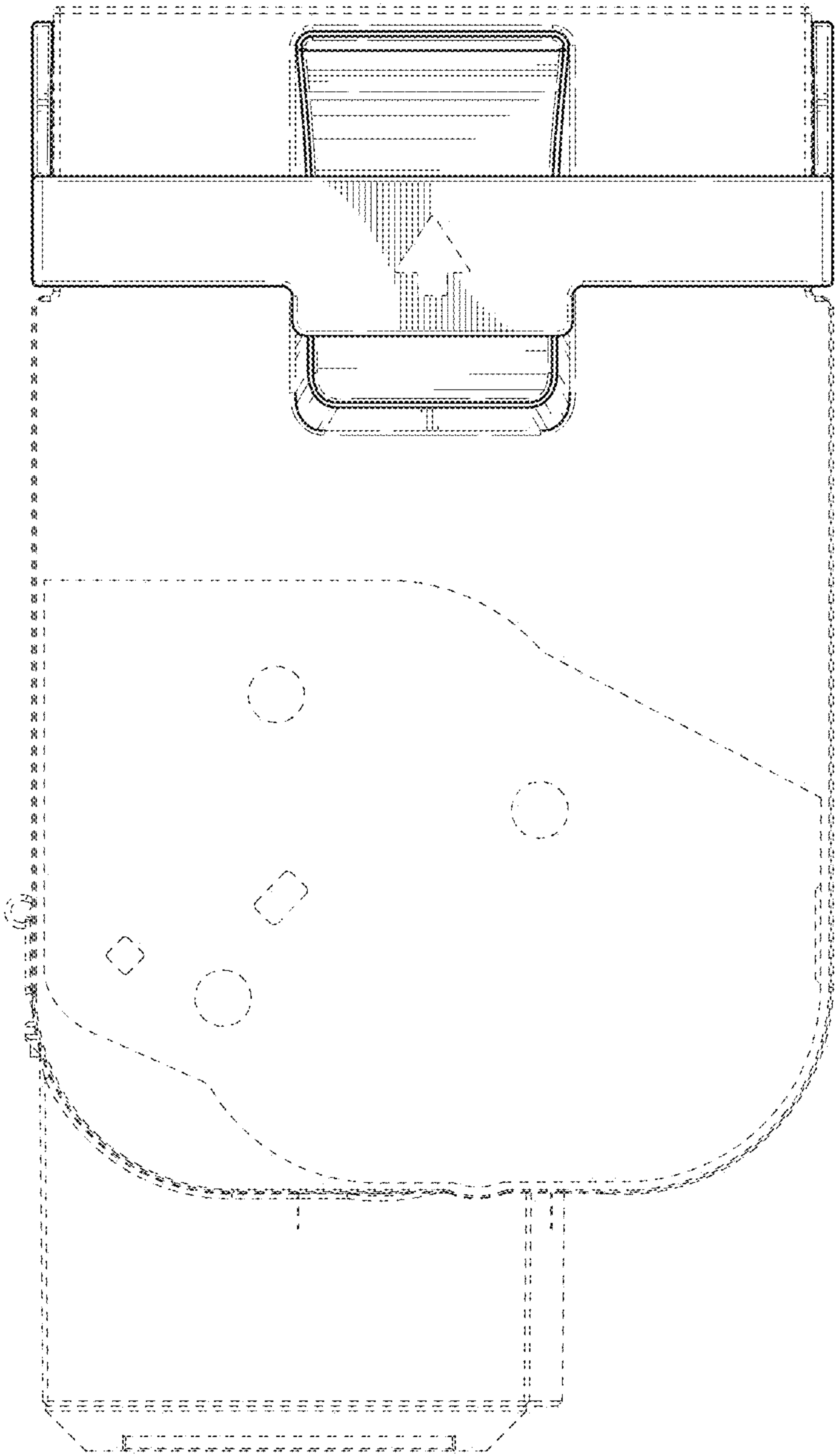

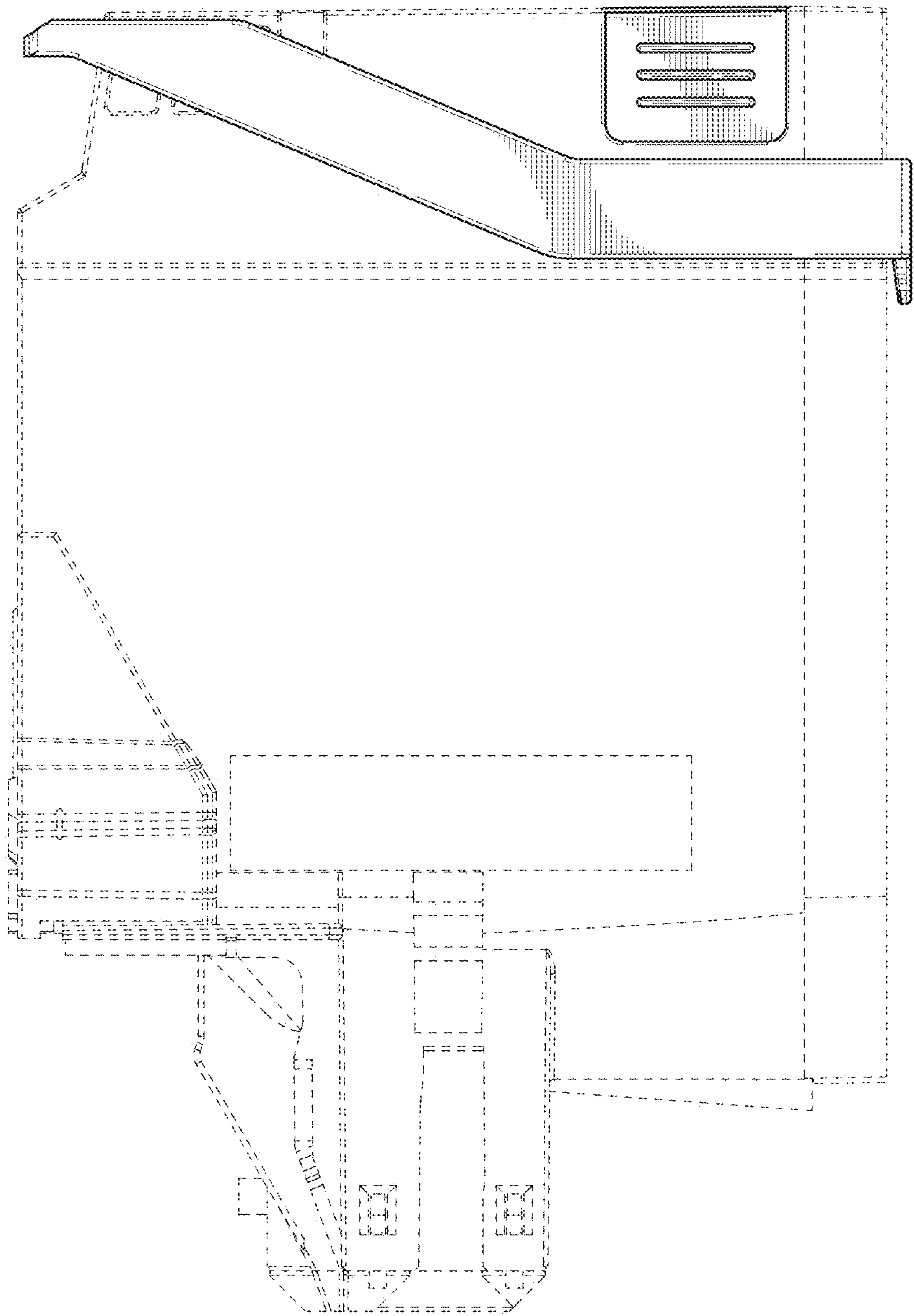

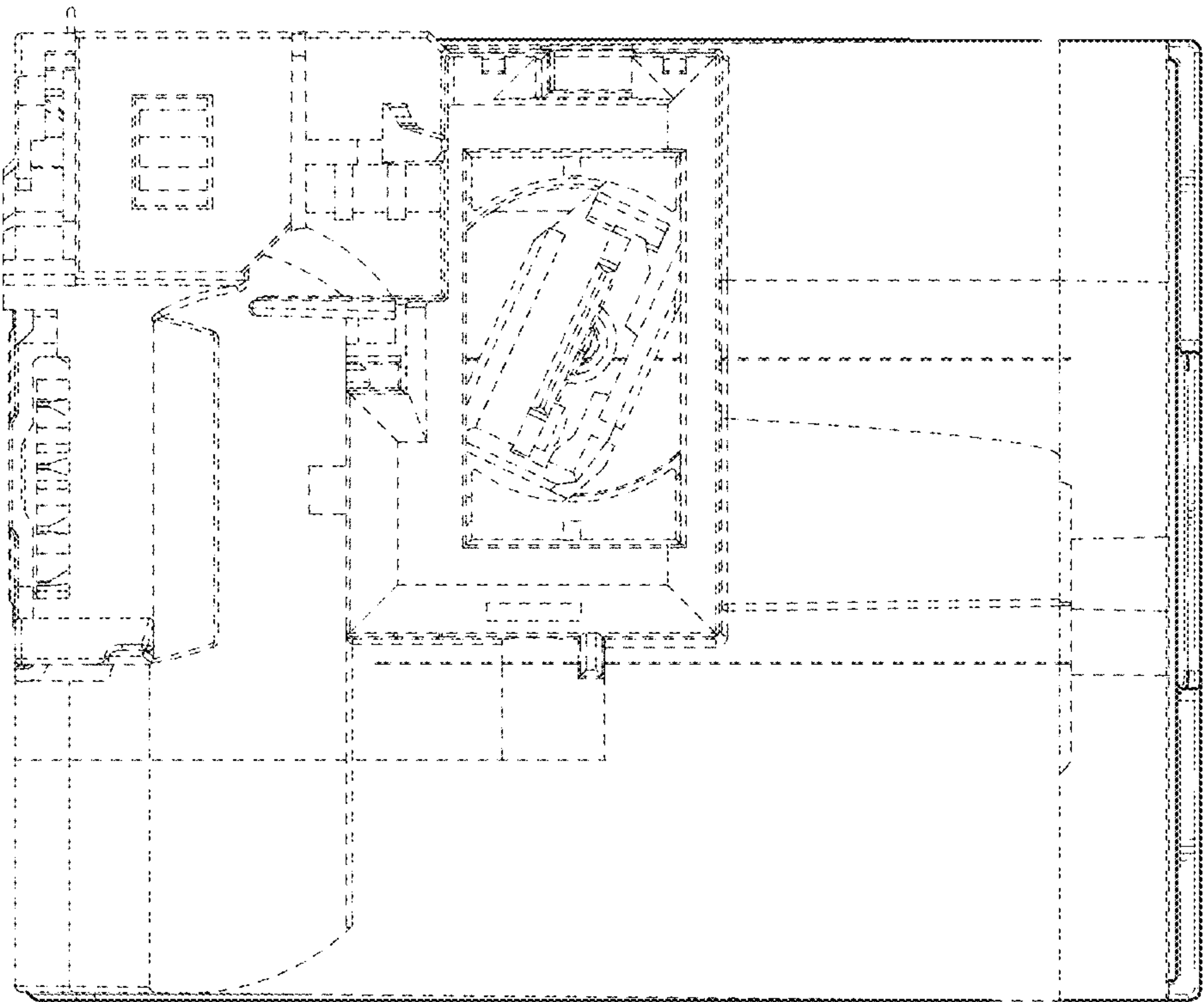

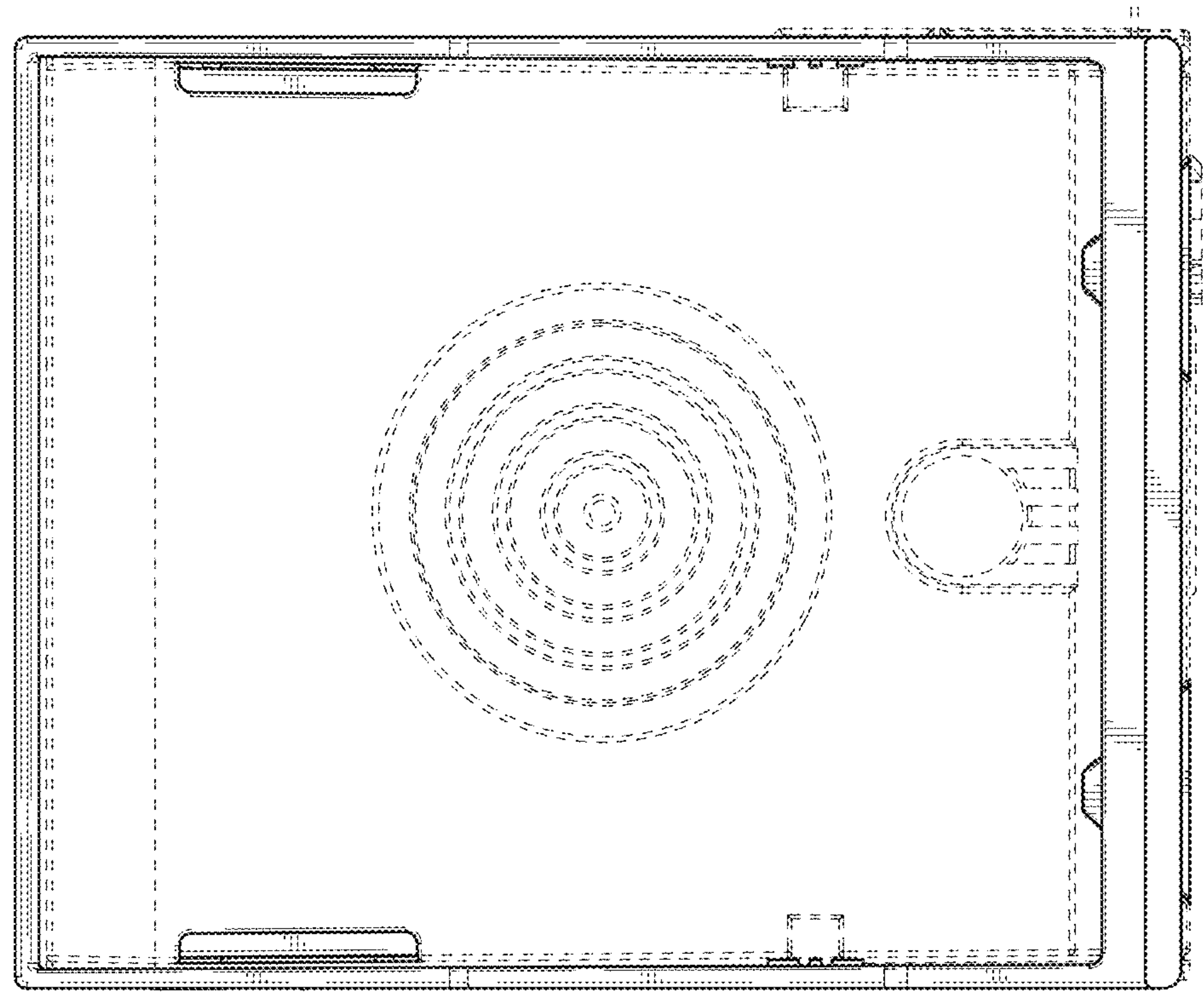
