DESCRIPTION

FIG. 1 is a bottom right rear perspective view of a first embodiment of a battery pack showing our new design.

FIG. 12 is a rear elevation view of the battery pack of FIG. 9.

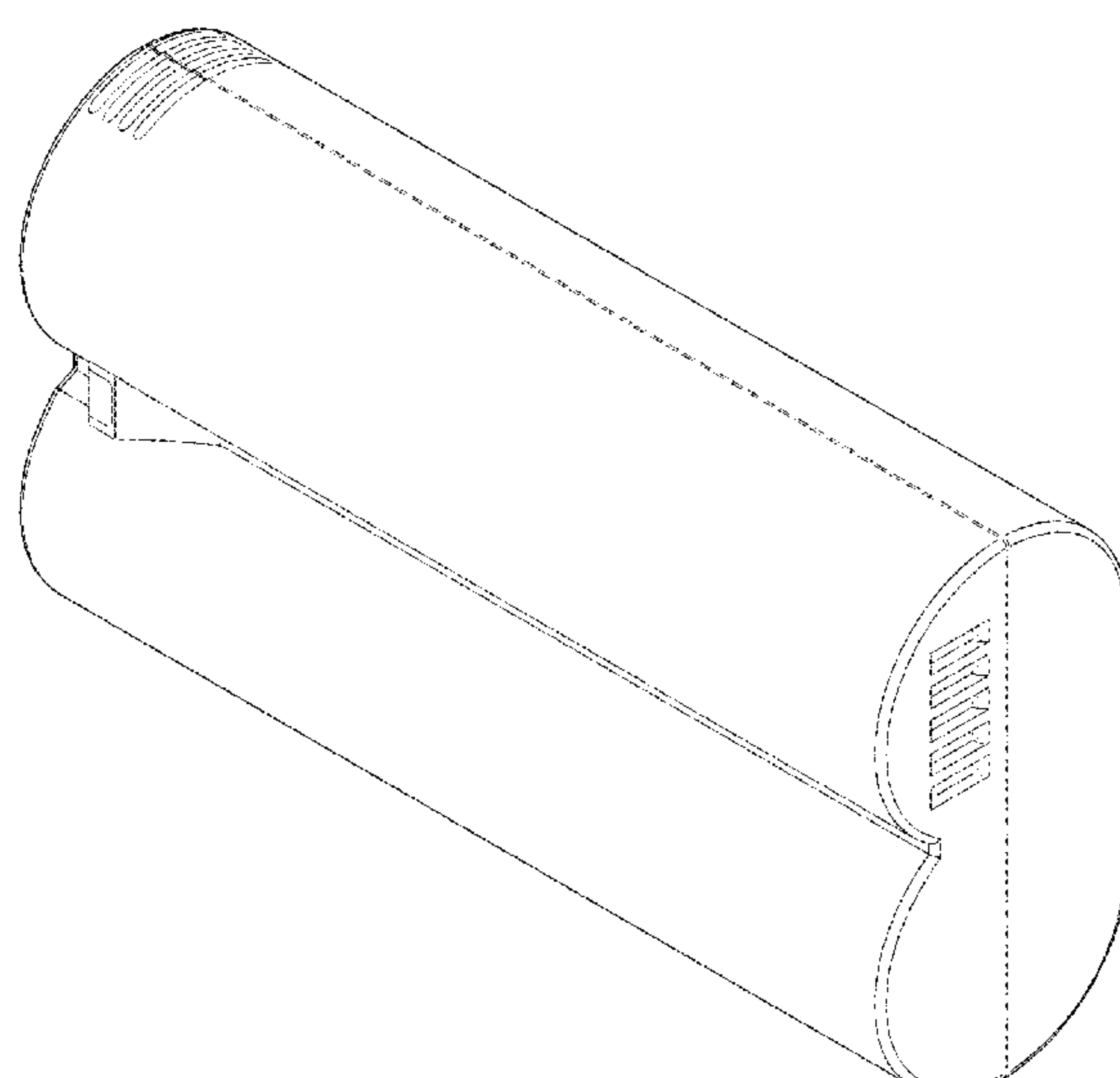
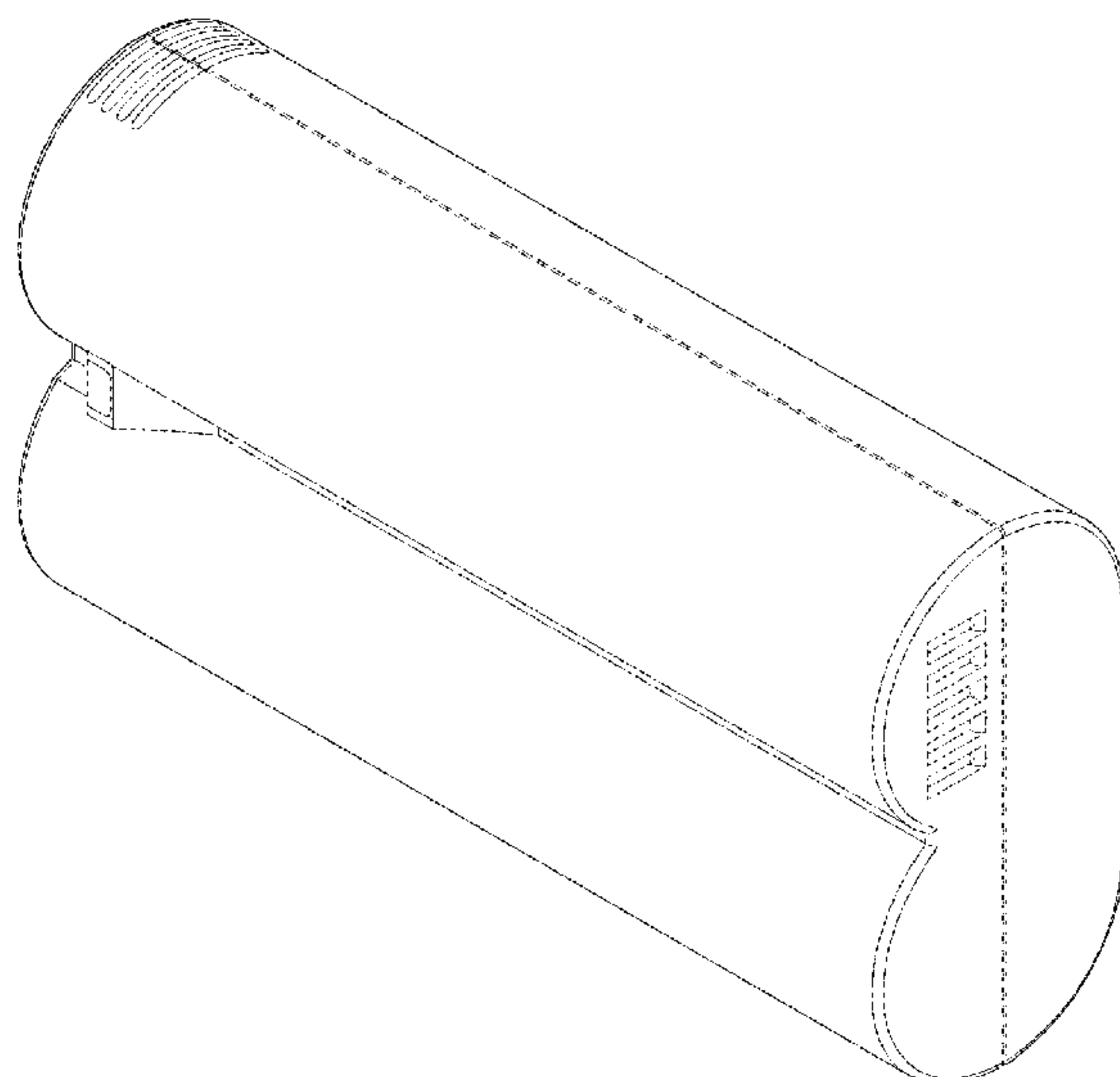
FIG. 13 is a right side elevation view of the battery pack of FIG. 9.

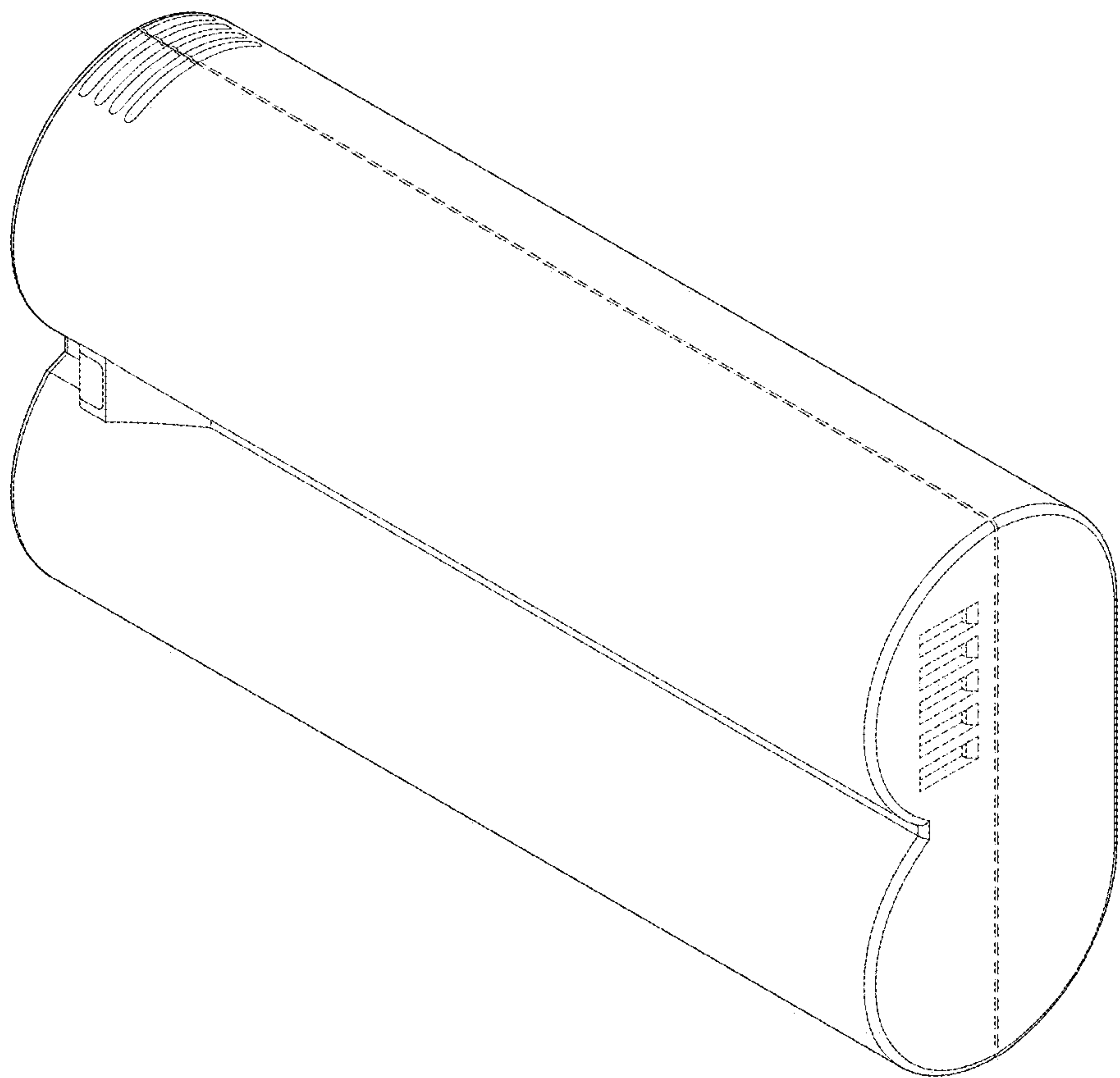

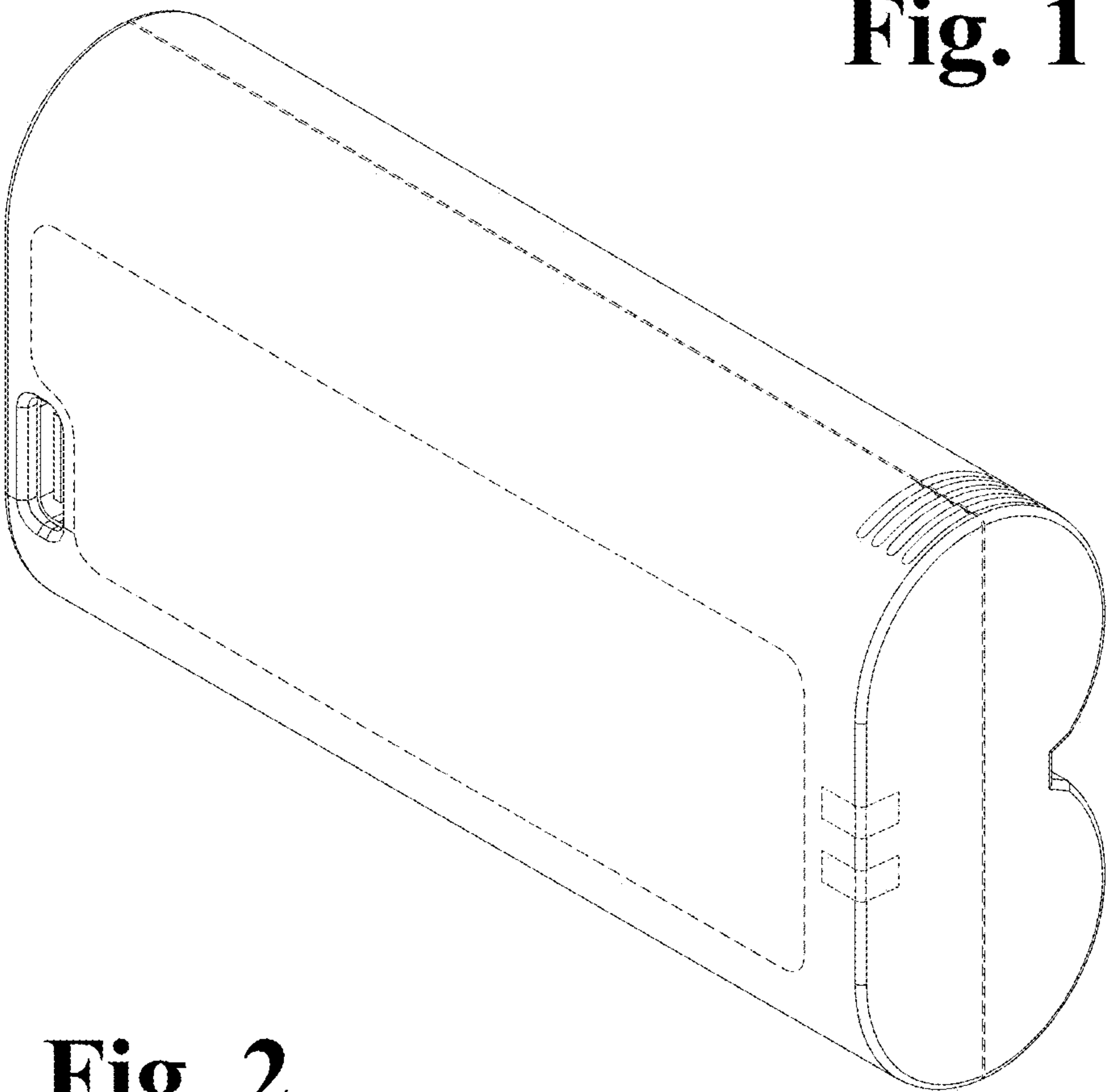

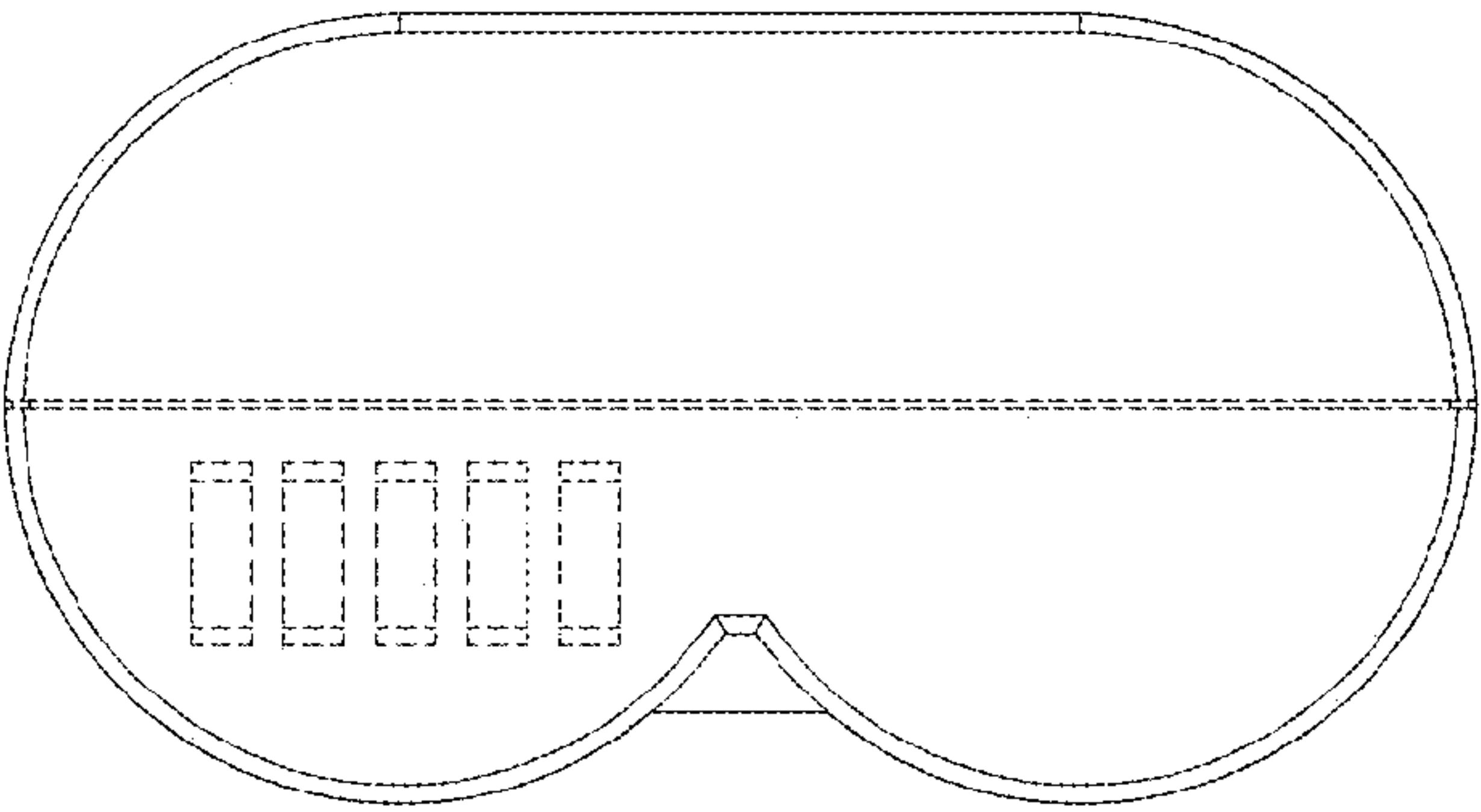
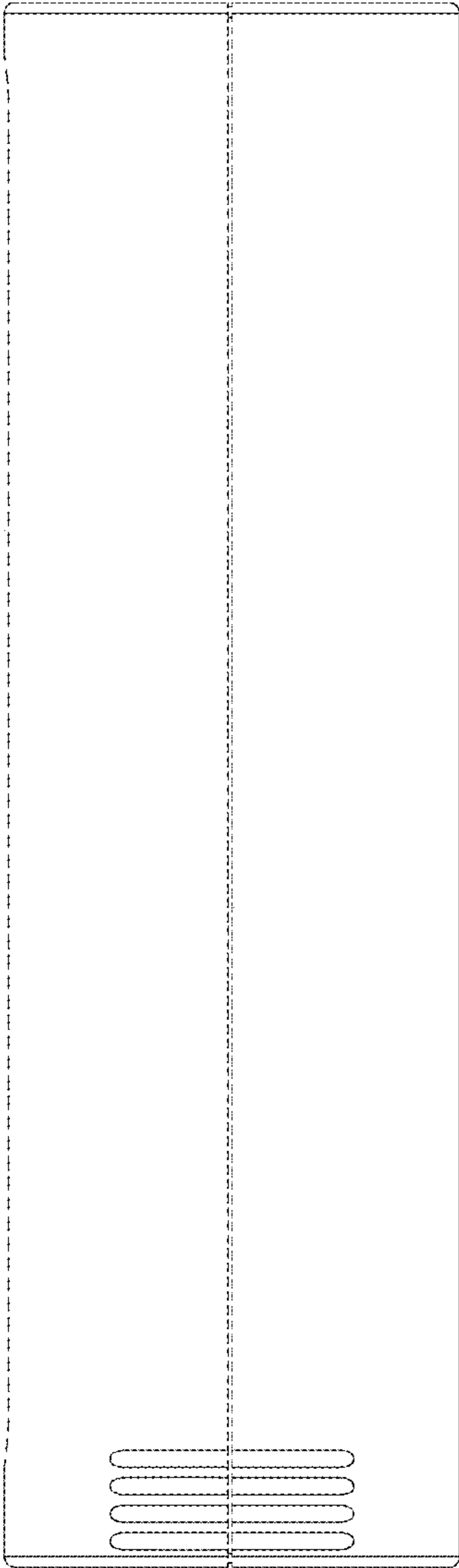

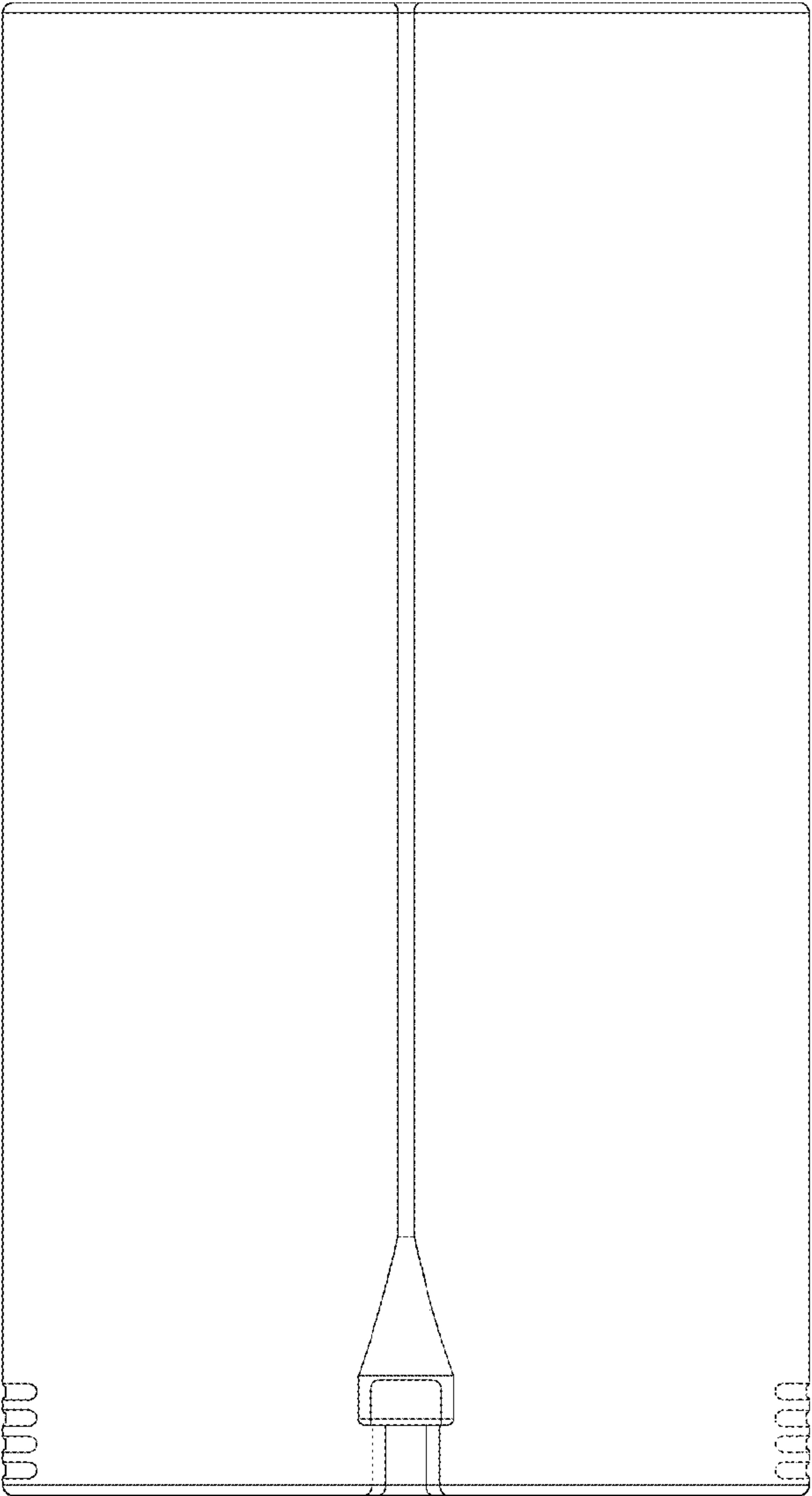

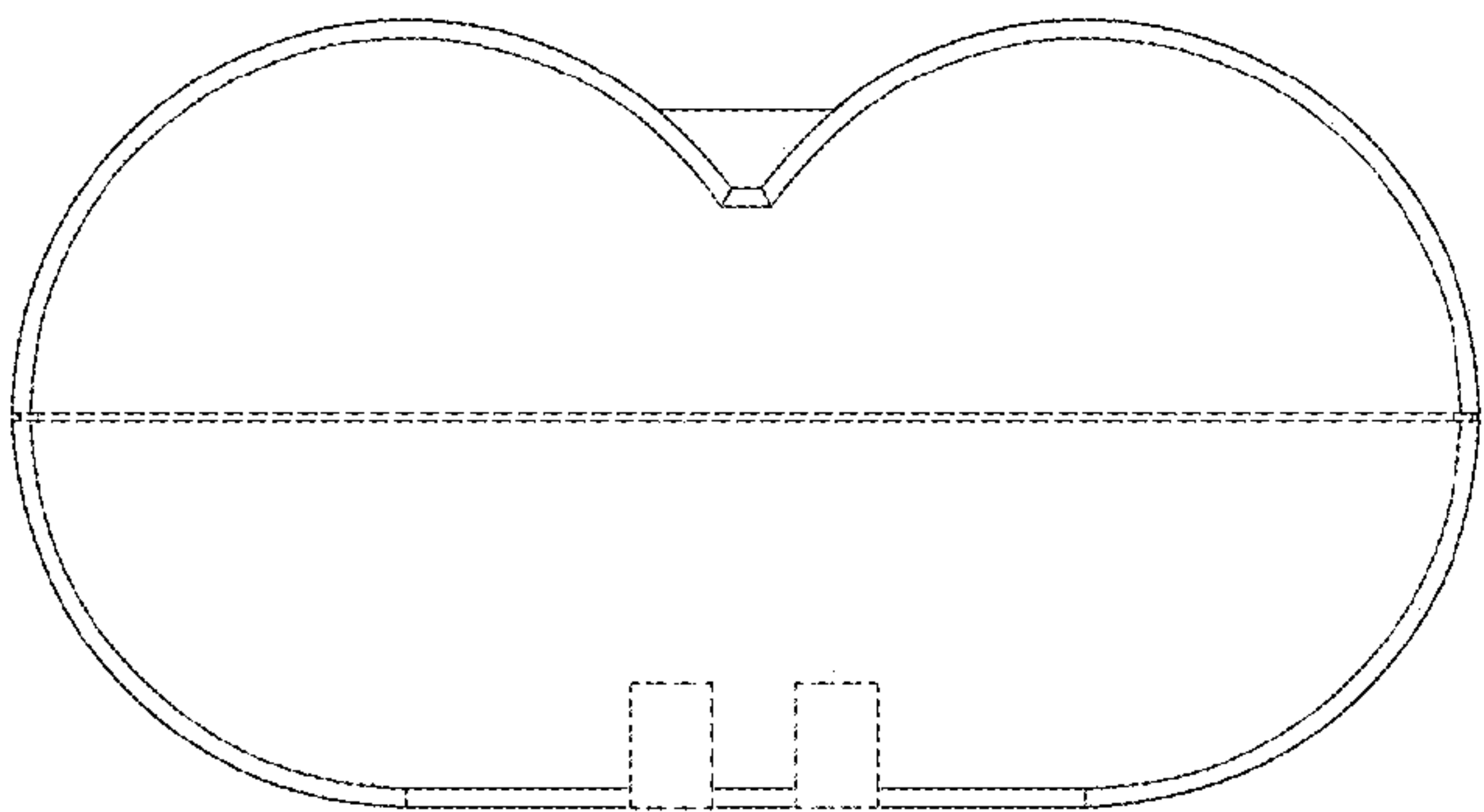

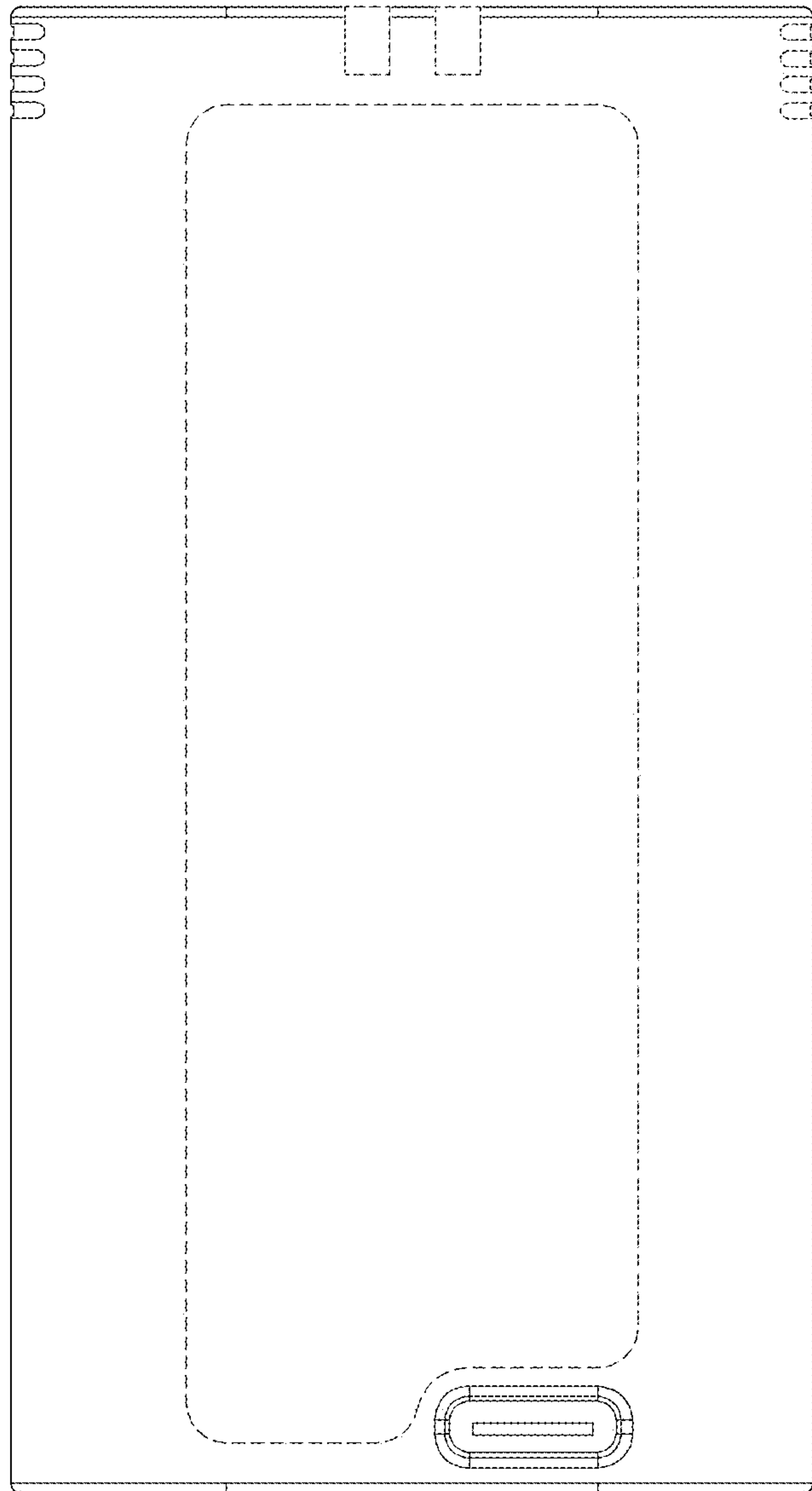

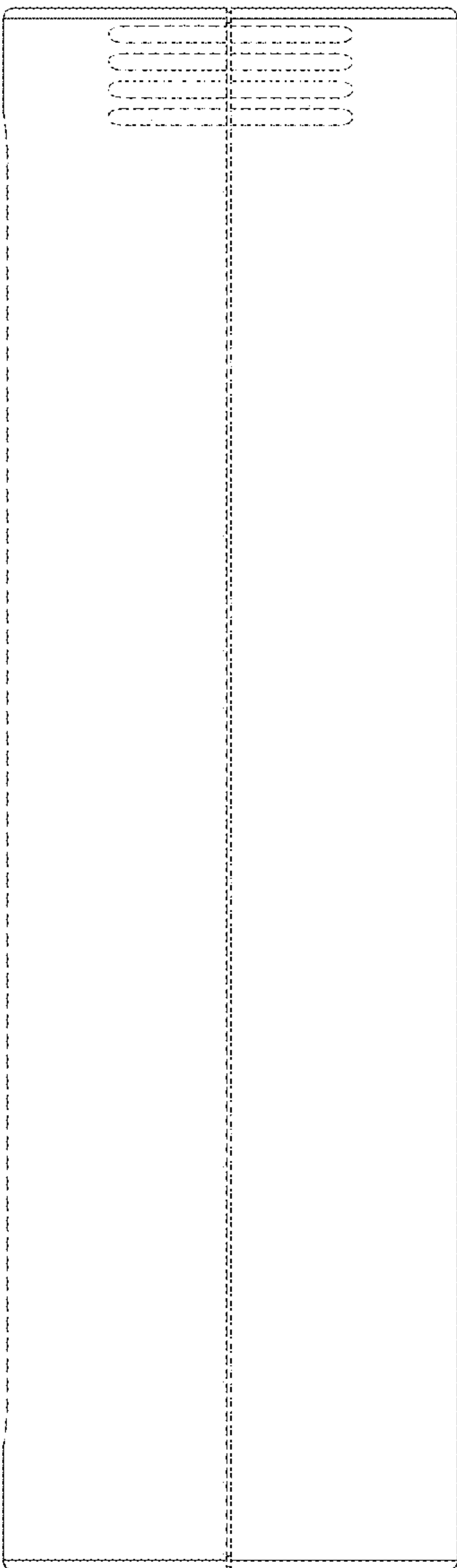

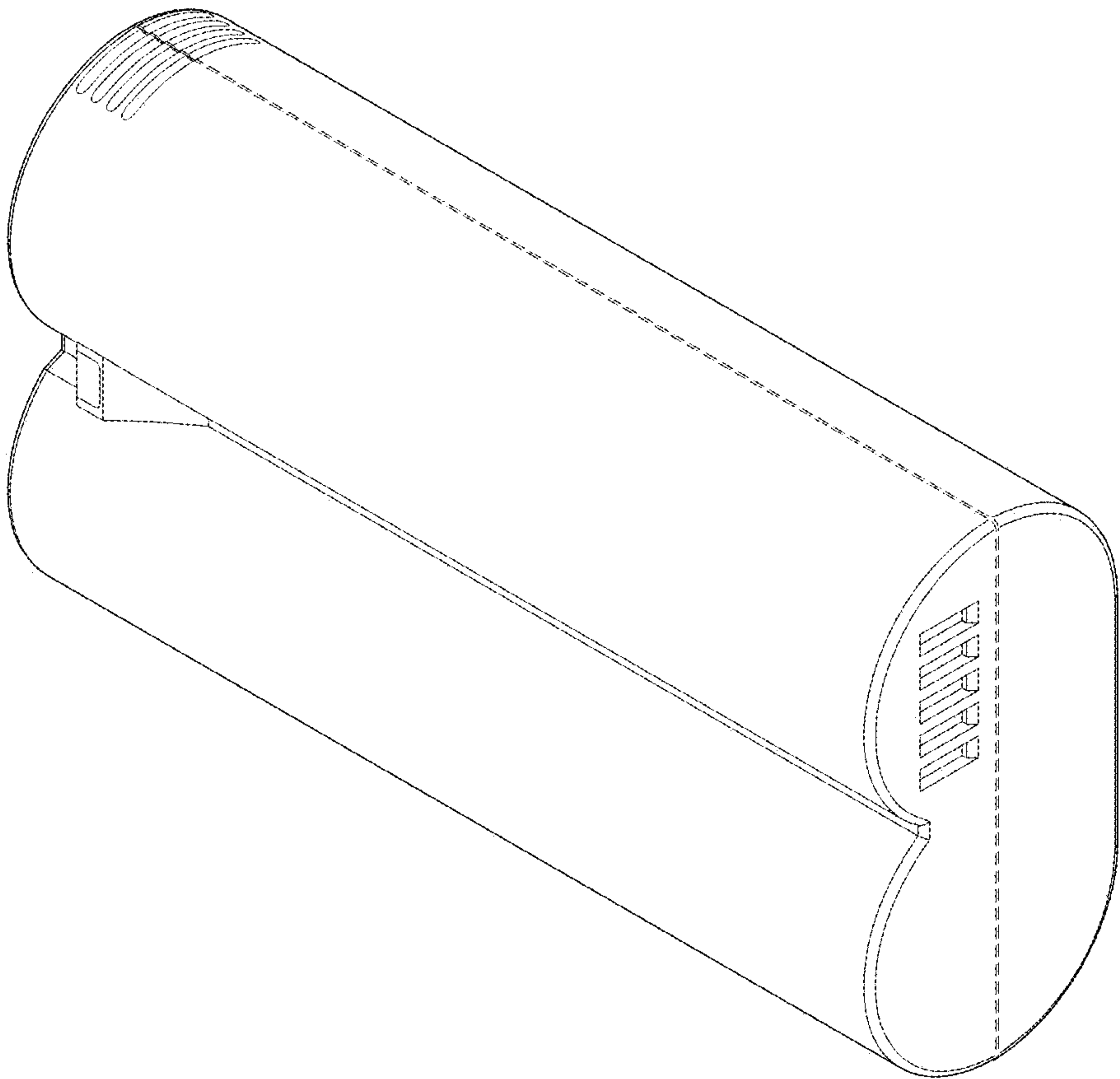

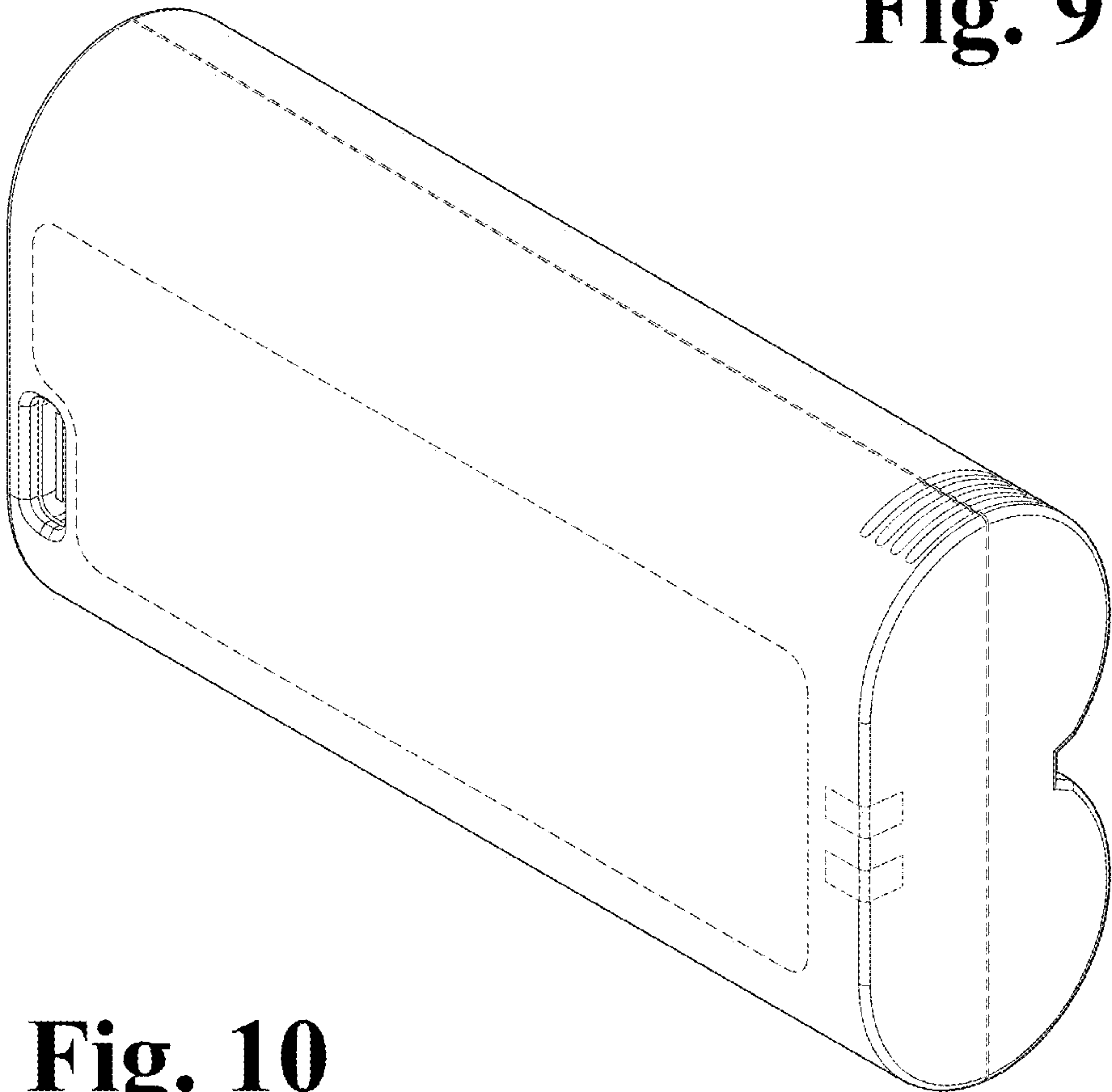

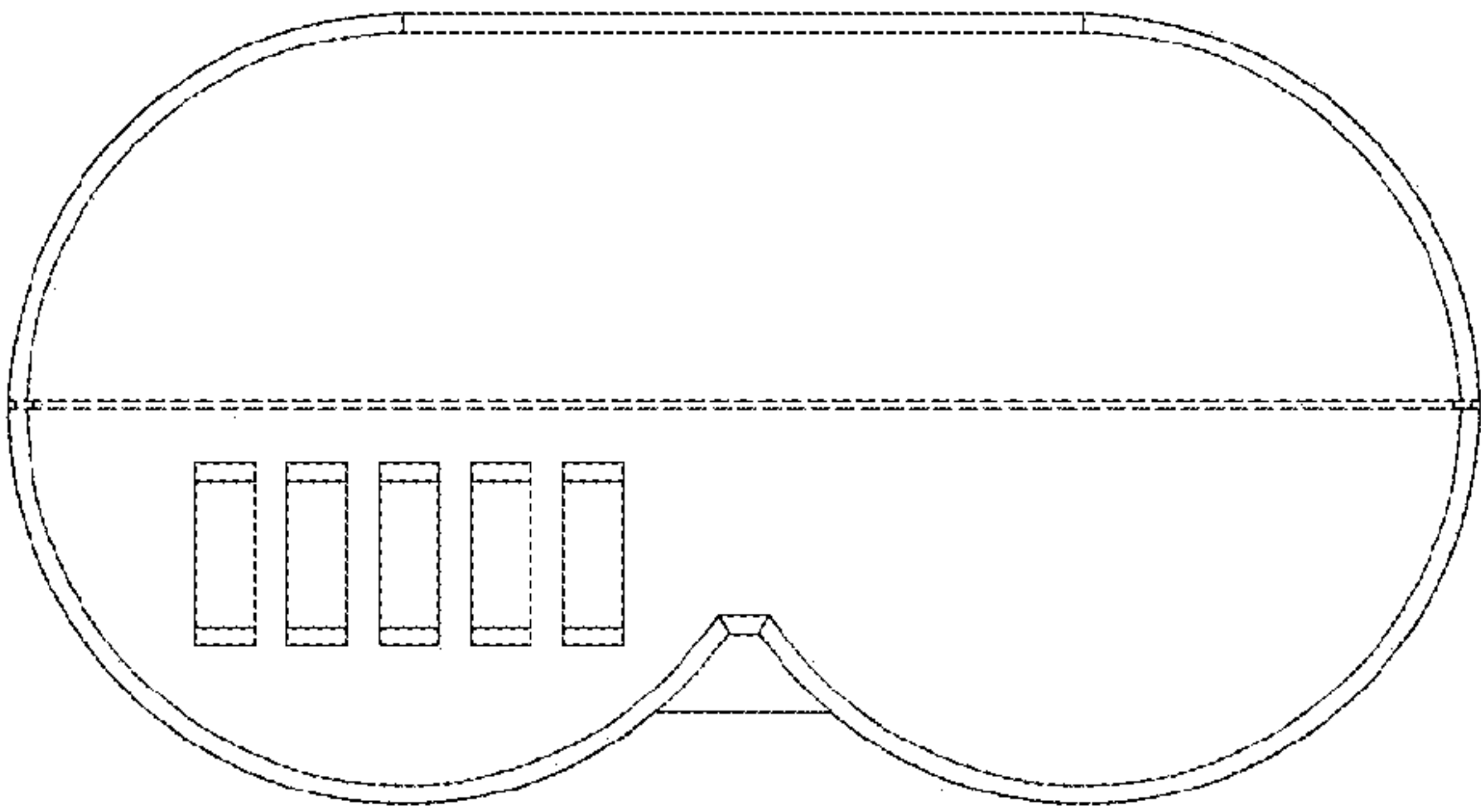
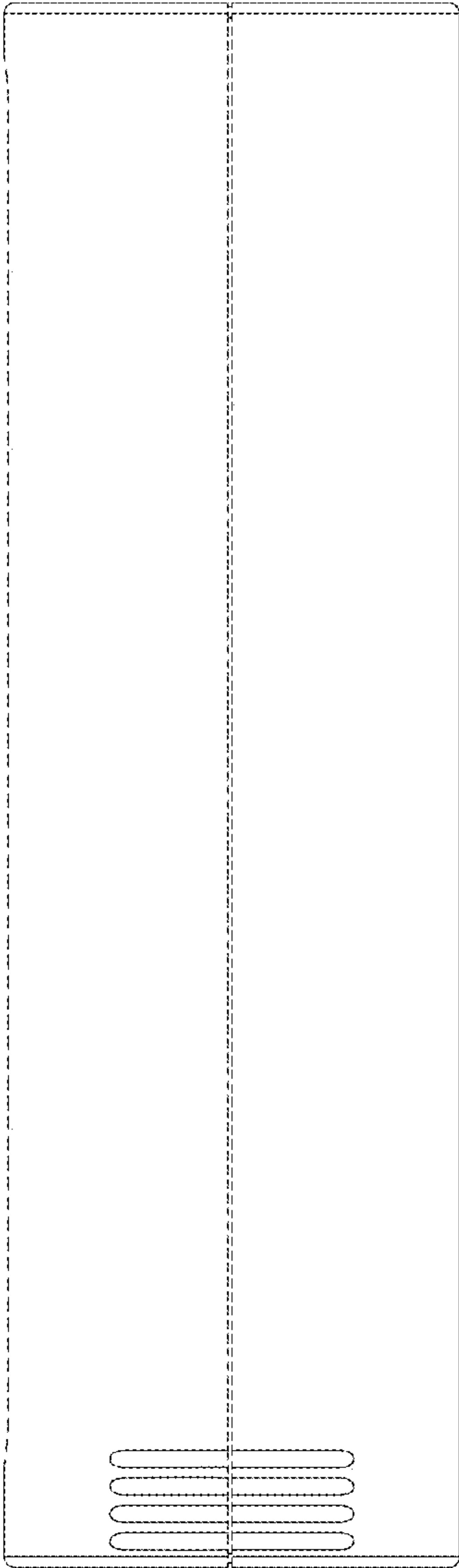

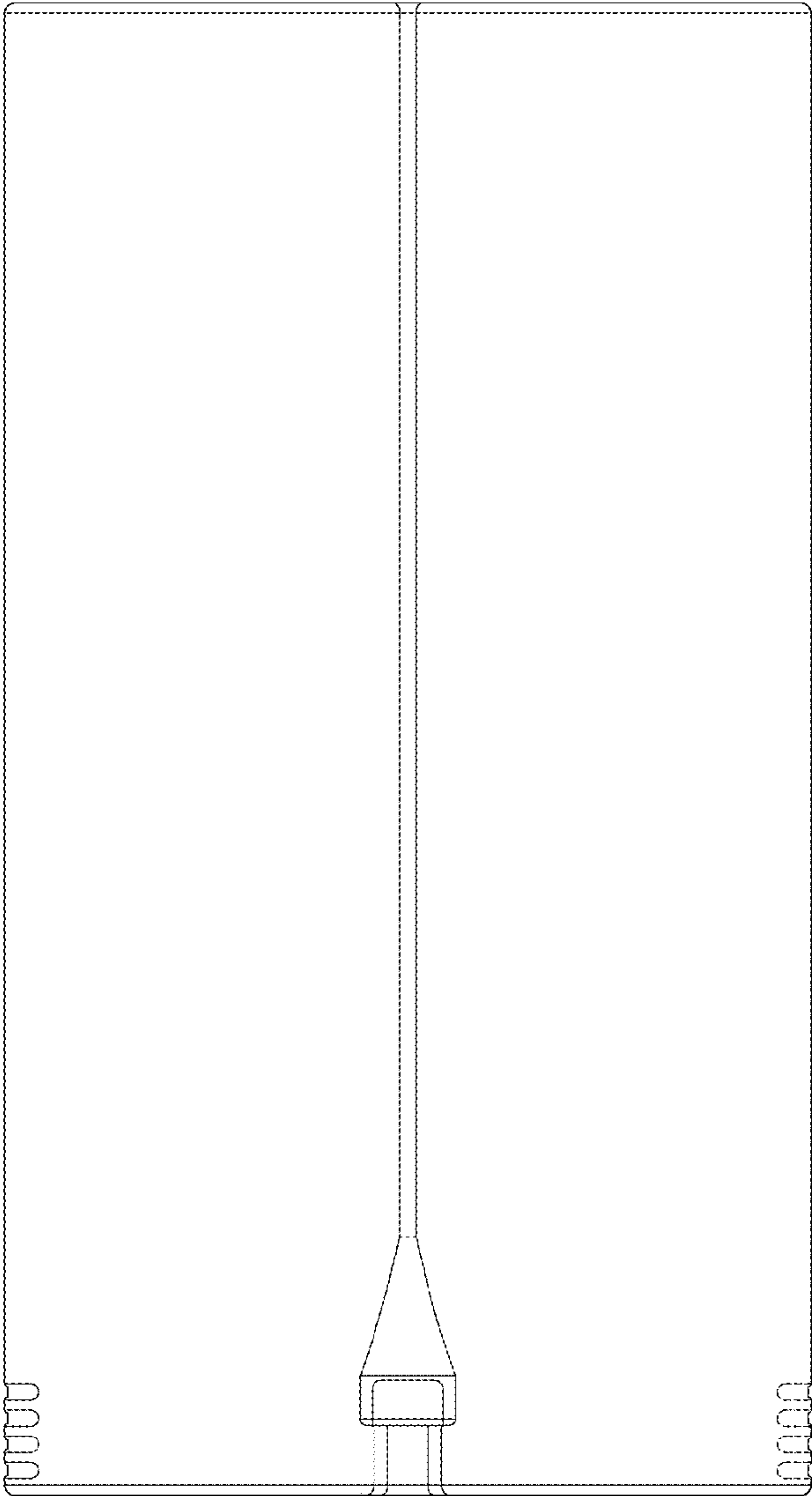

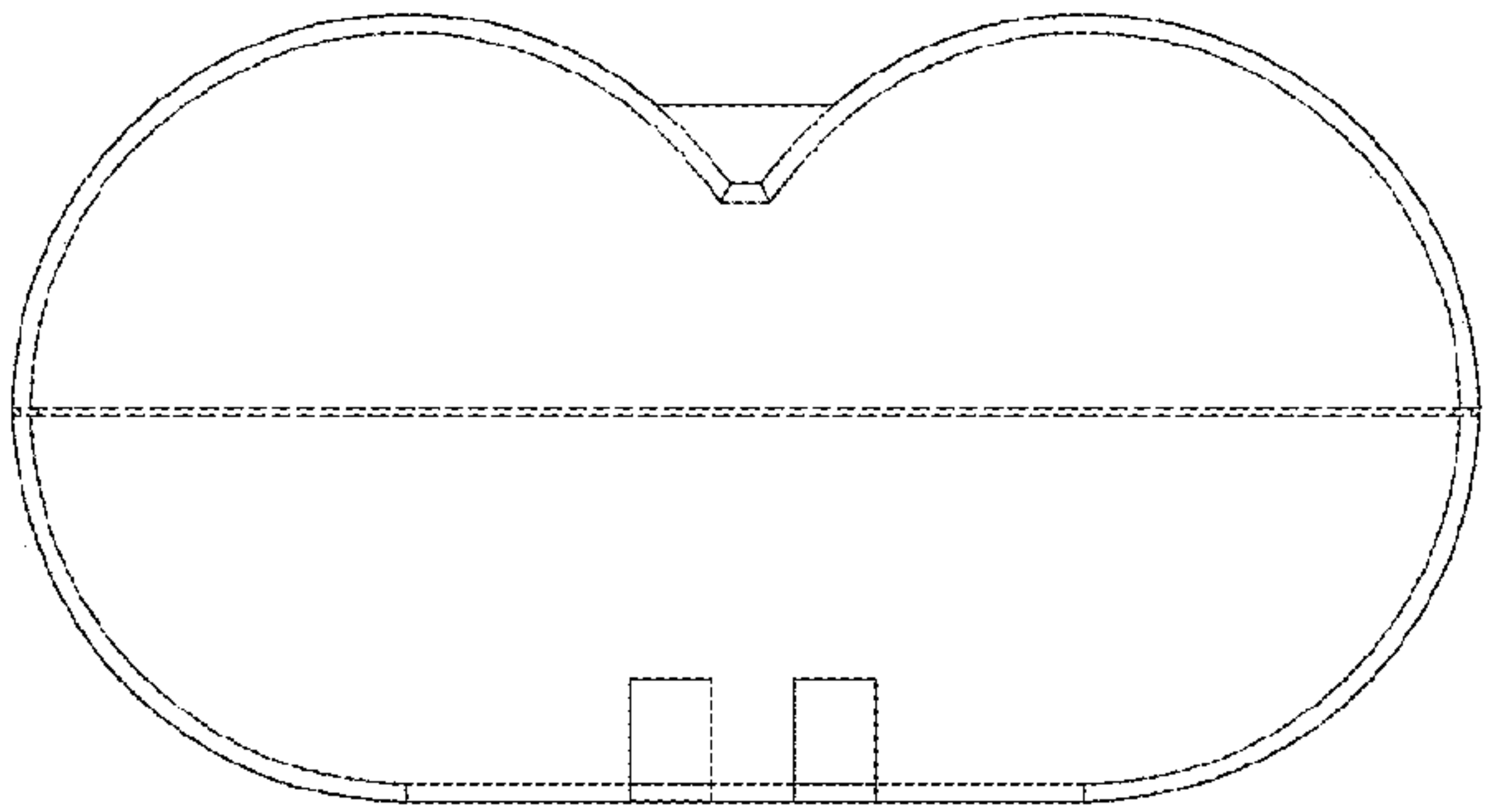

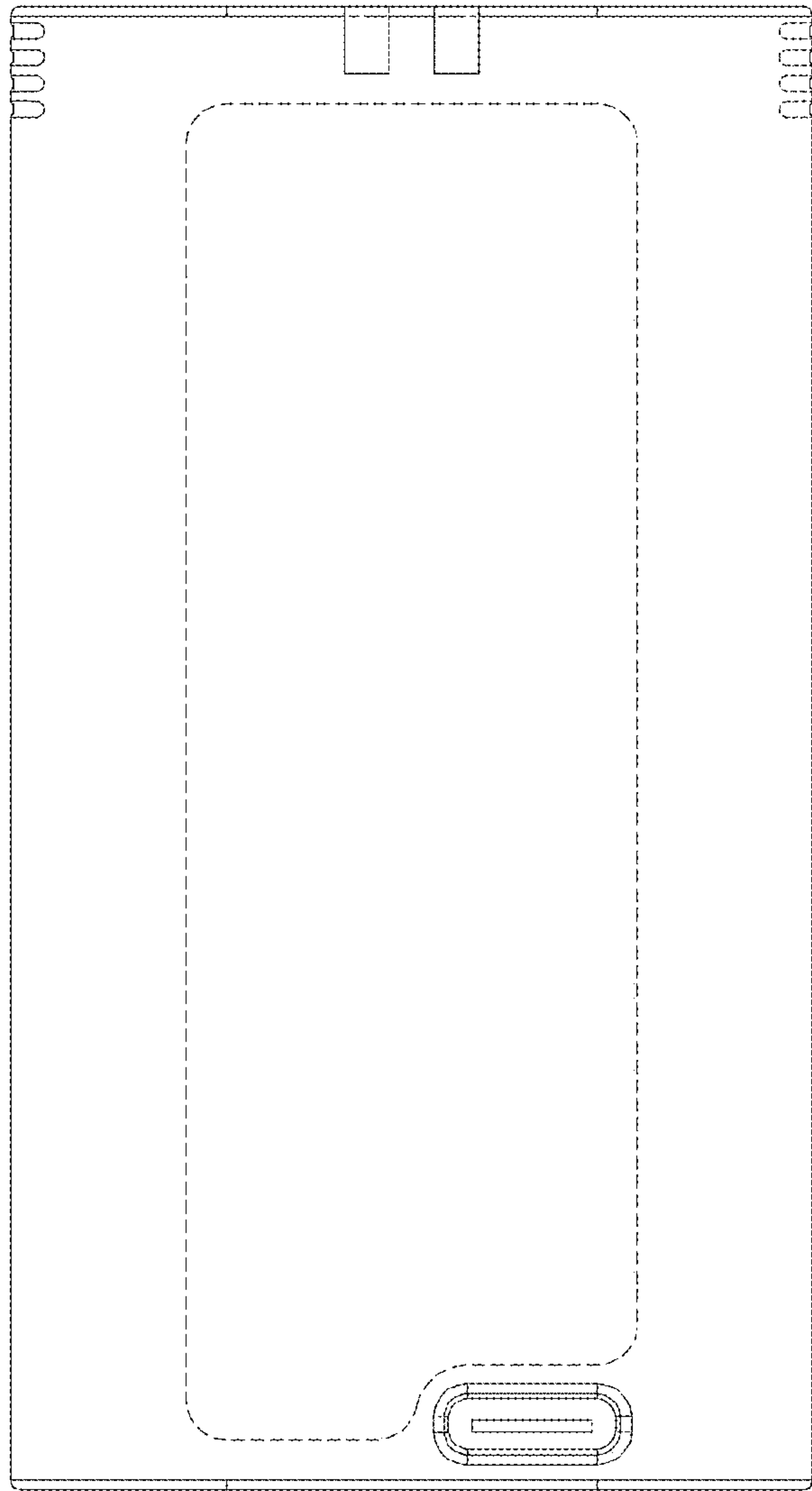

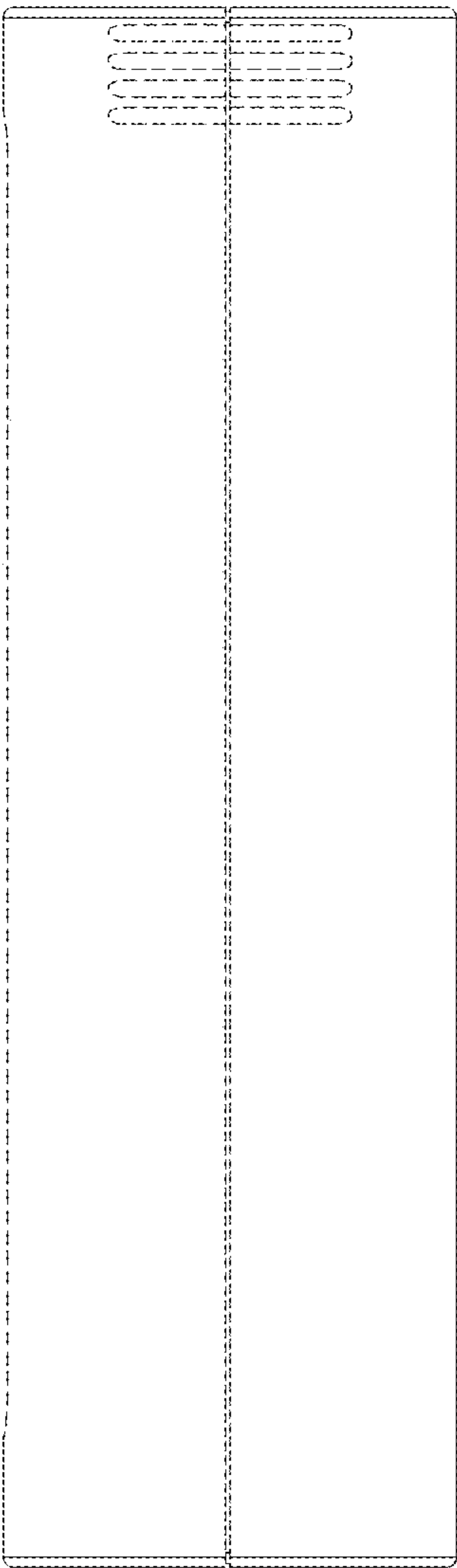
