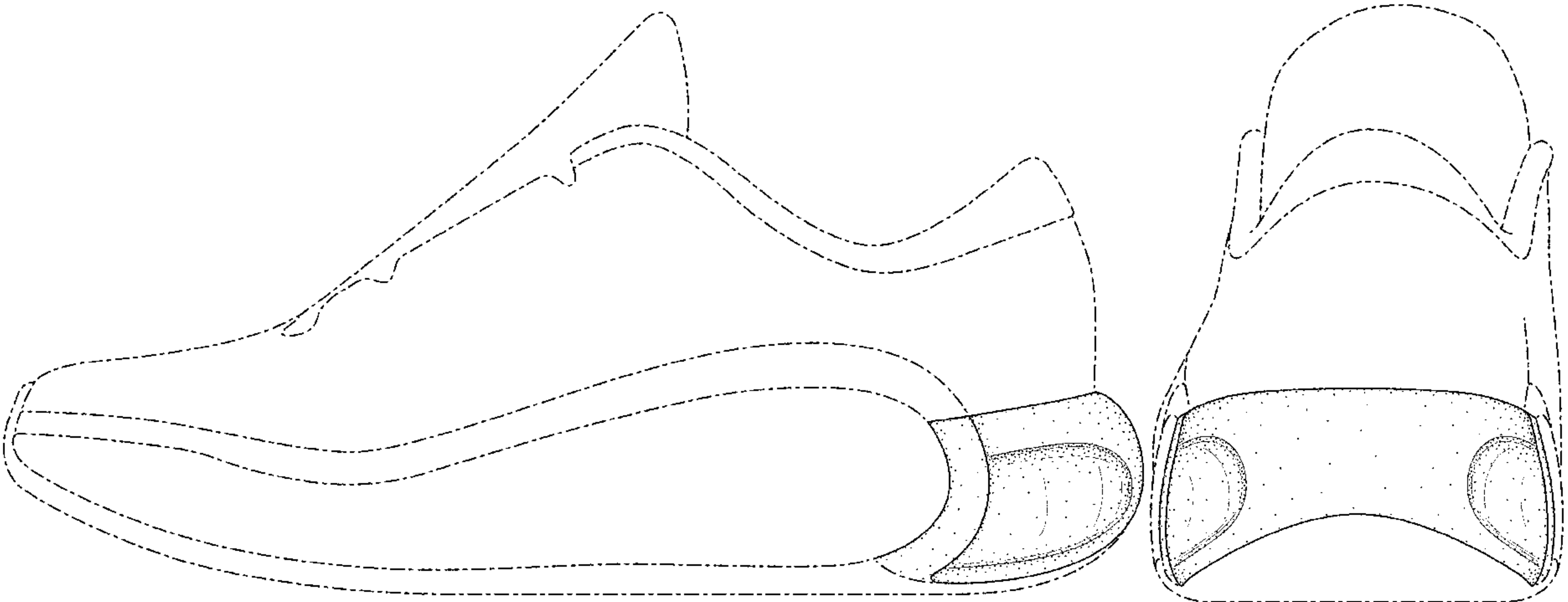
CLAIM

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design;

FIG. 5 is an opposite side view thereof.

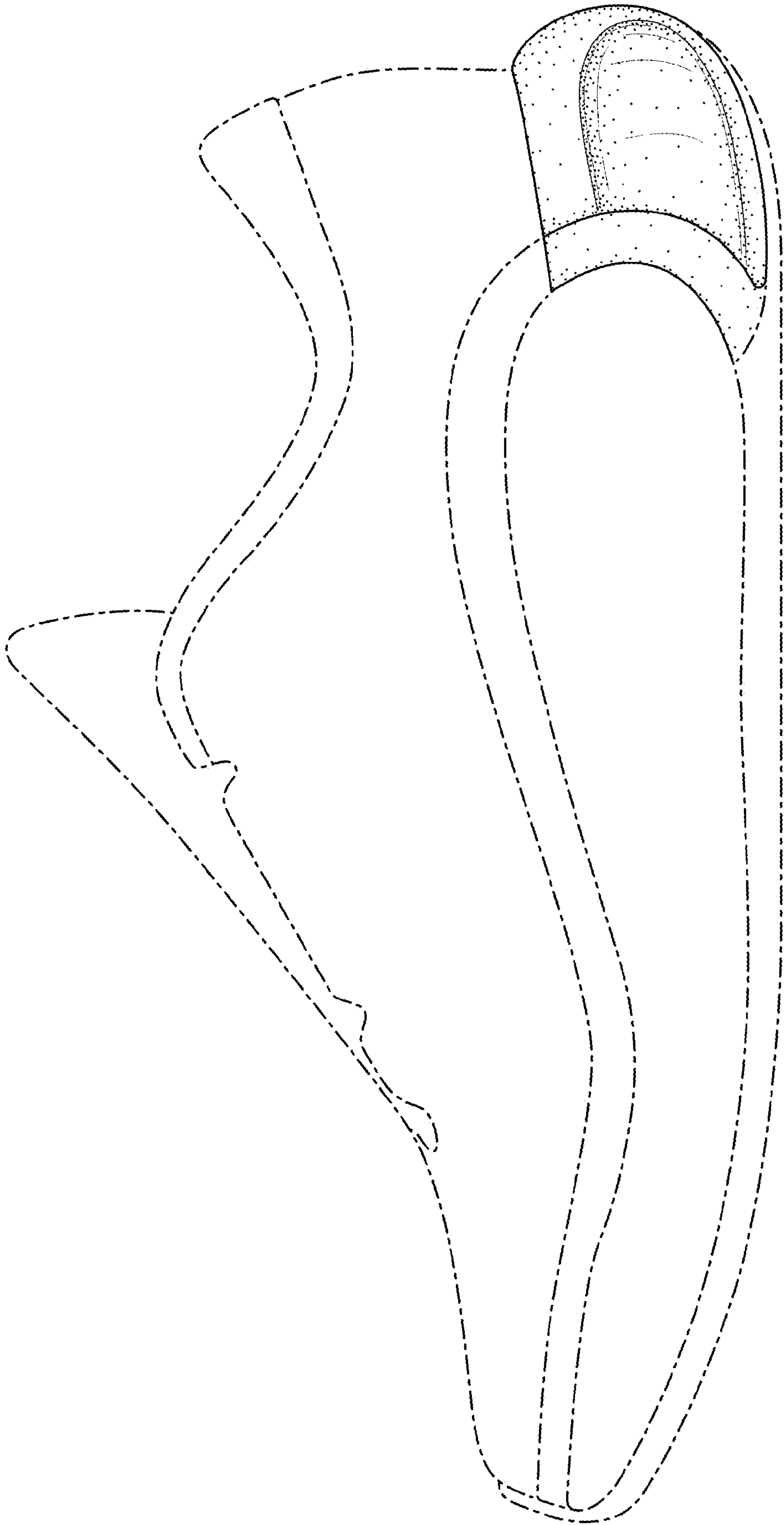

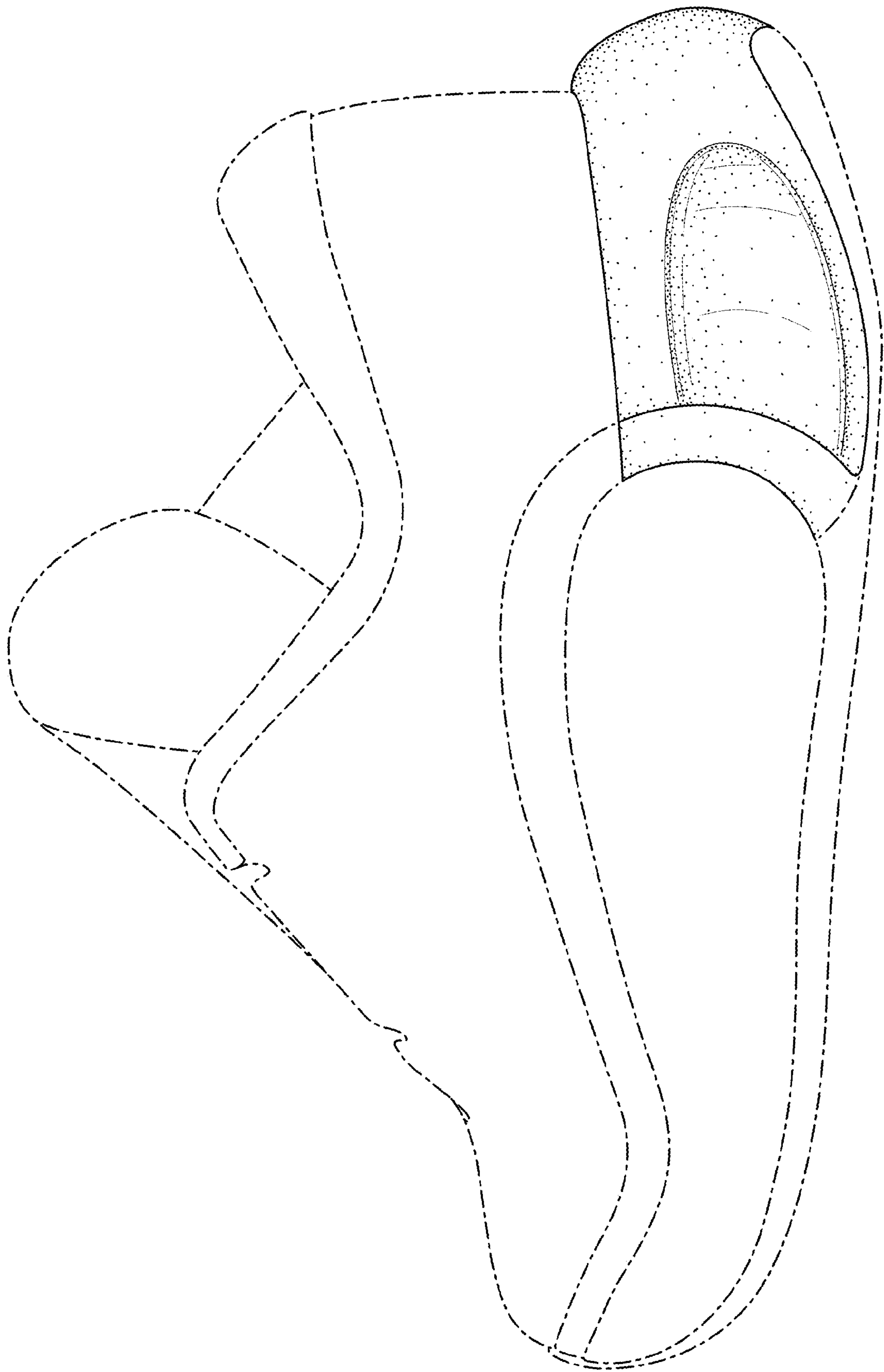

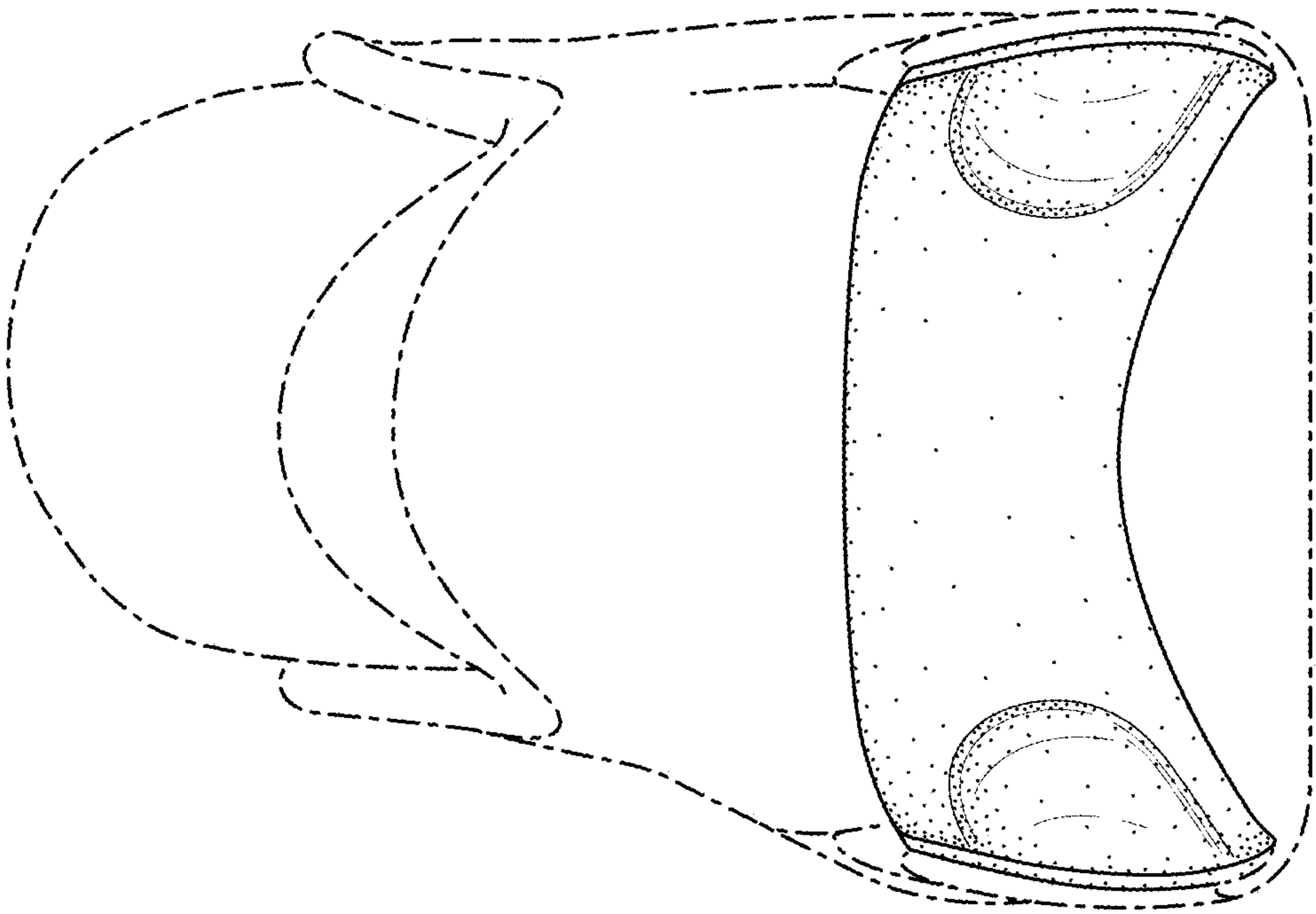

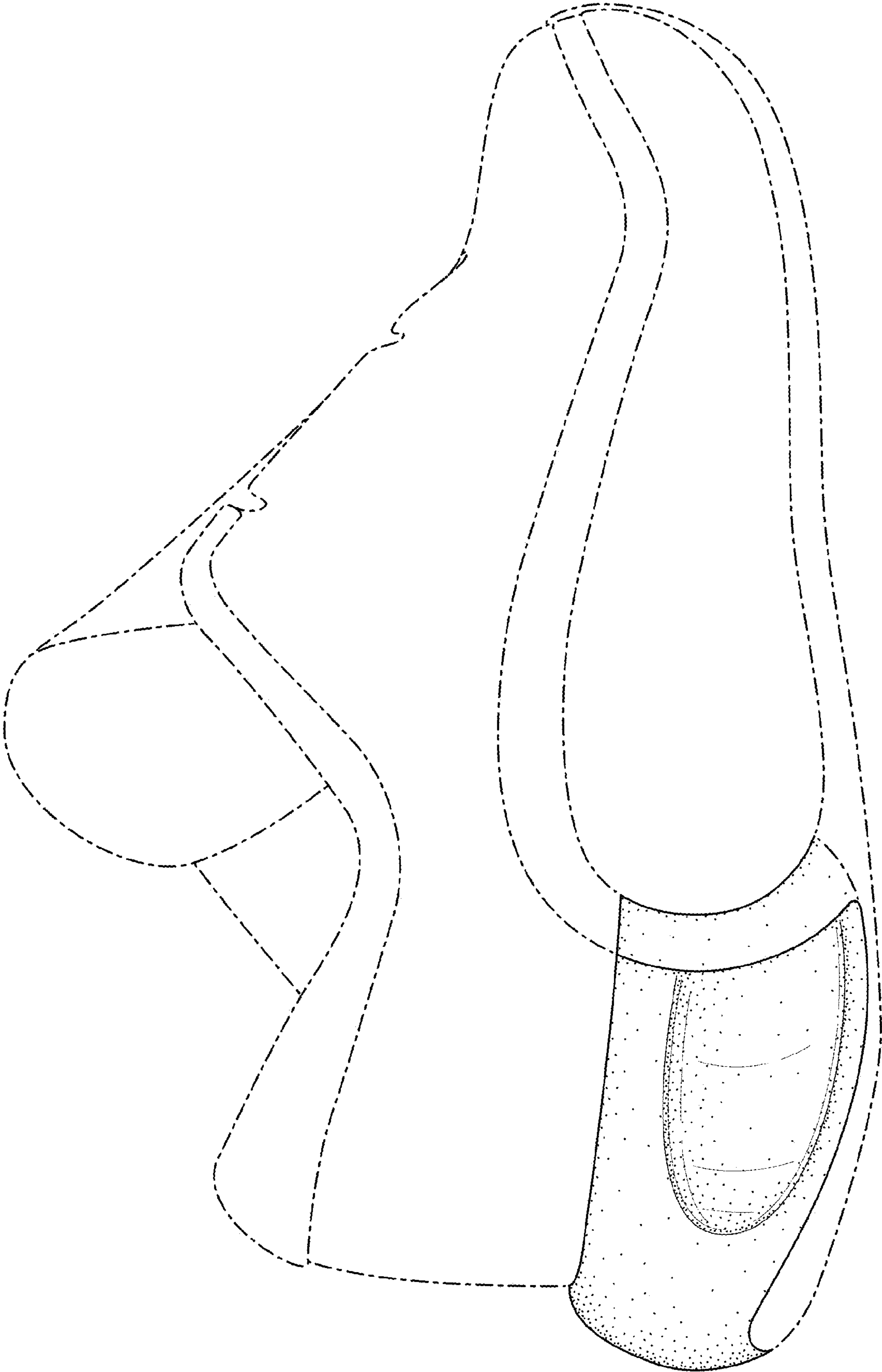

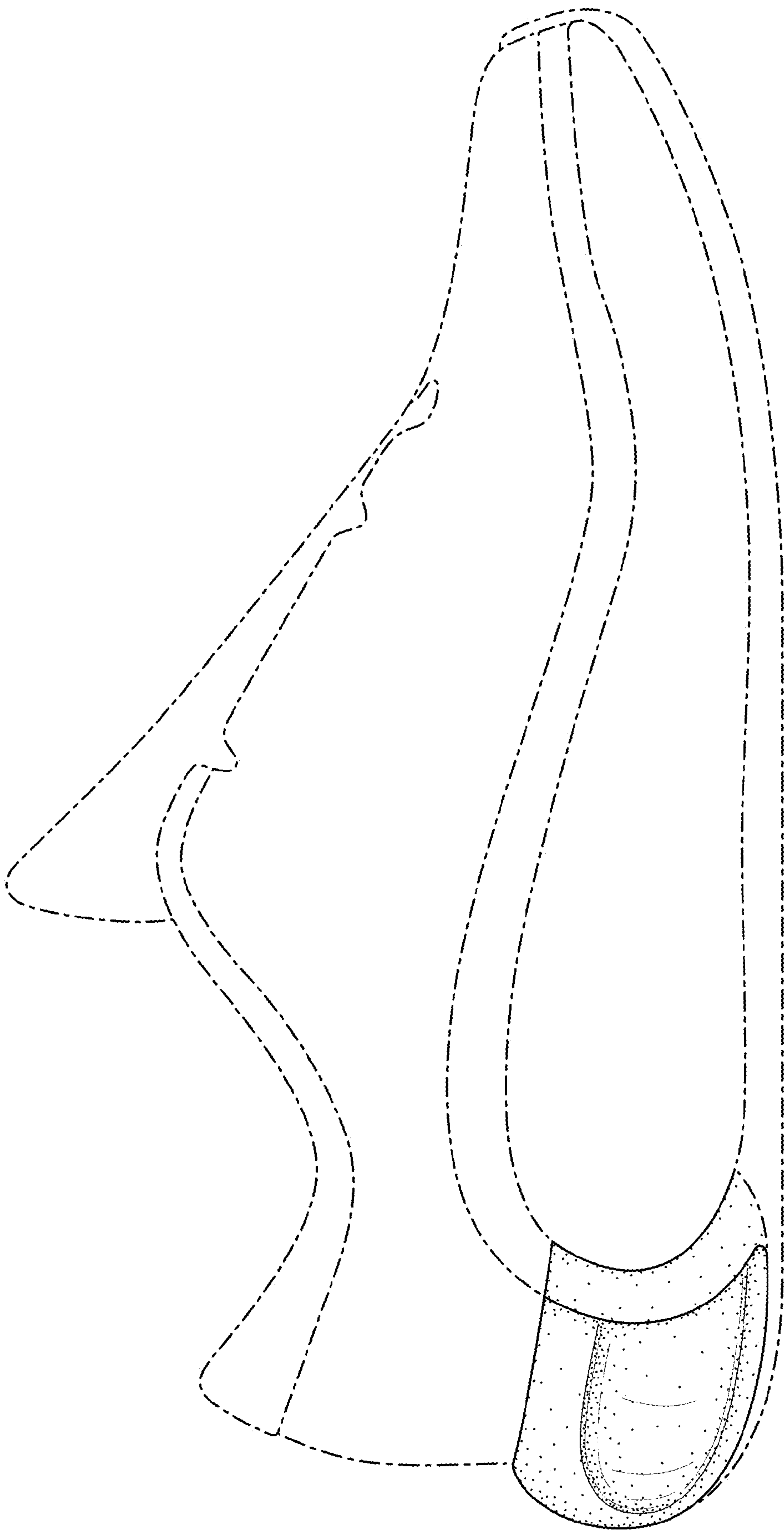
