(57) **CLAIM**

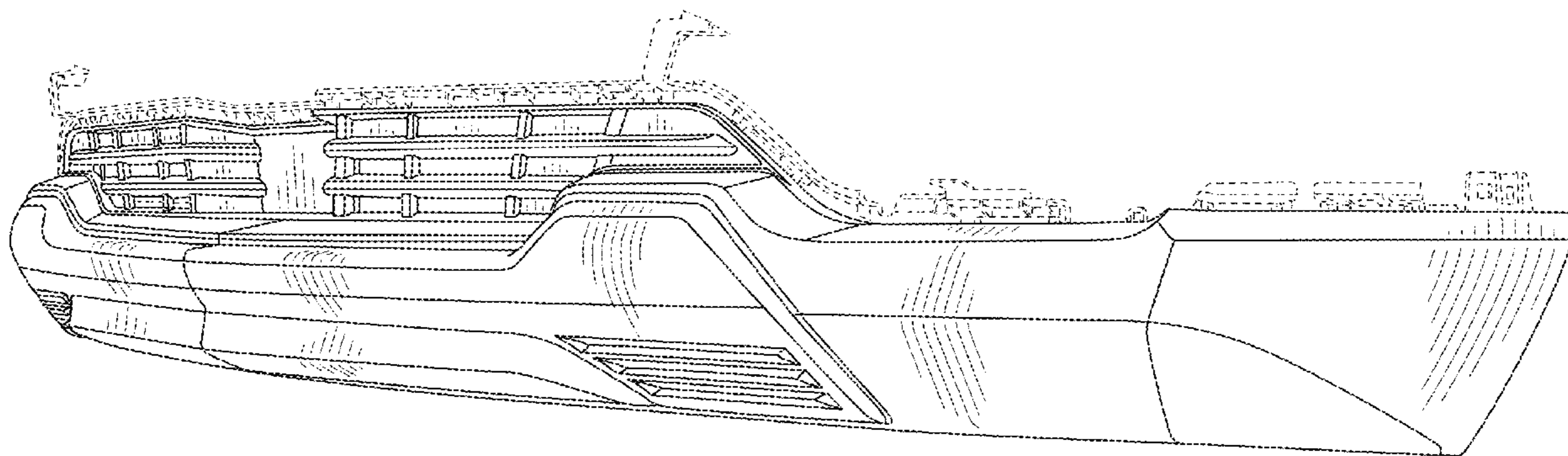
The ornamental design for a vehicle front lower fascia, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a vehicle front lower fascia showing my new design; FIG. 2 is a front elevation view of the vehicle front lower fascia of FIG. 1; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a back elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings depict portions of the vehicle front lower fascia that form no part of the claimed design.

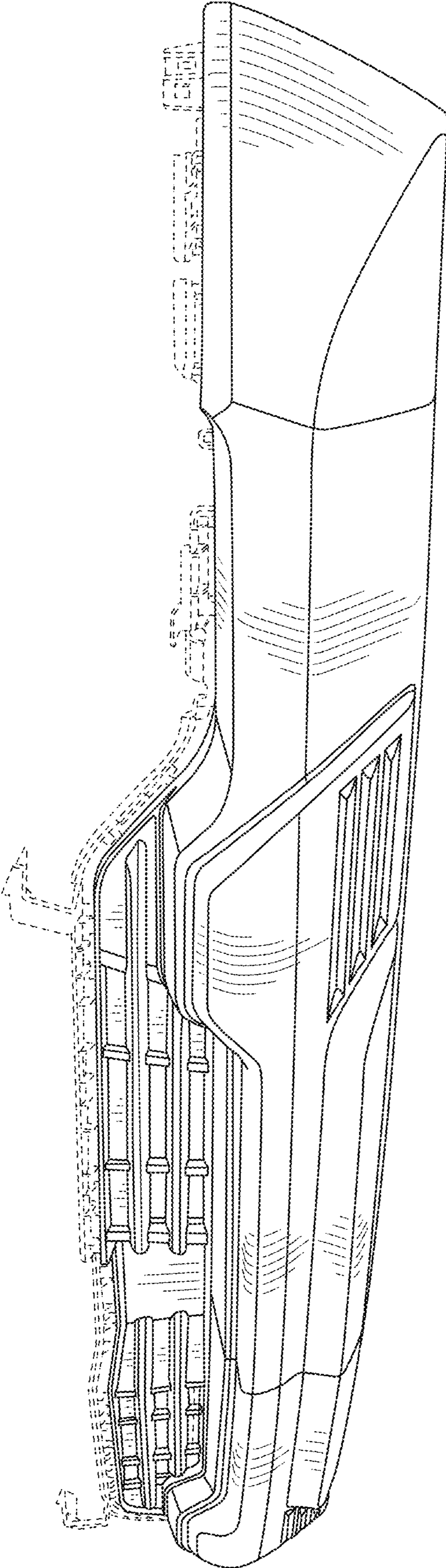

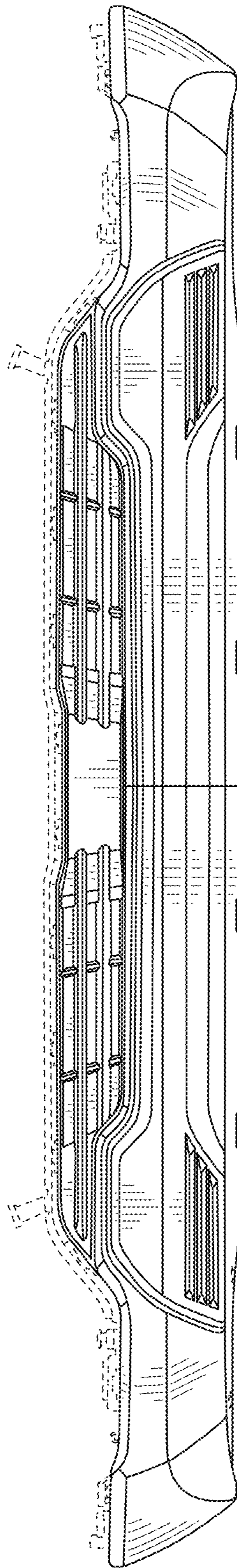

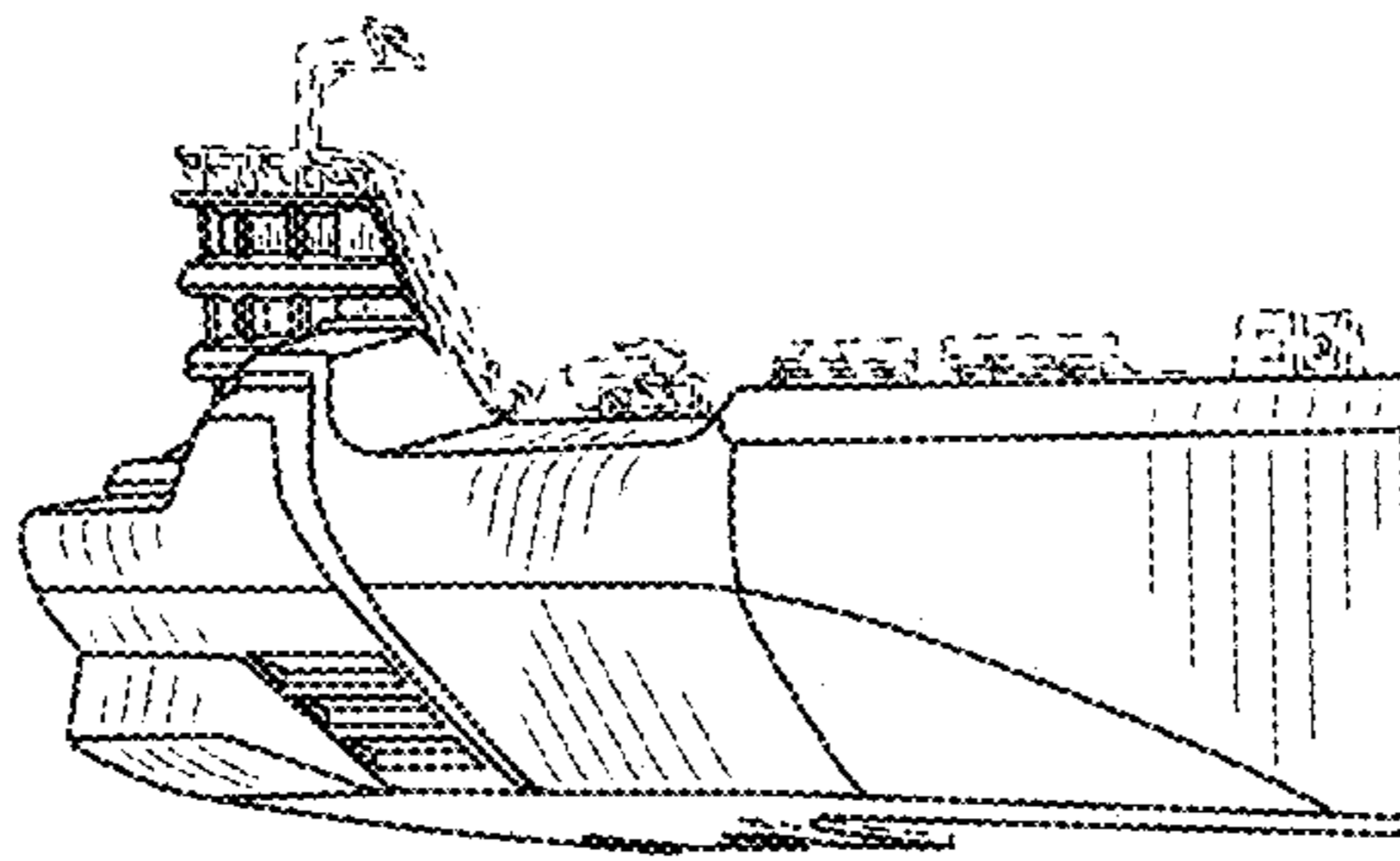

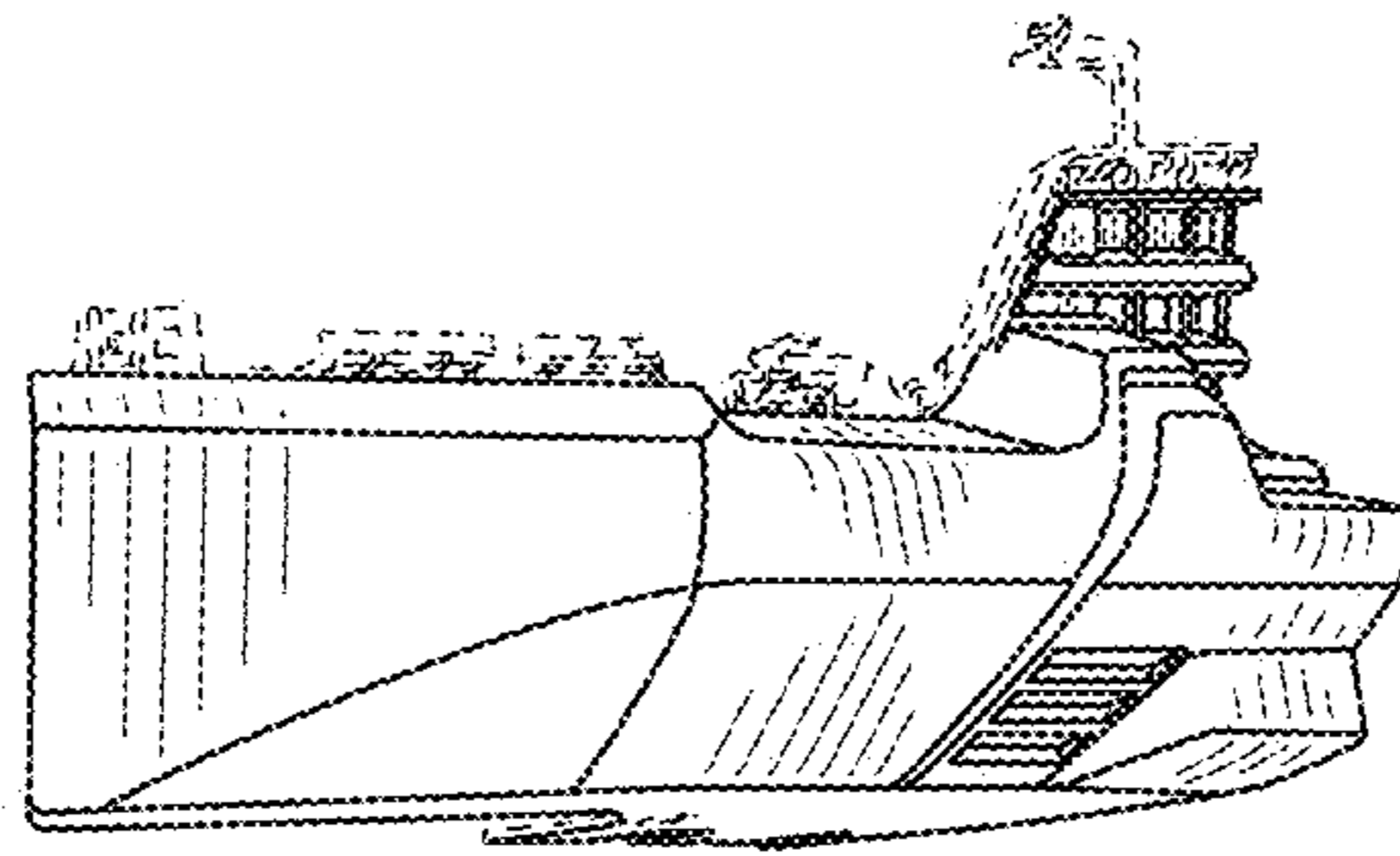

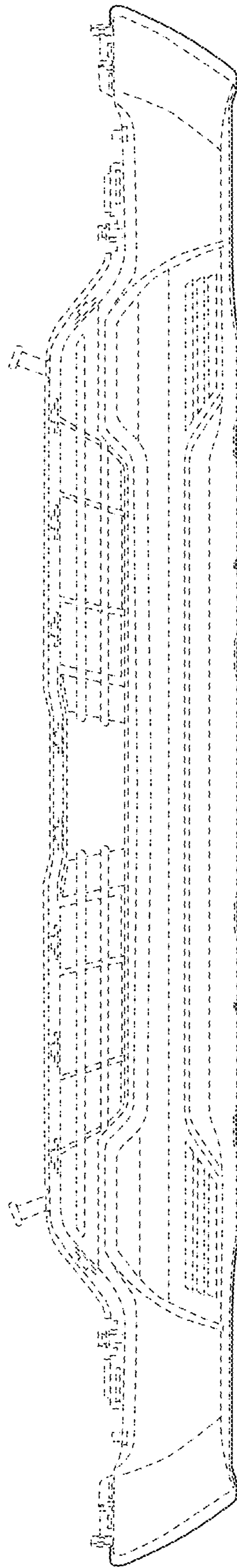

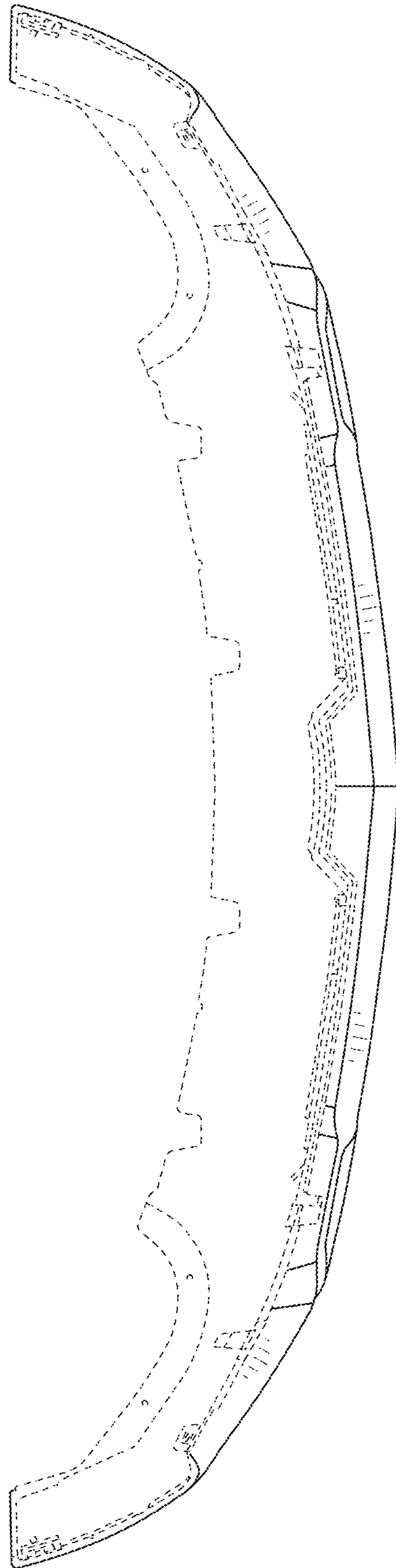

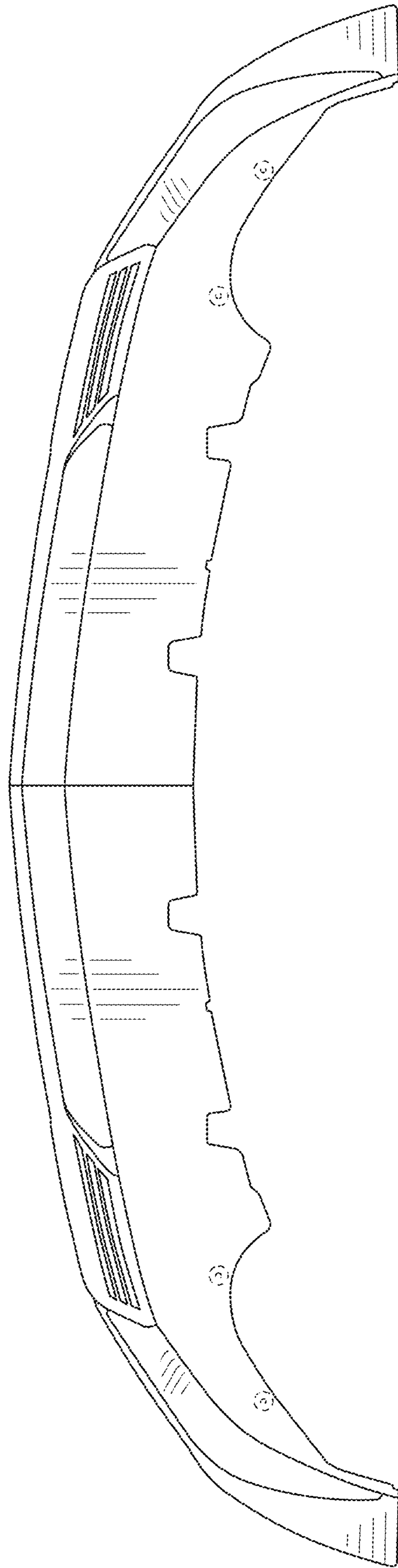
