(57) CLAIM

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front, left and top side perspective view of a tire showing the design;

FIG. 2 is a rear, right and top side perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

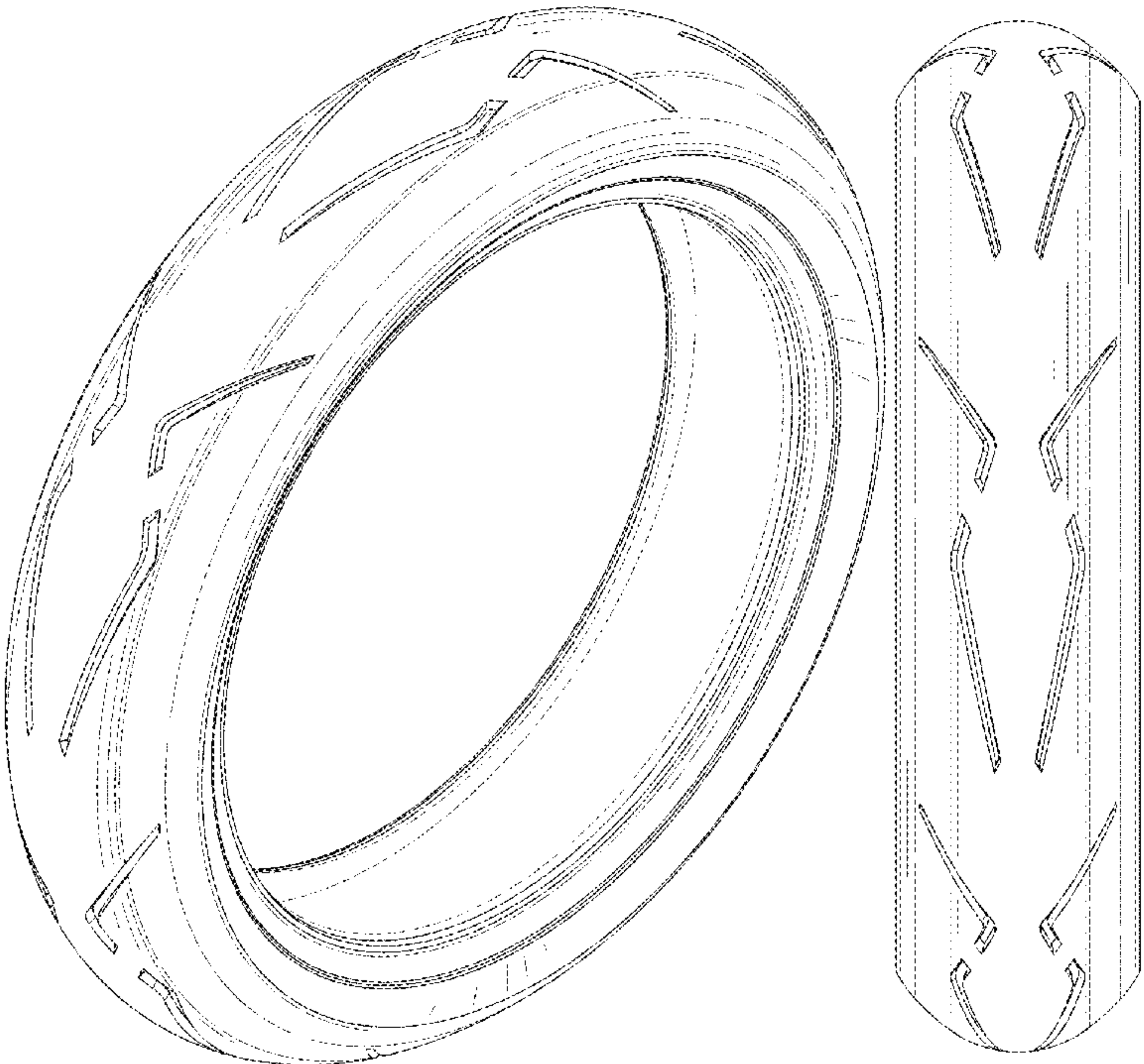
FIG. 9 is an enlarged view of the portion marked ‘9’ of FIG. 2; and,

FIG. 10 is a cross-sectional view of the portion marked ‘10’ of FIG. 3.

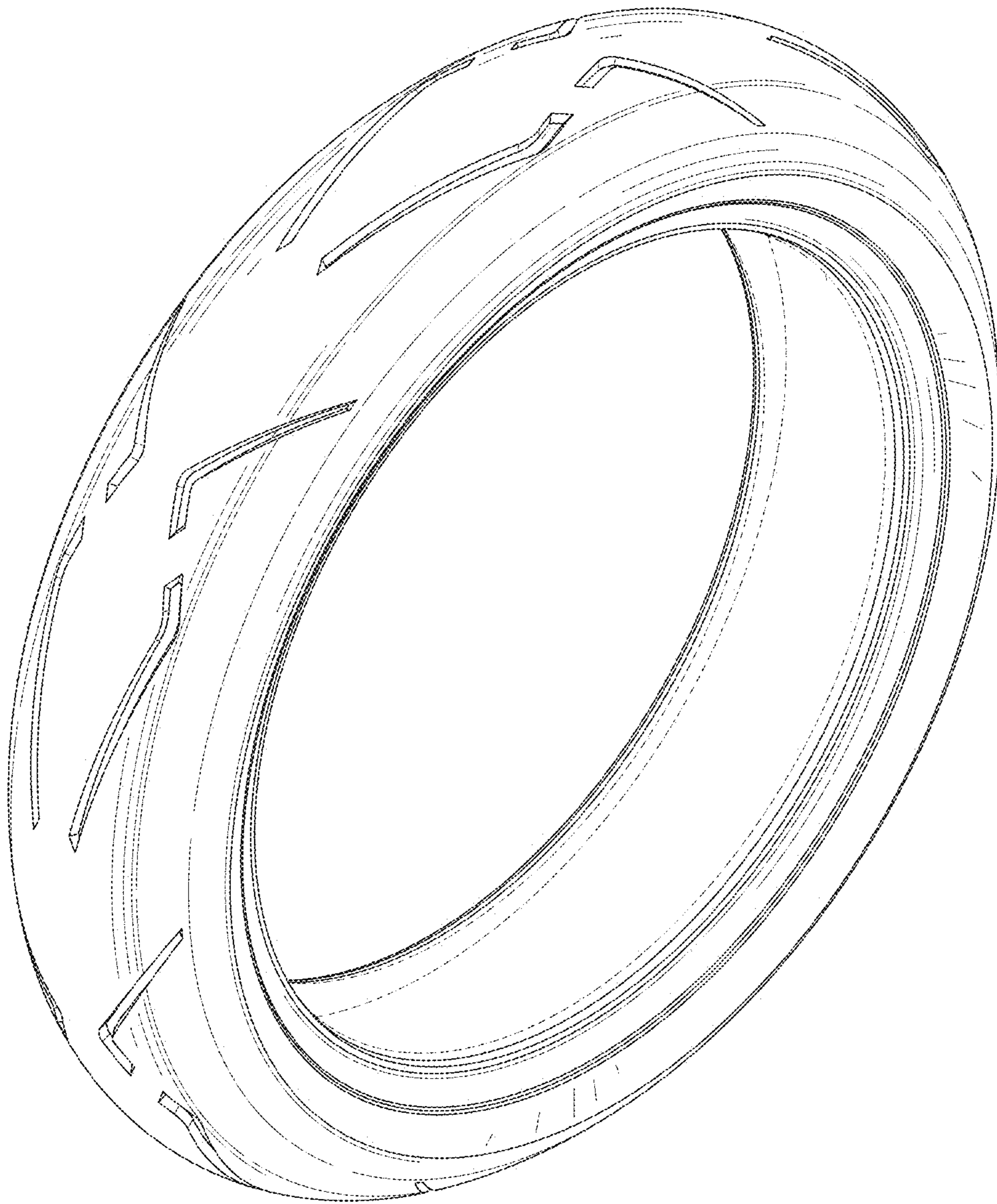

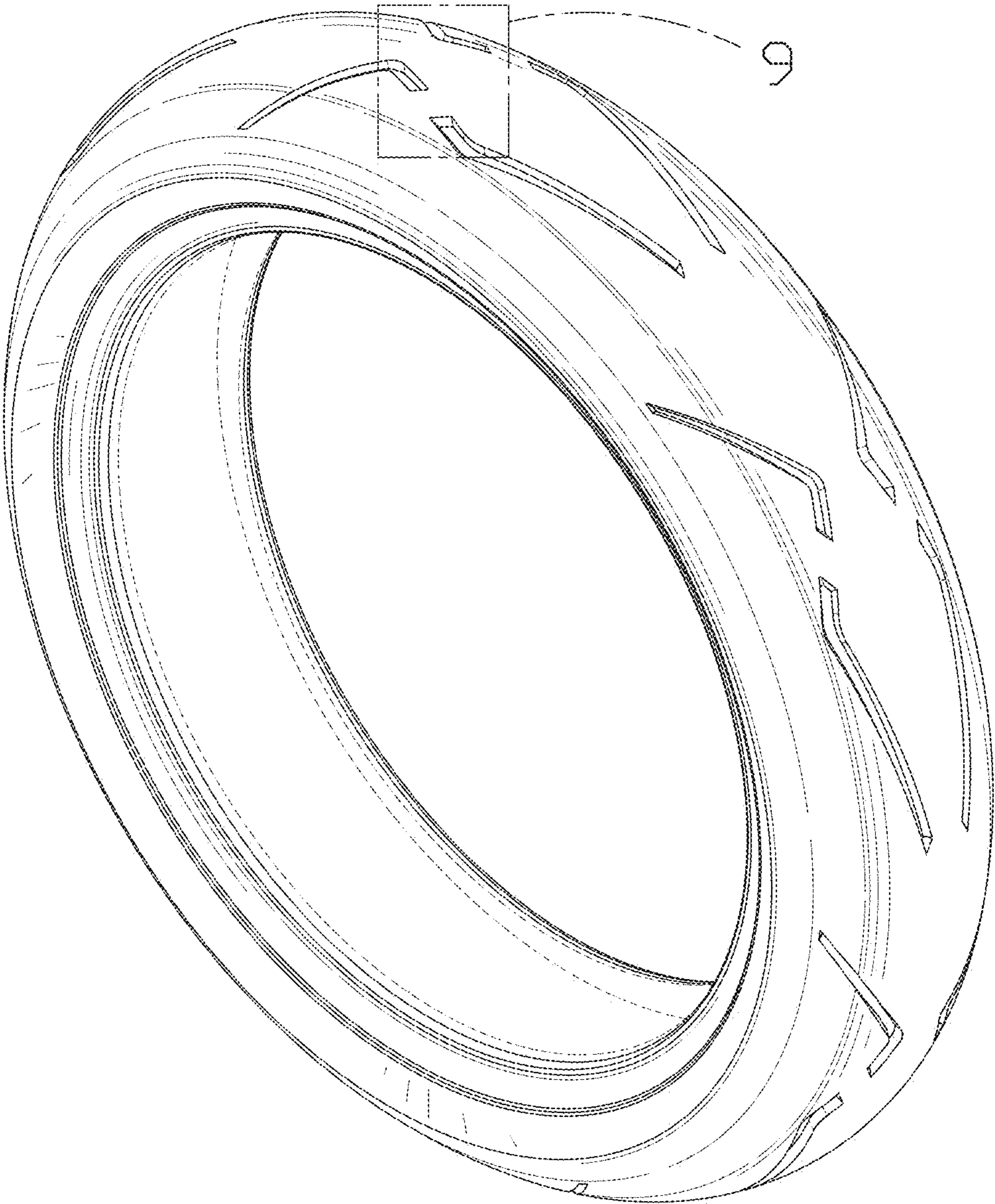

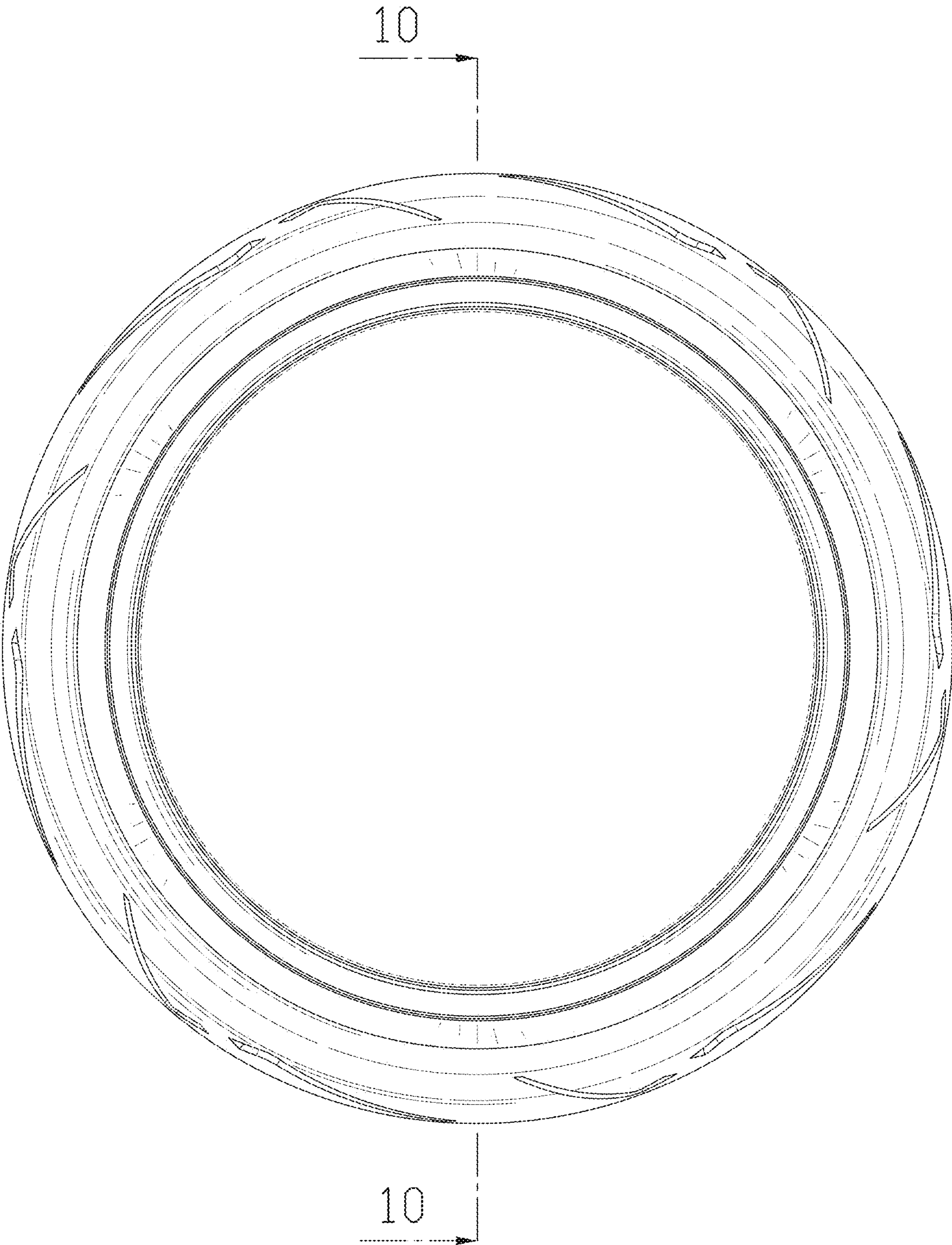

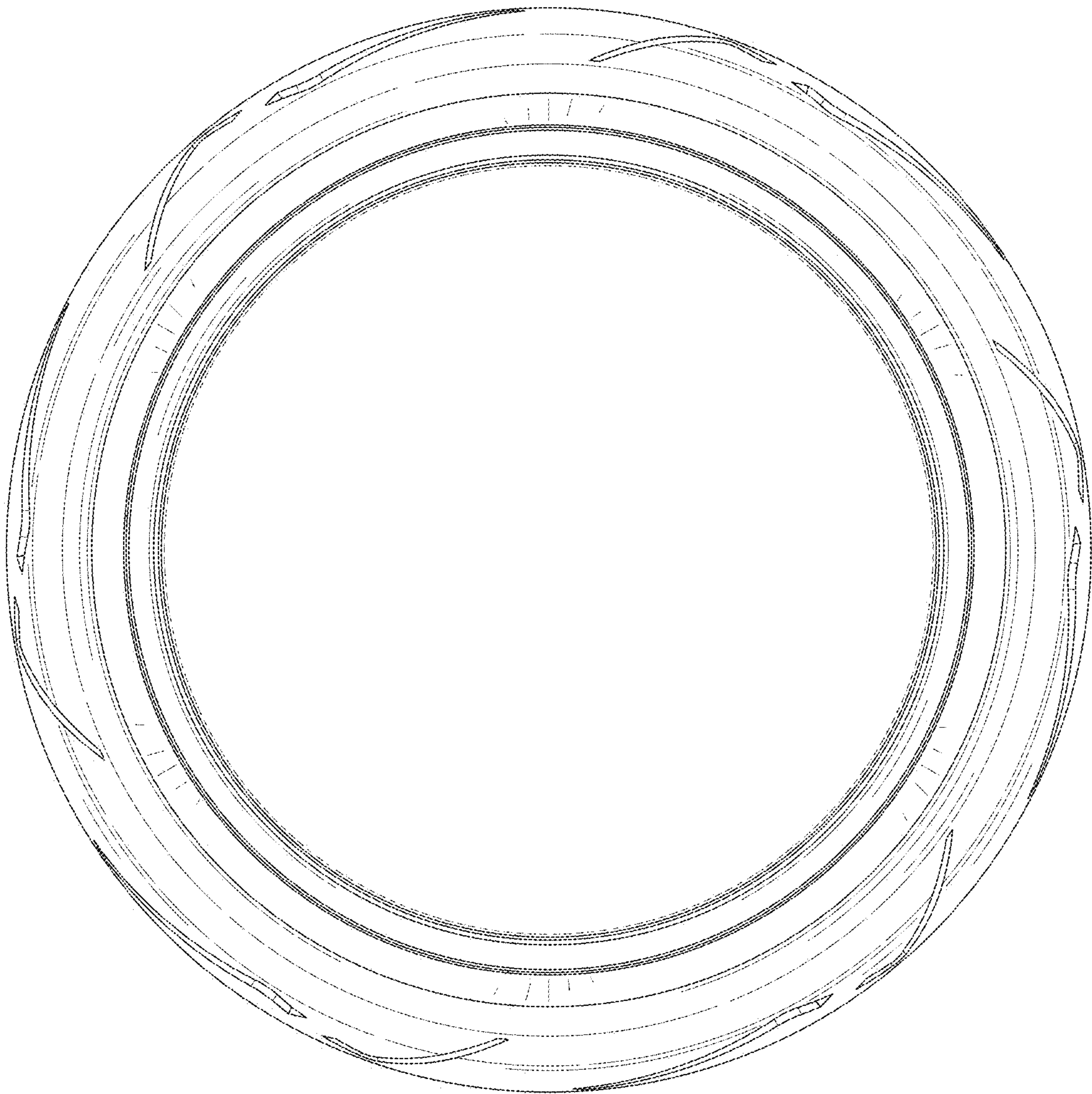

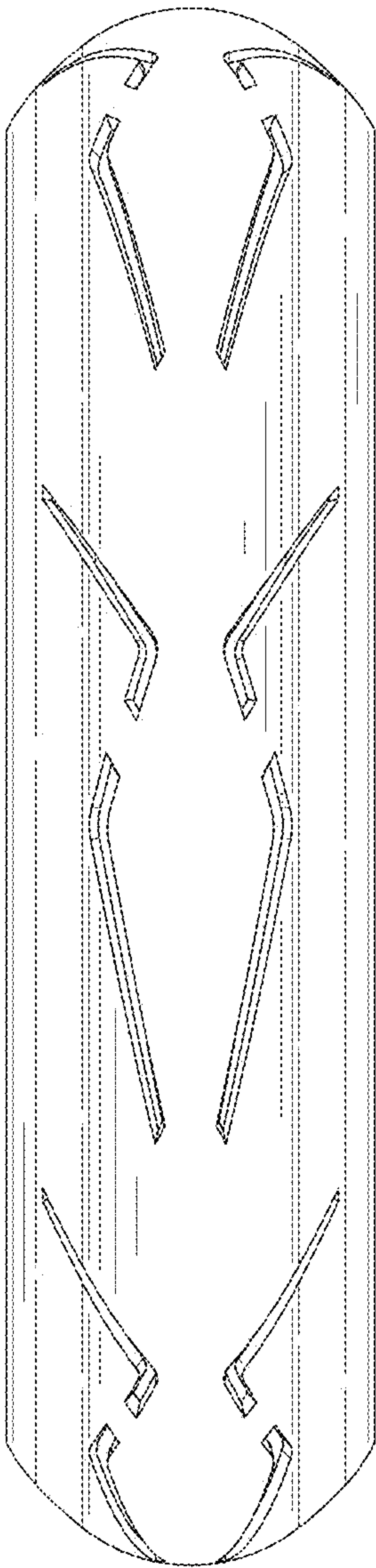

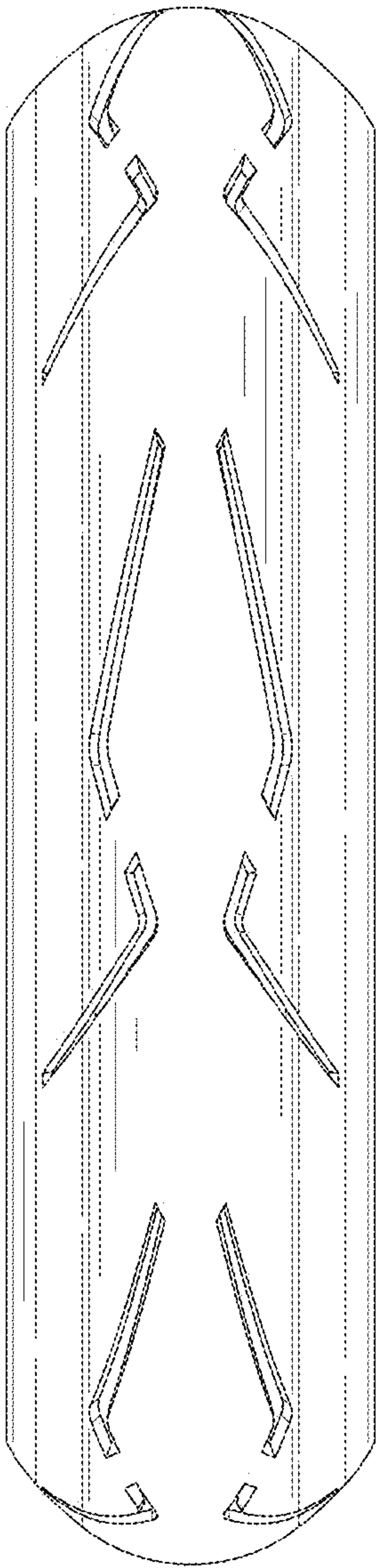

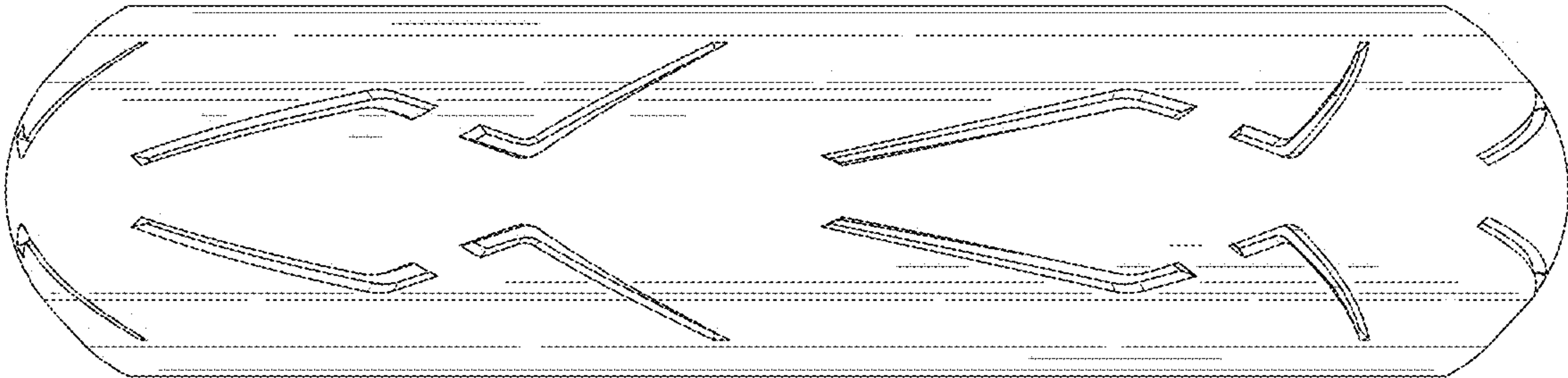

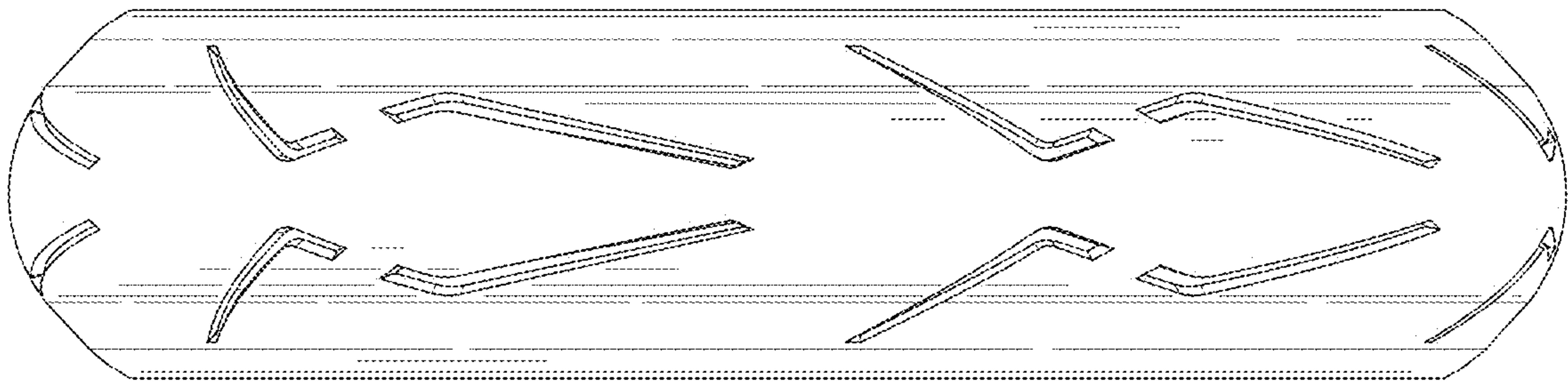

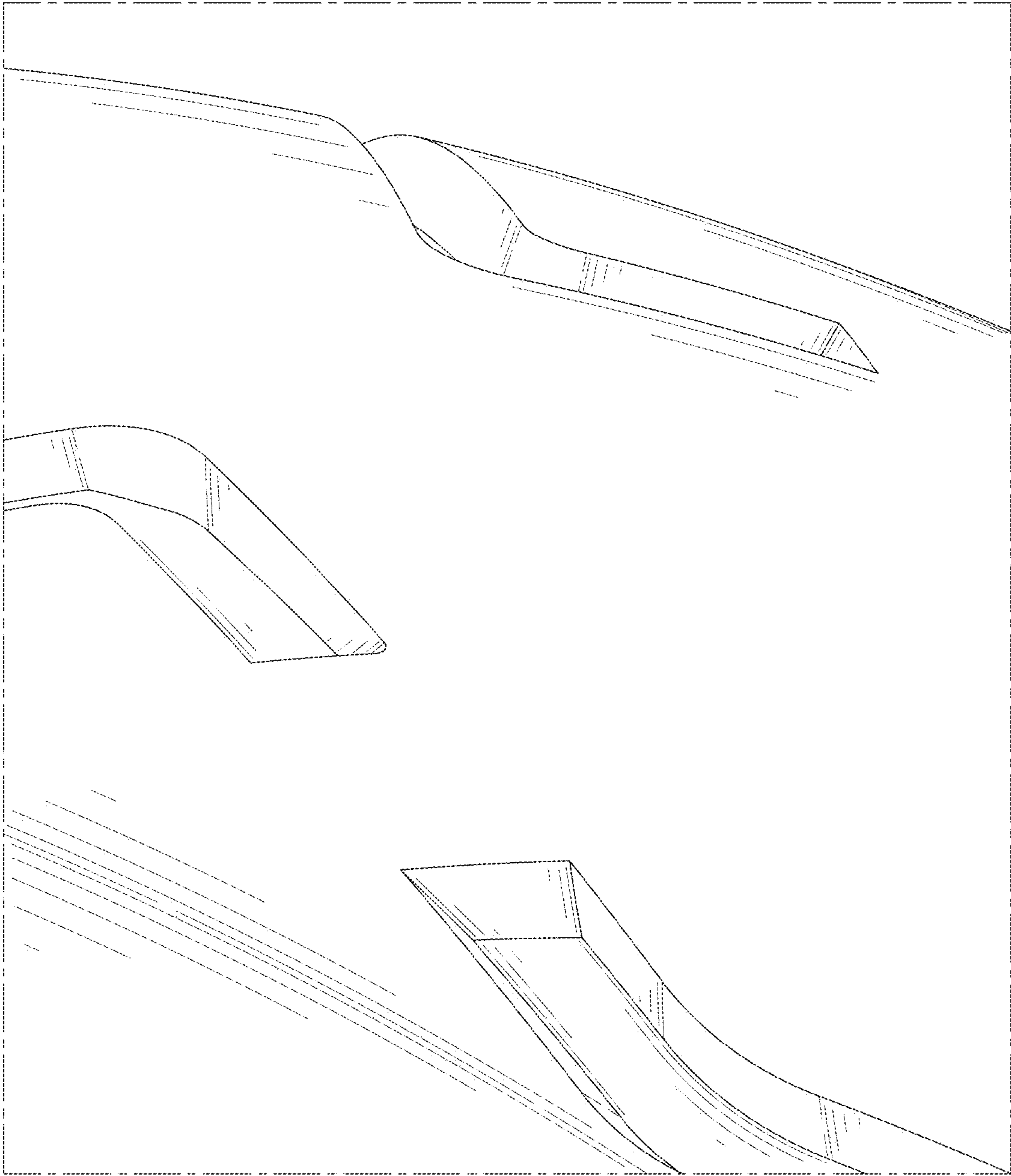

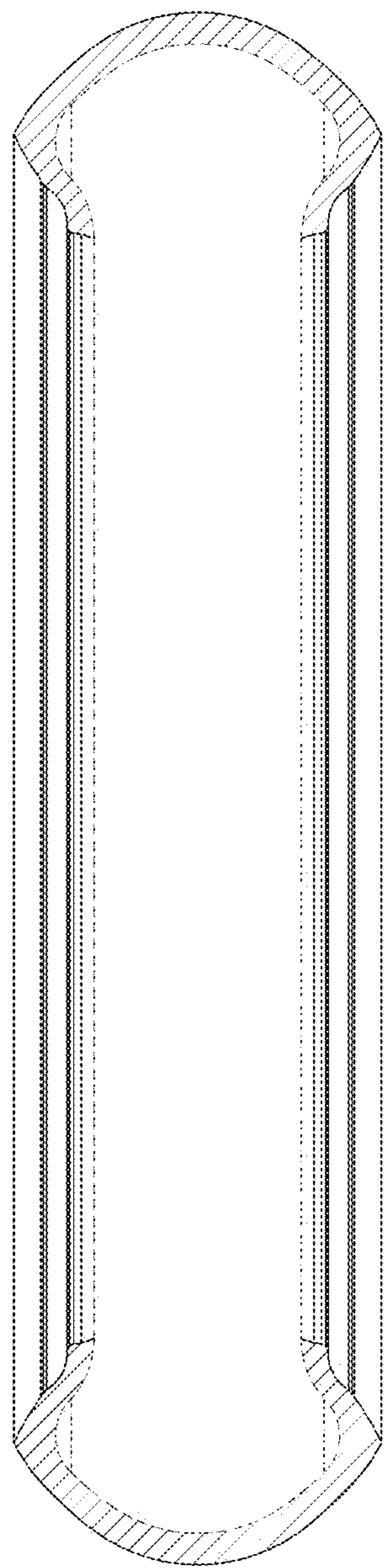
