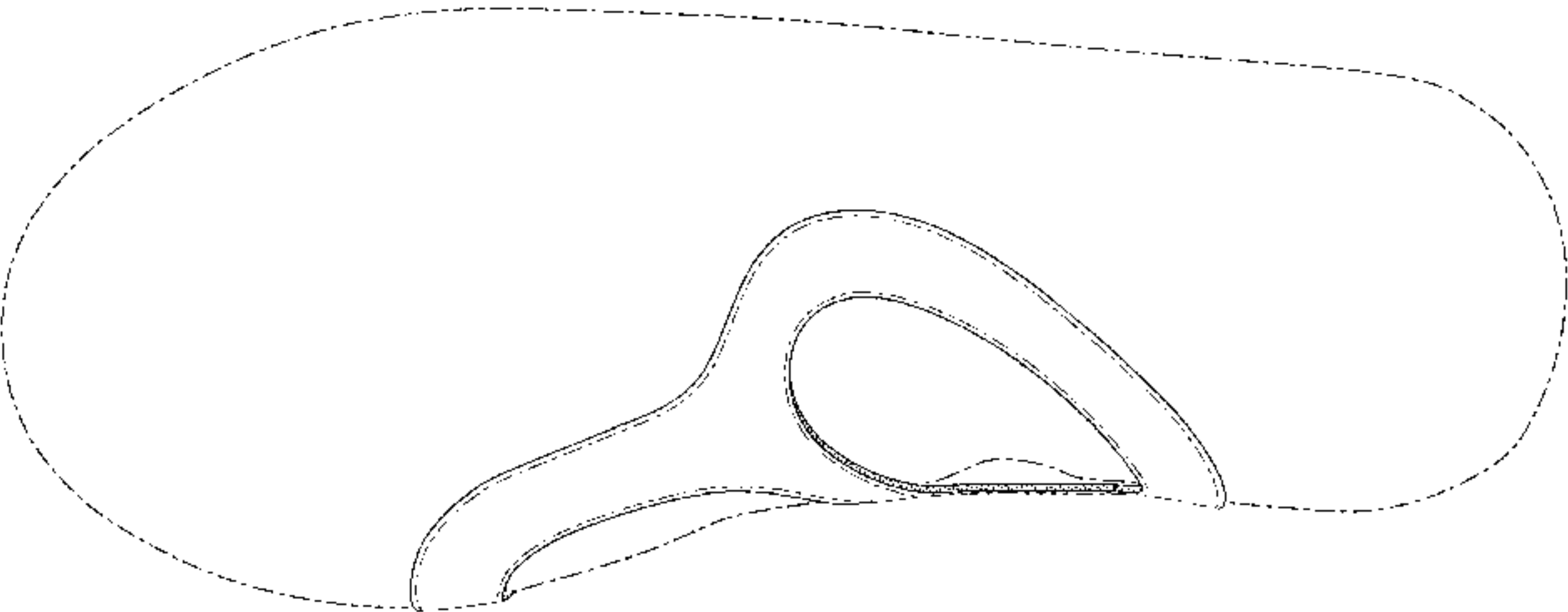
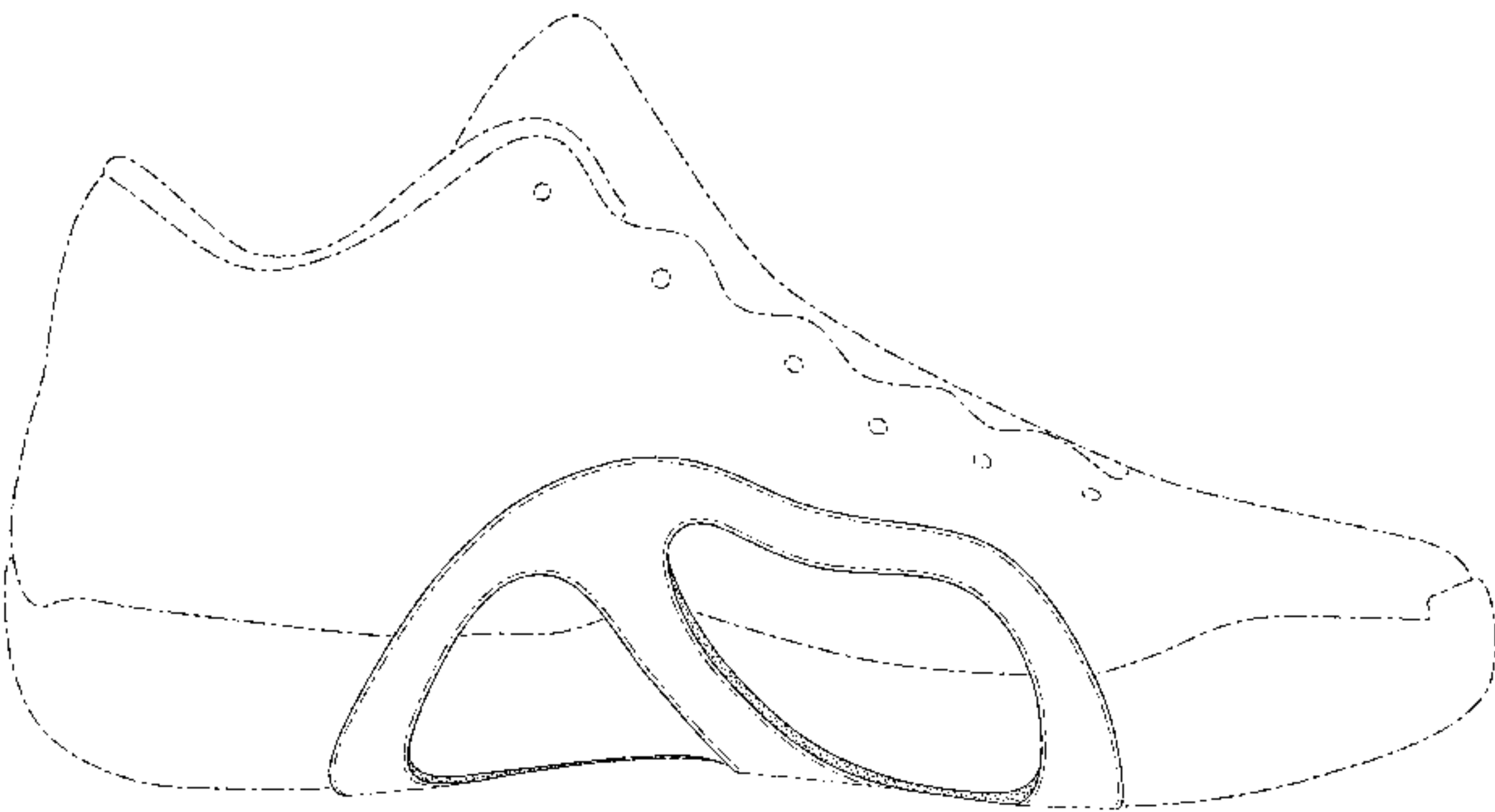
(57) CLAIM

The ornamental design for a shoe as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a bottom view thereof; and,
FIG. 5 is a bottom rear perspective view thereof.
The broken lines and unshaded areas depicting the outward-facing surface of the element form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

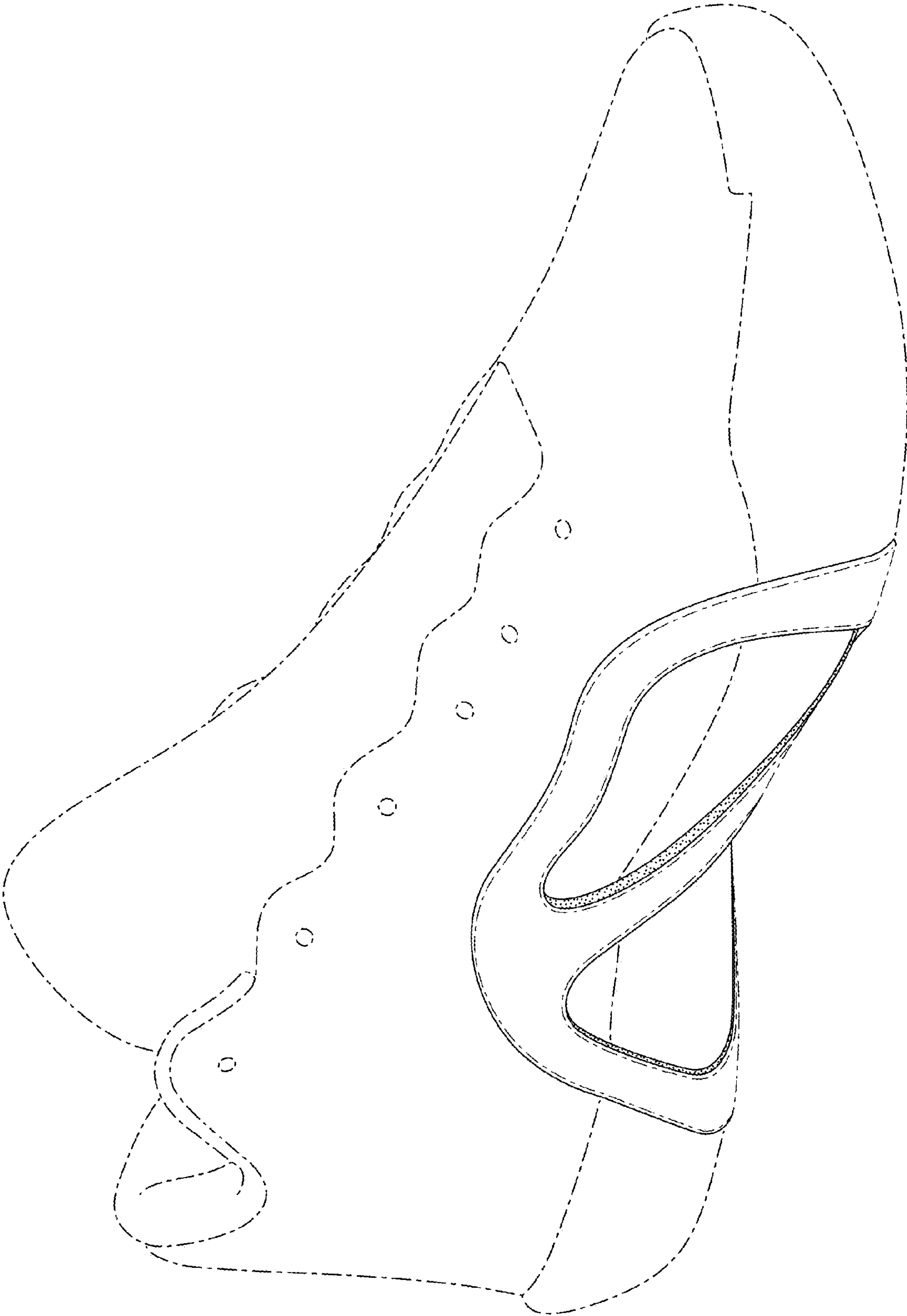

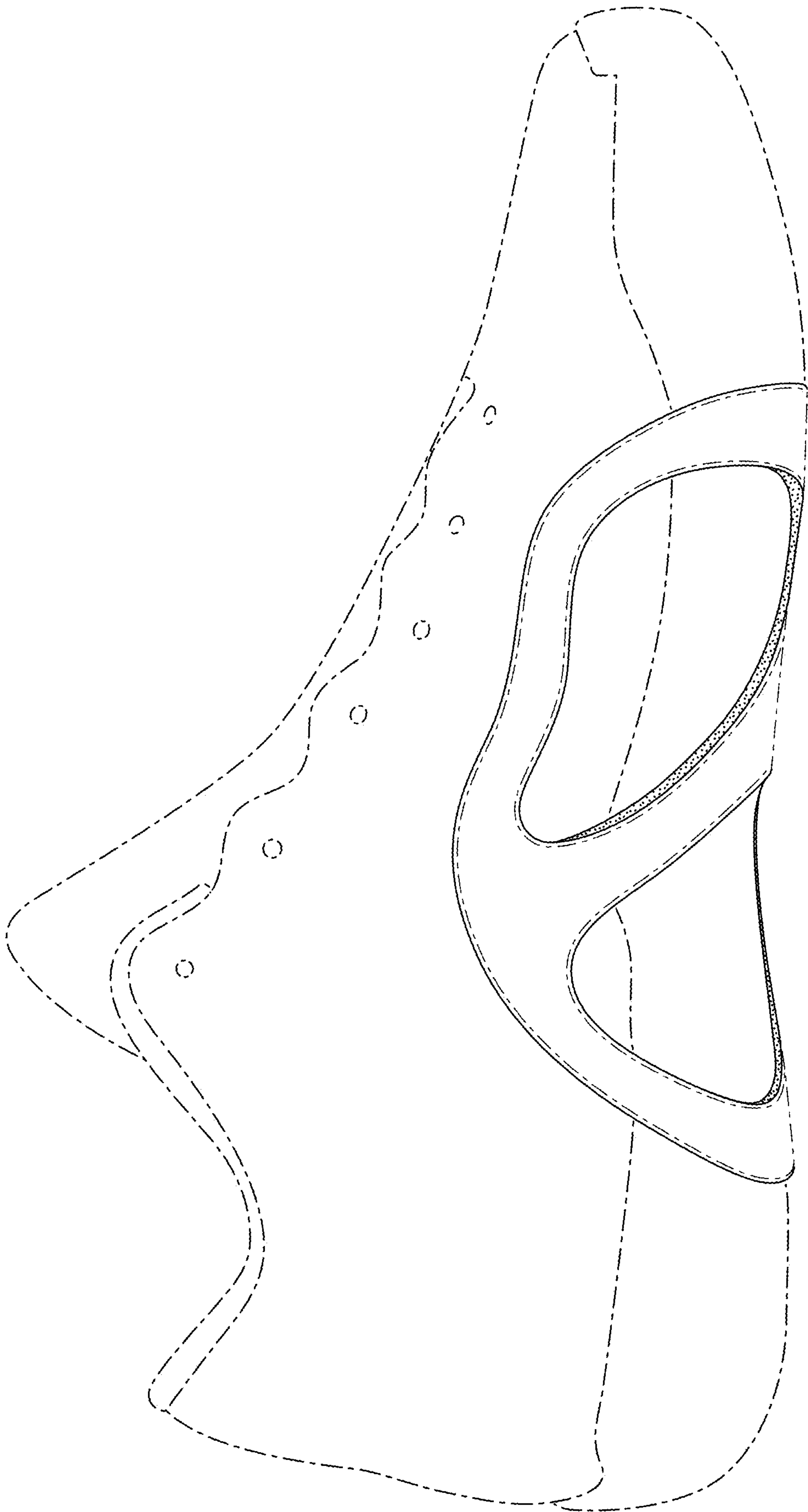

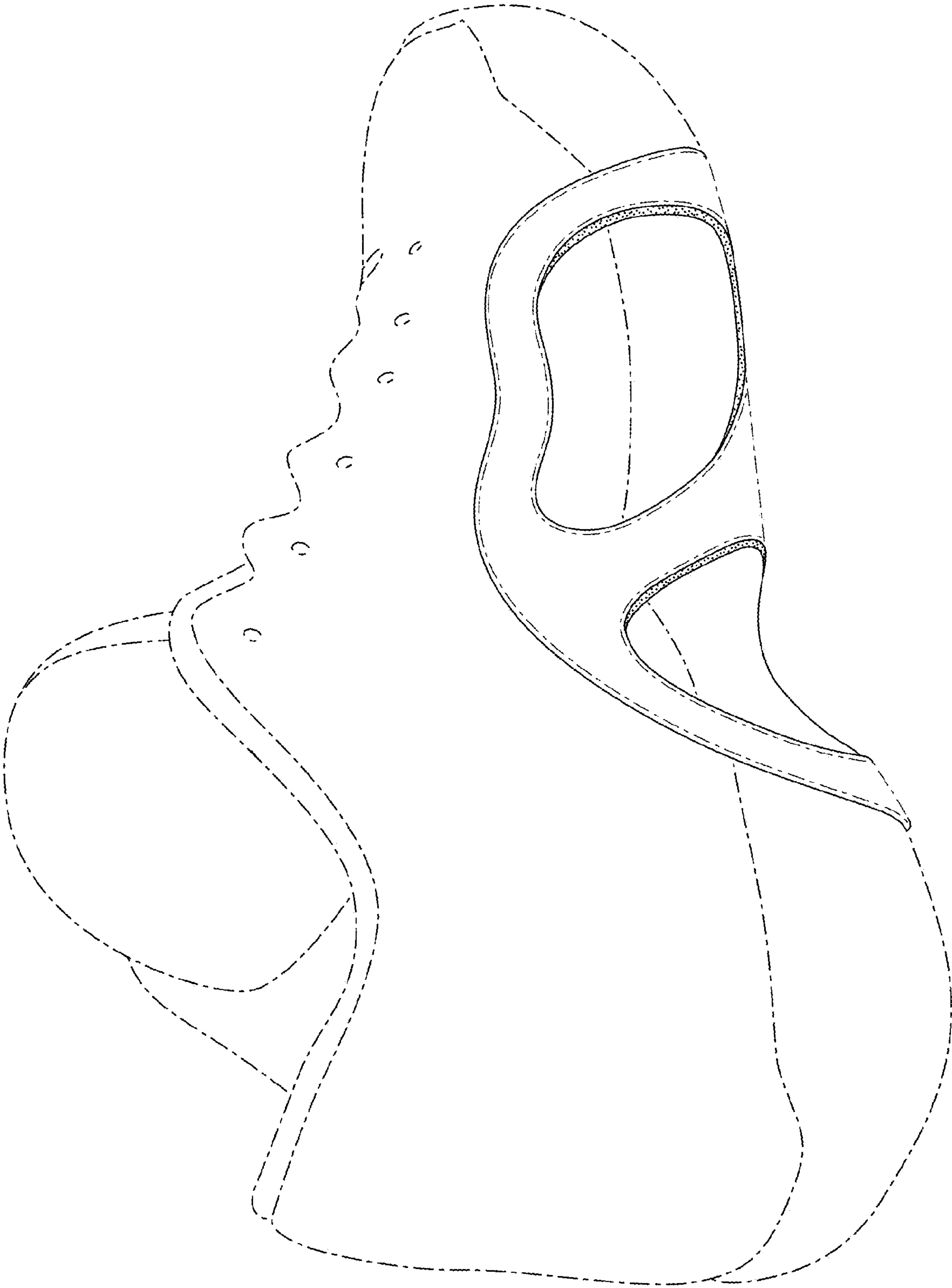

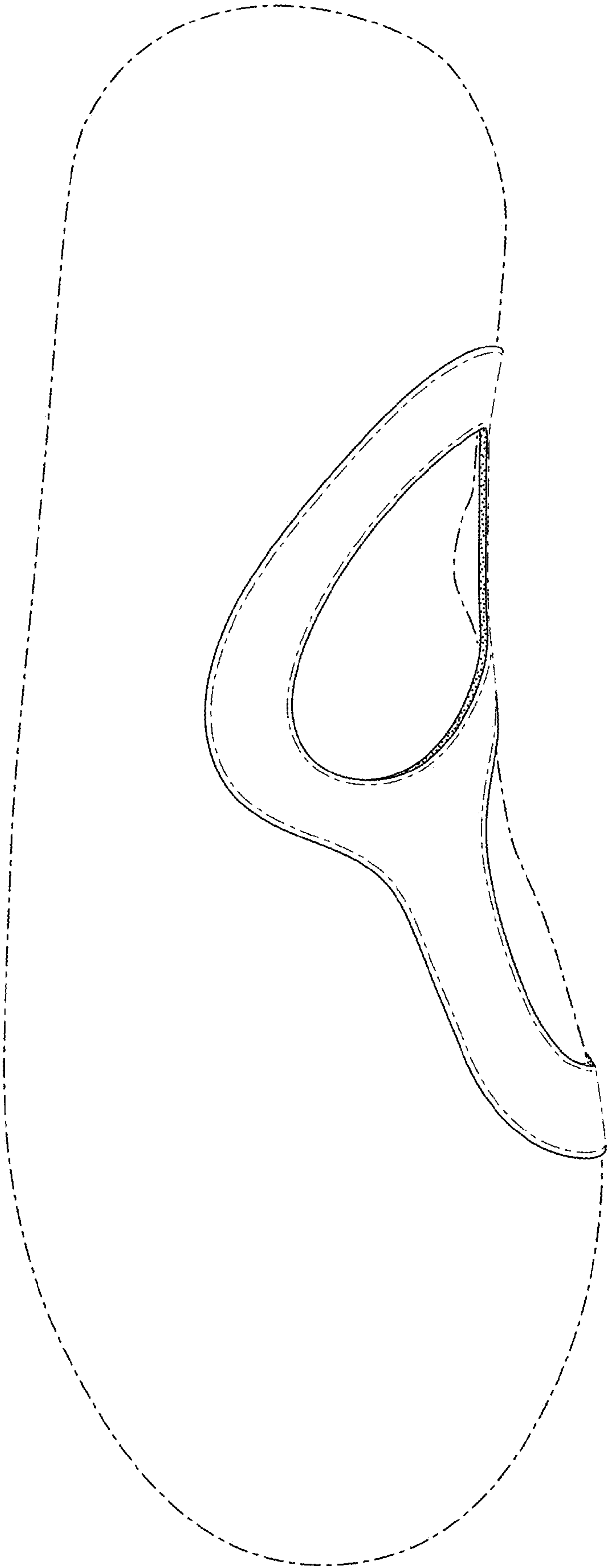

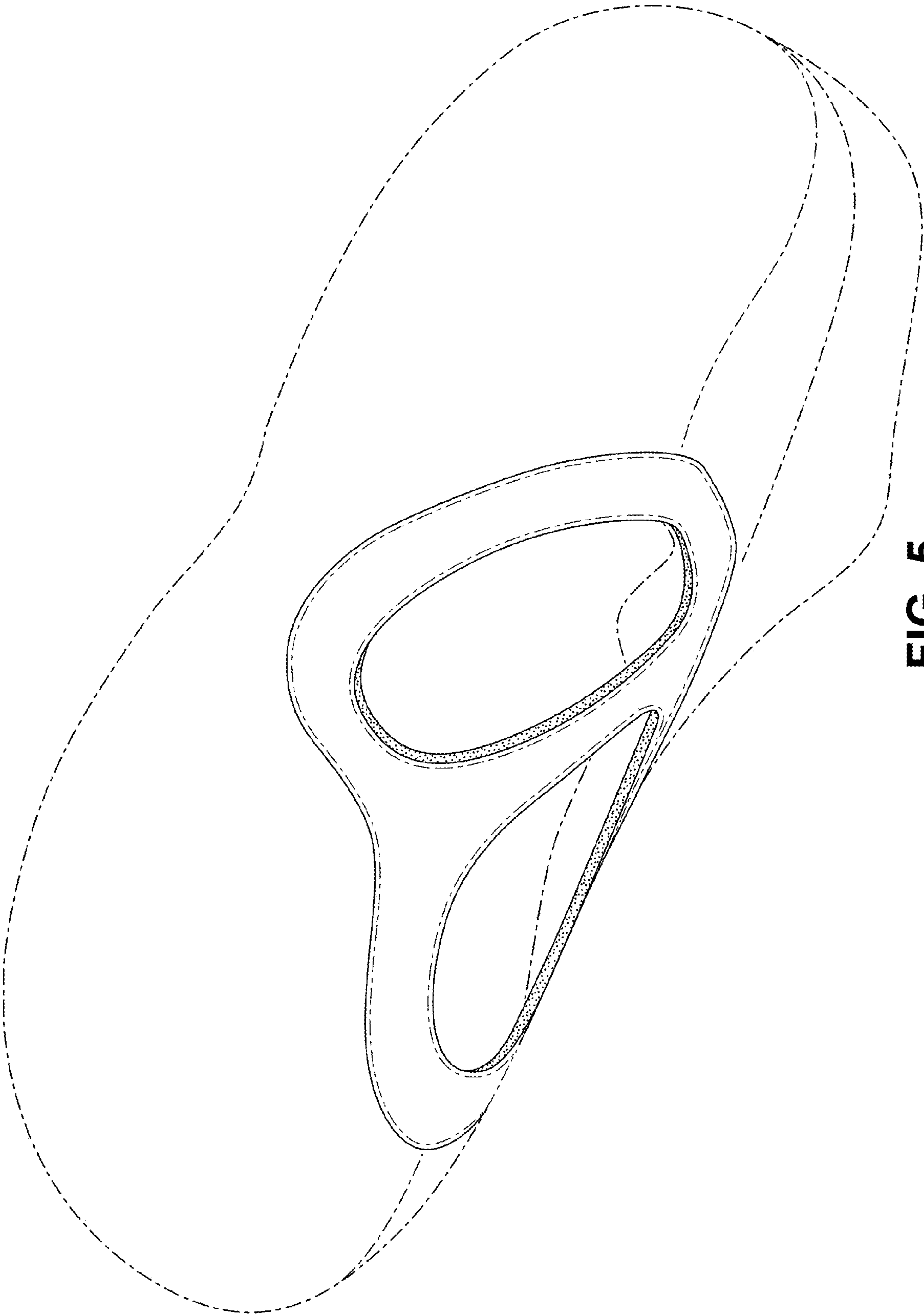
