DESCRIPTION

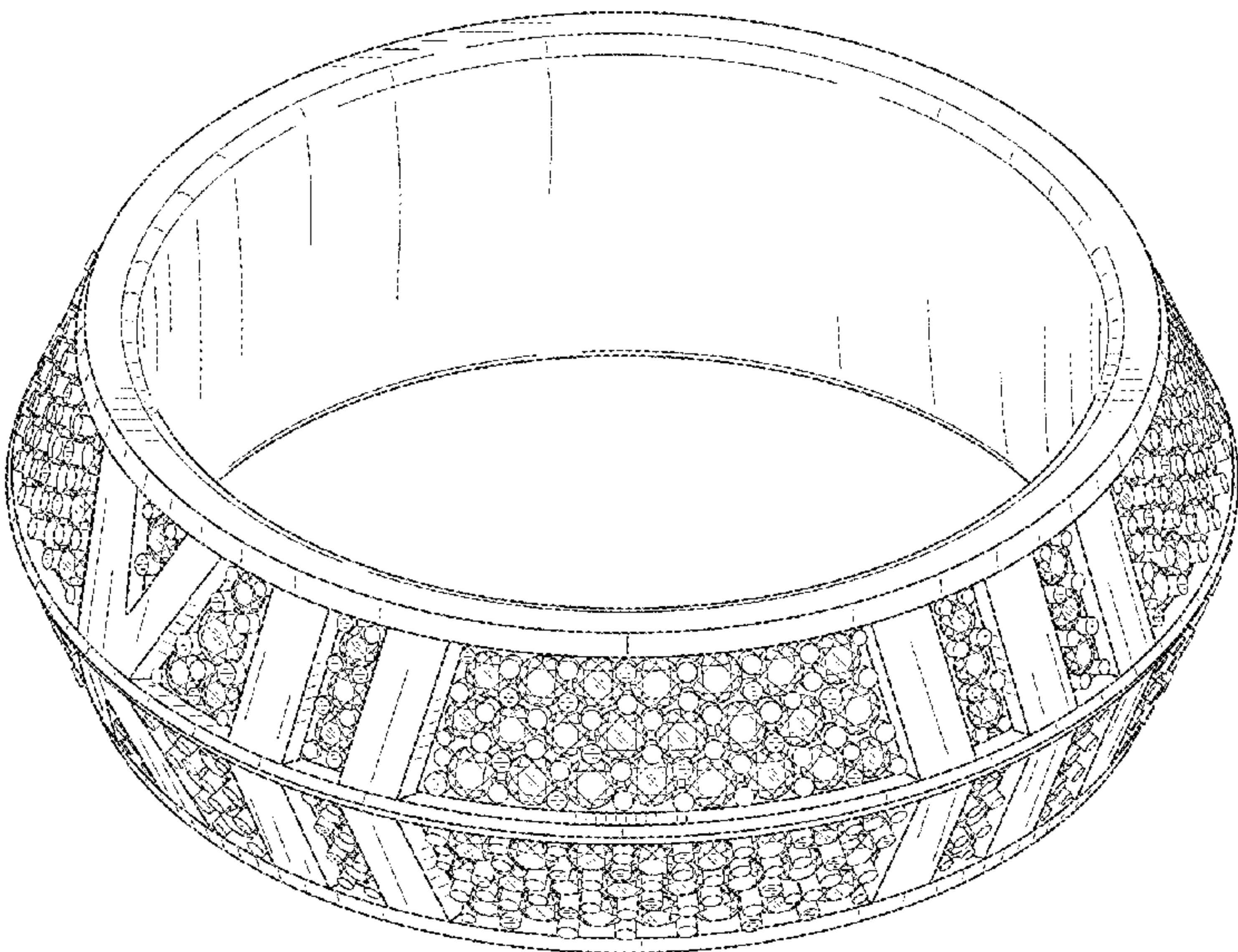
FIG. 1 is a perspective view of the article of jewelry showing our new design;

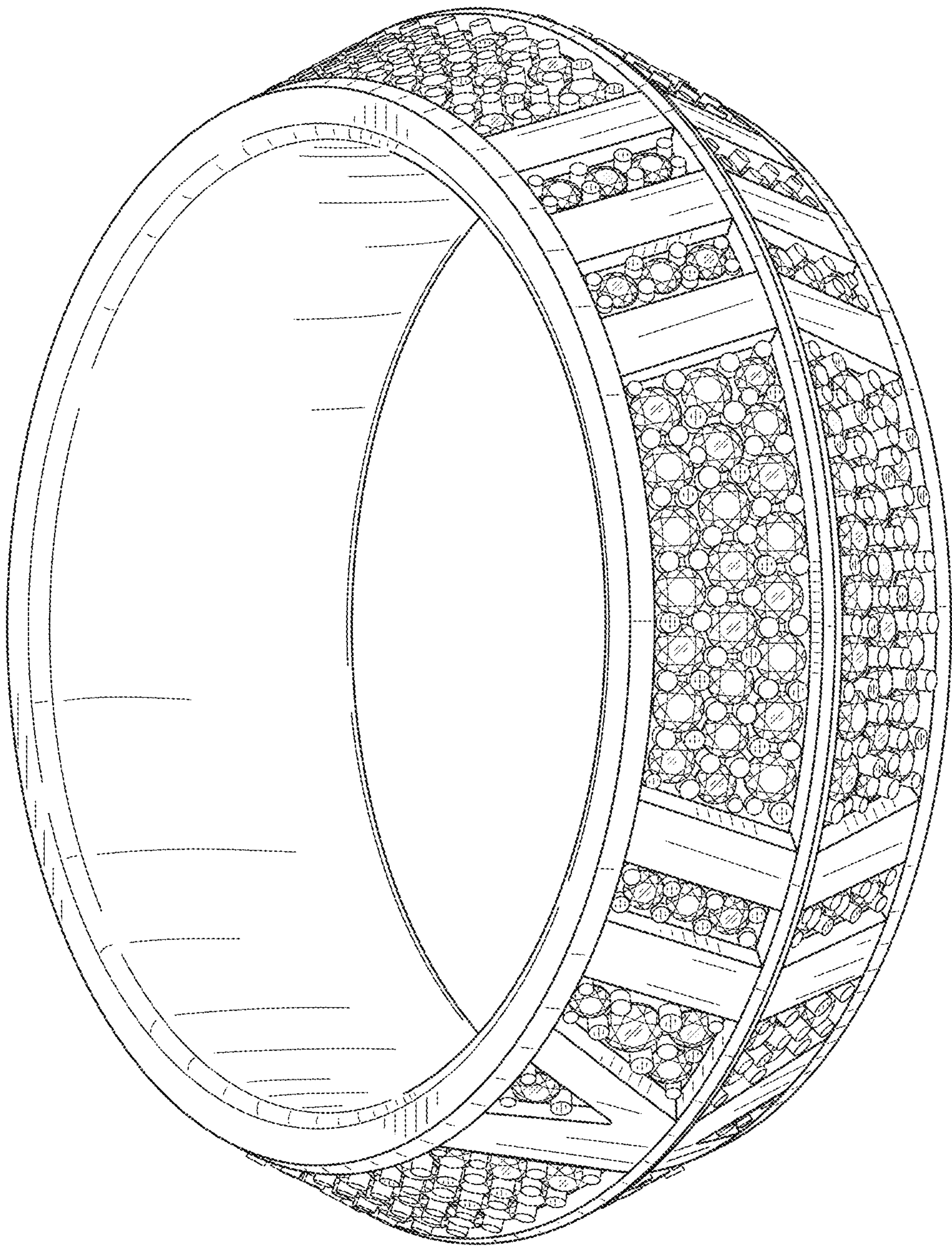

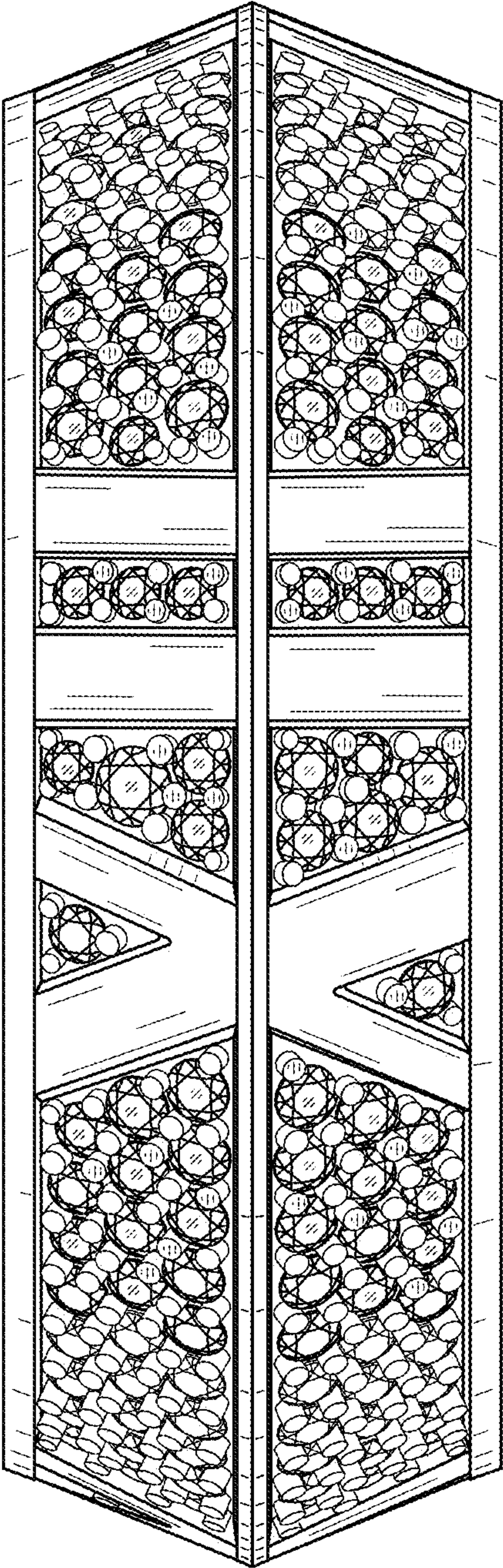

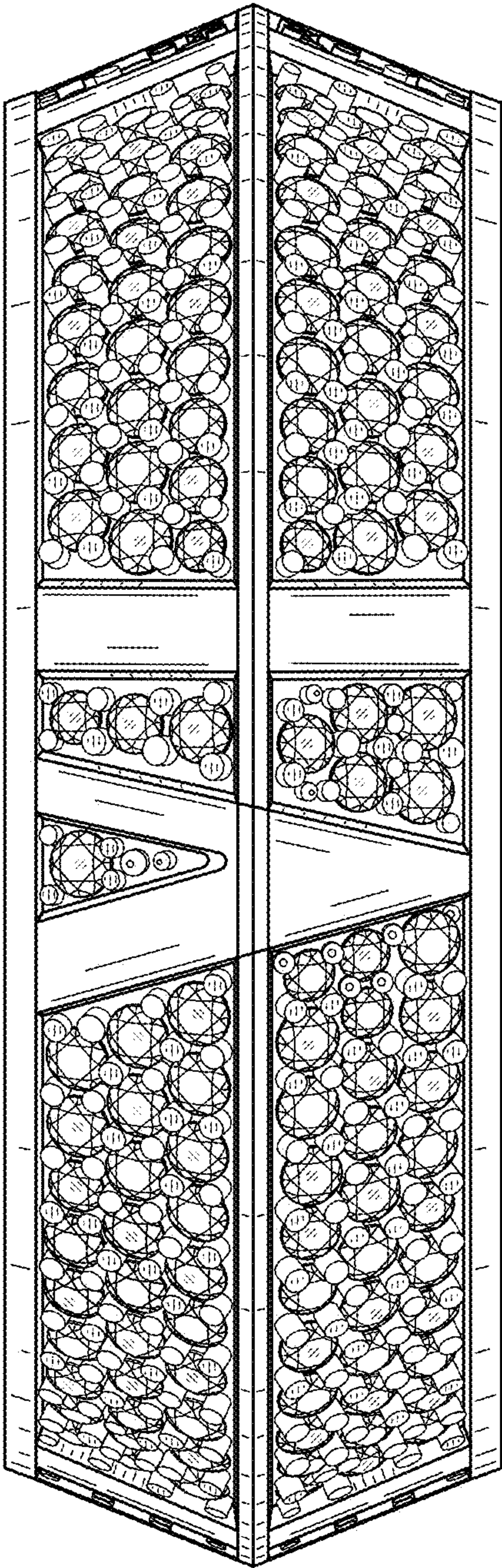

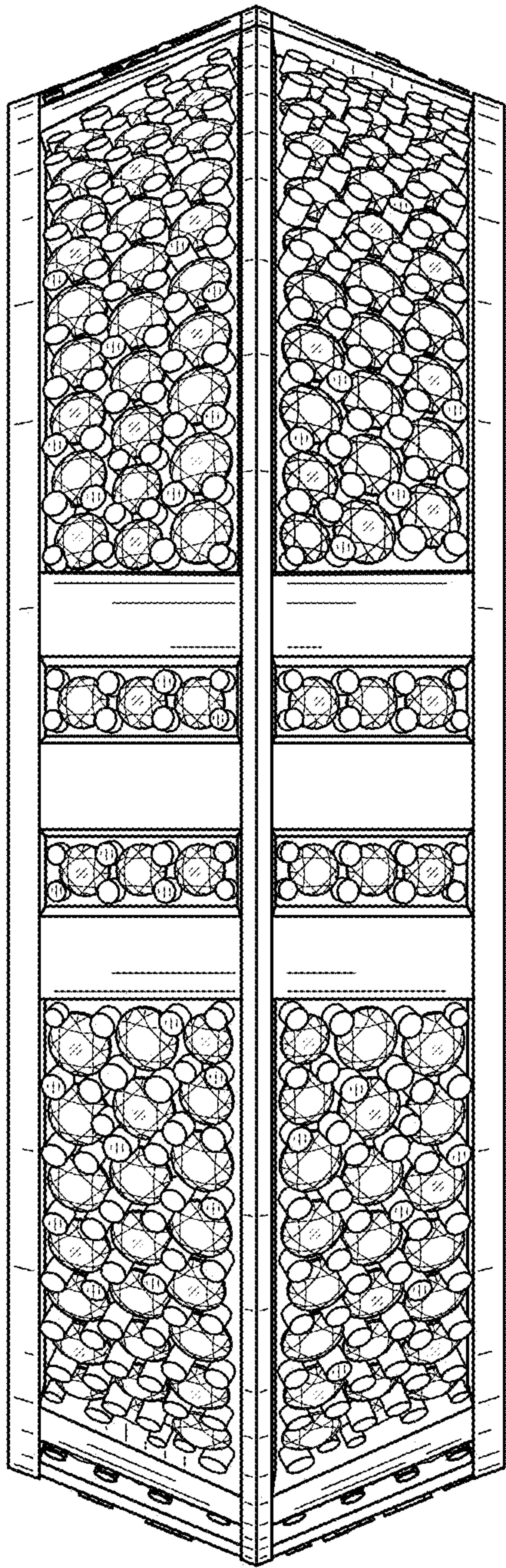

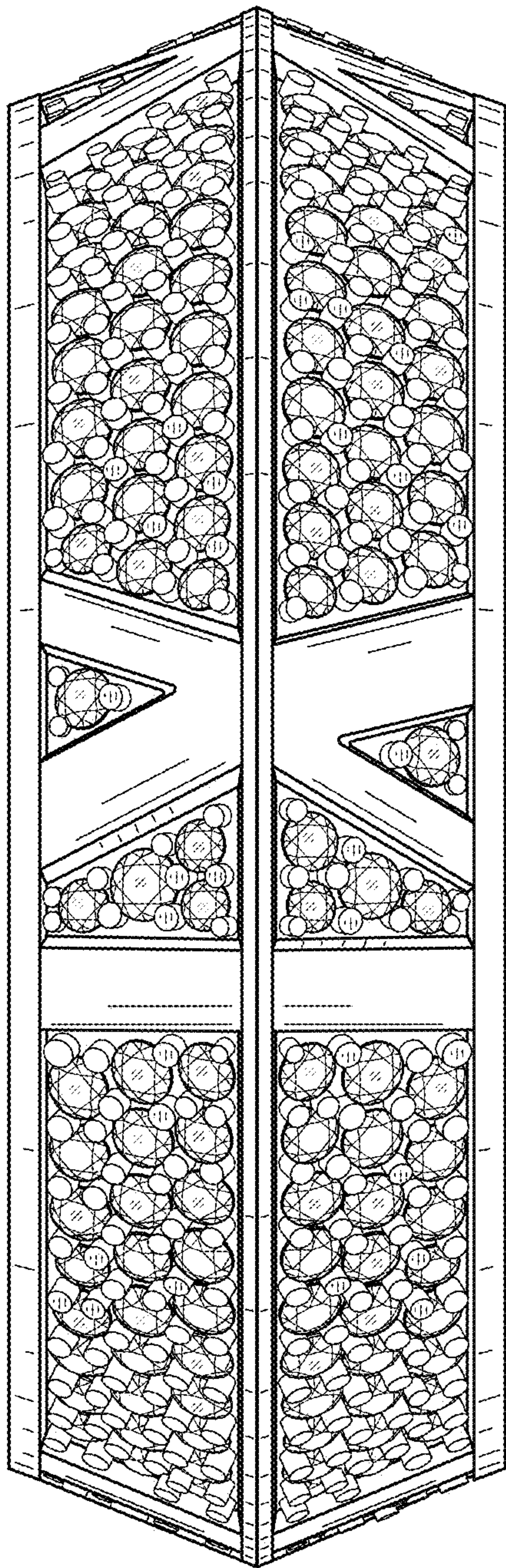

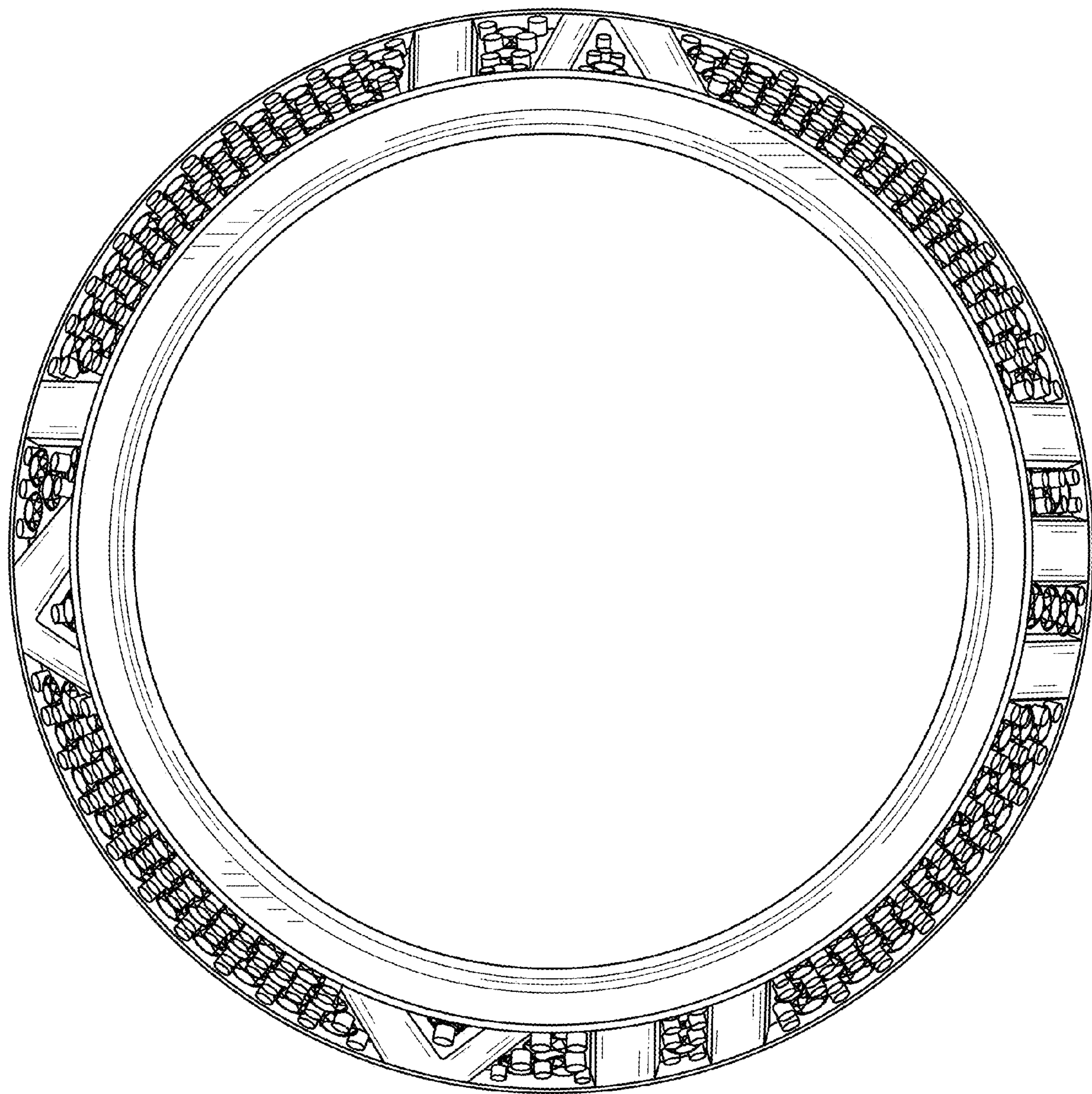

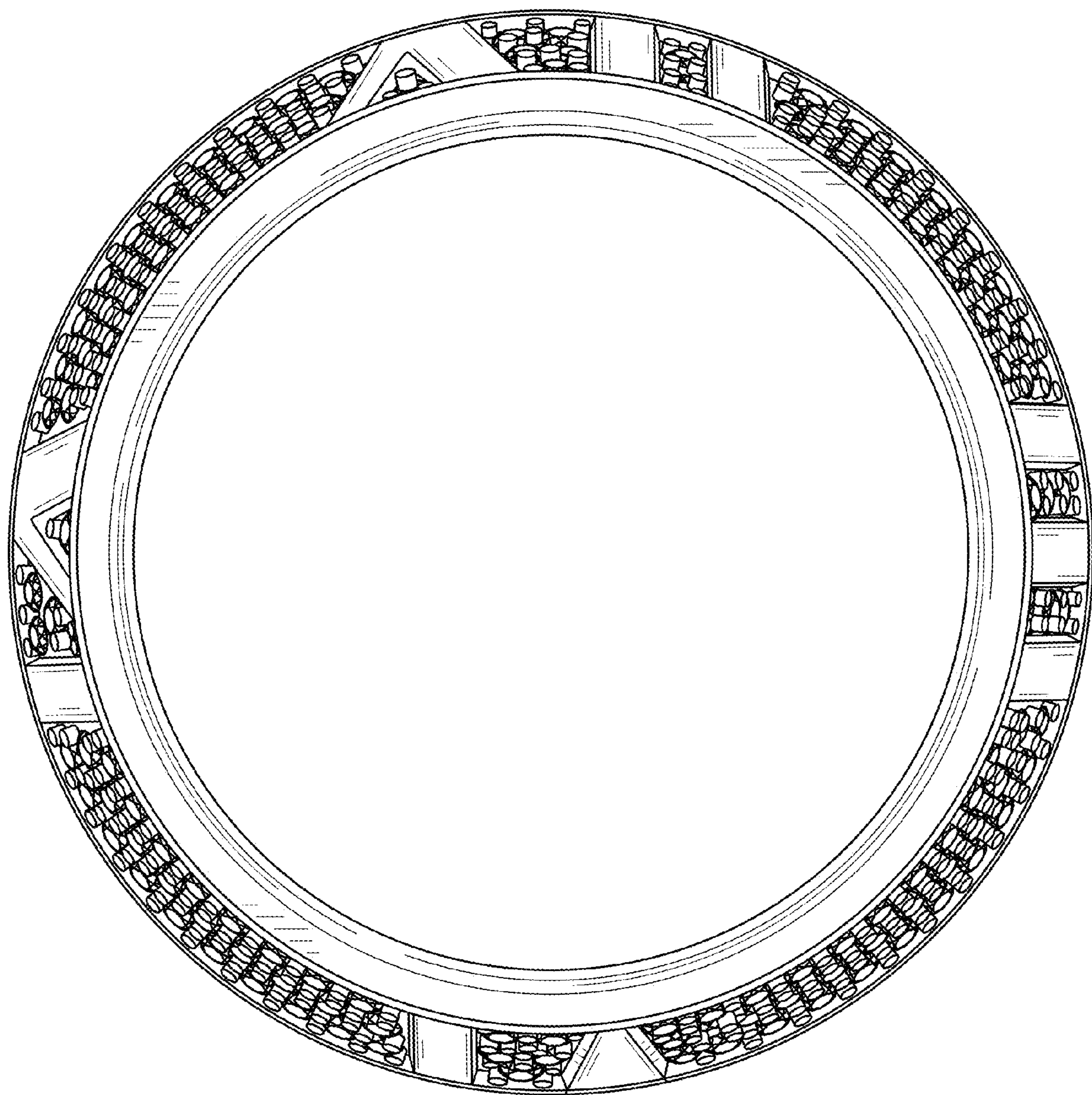
