FIG. 5 is a front view of the golf club head of FIG. 1;

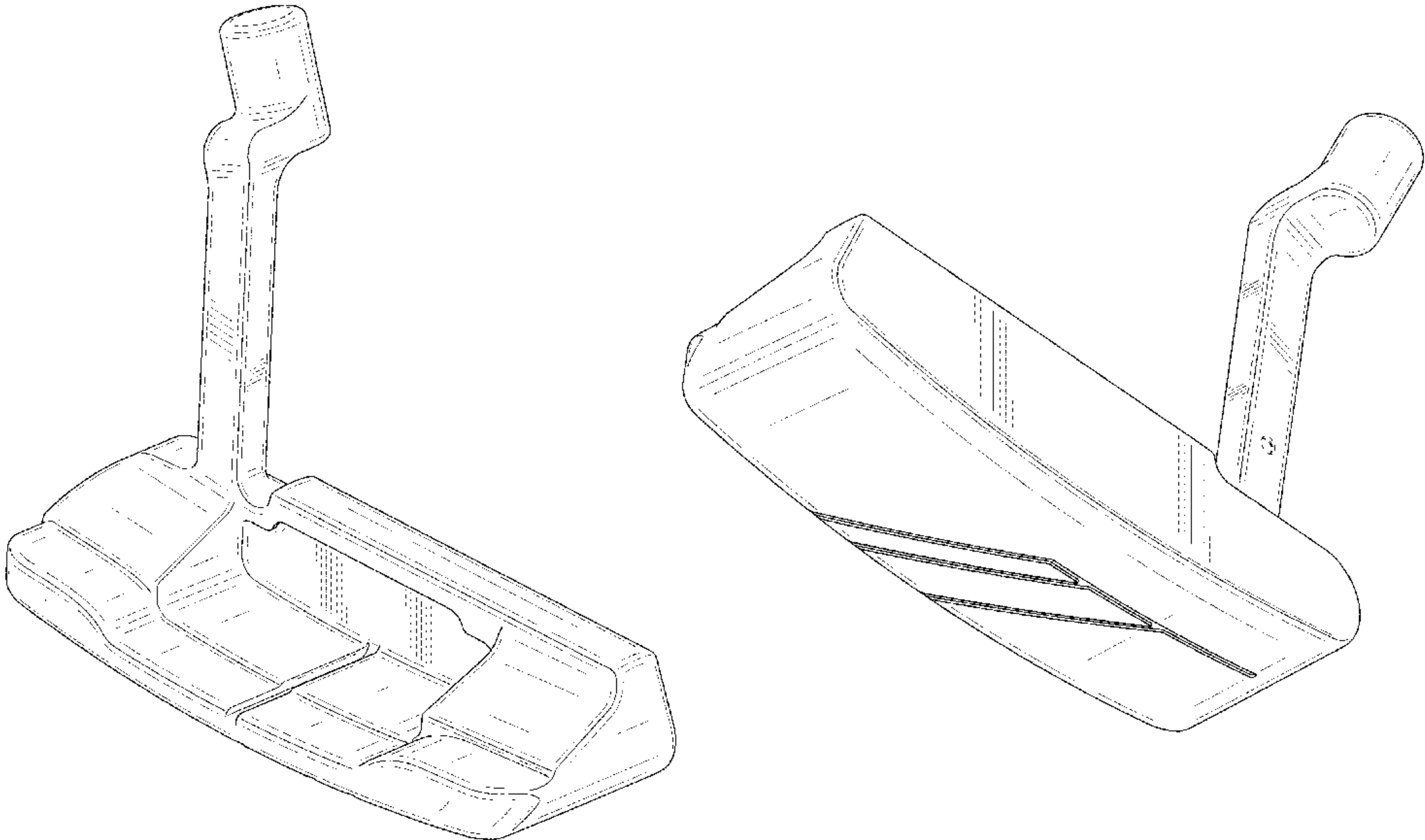
FIG. 6 is a rear view of the golf club head of FIG. 1;

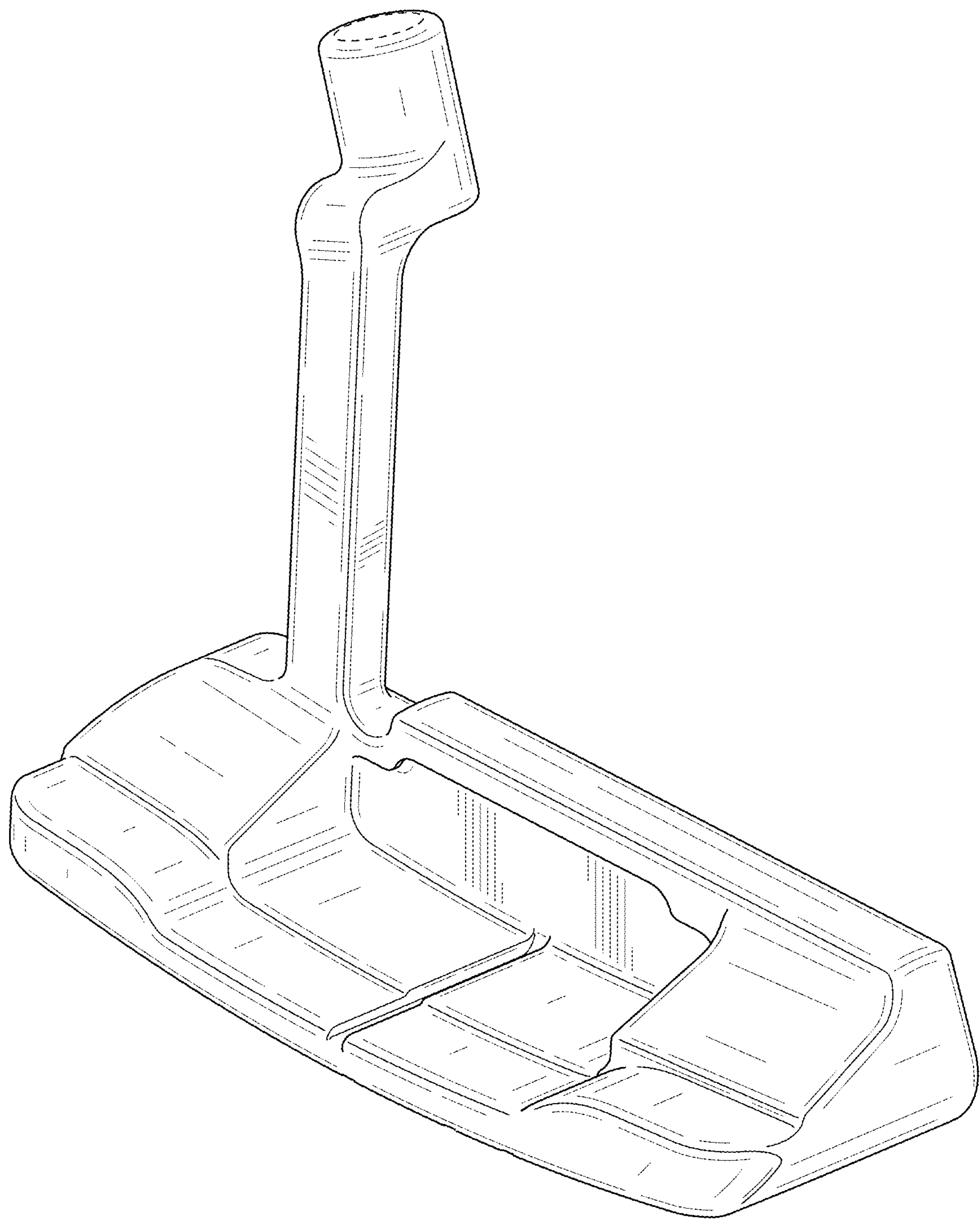

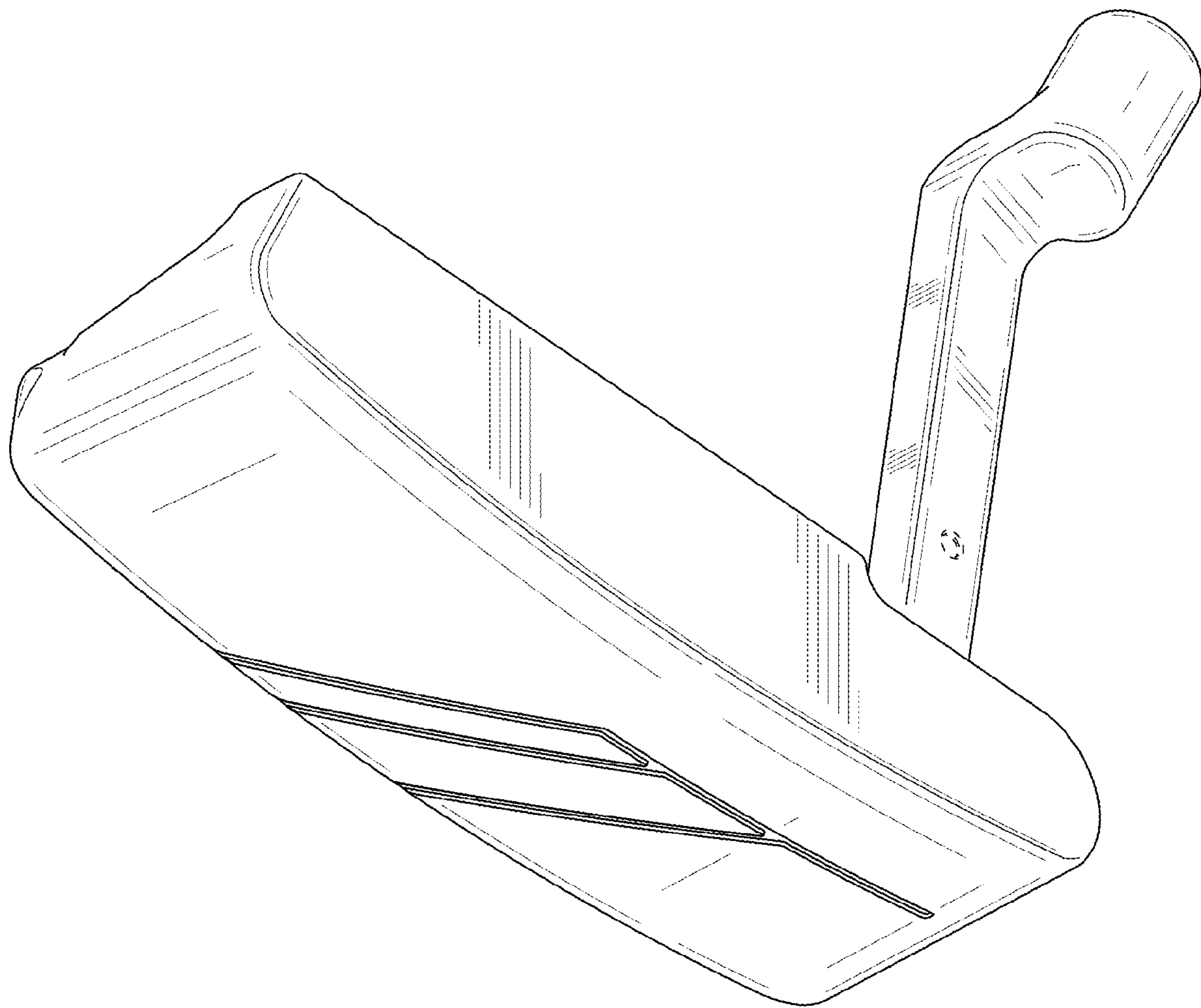

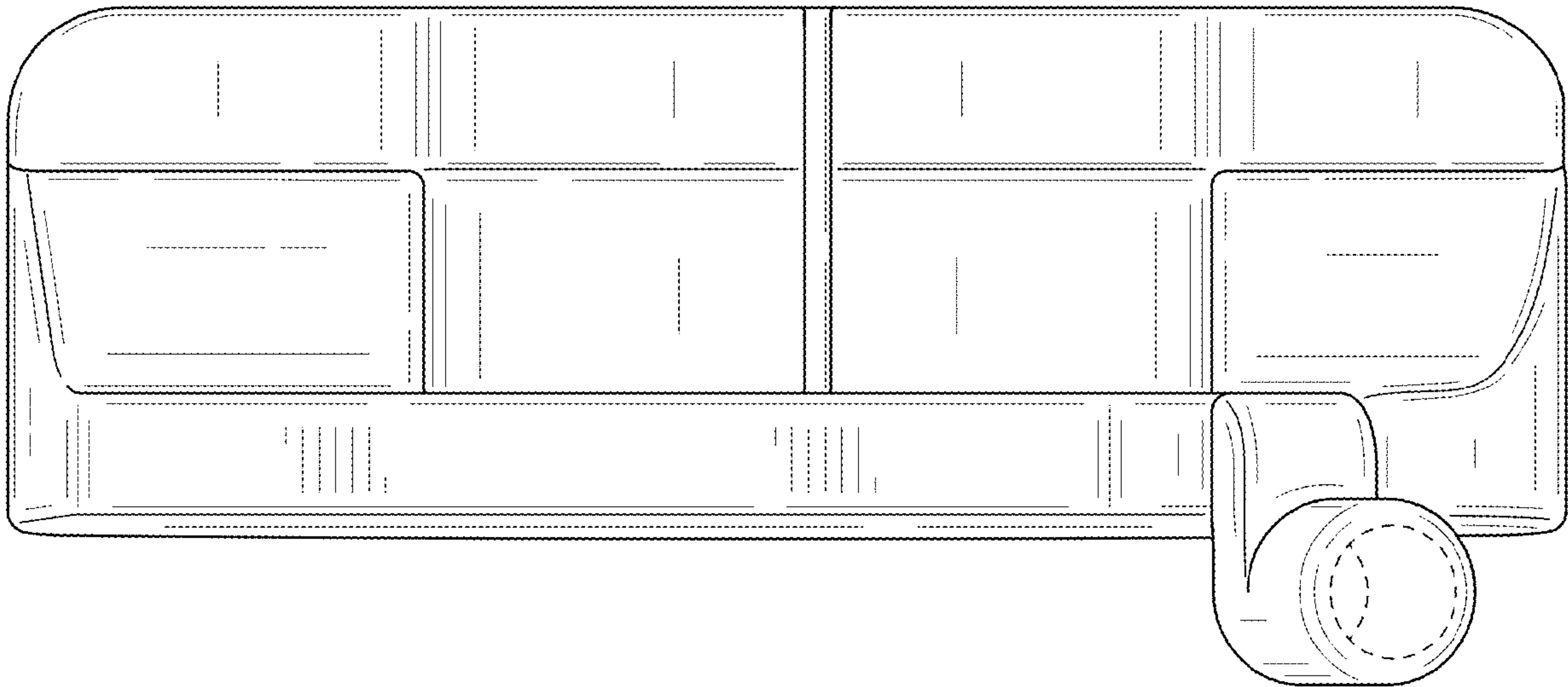

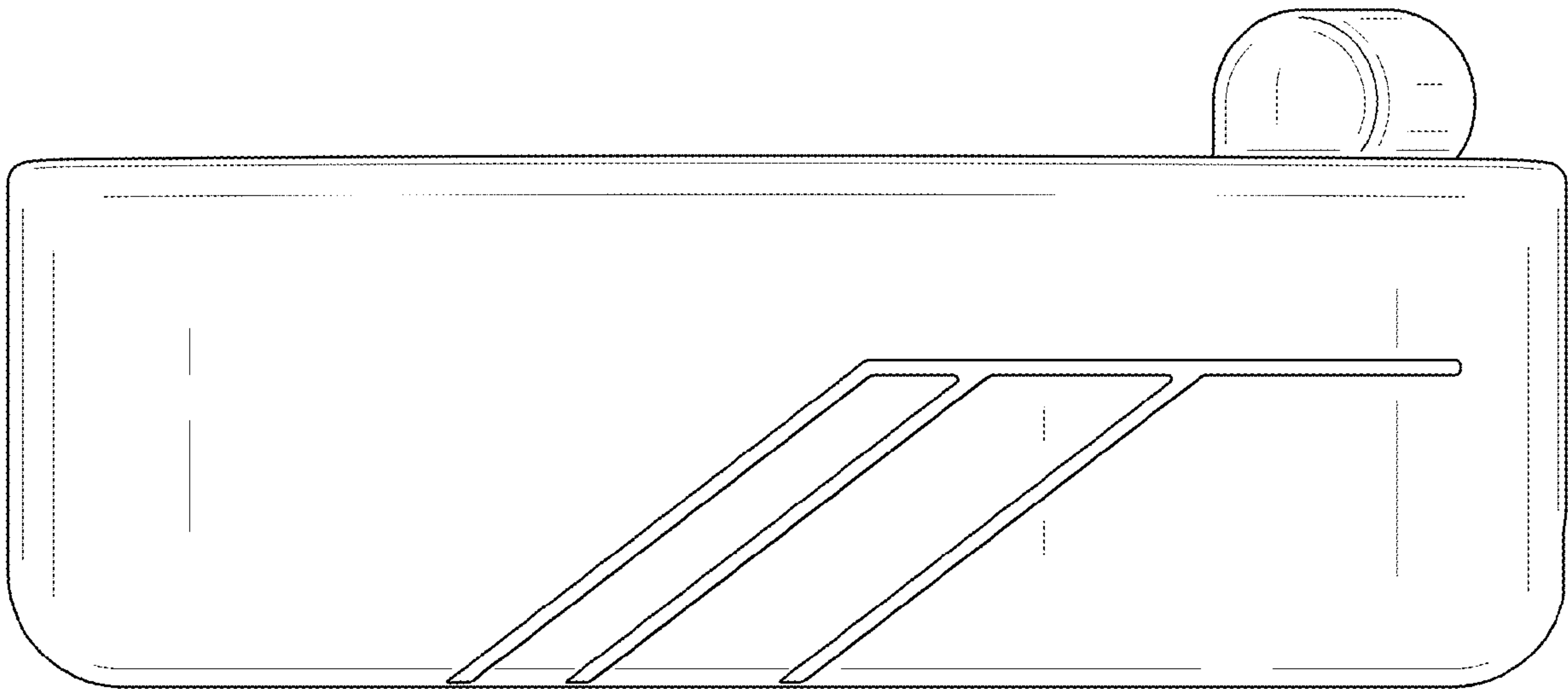

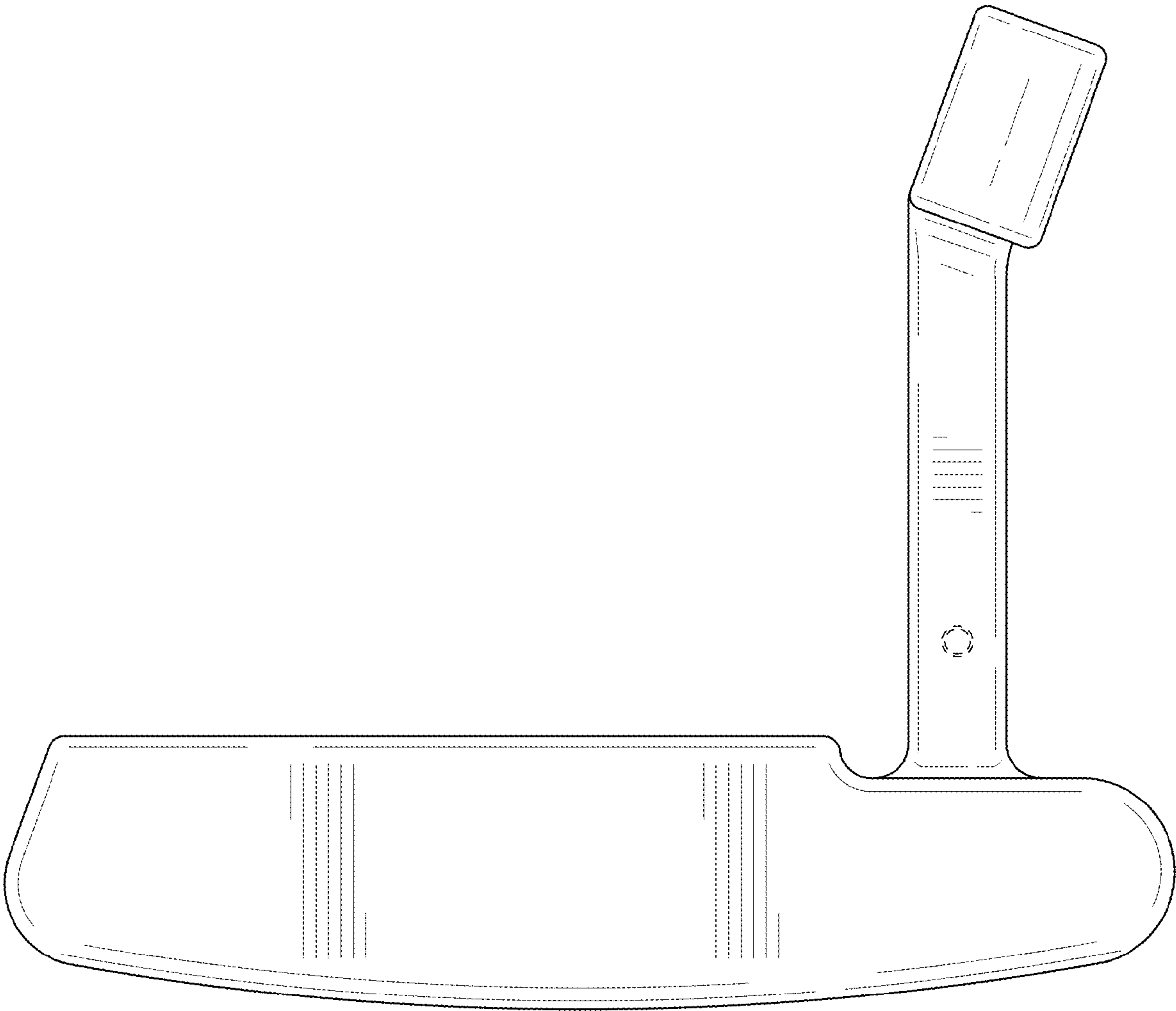

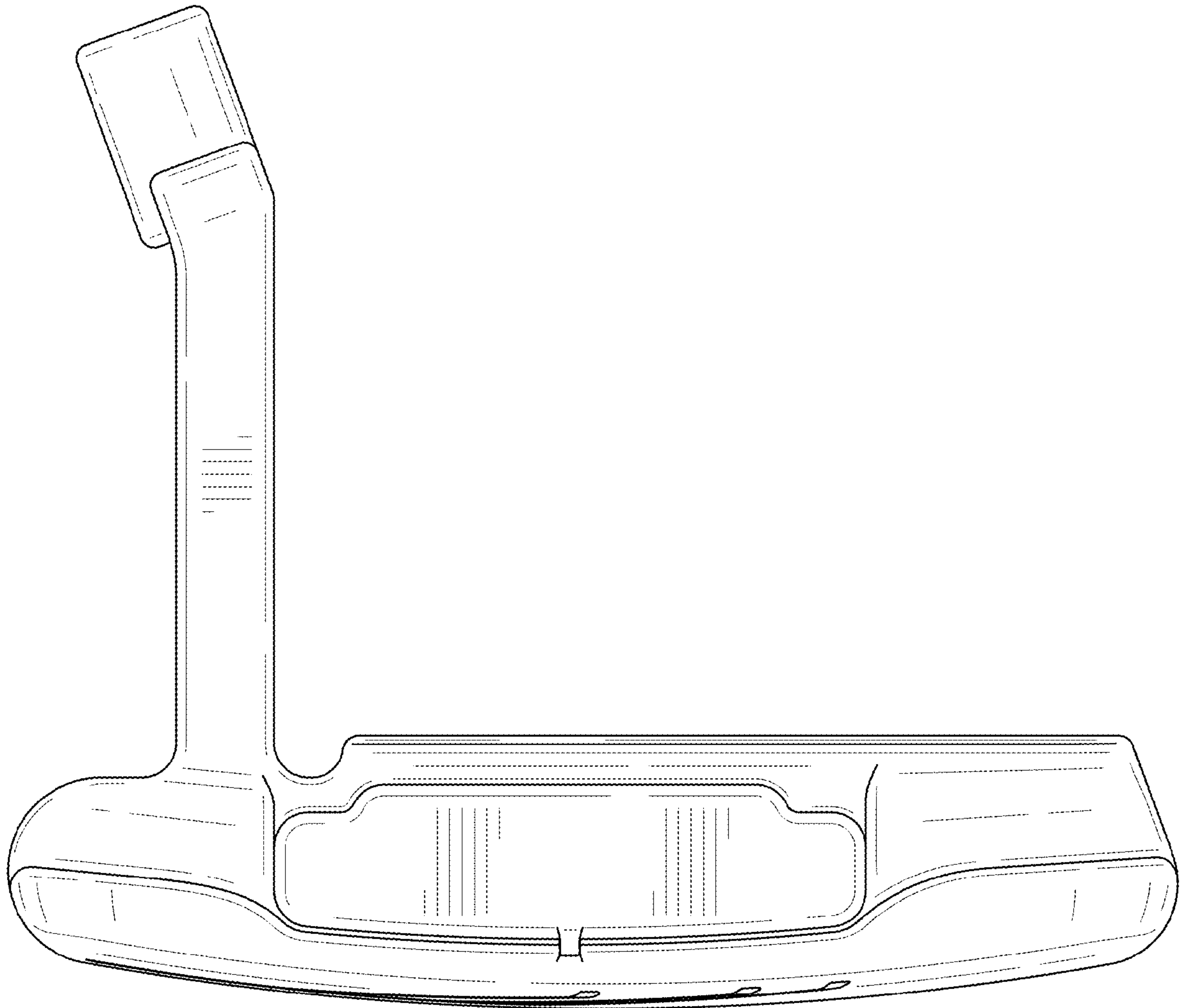

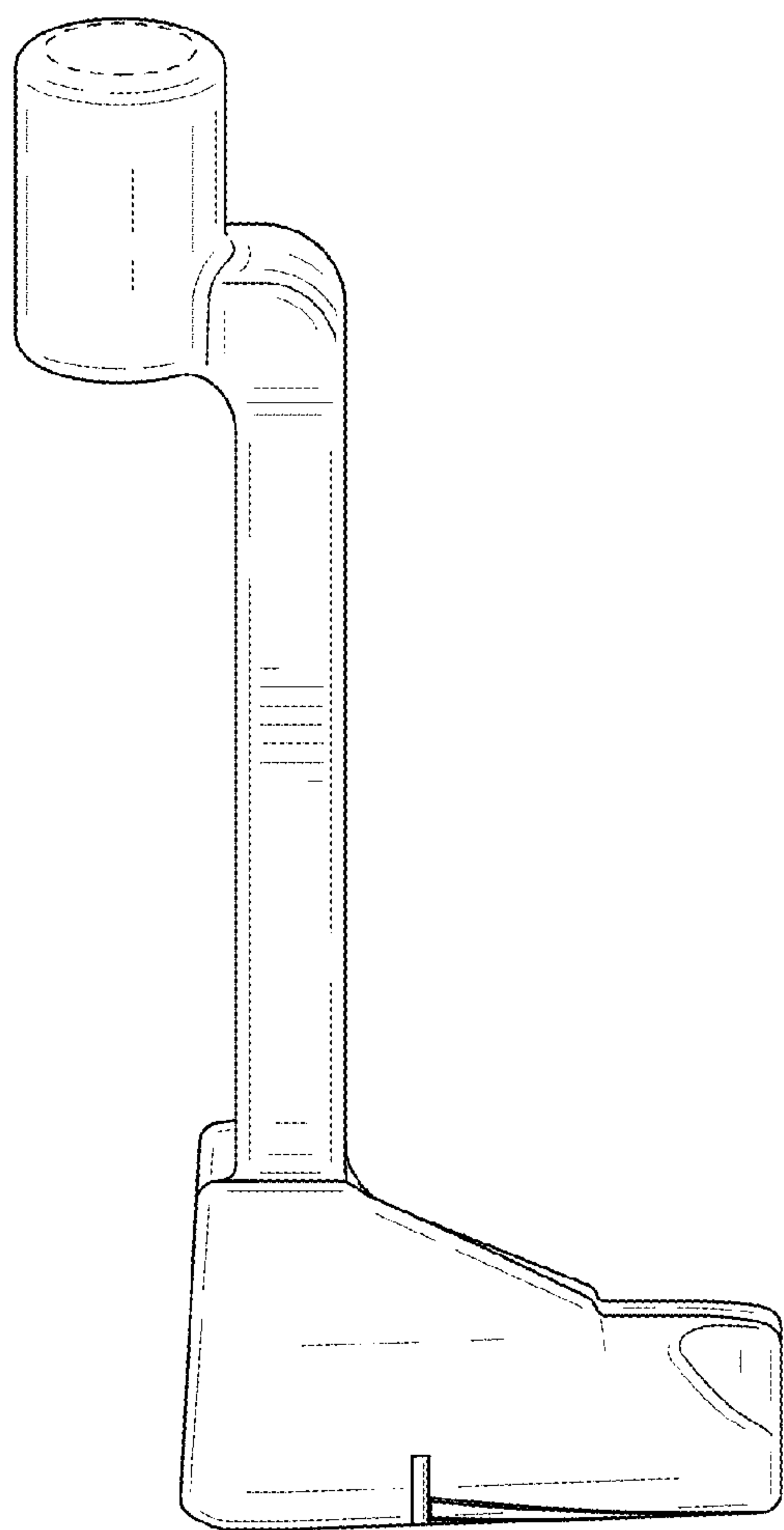

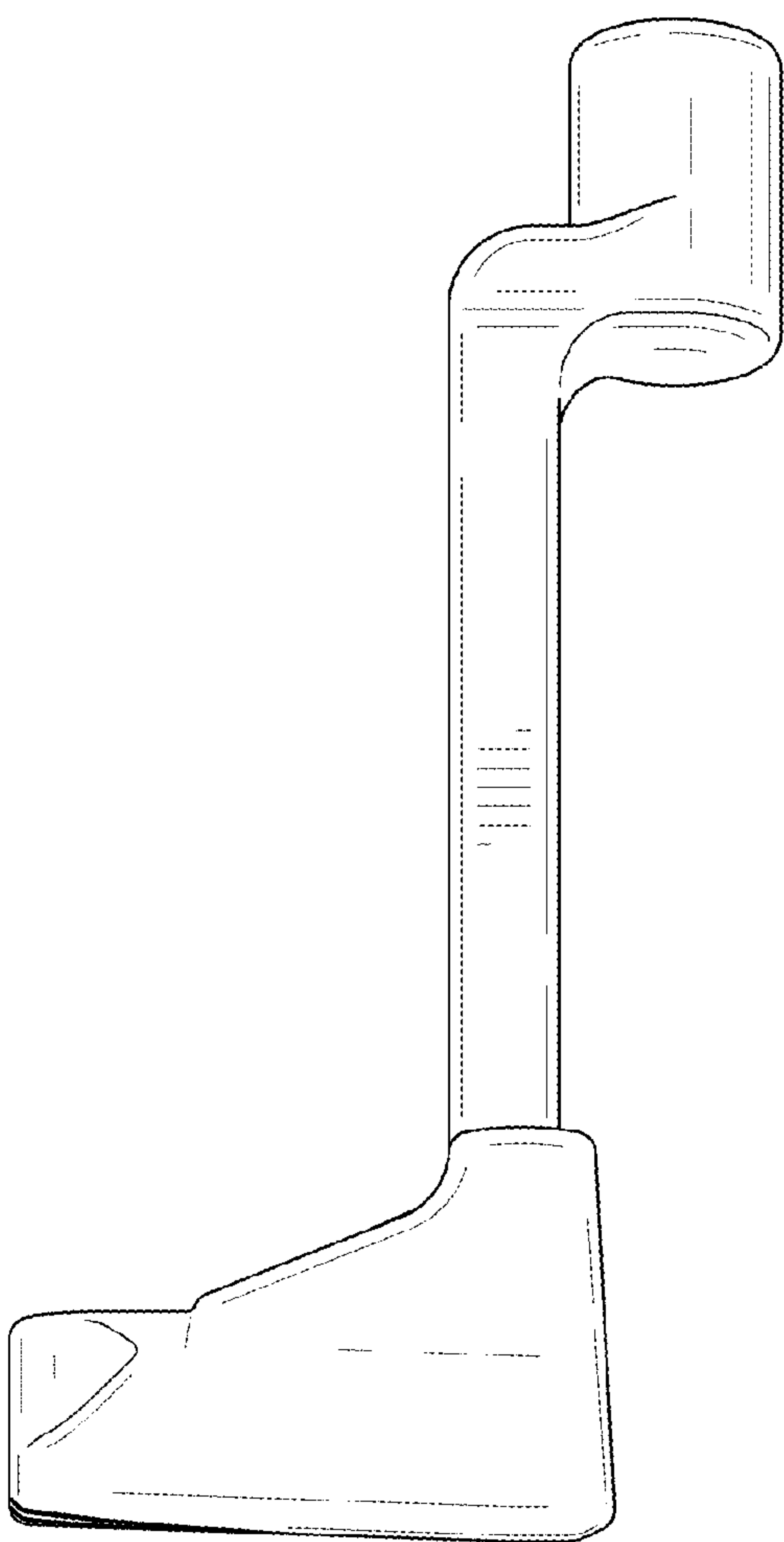
