FIG. 5 is a fifth image thereof; and

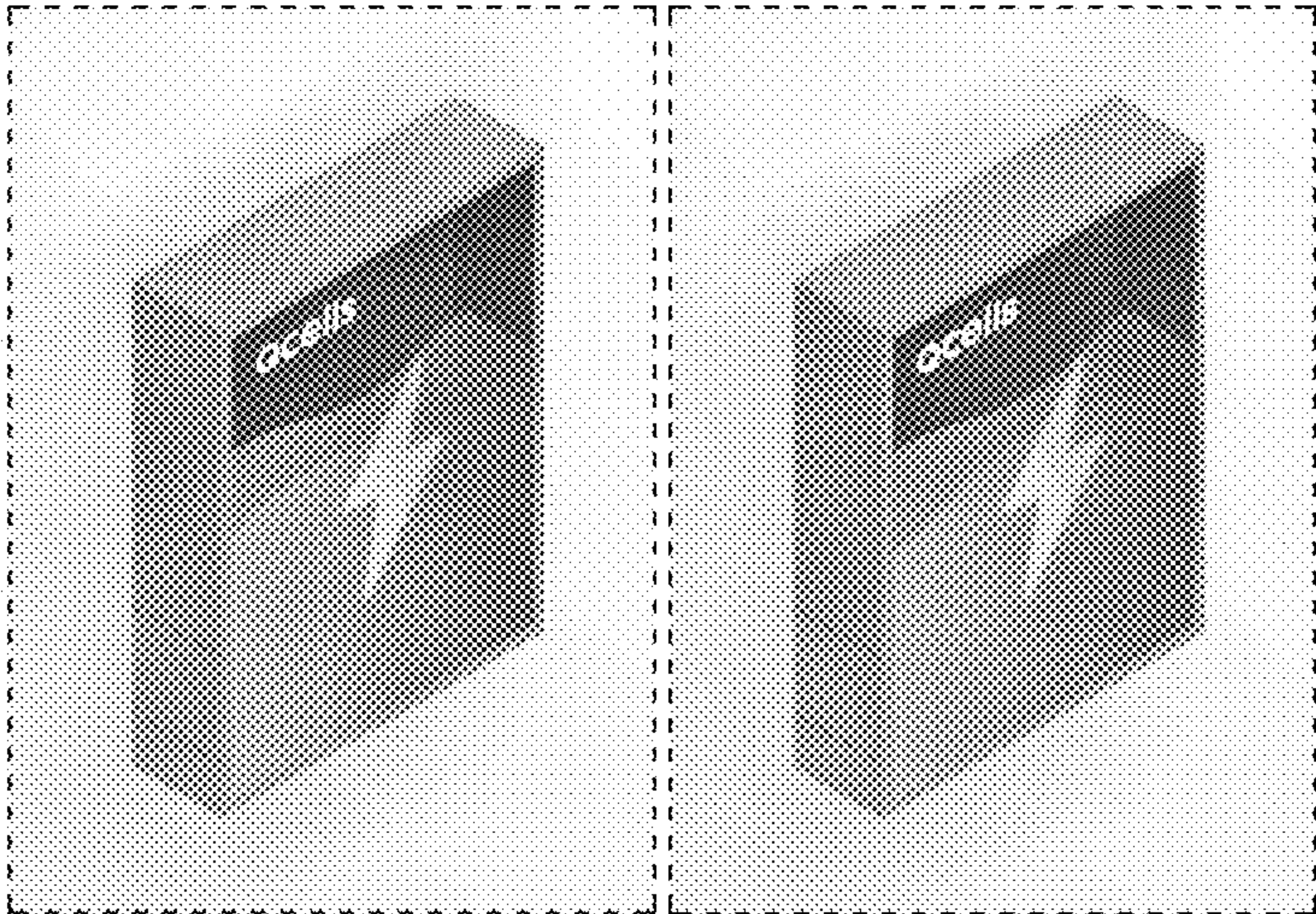
FIG. 6 is a sixth image thereof.

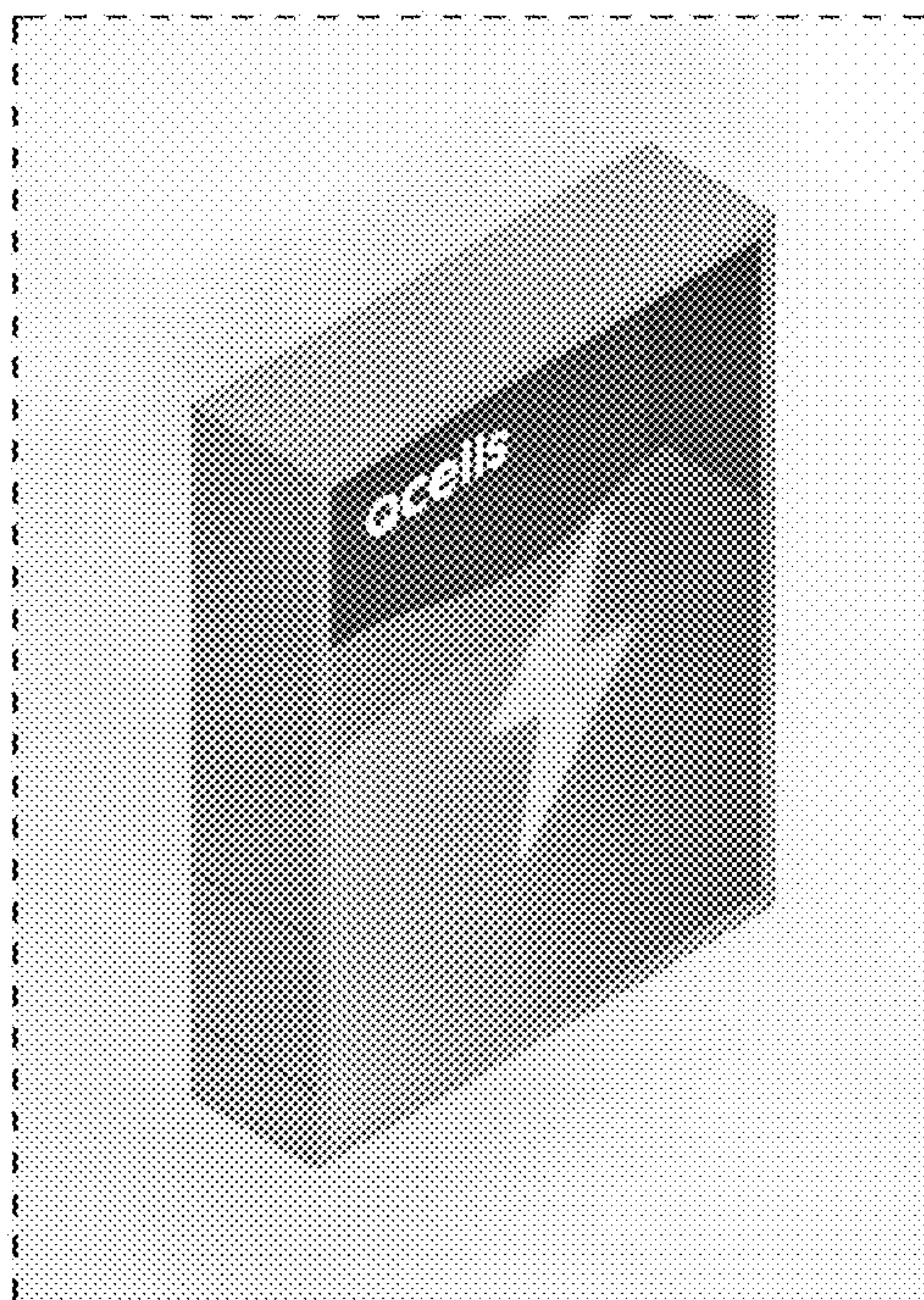

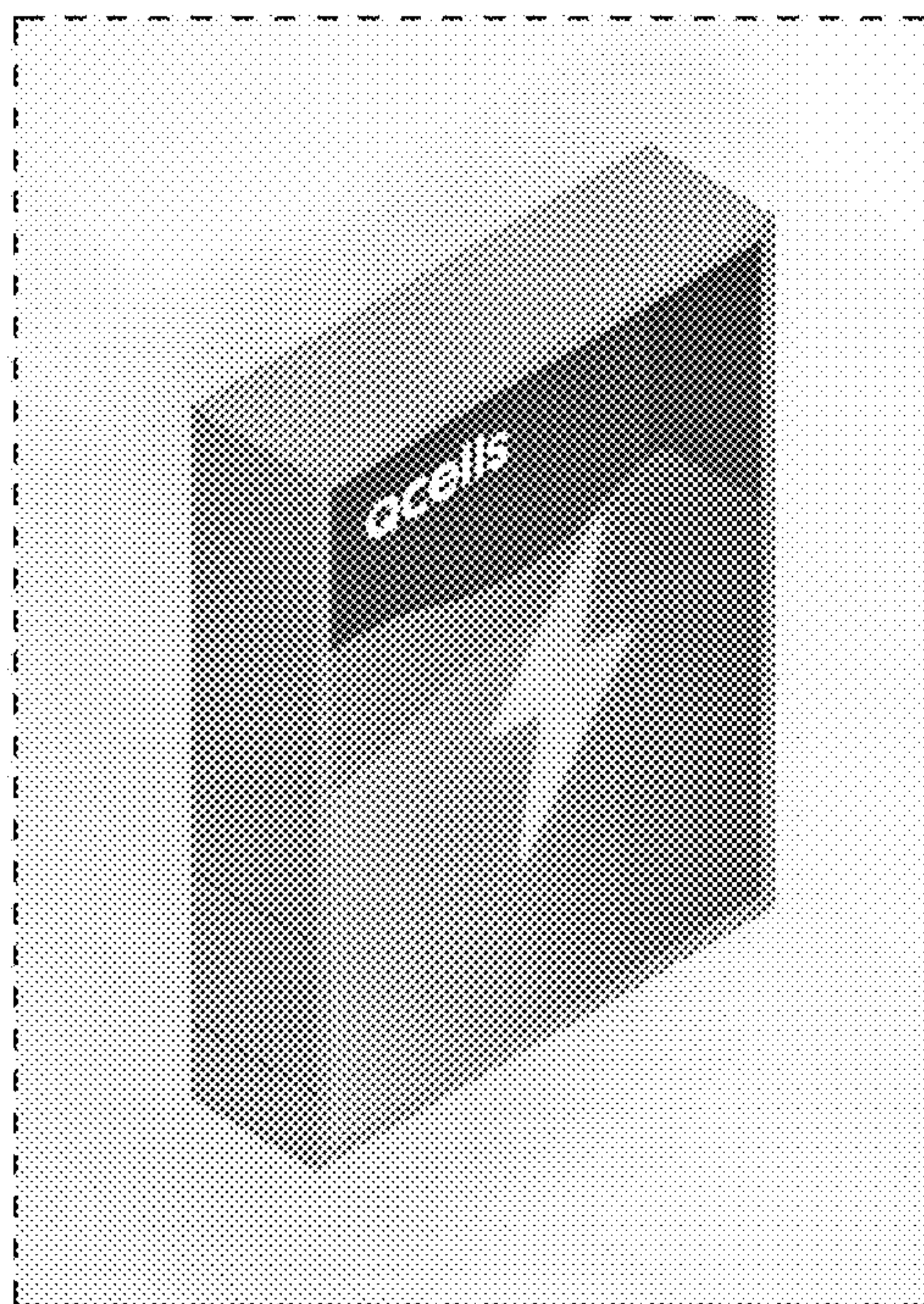

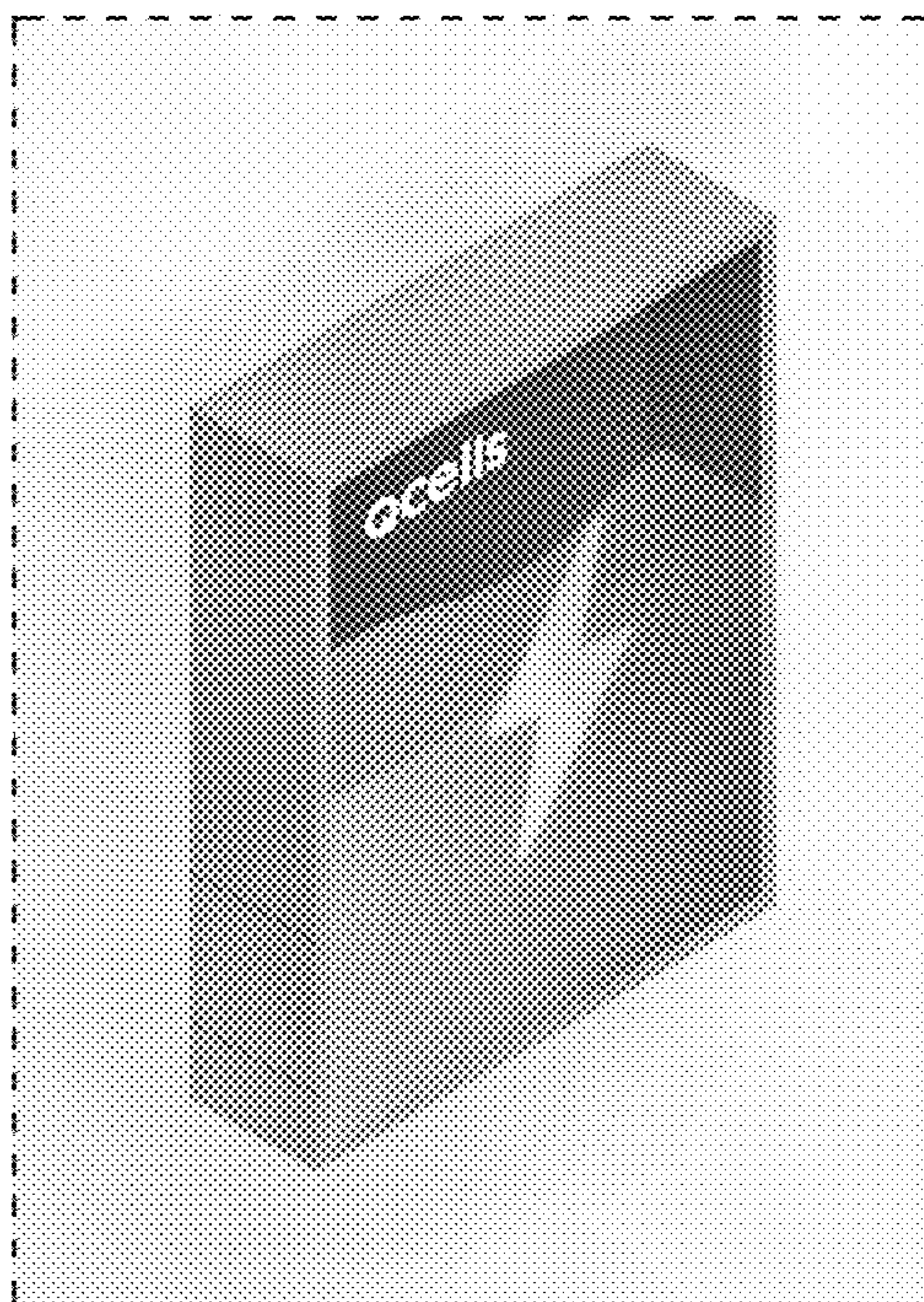

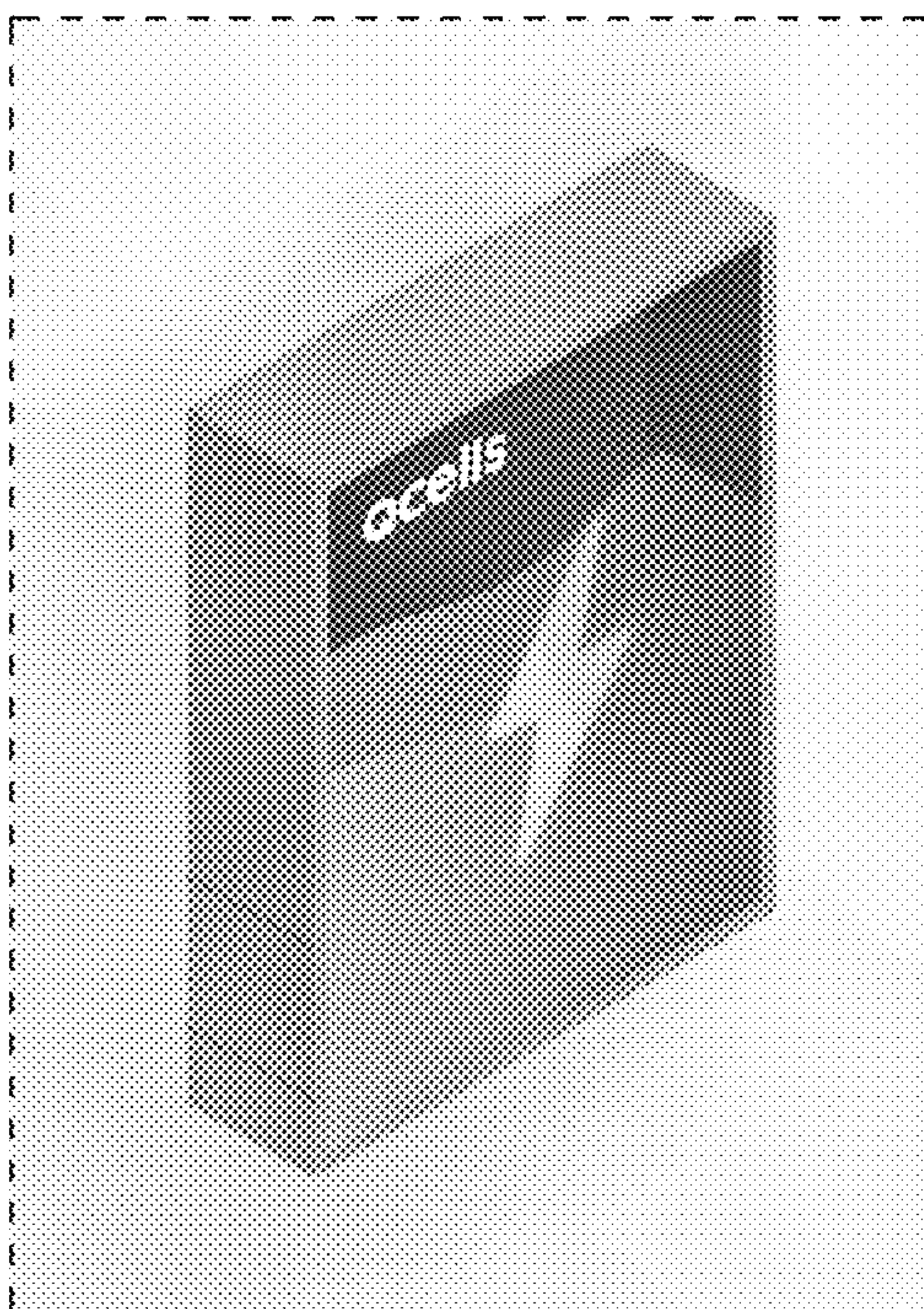

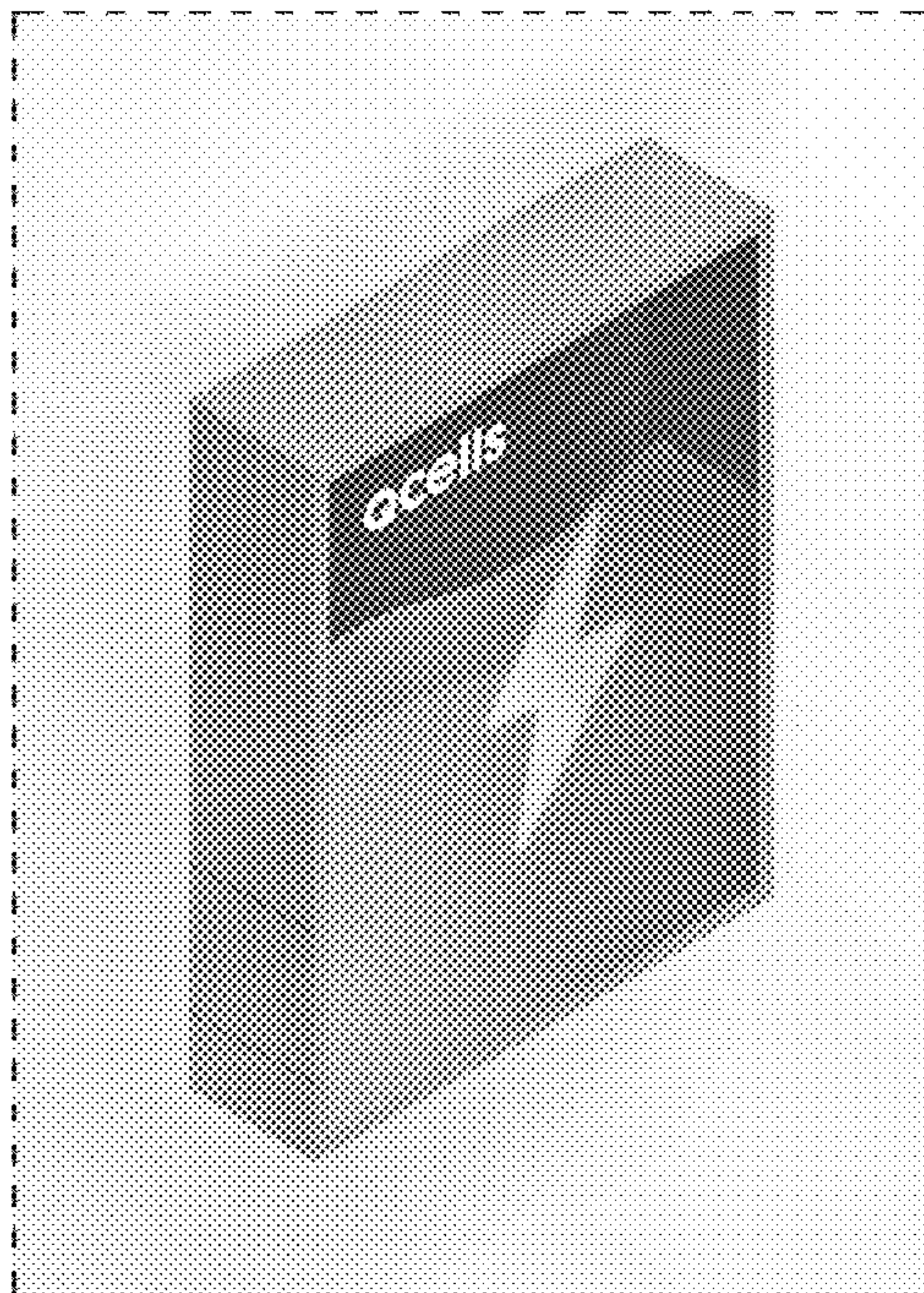

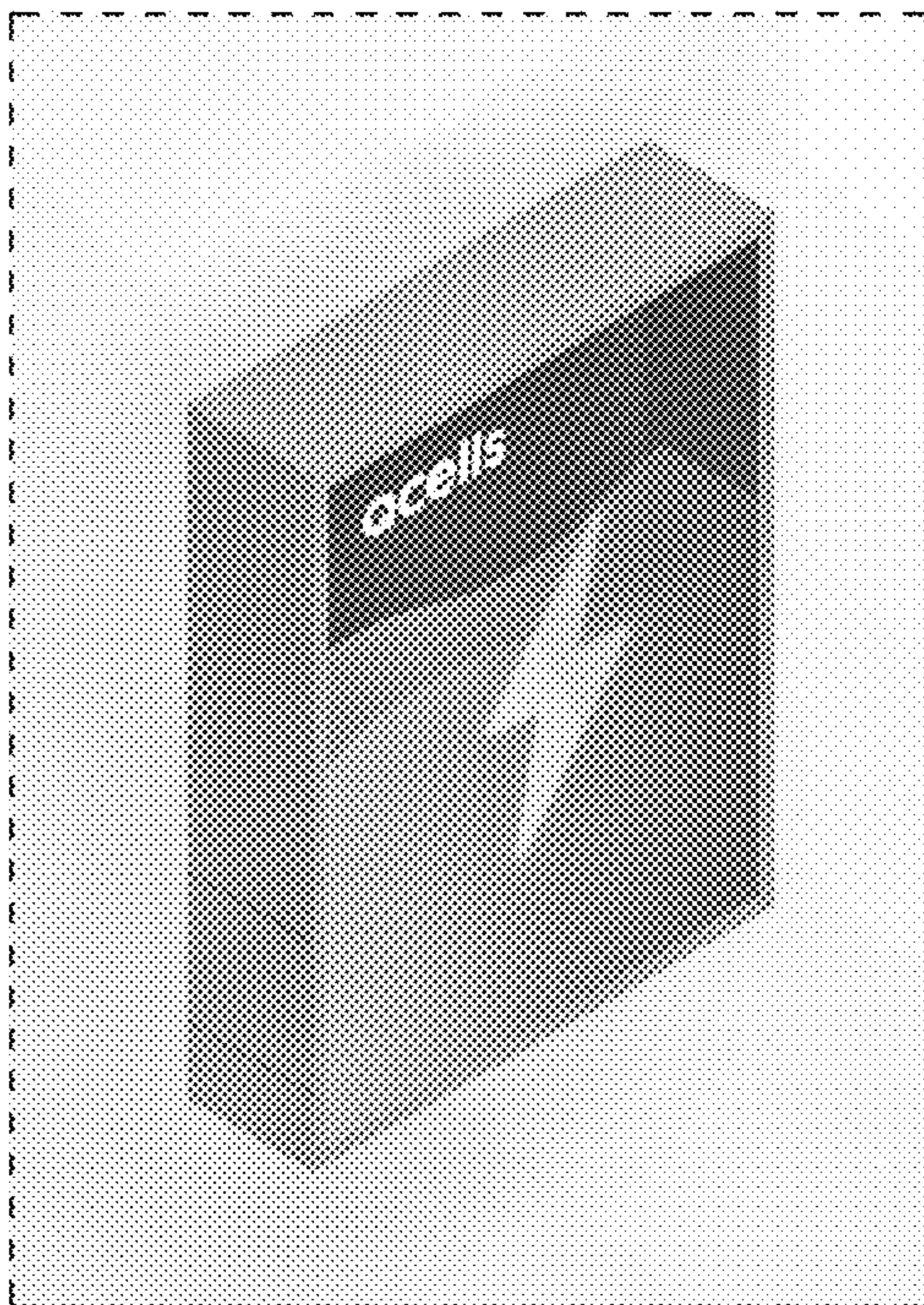
