DESCRIPTION

FIG. 1 is a front perspective view of a case for electronic device showing my new design;

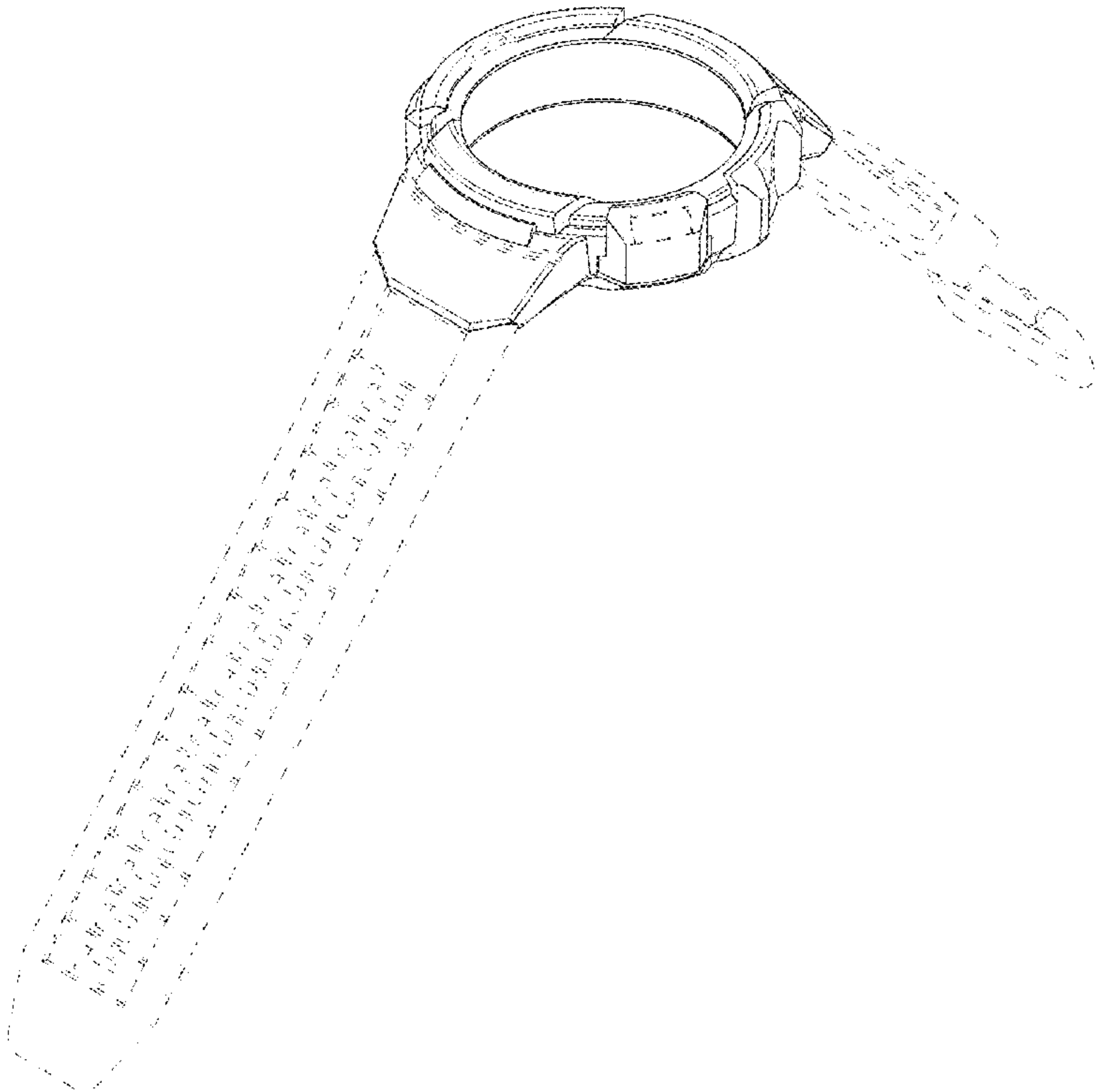

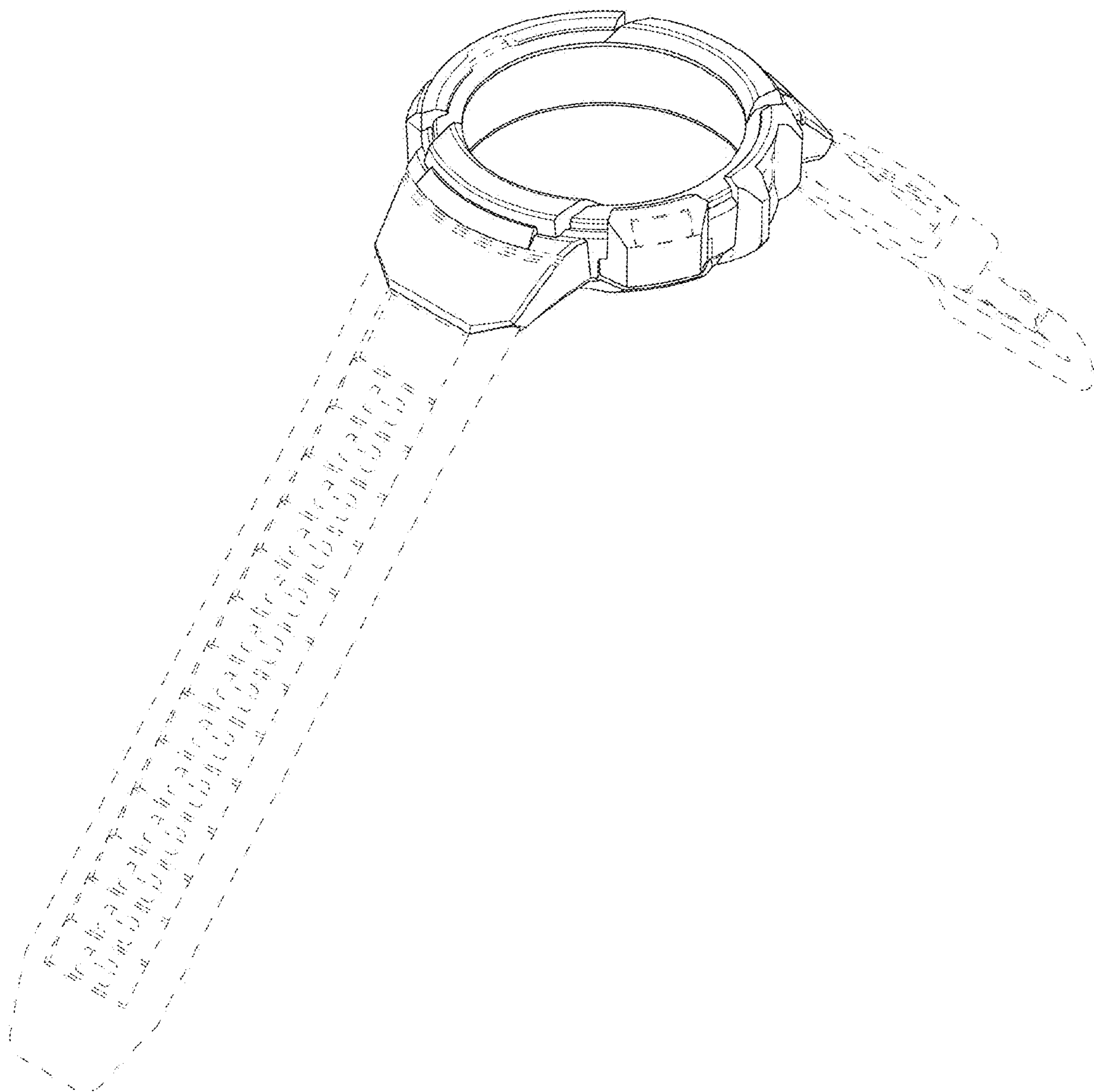

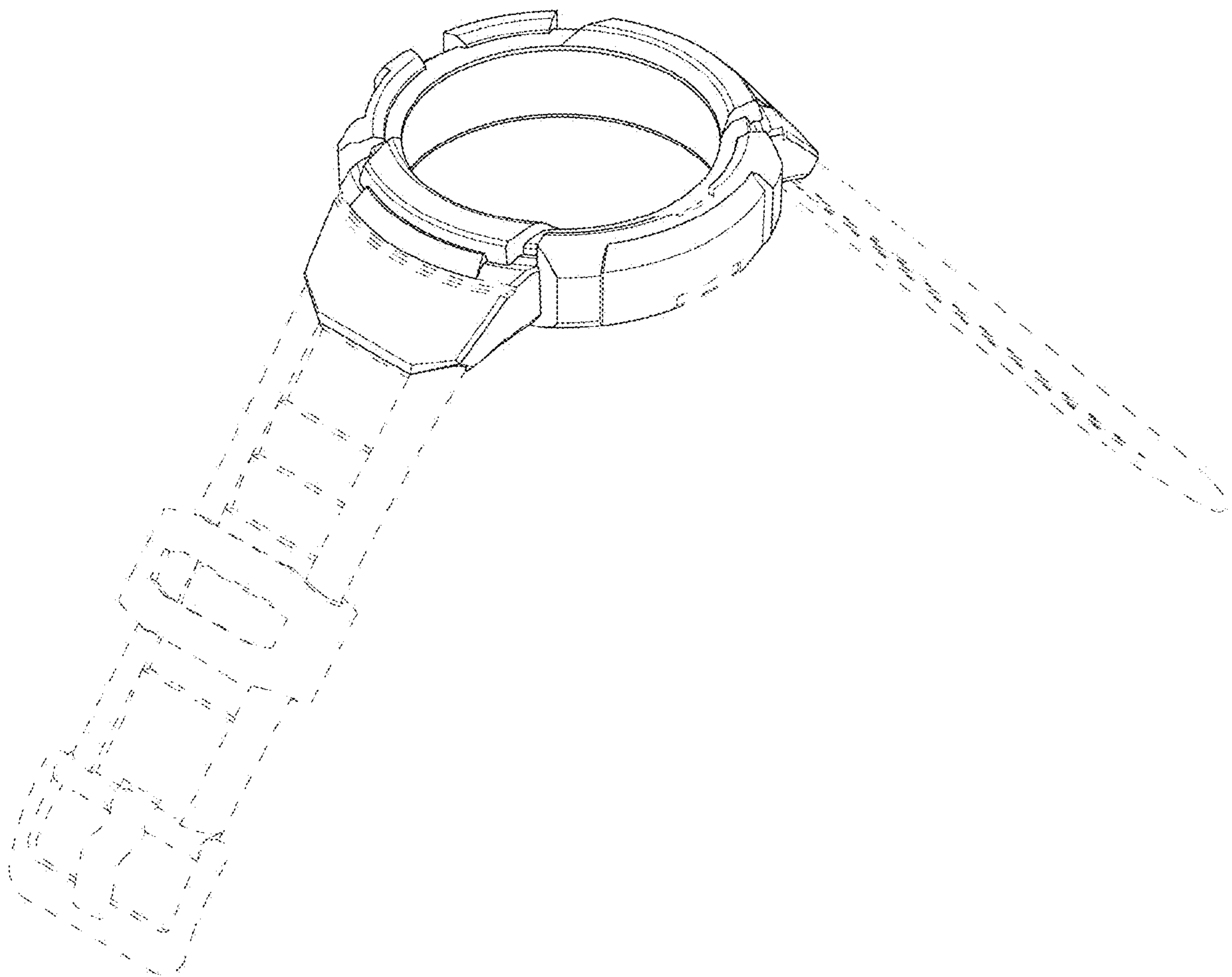

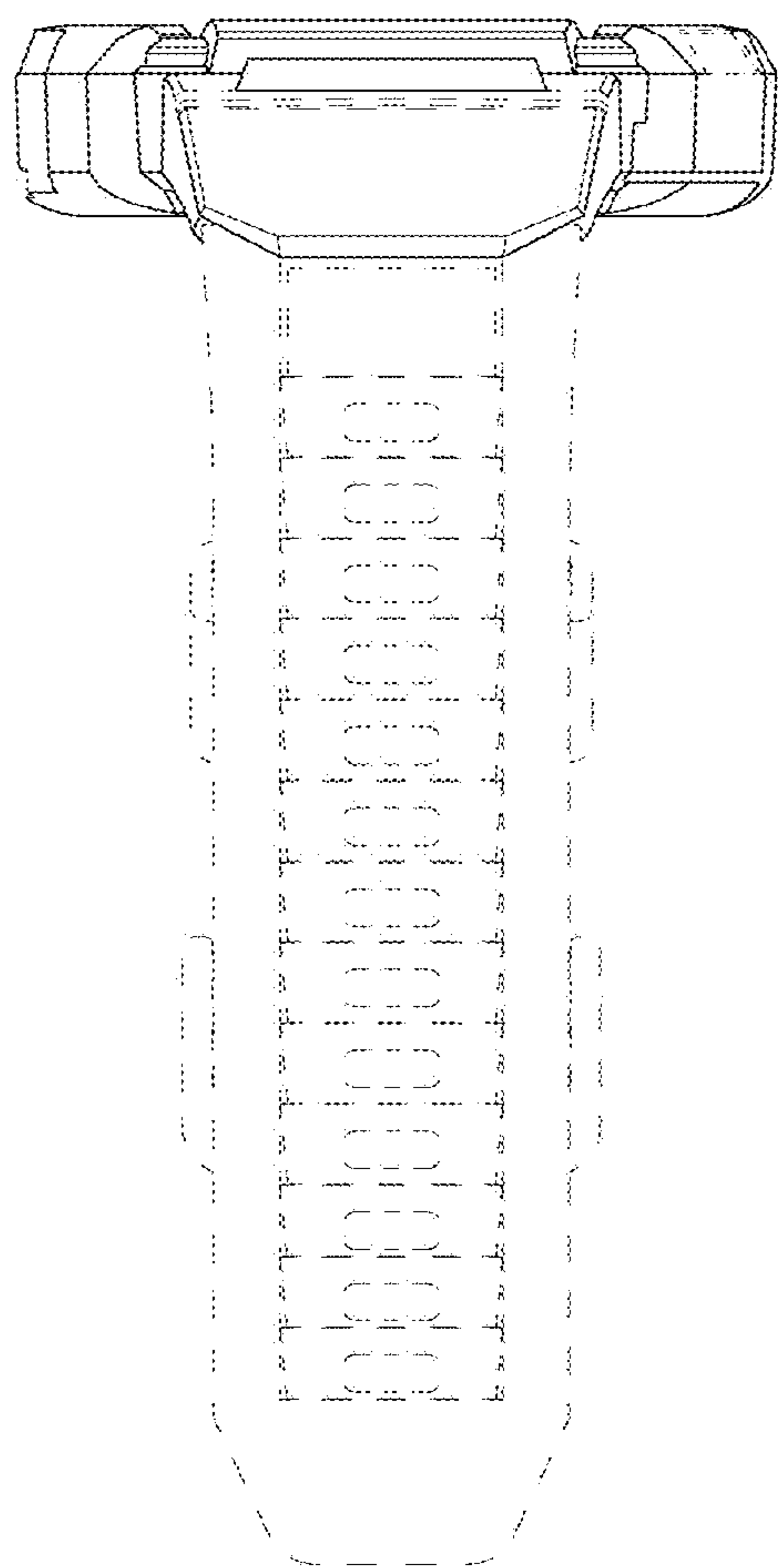

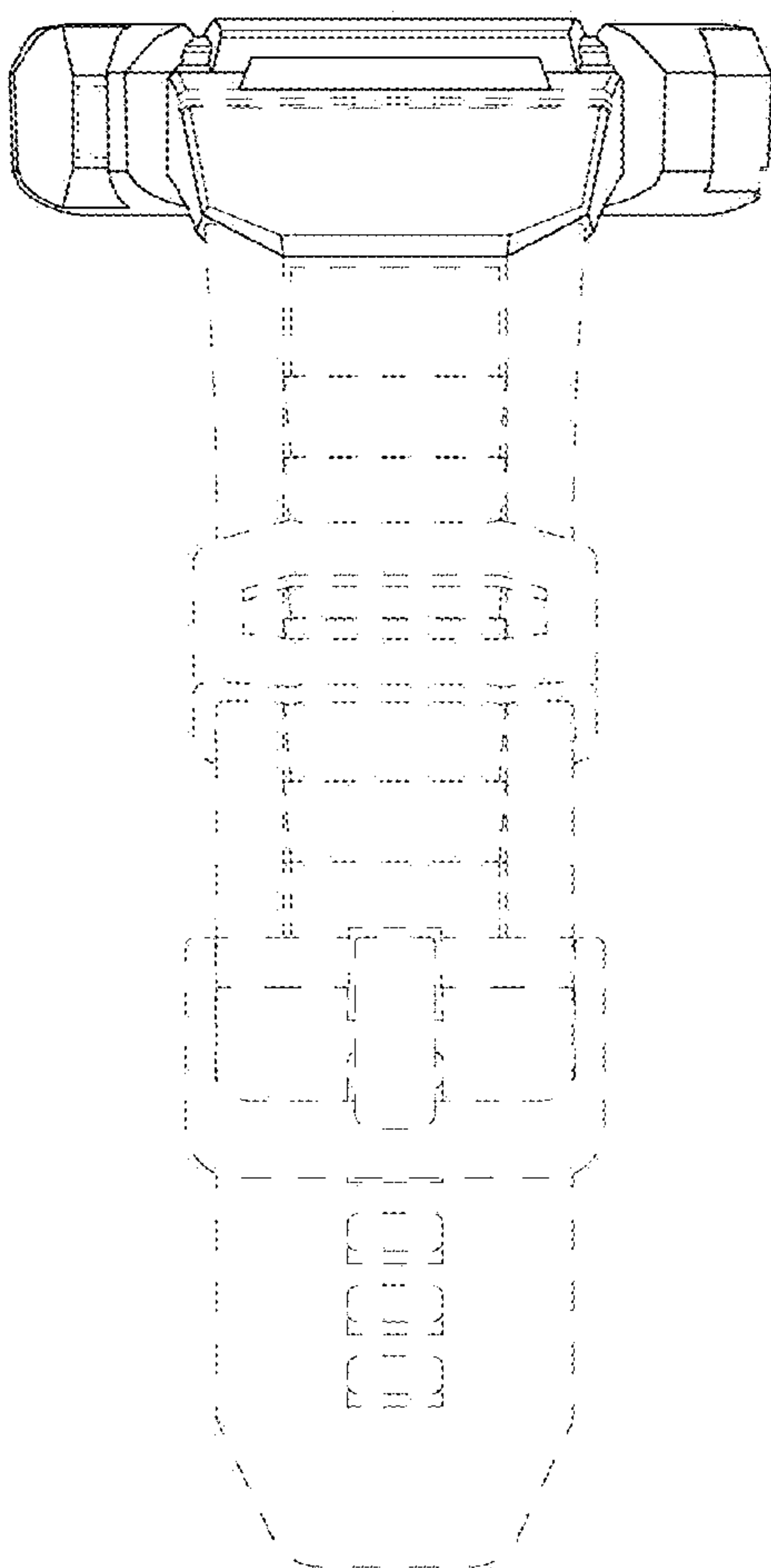

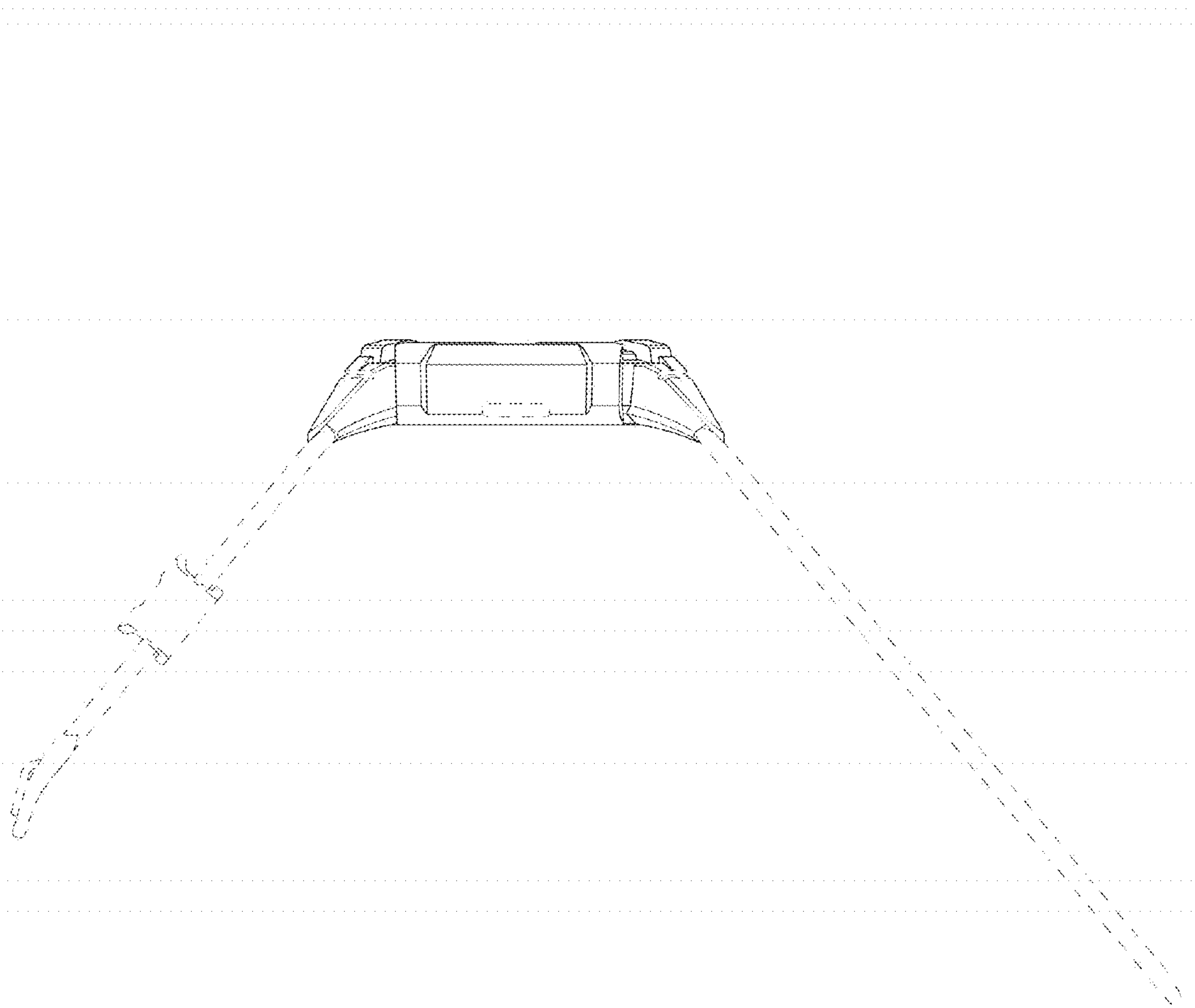

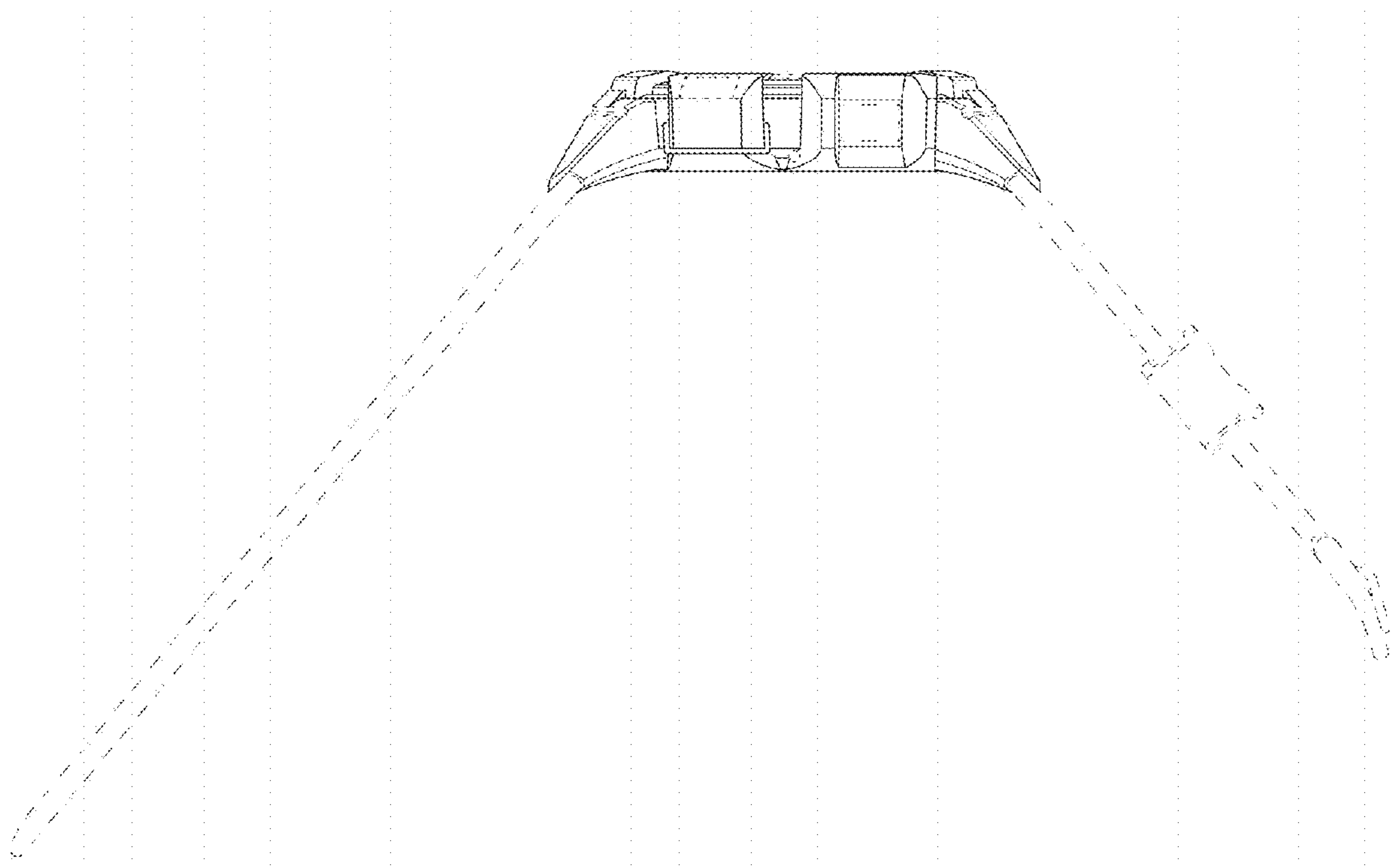

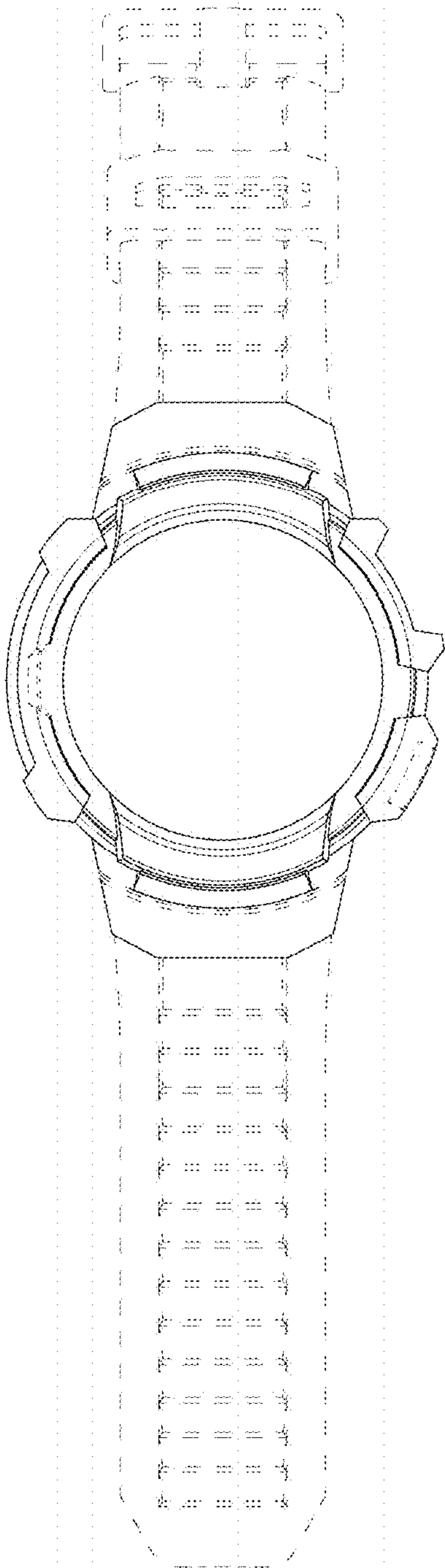
