**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a multipurpose forceps, in accordance with the disclosed principles;

FIG. 2 is a front elevation view of the multipurpose forceps illustrated in FIG. 1;

FIG. 3 is a rear elevation view of the multipurpose forceps illustrated in FIG. 1;

FIG. 4 is a right side view of the multipurpose forceps illustrated in FIG. 1;

FIG. 5 is a left side view of the multipurpose forceps illustrated in FIG. 1;

FIG. 6 is a top view of the multipurpose forceps illustrated in FIG. 1;

FIG. 7 is a bottom view of the multipurpose forceps illustrated in FIG. 1;

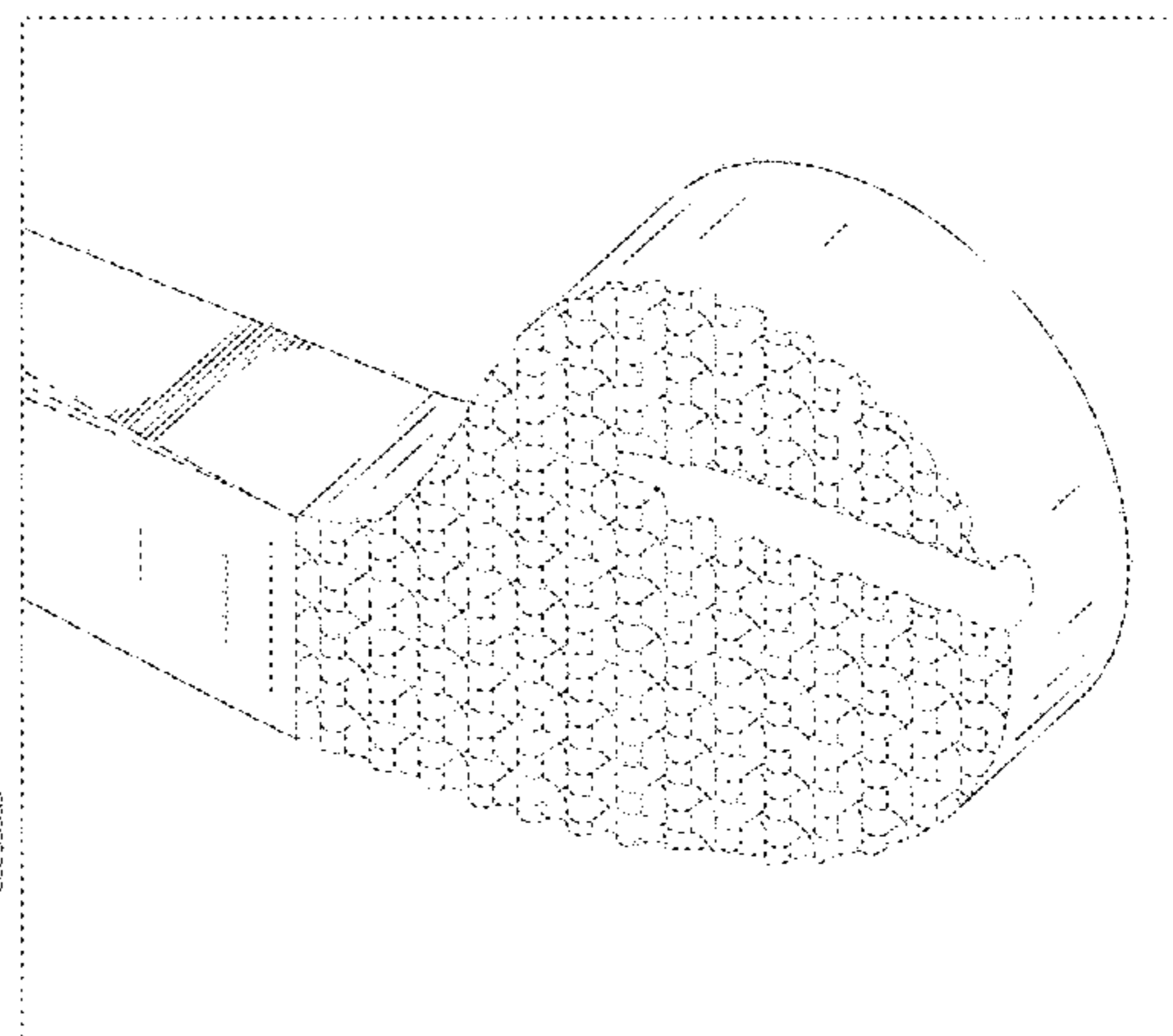
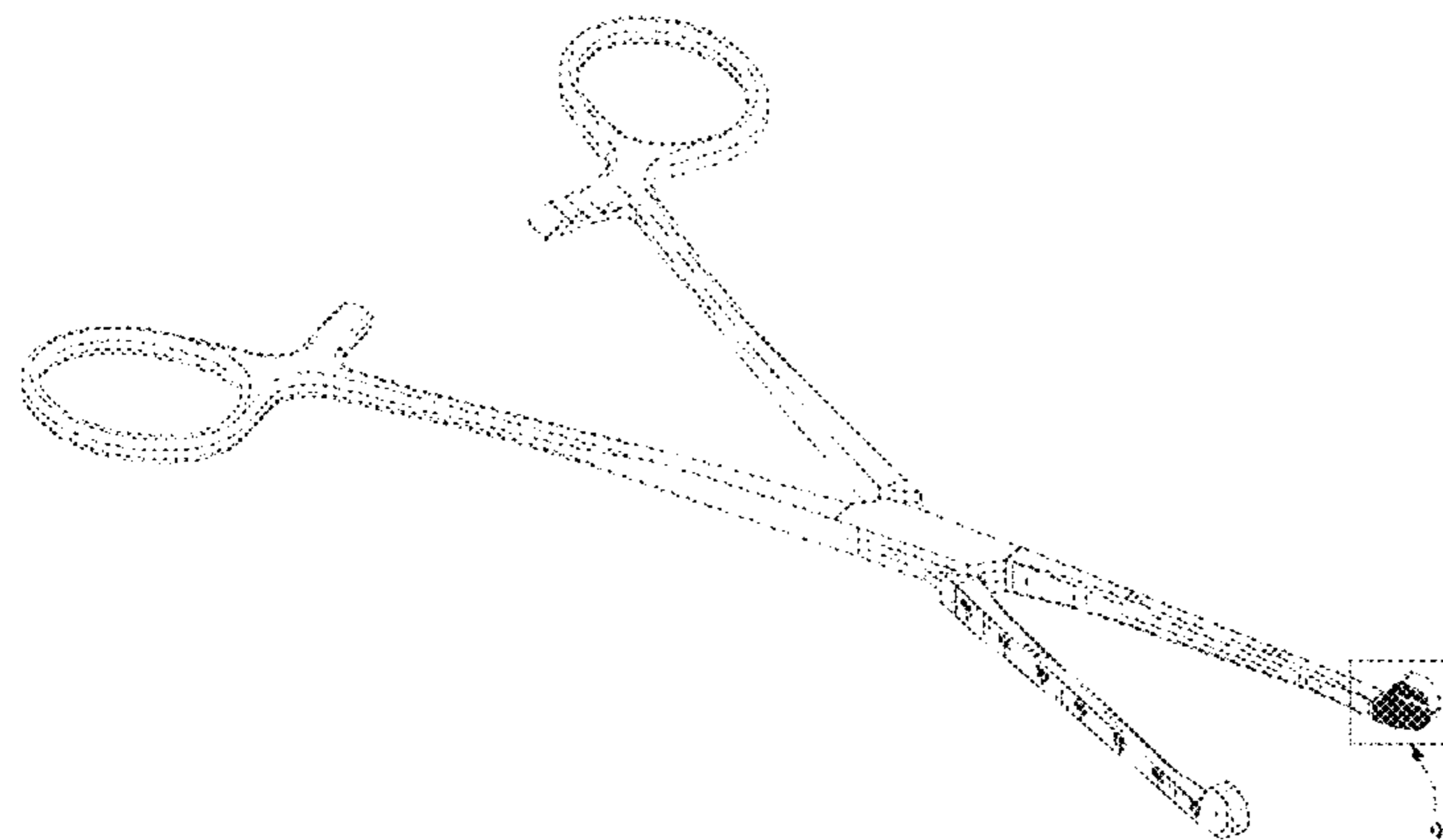
FIG. 8 is a rear perspective view of the multipurpose forceps illustrated in FIG. 1;

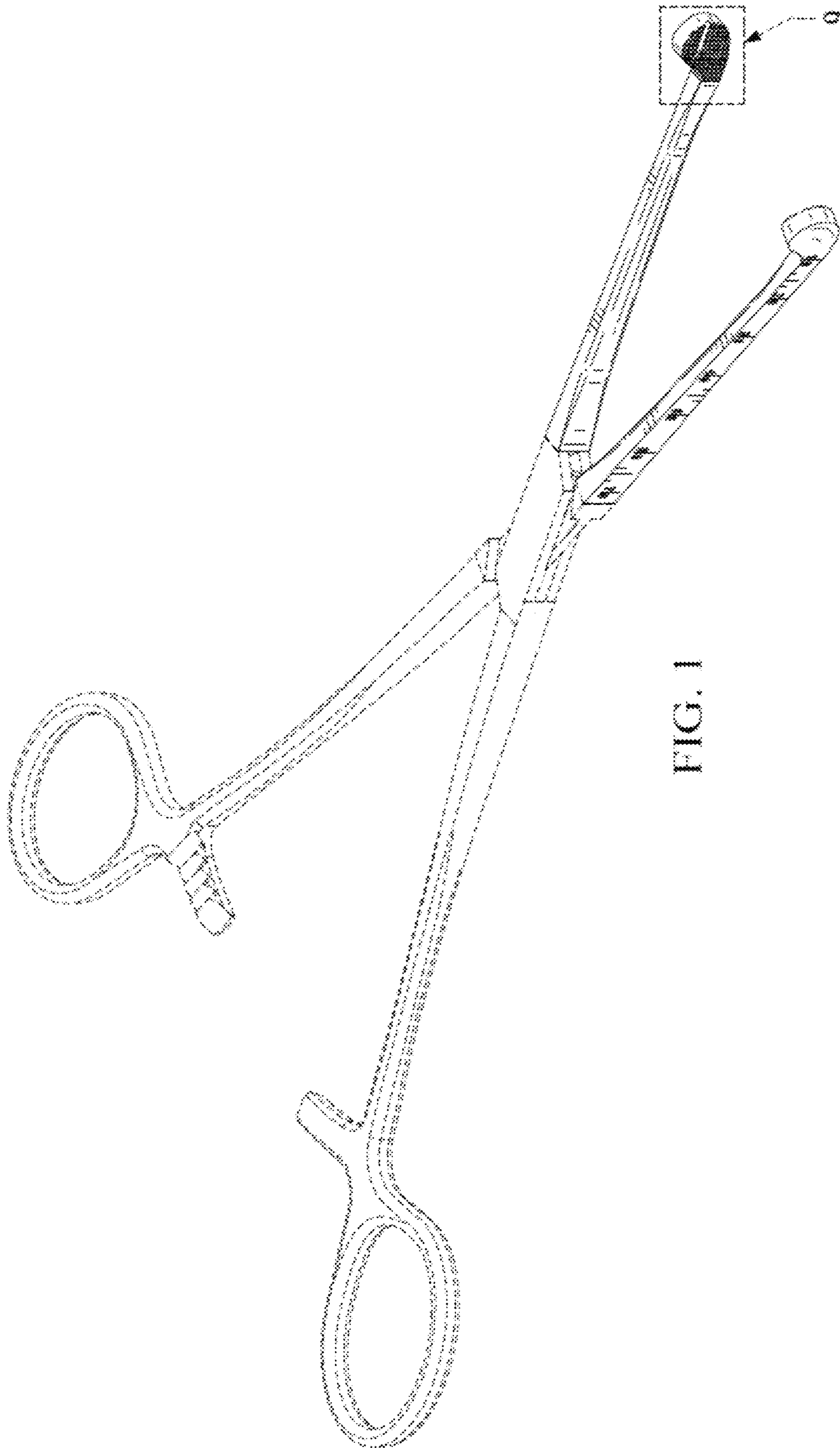

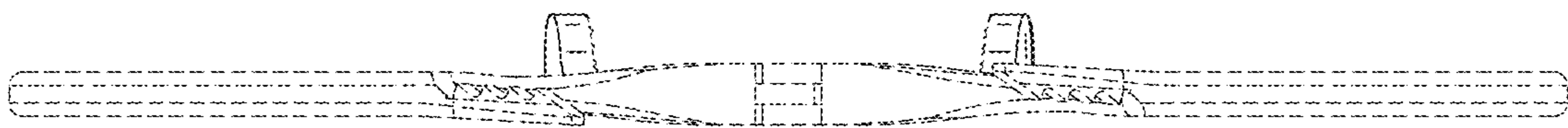

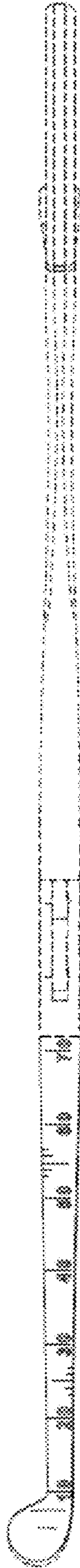

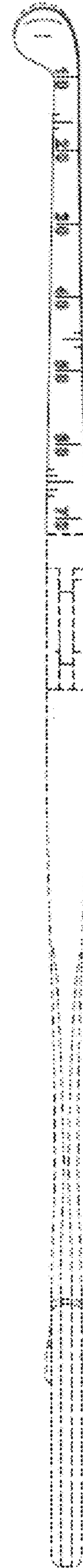
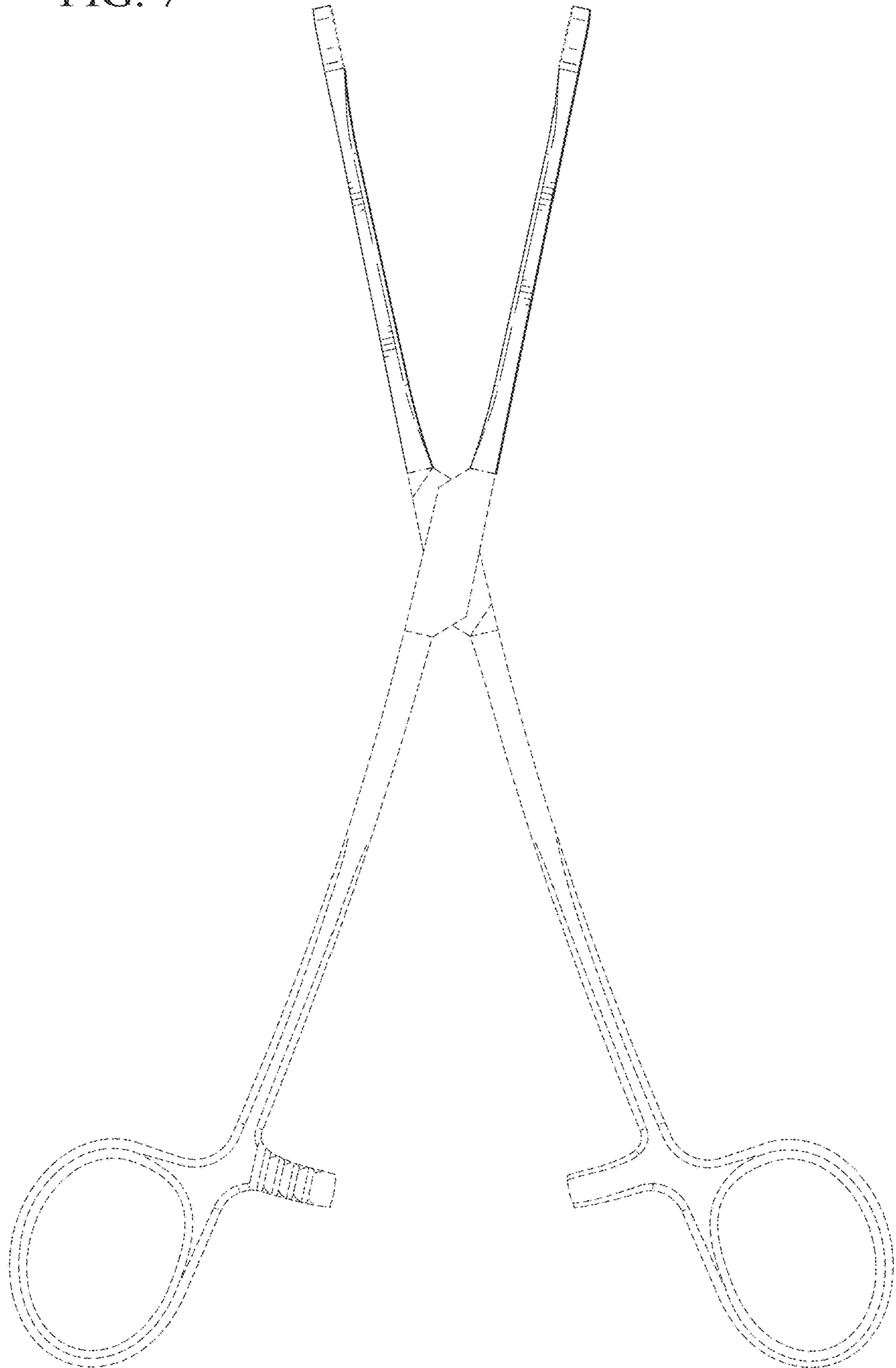

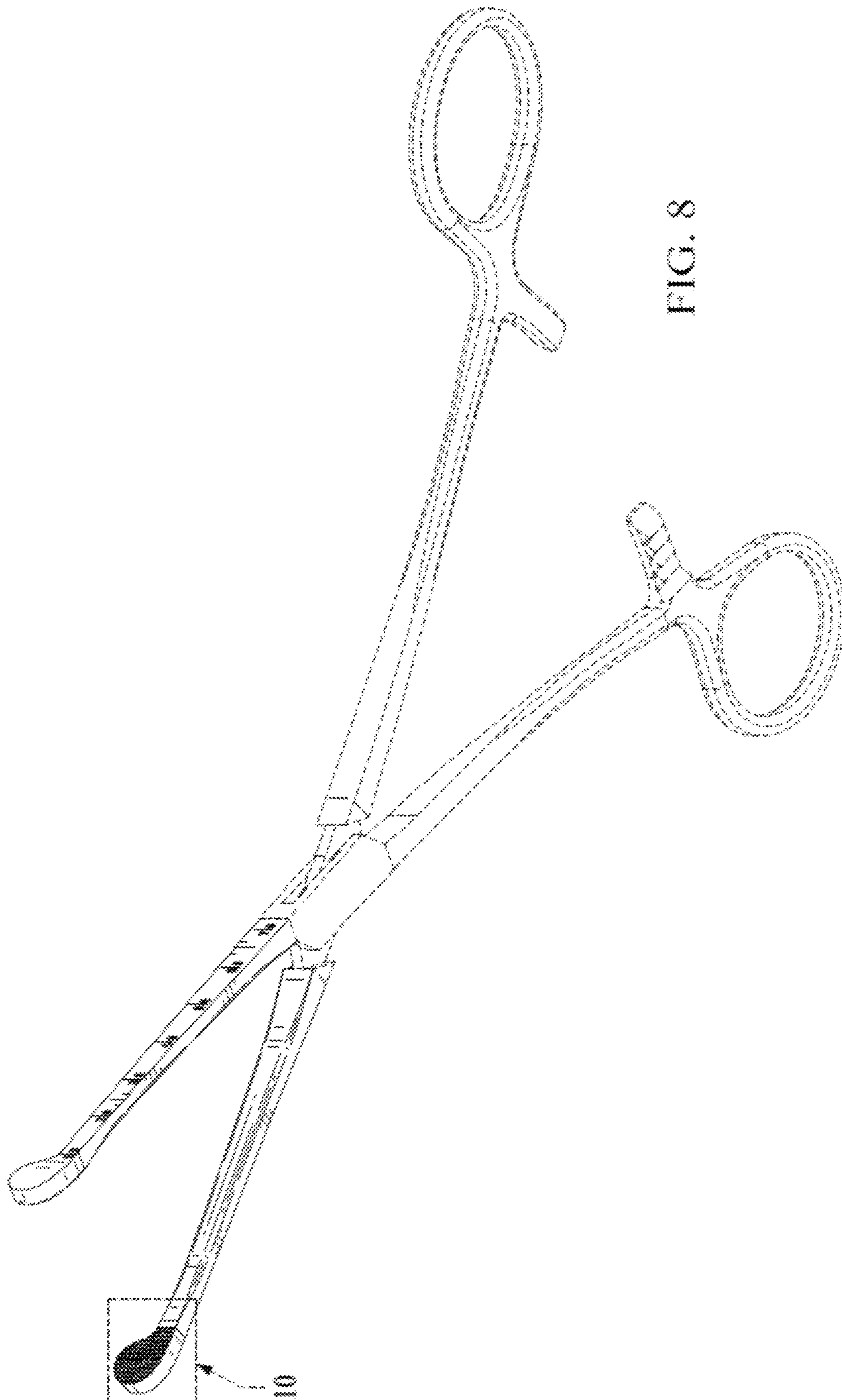

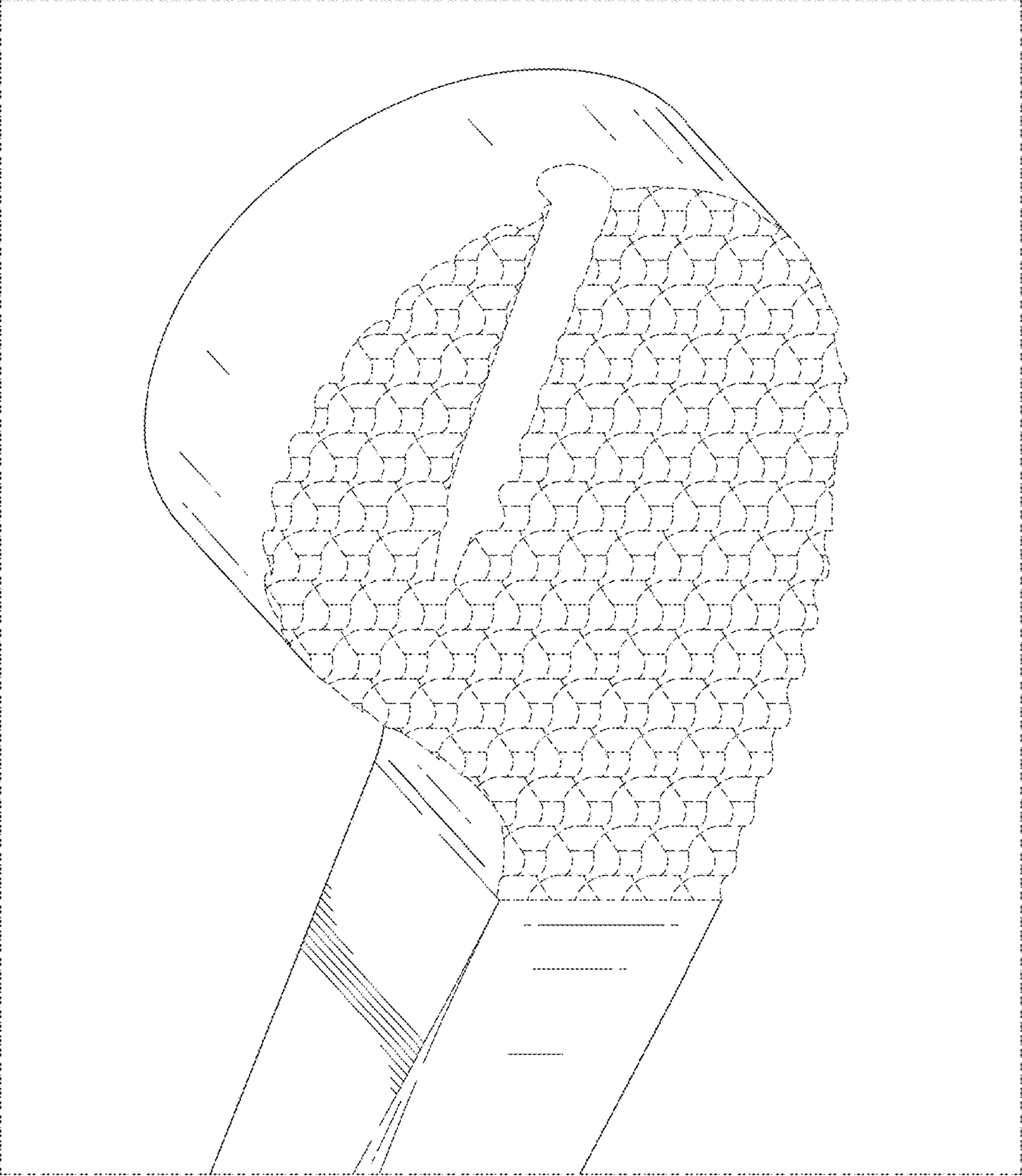

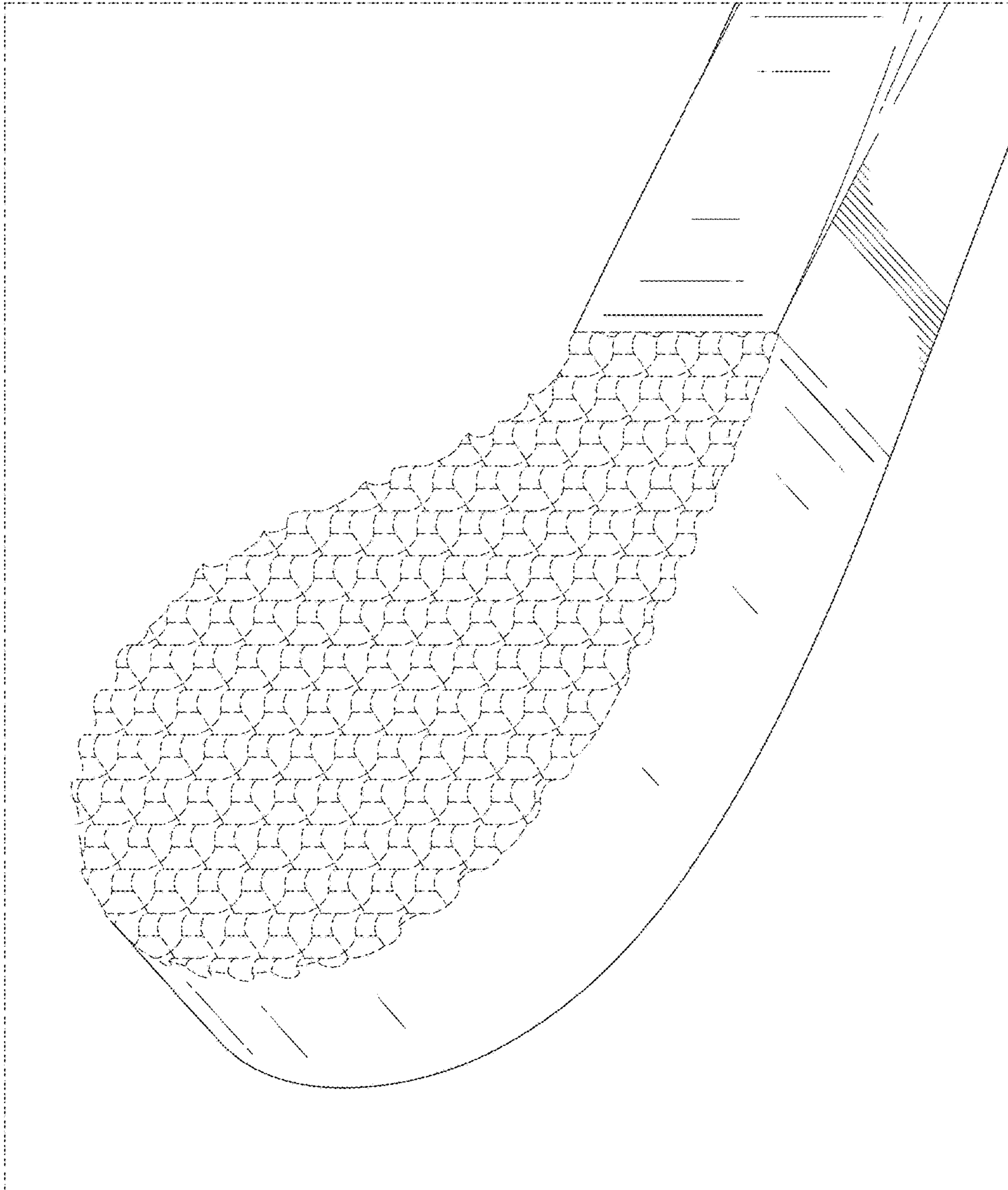
