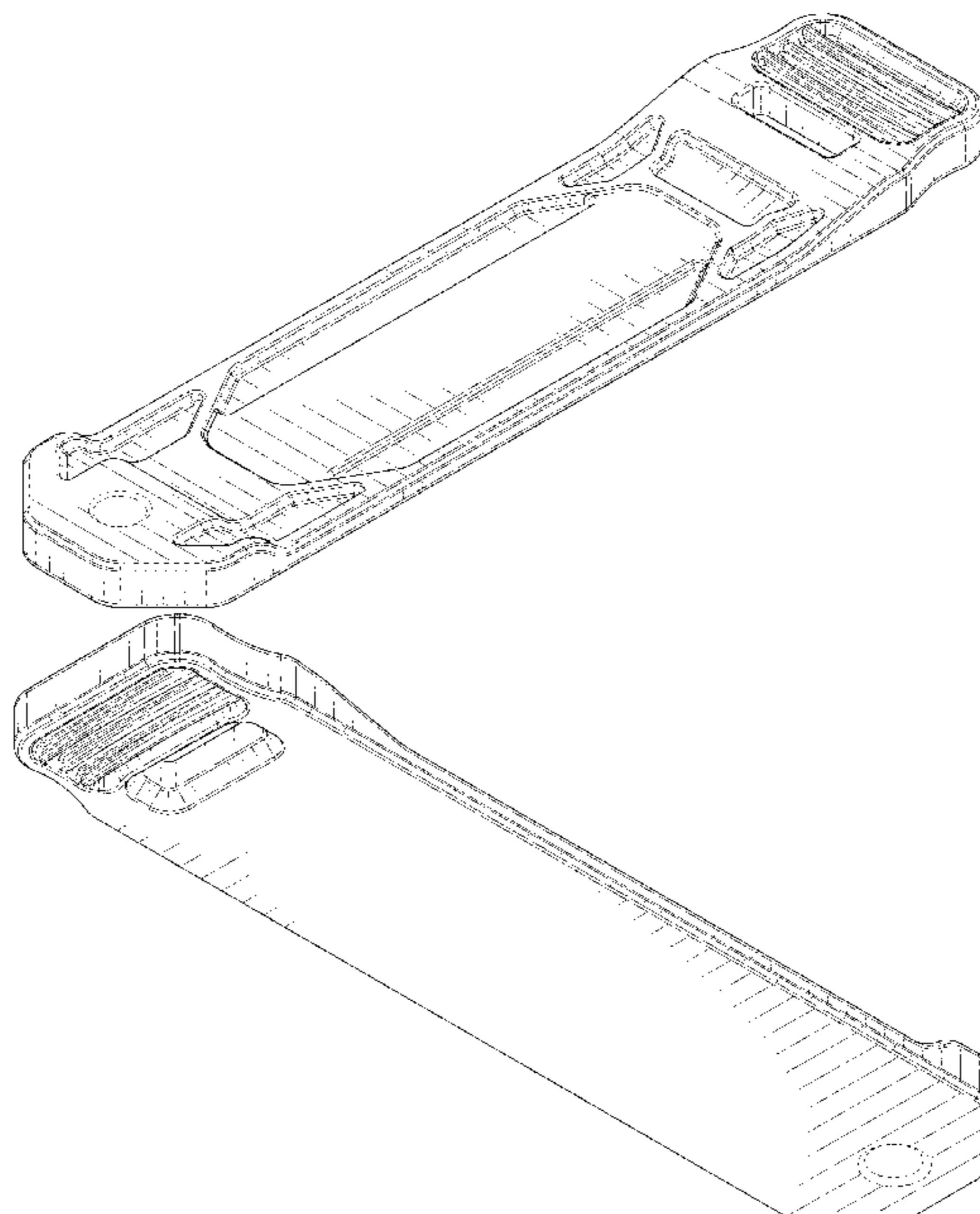
(57) **CLAIM**

The ornamental design for a model vehicle battery strap as shown and described.

DESCRIPTION

FIG. 1 is an upper, left, front perspective view of a model vehicle battery strap showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is an upper plan view thereof; FIG. 7 is a lower plan view thereof; FIG. 8 is an upper, right, rear perspective view thereof; and, FIG. 9 is a lower, right, rear perspective view of the model vehicle battery strap. In the drawings, the broken lines illustrate portions of the model vehicle battery strap that form no part of the claimed design.

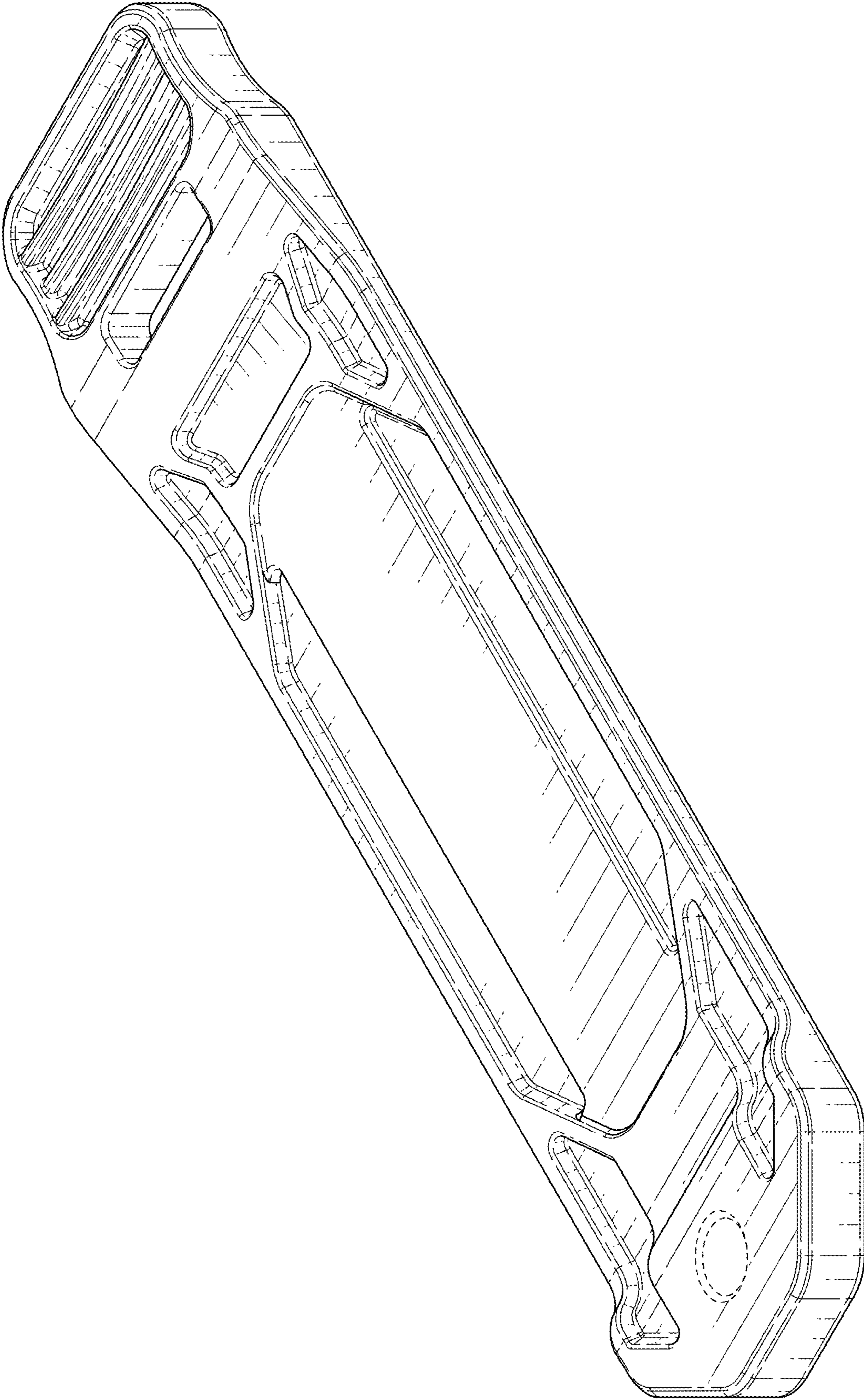

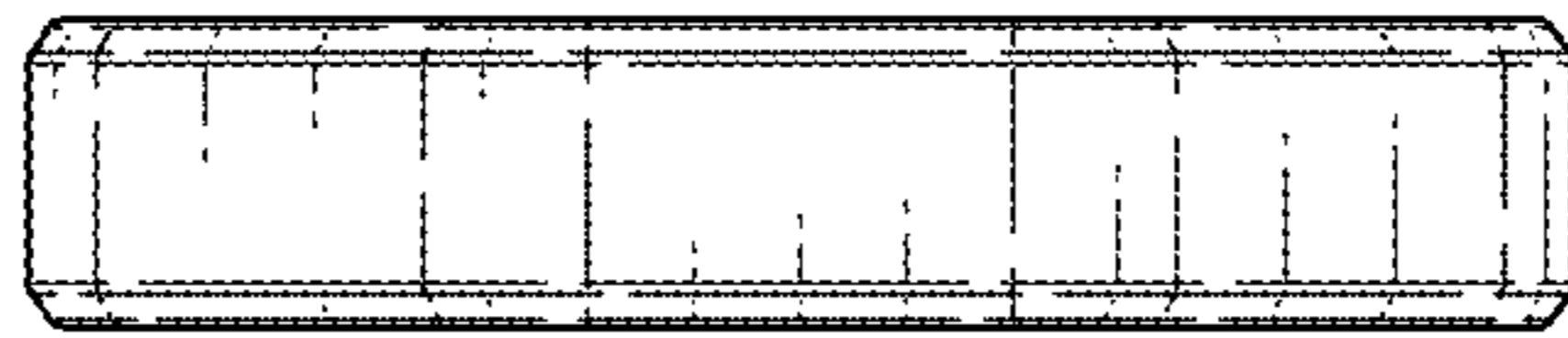

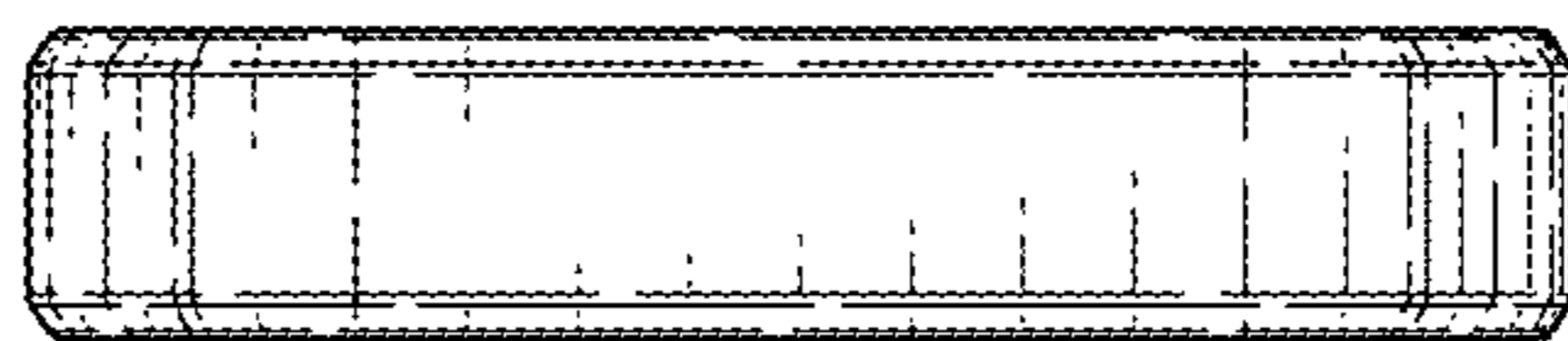

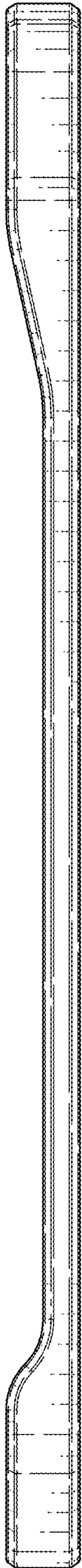

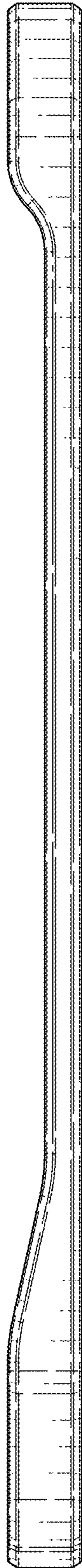

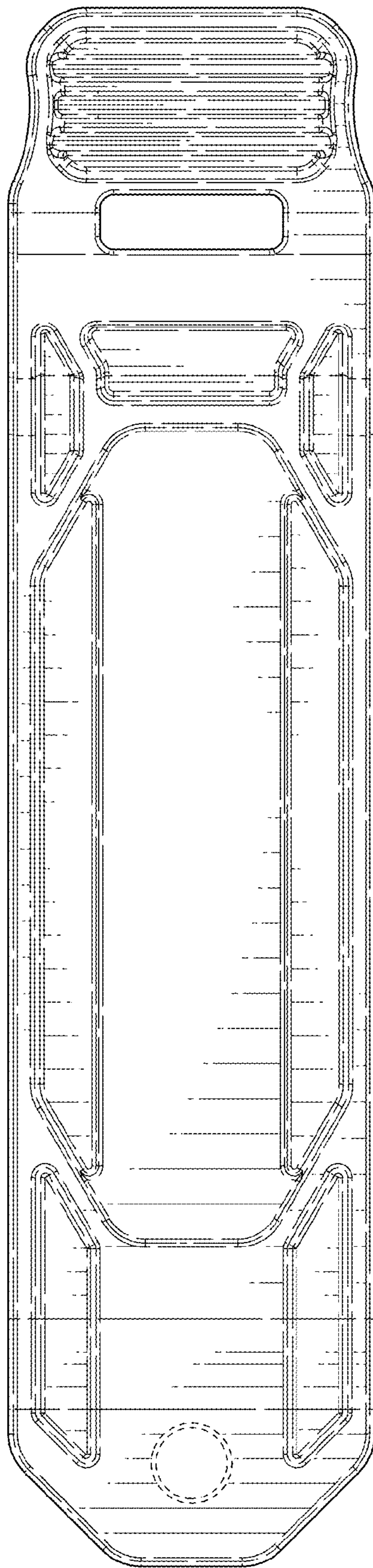

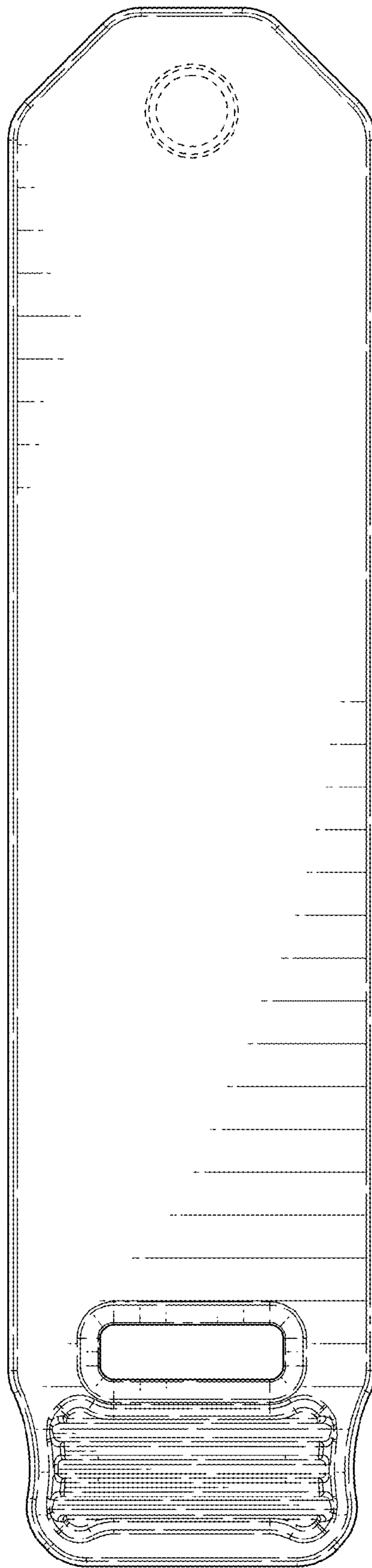

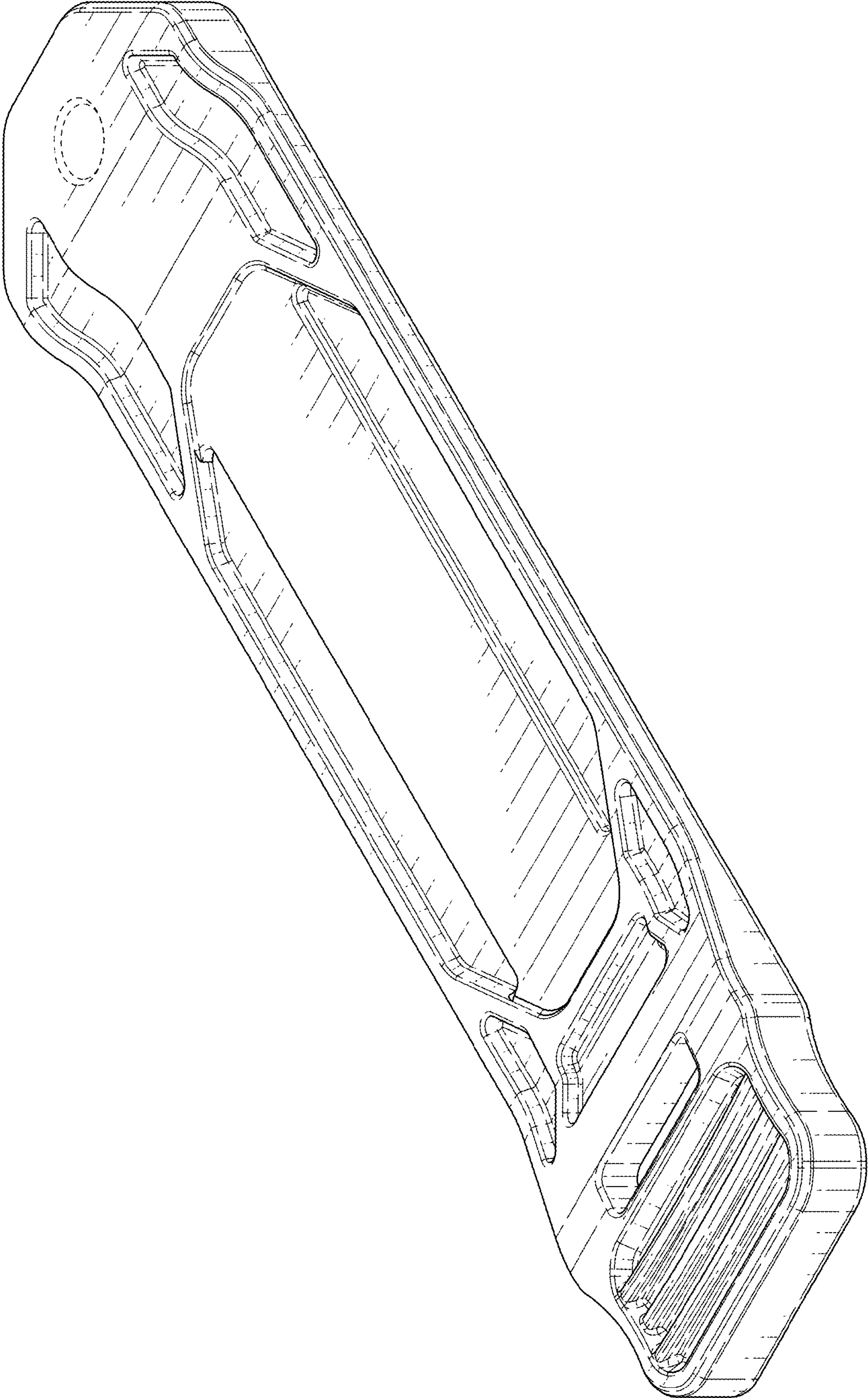

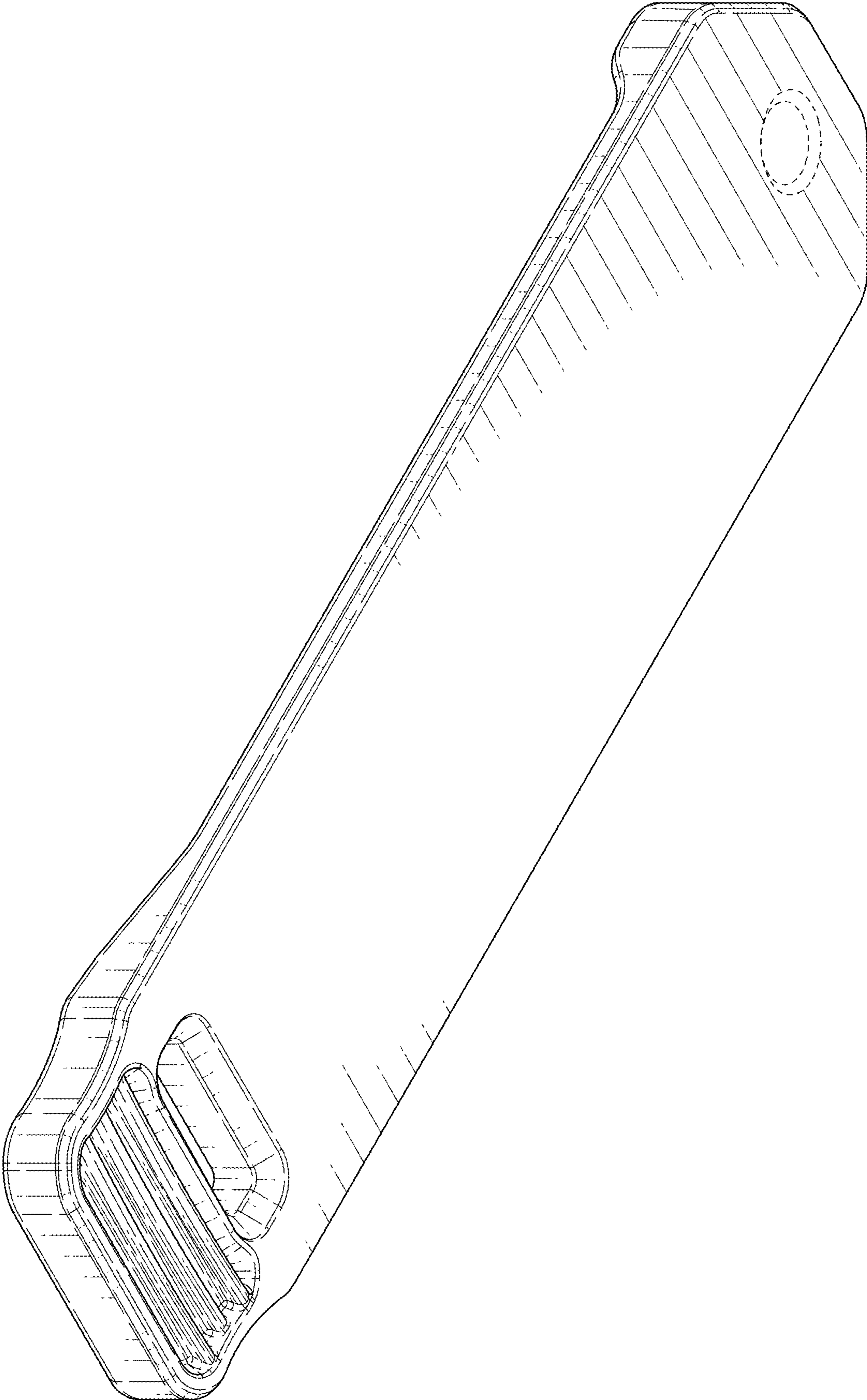
