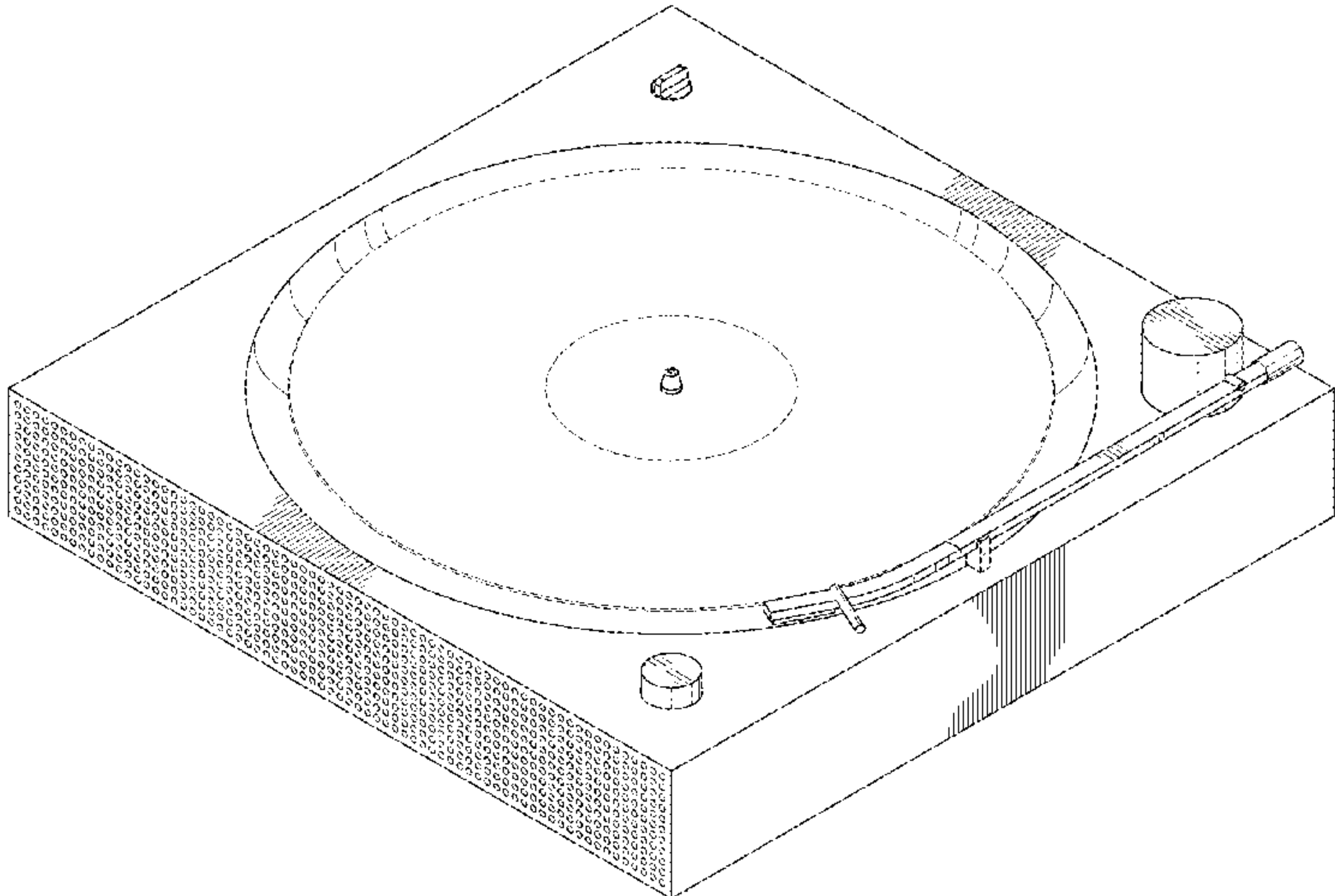
(57) CLAIM

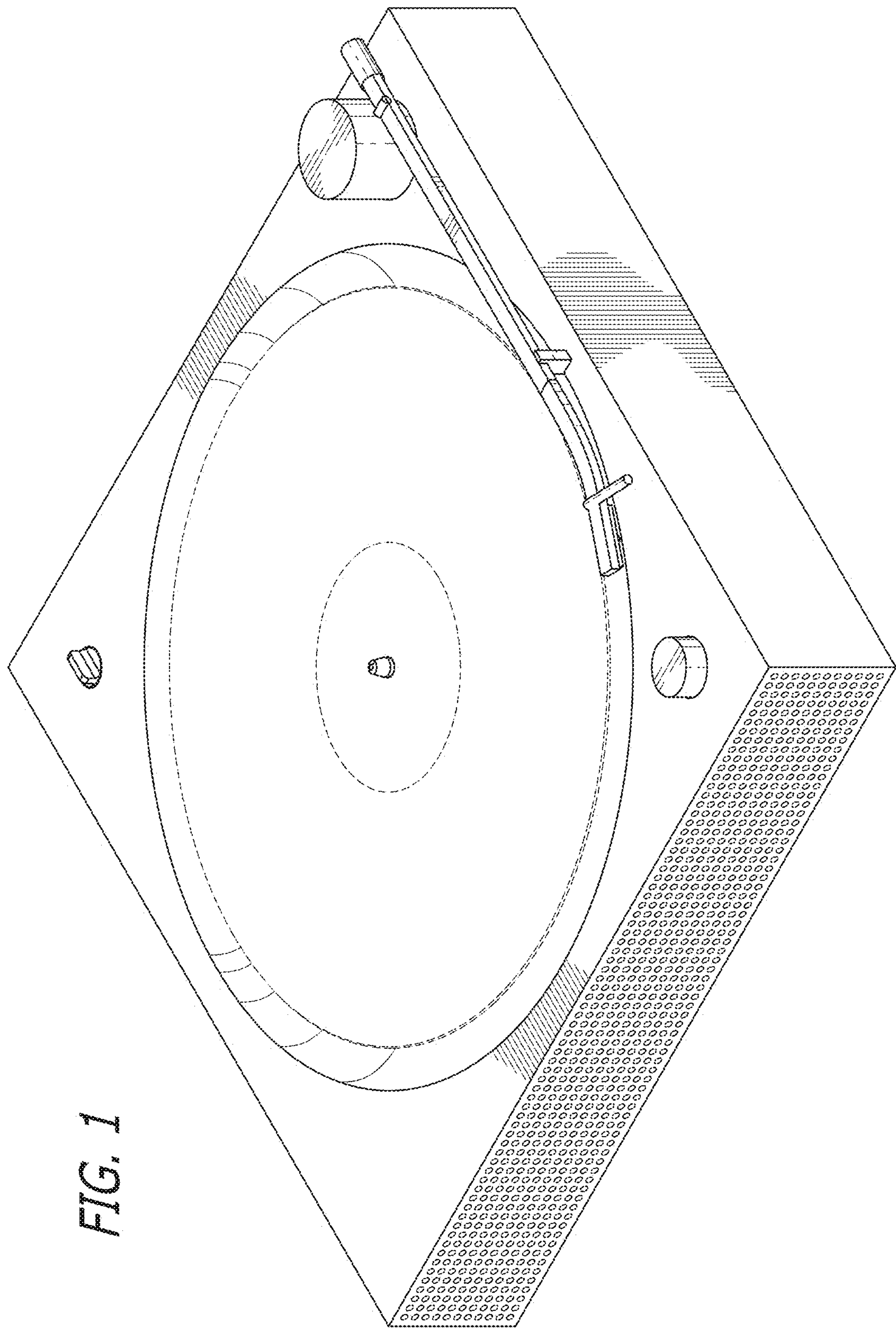

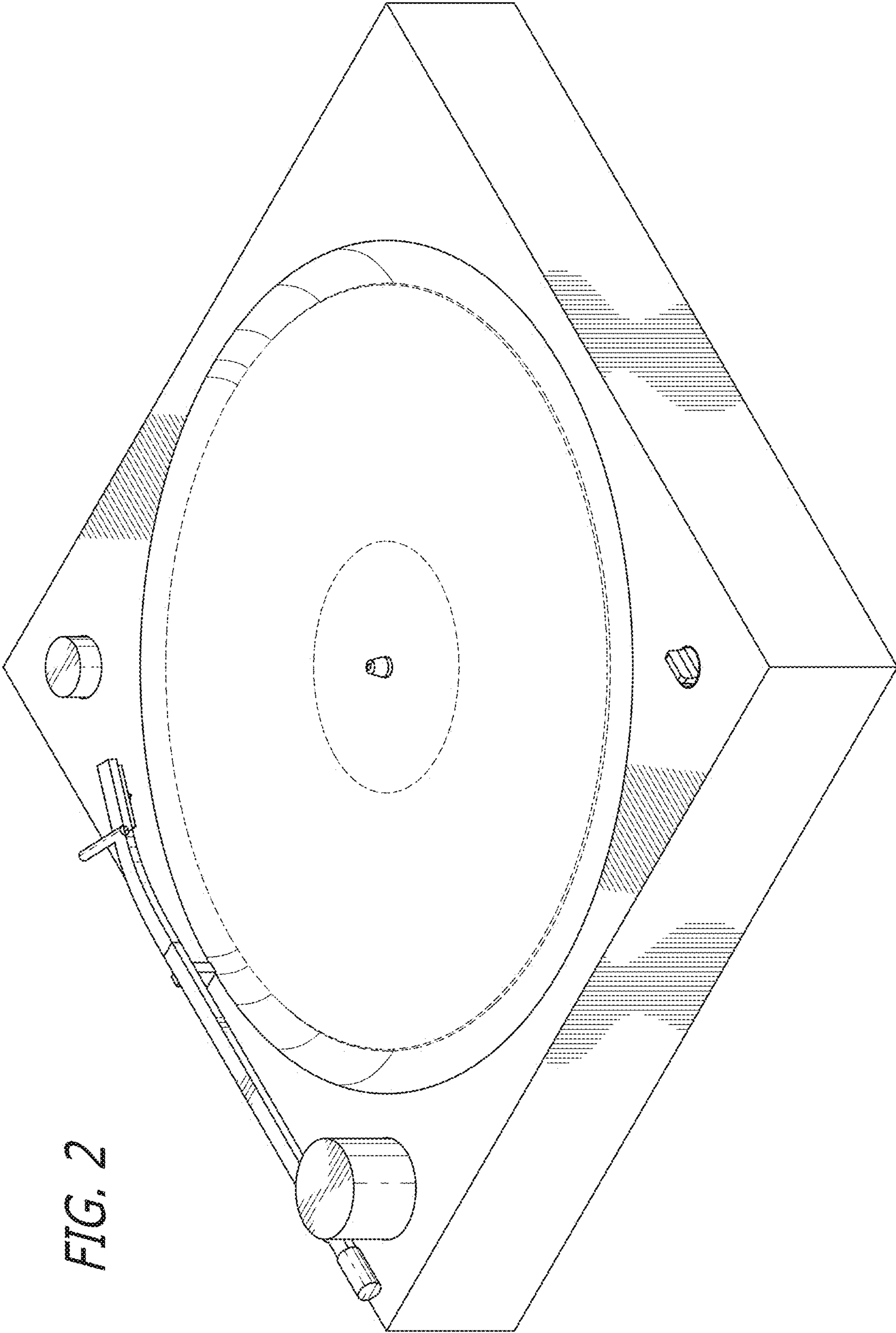

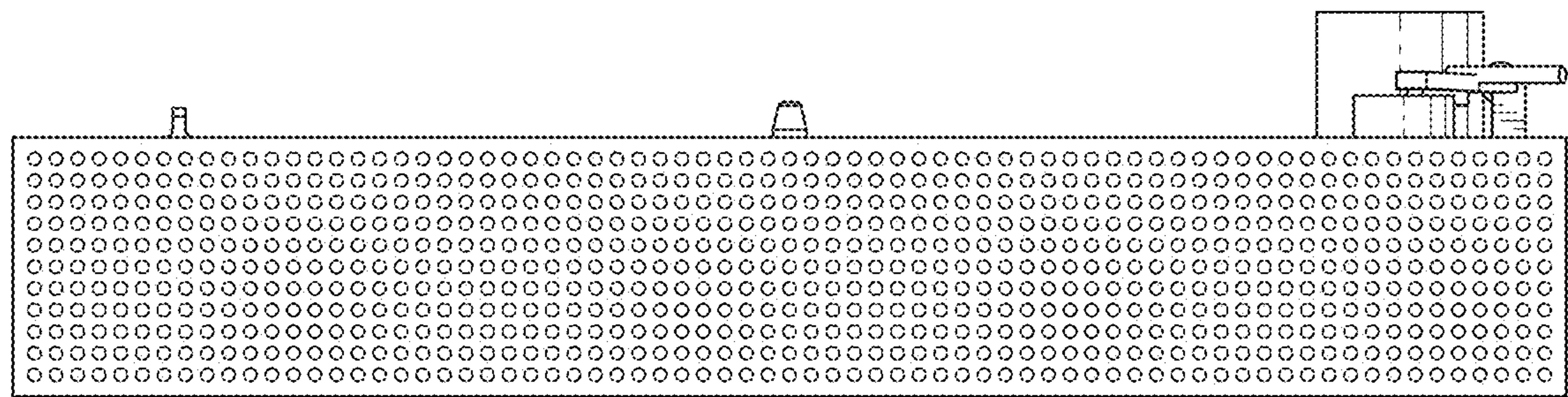

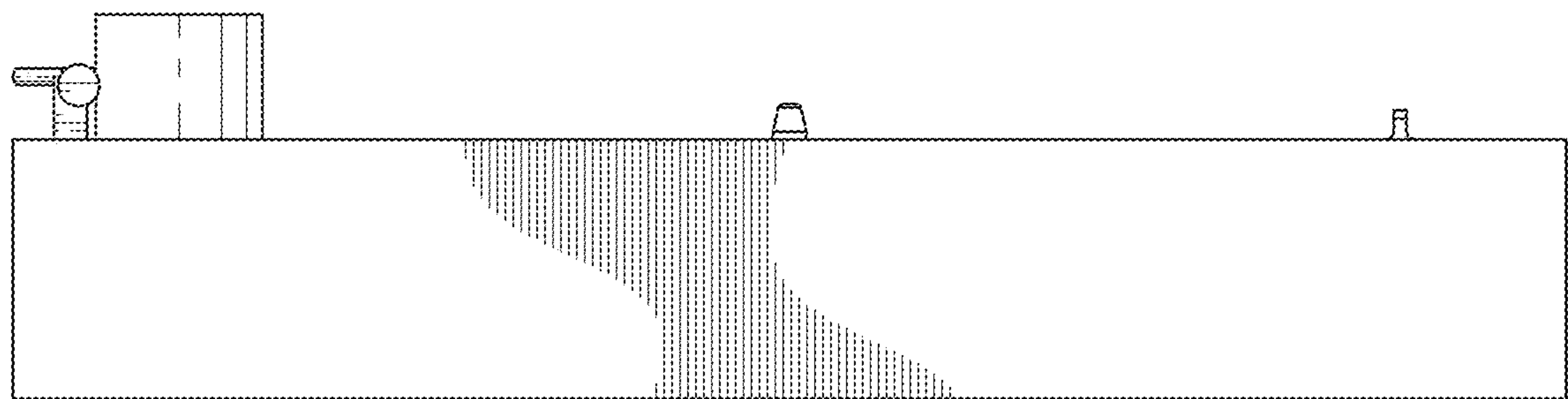

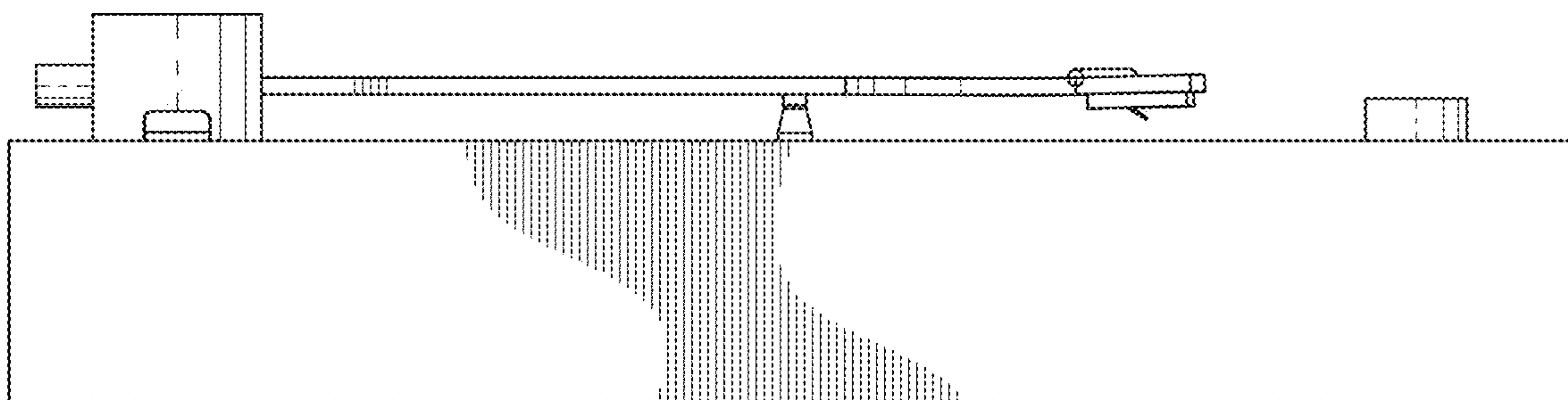

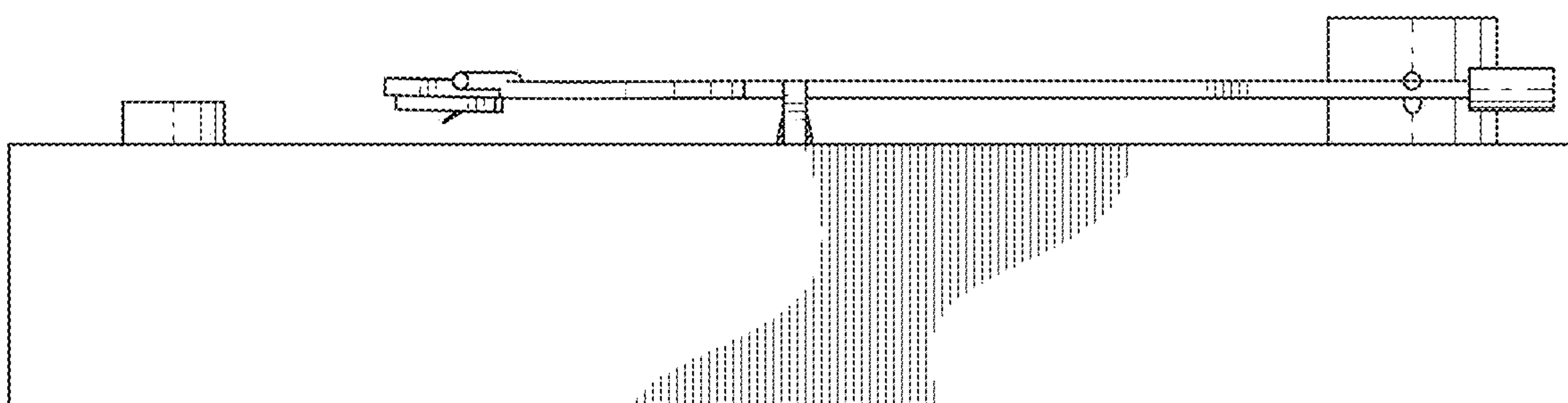

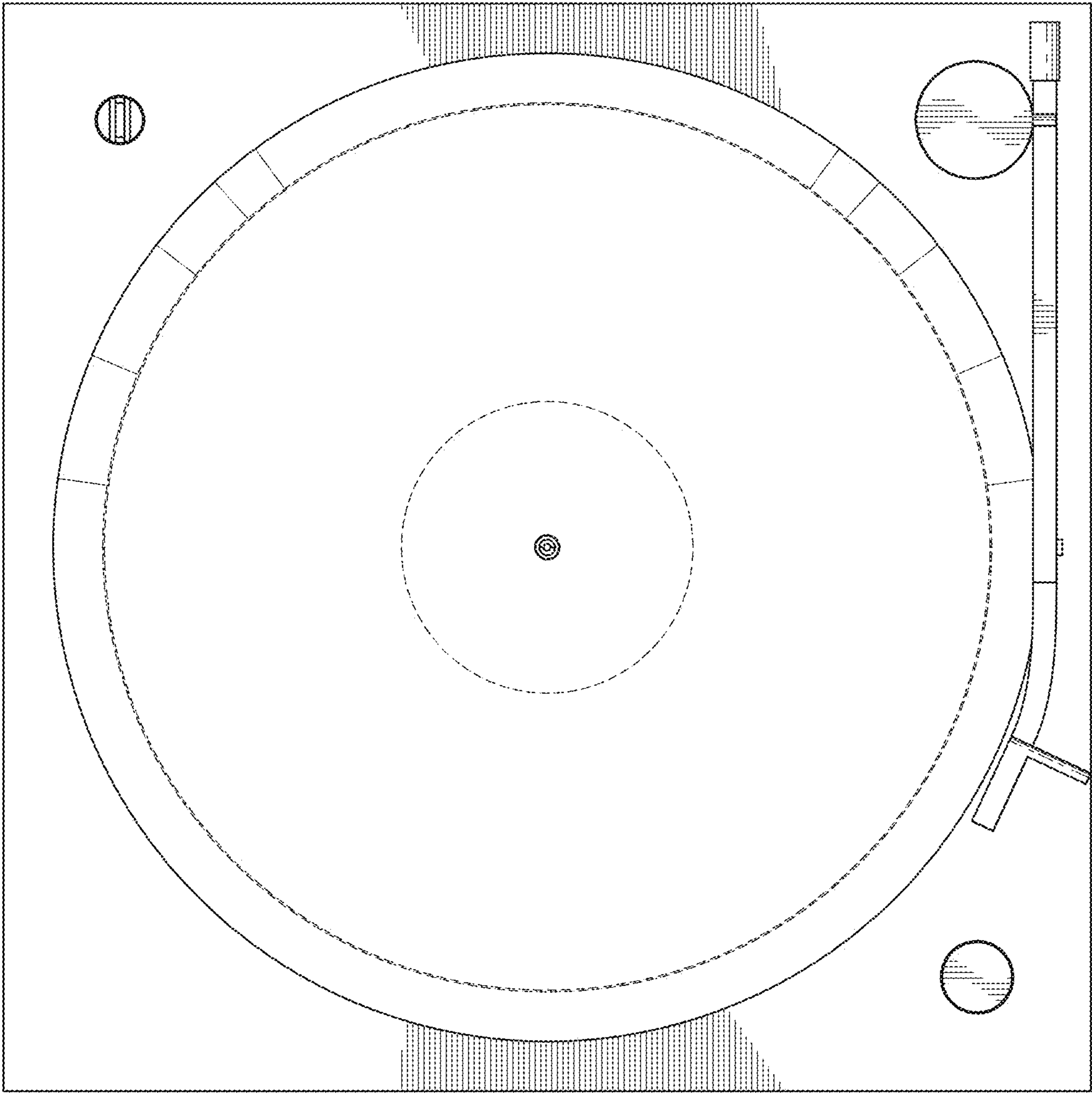

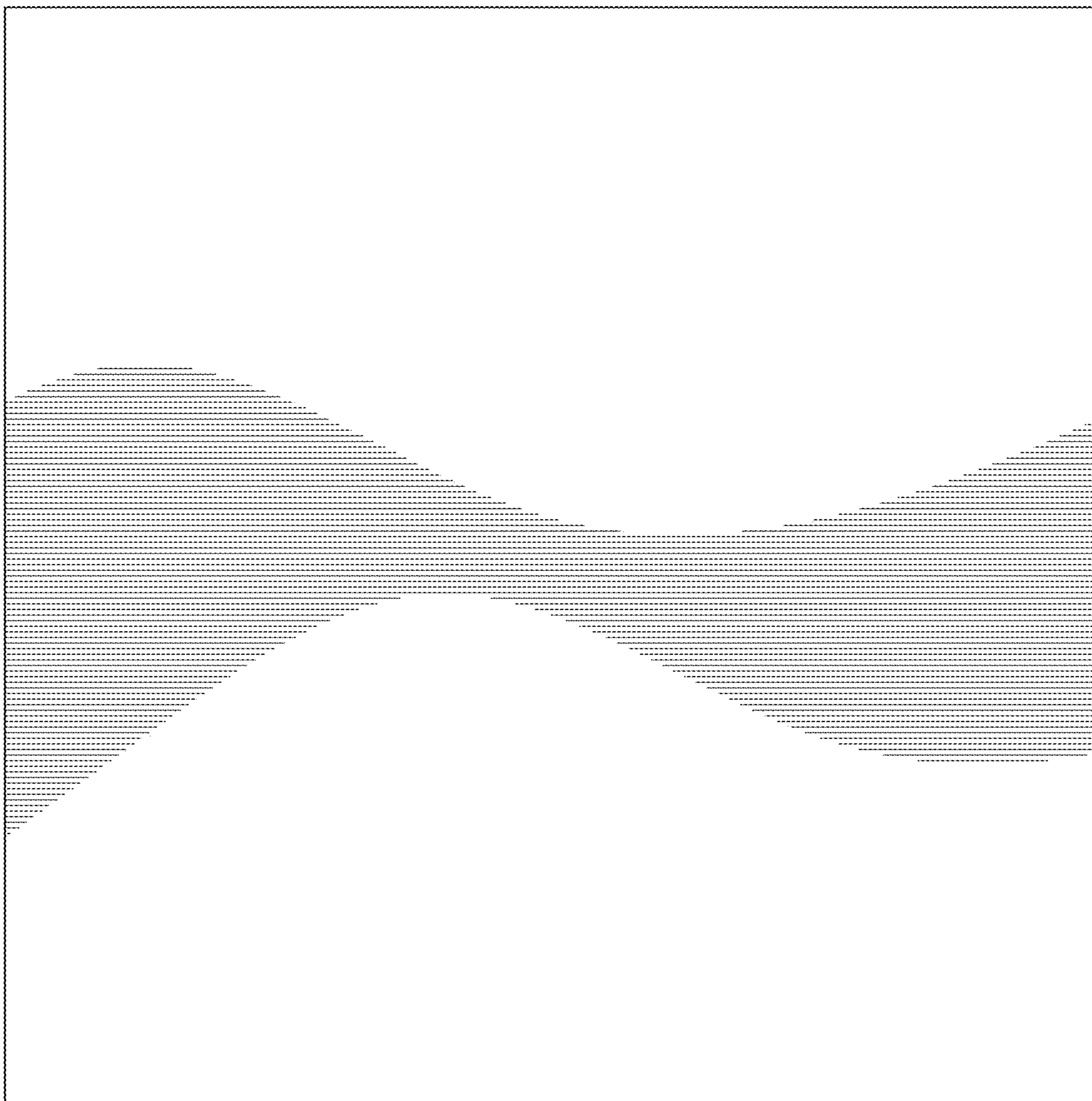

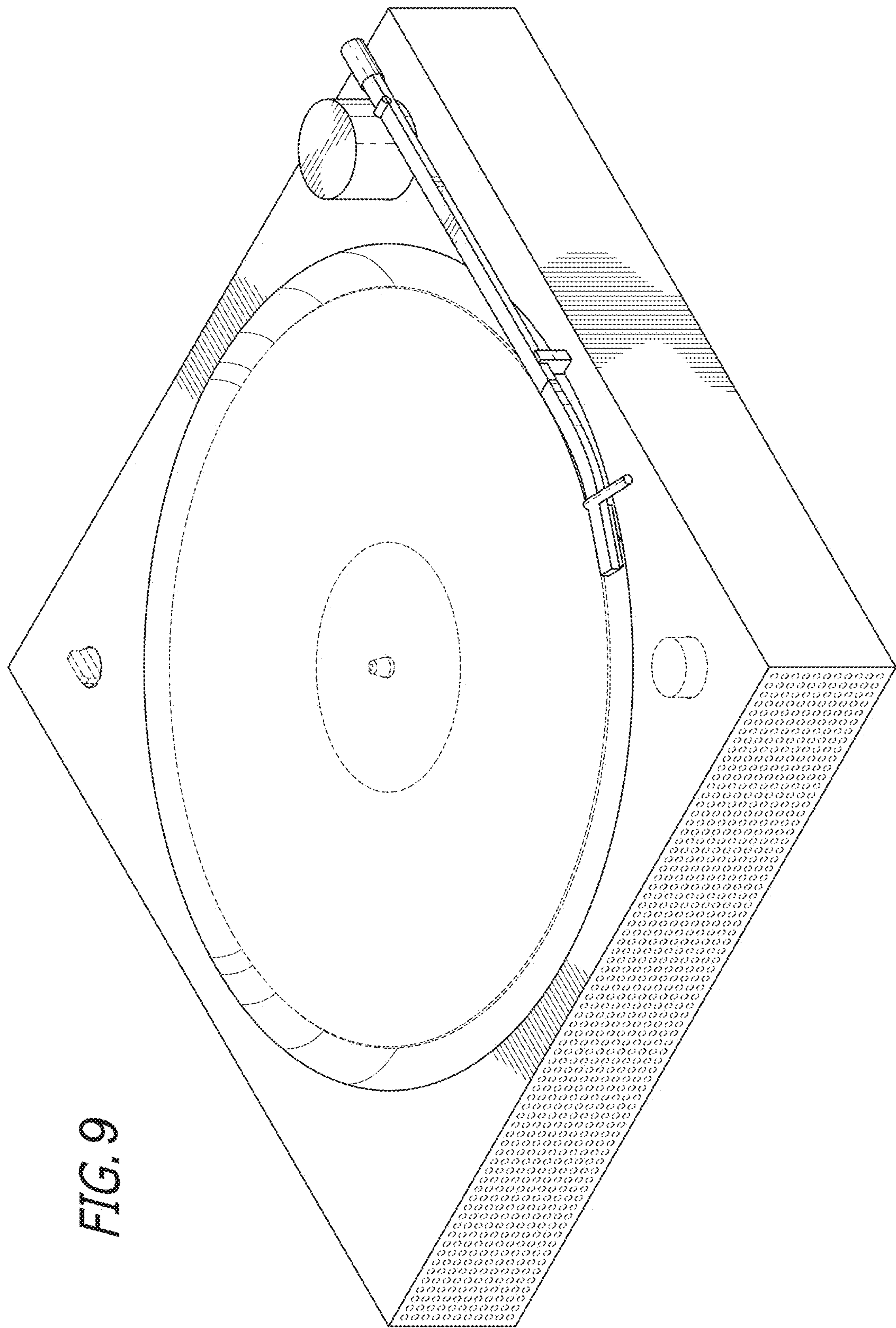

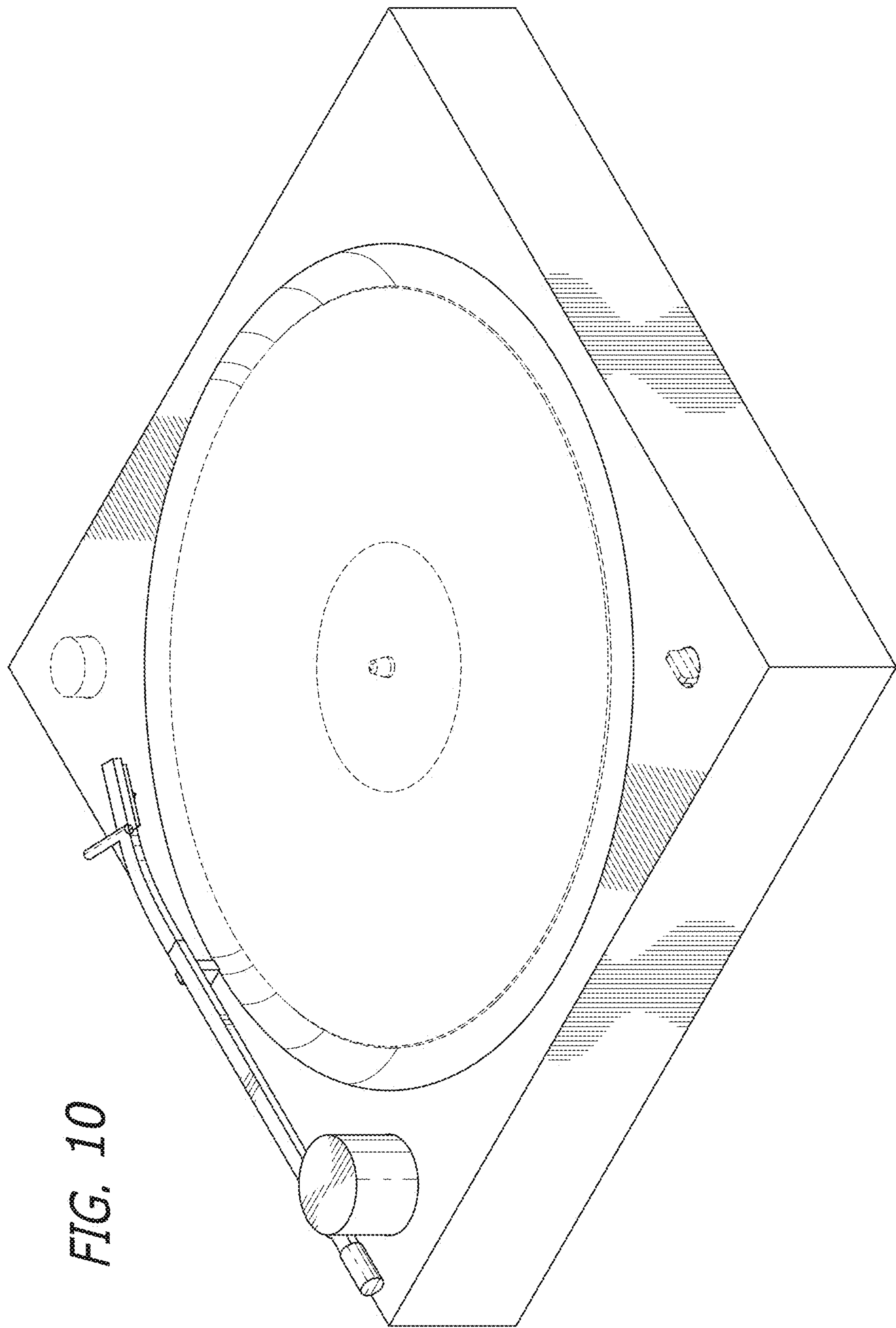

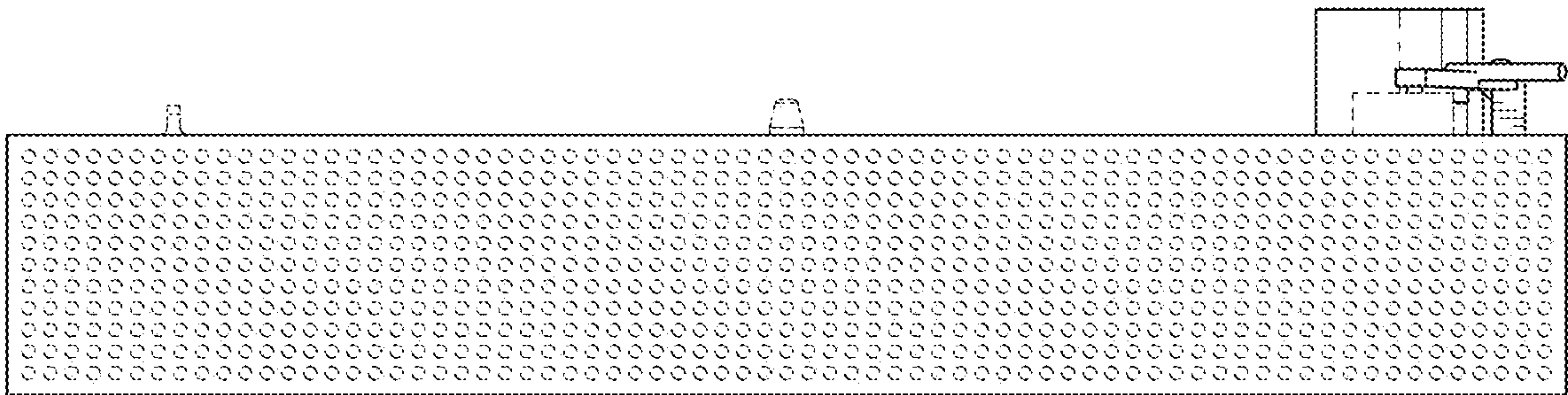

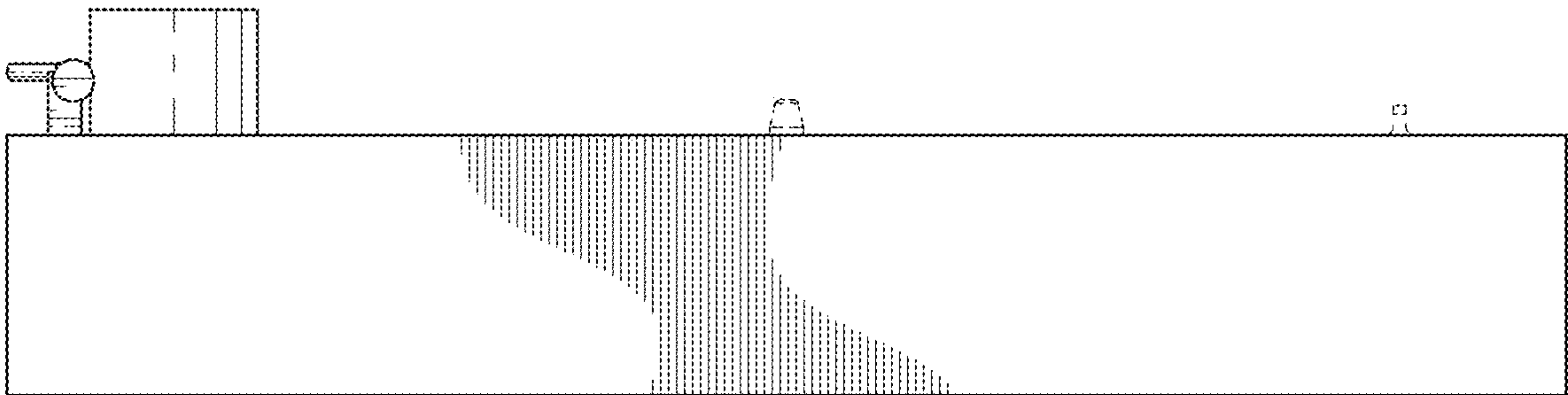

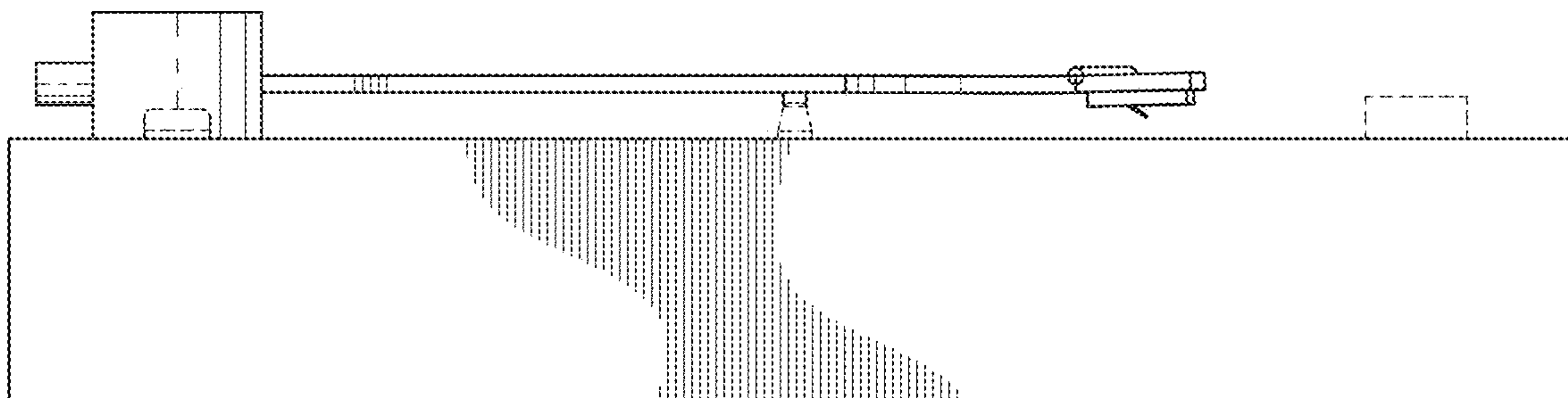

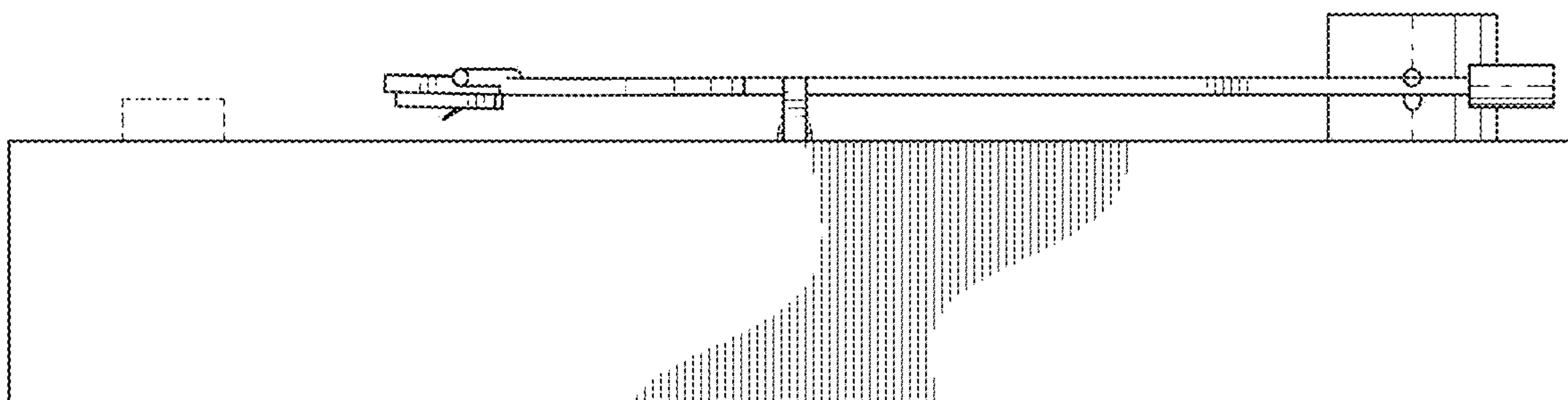

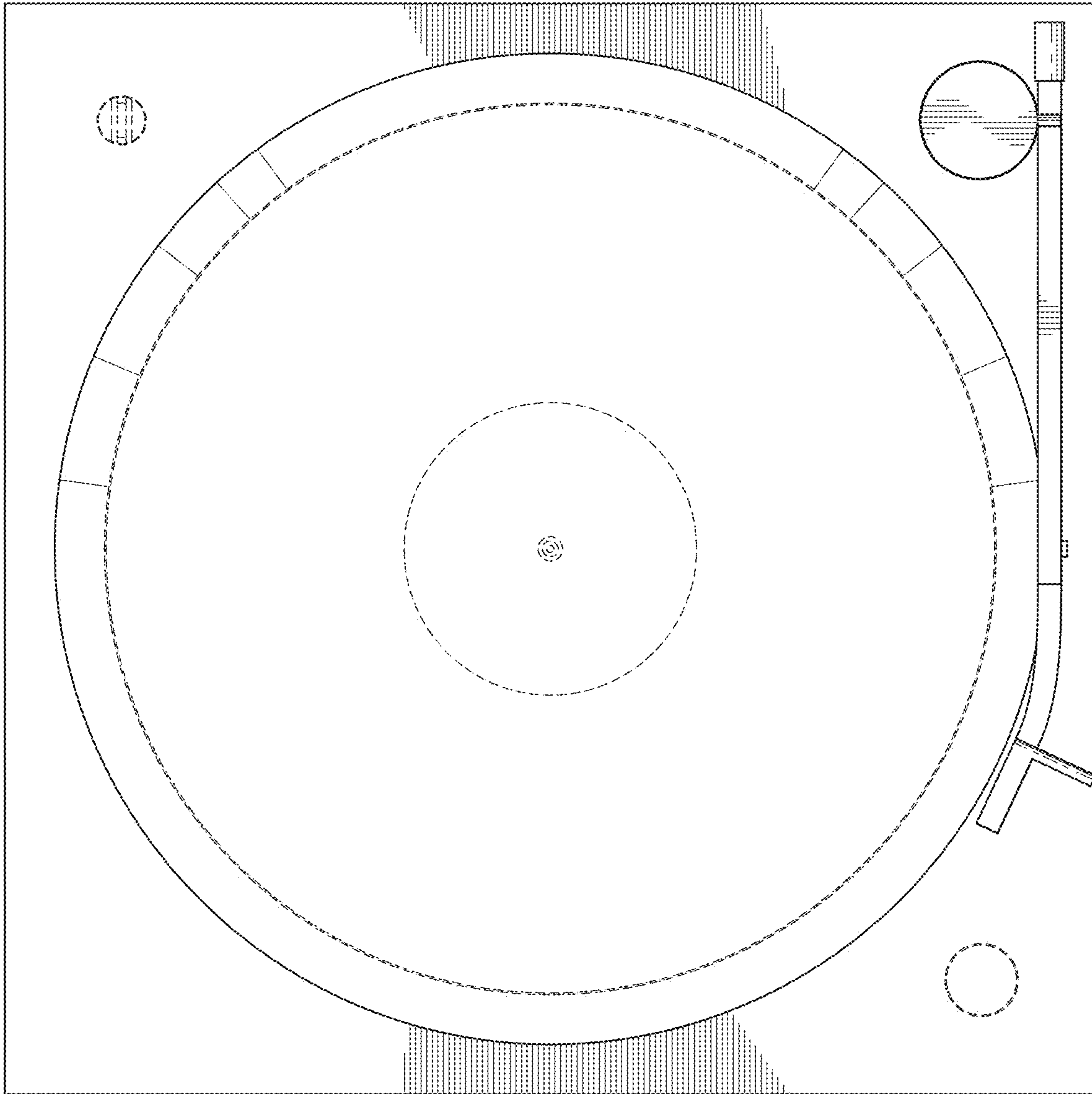

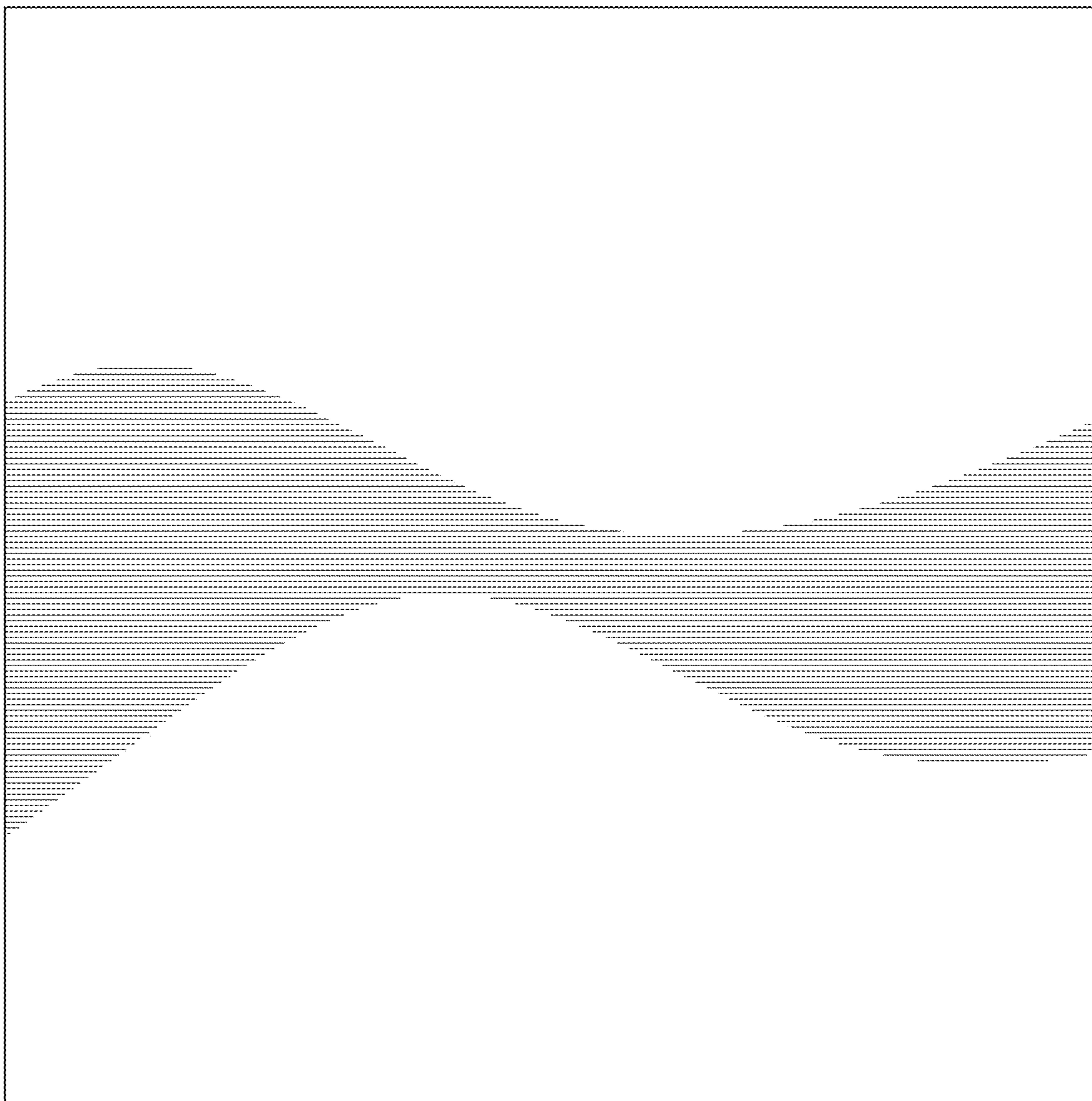
