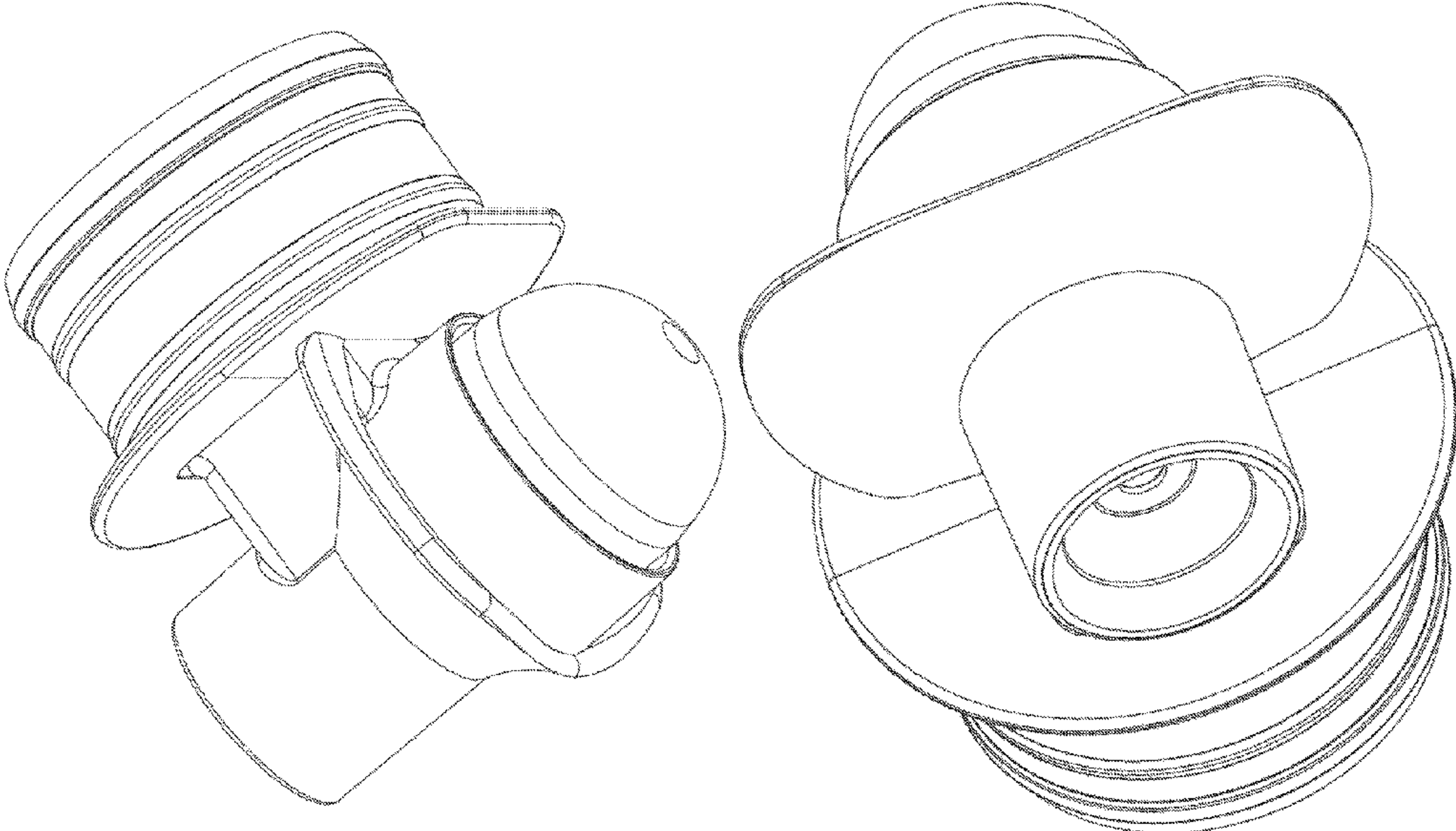
The ornamental design for a fluid dispensing tap, as shown and described.

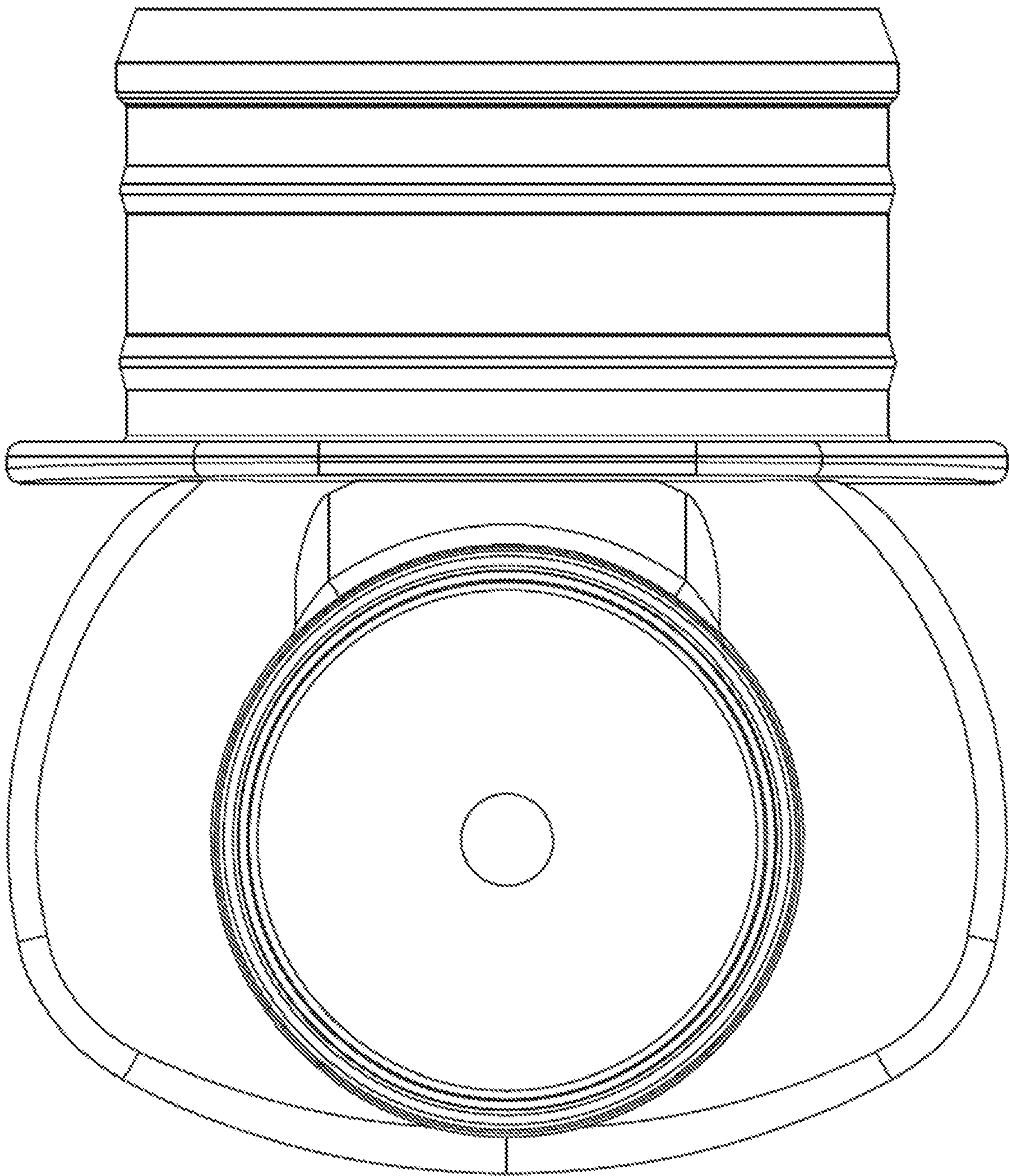

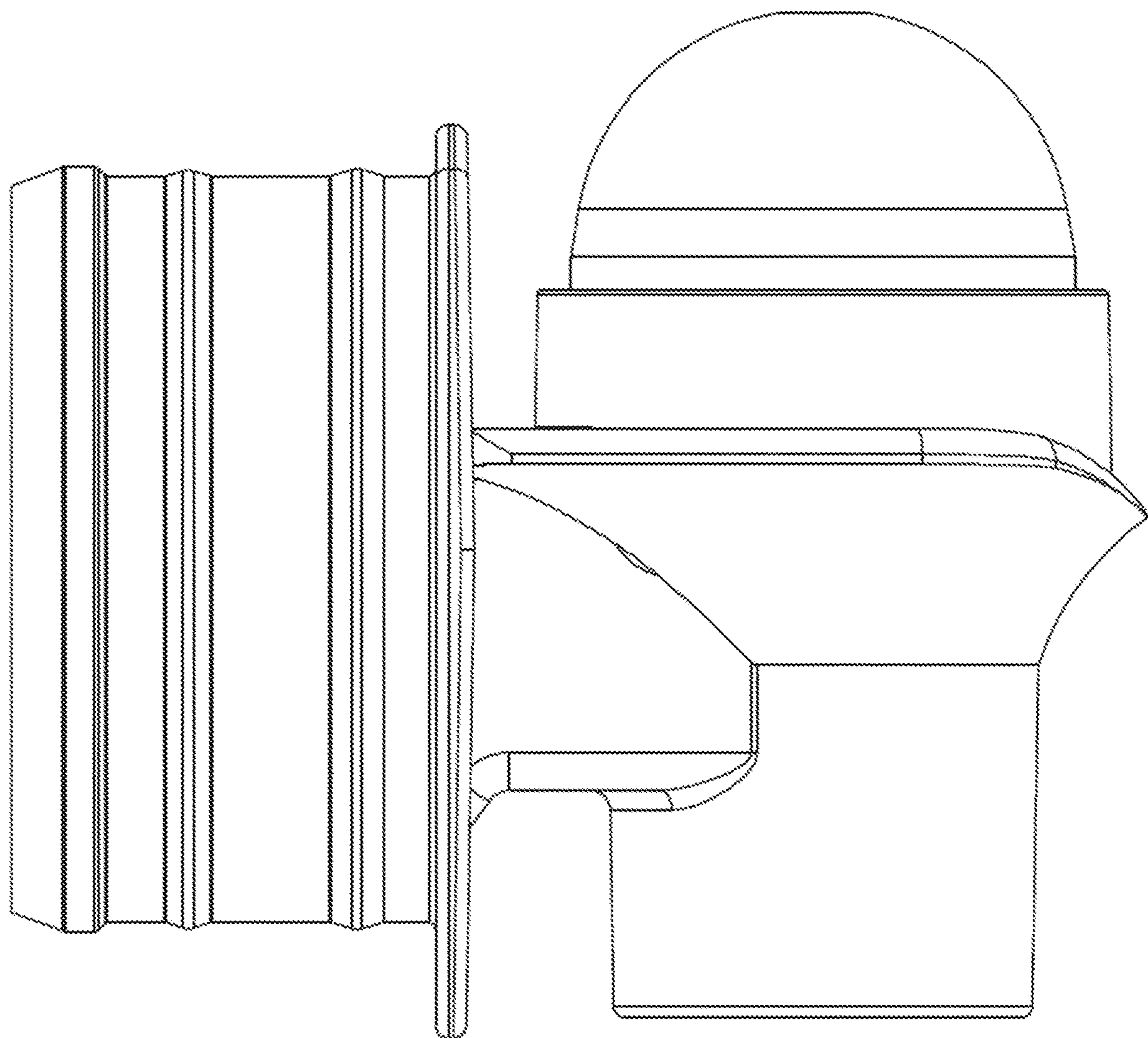

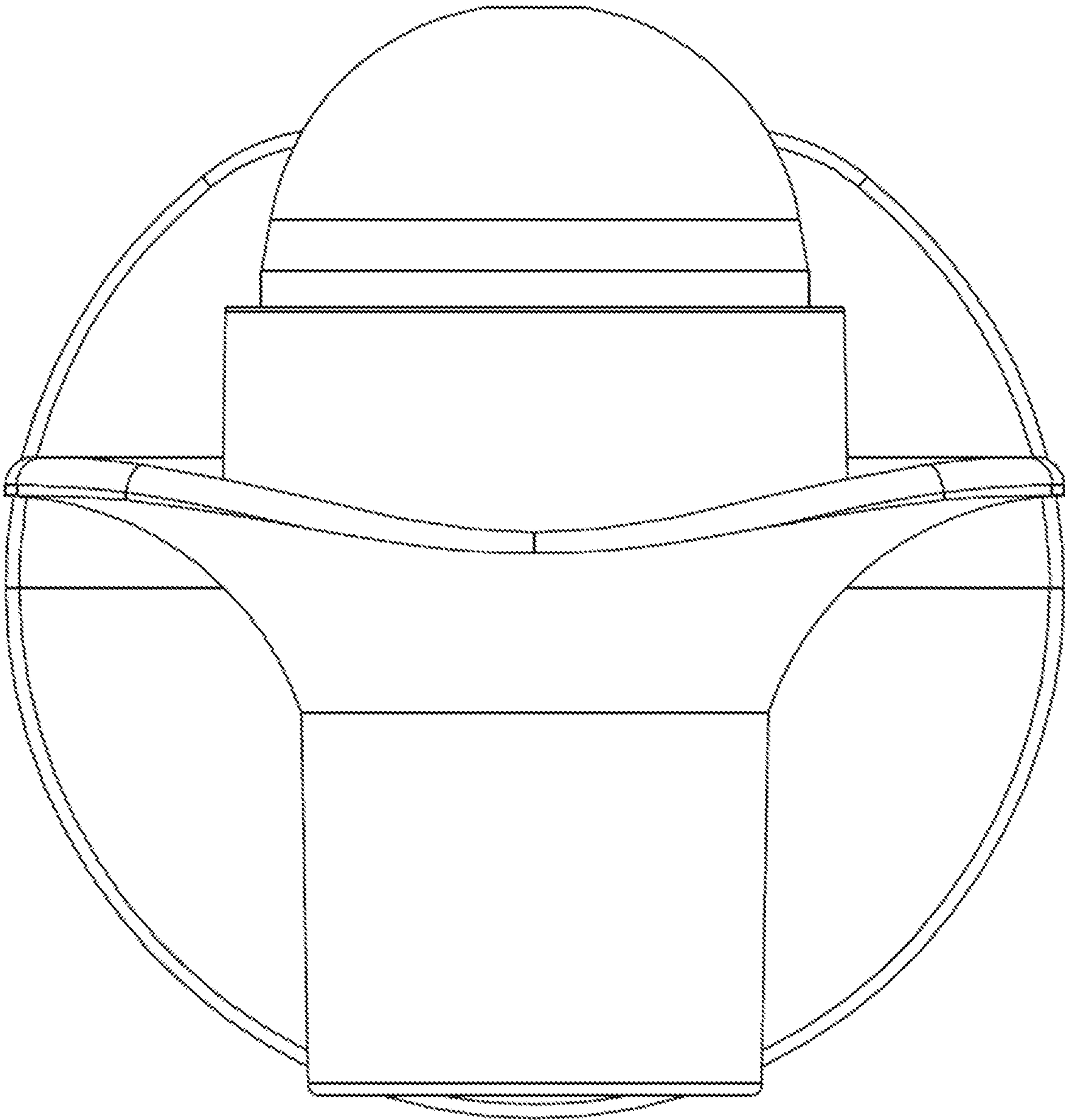

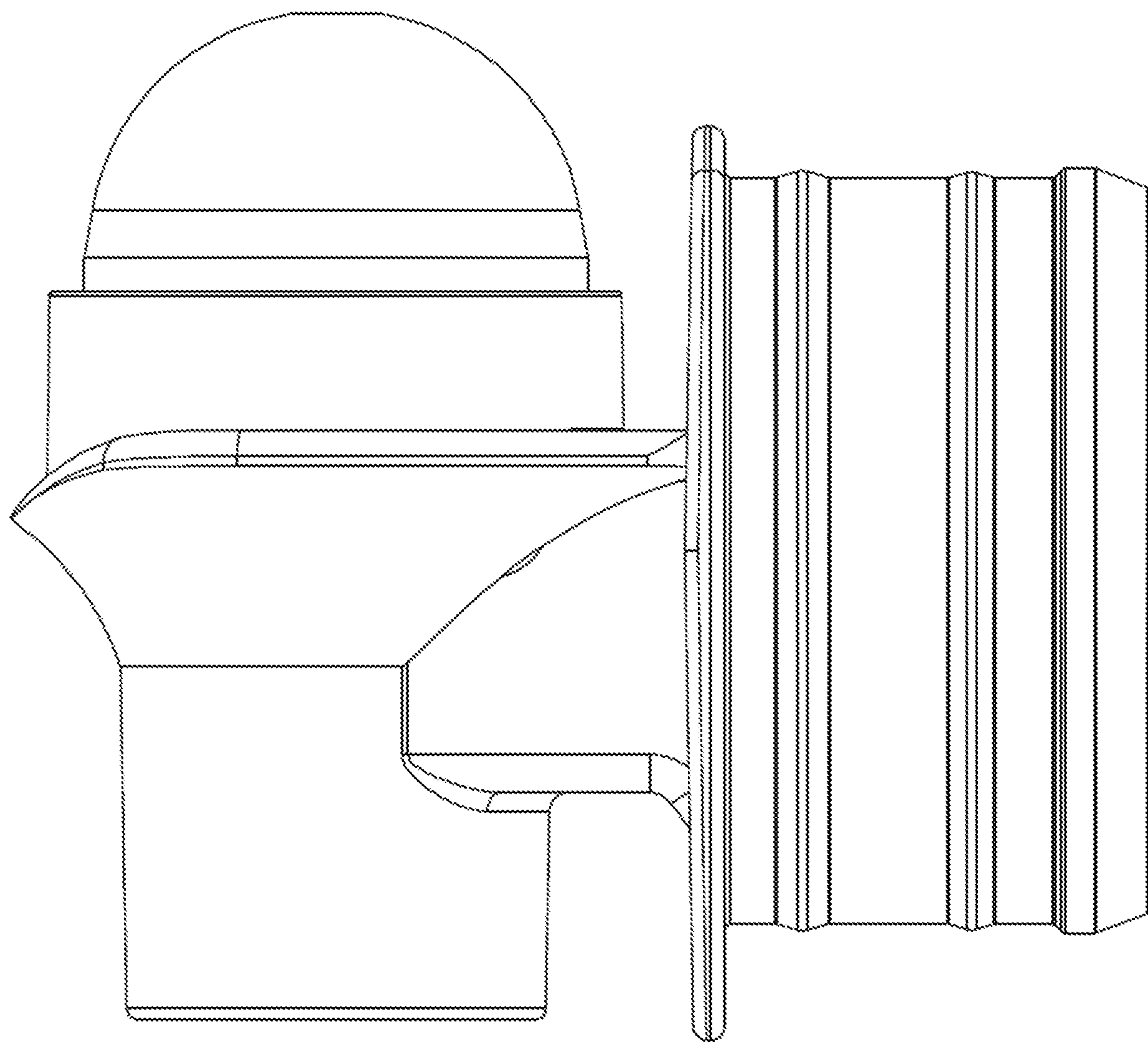

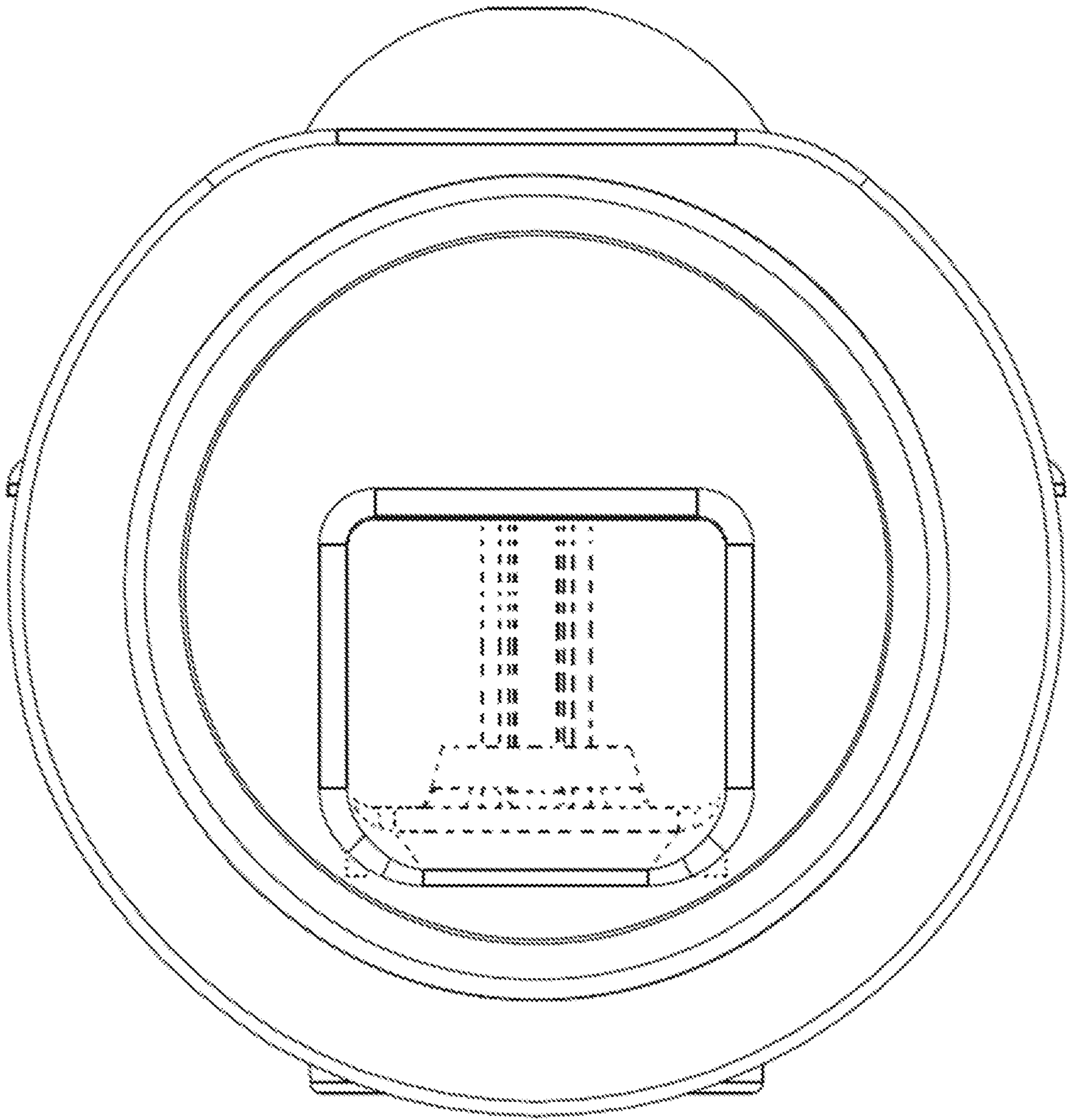

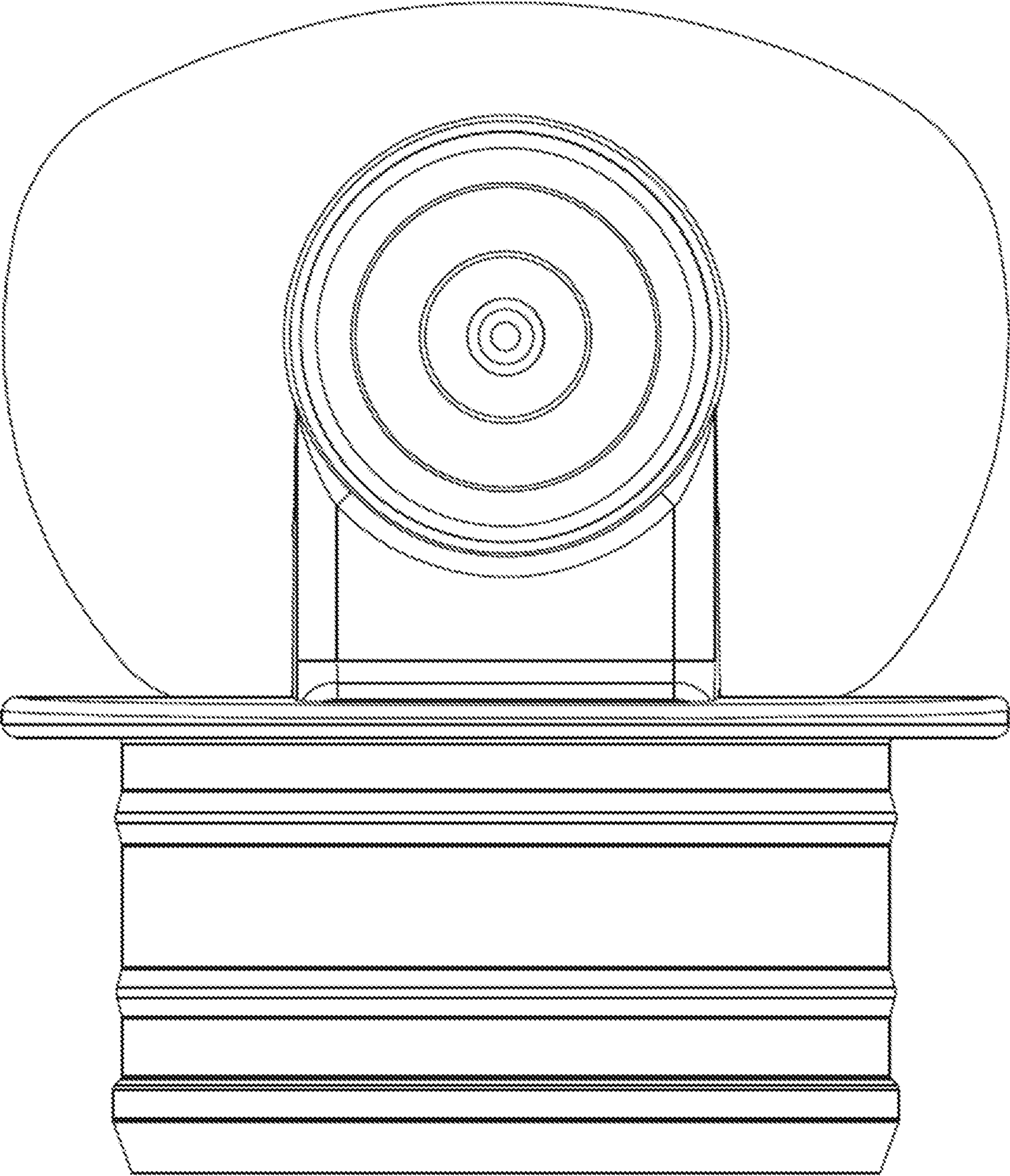

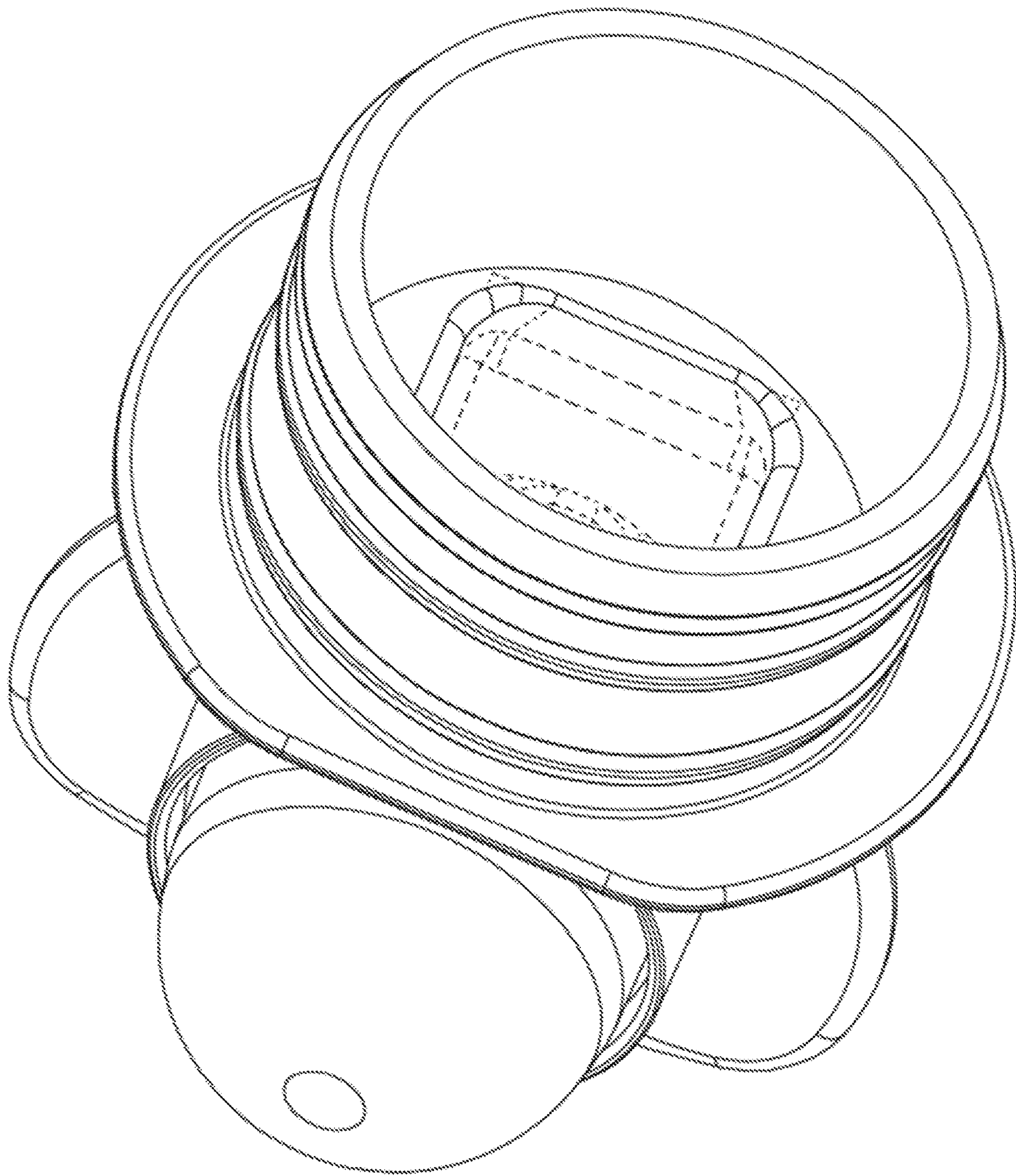

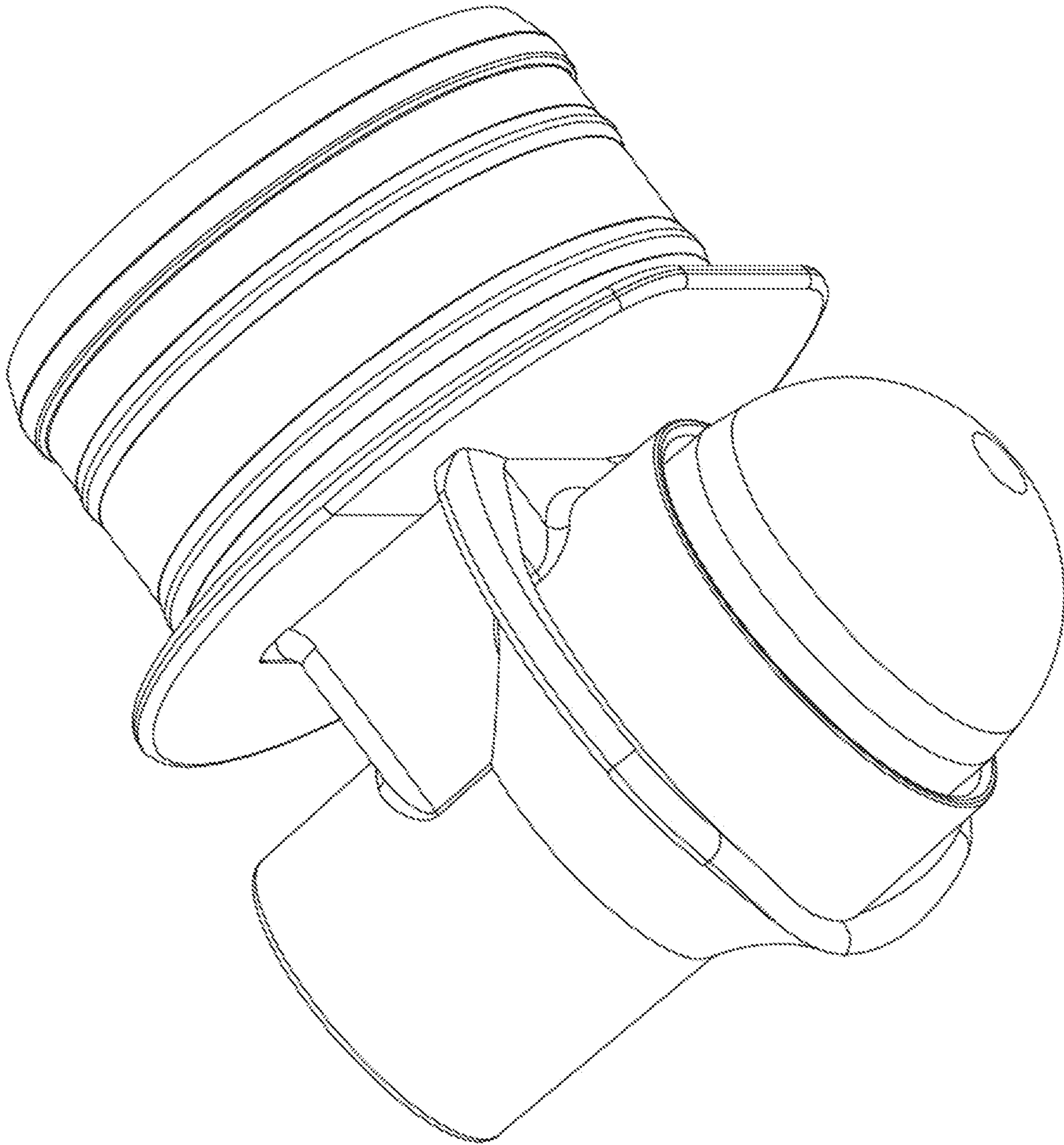

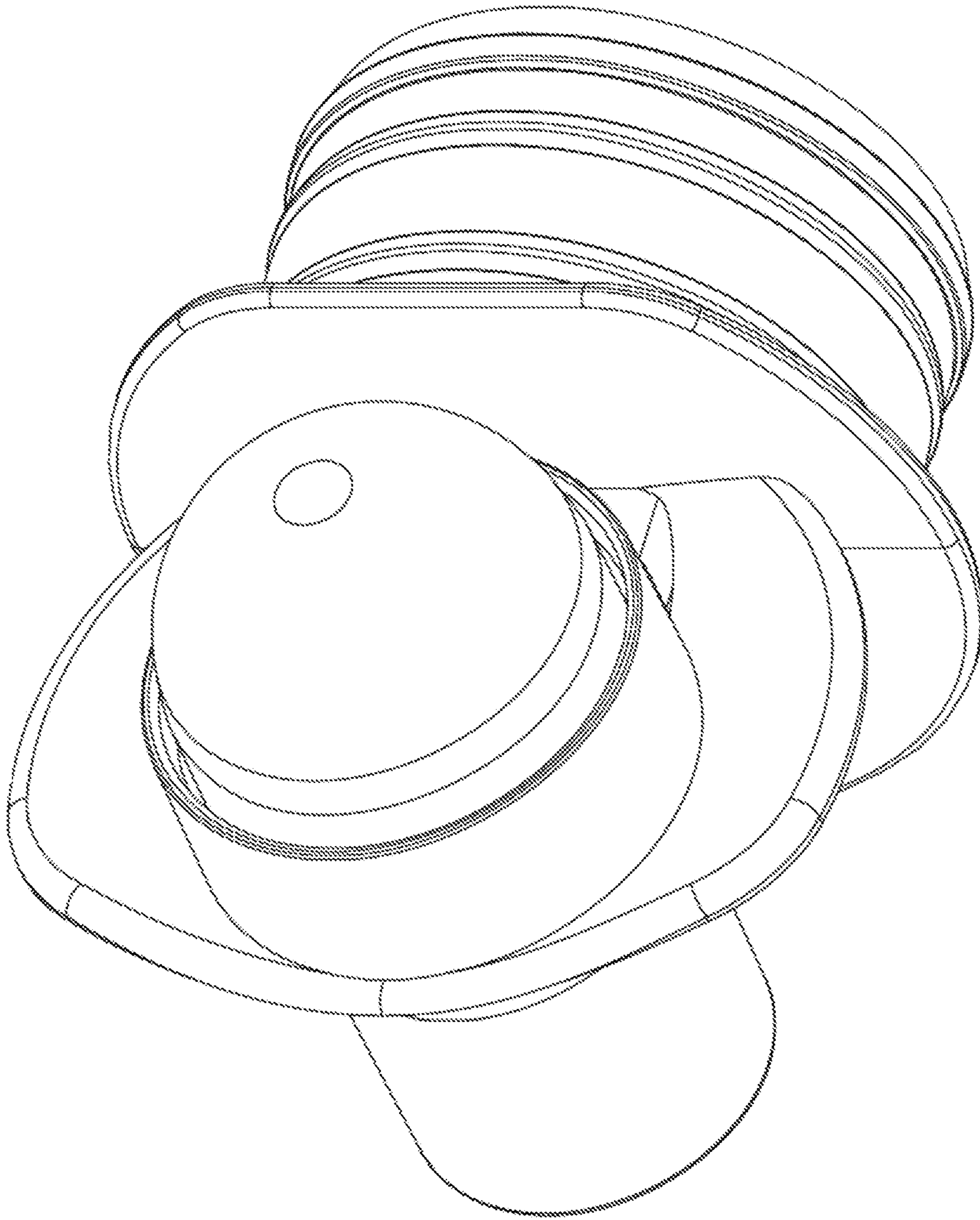

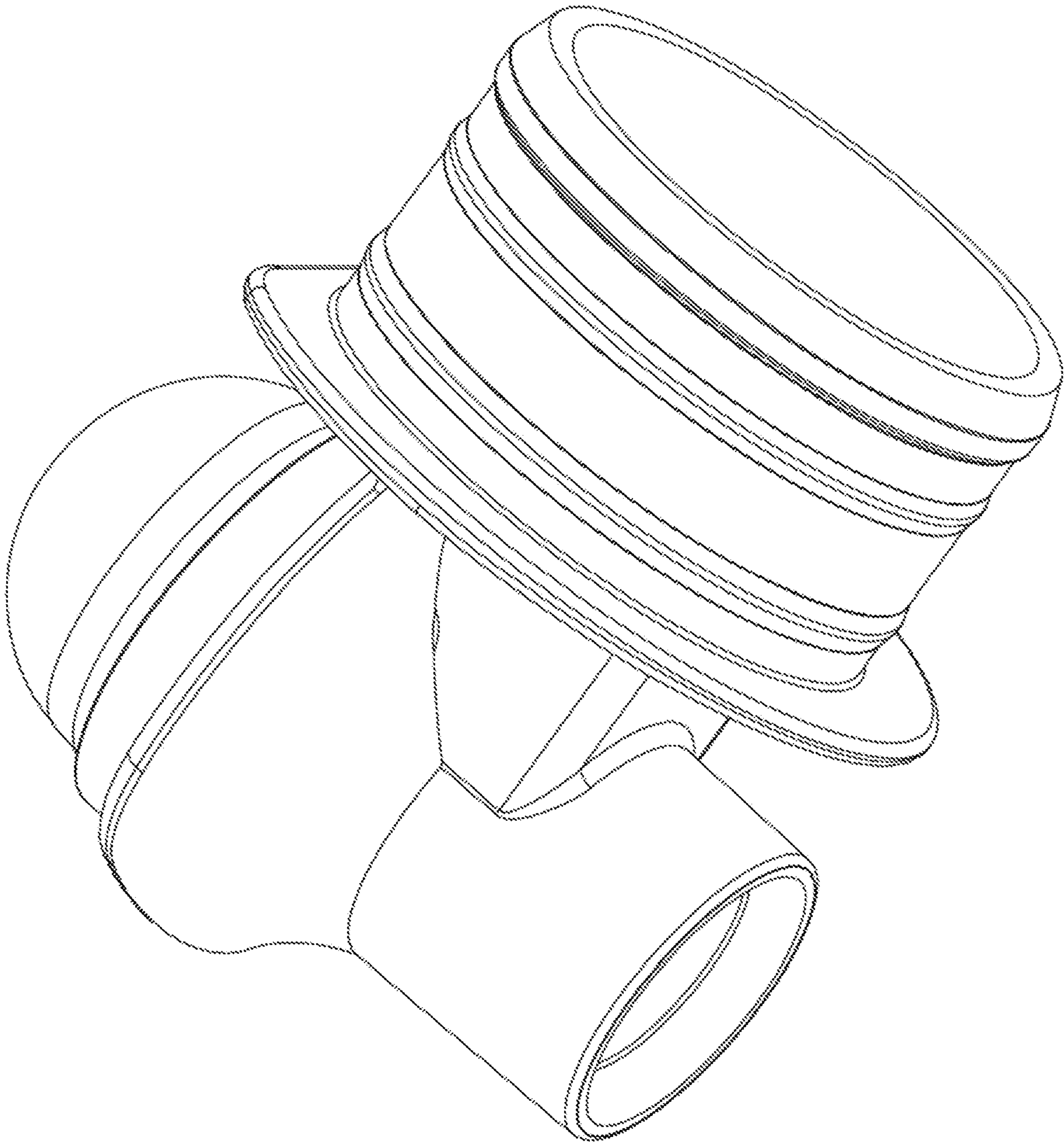

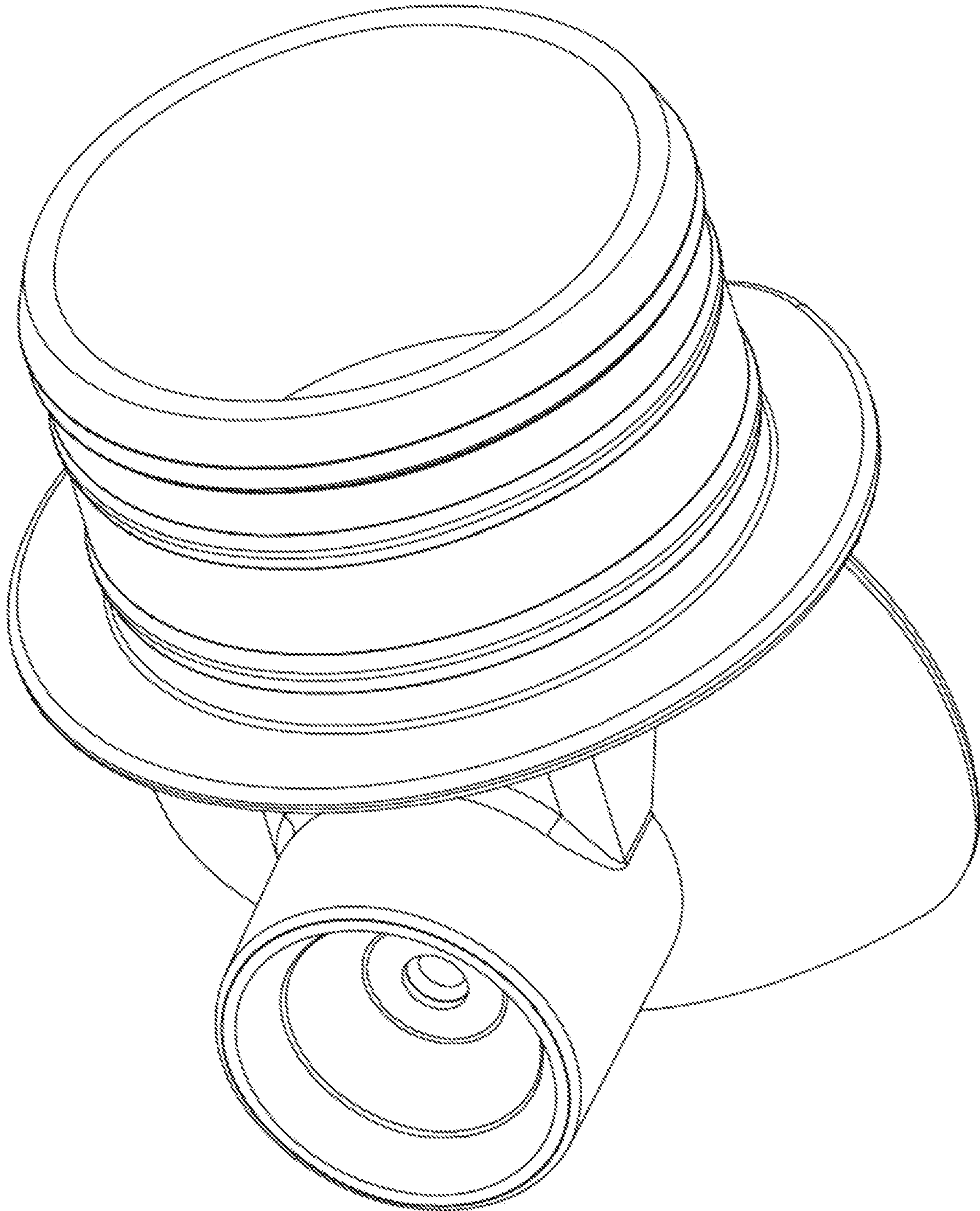

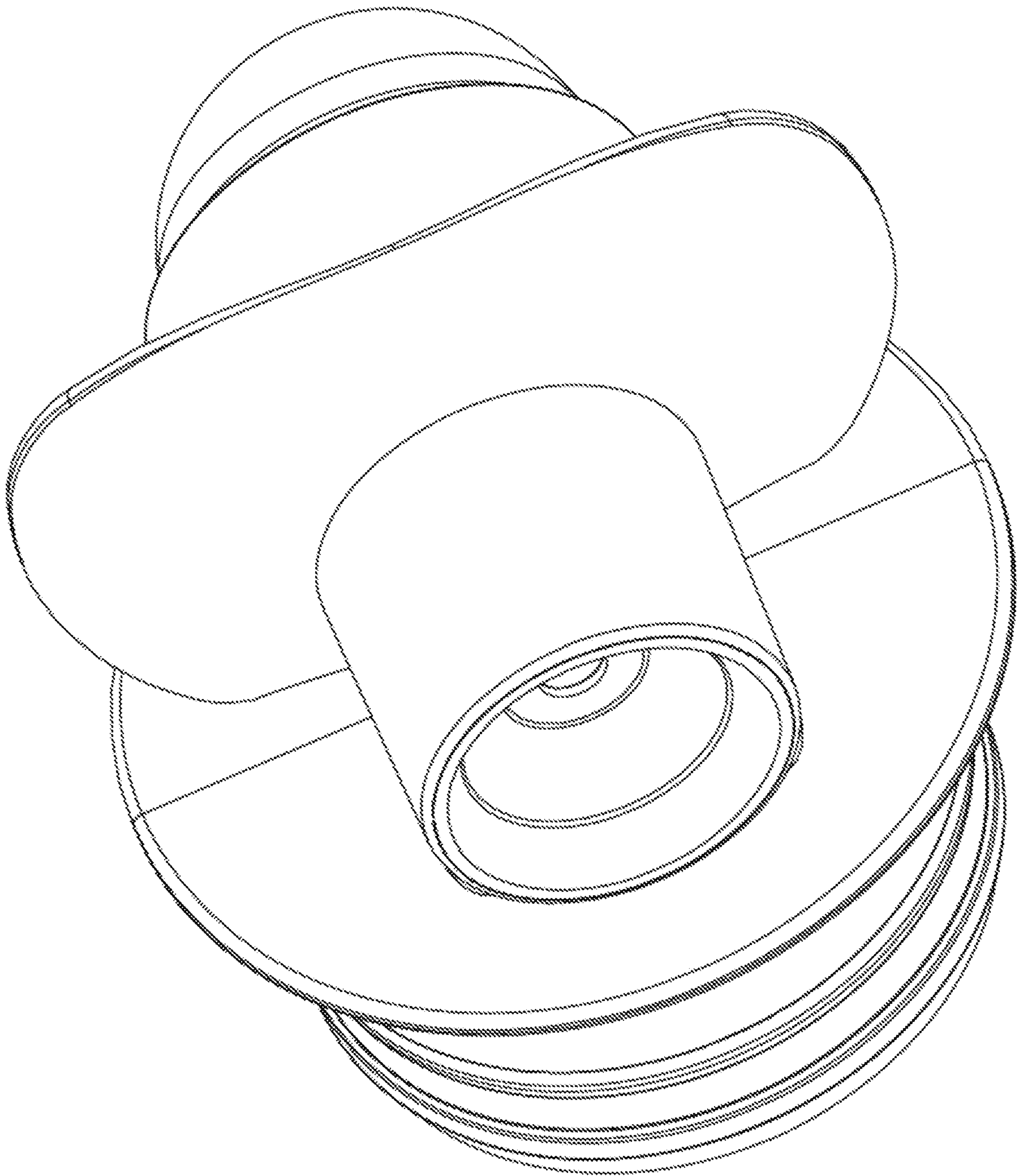
