FIG. 4 is a perspective view thereof

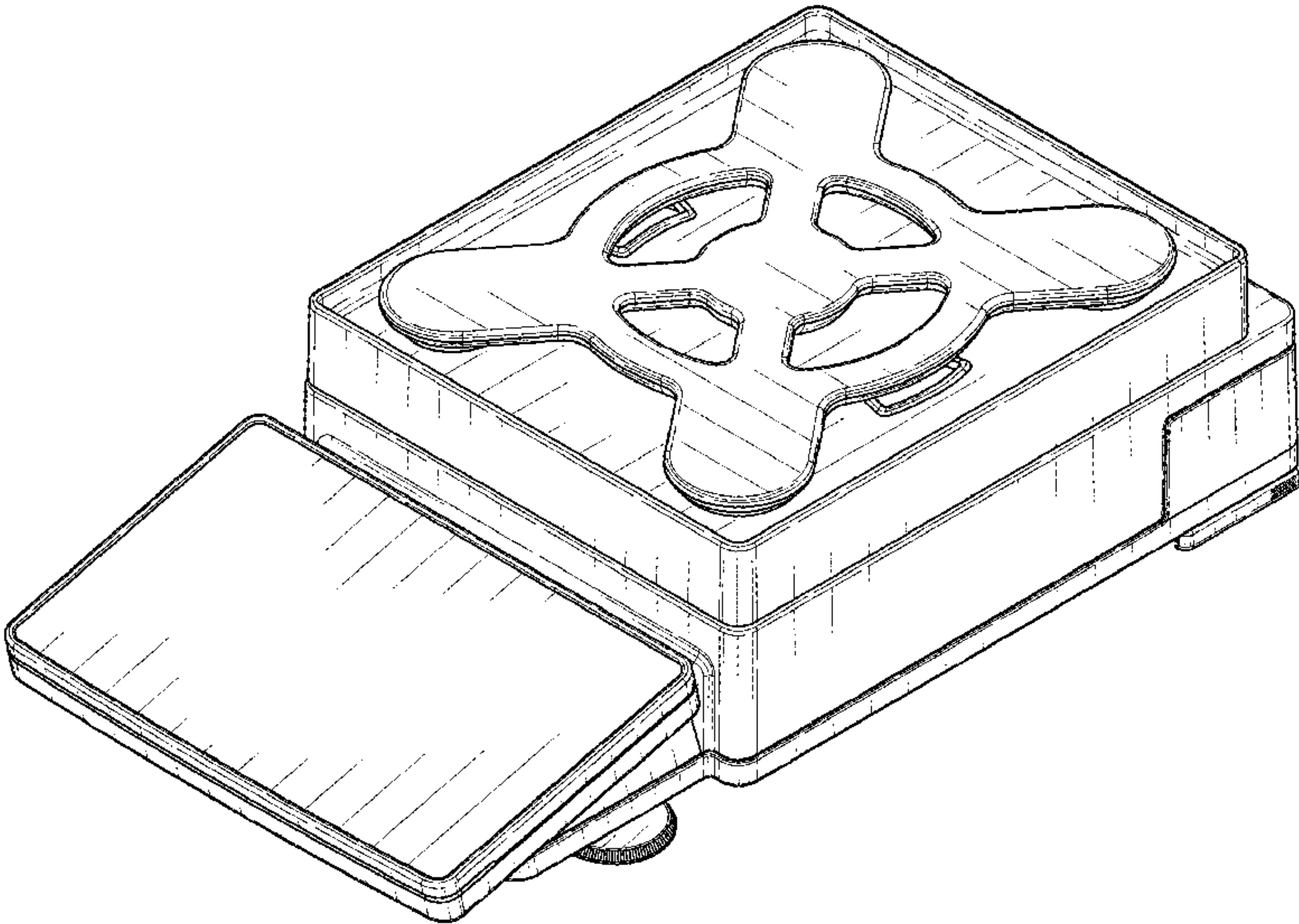
FIG. 5 is a rear view thereof;

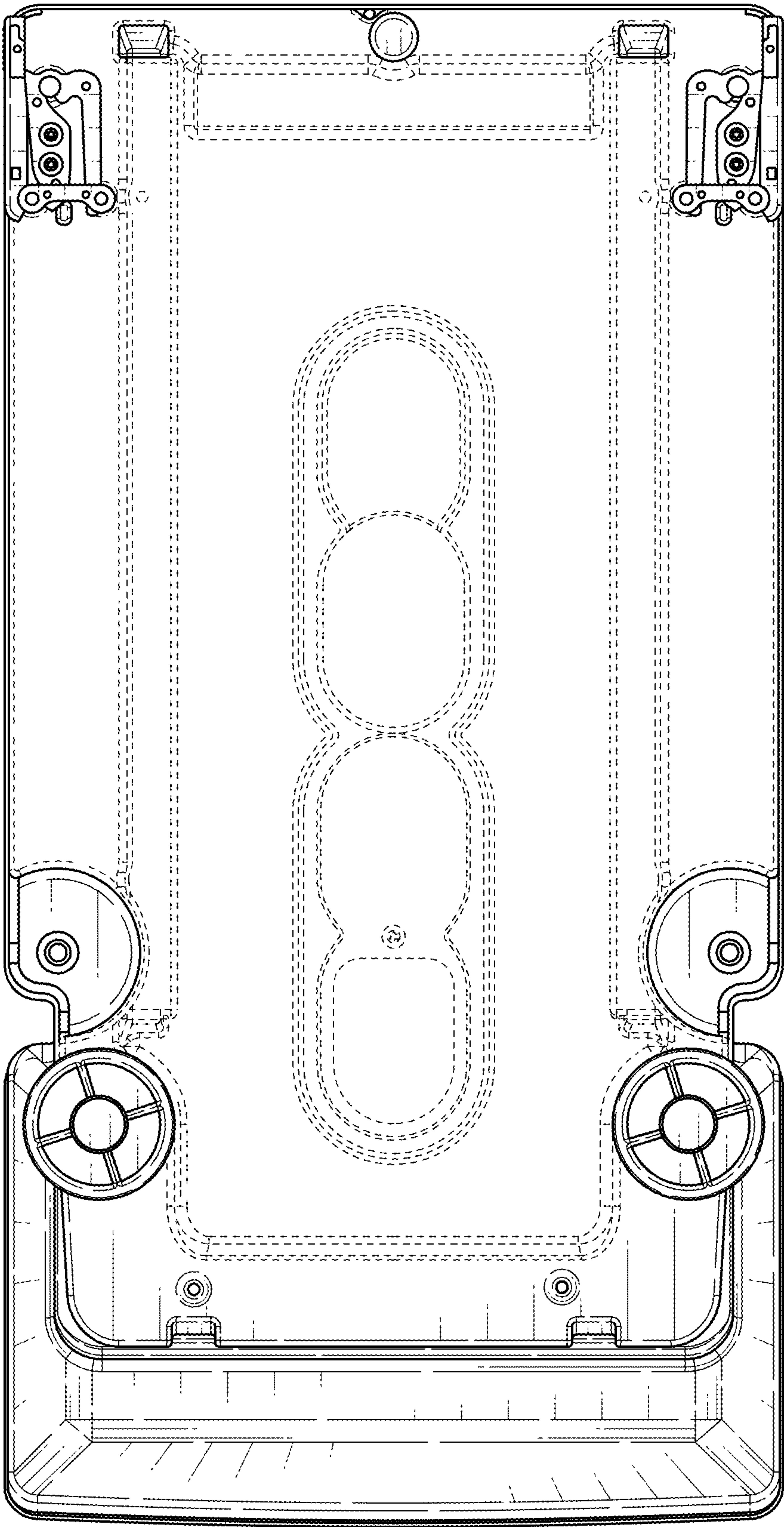

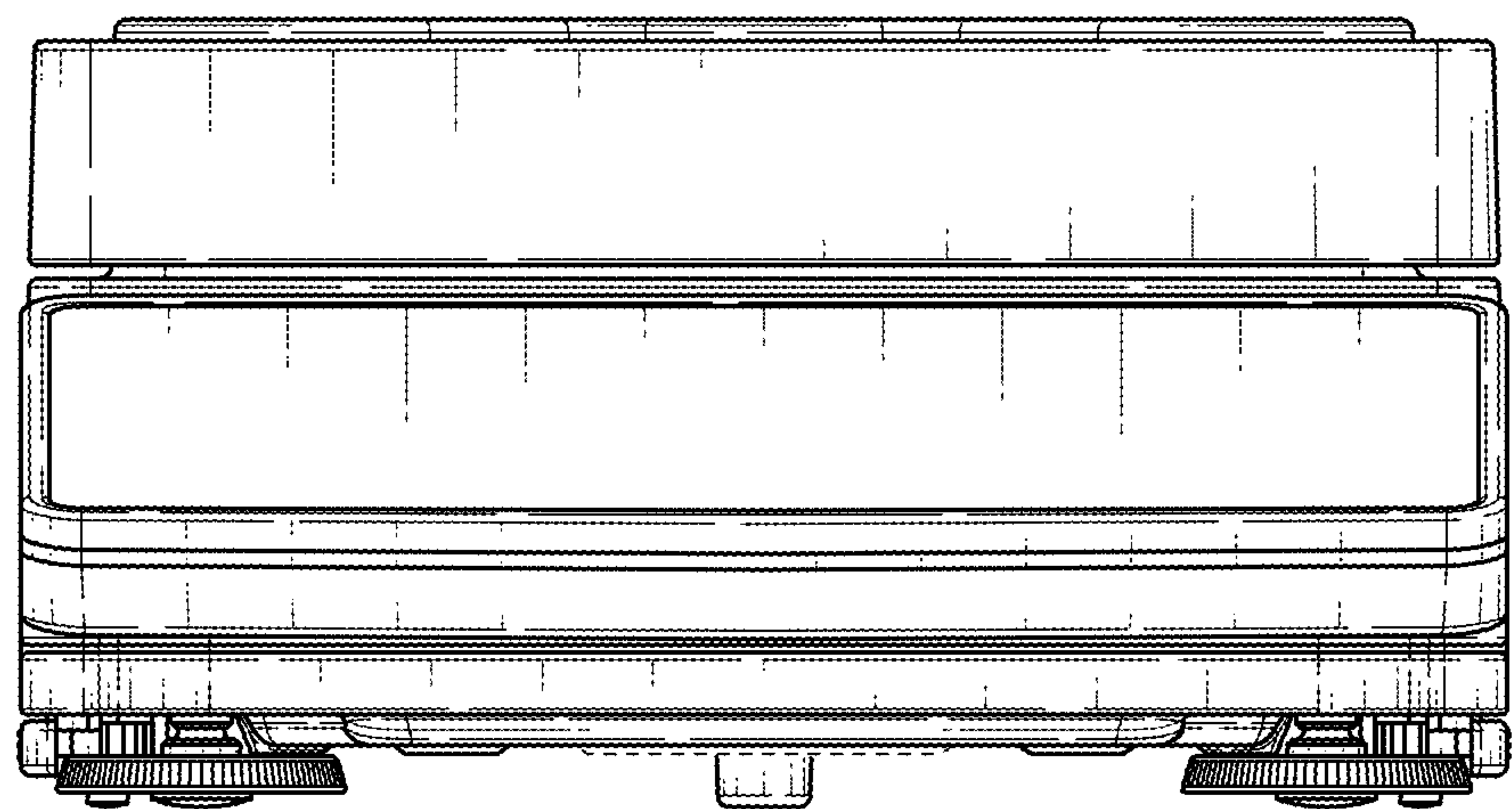

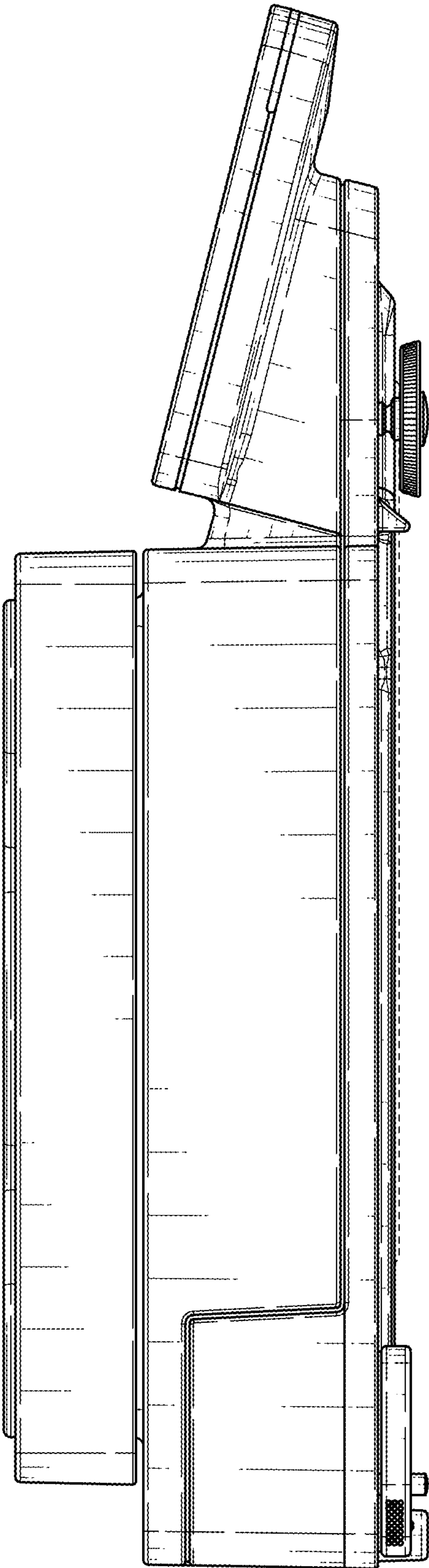

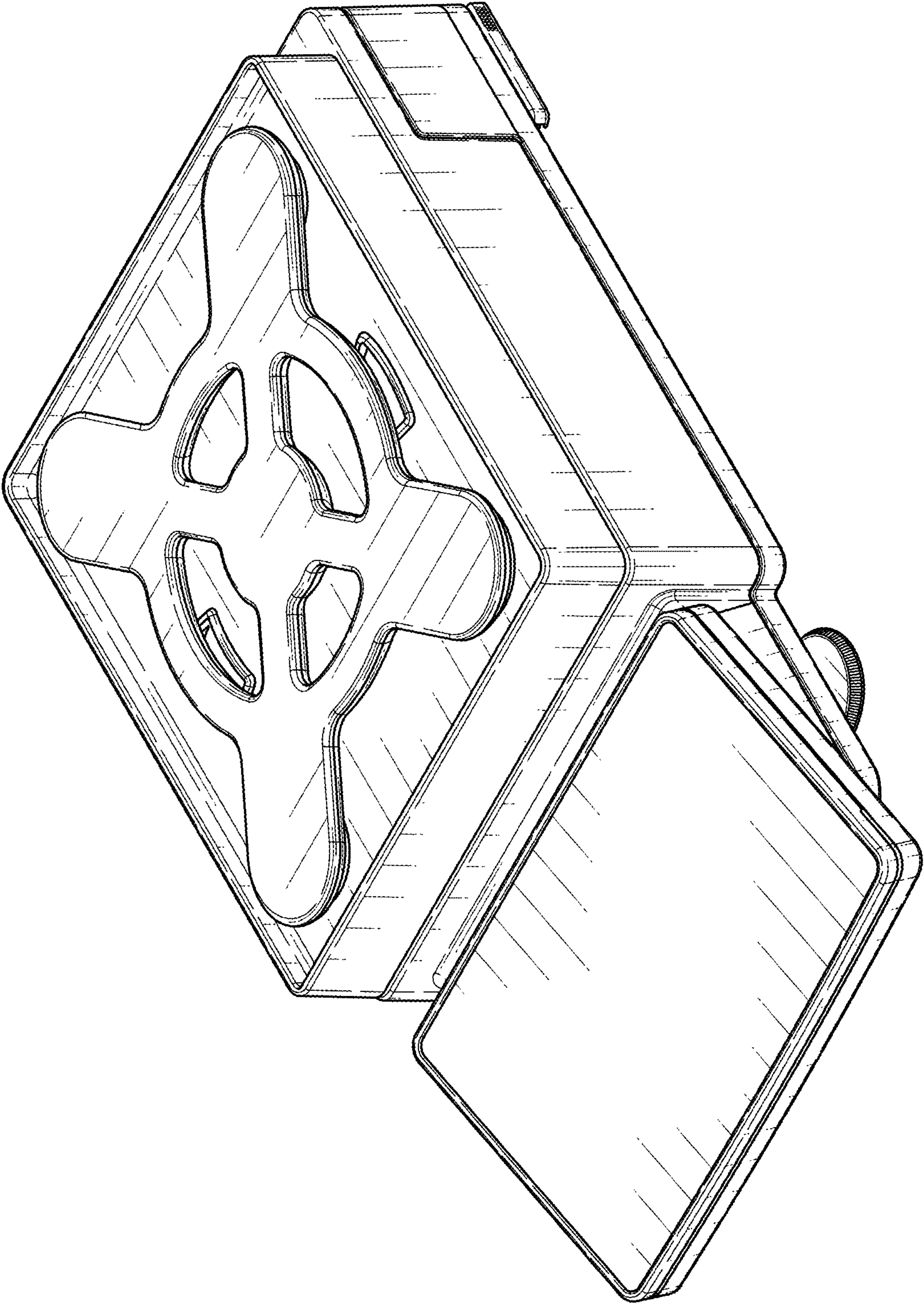

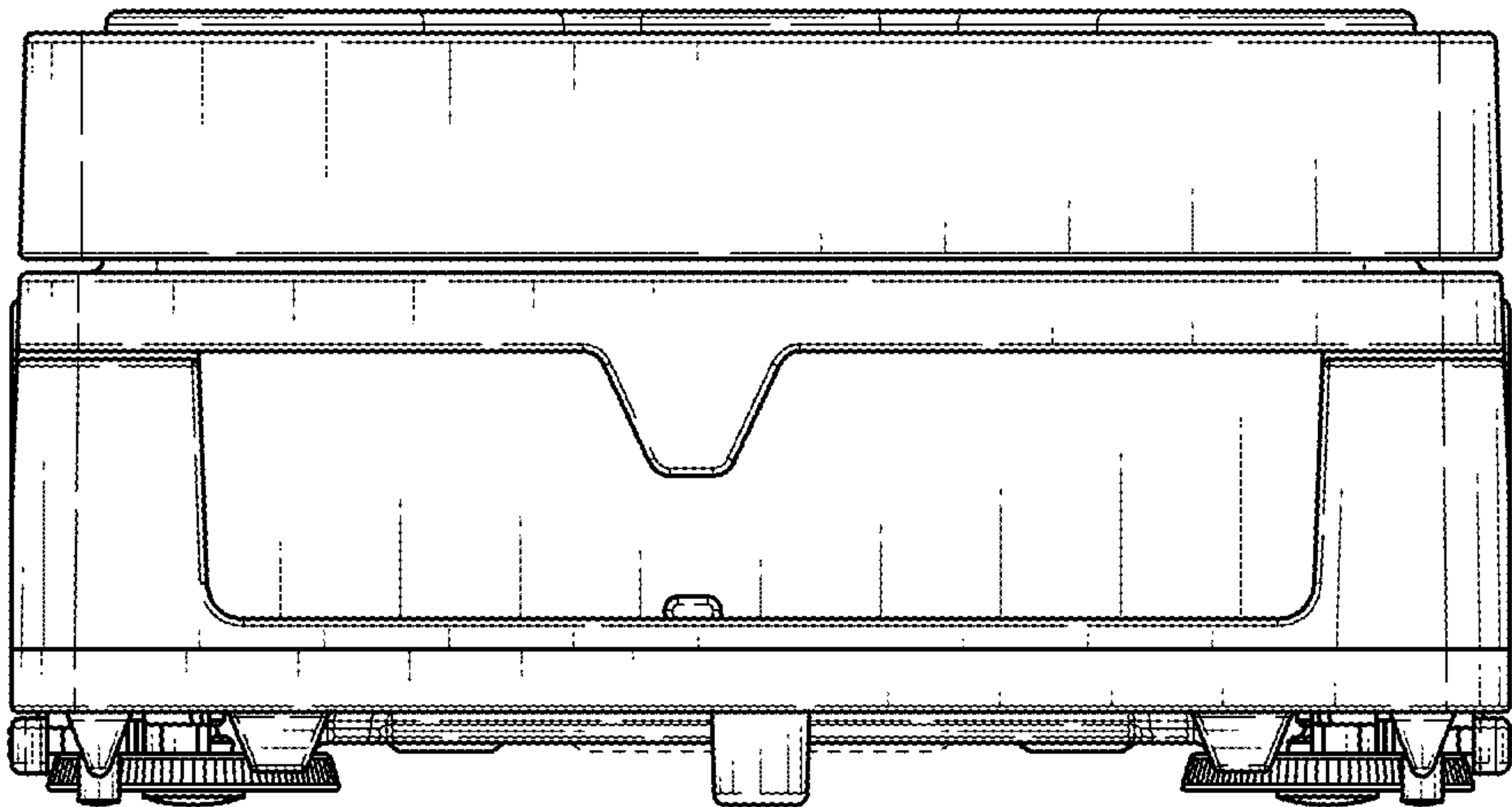

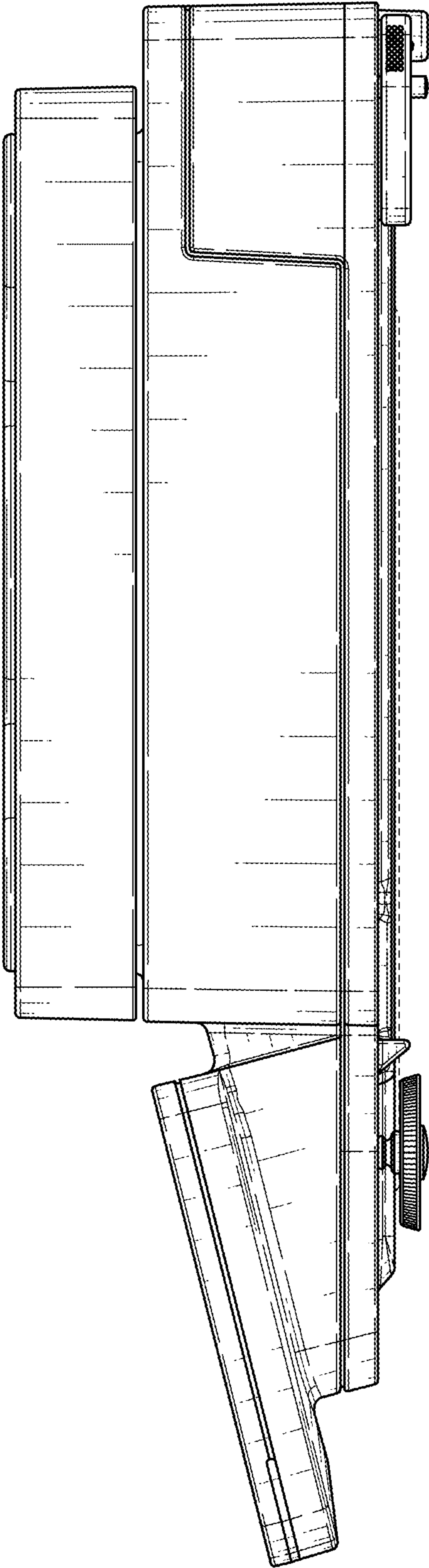

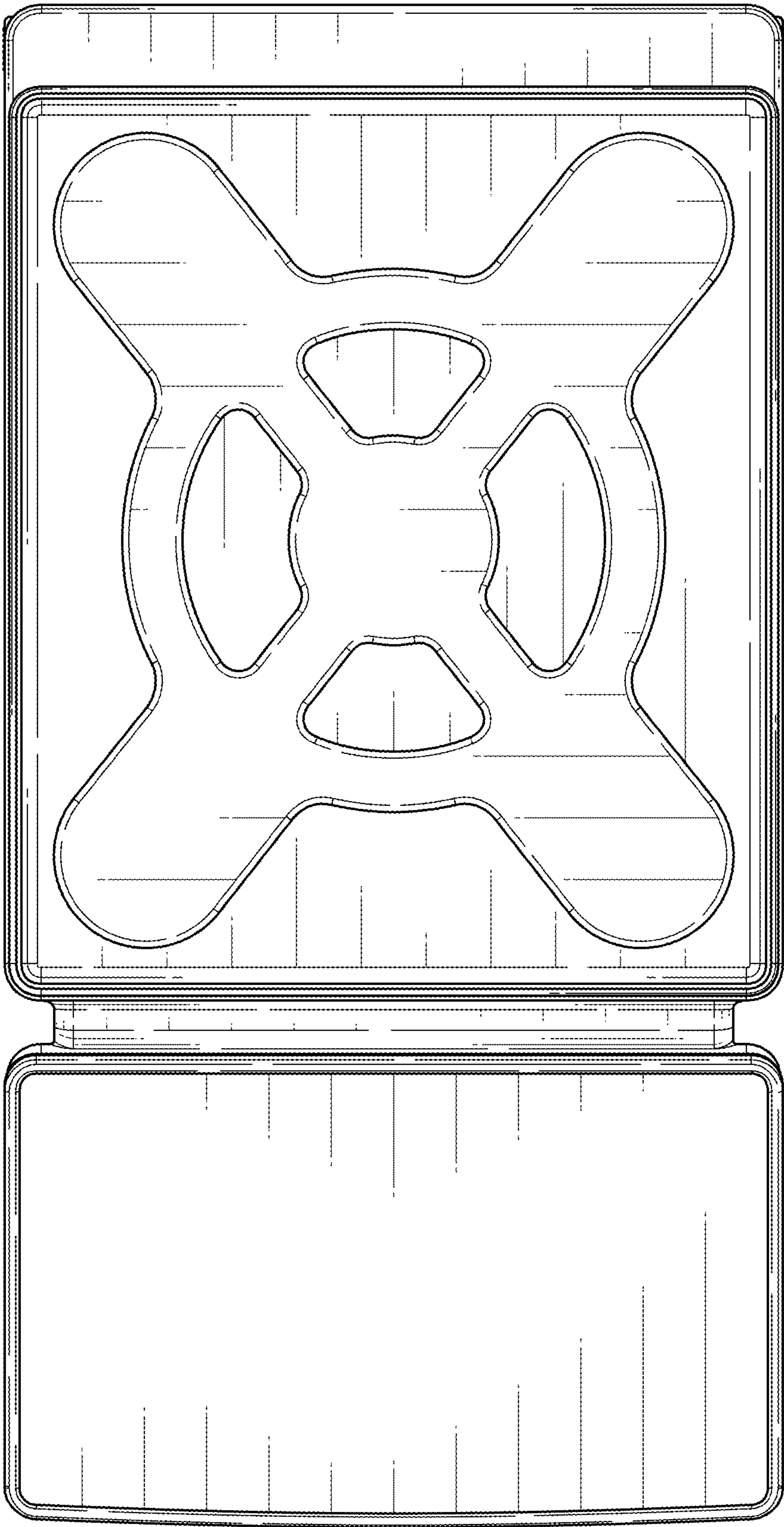
