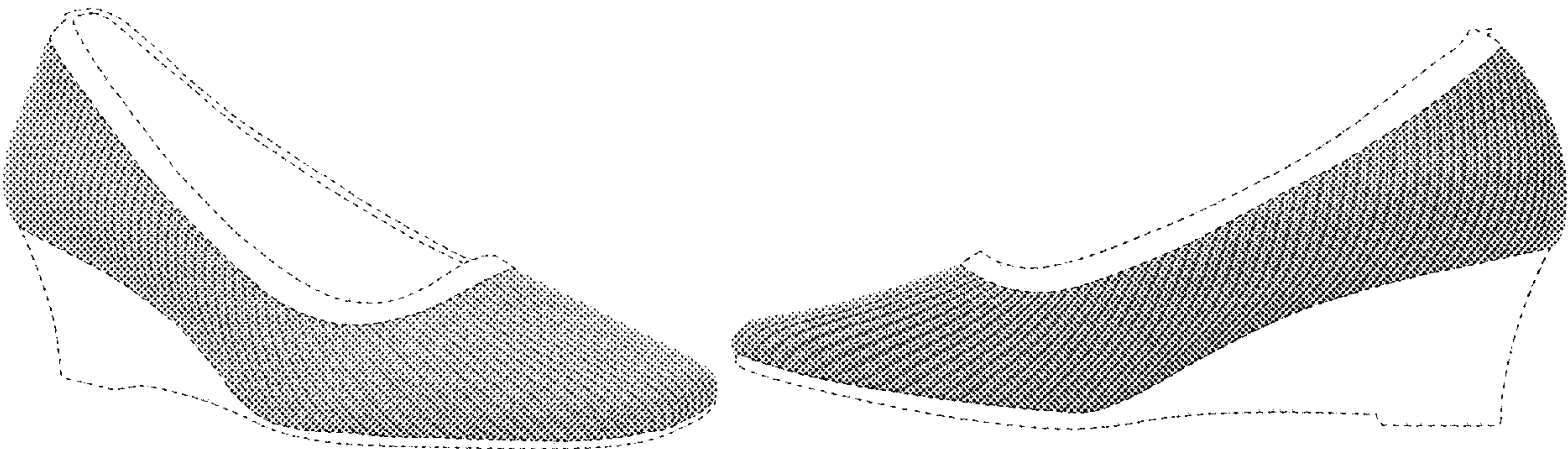
CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a shoe showing my new design;
FIG. 2 is another perspective view thereof;

FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;

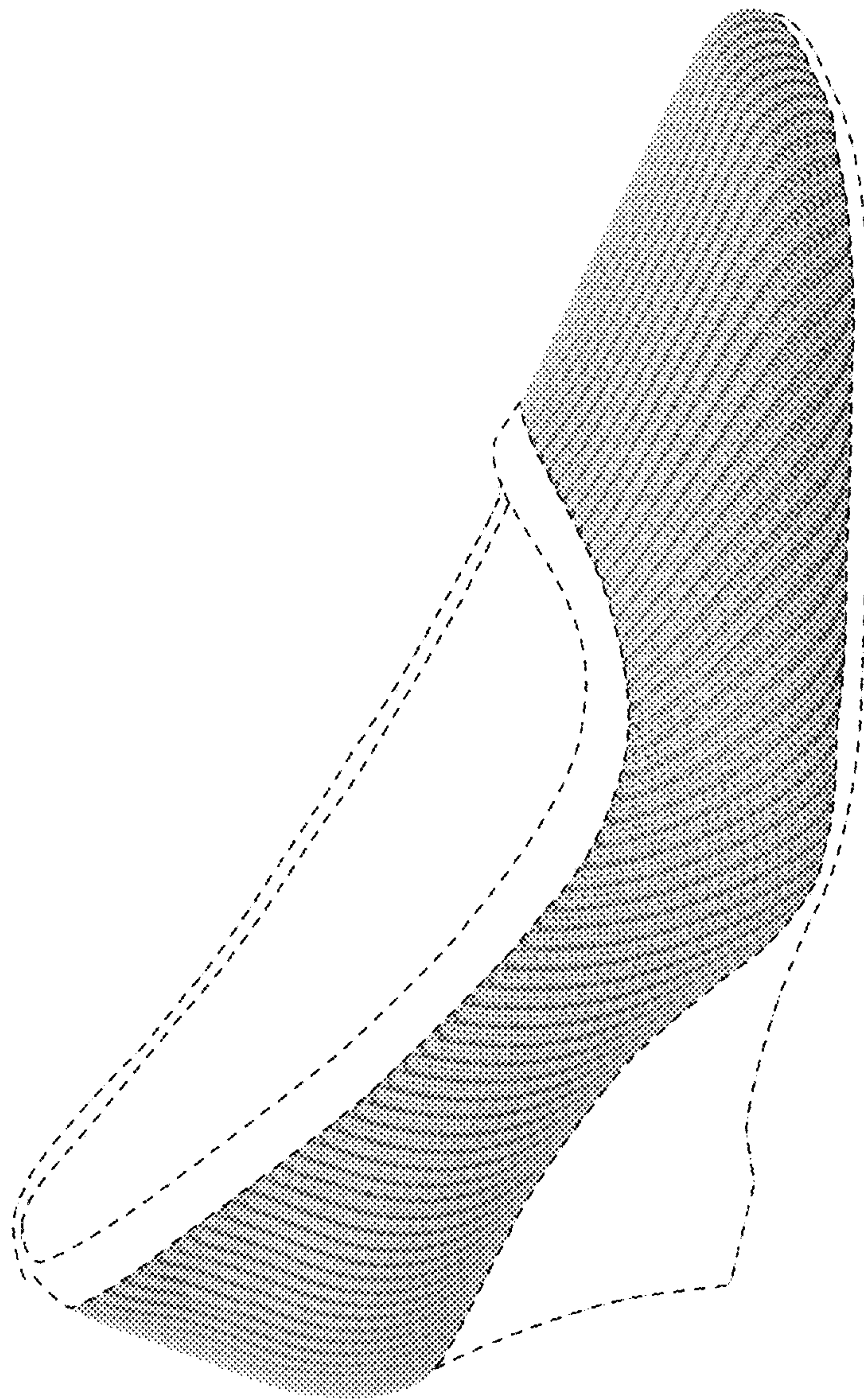

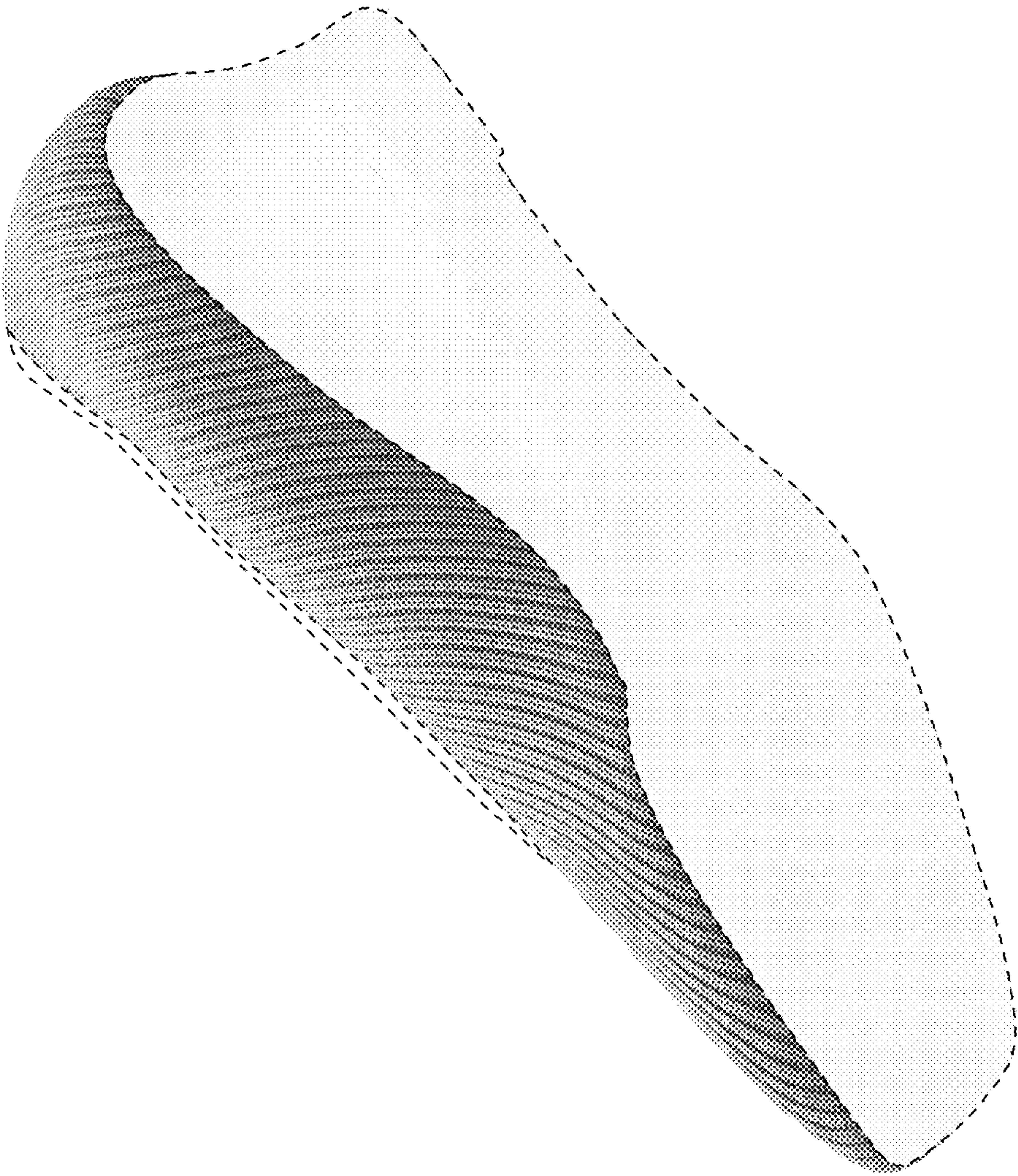

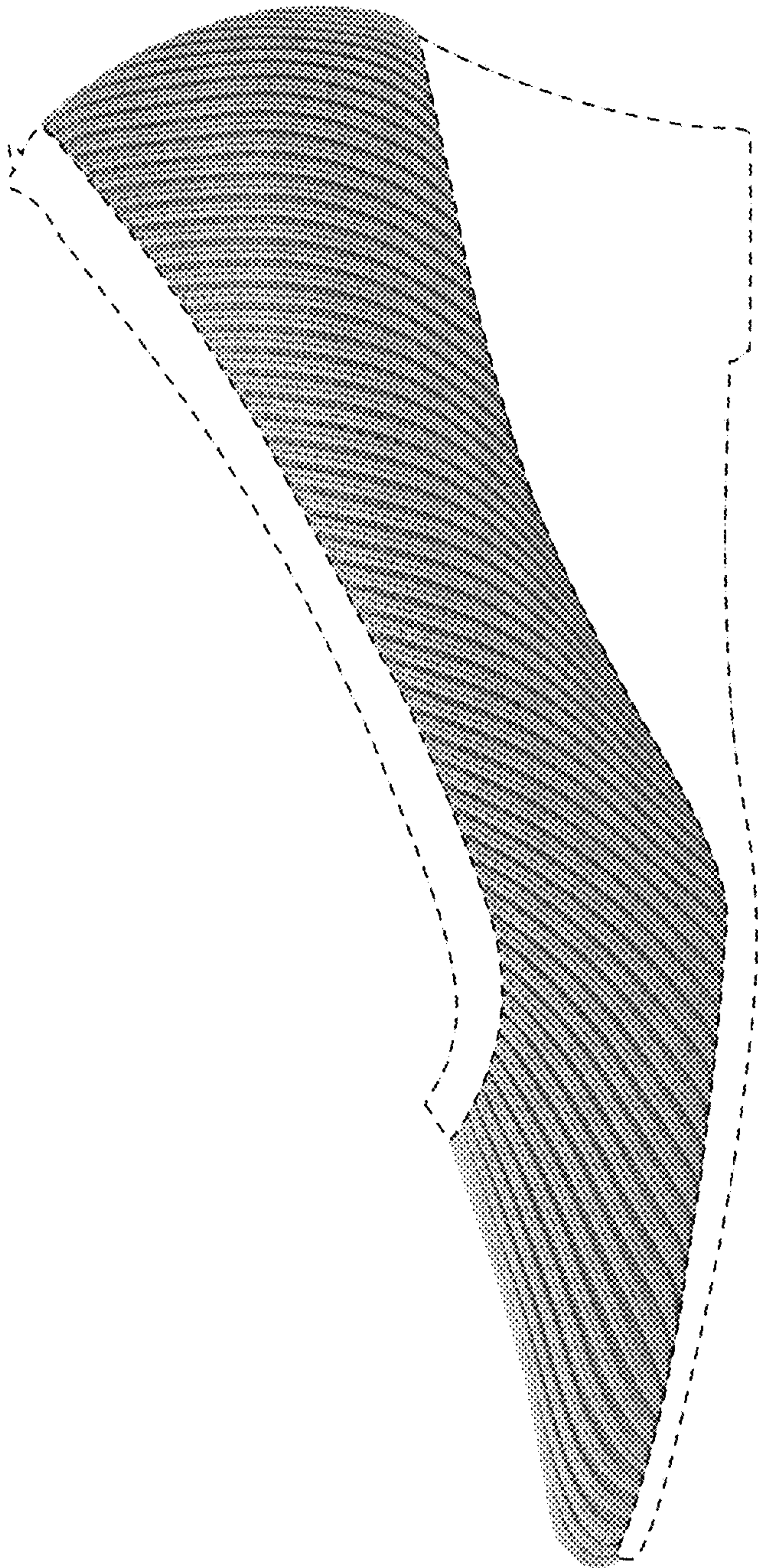

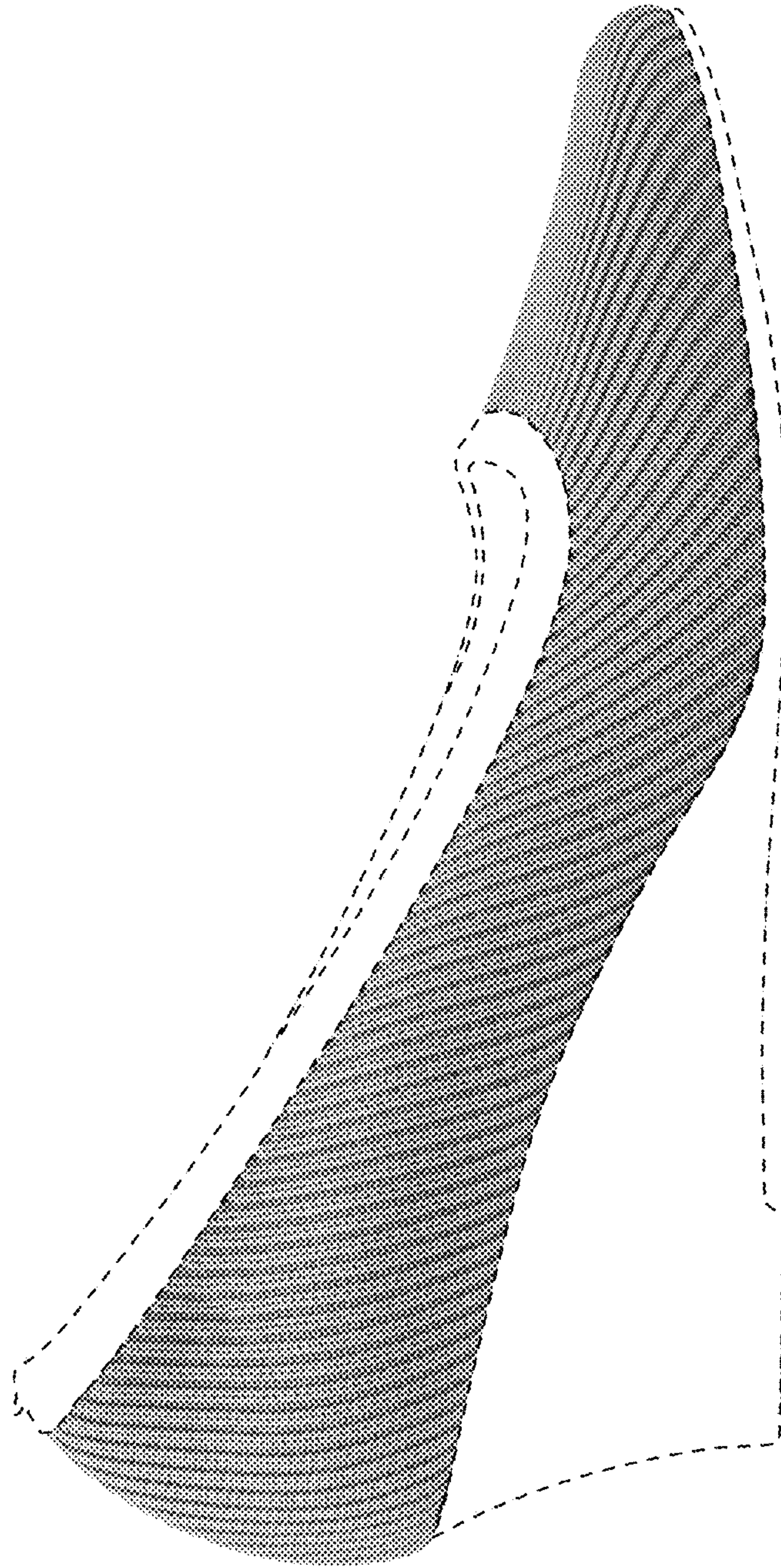

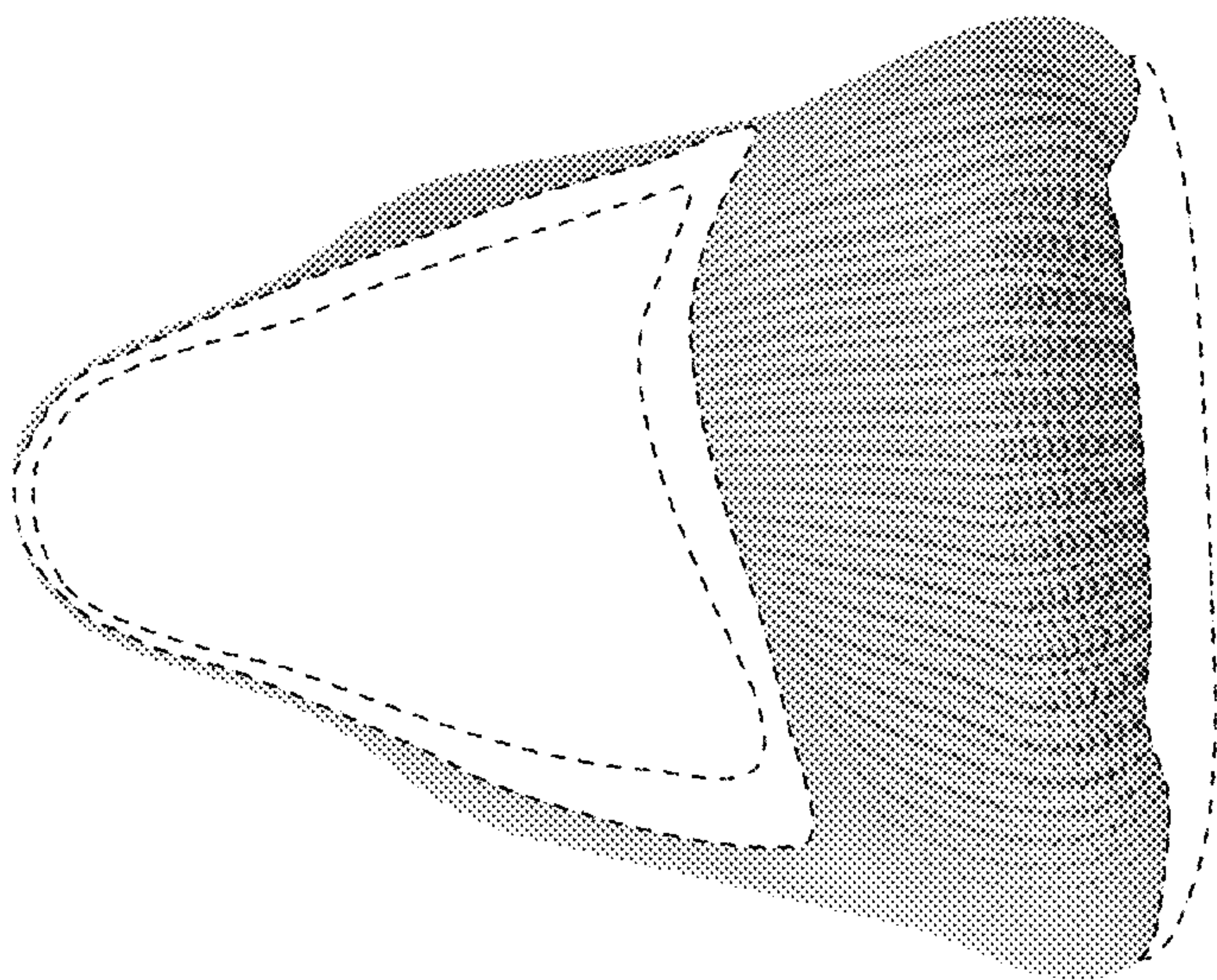

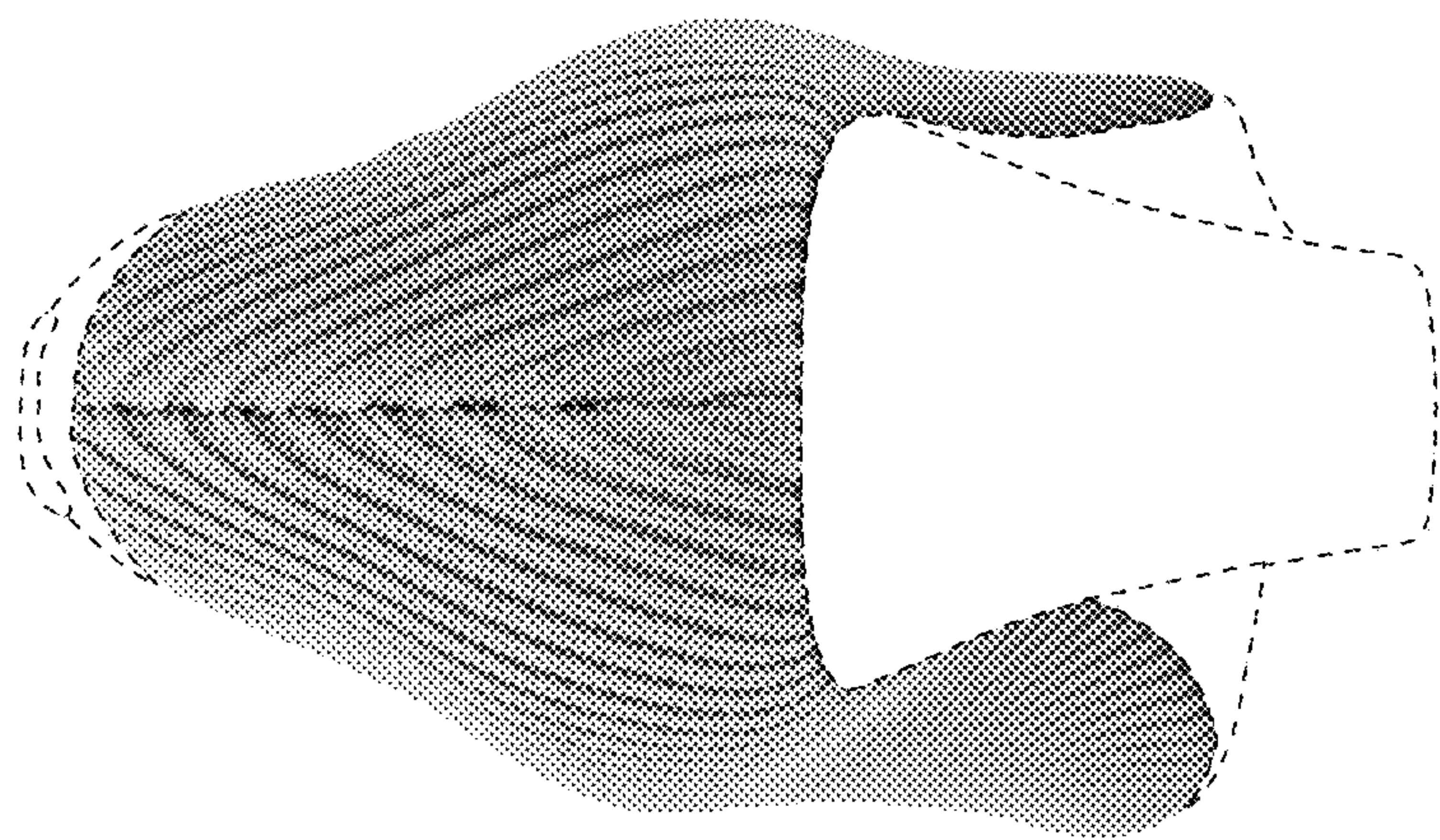

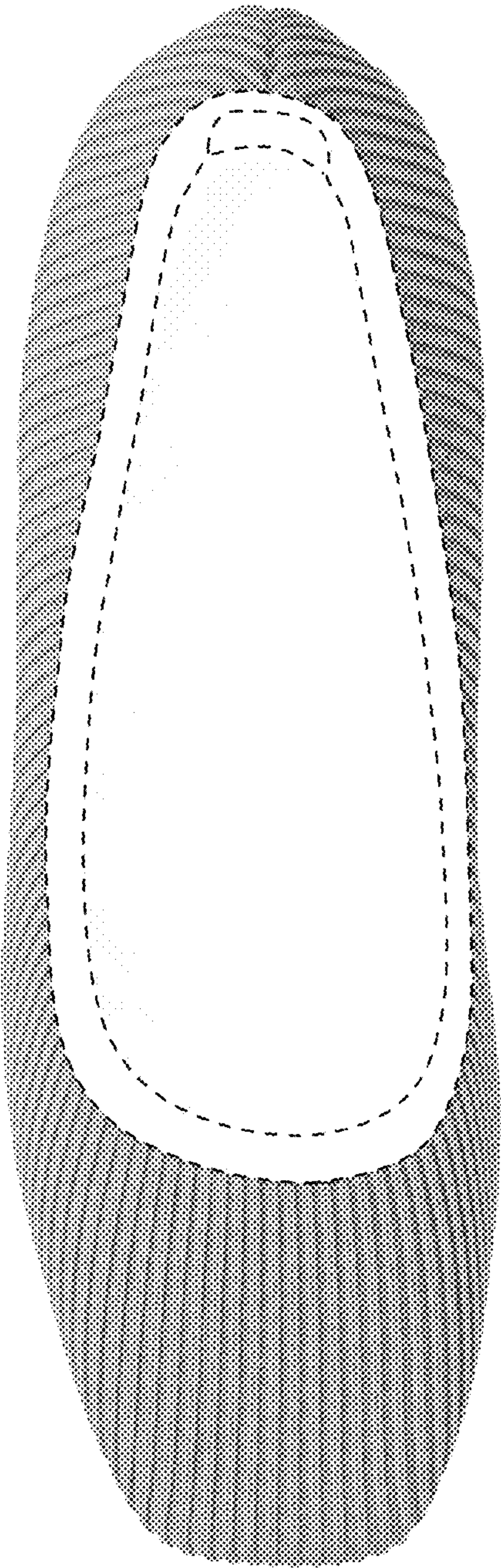

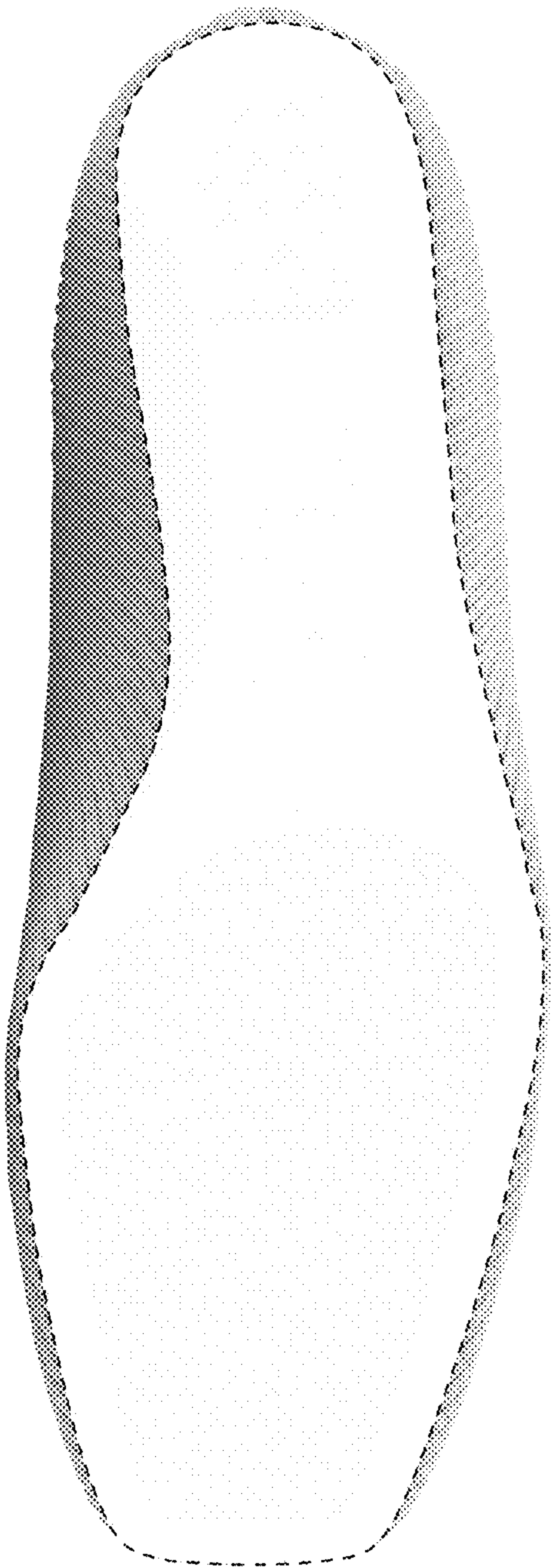
