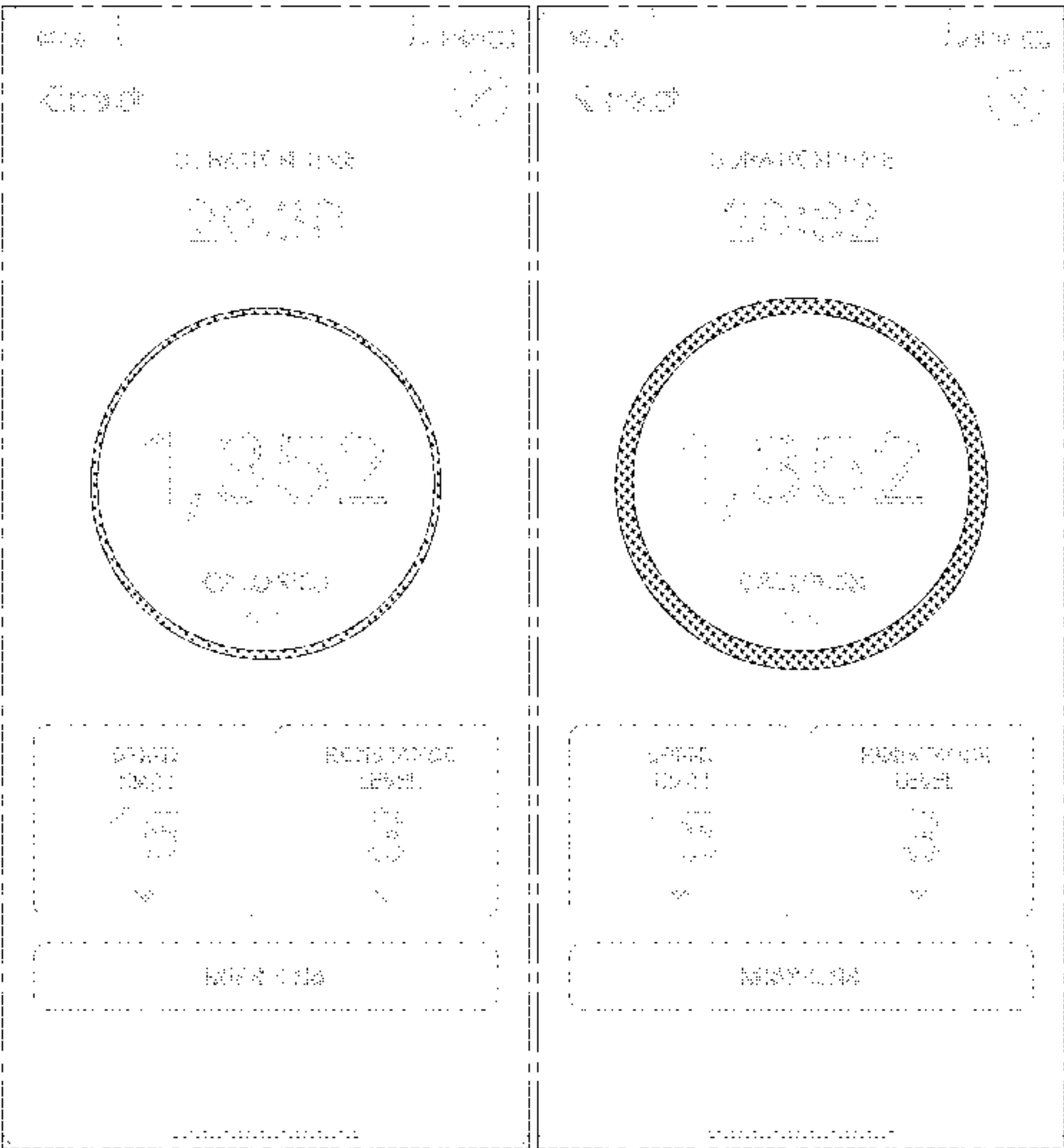
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of a display screen or portion thereof with animated graphical user interface showing our new design;
FIG. 2 is a front view of the second image thereof;
FIG. 3 is a front view of the third image thereof;
FIG. 4 is a front view of the fourth image thereof;
FIG. 5 is a front view of the fifth image thereof;
FIG. 6 is a front view of the sixth image thereof;

FIG. 9 is a front view of the ninth image thereof.
The appearance of the image transitions sequentially between the images shown in FIG. 1-9 of the display screen or portion thereof with animated graphical user interface. The dot-dash broken line illustrates a display screen or portion thereof and forms no part of the claimed design. The even-dash broken lines illustrate portions of the animated graphical user interface that form no part of the claimed design. The shading depicts a contrast in appearance.

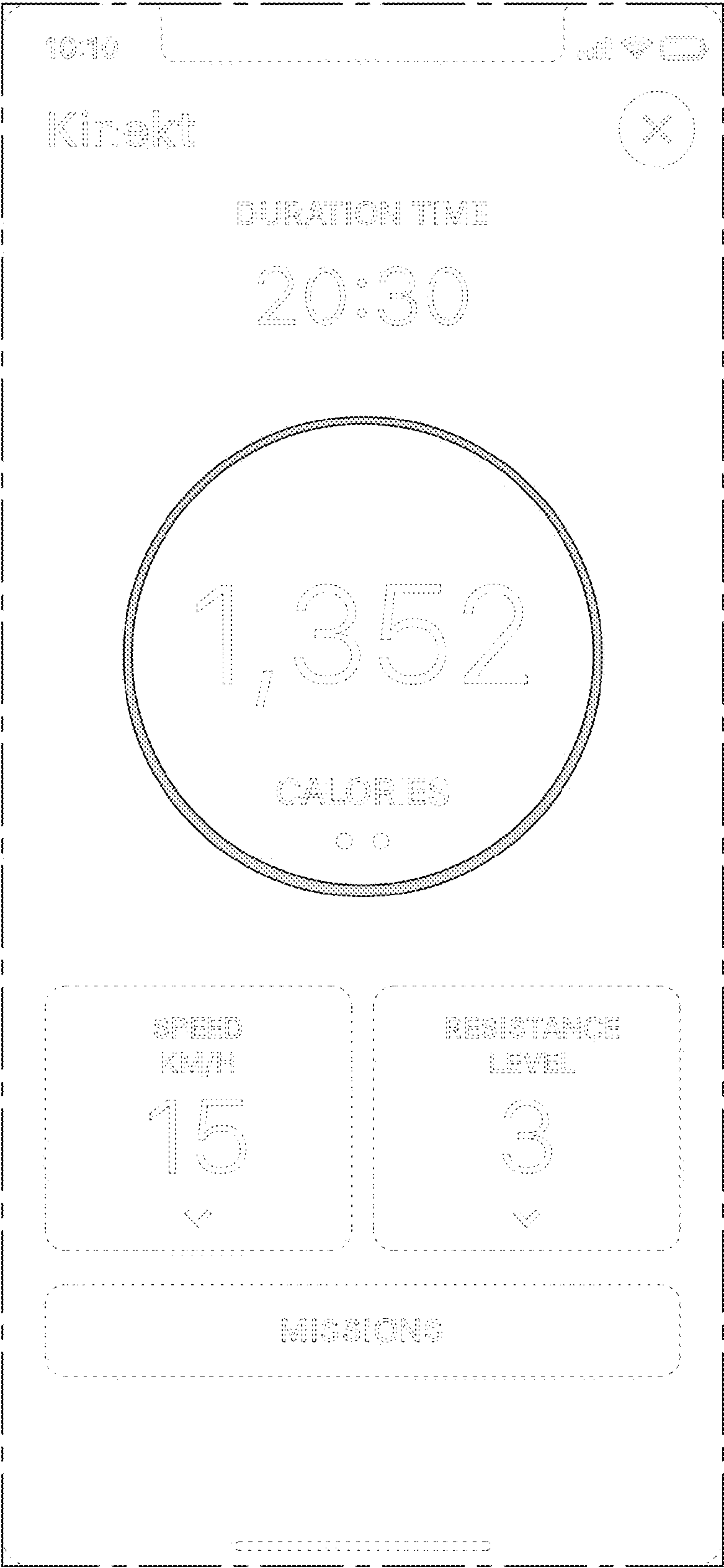

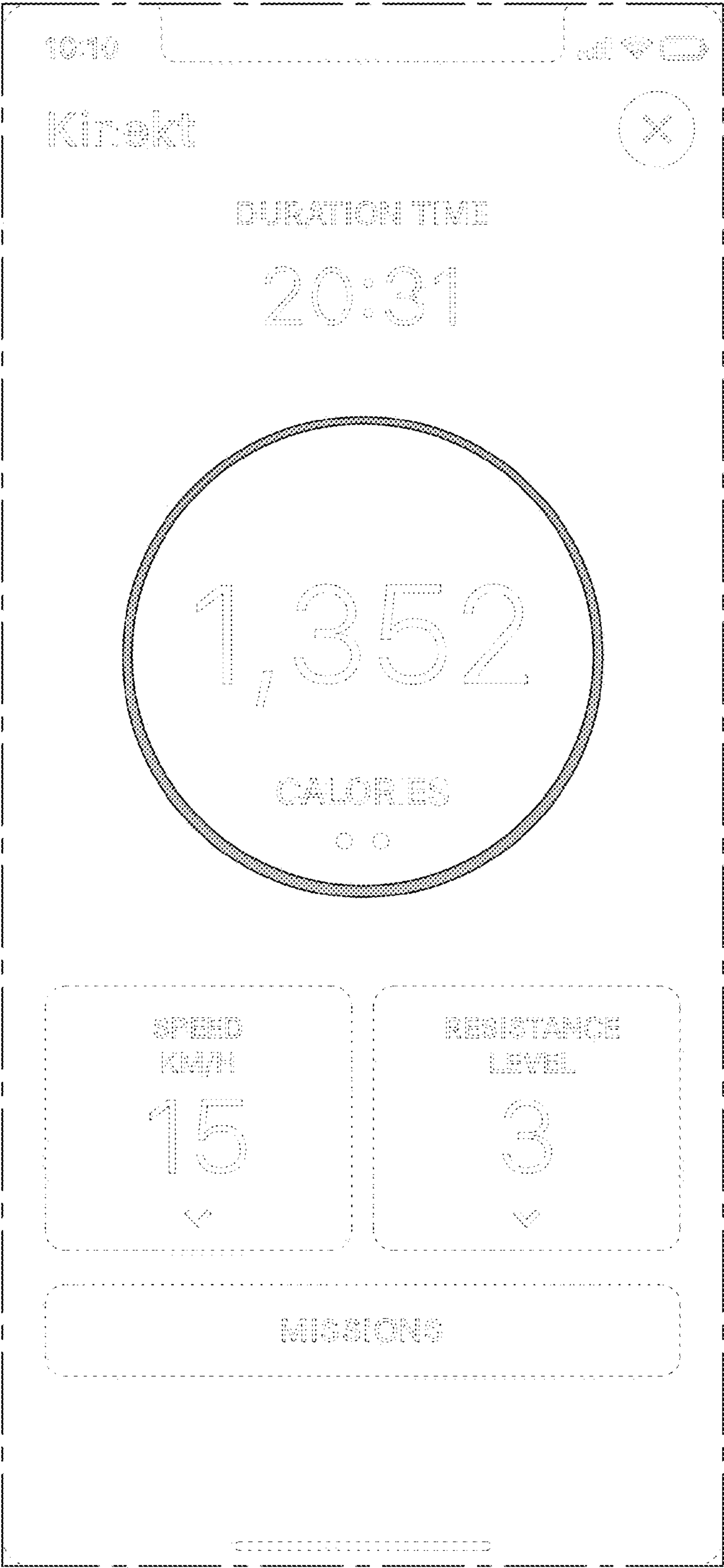

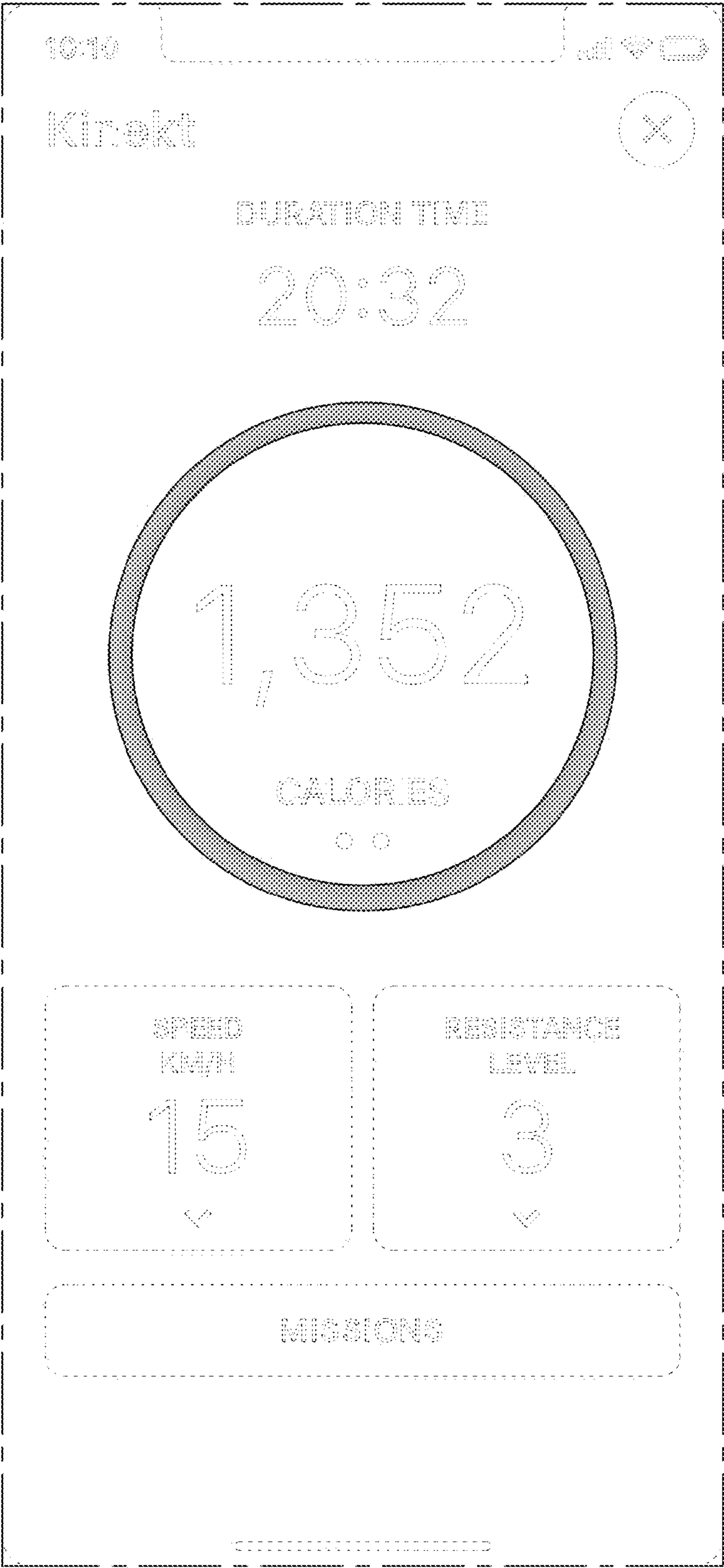

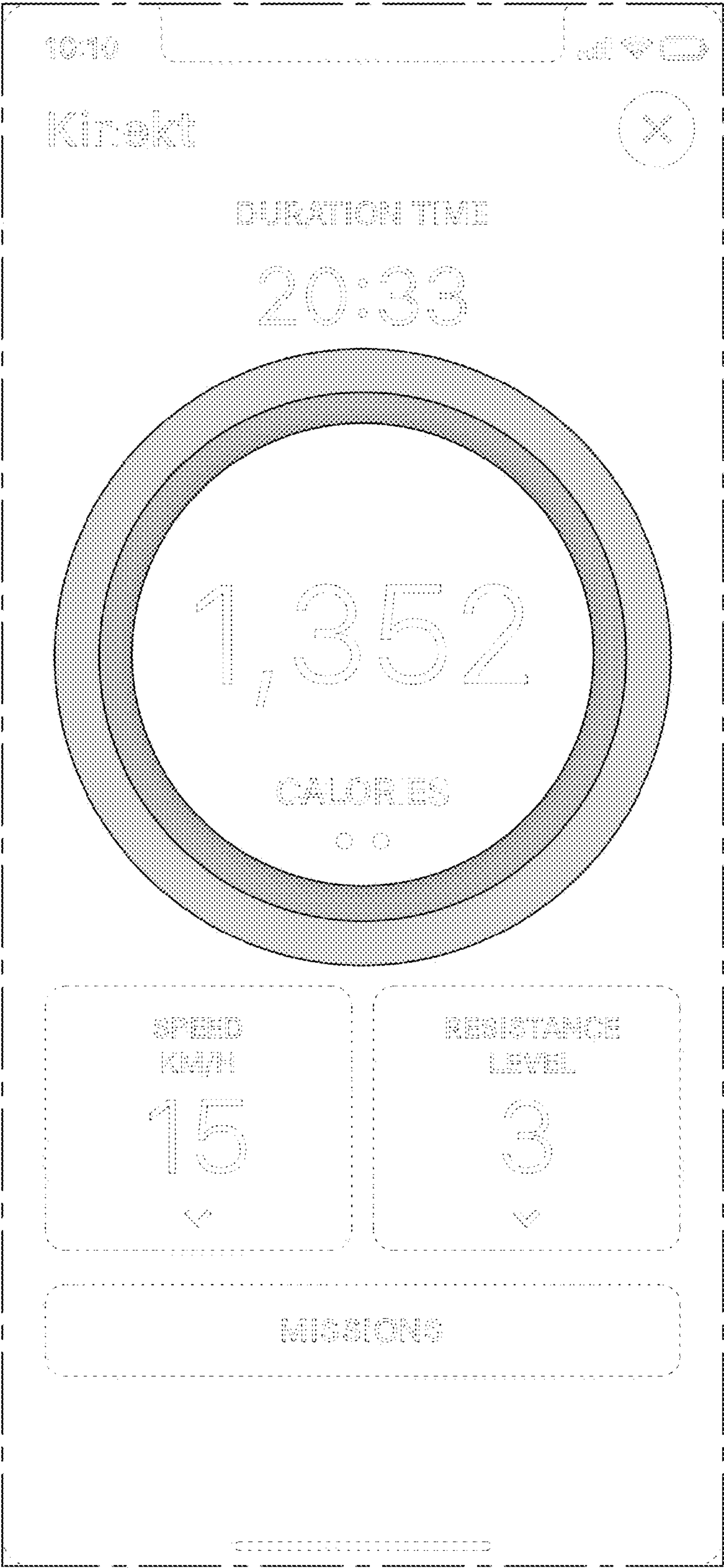

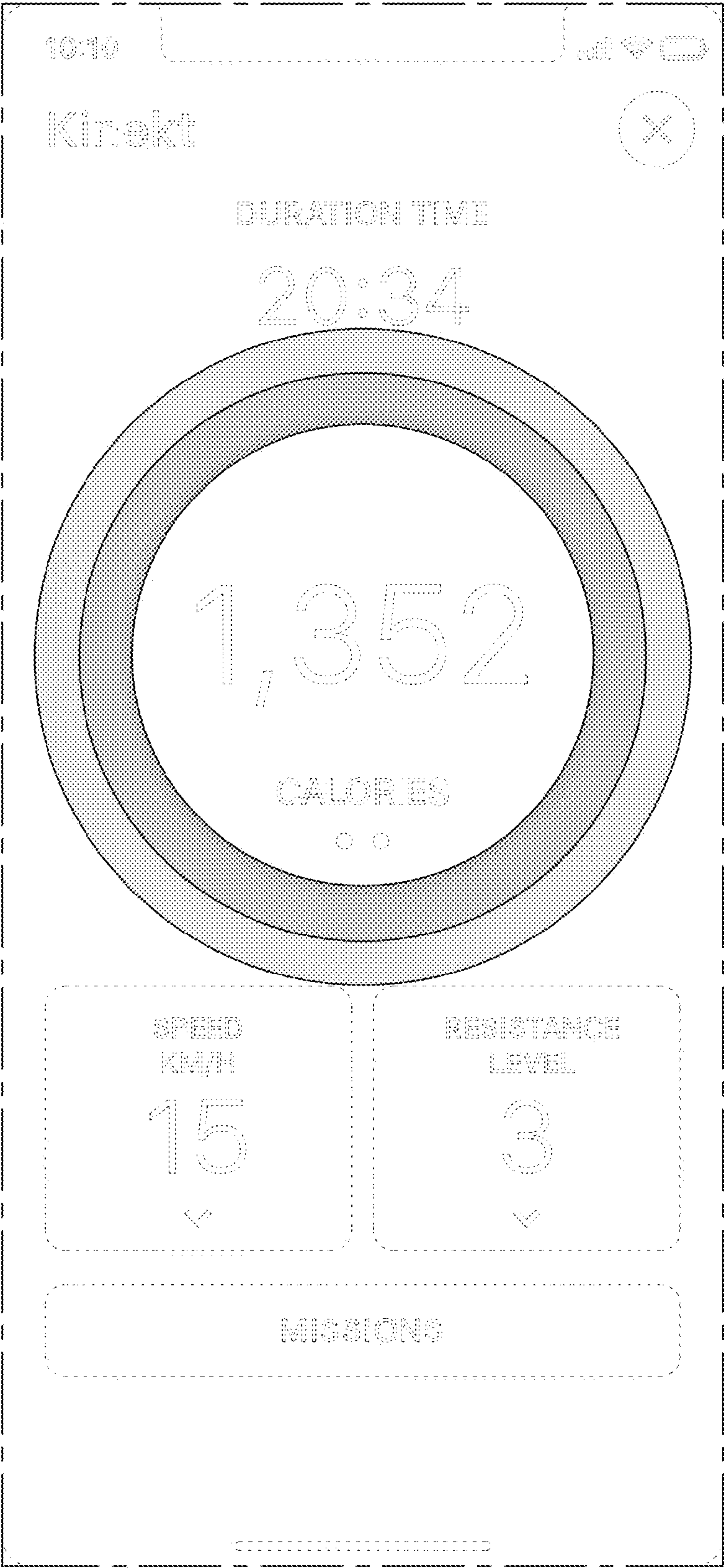

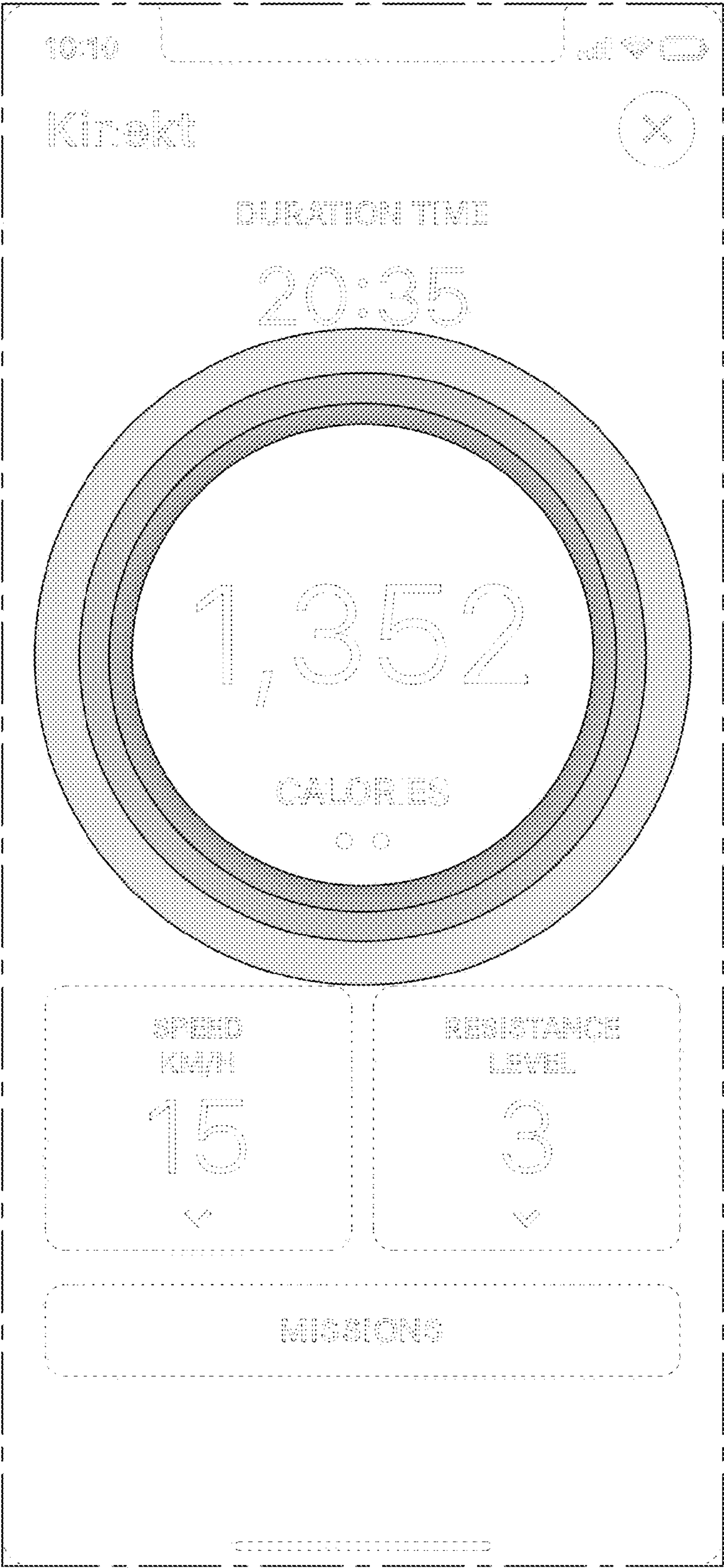

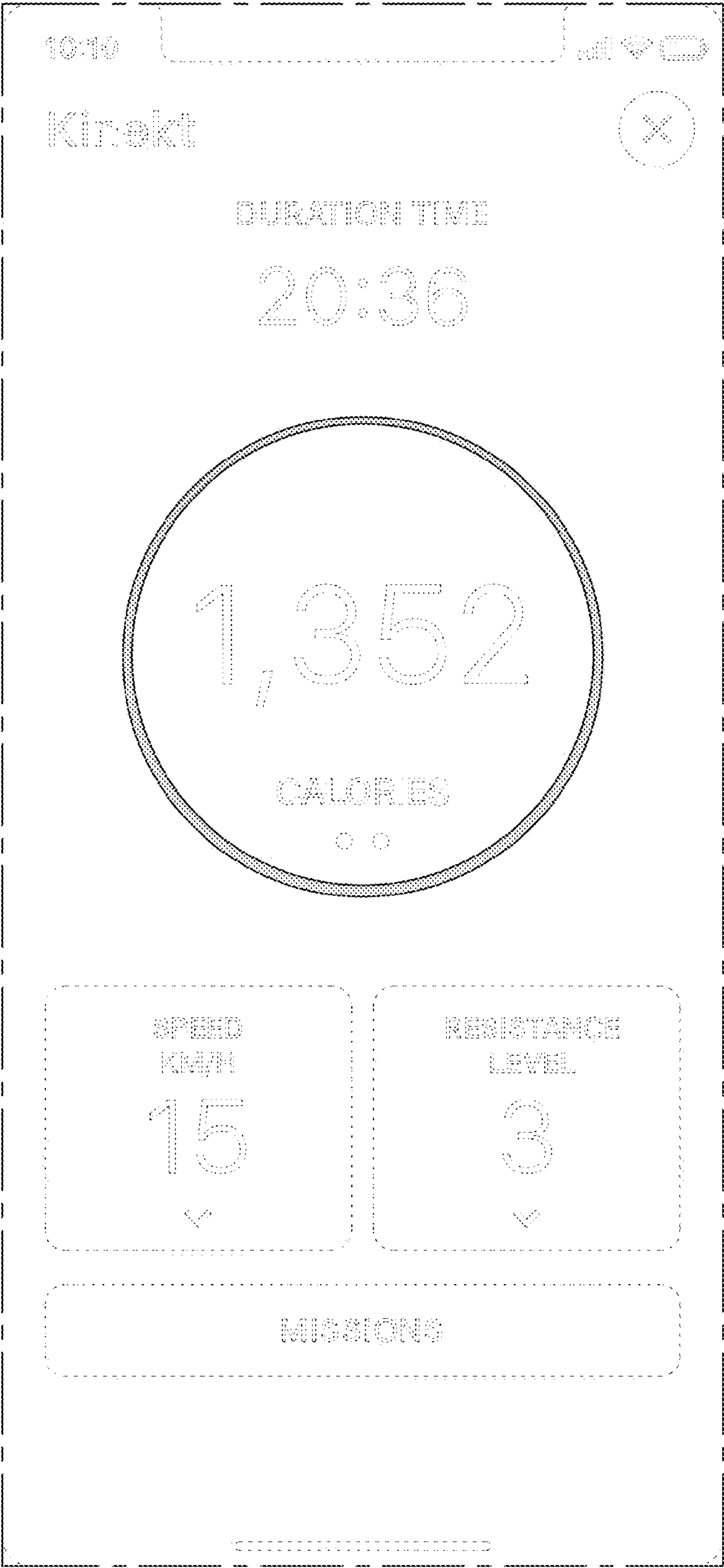

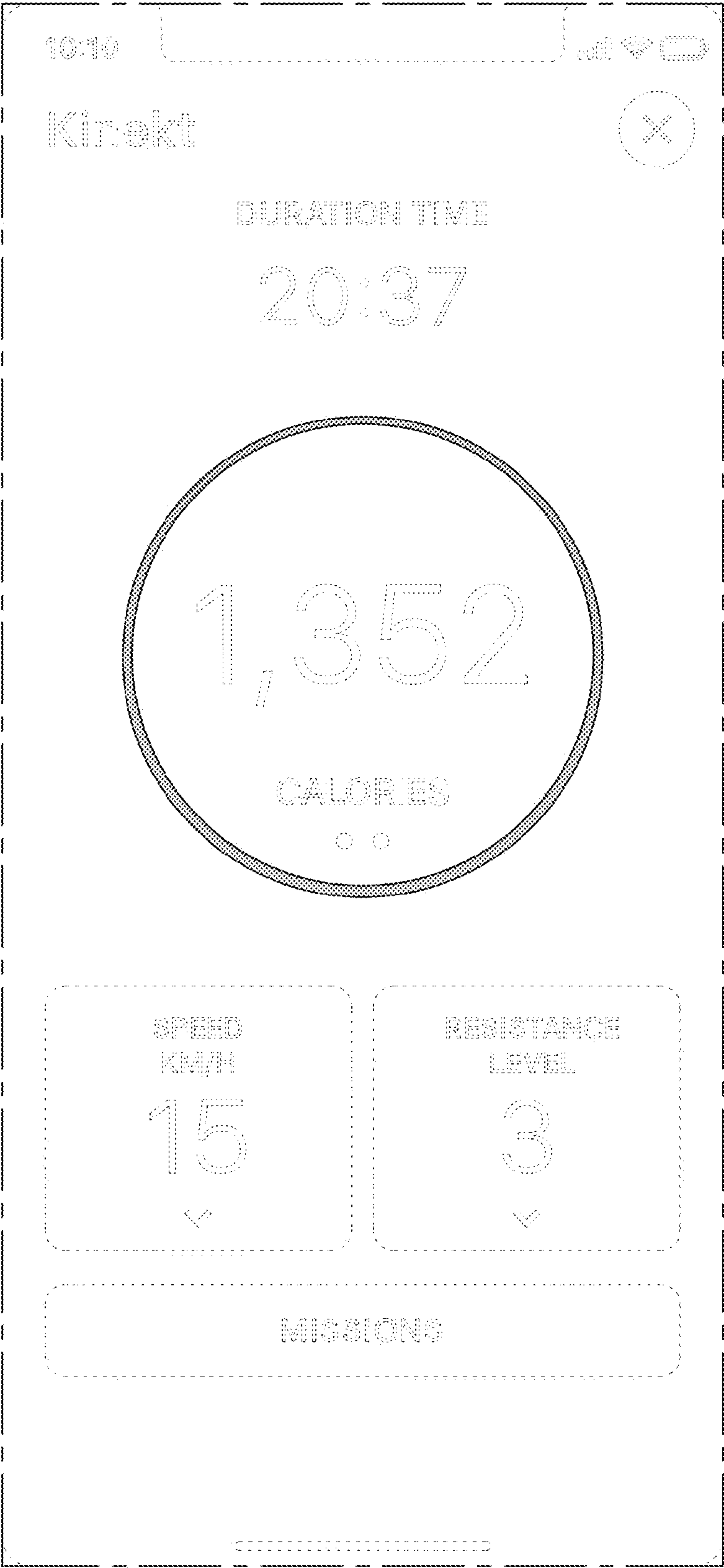

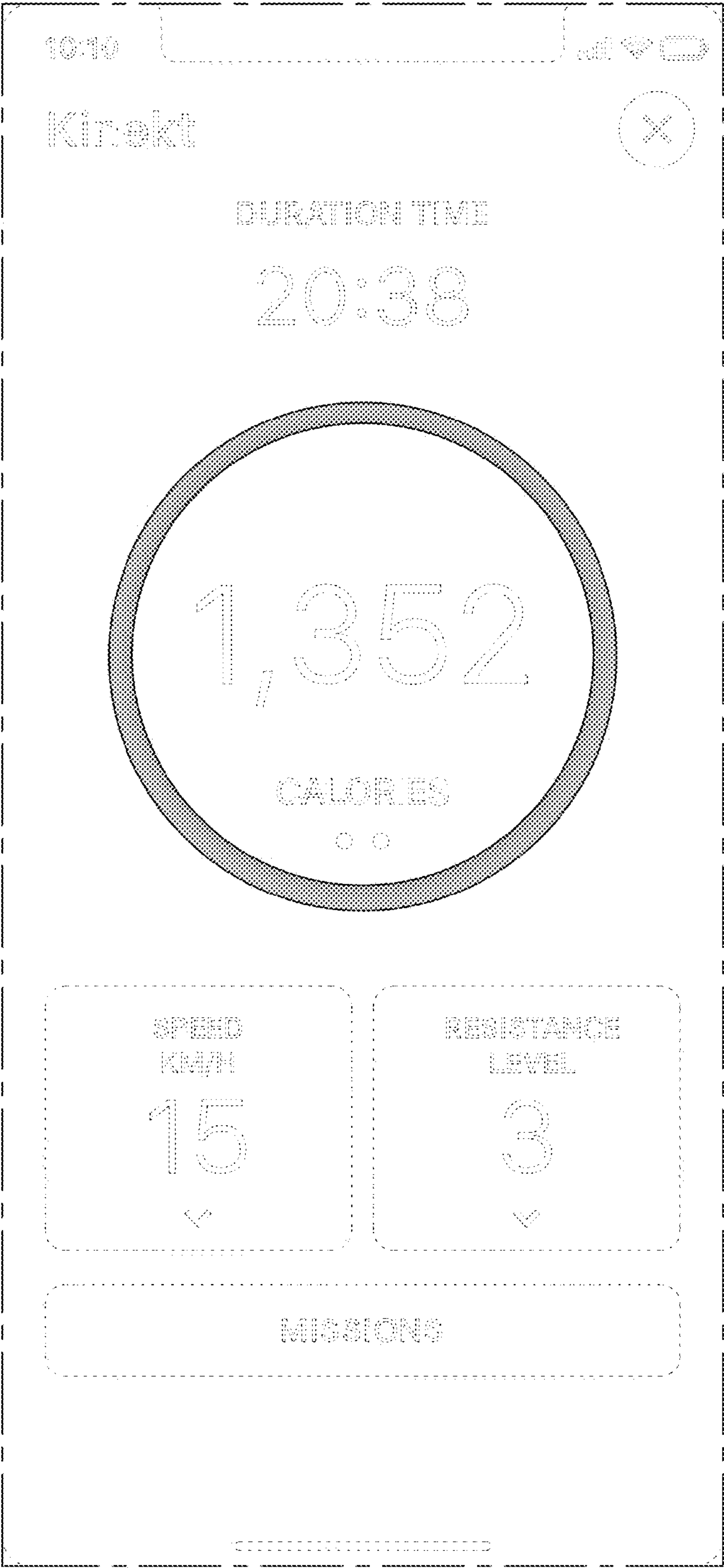
