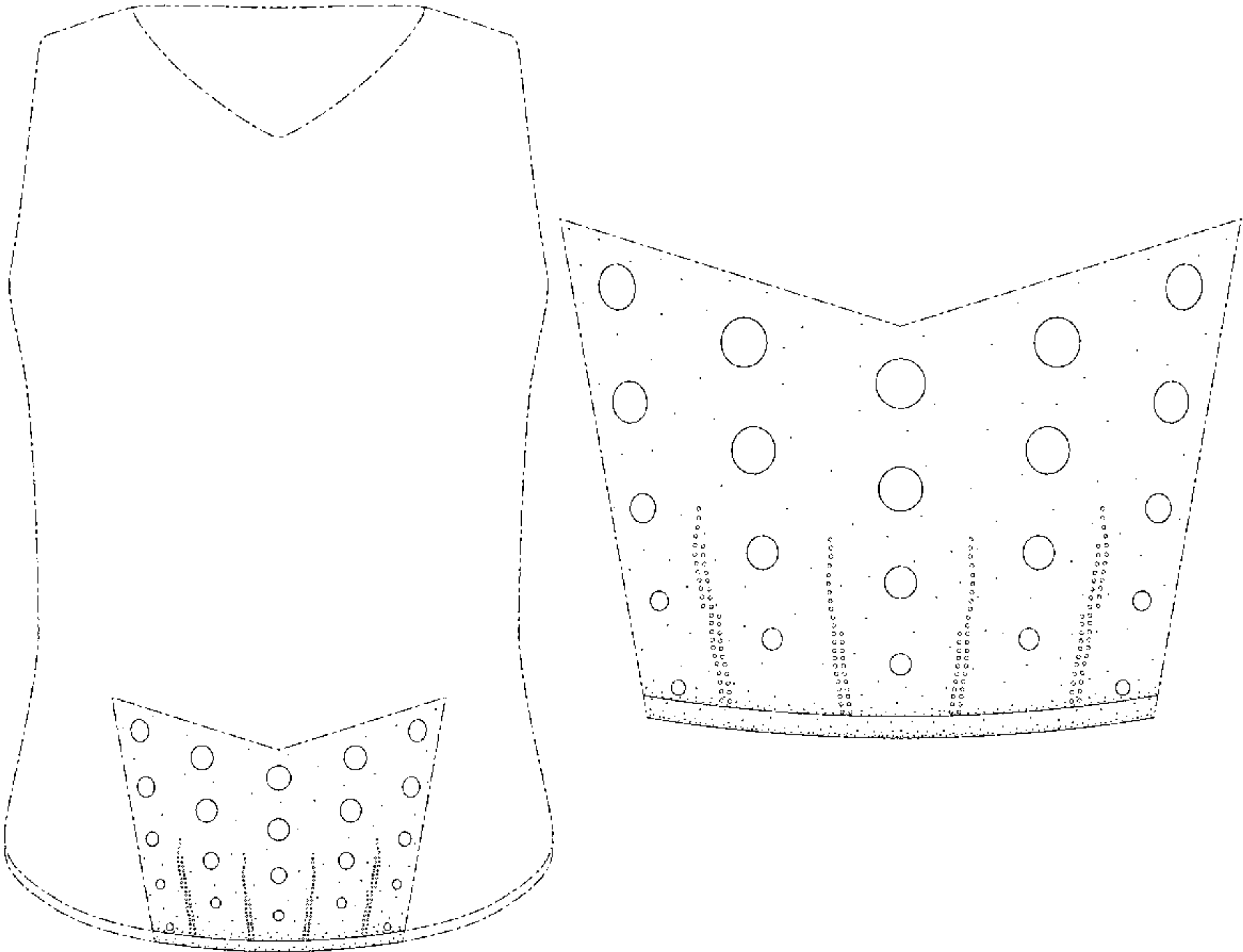
(57) **CLAIM**

The ornamental design for a shirt as shown and described.

DESCRIPTION

FIG. 1 is a front view of a shirt showing our new design; FIG. 2 is a right side front perspective view thereof; FIG. 3 is a left side front perspective view thereof; FIG. 4 is an enlarged view of the claim as shown in FIG. 1 with environment removed for clarity purposes; FIG. 5 is a front view of a shirt showing our new design in an alternate embodiment; FIG. 6 is a right side front perspective view thereof; FIG. 7 is a left side front perspective view thereof; and, FIG. 8 is an enlarged view of the claim as shown in FIG. 5 with environment removed for clarity purposes. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shirt form no part of the claimed design.

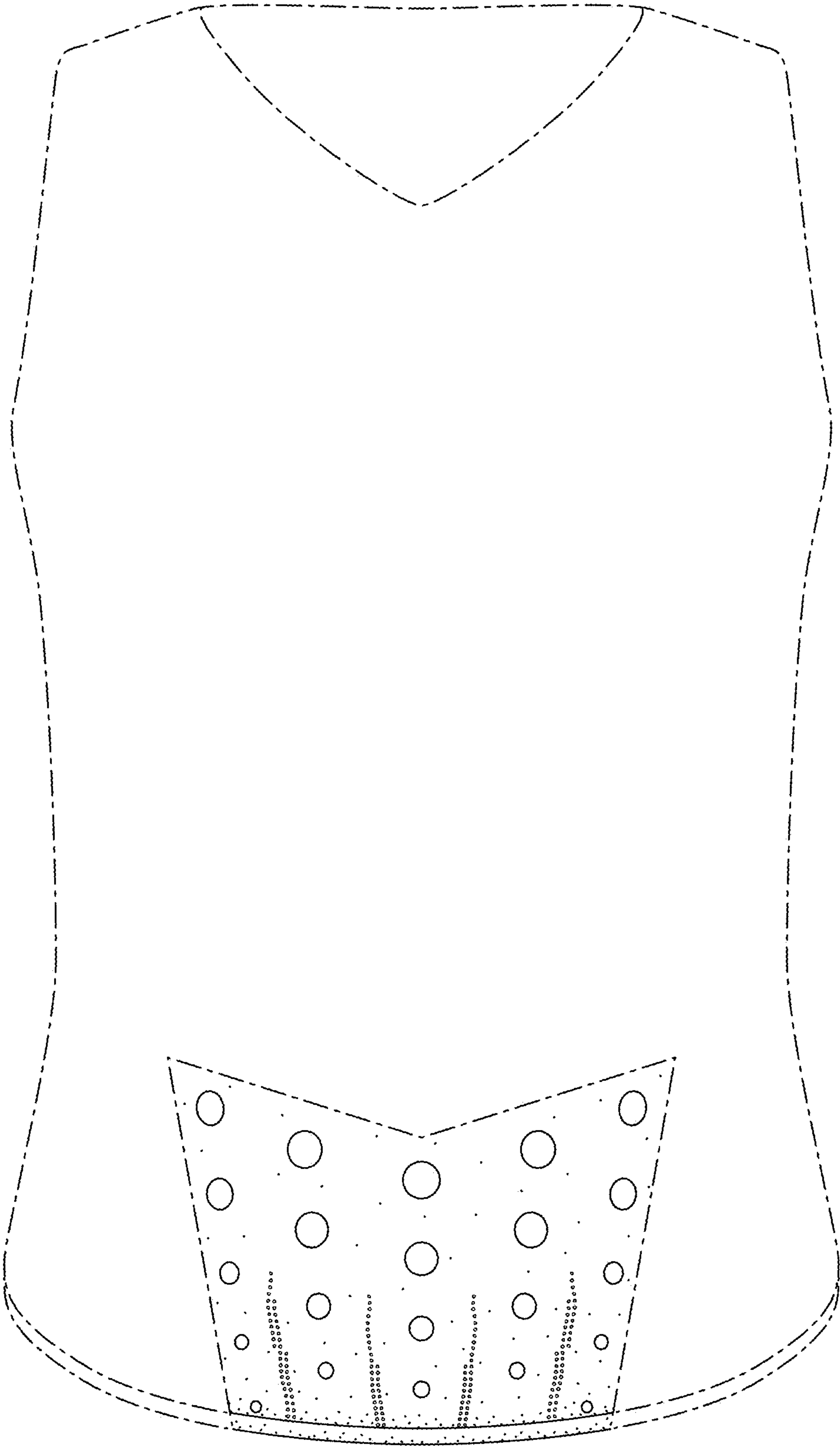

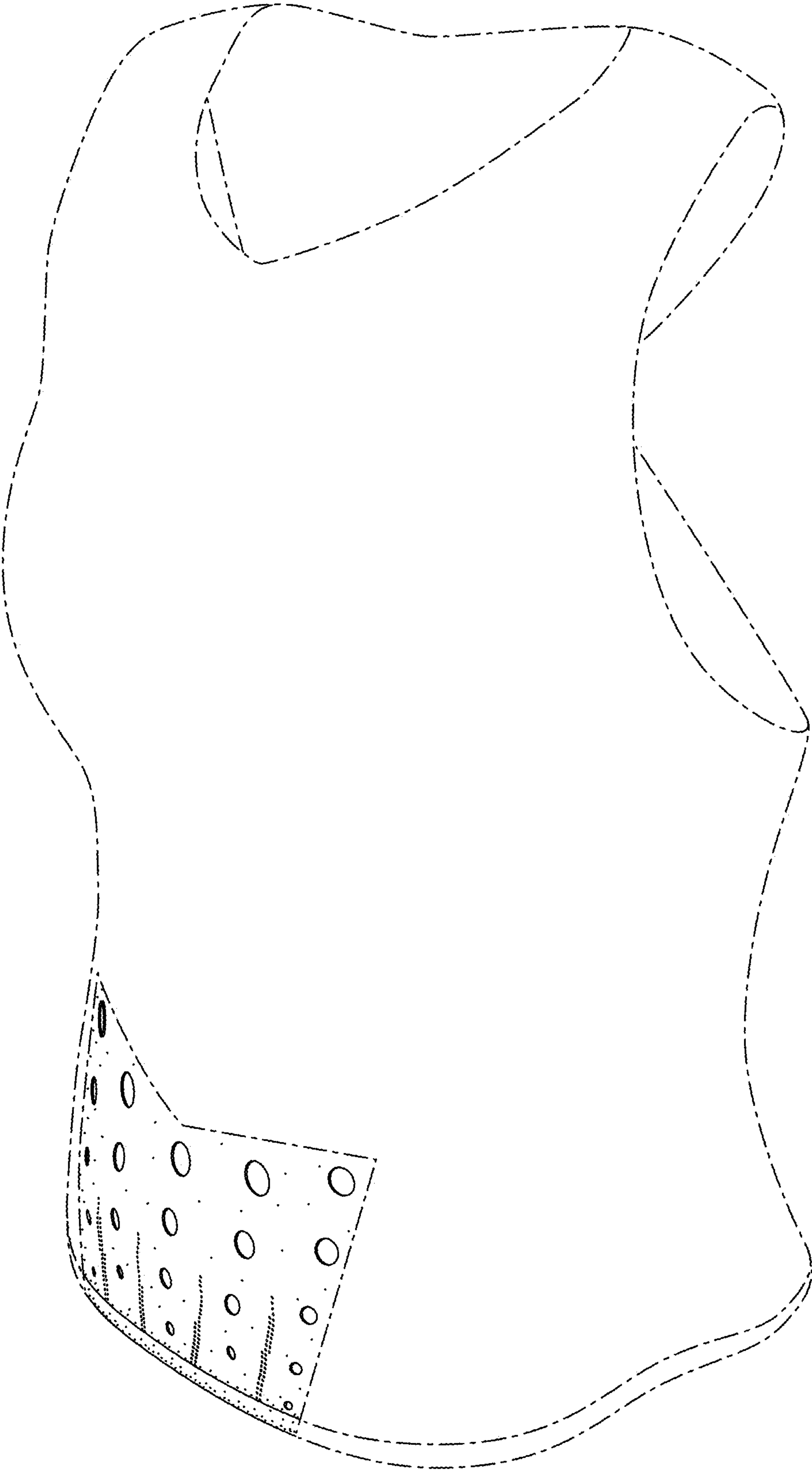

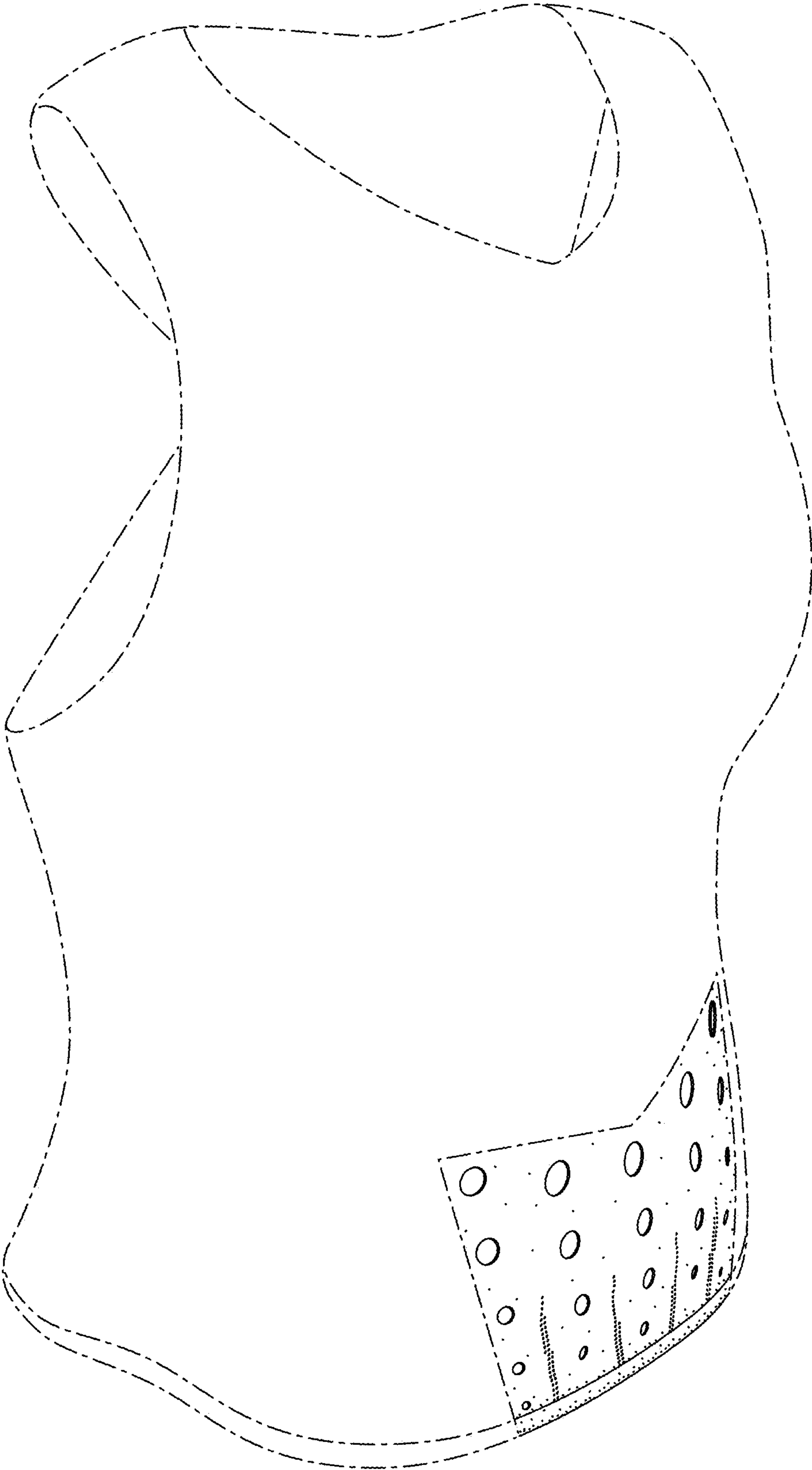

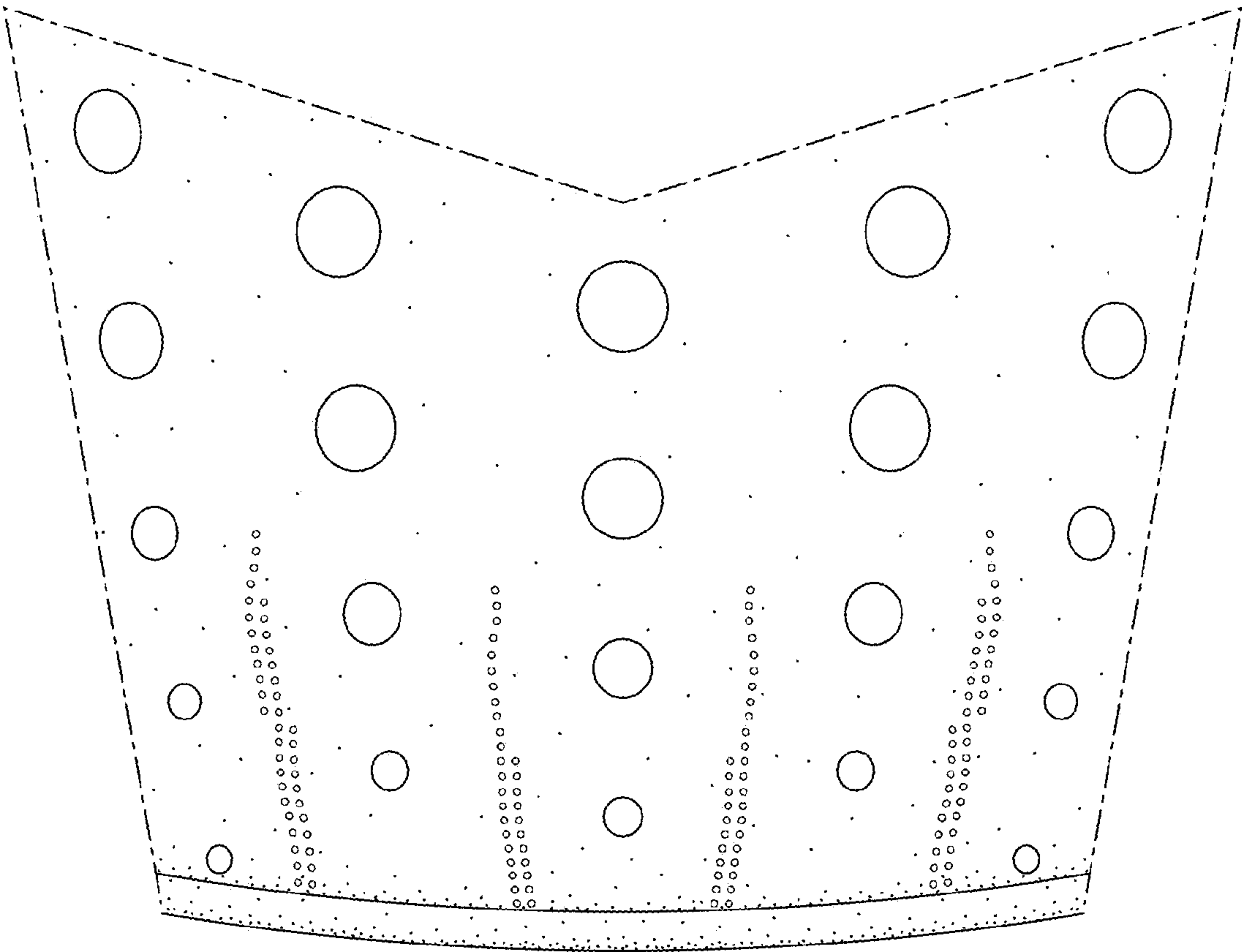

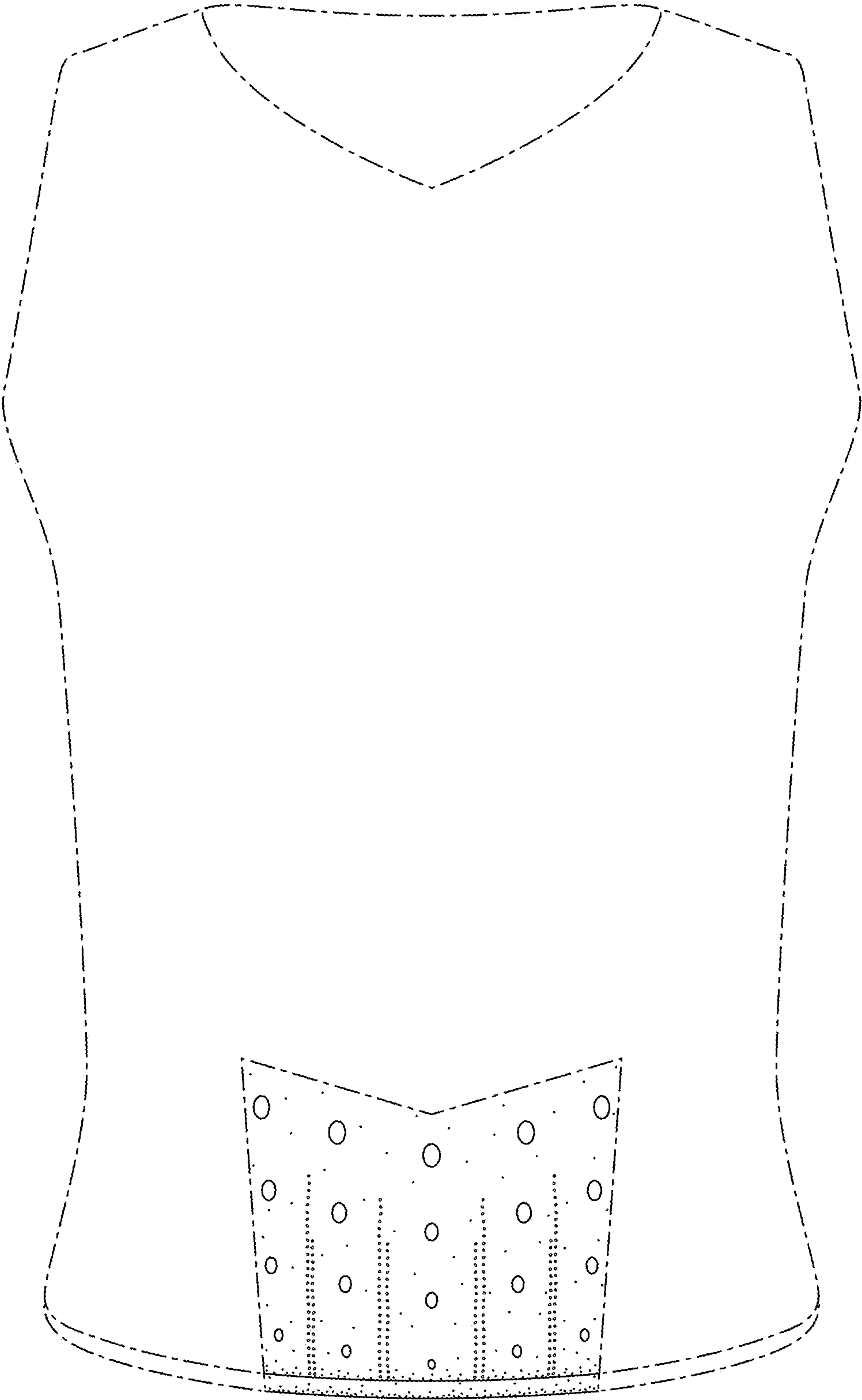

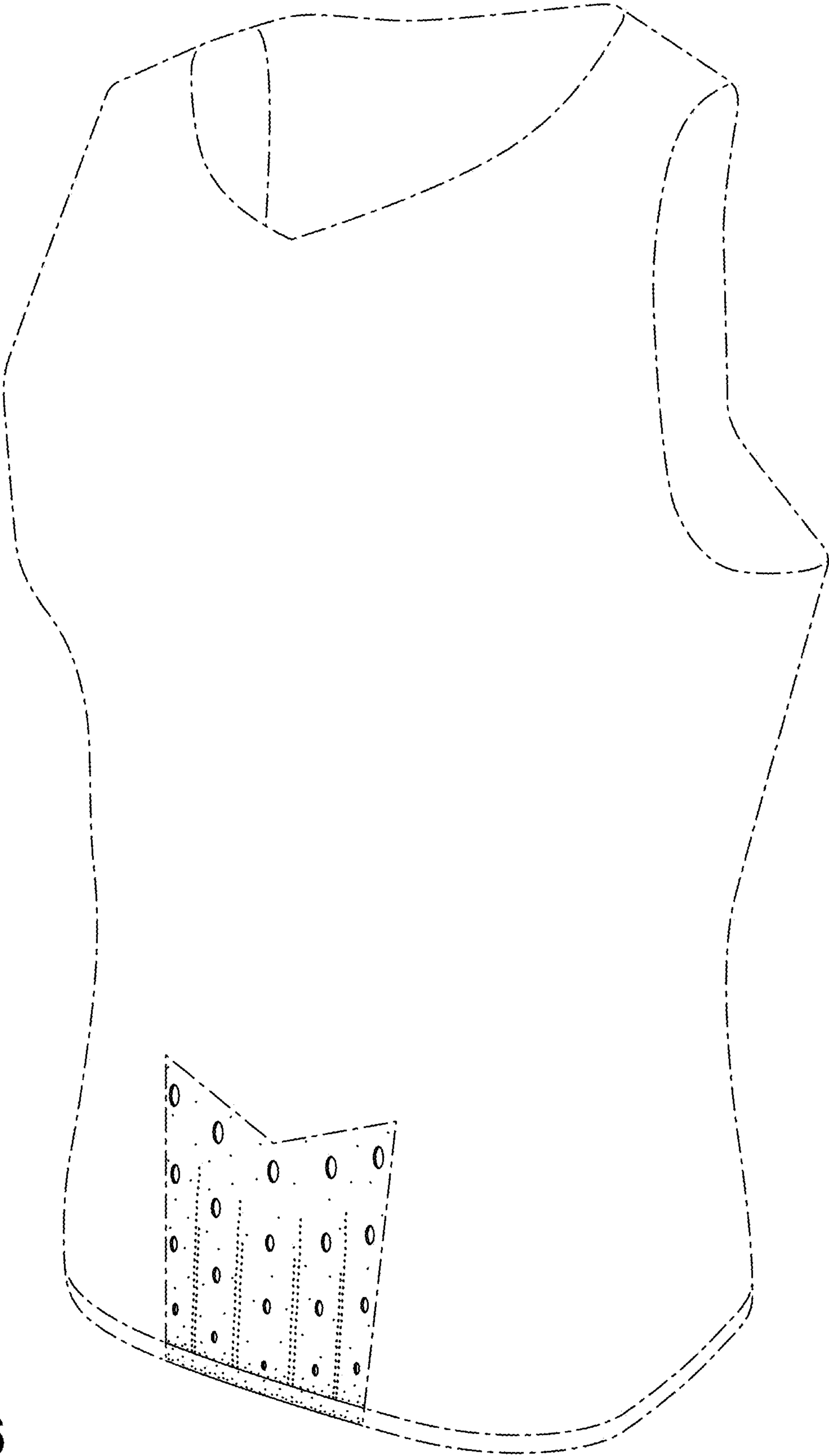

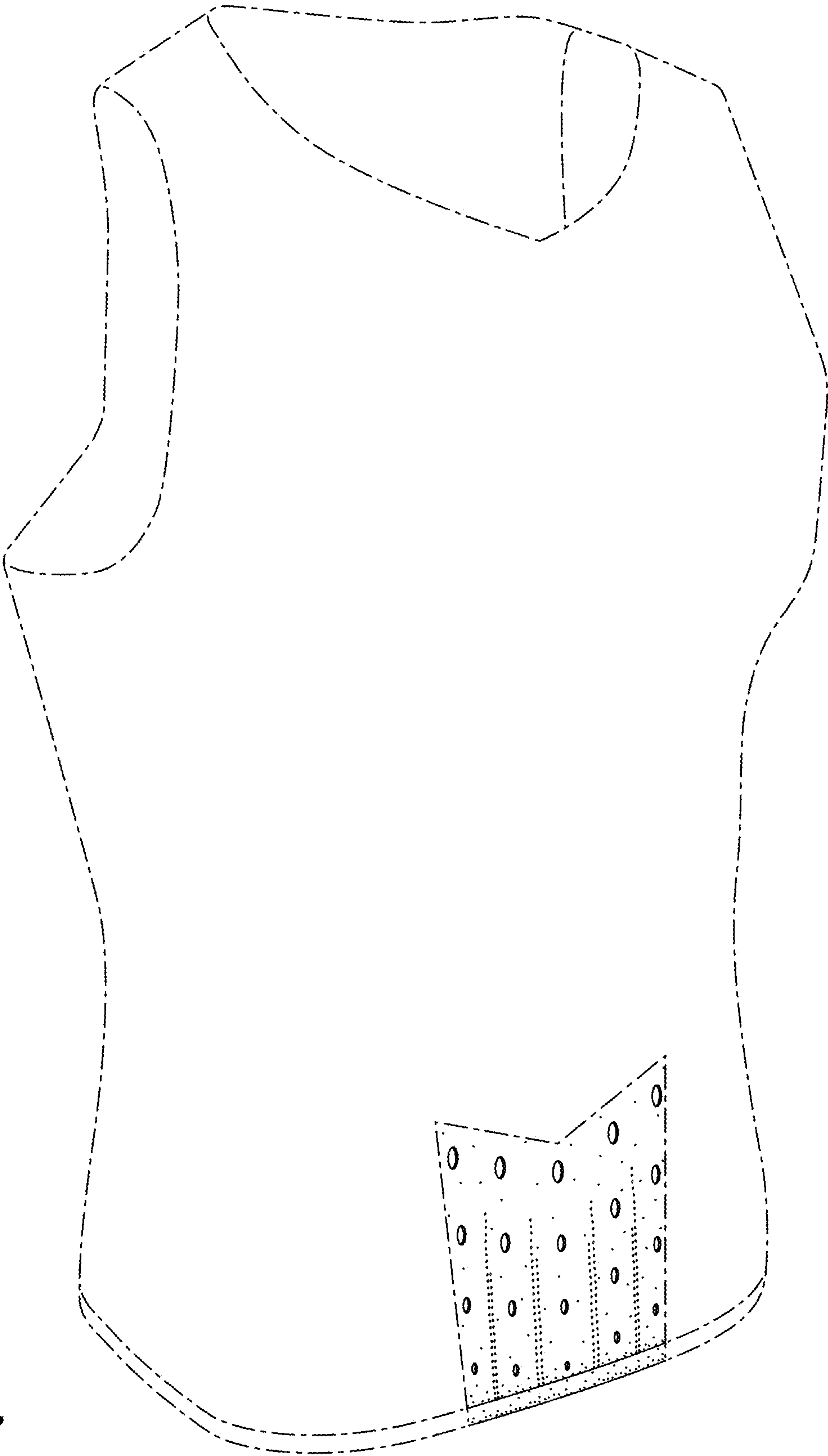

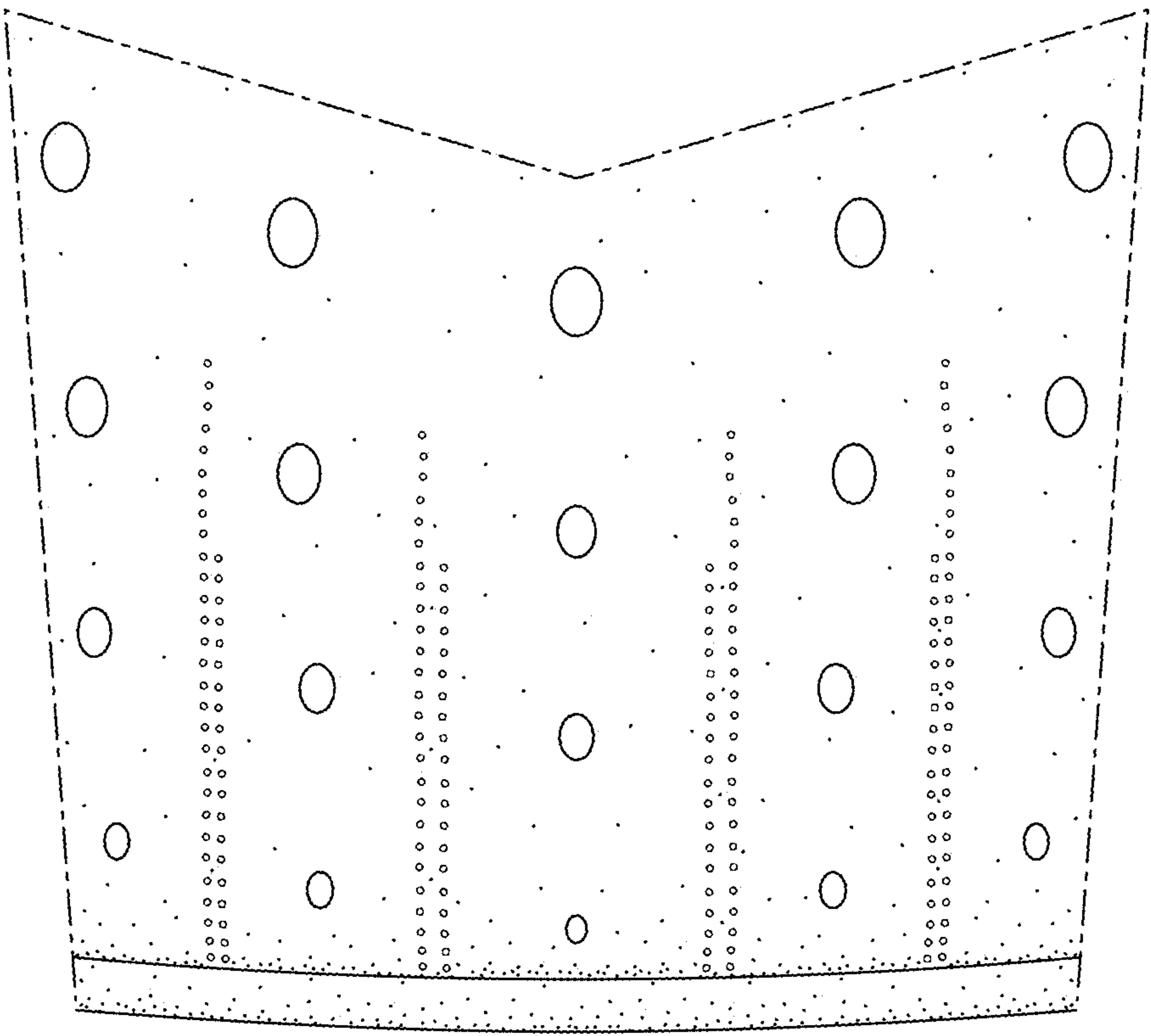
