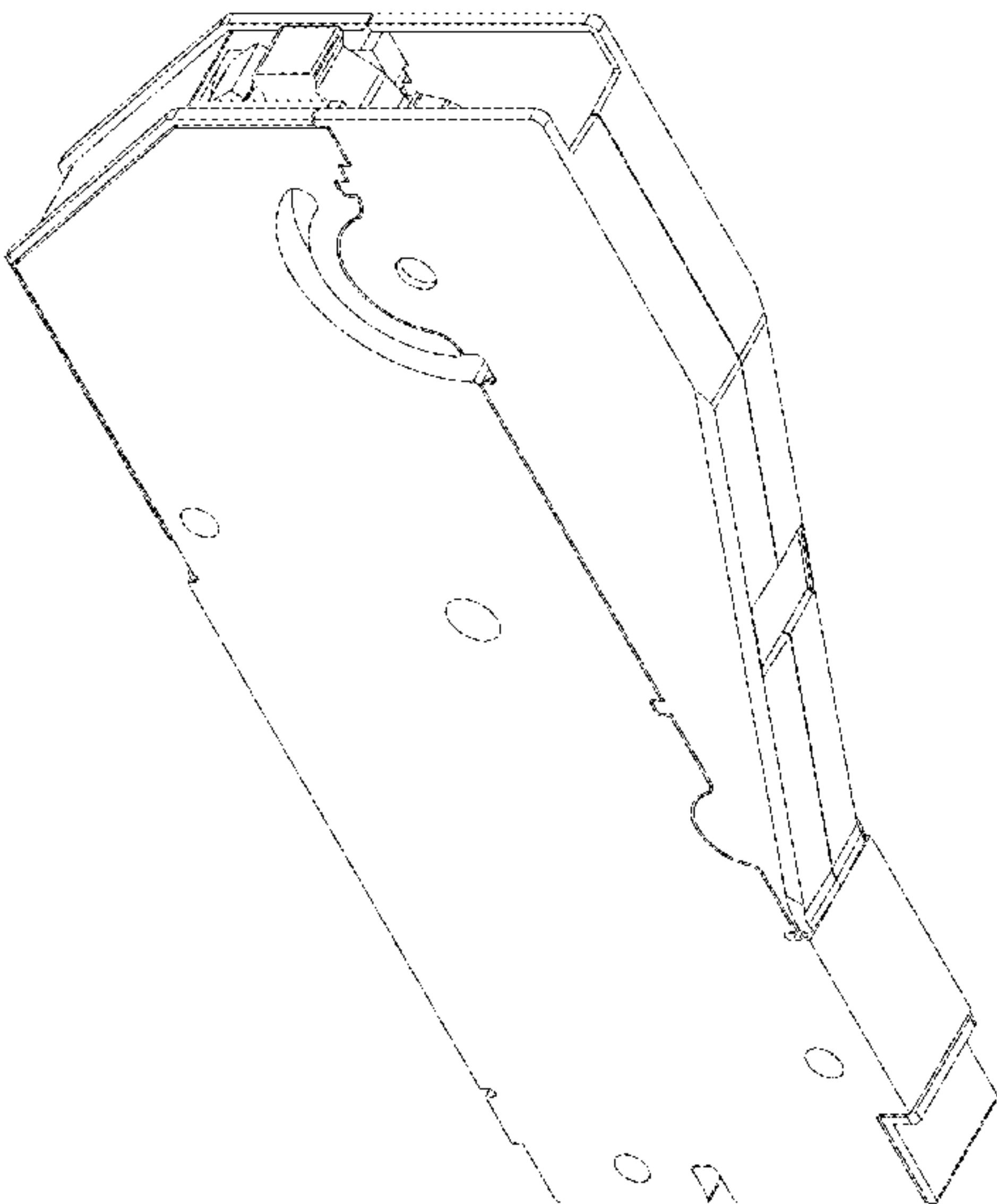
CLAIM

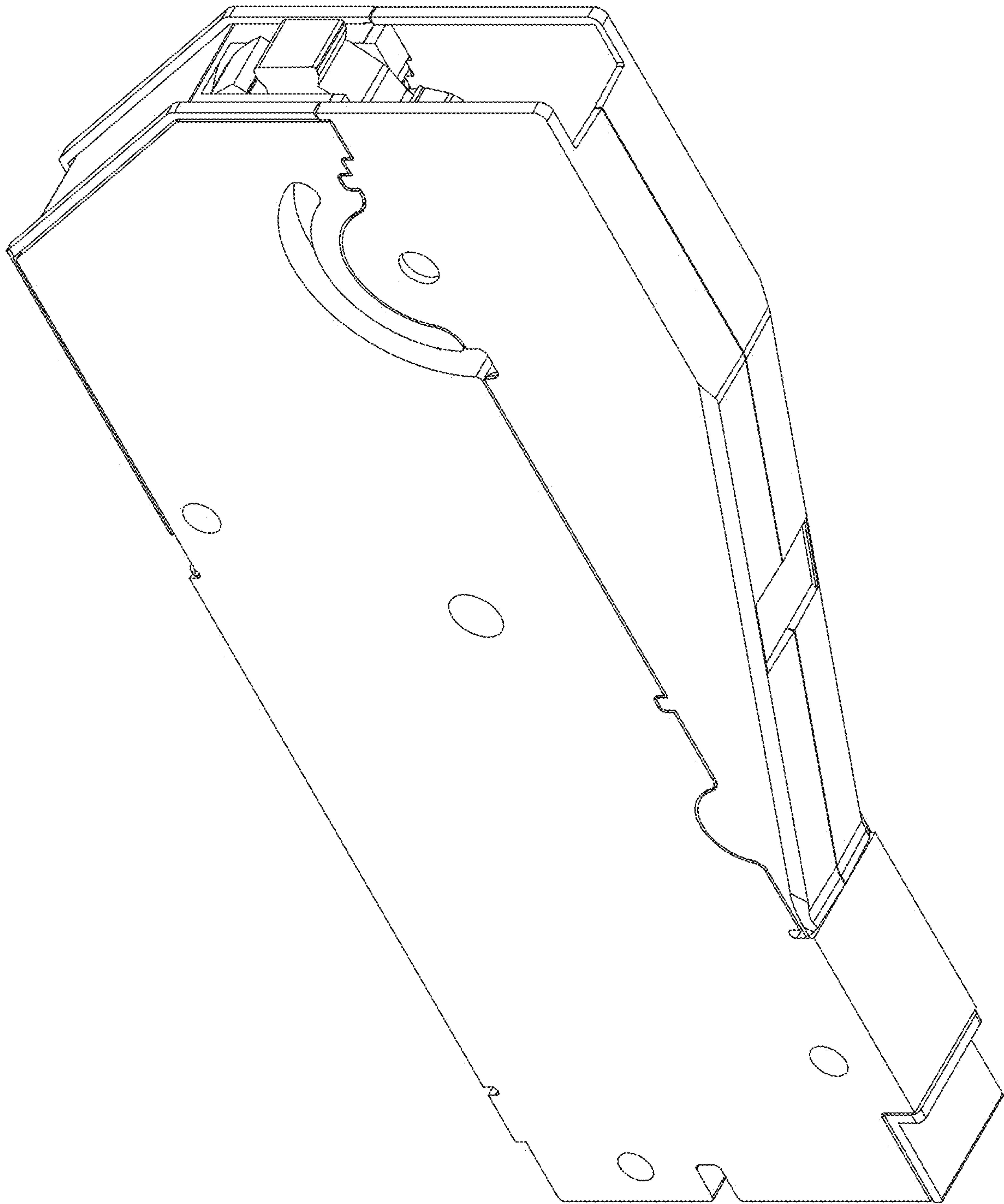

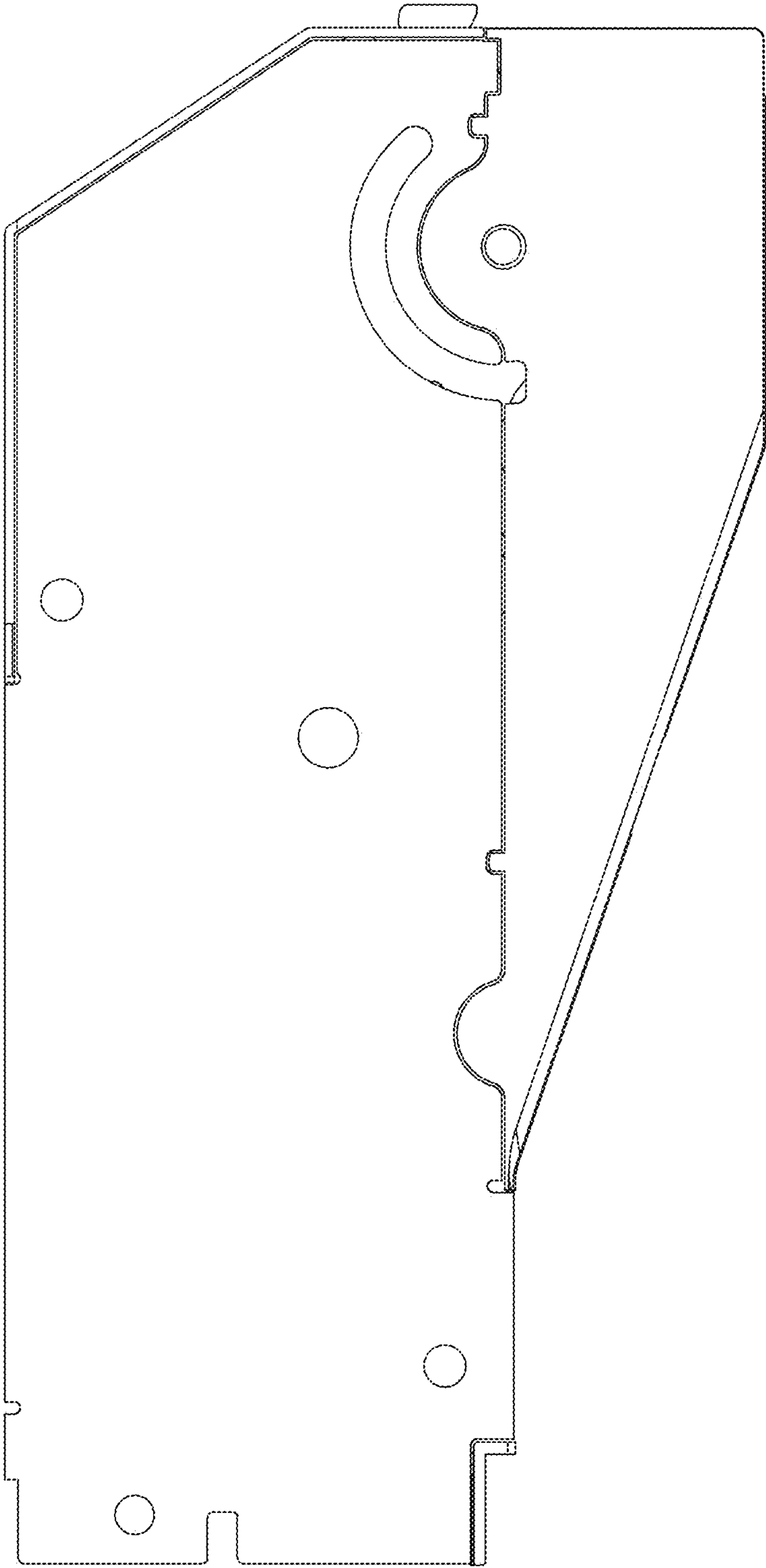

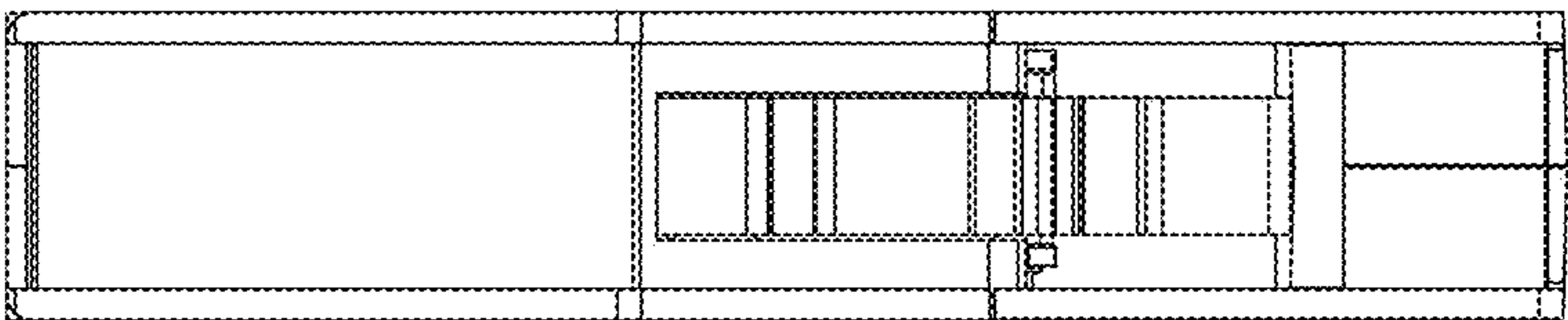

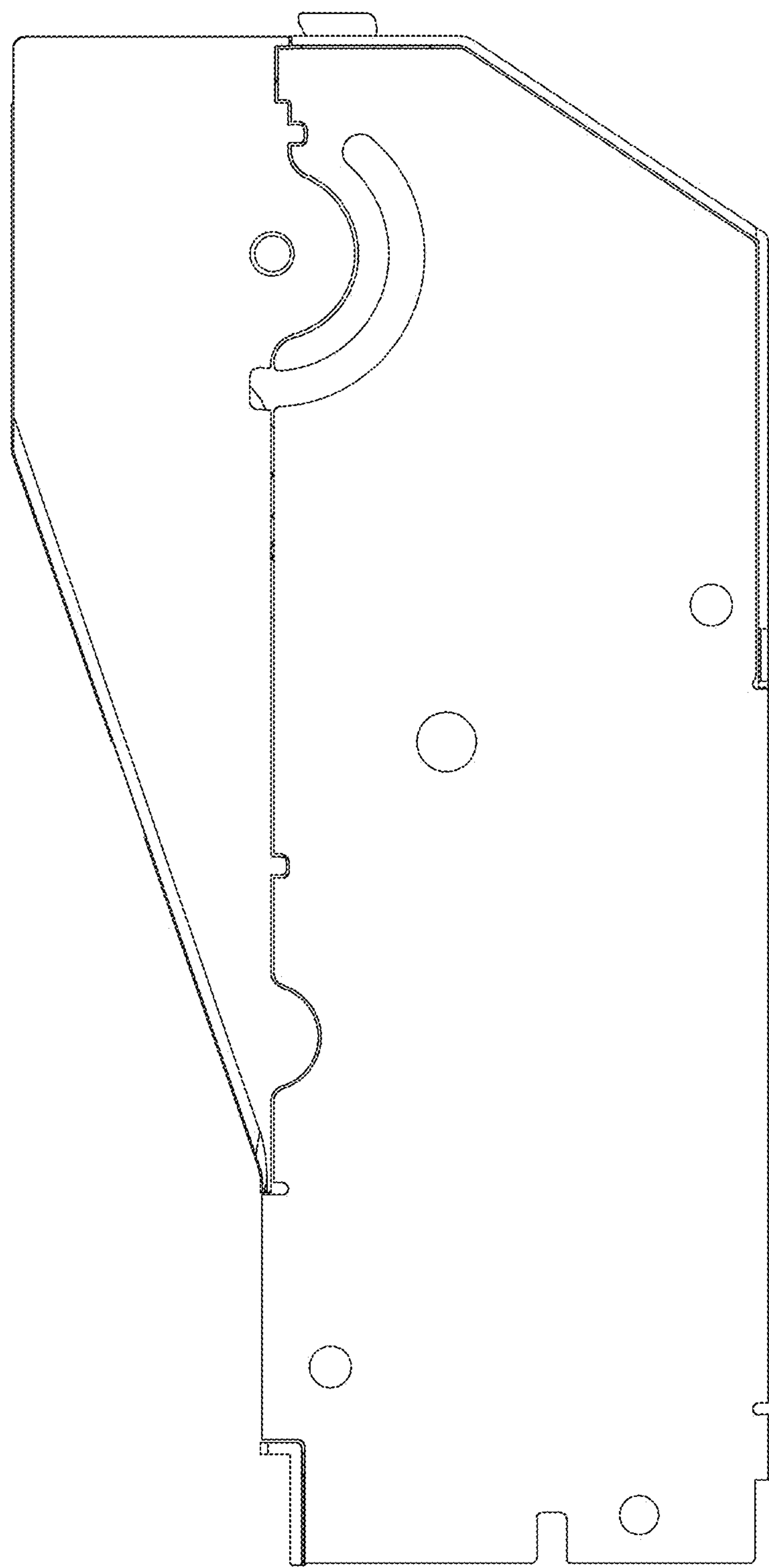

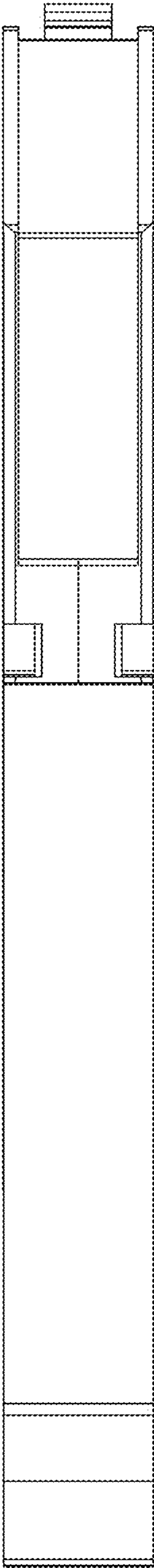
