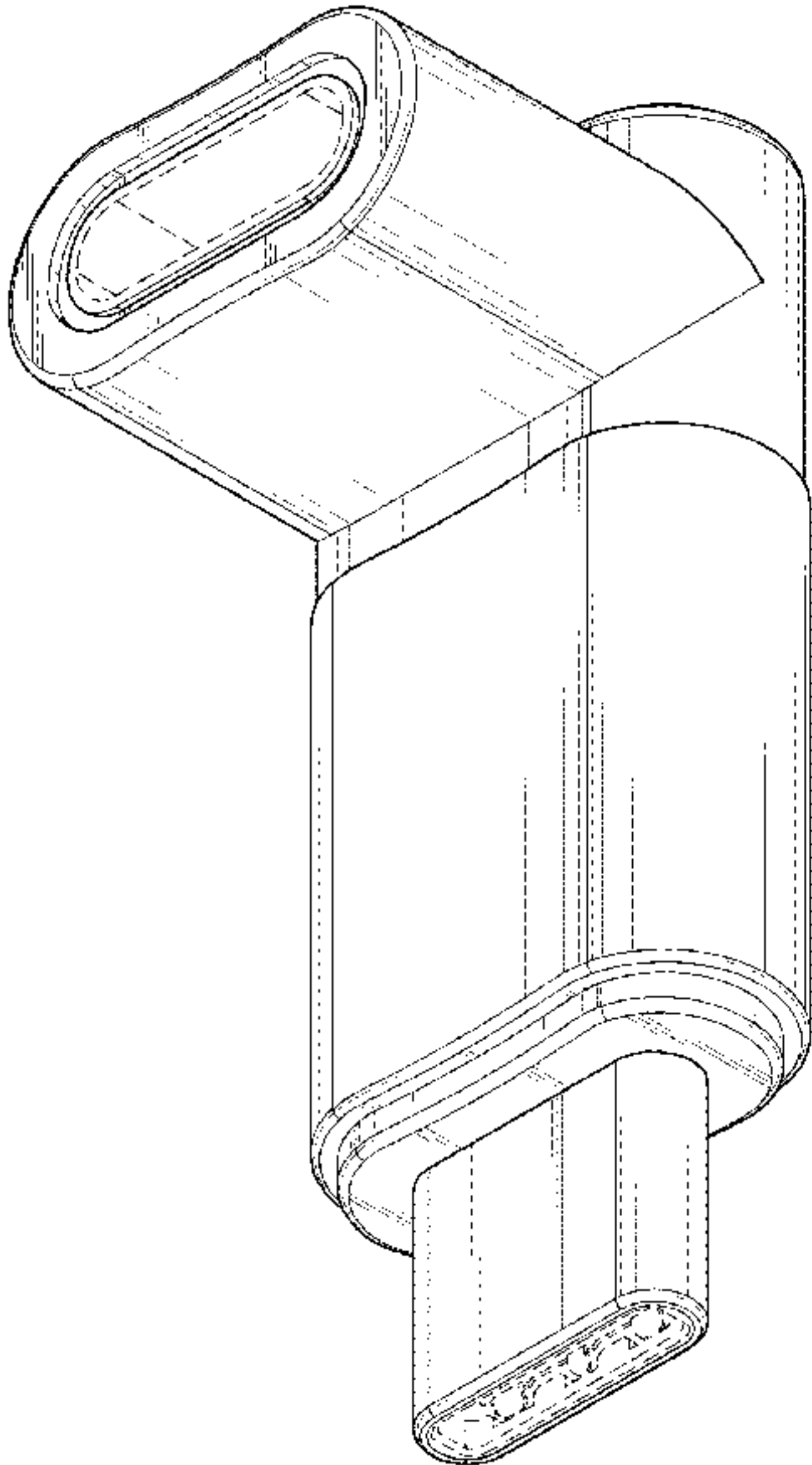
(57) CLAIM

The ornamental design for an electrical connector adapter as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front, right side perspective view of an electrical connector adapter, showing the claimed design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The dashed broken lines in the drawing depict portions of the electrical connector adapter that form no part of the claimed design.

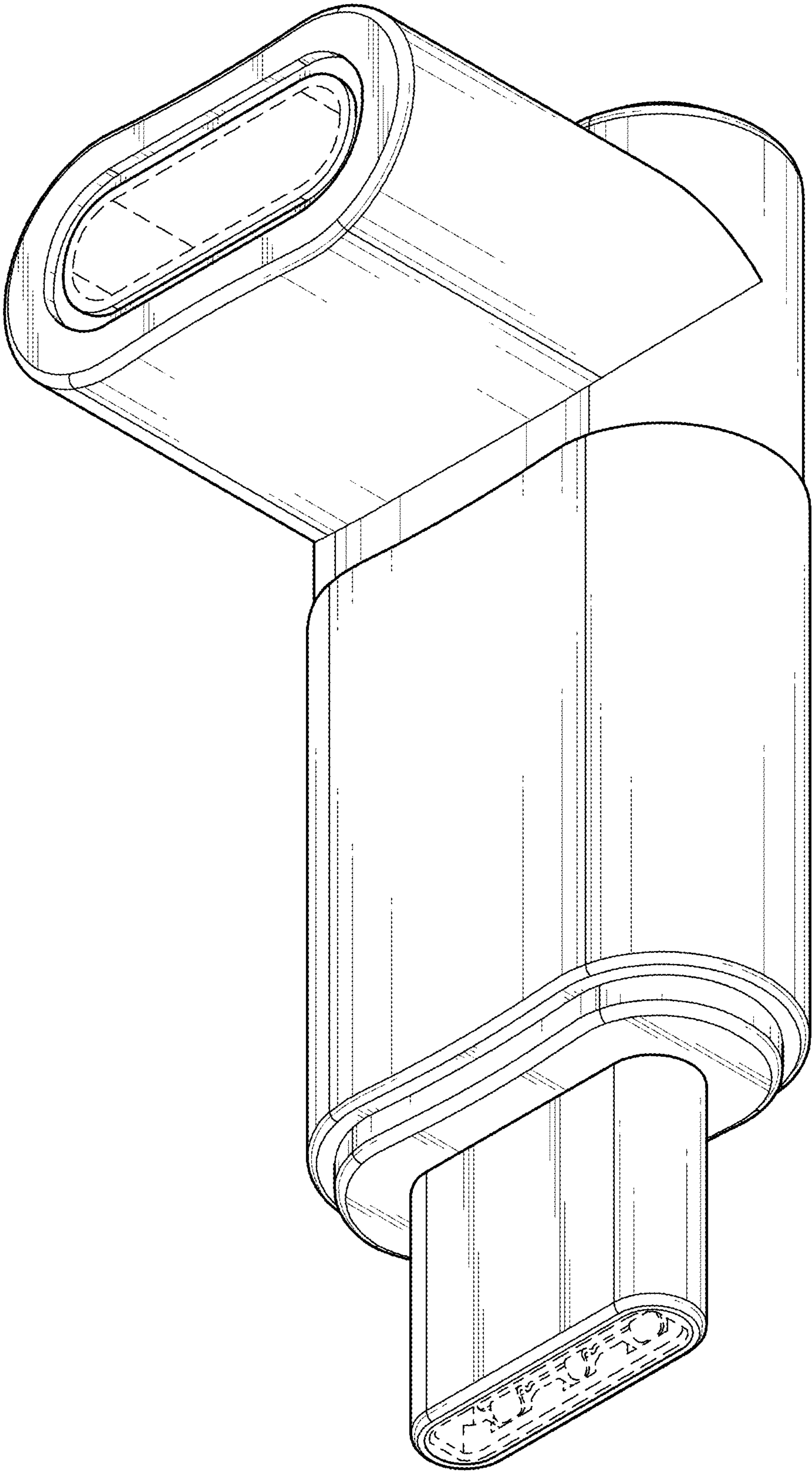

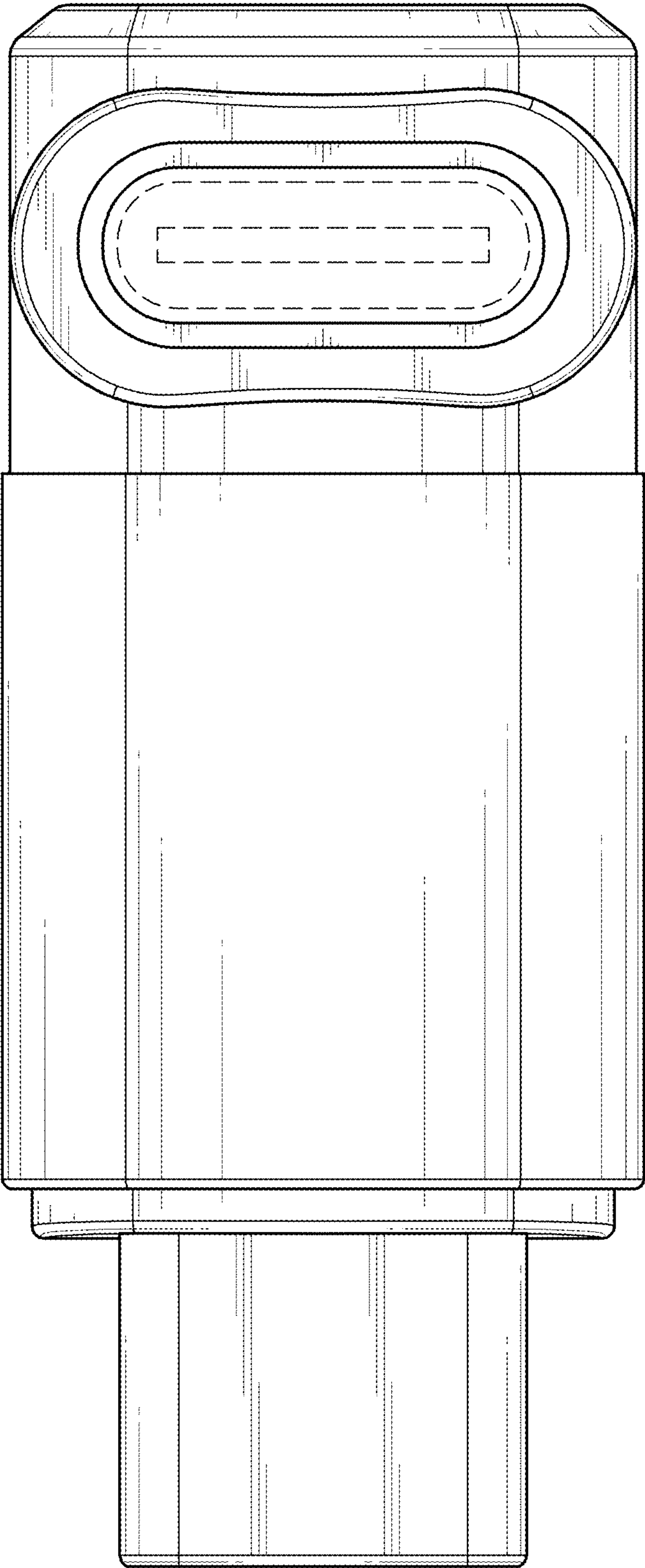

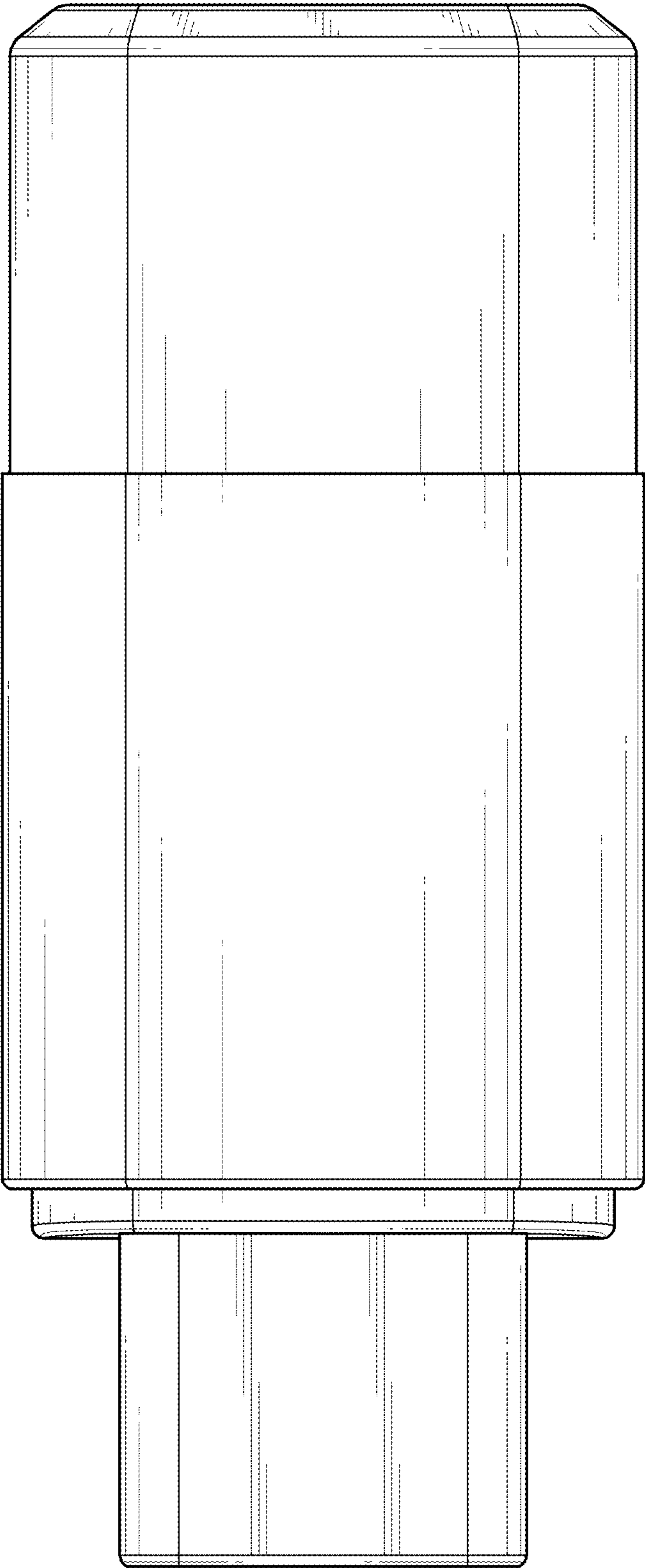

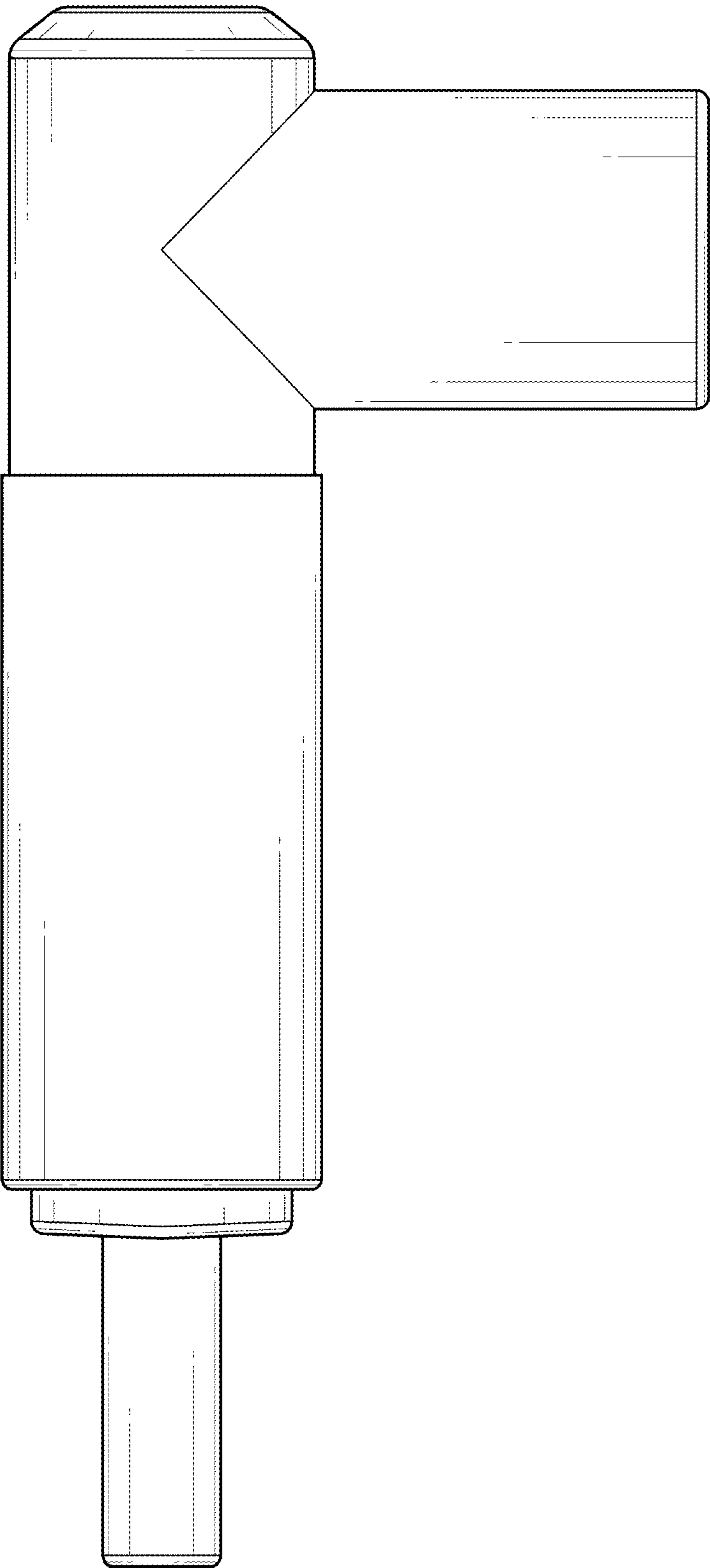

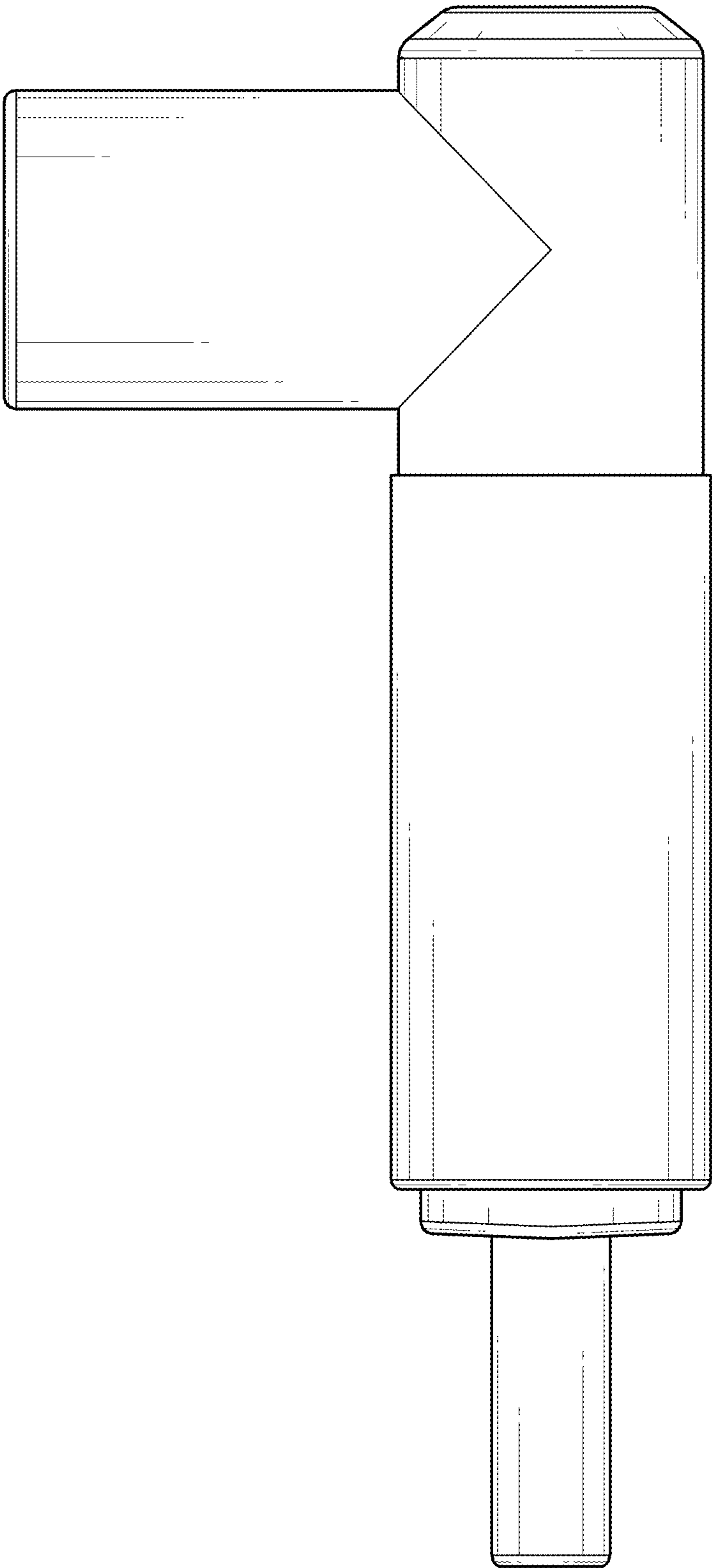

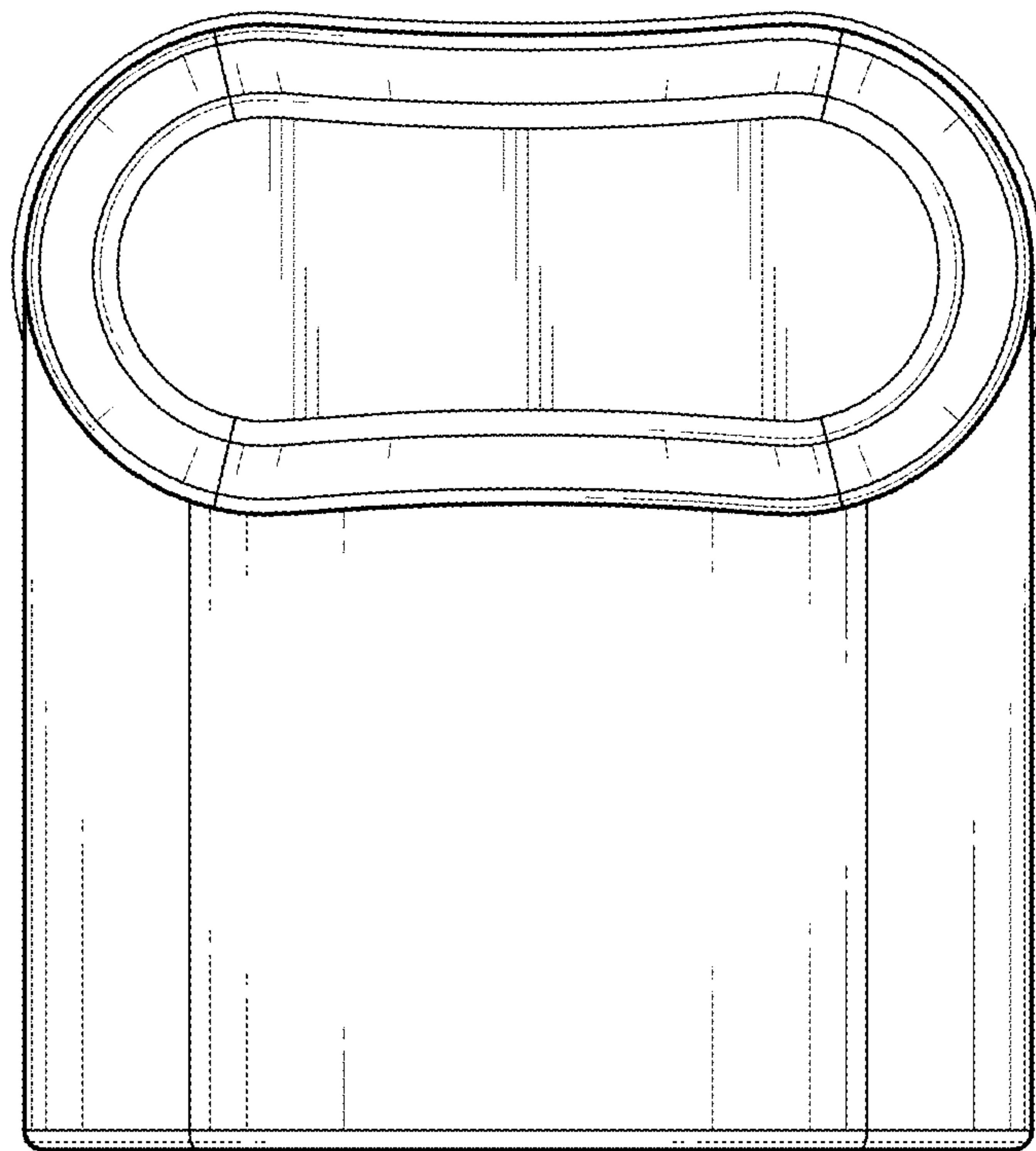

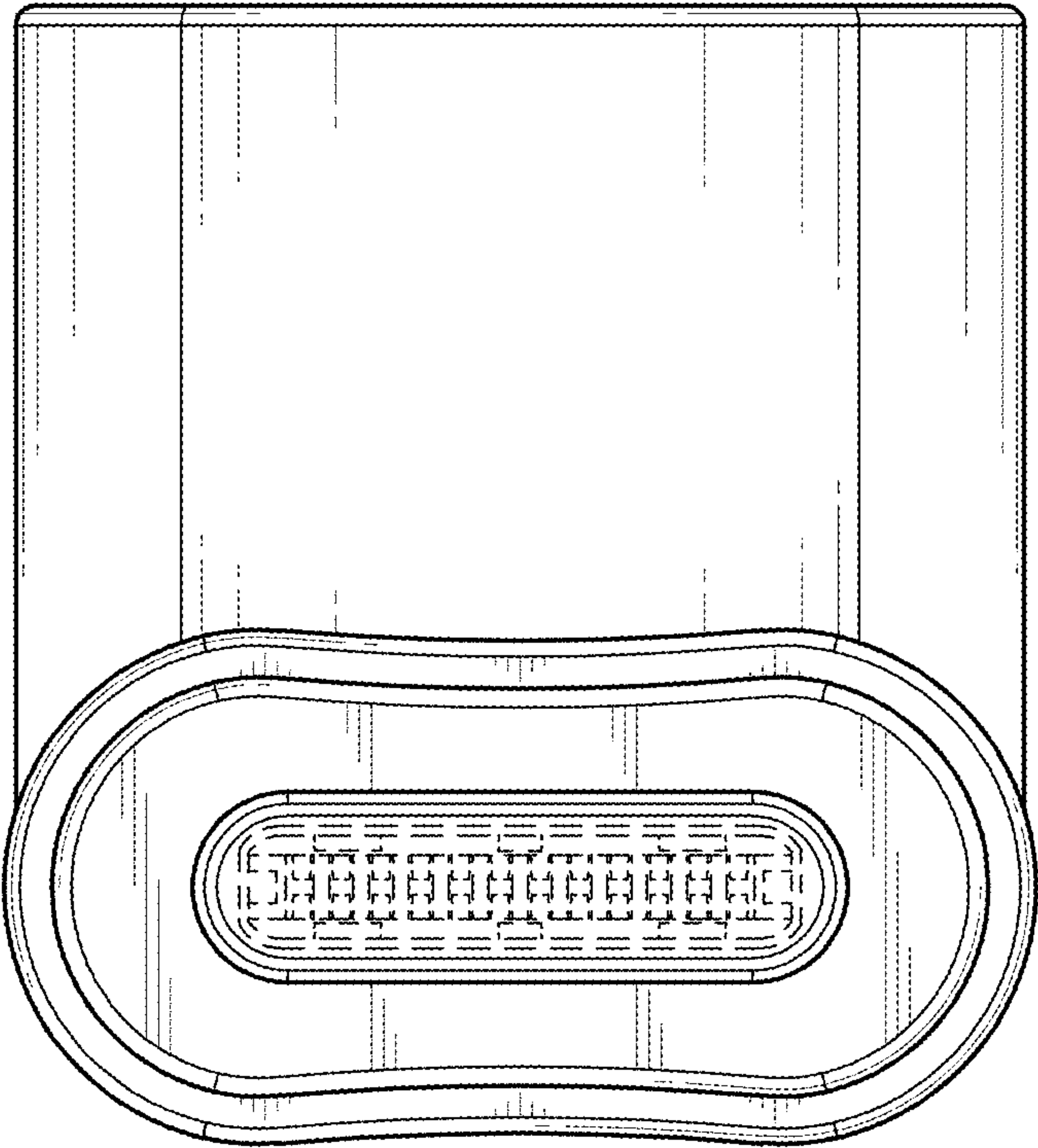
