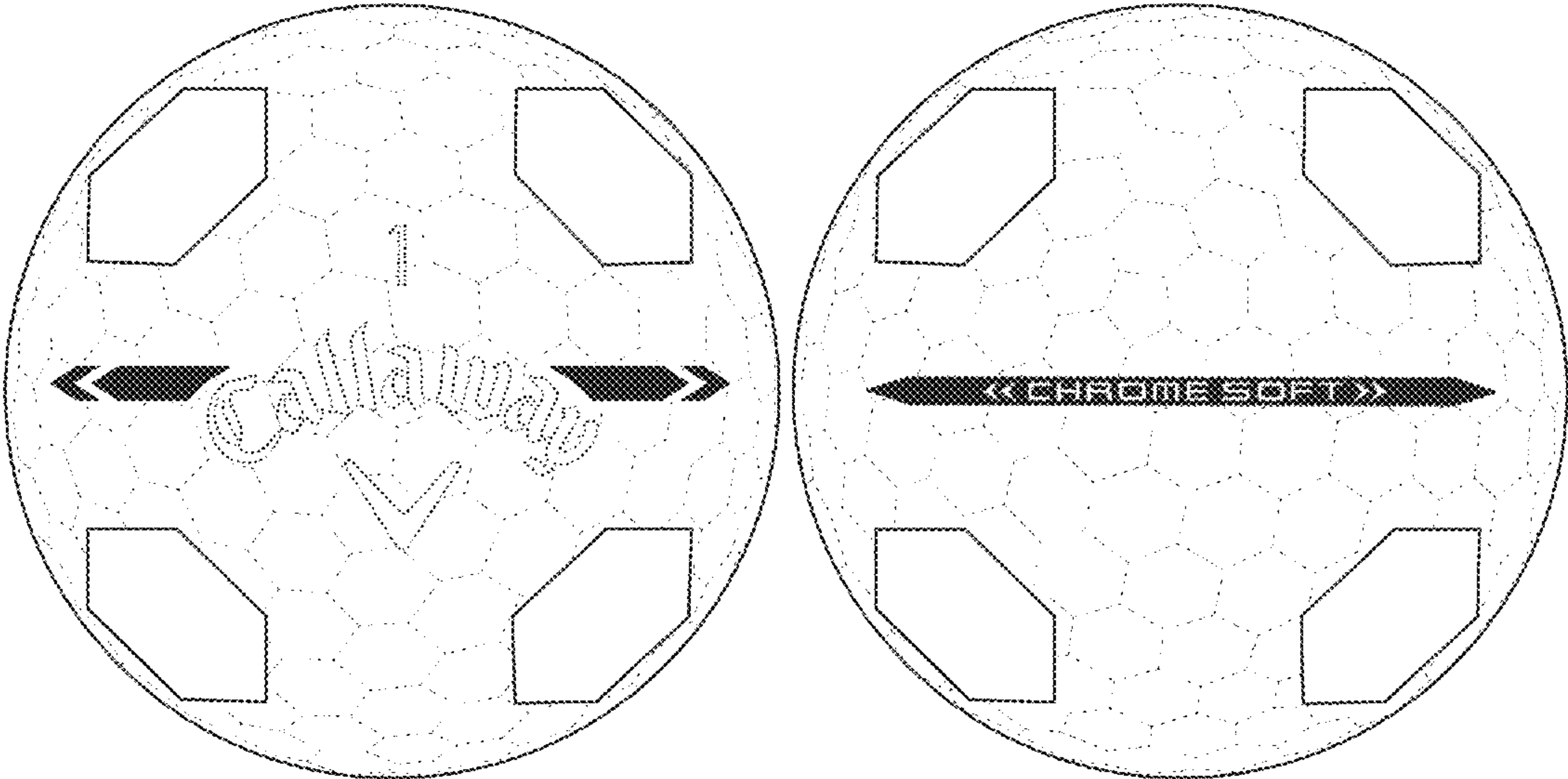
CLAIM

DESCRIPTION

FIG. 1 is a front elevation view of a golf ball, showing our new design;
FIG. 2 is a rear elevation view thereof;

FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof; and,

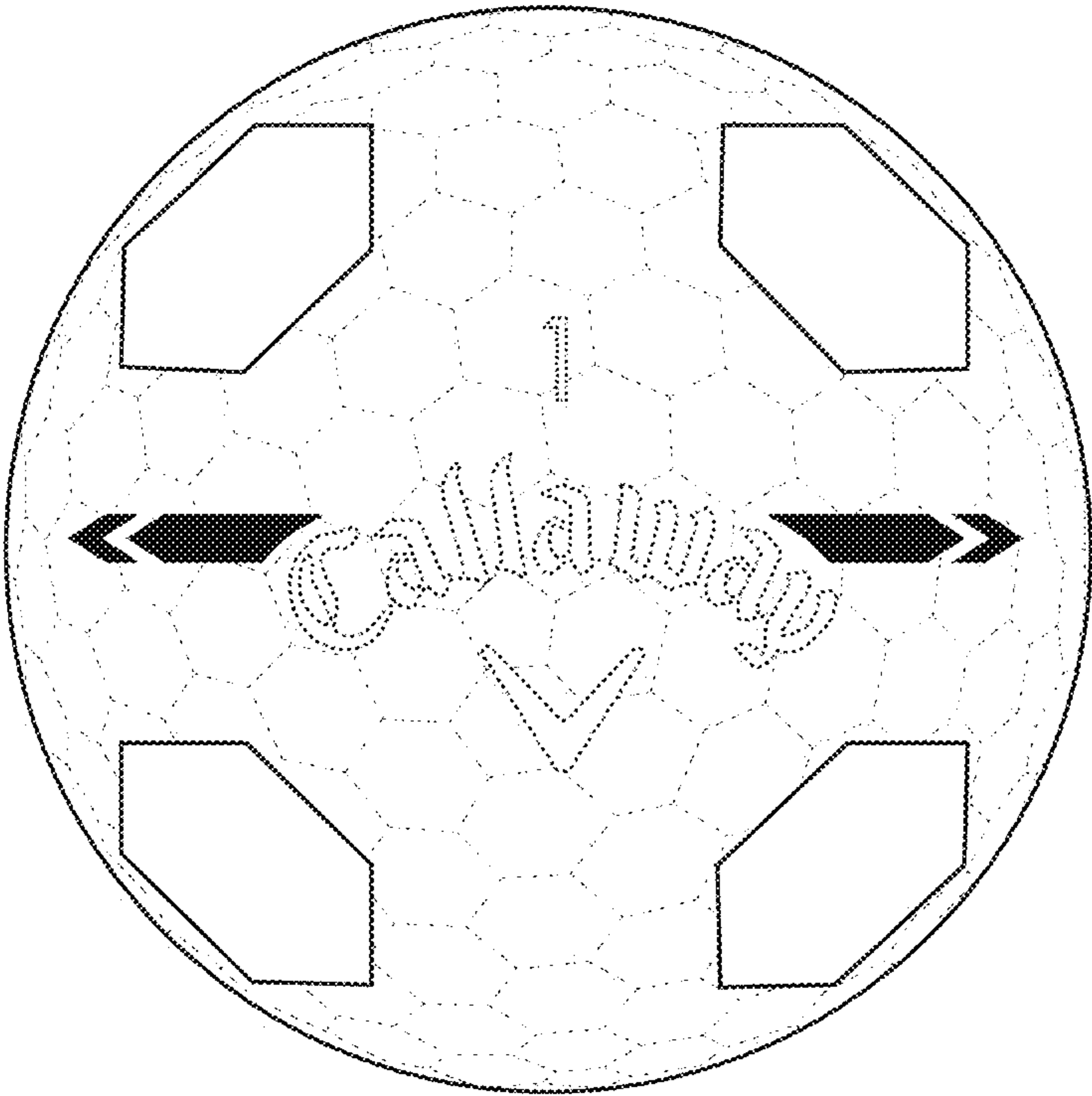

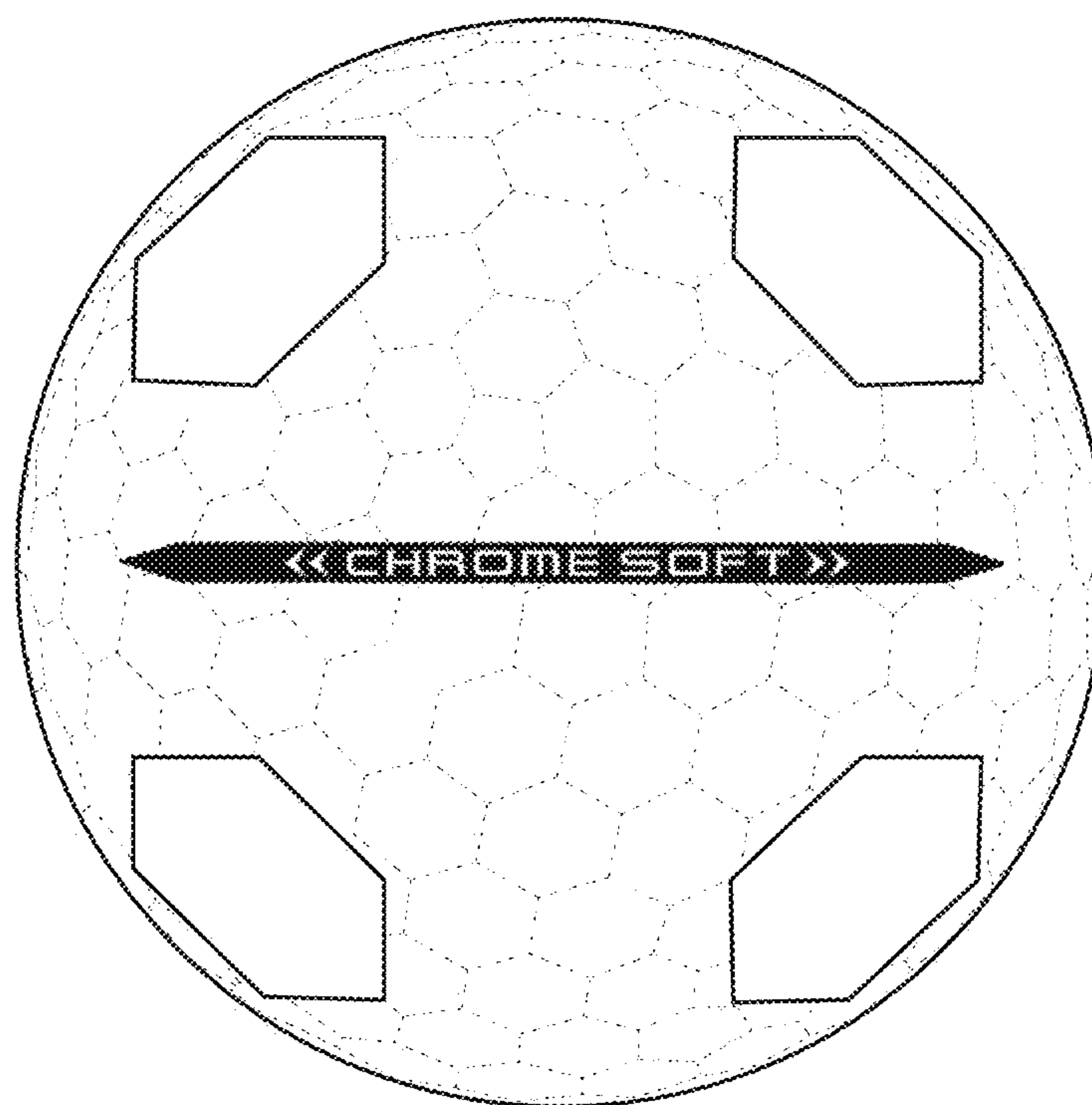

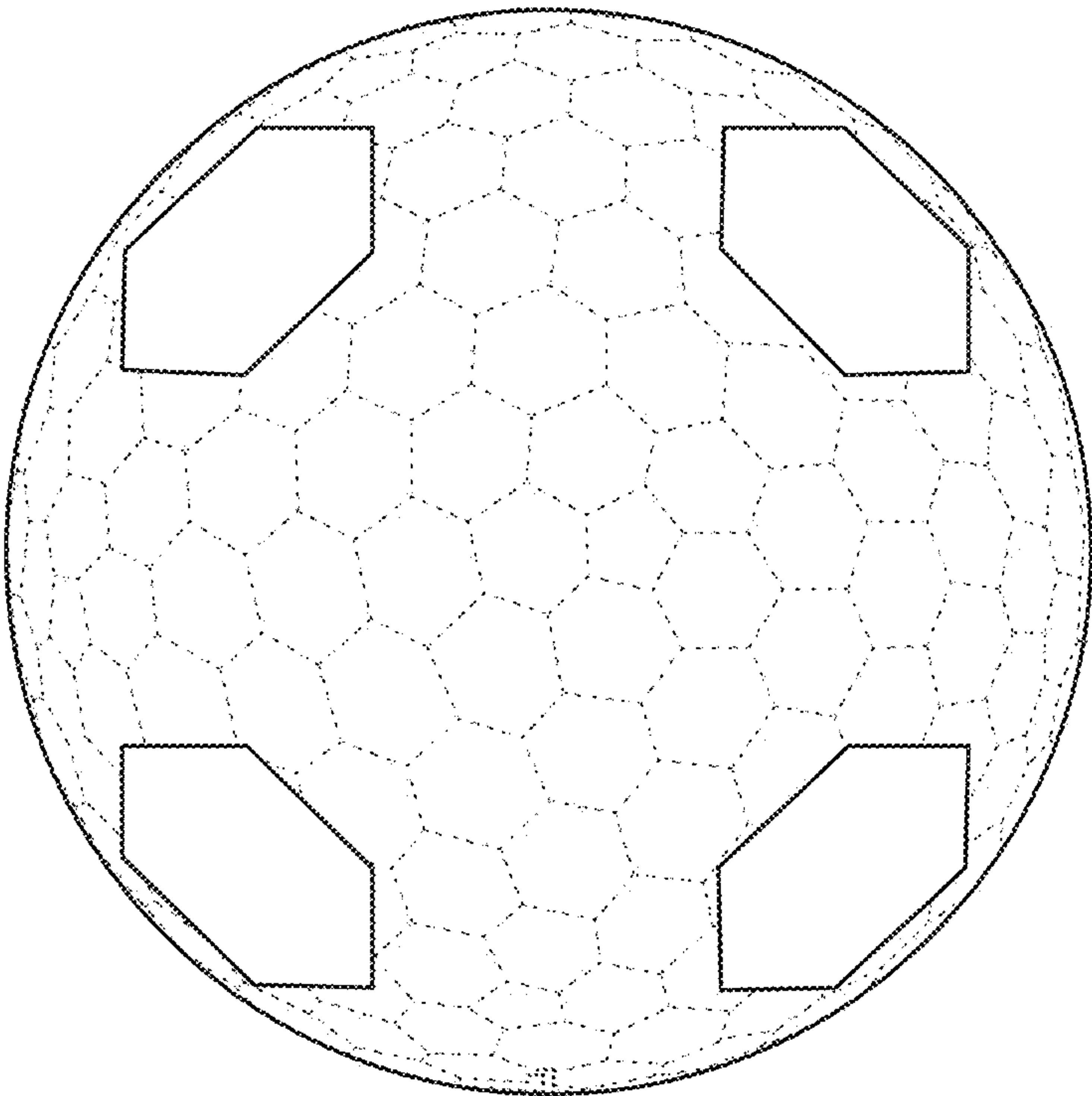

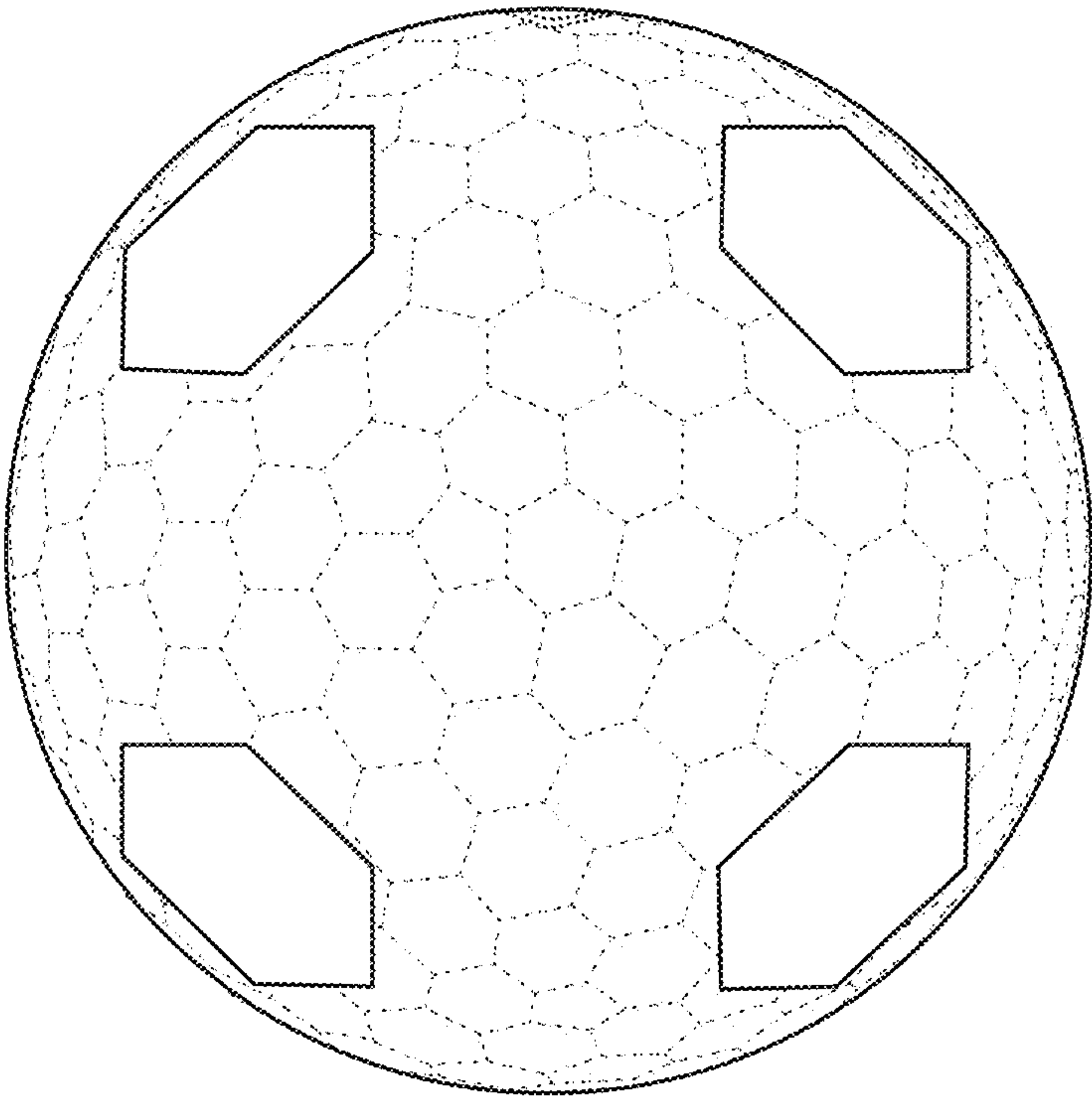

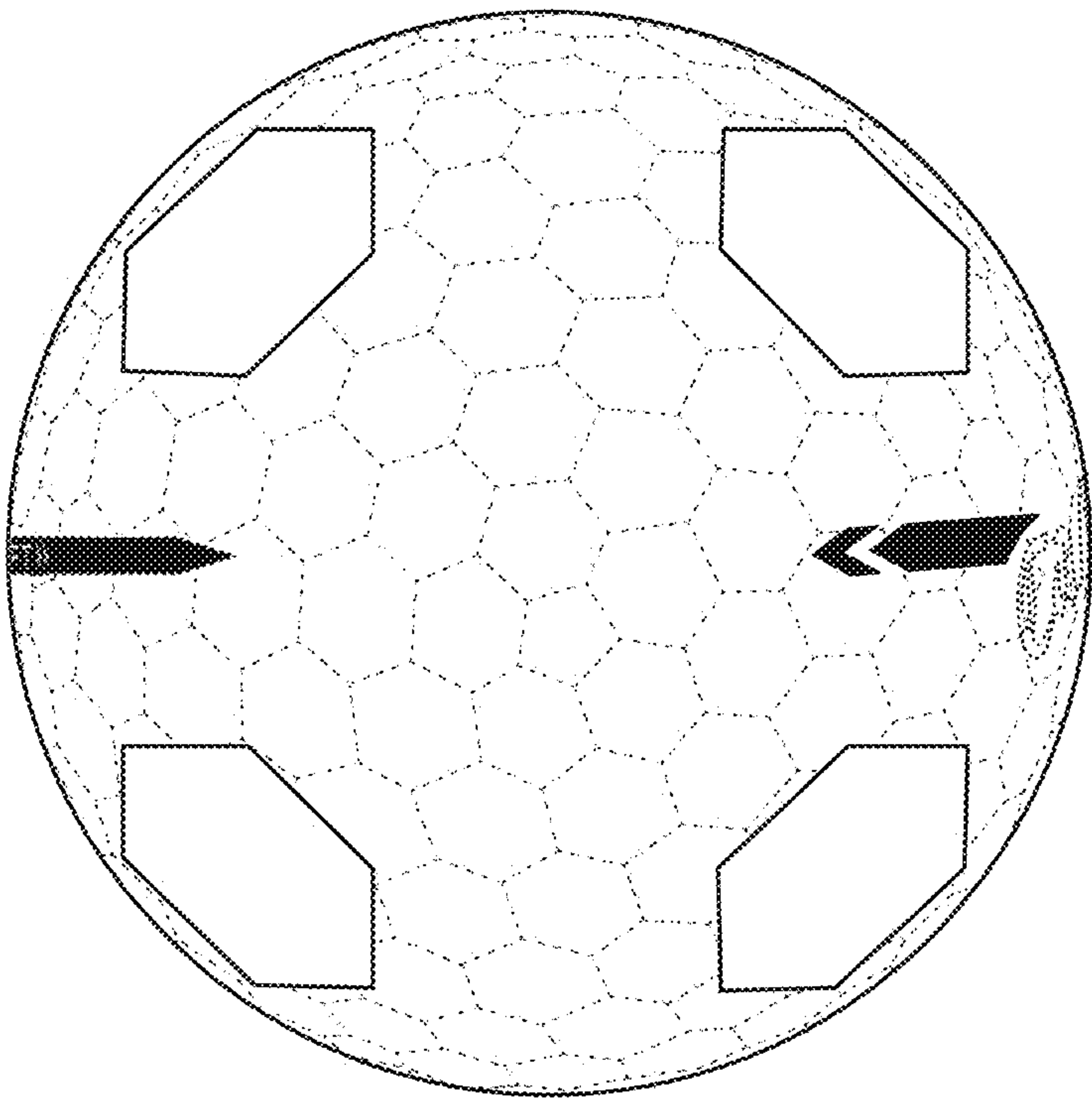

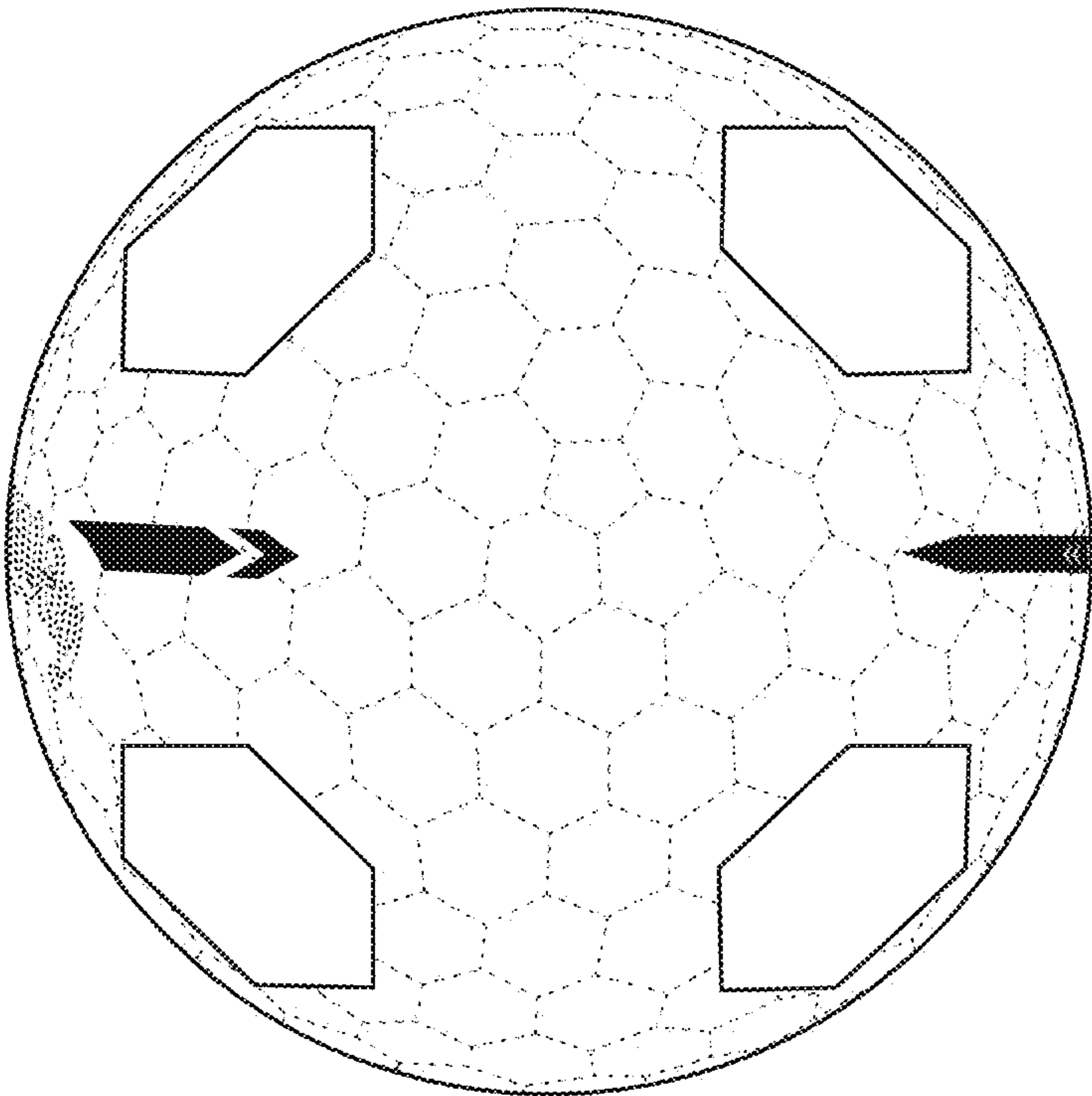

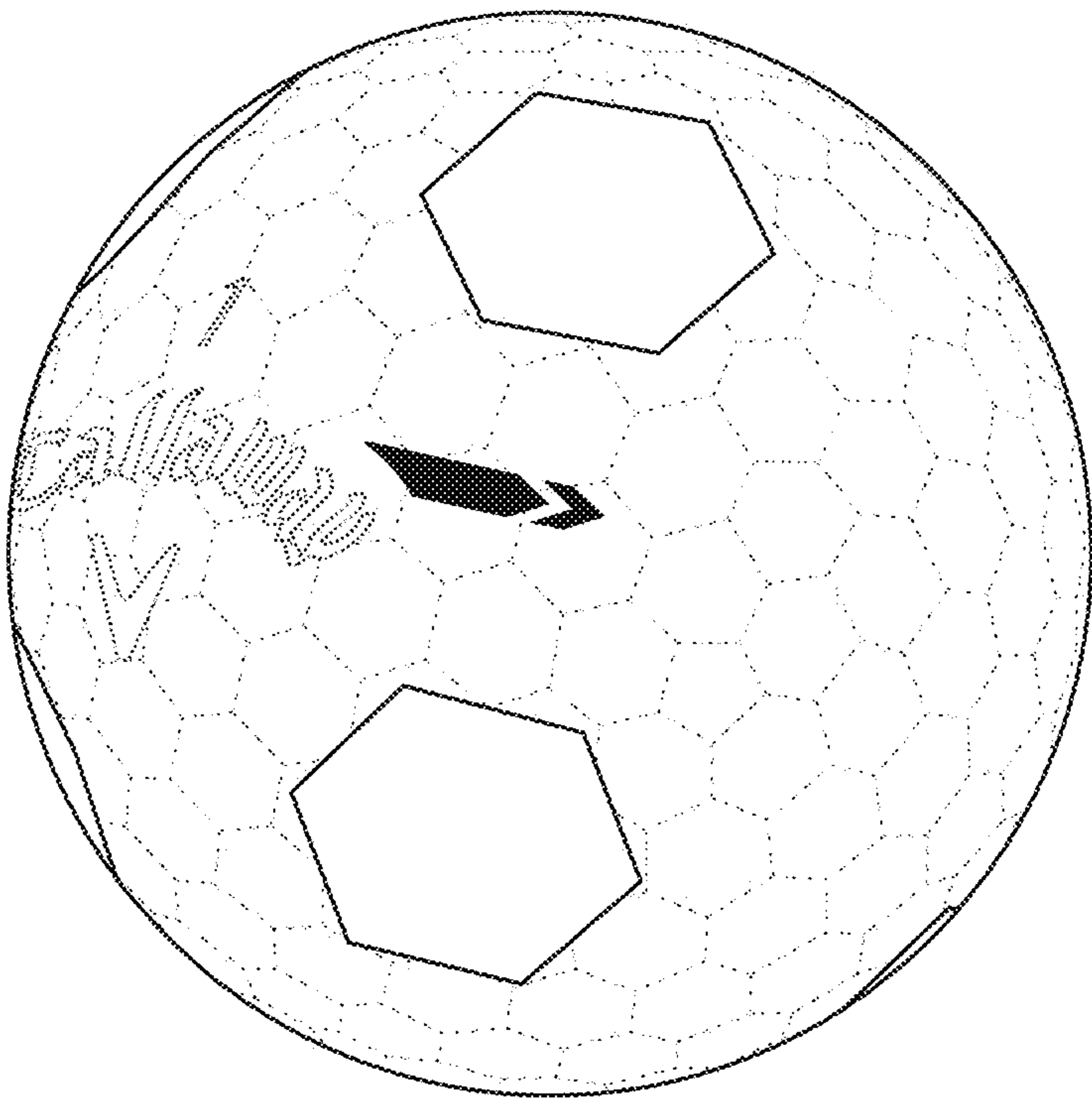
