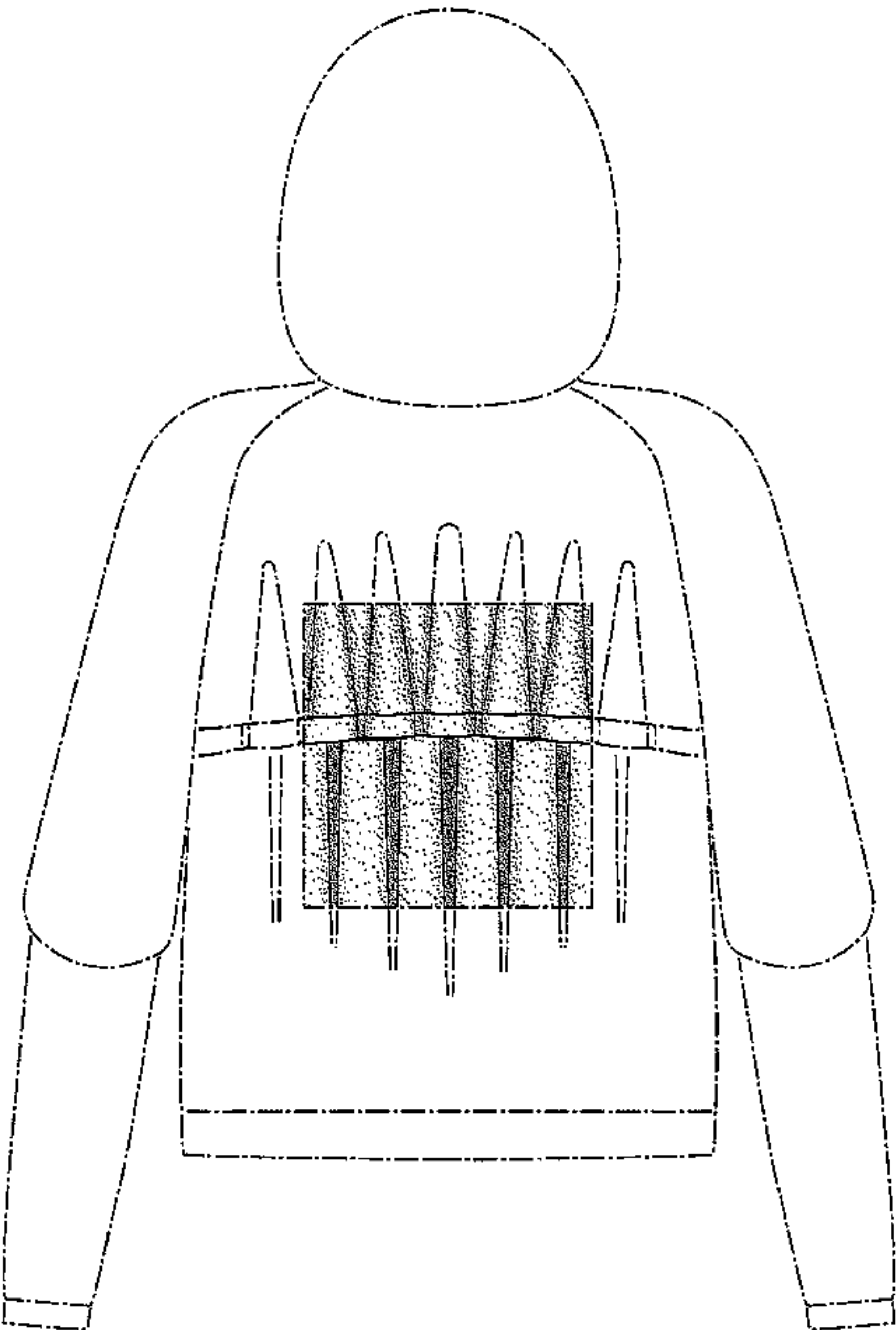
(57)CLAIM

The ornamental design for a jacket as shown and described.

DESCRIPTION

FIG. 1 is a rear view of a jacket showing our new design; FIG. 2 is a right side rear perspective view thereof; FIG. 3 is a left side rear perspective view thereof; and, FIG. 4 is an enlarged view of the area demarcated in FIG. 2 with certain environment removed for clarity purposes. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the jacket form no part of the claimed design.

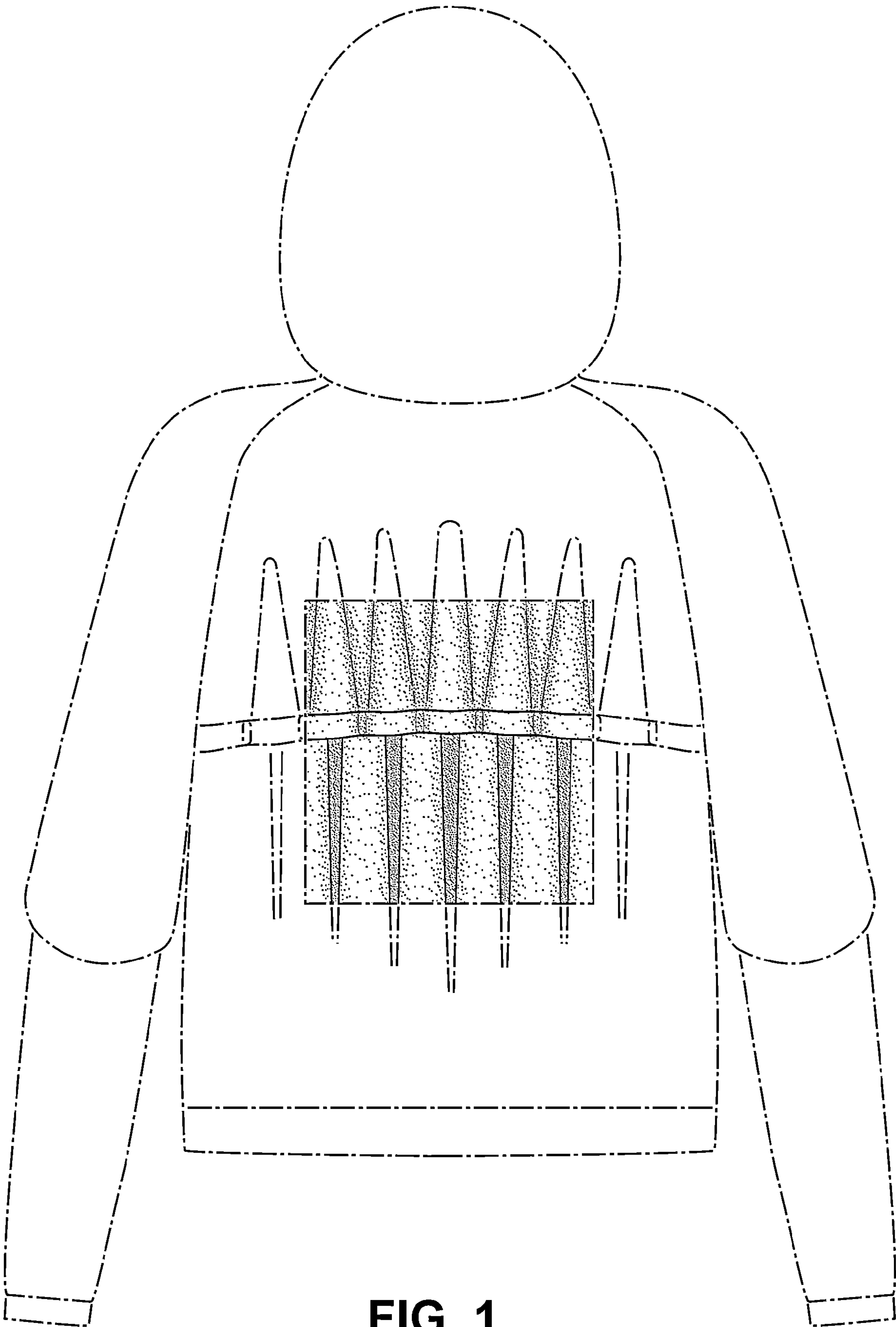

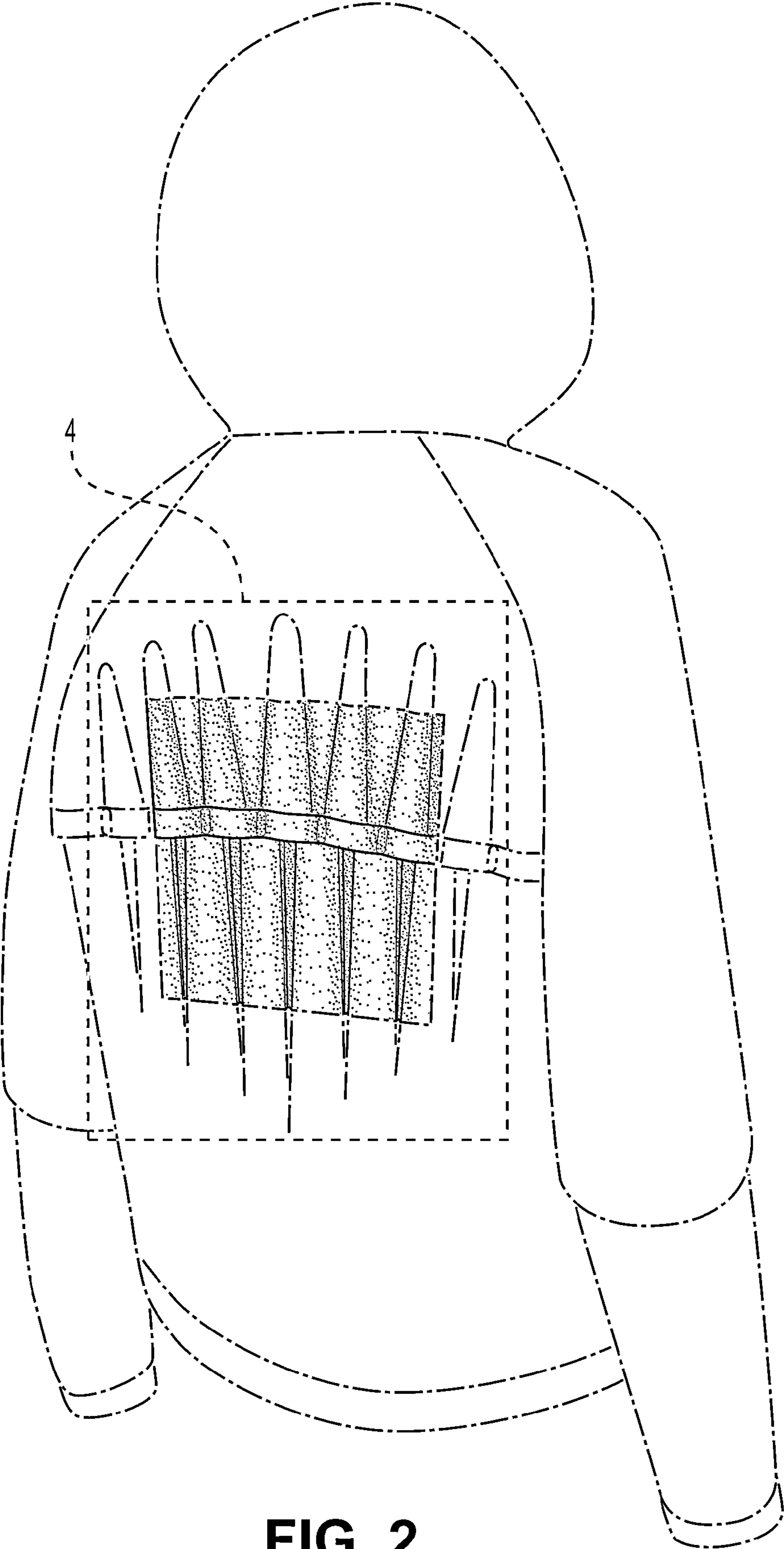

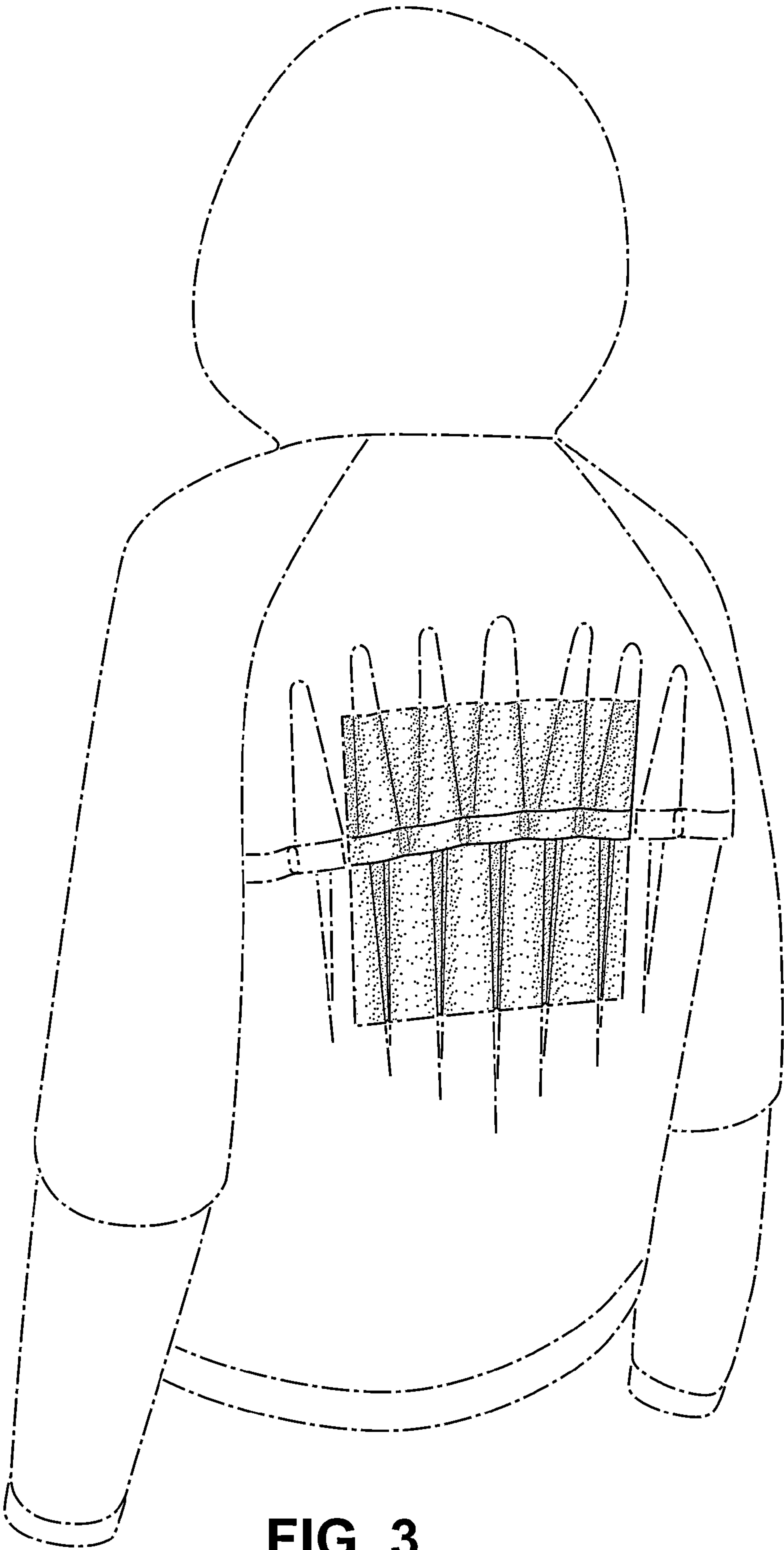

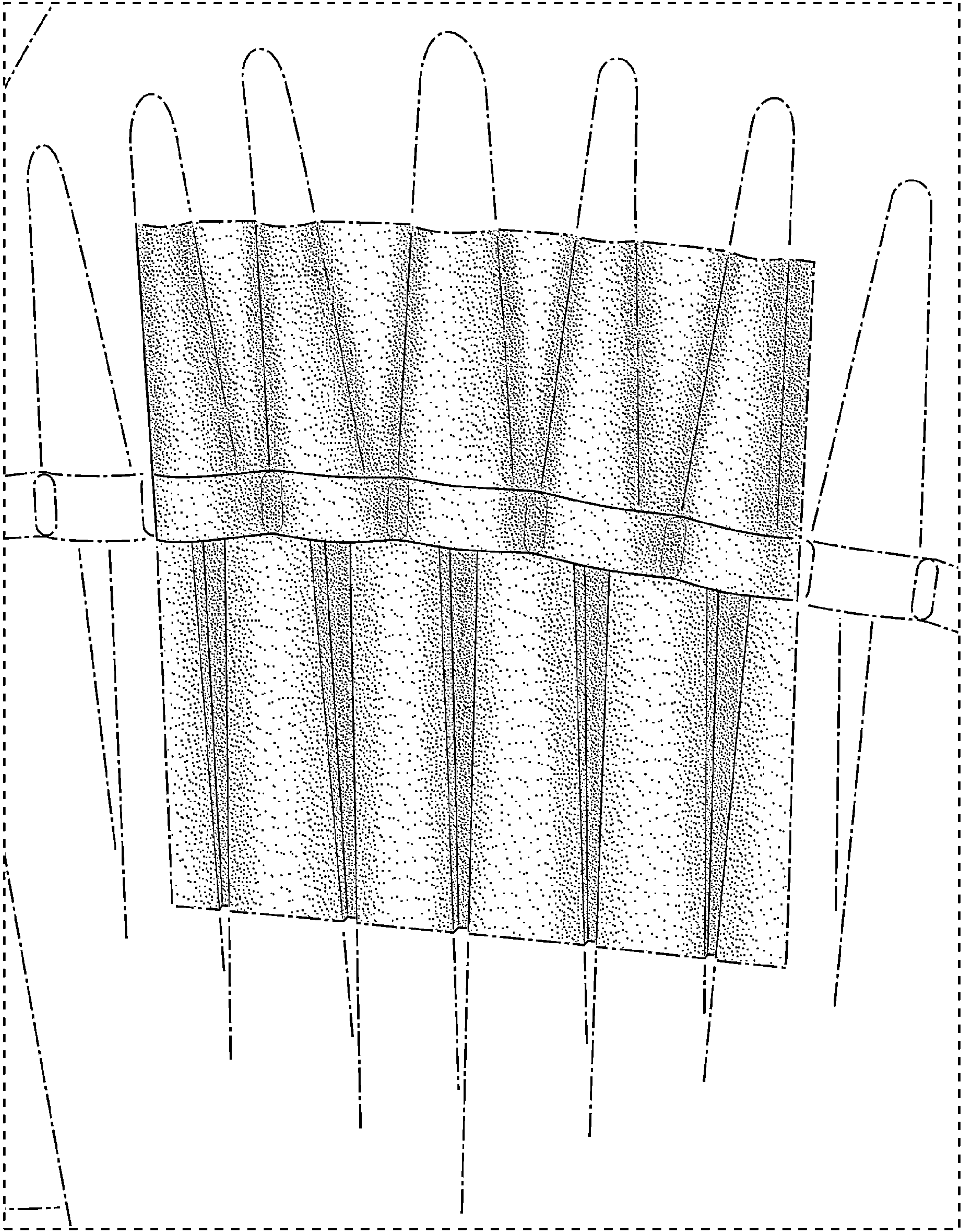
