(57) **CLAIM**

The ornamental design for a cleaning device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cleaning device showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a rear view thereof;

FIG. 7 is a front view thereof; and,

FIG. 8 is a perspective view of the cleaning device with a rod interface, showing our new design.

The broken lines in the drawings illustrate portions of the cleaning device which form no part of the claimed design. The broken lines in the Figures show portions of the cleaning device that form no part of the claimed design. The oblique shade lines in the Figures illustrate the relative curvature of various surfaces, and not surface ornamentation.

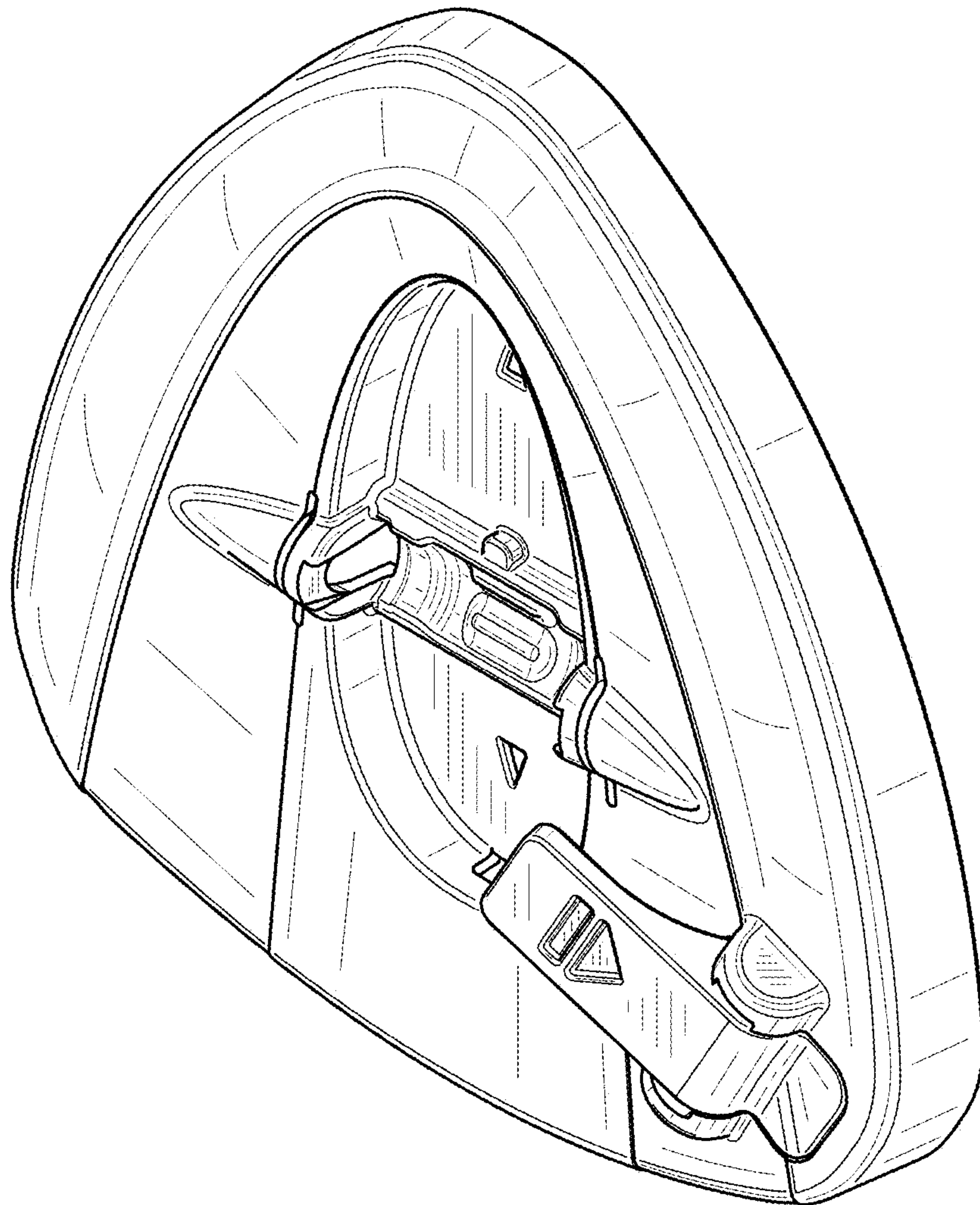

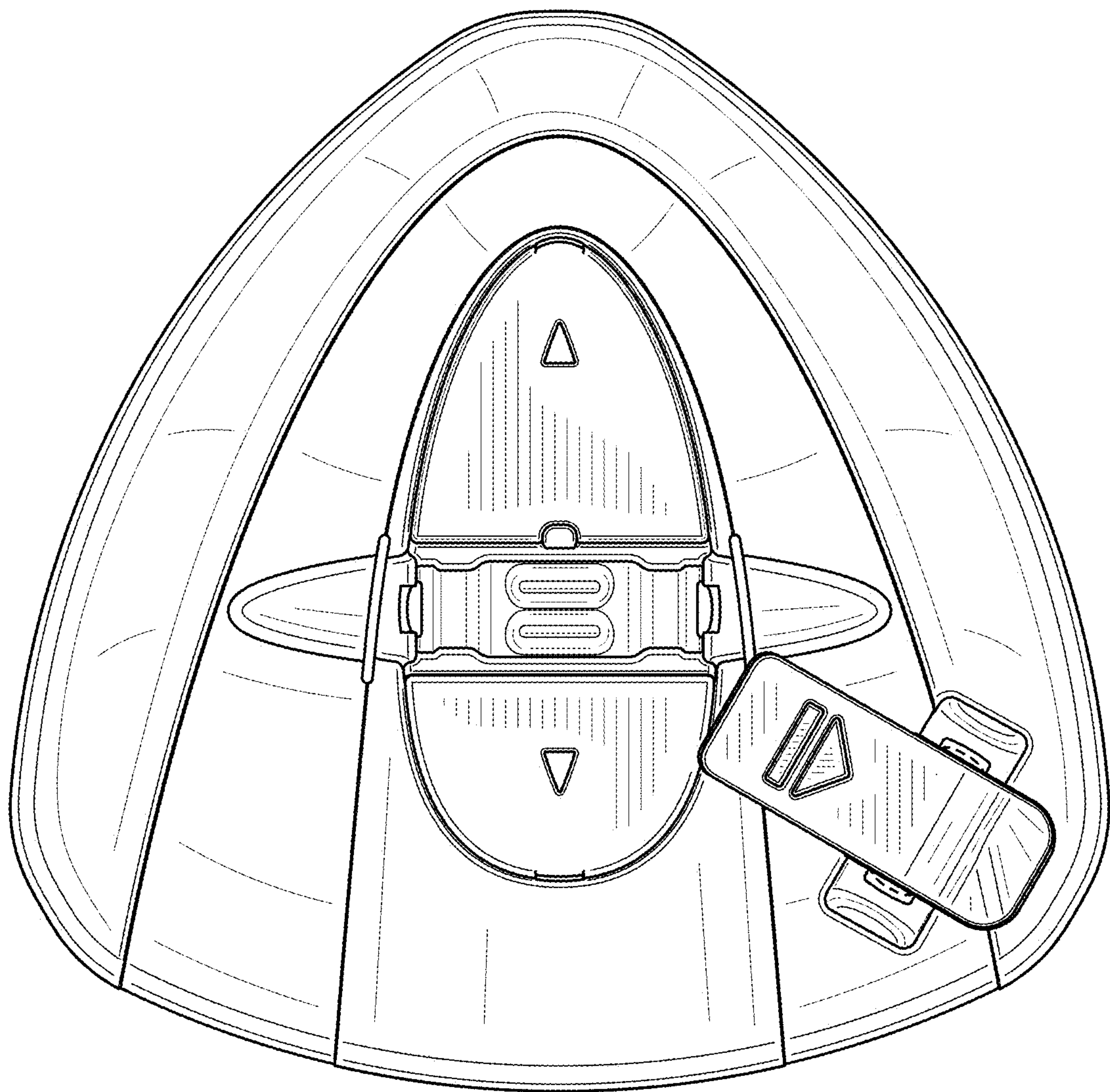

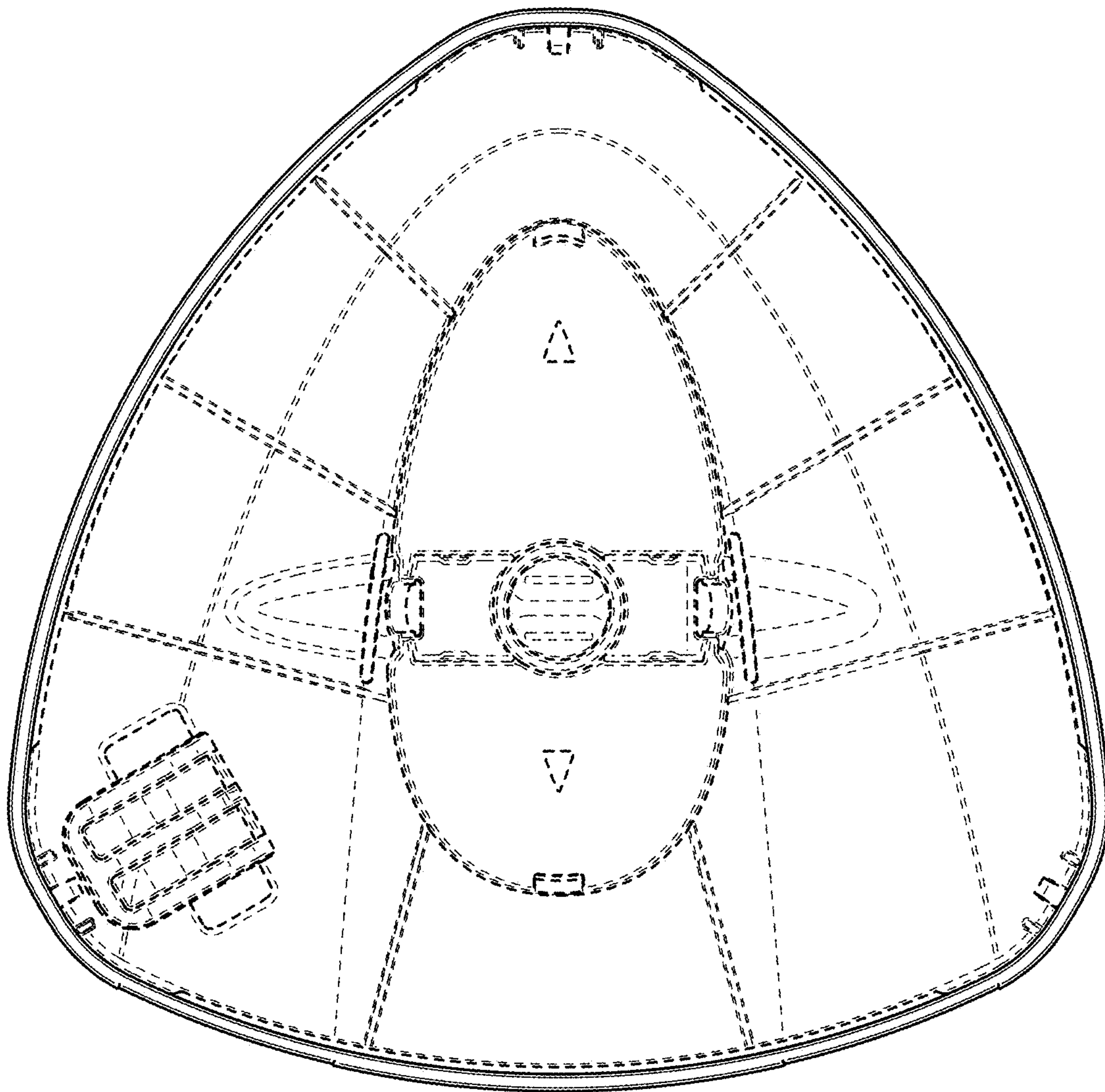

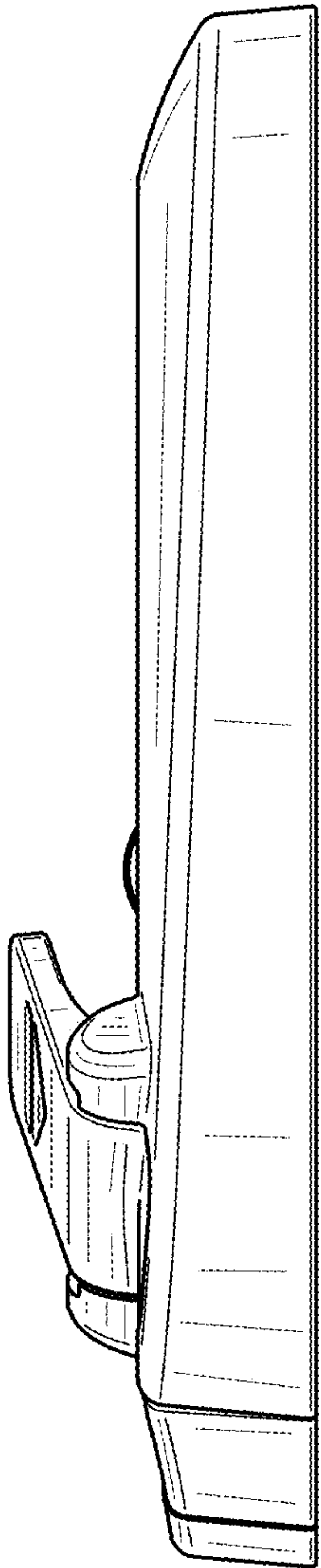

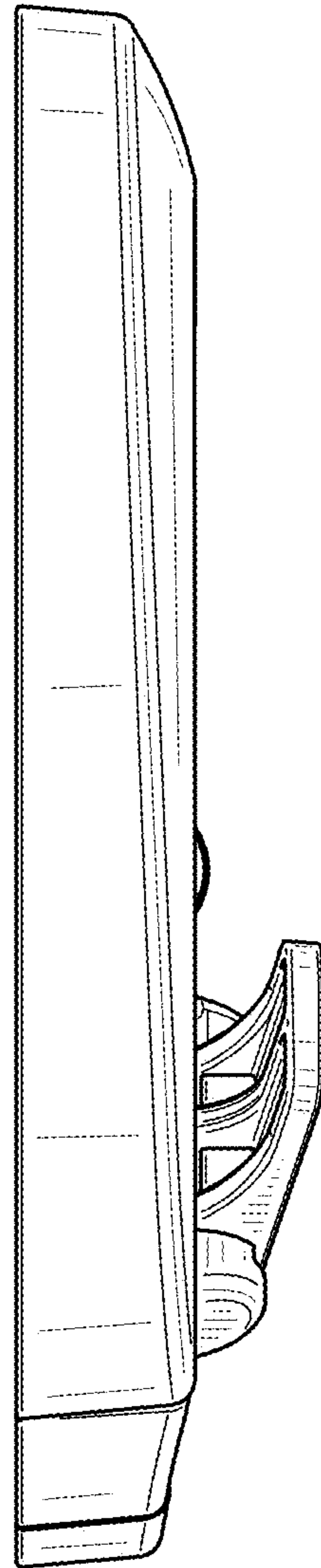

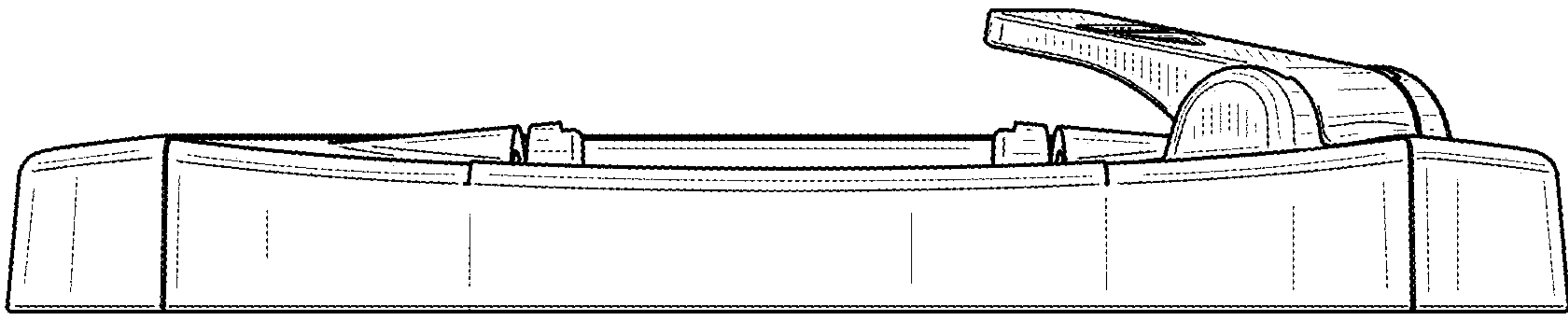

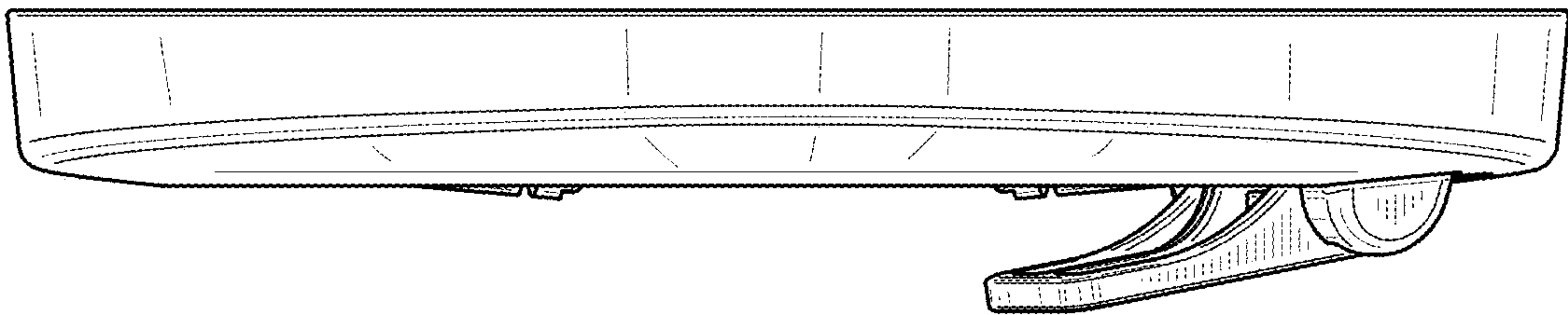

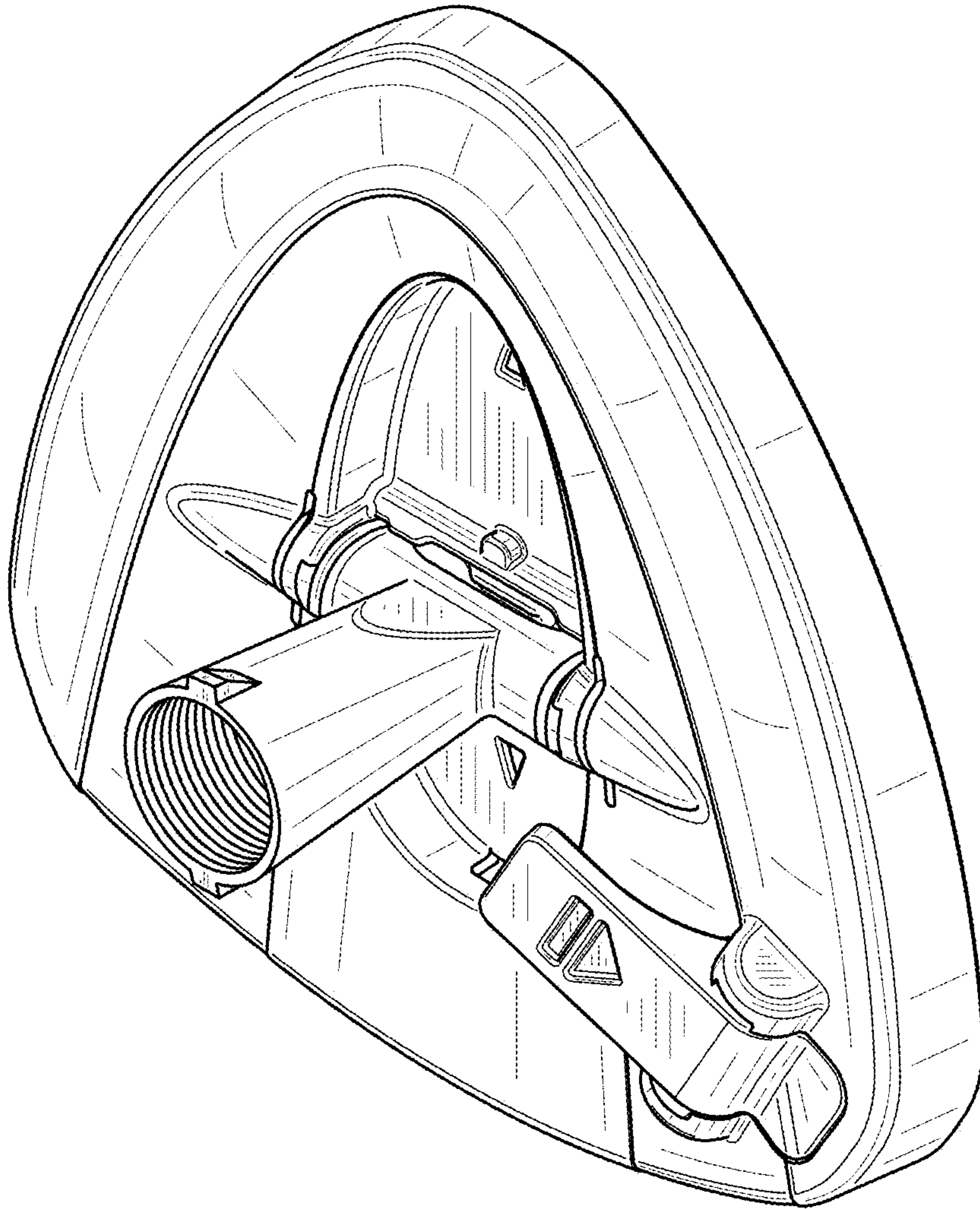

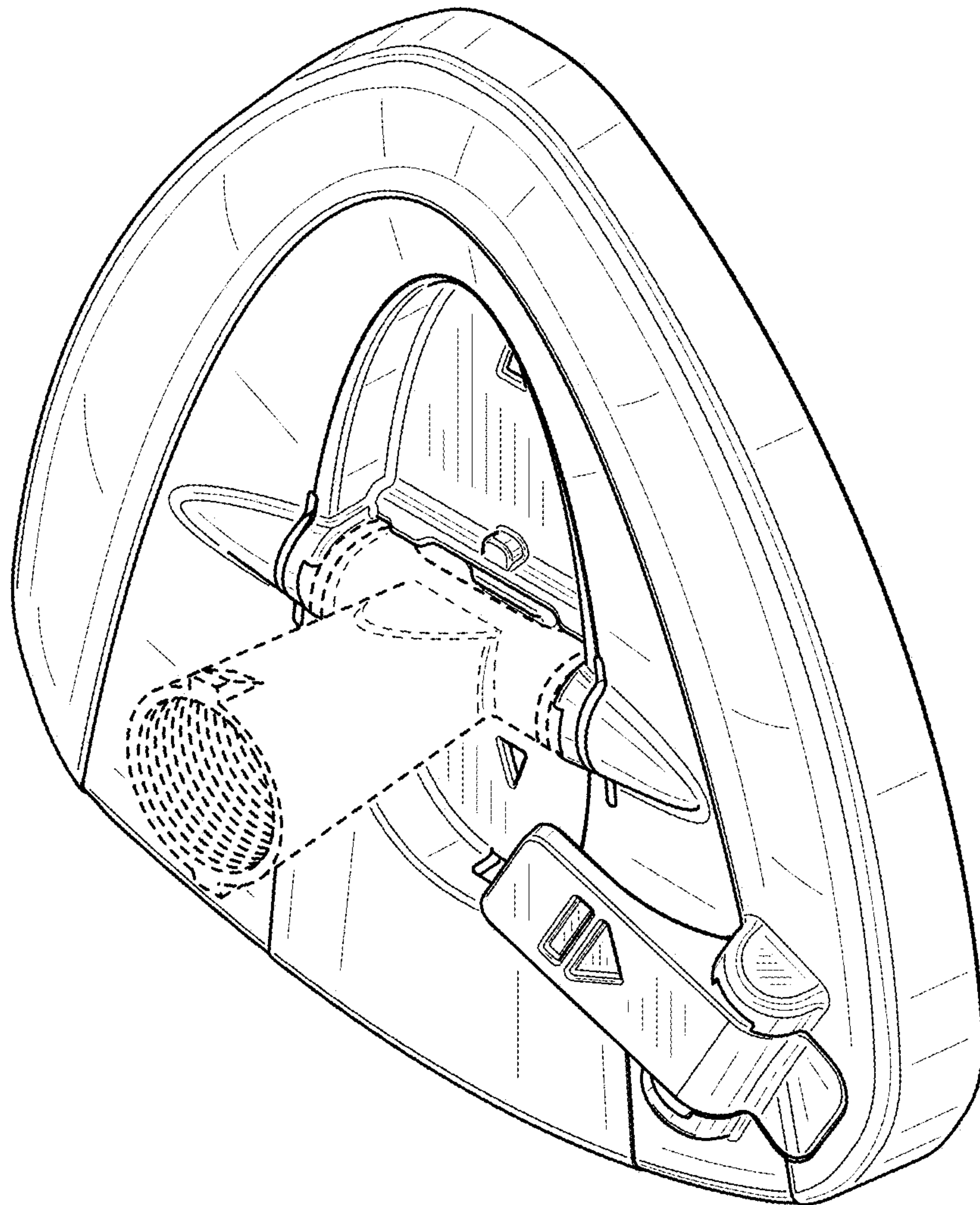
