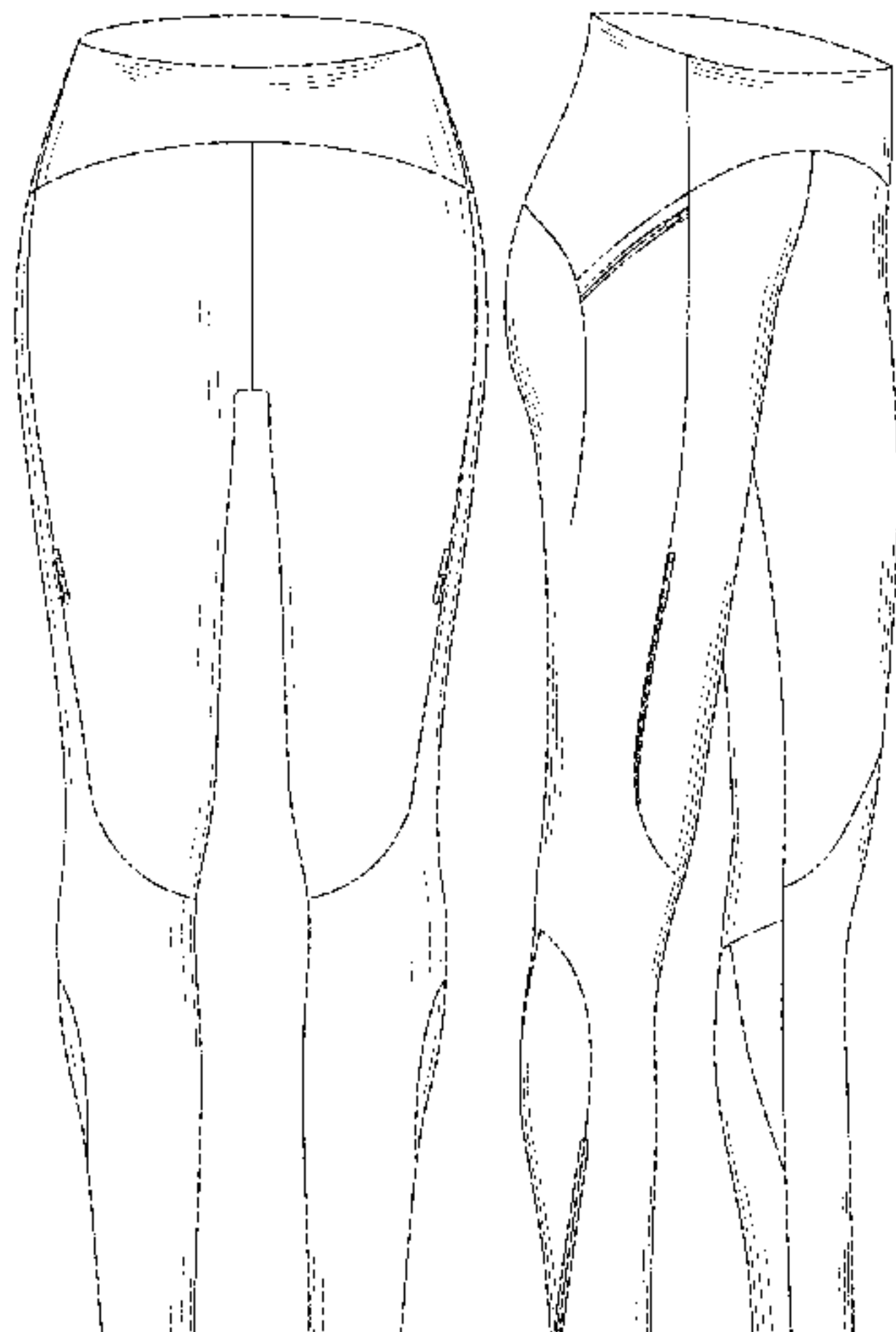
(57) CLAIM

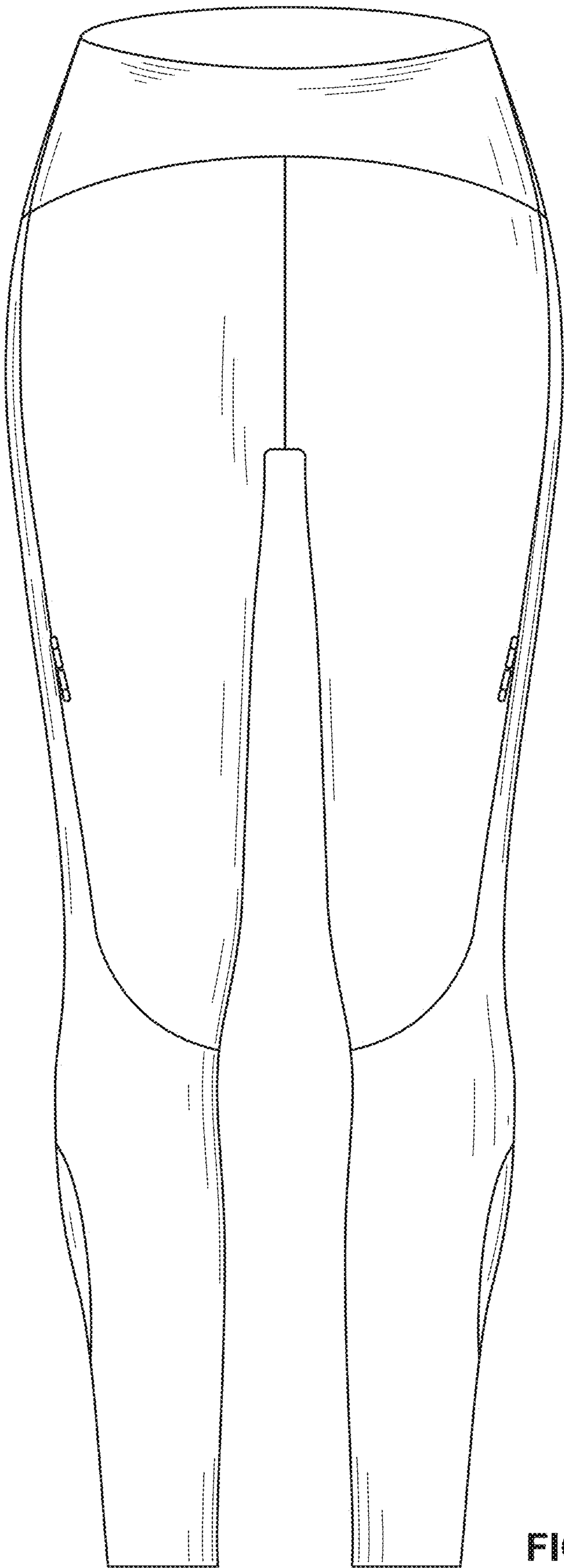

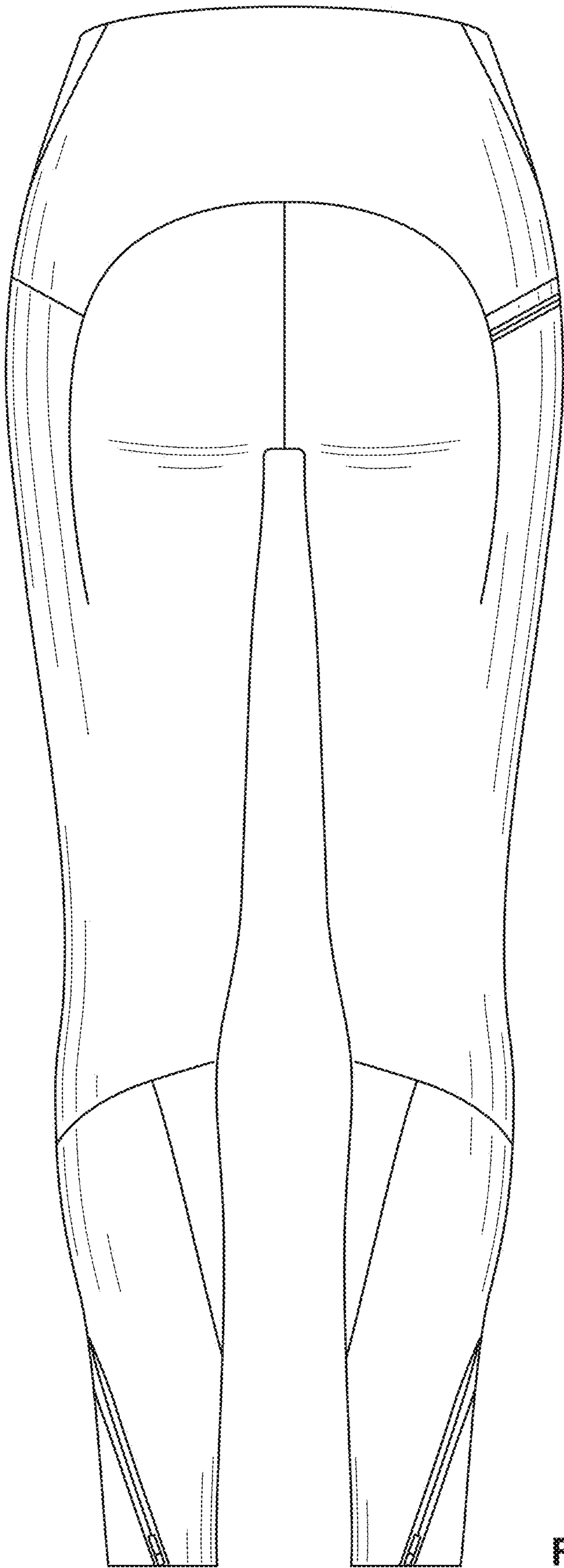

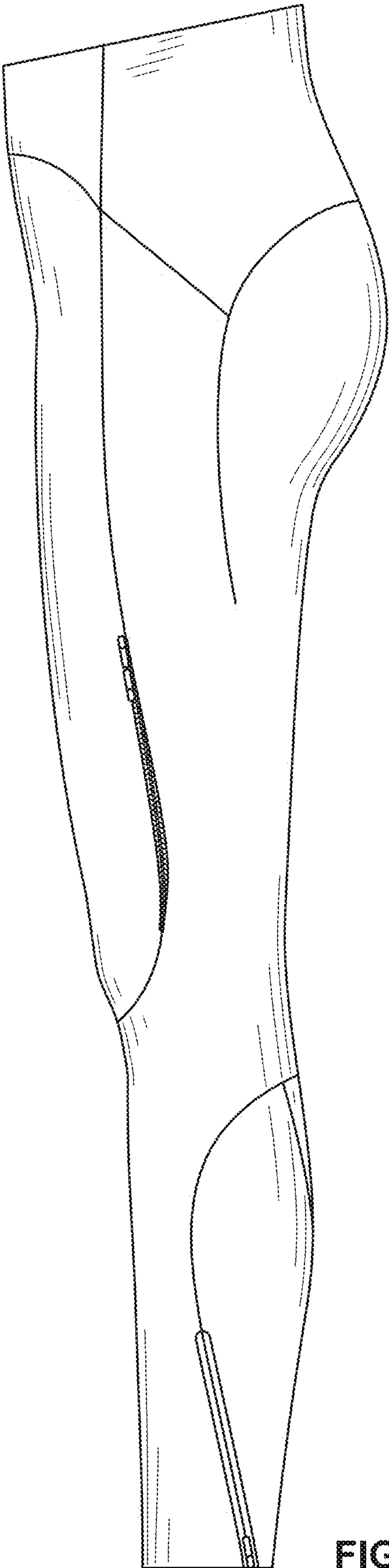

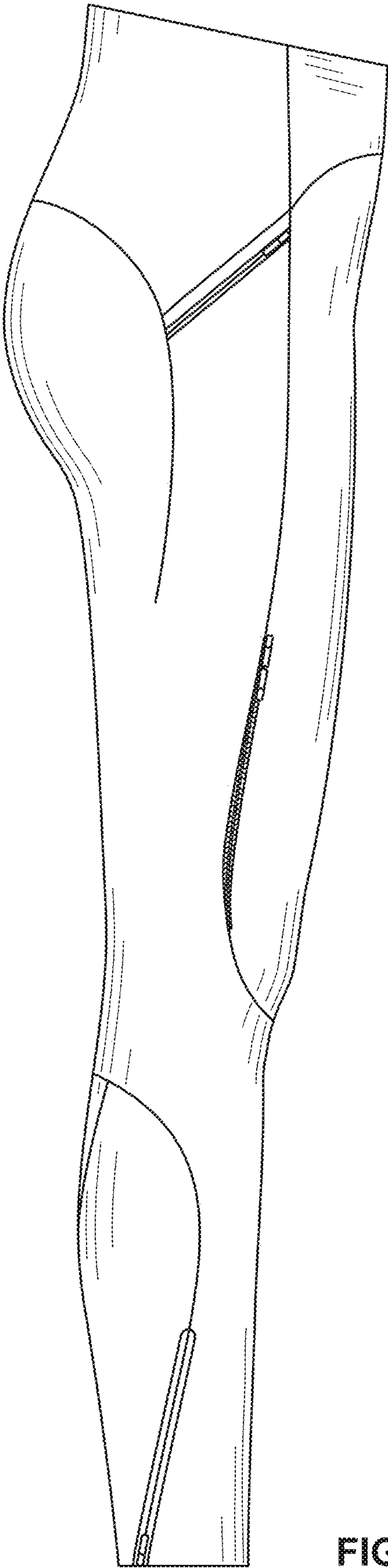

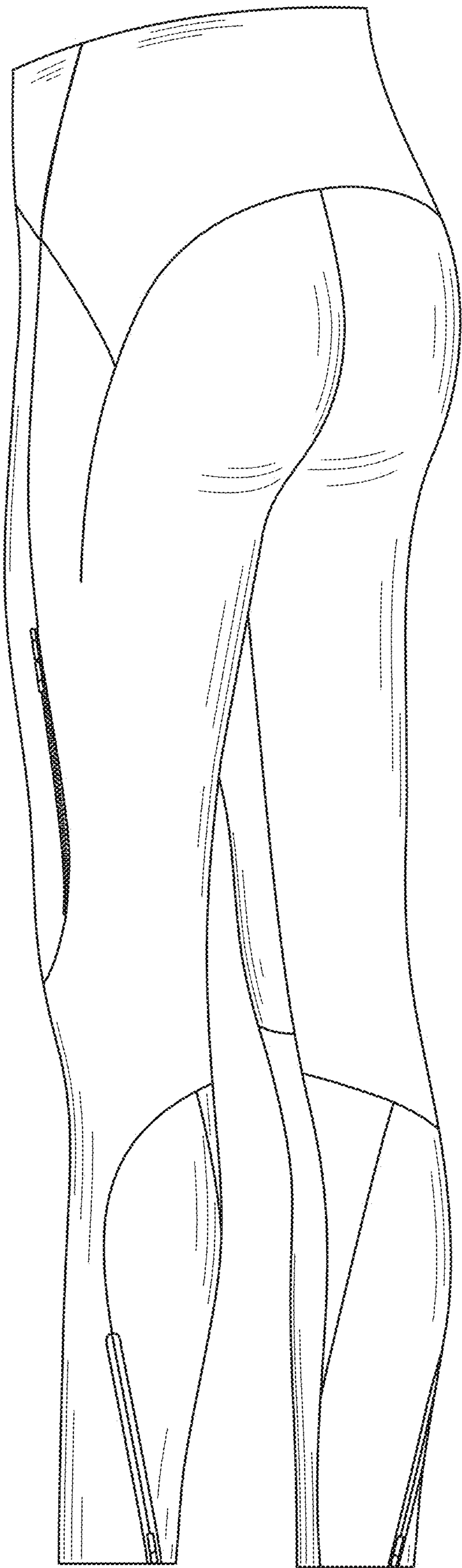

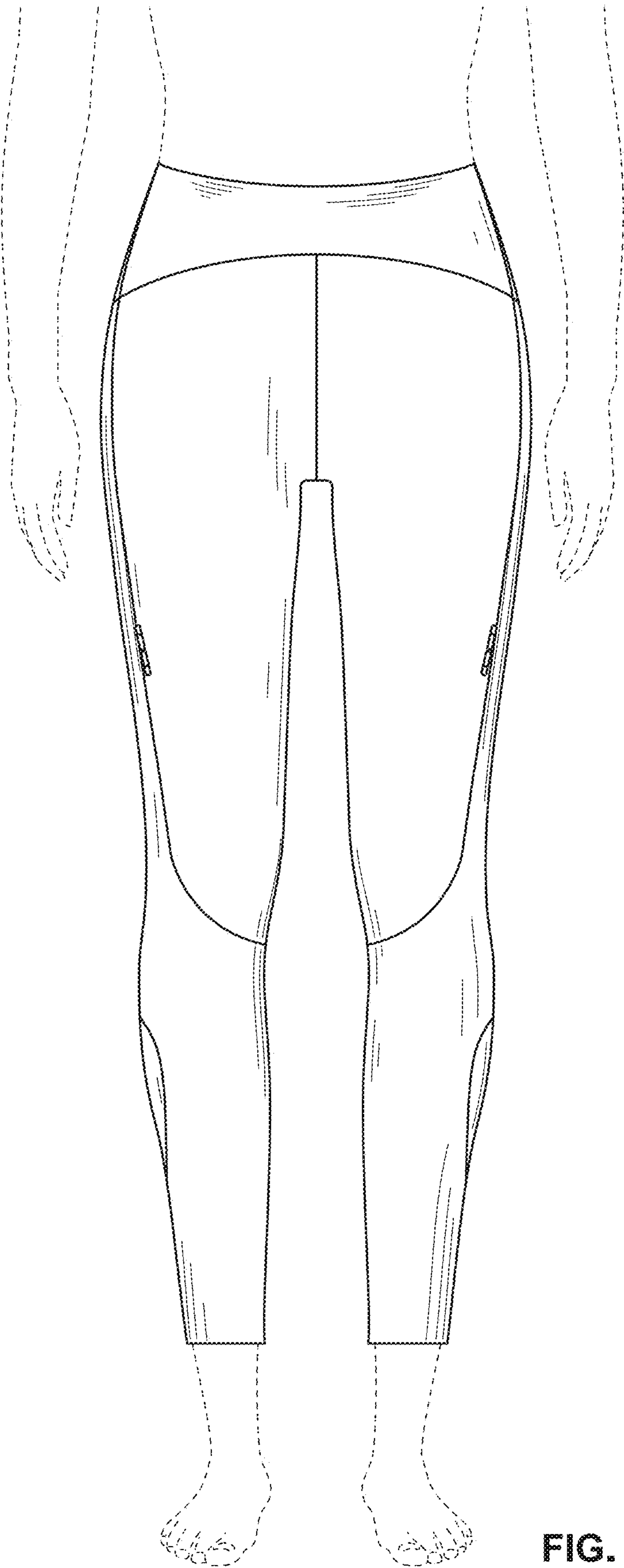

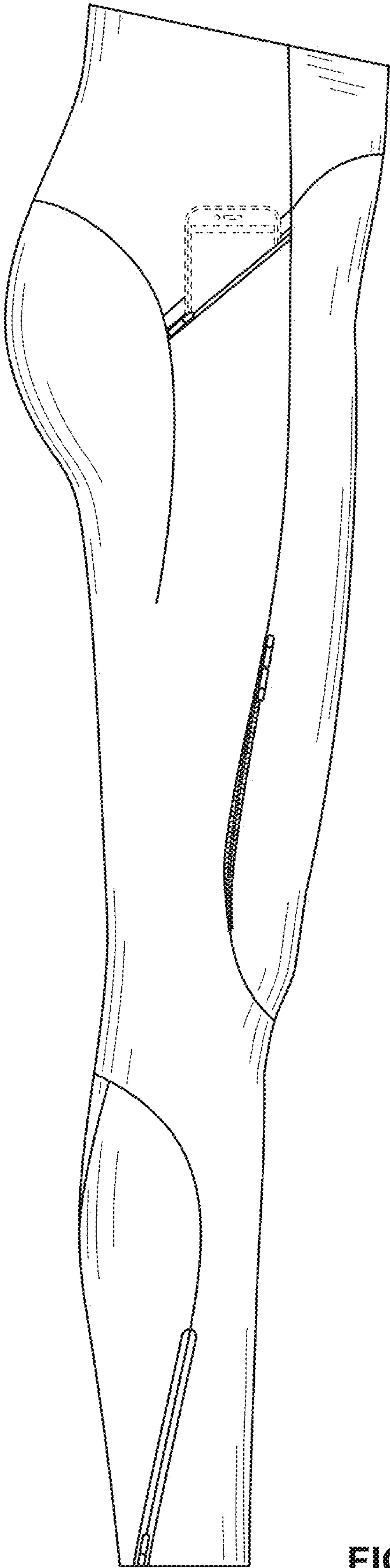

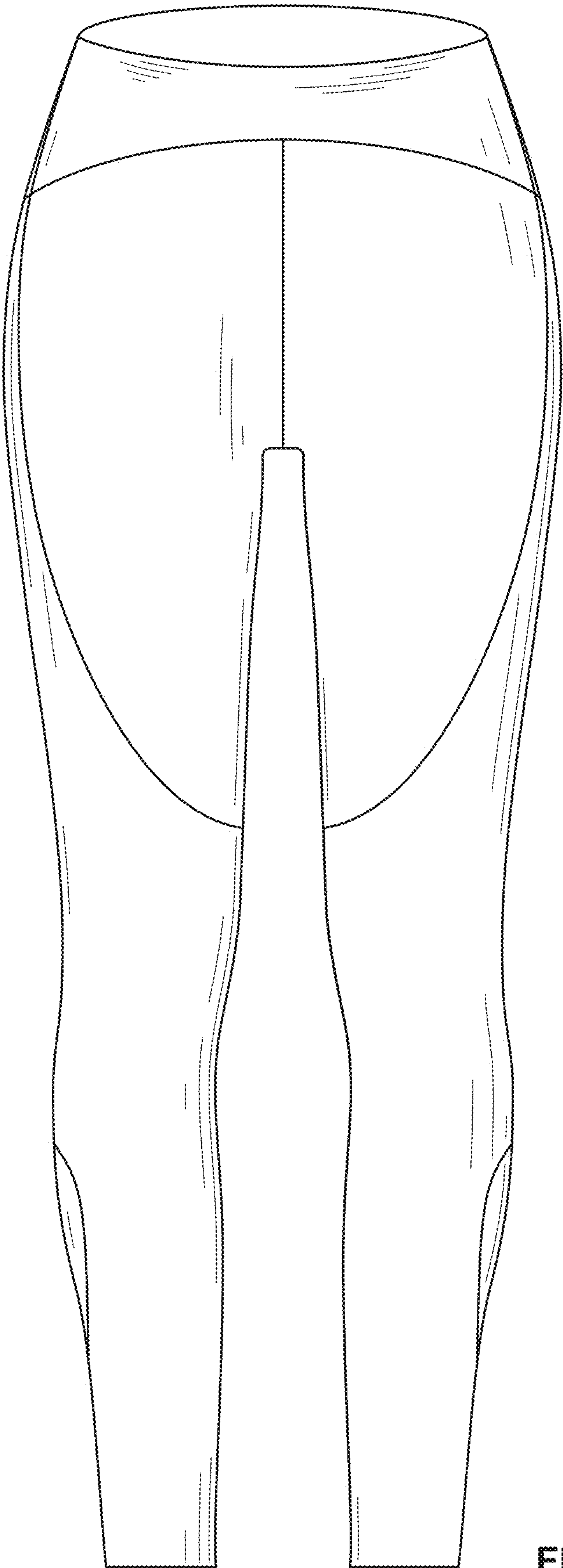

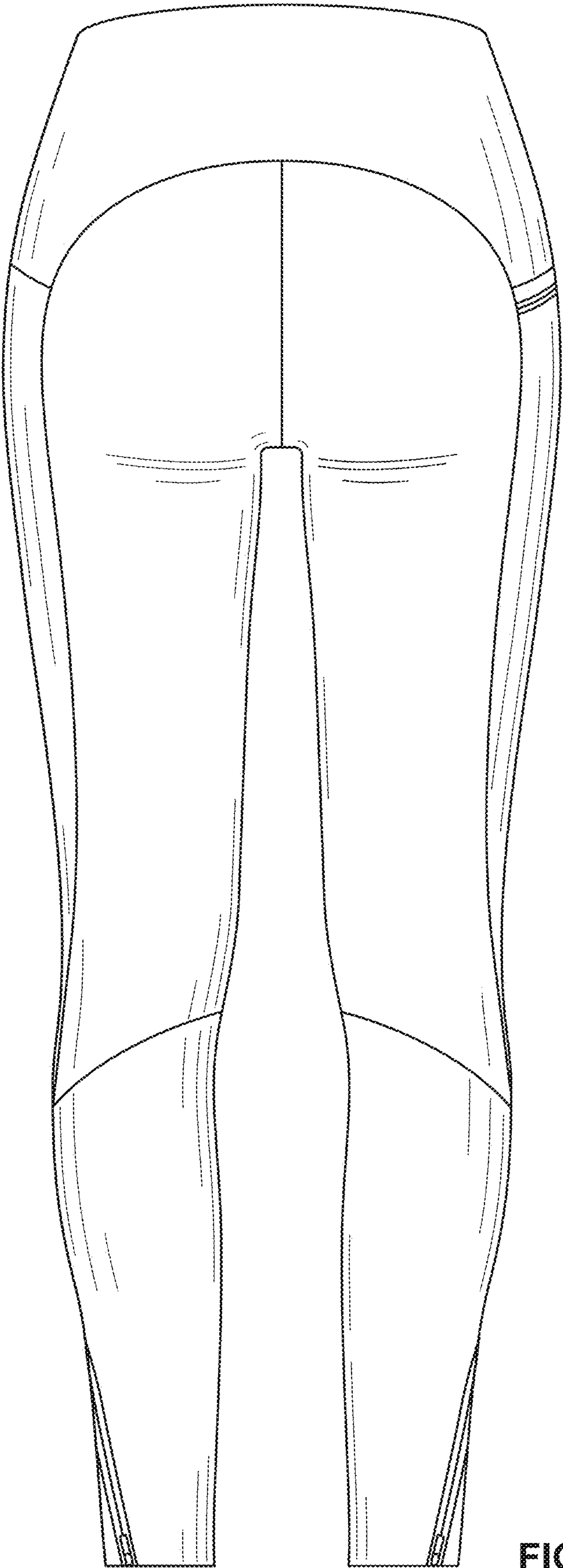

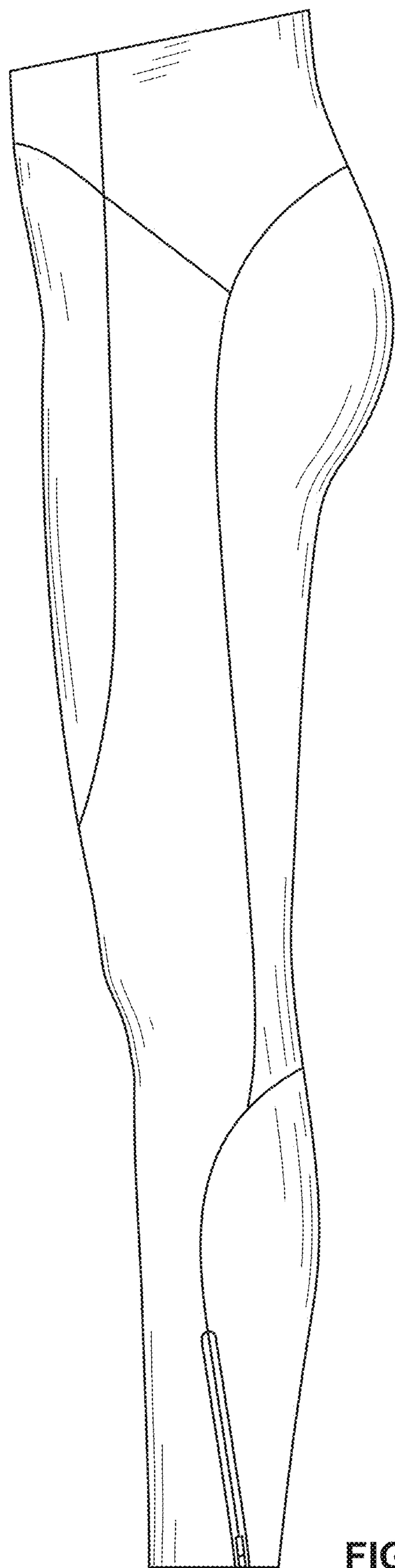

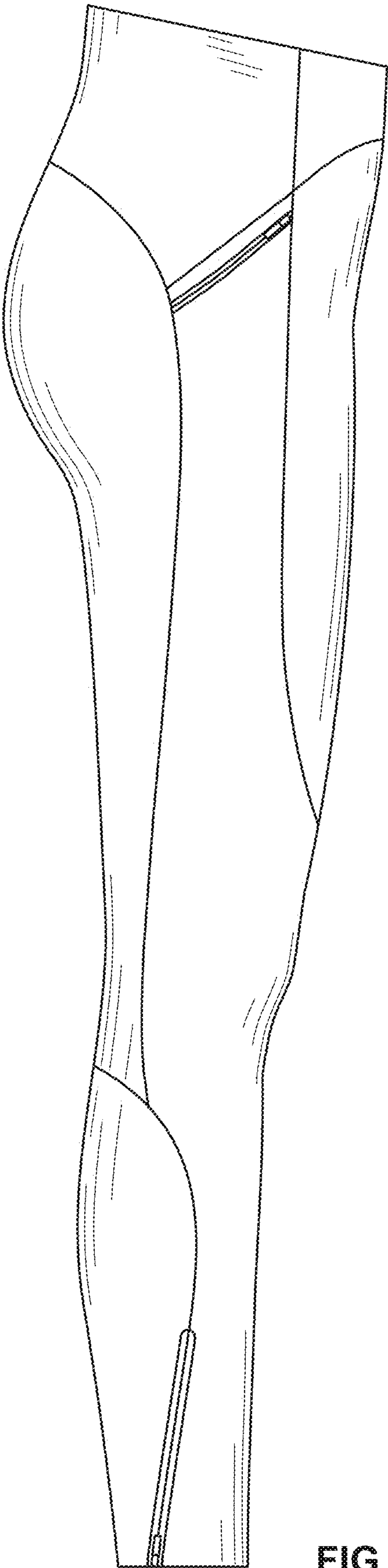

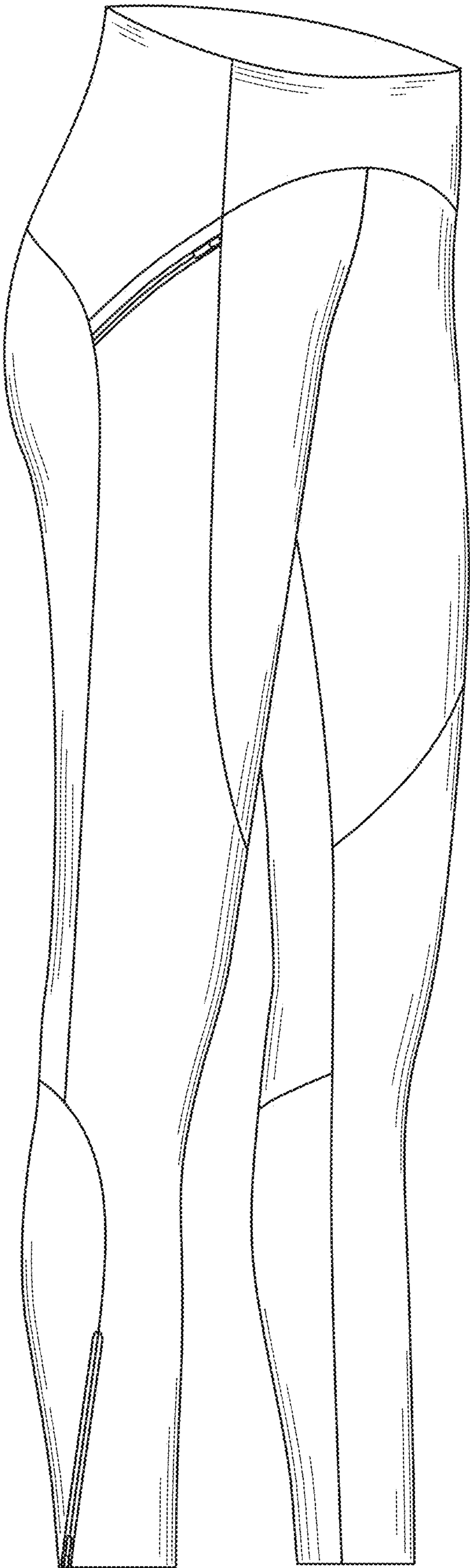

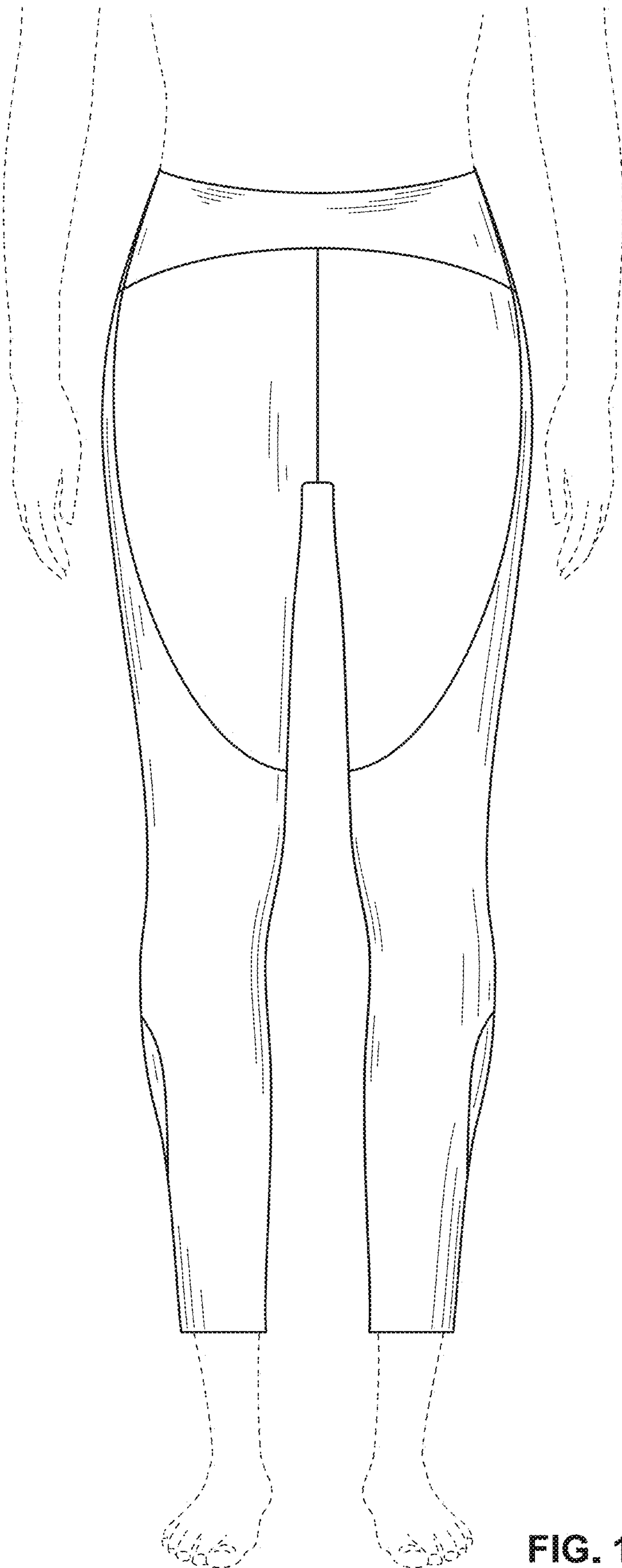

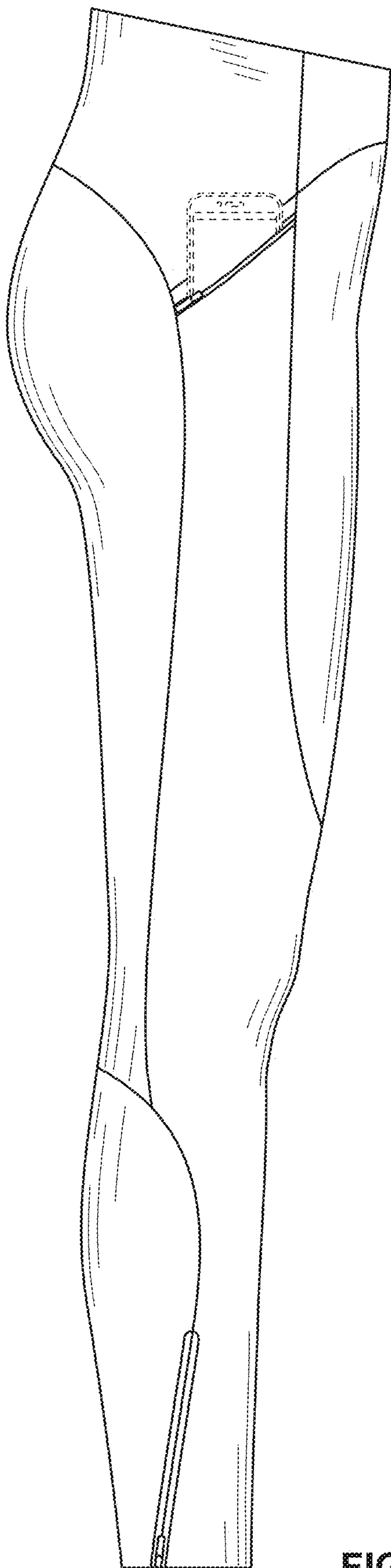
