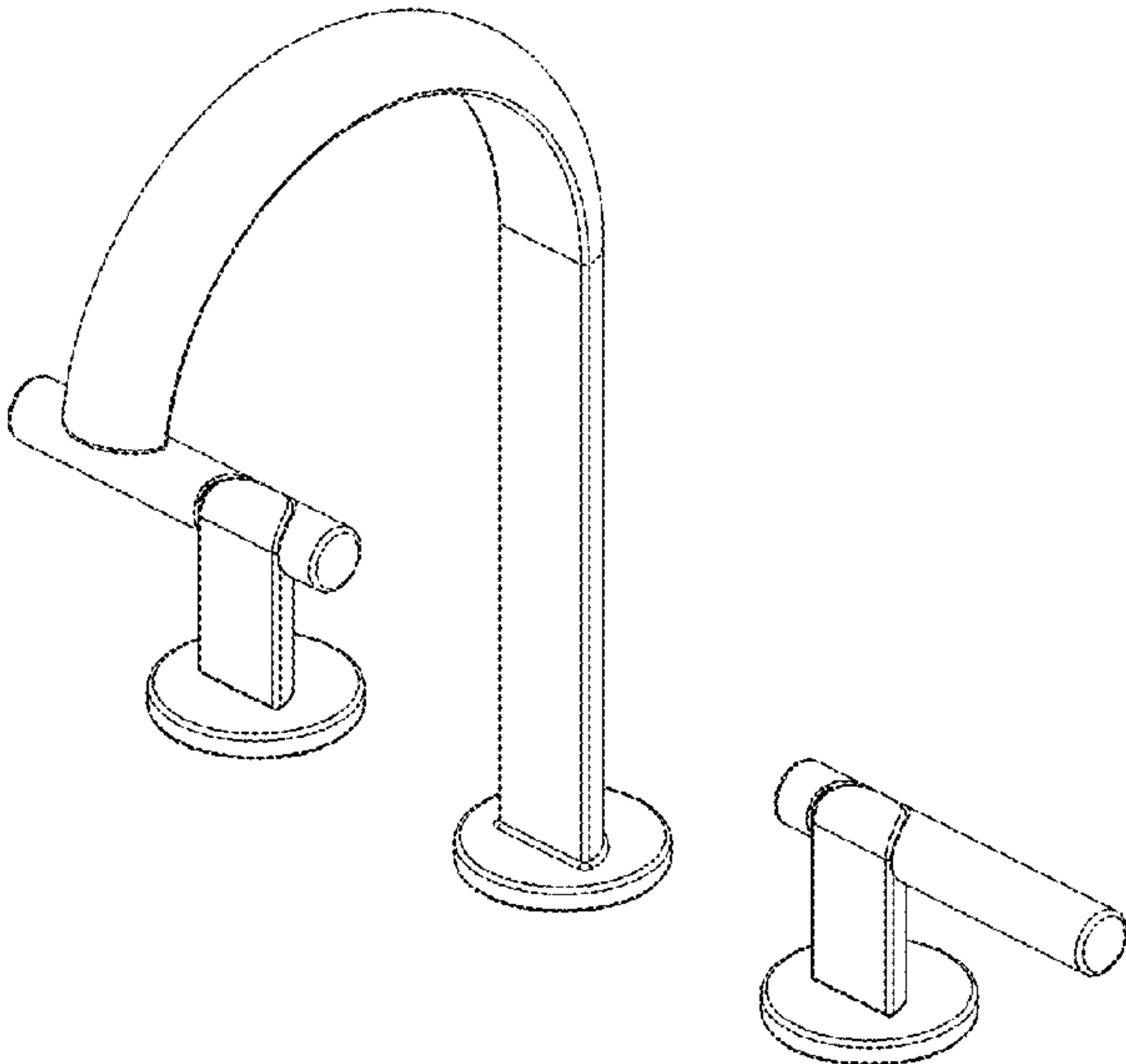
(57) CLAIM

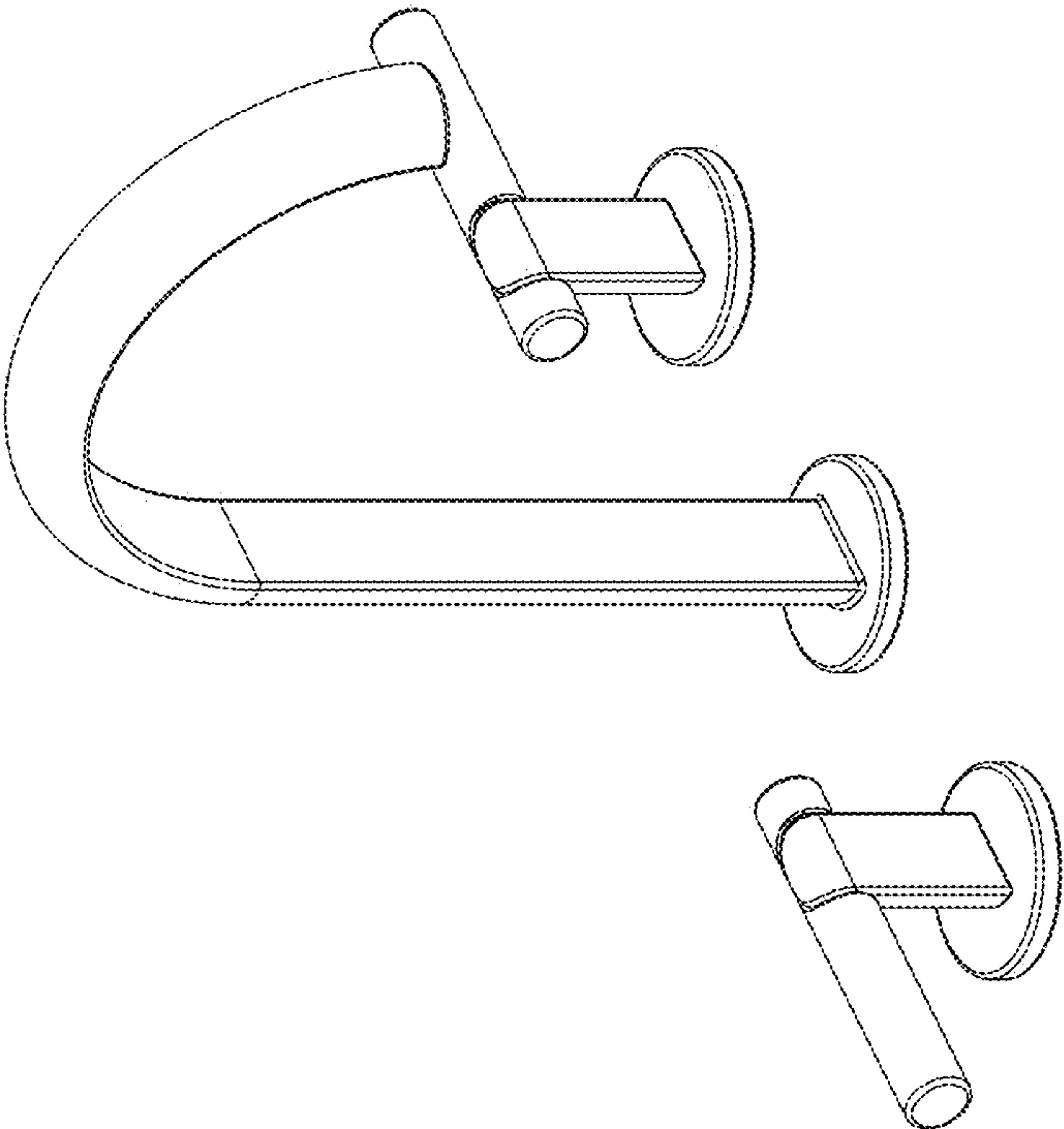

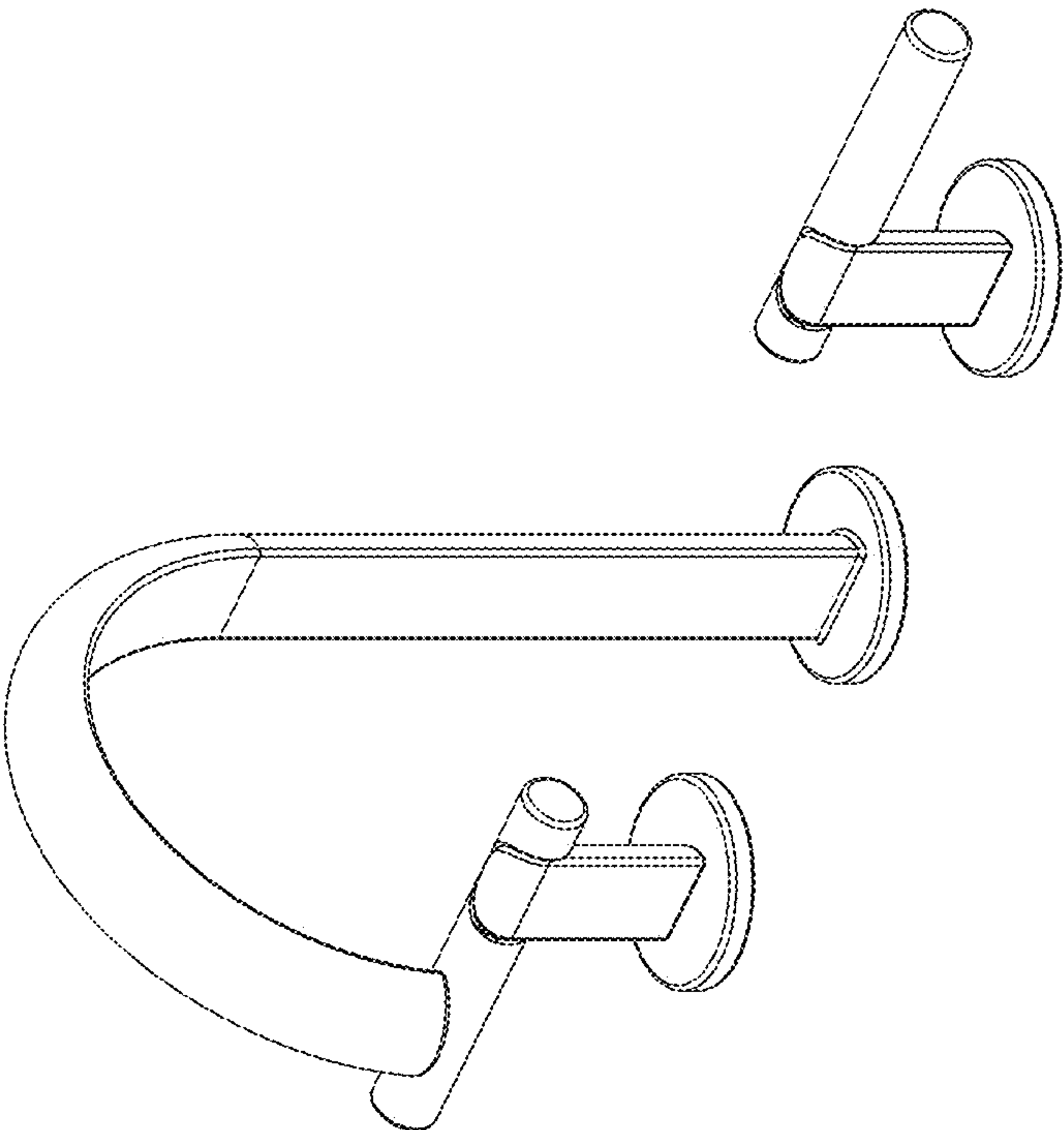

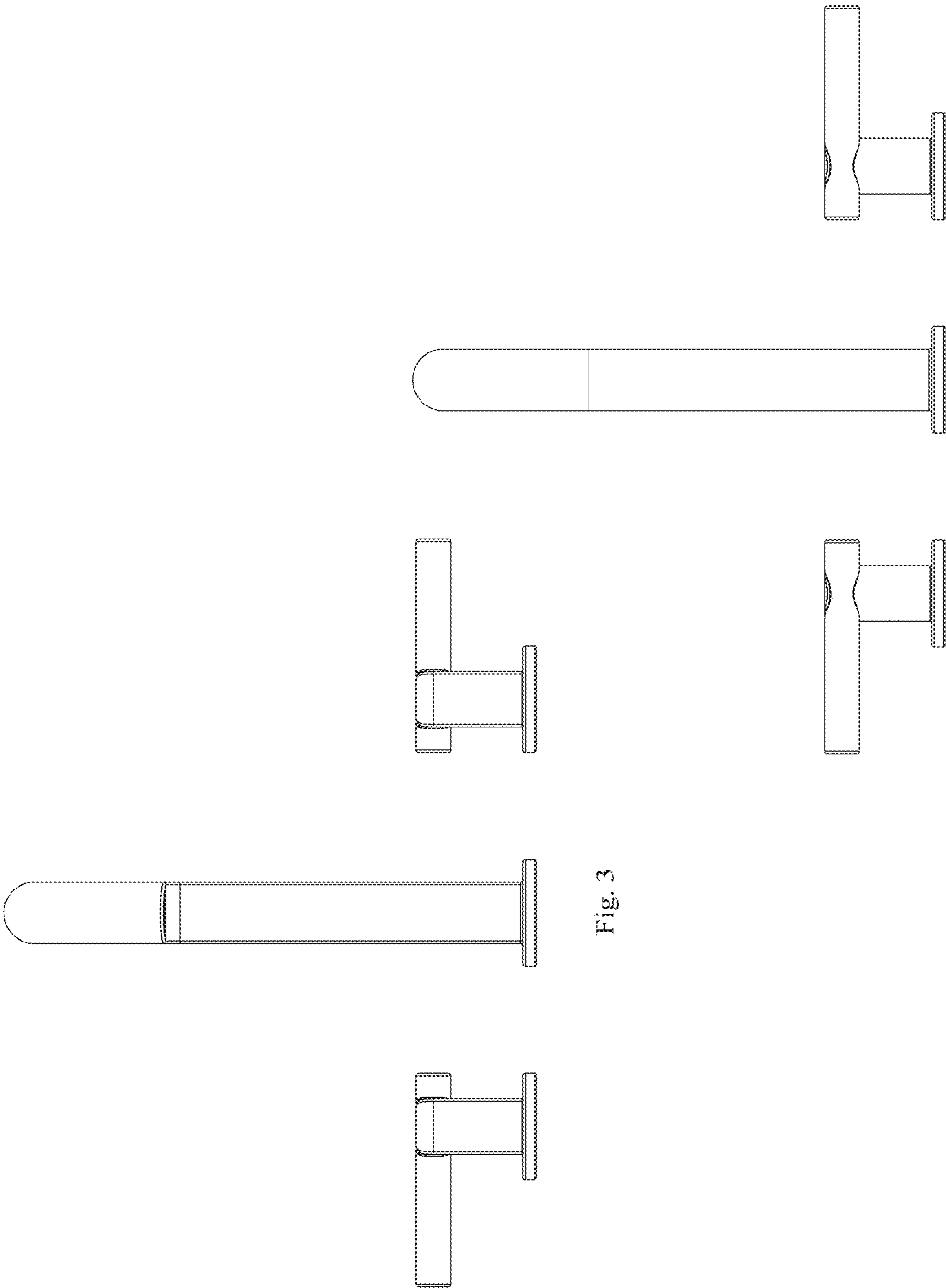

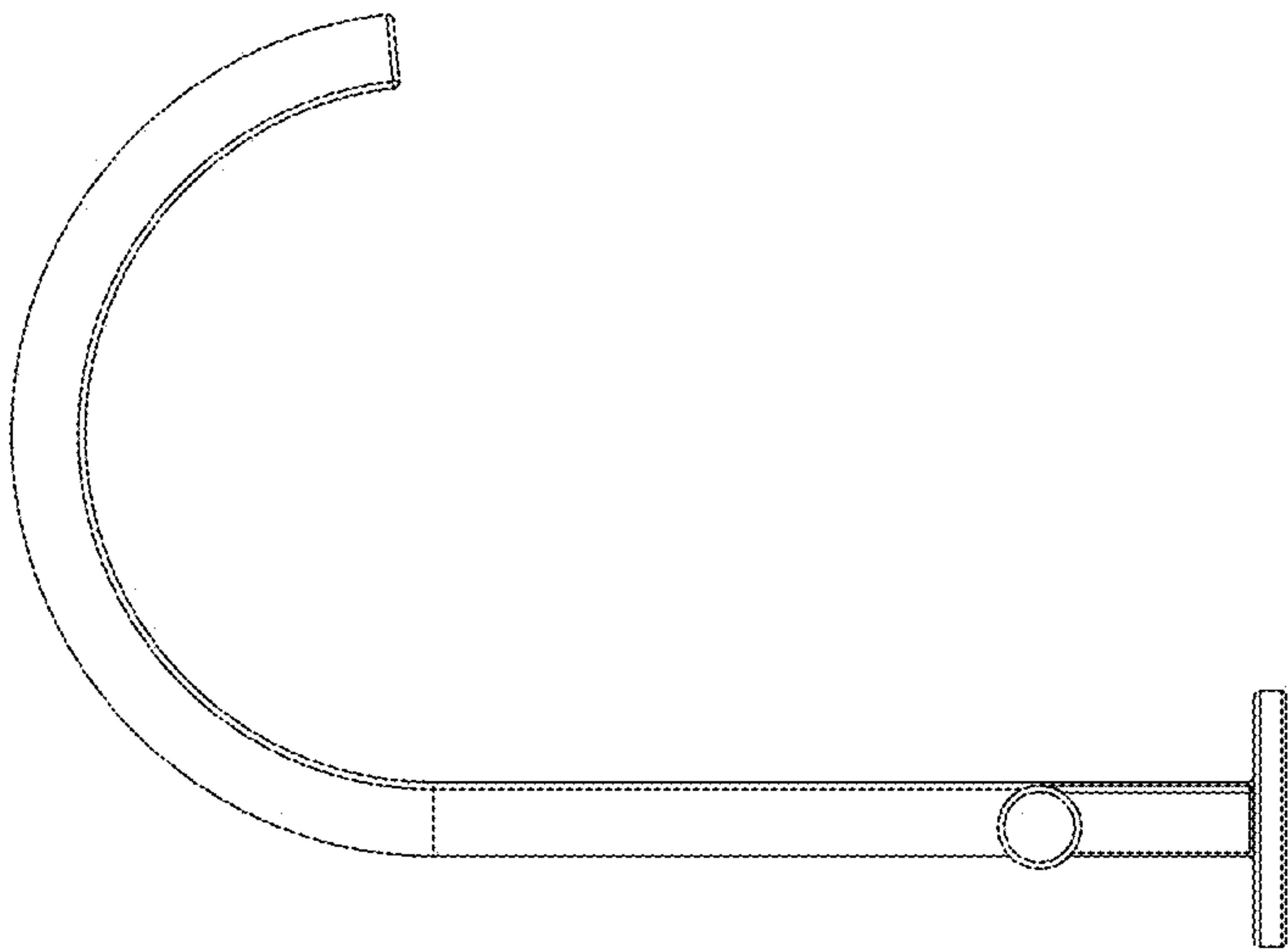

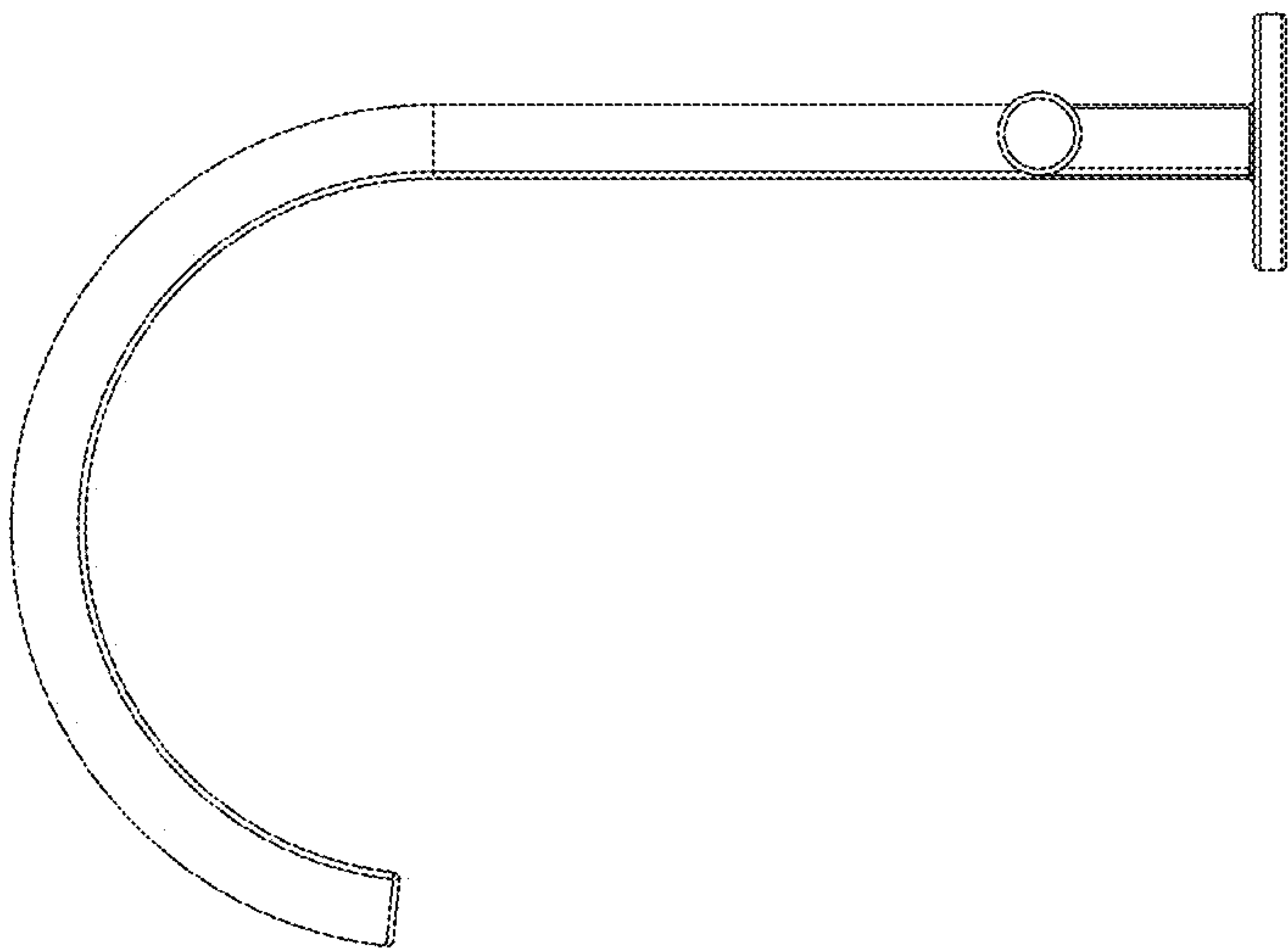

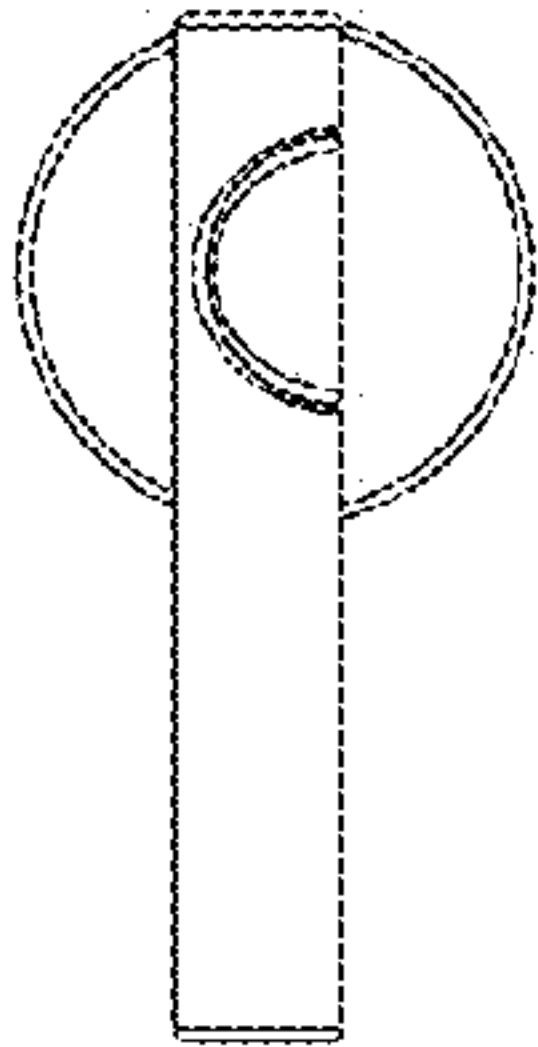
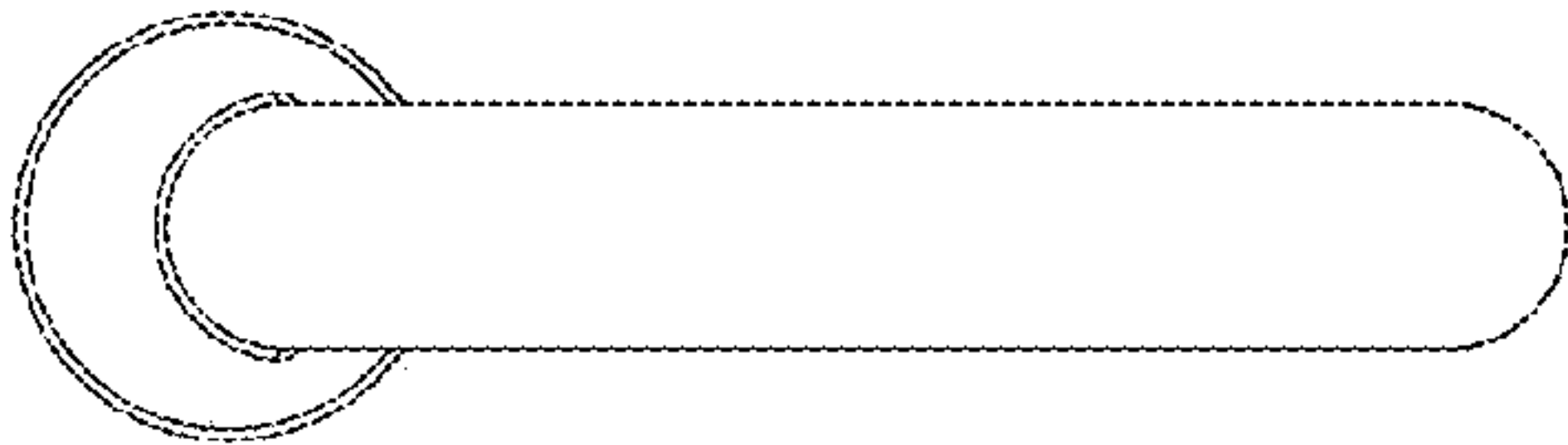
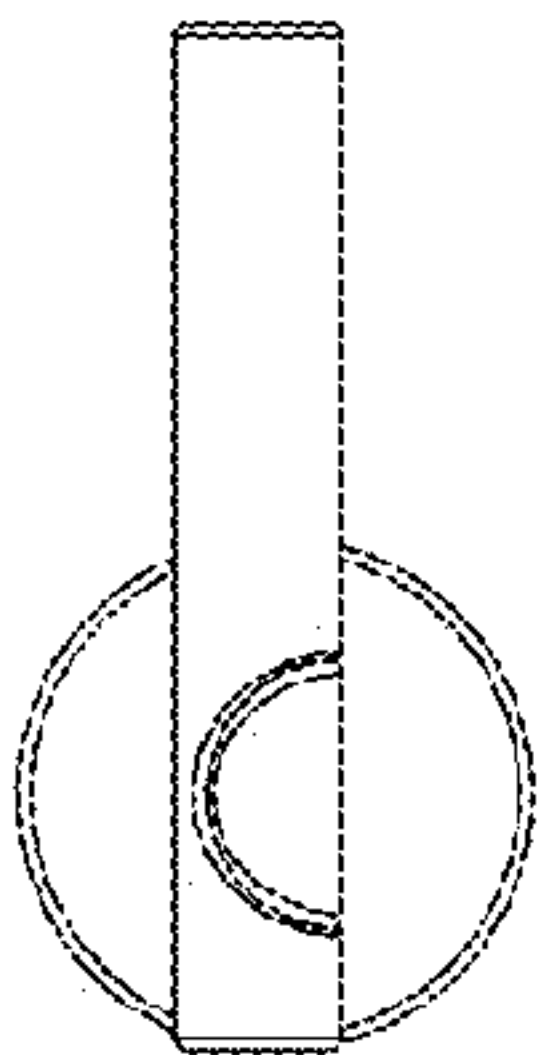

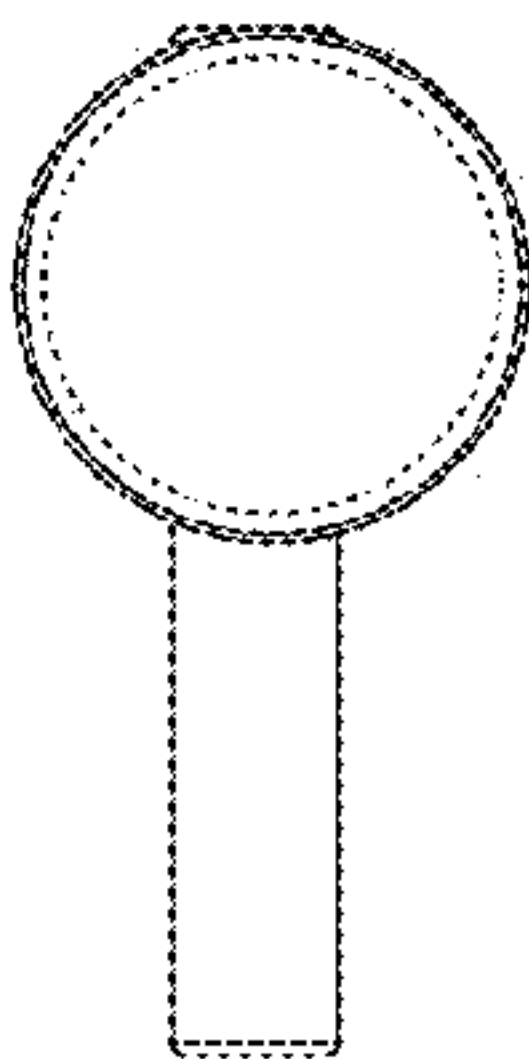
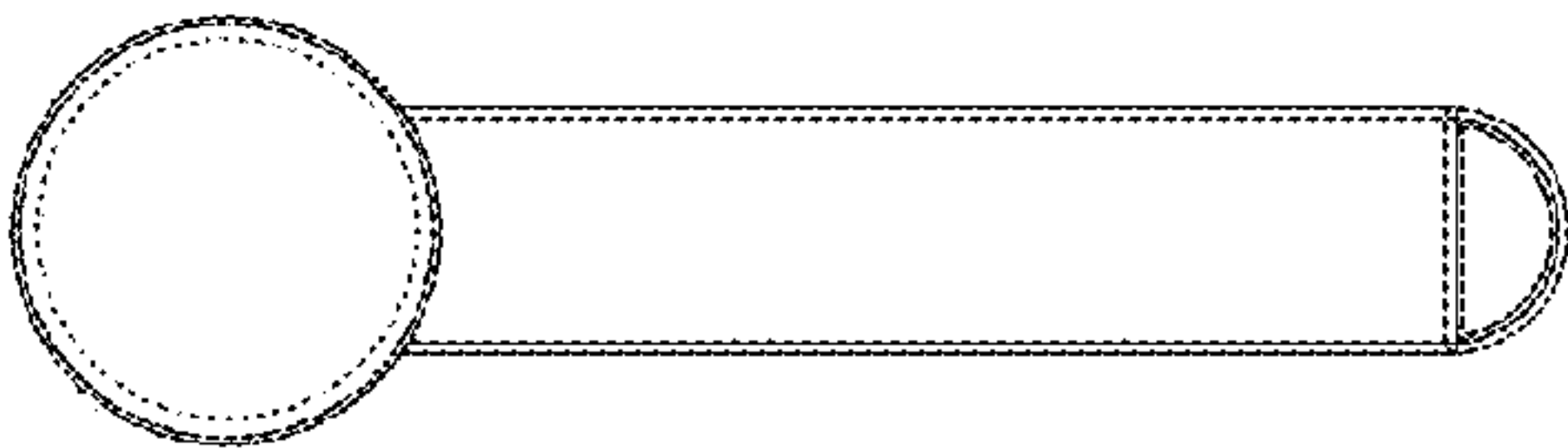
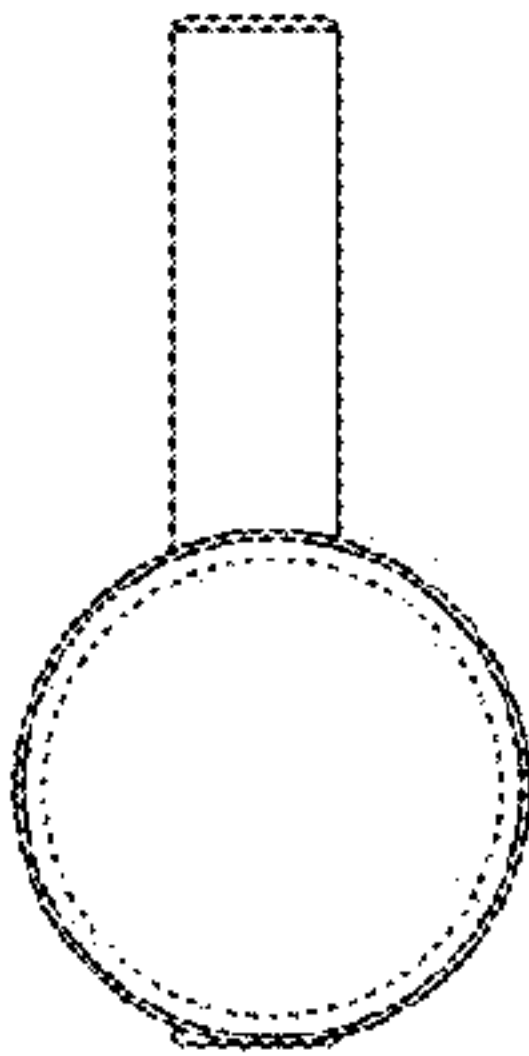
