(57) **CLAIM**

The ornamental design for a media player device with light, as shown and described.

DESCRIPTION

FIG. 1 is a top-front perspective view of the media player device with light, with an ambient light turned off;

FIG. 2 is an alternate top-front perspective view thereof, with the ambient light turned on, as shown by the dashed lines;

FIG. 3 is top-right perspective view thereof, with the ambient light turned off;

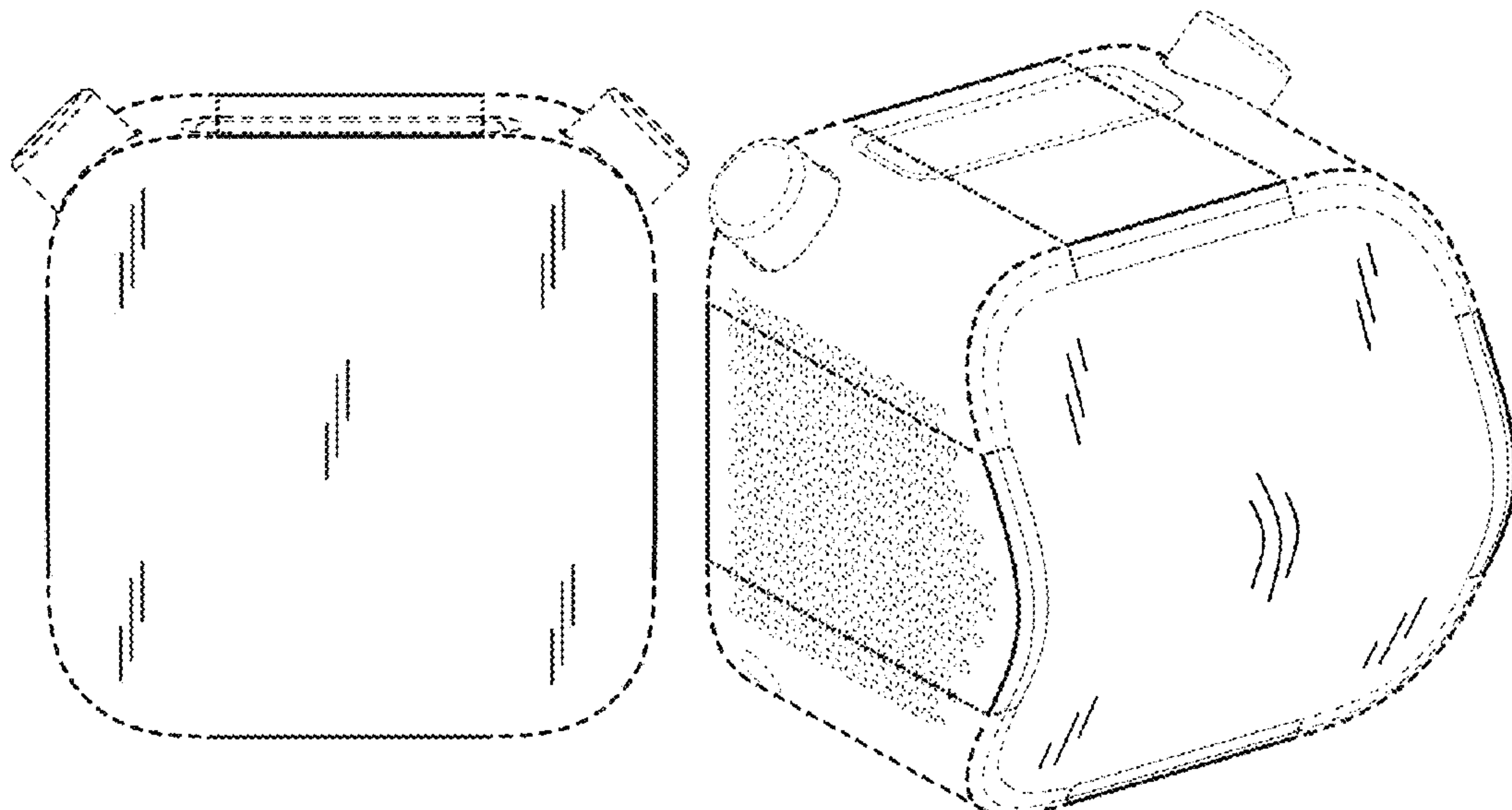
FIG. 4 is an alternate top-right perspective view thereof, with the ambient light turned on, as shown by the dashed lines;

FIG. 5 is a top-rear perspective view thereof, with the ambient light turned off; and,

FIG. 6 is a different top-rear perspective view thereof, with the ambient light turned off.

The dash-dash broken lines seen immediately adjacent the shaded areas and the dot-dash broken lines represent the bounds of the claimed design. The radiating broken lines seen in FIGS. 2 and 4 are included for the purpose of illustrating environmental matter. All other broken lines are included for the purpose of illustrating portions of the media player device; all of the broken lines form no part of the claimed design.

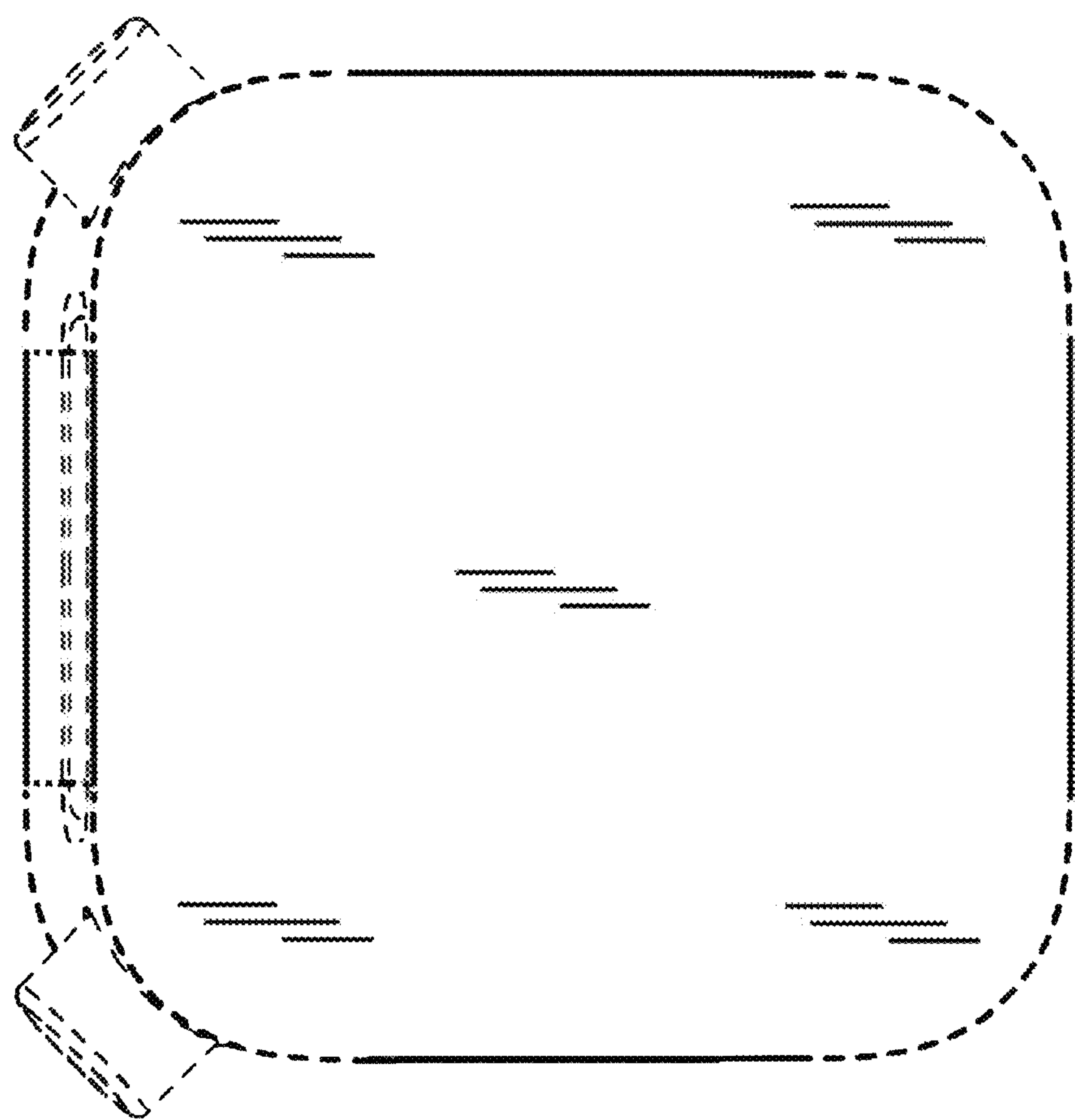

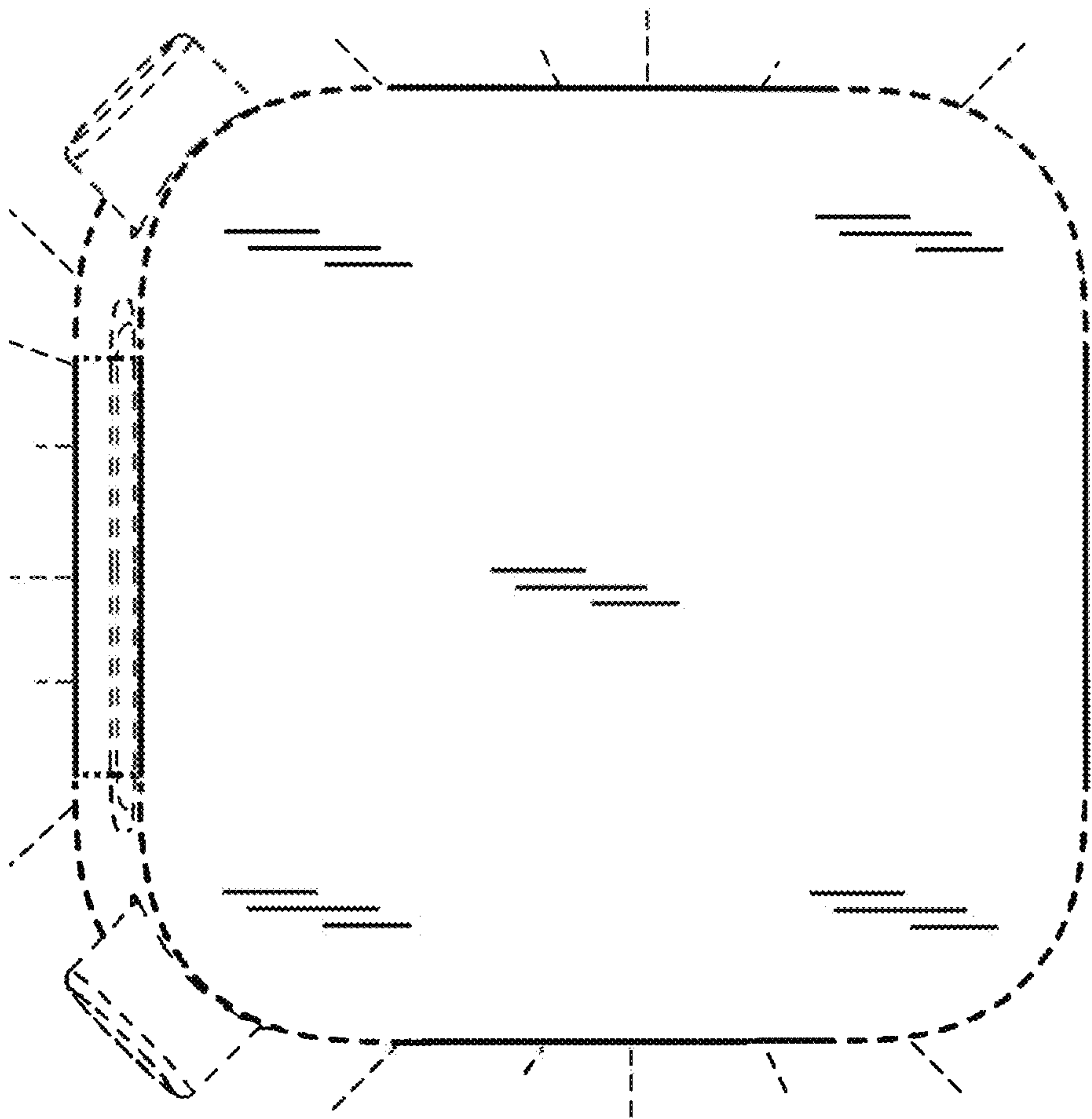

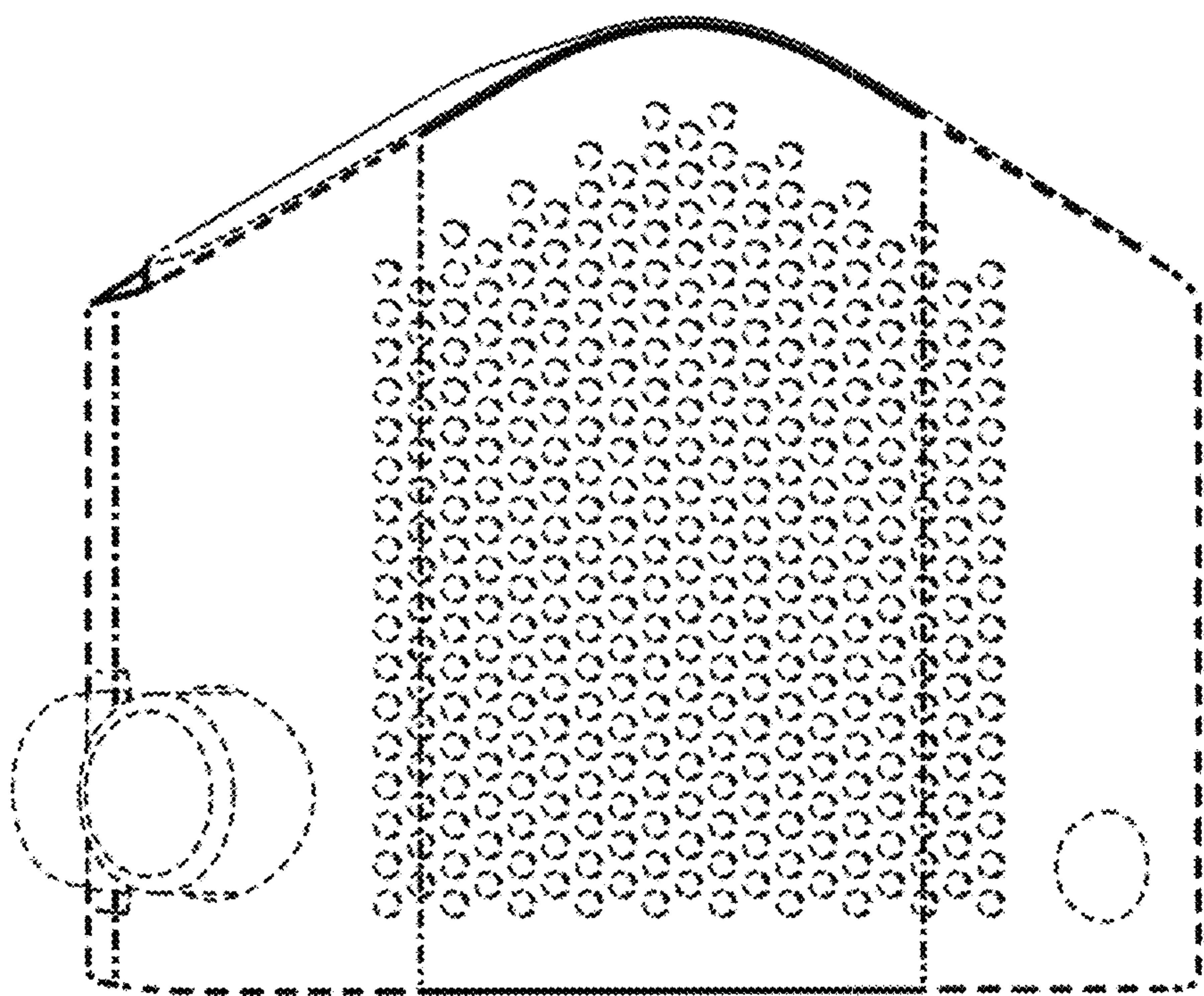

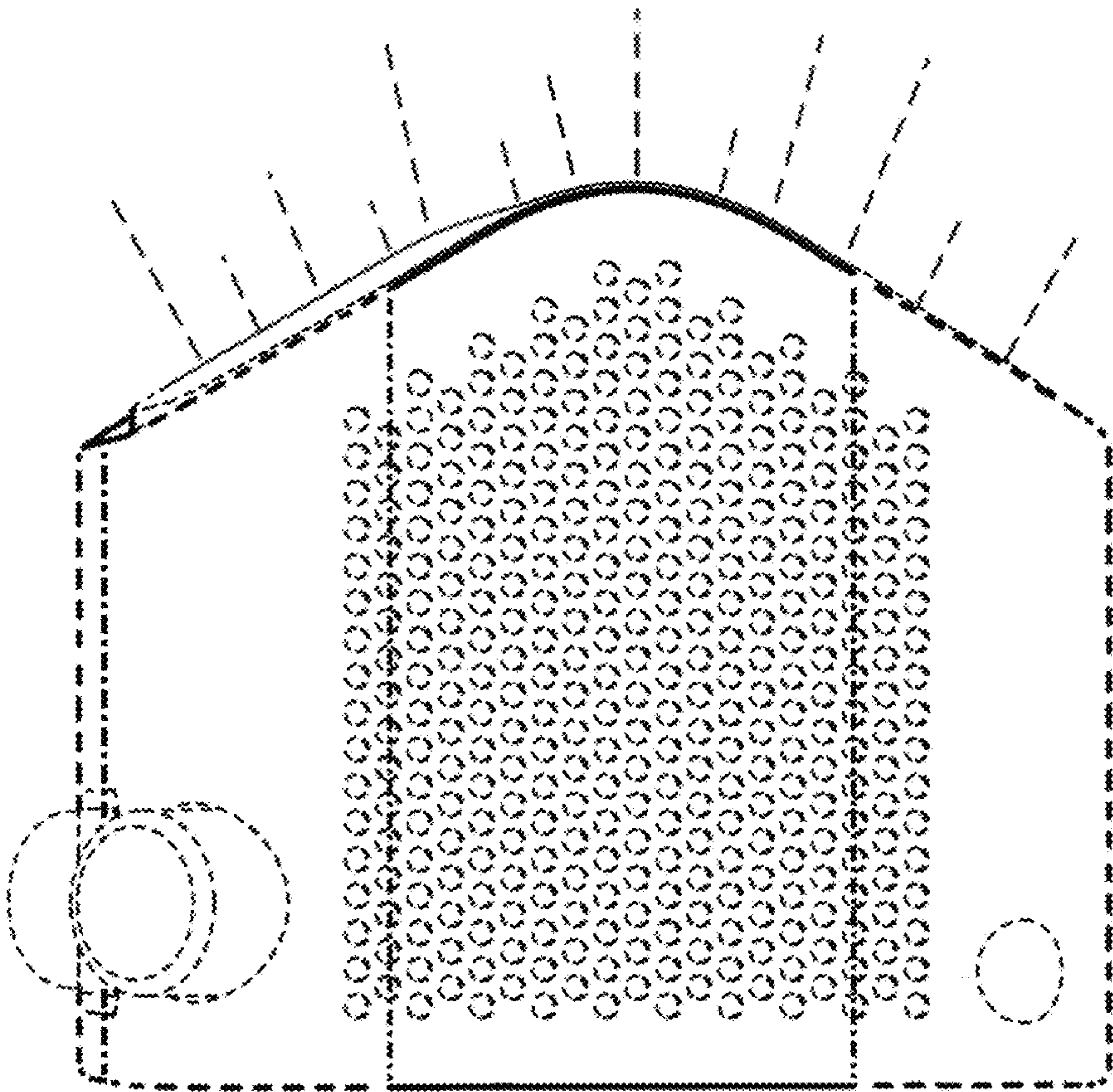

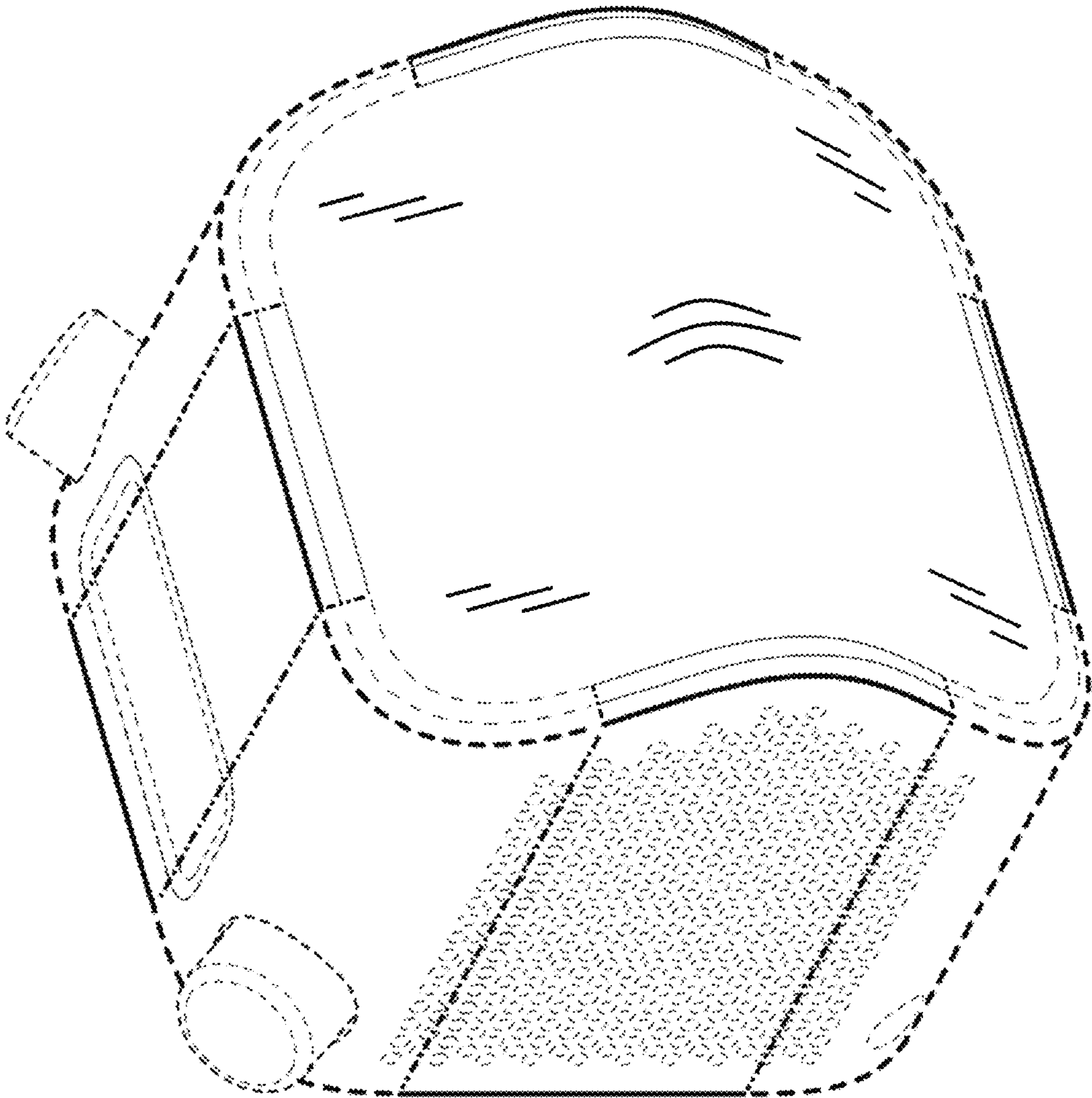

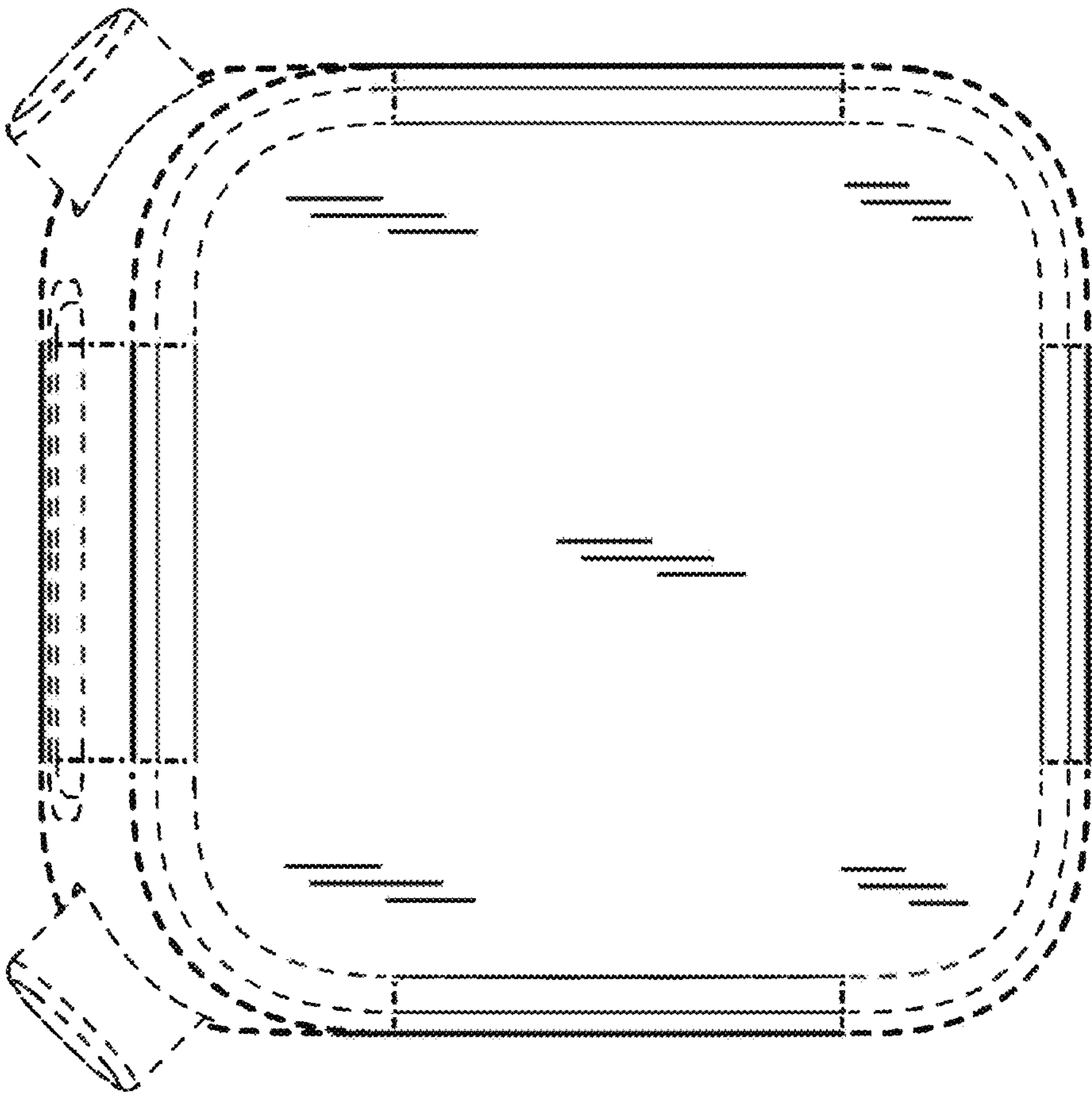
